U. S. MOVES TO PROTECT LAND

Land Utilization Conference Called For Nov. 18 to 21 to Consider Problem.

Chicago, Nov. 14.—(AP)—After 150 years without a formulated land policy the United States abruptly faces the need for a program to protect the economic and social values of its 900,000,000 acres in farms.

To this end Secretary Hyde of the Department of Agriculture and the Association of Land Grant Colleges and Universities have called the first land utilization conference in history into session here November 19 to 21.

States have studied the subject but never before has the national government moved so broadly to regulate the use of public and private domain. From Colonial days it has been assumed that all cultivable land was destined to be used to produce and fiber and that the sooner it could be put to that purpose the better.

The conference is a frank refutation of that theory, an open admission that too much land is being cultivated and a signal that farms not paying the cost of production must be retired if relief for agriculture is to be effective. The conference's recommendations are expected to form the base of state and national legislation to remedy overproduction, maladjustment of crops, tax delinquency and warm abandonment.

Secretary Hyde says the way has been pointed to by certain of the New England and Great Lakes states.

Wisconsin has a law enabling counties to take over tax delinquent lands and make forests out of them. New York is spending \$2,000,000 a year to reforest waste lands. Of the 30,000,000 acres in New York 22,000,000 at one time was in farms. There now is only 18,000,000 which means that 4,000,000 acres have been retired. Governor Roosevelt says 20 per cent of the remainder should be turned into permanent forests and pastures.

SEEKS TO AID HOME OWNER

Hoover to Ask Congress for String of New Federal Banks to Help Credits.

Washington, Nov. 14.—(AP)—A \$1,800,000,000 blast beneath the frozen home building credit jam planned by President Hoover through the creation of a nationwide string of new federal banks. The President announced late yesterday he would request Congress to set up a dozen home loan discount banks, capitalized at around \$150,000,000, but capable of advancing 12 times that amount to institutions dealing in small mortgage loans. He expects the results to spread far and wide. Among those hoped for he listed:

A revival of home building and a resultant increase in employment. An emergency easing of financial strain upon sound banks and loan associations dealing in home building securities. A safeguarding against future building slumps. A long-time promotion of home ownership through the financial strengthening to credit institutions.

The Chief Executive's sudden launching of his plan caused some surprise. Although he has conferred twice recently with groups of bankers, real estate and building and loan association men, still another such conference is scheduled. (Continued on Page Three)

Convict Minister of "Impudence"

Atlanta, Ga., Nov. 14.—(AP)—The Rev. Rembert G. Smith, of Sparta, Ga., has been convicted of "gross impudence and unministerial conduct" by a committee of thirteen members of the North Georgia Conference of the Methodist Episcopal church, South and his suspension for one year recommended. The committee reached the verdict last night and prepared it for presentation to the general conference today. Mr. Smith was acquitted of other charges which the committee described as a "very serious" nature. The charges on which the minister was tried will not be made public. The defendant minister had been outspoken in opposition to what he described as "the political activities" of some of the leaders of the southern church. Mr. Smith vigorously criticized Bishop James Cannon, Jr., and others of the church for activities in the 1928 Presidential campaign.

TELLS TALE OF TRIALS AT SEA

Eleven Shipwrecked Men Recount Harrowing Experiences Before Rescue.

Colon, Panama, Nov. 14.—(AP)—Eleven survivors of the crew of the motor ship Baden-Baden which foundered off the Colombian coast Monday, rested today and recounted the experience of three days and nights in a storm-tossed open boat, facing starvation. Twenty minutes after the freighter went down and they had seen a second life boat overturn carrying five of their comrades to their deaths, the eleven heard the comforting drone of an airplane, they said.

Cheered by the prospect of a quick rescue they momentarily forgot that they had but little food and no water, as the Baden-Baden sank so quickly they had scarcely time to clear ship. Two cans of beans and cheese and a single banana comprised their rations. But when hours wore into days and they had parceled out the last of their rations, when chills and fever spread among the occupants of the boat and they found themselves fighting a losing fight against the seas which swept over their craft, they began to despair. Charges Against Officials To Go to Jury Monday

Asheville, Nov. 14.—(AP)—Solicitor Zeb V. Nettles has announced that indictments against John Mitchell, former state bank examiner, and members of the State Corporation Commission, will be presented to the Buncombe county grand jury when it convenes here Monday. The indictments will charge various forms of embezzlement in office because the examiner and commissioners did not, it is alleged, close the Central Bank and Trust Company here, although they were said to have known it was insolvent. Drawing of the indictments followed a recommendation by a recent grand jury after an investigation into charges of laxness in the courts. Discussing the situation in Raleigh last night, Commissioner G. P. Pell said the examiner had not informed the commission the bank was insolvent prior to its voluntary closing November 19, 1930.

BEGINS SPEECH FOR CONGRESS

President Hoover to Stress Economic Relief in Annual Message to Congress.

Washington, Nov. 14.—(AP)—President Hoover retired to the seclusion of his White House study today to begin his annual message to Congress, which he intends to focus directly upon relief of the economic situation. At least half a dozen of the President's recommendations already can be forecast in part. With the approval of the moratorium a first consideration, he plans to center his suggestions next upon measures designed to dynamite jams from the path to prosperity.

First word that the Chief Executive had started the actual writing of his message came as he left the executive offices early in the day. Realizing the shortness of time before Congress gathers December 7, he set aside the entire day for this task. Visitors have been denied engagements. One of the foremost problems to be dealt with is the leaping deficit. The President has refrained from hinting as to whether he will place the administration for or against an increase in taxes. With the deficit approaching \$700,000,000, it is certain he will recommend some step to reduce this figure. Mr. Hoover has served notice he would ask Congress to deny the request of what he calls "sectional interests" so as to conserve federal expenditures. He has stressed this particularly in regard to increased bond legislation.

LEAF SALES HEAVY HERE

Market Sold Over a Million Pounds During Closing Sales of Week Yesterday.

The Greenville tobacco market has sold 4,840,254 pounds of tobacco for \$4,576,316.31 during the present season, it was made known today in the official report of K. W. Cobb, supervisor of sales. Up to the same period last season the market had handled 49,307,244 pounds, the market report also indicated. Sales for yesterday were given as 1,185,129 pounds for \$110,947.18 at a general average of \$9.36 per hundred pounds. The highest average for a barn of tobacco recorded in the belt for this season was established on the market Thursday. Prices for good tobacco continued to show life.

Harry F. Powers Pleads Not Guilty of Killings

Clarksburg, W. Va., Nov. 14.—(AP)—Harry F. Powers pleaded not guilty today to charges of killing Mrs. Asta Buick Eigher and her three children, of Park Ridge, Illinois, and Mrs. Dorothy Pressler Lank, Worcester, Mass. Powers is accused of luring the women here with promises of marriage, killing them and the children, and burying the bodies in a ditch near his garage at Quietdale near here. THREATEN TO TAKE ACTION

Warn Mah Chan-Shan that Unless District is Evacuated Effective Steps Will Be Taken to Handle the Situation; Chinese General Says He'll Fight to Last Man and Last Bullet.

Chinese reports say General Honjo, commanding the Japanese in Manchuria has delivered a new ultimatum to Mah Chan-Shan, the Chinese general, demanding that he evacuate Tsitsihar by November 25 or Japan will take "effective steps."

New fighting in which more than forty were reported killed has taken place near Kalyuan in the Nonni sector, the Chinese flanking movement is continuing and there were prospects of heavier fighting. A fresh brigade left Tokyo to the cheers of the citizens, and reports circulated that Henry Pu-yi, one-time boy emperor of China is on the way to Harbin to be enthroned under the Japanese protection, instead of to Murkden as was previously reported. A Moscow newspaper charged that "white" Russians in Siberia were plotting with Japan to provoke Soviet Russia into taking a hand in the Manchurian dispute.

CONFERENCE CLOSES HERE

Northeastern District Educators Return to Homes After 2-Day Session.

Teachers of the North Eastern District Association completed their two-day session at the East Carolina Teachers college shortly after the noon hour today and immediately began their pilgrimages home. About one thousand educators from different sections of the district were in attendance, including several men and women high in the ranks of educational life of other states. Numbered among the visitors were Dr. A. T. Allen, director of Public Instruction of North Carolina, Jule B. Warren, secretary of the North Carolina Education Association, Dr. Lois Coffey, M. S. Stanwood, president of Progressive Education, and Dr. Elbert Fretwell, Columbia University. Miss Maude Leigh, of Elizabeth City, presided.

The principal address of the closing session this morning after a concert by Elizabeth City High School orchestra, was delivered by Stanford Martin, editor of the Winston-Salem Journal. Dr. Stanwood Cobb also spoke on the subject of "Creative Education."

Mr. Martin discussed the educational progress of the state and called attention to the fact that the value of the public school property had increased in the last twenty-five years from three million to one hundred ten million dollars, and following the prophecy of Aycock, our wealth had not only doubled as Aycock predicted, but that it had increased by seven (Continued on Page Three)

SMITH HEADS KIWANIS CLUB

Tobacco Warehouseman Elected President Last Night; R. C. Deal Speaks.

G. V. Smith, prominent Greenville tobacco warehouseman, was elected president of the Greenville Kiwanis Club at the regular meeting at the Woman's Club last night. He succeeds W. A. Darden, who was elected several months ago to fill the unexpired term of J. J. Sumner, who moved to Raleigh. Rev. E. L. Hillman, pastor of Jarvis Memorial Methodist Church, was elected vice-president, a position he had held since the resignation of Mr. Sumner. Dr. W. I. Wooten, H. L. Rivers and Dr. R. S. McGrady were elected members of the board of directors.

The new president is probably one of the best known men in this part of the state. He is president of the Eastern Carolina Chamber of Commerce, an organization embracing over forty counties in this part of the state. For years he has been engaged in the tobacco industry of the community, being one of the owners and operators of the Star Warehouse. The other officers are also prominent in community life. Ralph Deal, former district governor, told of the nation-wide observance of American Education Week from Nov. 9 to 15, and of what the schools of the nation are doing in behalf of improvement of rural and urban life. He said the purpose of education was to enable people to render a higher type of service in the various fields of endeavor. He asserted that education was responsible for the development of the rural communities. It created a spirit of dissatisfaction among the children and caused them to impress upon the parents the necessity for a higher standard of living. Although admitting that the subject was a bone of contention among leading schools of thought of the day, Mr. Deal asserted that people were better than they used to be. Mah Chan-Shan told Chinese newspapermen at Tsitsihar today after he returned from an inspection trip at the front. "Our defense plans are made in accordance with instructions from Chang Hsueh-Liang. Judging from movements of the Japanese it seems certain they plan to launch an attack upon our lines before November 16. "We have made full preparations and are determined to defend the territory to the last ditch. The morale of our troops leaves nothing to be desired and we will fight as long as a single soldier remains." Chinese telegrams from Tsitsihar reported that Japanese cavalry made several attacks on the left flank of the Chinese front line yesterday but were thrown back each time. Four Japanese airplanes recently sent to the Nonni river area have been damaged, these advisors said, and returned to Changchun for repairs. Chinese police conducted a search of No Man's Land between the city and the Japanese concessions here today. It was understood the consuls of both nations expressed the strongest desire to clear up the situation which has completely disrupted normal life here.

(Continued from page one) fold. The people of the state, he said, will not now stand by and see this school system torn down by a bunch of political tinkers.

The way out of this depression, he pointed out, is not to retreat in educational activity, but to go forward. "I believe in wise economy," he said, "but there are a thousand sacrifices we should make before placing the child upon the altar of this depression."

There are two reasons, Mr. Martin said, why industrial leaders are in favor of education; one is that it increases the buying power of the public, the other is that if there should ever come a showdown between public education and industry, the leaders already know who would win.

"The last legislature," he said, "gave the communities of the state an opportunity to destroy their schools by popular election, but it stands to the credit of the state that, in every community in which school elections have been called since the legislature adjourned, the schools have won overwhelmingly."

The principal address of the opening session yesterday afternoon was delivered by Lois Coffey Mccsman, Teachers College, Columbia University. She spoke on the subject, "Processes and Products in Children's Learning," presenting many interesting facts for consideration of the profession. Departmental meetings were held during the afternoon and early today.

Last night following presentation of a one-act play, "Fame of the Poet," by the English club of East Carolina Teachers College, Dr. Elbert Pretwell addressed the teachers on the subject of "Secondary Education."

Although the address was strictly of a professional nature, it contained many timely hints to the hundreds of teachers charged with the moulding of the lives of thousands of children of the district.

He declared that dissatisfaction with conditions of each generation had resulted in the development and experienced by the world today. He discouraged the "yes, yes" habit in evidence among certain types of the people, asserting that they were too ready to agree without going to the bottom of a question. The world needs more disagreement so that every question may be completely threshed out and some definite conclusion reached.

He impressed his hearers with the necessity of intelligent development of subject matter so that the interest of the student might be held until the field had been fully covered.

He saw the need of more atten-

tion to extra curricula activity, especially the dramatic element. The power to create our own moving pictures in our minds is an invaluable asset. The ability to visualize human achievement must come through the schools.

He expressed opinion that citizenship should be taught now and not some other time so that living might be conducted upon a higher plane and that progress might continue uninterrupted.

(Continued from Page One) duced for next week. Then, early in December, he will meet with a White House conference on home building and home ownership, planned as the first of its kind and expected to delve into every ramification of the problem.

Mr. Hoover's disclosure of his \$500,000,000 national credit corporation plan of seven weeks ago contained no forecast of the present discount bank proposal. The proposed institution, he said, will not displace the former, but is intended to "occupy an entirely different field of action."

The credit corporation was formed to rediscount gilt-edge securities held by banks but not eligible for rediscount by the federal reserve system.

"There is no element of inflation in the plan," he asserted, "but simply a better organization of credit for these (home building) purposes."

Since more than 200,000 homes are erected annually in normal times, contributing, with furnishings, to expenditures of over \$2,000,000,000 a year, the President hopes for a sharp revival of employment from the operation of his proposal.

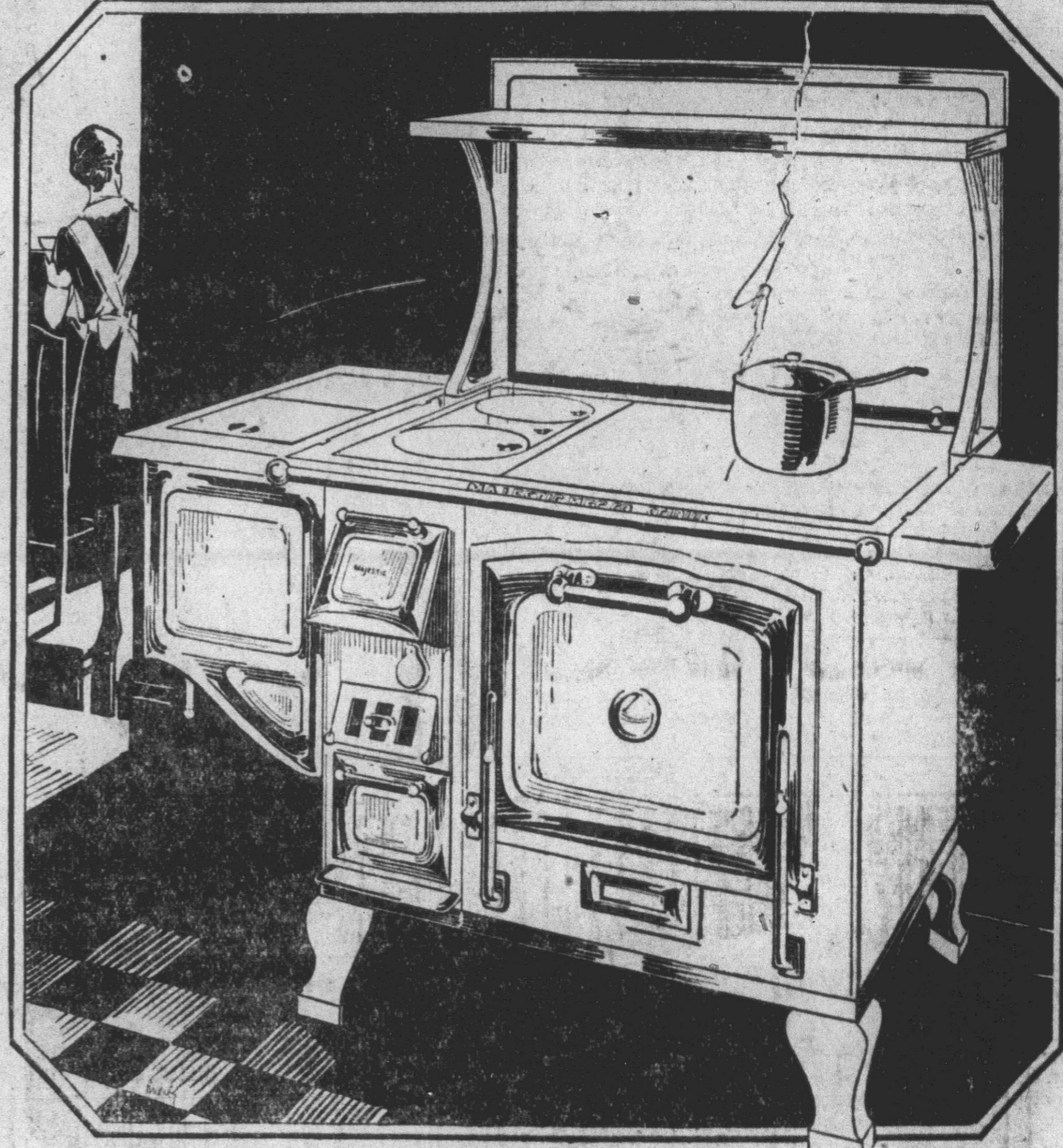
