JAPAN AND CHINA HAVE AGREED TO ARMISTICE

Both Nations Ready To Lay Down Arms In Manchurian Area

Methodists Will Meet Next at Rocky Mount

COMMISSION TO PROBE AFFAIR

Reports occupied the attention of the several hundred delegates at the North Carolina Conference of the M. E. Church, South, here today.

Representatives of Two Nations and all Other Members of the League Council Adopt the Proposal, Which is Largely a Japanese Suggestion, and After Its Adoption Council is Informed Chinese are Ready to Accept.

Paris, Nov. 20.—(AP)—Both Japan and China agreed in principle tonight to a proposal for an armistice in the Manchurian military activities.

Tokyo, Nov. 20.—(AP)—The government announced today that a group made up of the American, French, British and Polish military attaches would start today for Manchuria, as official guests, to investigate actual conditions there.

It was emphasized, however, that Japan considers this as a considerable concession on her part and it was intimated that the original intention was to compromise on a two-fold suggestion—that the League should send a commission but insist, at the same time, on China's opening direct negotiations with Japan.

Announcement that the military attaches of the four nations in Tokyo would go today followed Japan's instruction to its delegation at Paris that it approved the League proposal for a commission.

A dispatch from Mukden to the Rengo News Agency said Japanese airplanes bombed a detachment of Chinese troops at Hailun, about 100 miles north of Harbin yesterday, "annihilating the enemy forces."

It was understood that the government was urged that Japan be given a place on the League investigating commission if one is approved that it is prepared to agree that China also be represented.

Japan will not oppose any proposal that General Dawes, American ambassador, sit in the League council sessions, the foreign office announced in a statement today.

The war minister, reporting this afternoon to the cabinet, said Gen. Mah Chan-Shan appeared to have retreated to a point 40 kilometers northeast of Tshitshar.

WILL REFUTE ASSAULTS ON FARM BOARD

Chairman Stone Now Ready to Show Public What Has Been Done with Money.

Washington, Nov. 20.—(AP)—Chairman Stone is ready to show the American public exactly what the Federal Farm Board has done with the \$500,000,000 entrusted to it to help the farmer.

If the senate agriculture committee demands it, he will spare no details of the board's ventures into wheat and cotton markets to refute charges it has failed in its purpose.

The committee's hearings begin Tuesday—marking a reopening of the aged farm relief controversy which undoubtedly will echo far into the 1932 presidential election.

If requested, complete information on the board's wheat and cotton holdings and its financial position will be furnished by Stone. Otherwise, it will be reserved for the annual report due early in December.

"We have nothing to conceal," he said today. "We are not ashamed of what we have done. We do believe, however, that these last two years of falling prices have not been a fair period in which to test the agricultural marketing act."

When Stone appears before the committee he will bring an armful of data to support his contention that the board's purchase of more than 200,000,000 bushels of wheat averted a general break-down of small banks last fall, and placed \$100,000,000 in increased prices in farmers' pockets.

These benefits, he will contend, far outweigh any losses the board suffers to its \$500,000,000 bankroll and should be placed on the credit side of the ledger.

Further, the chairman will assert the board's assistance to cooperative marketing associations has been proven valuable by the growth of these organizations in the last two years, the larger volume of commodities handled by them and their generally sound financial condition.

Both had been indicted for second degree murder, but their guilty pleas were accepted on the lesser charge.

LIVING COST SHOWS DROP

Atlanta, Nov. 20.—(AP)—The high cost of living is one the run in the south and the trail of the fight leads downward.

Living quarters, food and wearing apparel can be had at prices that in many instances are barely shadows of their corpulent predecessors of 1929.

Statistics gathered from real estate boards, retail merchants' associations in Dixie's representative cities show decreases in the prices of essential living commodities range from 50 to seven per cent as compared with prevailing costs two years ago.

Perhaps the most outstanding decline involves milady's wardrobe. In New Orleans a woman can dress in good style at a total cost of \$12 for the outfit, one store manager pointed out. The general average would run the total up to \$18 or a fraction thereof, including \$10 for a dress, \$2 for a hat, and shoes at \$6 a pair.

Memphis, Tenn., reported a 50 per cent decrease in the price of women's clothing for the two-year period. The decline in Richmond, Va., ranges from 30 to 35 per cent. A wider range is noted in Nashville, Tenn., where prices for ladies' finery are 30 to 50 per cent cheaper.

Since 1929 rental on houses and apartments has declined approximately 25 per cent in Louisville. A four room house, described as "first class," can be had for \$35 to \$40, a three to four-room furnished apartment rents for \$30 a month.

The decrease for the same period in Birmingham is 35 to 38 per cent. An average apartment can be secured for \$40 to \$50 a month and "the best" rents for \$55 upward.

As regards groceries in general, they are 28 to 33 per cent cheaper in Louisville; 17 to 20 per cent lower in Birmingham; 27 per cent less (Continued on Page Four)

Probe Shooting of Prison Guard

Two trustees at the camp said they saw Latham's gun fall from its holster and discharge but they were placed in confinement pending completion of the investigation.

They were Herman Wheeler, of Durham, and Clifton Ely, of Buffalo, N. Y.

The bullet struck Latham in the back and pierced his lungs.

Morganton, W. Va., Nov. 20.—(AP)—The jury in the trial of John T. West, Morganton high school principal, accused of misconduct with Esther Williams, a teacher, disagreed today and was discharged by Judge Charles G. Baker.

The case was replaced on the court calendar but Albert Shuman, county prosecutor, said it would be re-tried at this term of court.

FOREST FIRES STILL RAGING

Shifts of Men Keep up Constant Battle Against Flames At Bonnerston.

Washington, N. C., Nov. 20.—(AP)—Shifts of men kept up a constant fight today on a forest fire in the Bonnerston section which threatened several homes and the Episcopal church there.

The fire fighters were handicapped by lack of water. In many sections suffering from forest fires there is only enough water for human consumption.

Predicted rains which it was hoped would check the fires failed to materialize yesterday and the sky was clear today.

The damage already done by fires in the county is estimated at \$400,000 by county officials.

Mrs. S. F. Spencer, of Fairfield has defeated forest fires on her Hyde county farm while armies of men over the state have found themselves helpless in combatting the flames.

Mrs. Spencer is keeping her peak soil safe by flooding it with water pumped by tractor from man irrigation which near the canal in the lake district. She has saved her three farms.

FORMER KING IS OUTLAWED

Don Alfonso De Bourbon, Formerly King of Spain, Banished By Assembly

Madrid, Nov. 20.—(AP)—Don Alfonso de Bourbon, former King Alfonso XIII of Spain, was declared outlawed and banished by the Constituent assembly today.

Alfonso is in voluntary exile in France.

The assembly voted by acclamation after a long dramatic protest by the aged and aristocratic Count de Romanones, one of Spain's wealthiest men, 40 years ago dangled the baby Alfonso on his knee at Escorial palace.

The vote came after a five hour debate in the assembly chamber, packed with radiantly dressed women, and faultlessly attired men, many of them friends of the former royal family. The scene, inside the chamber and in the streets outside, was more like the opening of the opera in the days of the monarchy (Continued on Page Eight)

SEEK VOTE ON PROHIBITION

Sen. Bingham Says Congress Will Be Asked Provide National Referendum.

Washington, Nov. 20.—(AP)—Congress will be asked by Senator Bingham, Republican, Connecticut, to provide a national referendum on prohibition.

Bingham has completed a resolution calling for repeal of the 18th amendment.

He would have Congress submit the question to state conventions in a new amendment to the constitution. By state conventions, Bingham said the issue would be voted upon by the people in selecting delegates.

"I believe there will be more support in Congress for a measure of this kind than for any other move, including modification," he said. "I know of some drys who will be willing to support this because they believe in a referendum. The drys ought not to block an attempt to give people a vote on prohibition."

Bingham's amendment would state:

"Article 18 of the amendments to this constitution is hereby repealed. The power to regulate or to prohibit the manufacture, sale or transportation of intoxicating liquors is reserved to the several states. The Congress shall have the power to regulate the sale or transportation of intoxicating liquors in interstate commerce in a manner not to abridge or deny the powers herein reserved to the several states."

Lindbergh Flies Amphibian Plane

Miami, Fla., Nov. 20.—(AP)—Colonel Charles A. Lindbergh completed his test flights this morning in the giant Pan American amphibian, the American Clipper and was ready to pilot the craft on its maiden voyage into Latin America.

Arriving at the seaplane base at Dinner Key at 7 A. M. Colonel Lindbergh, made four trial flights before the big ship was docked for final preparations for departure over the new Caribbean route to Cristobal.

He was to have made ten trials but the Pan-American Airways, for which Lindbergh is technical advisor, waved the other six flights because of lack of time. Two of the four trials were dead stop landings which filled the requirements of the Department of Commerce.

The plane functioned perfectly. Thirty-two passengers were ready for the takeoff southward.

LEAF SALES STILL MOUNT

Greenville Market Has Sold 49,815,880 Pounds During the Present Season

Sales on the Greenville tobacco market today drew near to the fifty million pound mark.

The weekly report of K. W. Cobb, supervisor of sales, made public this morning, showed that the market had sold a total of 49,815,880 pounds at an average of \$9.98 per hundred pounds. The amount paid out was given as \$4,975,334.89.

The report showed that during the present week the market sold 5,160,754 pounds of leaf for \$509,965.76 at an average of \$9.88 per hundred pounds.

The report indicated that there was approximately 1,250,000 pounds of leaf on the floors of the various warehouses today, but sales were scheduled to be completed during the late afternoon.

The supervisor also set forth the fact that numbers of new customers were in evidence on the market this week. They came from as far as 25 miles southwest of Wilmington, from the other side of Burlington in Alamance county, from Virginia on the north, and from as far as the shores of the Pamlico on the east.

The visitors, it was said, expressed themselves as highly pleased with conditions prevailing here, and expressed amazement at the enormous facilities afforded by the Greenville market.

Hurls New Charge Against Lawyers

Asheville, Nov. 20.—(AP)—Wickes Wamboldt, blind city councilman and newspaper columnist, today had hurled a new gauntlet into the face of the Buncombe County Bar Association—a claim that he had former jurors who would swear, if promised immunity, that they were bought by lawyers.

He broadcast his challenge last night at a mass meeting where 1,800 persons could hear and where other hundreds were turned away. It was a recent charge by Wamboldt that there is "rascality in our courts and juries are bought and sold like sacks of corn," which precipitated the investigation which resulted Wednesday in the indictment of members of the State Corporation Commission and John Mitchell, former chief state bank

examiner, on charges of conspiracy to allow insolvent banks to remain in operation. He said last night that before the grand jury investigation he had "witnesses coming in droves" to tell him of irregularities, but that when the hearing began they stopped coming for fear they would be forced to testify. Wamboldt called the mass meeting after the Bar Association, which called his earlier remarks to the attention of Superior Court Judge, had decided the "incident is closed."

At the mass meeting he said his challenge of willingness to produce the jurors was his last word to the Bar Association unless it should take him up.

METHODIST CONFERENCE OCCUPIED WITH REPORTS

(Continued from Page One)

appropriations from the endowment fund of the late J. B. Duke had started in building 46 churches in the conference.

The Duke endowment appropriation totaled \$65,490. A total of \$54,750 was appropriated from the same fund for church maintenance, while the superannuate fund and conference claimants received \$39,650.

Rocky Mount was selected as the meeting place for the next convention of the conference. Invitations had been received from Rocky Mount and Wilmington.

This afternoon the conference heard a sermon on "Christ and Freedom," by Rev. T. G. Vickers, former pastor of the Methodist church at Ayden. He painted a graphic picture of the work of Christ, and declared that freedom could come only through belief and practice of His teachings.

Tonight at 7:30 the annual meeting of the Conference Historical Society will be held, and the program will be dedicated to the late Governor Thomas J. Jarvis, of Greenville.

Hon. Josephus Daniels, editor of the Raleigh News & Observer, will preside, and addresses will be made by Mr. Daniels, Hon. George W. Connor, Dr. R. H. Wright, Hon. R. N. Page, and Dr. M. T. Plyler.

Last night the conference heard a sermon by Dr. Harry M. North, presiding elder of the Raleigh district, and a program by Lenoir Glee club.

Dr. North spoke on the subject, "What Men Have Seen in the Cross of Christ," and brought out many interesting points in this connection.

It was described one of the finest sermons of the session and was heard by a crowd that packed the spacious building to capacity.

Bishop Mouzon referred to the case on the Methodist church at Chapel Hill, for which both the North Carolina and Western North Carolina conferences are standing.

The Bishop said that in this time of necessary economy it would seem that a pastor could be obtained for Chapel Hill at a salary of \$3,000 annually instead of \$4,000, particularly since a parsonage is available.

The report of the trustees of the conference orphanage at Raleigh showed 360 children there, and 180 waiting for admission and recommended an assessment for the orphanage for the coming year equal to ten per cent of the salaries pastors received last year.

The Rev. H. S. Barnes, superintendent of the orphanage, voluntarily requested that his salary be reduced from \$4,000 to \$3,600 per year, the report said. The reappointment of Mr. Barnes was recommended.

In the meantime there is much talk among the delegates of possible transfers of ministers.

The Rev. G. P. Combs, who transferred from the Western North Carolina Conference, is here and is expected to be sent to Durham to succeed the Rev. Dr. Walter A. Lambeth, transferred last week to the Western North Carolina Conference and assigned to Central church at Asheville.

Dr. Combs for three years was pastor of the Myers Park church at Charlotte.

Another transfer from the Western North Carolina Conference, the Rev. Albee Godbold, is reported going to Chapel Hill to succeed the Rev. C. E. Rozelle, who was transferred to Western North Carolina Conference and assigned to the First church at Lenoir.

The Rev. Mr. Godbold comes to the east from the pastorate of the College Place church, Greensboro.

Application for admission on trial in the conference were received from R. W. Bradshaw, A. C. Thompson, and M. W. Warren, all of Durham, and C. J. Andrews, of Fairmont.

The Rev. W. A. Lambeth told the conference of the "Golden Cross Conference Fund" for ministering to preachers and others unable to pay at Duke University Hospital.

E. F. Loftin of Durham, an applicant for admission to the conference in trial, was received.

Just before the morning sessions closed, announcement was made of the transfer of C. E. Rozelle of Chapel Hill and W. A. Lambeth of Durham, to the Western North Carolina Conference and the reception by transfer from that conference to the North Carolina Conference of Albee Godbold of Greensboro and G. P. Combs of Charlotte.

ABOUT TOWN

The people of Eastern North Carolina will not let their mission fields suffer during the period of depression, Bishop Thomas C. Darst declared, speaking before a congregation at St. Paul's Episcopal church here Wednesday night.

Despite the pie of hard times going the rounds, Bishop Darst was of the opinion that the people of the churches of the district would rally to their missionaries and help them carry on their great work. He also expressed the same opinion speaking before the Methodist conference yesterday morning.

Bishop Darst is one of the most consecrated leaders of the church in this part of the state and his plea that the work of the mission fields be carried on uninterrupted no doubt will receive the attention of the men and women who have contributed so liberally to the cause in past years.

The rain we have been looking forward to for so long has come at last and tobacco farmers who have experienced some difficulty preparing their crop for market no doubt will speed up and attempt to get the bulk of their products to market before the holiday season begins.

Eastern Carolina has suffered more from the lengthy dry spell than any other of a similar nature in years. Thousands of dollars' worth of timberlands has been laid waste by fires covering a wide area, and numbers of lives have been sacrificed because of the pall of smoke and fog which hung over the highways.

It is impossible to estimate the value of the precipitation to this territory, but it is probable it is worth just as much to the mountain sections which also have suffered severely from forest fires.

Opening the Methodist conference here Wednesday morning Bishop Mouzon said he did not know where Eastern Carolina hospitality could be surpassed.

The expression was a tribute to the hundreds of people of the city who have thrown their homes open to the visiting clergymen and lay delegates in an effort to make every minute of their stay here as pleasurable and profitable as possible.

Greenville has received considerable recognition as a convention city in past years, and will have the pleasure of also entertaining the Presbyterian Synod at the next annual session.

Like the Methodist conference, the Synod will bring to the city some of the most important members of that denomination in the state who will be given an opportunity to take advantage of the city's slogan, "Our Greenville, Yours If You Come."

The Methodist conference will come to a close Sunday night and the delegates will immediately begin their pilgrimage home, taking with them, it is hoped, pleasant recollections of their associations while in the capital of Pitt.

Greenville will always be delighted to have the opportunity to entertain the conference and the sooner it comes again the better everybody will like it.

STATE SPECIALIST GIVES RESULTS DEMONSTRATION

Results of a tobacco demonstration held in this county during the Spring were made public this week by E. Y. Floyd, state tobacco specialist.

The demonstration, conducted by Mr. Floyd and E. F. Arnold, director of the Pitt County Department of Agriculture, on the farm of J. C. Parker in Fountain community, was reported as very gratifying.

Nine different fertilizers were used in the demonstration, and the results placed the highest return at \$161.86 per acre, above cost of fertilizer, with 8-4-4 fertilizer. The lowest was \$124.85 per acre, above cost of fertilizer, with 8-3-3 fertilizer.

These tests, Mr. Arnold said, are giving the farmers a keen insight into the value of the different brands of fertilizers, and have been conducive to the production of a better type of leaf.

FLYING SERVICE WILL GIVE FREE EXHIBITIONS IN GREENVILLE THIS WEEK

The C. and W. Flying service will give a series of free exhibitions on Brown's farm on the Washington highway, near Greenville, Friday, Saturday and Sunday, it was announced today.

One of the features of the exhibition will be the bursting of balloons by plane while in the air. Two guineas will be turned loose from a plane at 2:30 Sunday afternoon and a free ride will be given for each one caught alive.

The plane will be operated by a transport pilot who has been flying eleven years without an accident.

JAPAN AND CHINA AGREE TO ARMISTICE

(Continued from Page One)
States and Chairman Aristide Briand spent an hour today in a conference which League circles hoped might produce a new plan for a solution of the Manchurian problem.

The conference ended at noon and Ambassador Dawes returned to his hotel immediately. He gave no indication of what had transpired beyond saying that the United States is deeply interested in seeing the "lofty purposes of the Kellogg pact and the nine-power treaty fulfilled."

The Japanese have radio equipment at the village of Tachin, just north of the Nonni river, but this station is now out of touch with Japanese troops, except by courier.

Japanese official reports said that since the Nonni river detachment advanced to Taitshih Chinese troops have been concentrating at various towns west of Chengchiatun. At most a whole brigade of cavalry is there now, the reports said, and a possibility of trouble exists because general of the League, attended the conference and it was thought a plan for a mixed commission to supervise conditions in Manchuria and guarantee of security there may have been considered.

The American representative cannot sit at the League council table in the present crisis, General Dawes said, but he added that this must not be interpreted as "a lack of sympathy" by the American government for the efforts of the League to bring about peace in the conflict.

Mukden, Manchuria, Nov. 20.—(AP)—The bodies of 19 Japanese dead, the first casualties of Wednesday's Nonni river battle, together with 80 wounded soldiers, arrived here by train today. A group of weeping women met the train.

It was a day of mourning in the Japanese community. No previous announcement was made of the arrival of the train, but the news leaked out and the crowd of mourners, with a military guard was at the station when it pulled in.

At the headquarters of General Honjo, Japanese chief of staff, it was said the total casualties of the battle were not known yet, approximately, but it was believed this trainload represented less than half of them.

Owing to the breakdown of the field radio station which is accompanying the advancing Japanese troops there was no news of developments in the region of Taitshih and beyond. Frequent cutting of telegraph wires between Taonan and the Nonni River bridge prevents ordinary communication. West Manchuria is practically clear of Japanese troops.

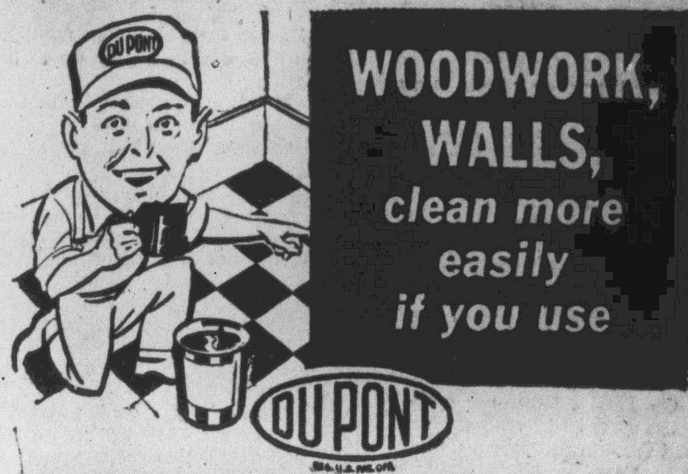
Mrs. Reynolds Files Suit for Divorce at Reno

SOUTH TAKES FRONT RANKS ON GRIDIRON

New York, Nov. 20.—(AP)—The south has come a long way up the gridiron trails since the rainy day that John Heisman's Auburn boys pulled the "Hidden-ball-under-the-jersey" trick on Pop Warner's Georgia team.

Likewise Dixie has leaped in large numbers aboard the all-American bandwagon since Day and Fincher of Georgia Tech, Mc Millin, Roberts and Weaver of Centre caught the expert eye of the late Walter Camp.

The gridiron campaign of 1931 moves down the stretch with Tulane and Tennessee among the nation's few unbeaten and highest ranked aggregations, plus a wealth of southern talent for consideration in the scramble for all-star honors.

The south, has always produced a powerful flock of ends. This year no exception with Catfish Smith of Georgia and the famous Tulane pair, Captain Jerry Dairymple and Vernon Haynes, among the very best to exhibit the gentle art of cracking up opposing interference.

Tulane's decisive victory over Georgia helped to give Dairymple the edge over Smith in some quarters but the nation-wide balloting now under way for the Associated Press selections indicates the closest kind of a race between these two stars.

If either Smith or Dairymple, or both, make the first All-American grade this year, it will be a record for the south, although the section has furnished such excellent wing-men in the past as Roberts of Centre, Bomer and Wakefield of Vanderbilt, Winslett of Alabama, Nash and Shiver of Georgia, and Van Sickle of Florida.

Gene McEver's come-back for Tennessee this year, after a year's layoff, has projected him into the All-American spotlight as one of the best backfield men of the year. The "Bristol Blizard" was not far from scaling the all-star peak in 1929, winding up with a berth on the second team. He has a good chance to reach the top for 1931.

McEver's chief rivals in the South for backfield honors include Tulane's versatile Don Zimmerman, Georgia's Jack Roberts, Kentucky's "Shipwreck" Kelly, and Alabama's "Hurry" Cain.

Since 1918, when Dar of Georgia Tech was the first Southern choice to break into Walter Camp's first team selections, the south's only first-string contributions to the all-American backfield have been McMillin of Centre, Spars of Vanderbilt and Holm of Alabama.

Although the stars have not been conspicuous, the south's candidates for the all-star award, from tackle to tackle, are among the best. They include Leathers and Hamrick of Georgia, Scalfide and Lodriguez of Tulane, Patton of Sewanee, Leander Decker and Gracey of Vanderbilt, Hickman of Tennessee, Torrance of Louisiana State.

Whatever the outcome of the Duke-North Carolina clash it will go down in the record books as producer of the season's record rumors—Wallace Wade developed a batch of rumors by drilling the Blue Devils behind locked gates all week and now comes from Chapel Hill a report that Johnny Branch, quarterback suspended five weeks ago for breaking training, may be in togs for the Blue Devil game.

Chuck Collins wouldn't comment on the rumor, nor would Branch.

Both the Tar Heels and the Blue Devils were down for short workouts this afternoon, but they wound up their heavy training yesterday. A long drill on all the plays they have learned this season marked the Tar Heels' final heavy work.

Duke's preparations continued to be made behind the locked gates of Stadium field.

After a dummy scrimmage and signal drill on Riddick Field, the Wolfpack boarded a train this morning for Columbia. A light workout was planned there this afternoon.

STOCK MARKET

New York, Nov. 20.—(AP)—Most of the financial markets skidded today, although in the case of securities the downward movement was accompanied by little increase in activity.

Stocks had a heavy tone and the bond market again assumed a spongy appearance. The break in wheat was contributed to the speculative gloom of the moment here and many so-called pivotal issues lost at least a couple of points, several touching new lows.

Selling in shares relaxed somewhat after a heavy opening, and partial recoveries of moderate losses were made, but the decline was resumed coincident with the opening of the Chicago grain pit. U. S. Steel met particularly insistent pressure, dropping more than 2 points to a level that closely approximated its bear market low. National Biscuit, Coca-Cola, American Telephone, International Harvester, Air Reduction, Columbian Carbon, McKeesport and Lambert yielded 2 to 3, while in the rails New York Central, Nickel Plate, Delaware & Hudson, Chicago North Western, Pfd., and Illinois Central reached new minimums on losses of 1 to 4 or more.

The favorable banking and credit situation revealed by the weekly federal reserve statements was leavened by a market which obviously felt the decline had gained sufficient momentum to warrant lower prices, especially since the week-end trade reviews made rather negative comment on the state of trade.

Retail trade is running considerably behind a year ago, but weather conditions seem largely reasonable. Call funds eased slightly "outside" but there was little real change in the complexion of the money markets.

As a result of the case, McCorkle has resigned and West and the two teachers were given leaves of absence by the Board of Education.

DINO GRANDI REACHES N. Y. (Continued from Page One) Grandi paid a brief visit to New York today and was accorded a hearty public and official welcome.

Coming from Washington, where for several days he had been considering matters of world welfare with President Hoover, Grandi was brought to the battery from the Jersey shore on the welcoming tug Macon as harbor craft saluted him with screaming sirens.

Dressed in formal morning attire and in high spirits the youthful black-headed diplomat climbed to the Macon's pilot house and personally returned the salutes, grinning broadly as he pulled at the landward of the Macon's sirens.

The Italian visitor reached New York before 9 o'clock and the crowds along Broadway, outside of office workers hurrying to their desks, were small but friendly. Several thousand were gathered at city hall, however, and when Grandi appeared on a balcony to fling high his hand in the Fascist salute, hundreds of hands rose from the throng in answering salutation and prolonged cheers were punctuated with enthusiastic cries of "Viva Dino."

Mayor James J. Walker delivered a welcoming address and pinned the medal of the City of New York on the visitor's breast.

Grandi replied with a speech in which he said that the flags of Italy and the United States were joined in the cause of peace and the solidarity of nations.

Grandi left New York for Philadelphia two hours after arriving.
