## Reynolds Tobacco Co. President Discusses Leaf Situation Here

### TALKS BEFORE ROTARY CLUB

S. Clay Williams Declares Present Condition Confronting Market Due to Lack of Foreign Demand and Increased Production in the New Areas; Quotes Great Array of Figures Dealing with Situation in This, Other Countries.

Decreased foreign demand was given as one of the main reasons for low tobacco prices prevailing at this time by S. Clay Williams, president of R. J. Reynolds Tobacco Company, speaking before the Greenville Rotary club last night.

He paraded before his hearers a great array of facts dealing with the situation, dwelled at length on supply and demand and referred briefly to the luxury tax considered by the last legislature. He denominated the luxury tax "as the most plausible form of legislation that has been developed in our generation for the purpose of transferring tax burden from the shoulders of the stronger to the weaker, and said the passage of such a tax in Ohio and Texas had produced loss of consumption.

Several members of the tobacco industry and business men had been invited to hear the address. The program was in charge of K. W. Cobb, and President Howard M. Ginn presided. Mr. Cobb presented Hon. E. G. Flanagan, who in turn presented Mr. Williams as one of the leaders of the tobacco industry of the nation and world. He paid a glowing tribute to the record of the speaker, declaring he was a native North Carolinian who had brought honor to the state.

Mr. Williams told of influences tending to create antagonism instead of harmony throughout the state. He said sometime they had the West against the East, sometimes agriculture against industry, and again the rural population against the urban population. "Of course," he said, "leaf tobacco prices are out in front as one of the reasons for part of these inter-animosities. Those who are interested in agitating the kind of animosities and in building in North Carolina the kind of atmosphere which such attitudes would create, say that people in North Carolina shouldn't like tobacco companies and particularly R. J. Reynolds Tobacco Company, because leaf tobacco is selling at too cheap a price.

"If R. J. Reynolds Tobacco Co. is responsible for the low average price at which leaf tobacco has been selling, then I agree with the critics and assert myself that lots of folks shouldn't like us. But let me state a few facts:

"Wheat has sold this year at a price of 45-5-3 cents which is about 10 cents lower than the low price of 1895 and about 10 below the price of 1861, the two other years of lowest commodity prices in this country. This new low of 45-5-3 cents made in 1931 stands in contrast to a high of \$3.50 made both 1919 and 1920, and to the competing former high of 45-5-3 made in 1917. I wonder if you realize that these figures show that wheat is selling in this year of 1931 for more than one-eighth of the price at which it sold for in 1917 and 1920. And I wonder how many of you realize that this new low was made with a powerful government pouring hundreds of millions of dollars into the market with a view to stabilizing it, all under the most expert judgment and management that a government could command from the whole country.

"Corn has sold down below 35 cents this year against a high of \$2.36 in 1917 and highs about \$2.10 in both 1919 and 1920. Do we realize that that low is less than one-sixth of the high of 1917?

"You know the similar story in cotton. Potatoes and peanuts and pork and dairy products, and practically everything else that a farmer grows, tell a similar story. And the worst part about it is that the story applies not only to North Carolina, and to the United States, but to the whole world.

"You will remember that Mr. Jas. C. Stone, chairman of the Federal (Continued on Page Three)

### CONGRESS TO MEET MONDAY

Legislation to Ease Economic Burden of Country Most Pressing Issue.

Washington, Dec. 1.—(AP)—The burden of the Congress which meets next Monday will be legislation to ease the economic strains on the country, but the product clearly will be one of compromise between contending interests.

With political factors what they are today, substantially no change appears of either Republicans or Democrats putting through a program of law-making entirely according to their respective ideas.

The party forces in Senate and House are divided by a fair line. The presidential campaign of 1932 is on the horizon, and President Hoover faces the near-certainty of an opposing House, led by Representatives Garner of Texas, as the Democratic speaker. The Republicans expect to continue control of the Senate, but the restless Insurgents hope to force their legislative ideas into the statute books.

The long session will continue until time to adjourn for the national conventions in June. The records to be made by the Democrats in the House may have a vital bearing on their party's chances in the national election to supplant President Hoover in the White House.

The Democrats expect no quarter from the administration nor from the congressional Republicans, except on legislation obviously demanded by the general public. However, their leaders have asserted that as far as their program goes, they plan to put patriotism above partisanship.

Business in the House this session probably will not get under way to any definite degree until after Christmas. It requires about two weeks for new committees to adjust themselves and prepare for hearings.

### Five Persons Face Perjury Charge in N. C.

Elizabeth City, Dec. 1.—(AP)—Judge I. M. Meekings, of Federal District court, has signed an order calling a special term of court for the week of January 4 in Wilson to try five Norfolk and South Mills, N. C., persons for conspiracy to commit perjury in seeking a receivership for the Home Mortgage Co. of Hickory.

The defendants, indicted by the Federal jury at Wilmington are: Mrs. Margaret Ramsey, Shephard Dewrey, A. B. Jordan and J. A. Davis, of Norfolk, and Clarence Dozier, of South Mills.

They were alleged to have planned and accomplished the introduction of false evidence in the Meekings, and the trial had been set for Raleigh originally. The new order complies with a defense petition for removal.

## BRITISH ROUND TABLE CONFAB COMES TO END

### Prime Minister Ramsay McDonald Declares Conference Been Failure.

London, Dec. 1.—(AP)—Prime Minister Ramsay MacDonald closed the second round table conference today with a declaration that it had failed, but that the work of arranging independence for India would go on.

Mahatma Gandhi, in his final word, said that as far as he could determine from listening to the Prime Minister's address, he and the British government had reached an understanding.

### G. O. P. GAINS SENATE LEAD

Appointment of Barbour to Succeed D. W. Morrow Gives Senate Majority.

Washington, Dec. 1.—(AP)—Senate Republican leaders today expressed pleasure at the selection of W. Warren Barbour of Rumson, N. J., to succeed the late Senator Dwight W. Morrow.

Barbour's selection by Governor Larson assures the Republicans of a majority in the Senate. The lineup stands: Republicans, 48; Democrats, 47; Farmer-Labor 1.

Senator Watson, Republican, Indiana, said he was gratified by the choice.

"I know Mr. Barbour well," Watson said, "and am sure he will make a strong character in the Senate."

Senator Walcott, Republican, Connecticut, said he was delighted to learn of the appointment.

Members of the New Jersey delegation in Congress took the new senator well. Those in Washington today commended the governor's choice.

### SKI GIRL NEAR DEATH'S DOOR

### Tragic Threads of Bizarre Love Affair Bind May Gledhill to Hospital Cot.

Mingola, N. Y., Dec. 1.—(AP)—The tragic threads of a bizarre love affair bound pretty May Gledhill, "Canada's Ski Girl," to a hospital cot today, with death standing by menacingly to cut the strands.

After signs of improvement yesterday, the 26-year-old young woman's condition turned for the worst last night and oxygen again was administered. Physicians have not been able to diagnose her illness. They believe it is the result of a sudden nervous breakdown.

In the meantime Mrs. William Connor, middle-aged wife of the man she says is the father of Miss Gledhill's two year old "Sonny," told of the strange triangle.

Her husband, she said, is serving a prison term in Vermont for forgery. Miss Gledhill has been making her home with Mrs. Connor. Both women received letters regularly from Connor, she said, and to each he repeatedly has avowed his affection. The women showed each other the letters, according to Mrs. Connor. She and her husband, then a successful engineer, were in Montreal a few years ago when Miss Gledhill passed by, crying.

Connor asked if he could be of any assistance, his wife said, and they took the young woman home. The affair between Connor and Miss Gledhill started then, the wife said.

"At first I thought she was to blame," she told reporters, "but after I read some of the letters he wrote her, I felt that he was about 75 per cent responsible. At one time I contemplated divorce, but my husband begged me not to, saying that he loved me.

"When he went to prison, it seemed the christian thing to do was to have Miss Gledhill and her baby come live with me. We got along splendidly.

Mrs. Connor does not believe that Miss Gledhill took poison, as was believed at first when she collapsed suddenly Saturday. She attributes her condition to shock over fear she might be deported to Canada and separated from her son.

### Barbour Appointed to Succeed D. W. Morrow

Trenton, N. J., Dec. 1.—(AP)—Governor Larson said Barbour's commission would be issued today and he assumed Barbour would go to Washington in time to be sworn by Governor Morgan F. Larson to succeed the late Dwight W. Morrow as United States Senator from New Jersey.

Barbour, who is 43 years old, is a manufacturer and wealthy thread manufacturer, was appointed today by Governor Morgan F. Larson to succeed the late Dwight W. Morrow when Congress convenes December 7.

### GERMANY TO RAISE TARIFF LEAF SALES FAIRLY HEAVY

Berlin, Dec. 1.—(AP)—In one of the shortest decrees he ever issued President Von Hindenburg today gave the Bruening government almost unlimited power to raise customs duties to a prohibitory point.

During the Reichstag recess, until next February 23, it empowers the government "in the event of stringent economic necessity" to change the present customs schedule and to enter into a system of bilateral treaties with foreign countries.

These things may be done without consulting the Reichstag and in some quarters the decree was regarded as empowering negotiations with England to agree to tariff schedules without submitting the agreement for ratification.

Observers here thought that part of the decree referring to new treaties might bring protests from nations now exchanging most-favored-nation treatment with Germany.

The decree itself contains only about twenty-five words, making it one of the briefest and at the same time one of the most powerful since Chancellor Bruening began governing by edict.

It reads: "The government is given power during recess of the Reichstag in the event of stringent economic necessity, 1—to change existing import duties; 2—to effect a system of temporary bilateral treaties with foreign countries."

### Hindenburg Gives To Governor Unlimited Power to Increase Custom Duties.

The Greenville tobacco market yesterday sold 774,609 pounds of tobacco for \$67,473.34 at a general average of \$8.67 per hundred pounds according to the official report of K. W. Cobb, made public this morning.

Five full sets of buyers were on the job when the market re-opened following observance of the Thanksgiving holidays, and sales moved along with accustomed rapidity.

The report indicated there was approximately 600,000 pounds of leaf on the floors of the various warehouses today and that sales would be completed during the early afternoon.

The price situation was described as similar to that prevailing at the suspension of sales for the Thanksgiving holidays last Wednesday.

### Allot \$137,400 for Work Along Cape Fear River

Washington, Dec. 1.—(AP)—The War Department today allotted \$137,400 for work on the Cape Fear river at and below Wilmington.

The fund was made available by the allotment of \$178,500 of unexpended balances remaining from previous allotments to other rivers and harbors projects in the South Atlantic division.

### Republicans Declare Dry Law Here to Stay

Washington, Dec. 1.—(AP)—A half-finished bill of Congress on a referendum of the Eighteenth Amendment was cited today by a group of prohibition leaders as proof that the dry laws were "here to stay."

The statement came in the form of a letter from the national prohibition board of strategy. It was based on the announcement by Mrs. Charles H. Sabin for the women's organization for prohibition reform that of 47.3 per cent of the members of Congress who replied to the poll, 59.2 favored, 19.5 opposed and 21.2 per cent were non-committal regarding a referendum.

"She reports less than one-third of the members, willing to vote for a referendum," the board said, "and not all of these favor repeal or modification. There must be a two-thirds vote in both Houses of Congress to order a repeal referendum, and then three-fourths of the states must ratify such repeal or modification."

"It is no wonder that the noisiest of the wets, the disgruntled ex-federal enforcement officer, Maurice Campbell, pessimistically admitted yesterday that it would be 1939 and probably 1941 before the wets could hope to see a hostile vote upon prohibition through Congress.

"The dries do not concede wet success then or at any time in the future.

"This sudden zeal of the wets for the people is a typical piece of wet inconsistency. Mrs. Sabin is old enough and experienced enough to remember that the wets fought every suggestion for a referendum on liquor in cities, counties, states and nation, and fought to the last ditch against a referendum in the Eighteenth Amendment.

## FINAL RESOLUTION TO STOP SINO-JAP WAR ADOPTED BY LEAGUE

### Growers Force Closing Kentucky Leaf Houses

Owensboro, Ky., Dec. 1.—(AP)—Threats of farmers to wreck warehouses if tobacco sales were continued caused two warehouses here to close this morning before completing sales of dark leaf tobacco on the opening day of the season. The farmers, more than 3,000 in number, expressed dissatisfaction over low prices for their crops and called a meeting in the courthouse this afternoon to take action.

### DRAFT SENT TO TWO NATIONS

Proposal Does Not Include Japan's Demand for Right to Take Action Against Bandits in Manchuria; Briand Expected to Make Reference to Jap Demand at Plenary Session; The Last Obstacle in the Way of Peace is Expected to be Removed Today.

Paris, Dec. 1.—(AP)—The League of Nations council tonight adopted its resolution offering a solution of the Manchurian dispute, substantially in the form which was approved last week by United States Ambassador Dawes.

Japan's demand for the right to take action against bandits in Manchuria was not included in the final Manchurian resolution completed late this afternoon by the drafting committee of the League of Nations council.

The resolution was submitted immediately to the Japanese and Chinese delegates who transmitted it to their governments for instructions.

It was expected that Aristide Briand would make reference to the Japanese demand when and if the council adopts the resolution in plenary session.

The League of Nations council turned to Japan today in an effort to remove what council circles believe is the last obstacle to Manchurian peace.

Yesterday league leaders hailed with eager optimism China's announcement that she is ready to accept the council plan if Japan's evacuation of the Chinchow area is established as definite.

Wily, China announcing her acceptance of the council's proposal, the council today sought to overcome Japan's insistence on its right to continue to police the area against bandits. On this point Japan's position is at variance with the League plan.

Some compromise in this demand on Japan's part was regarded today as essential to a complete agreement. A number of the members of the council, including the British and Spanish representatives, are known to oppose giving Japan full freedom to pursue anywhere in Manchuria.

The council also awaited word from the neutral observers in the field in Manchuria as an official check on reports from other sources telling of Japanese troop movements there.

Troops were reported in press dispatches to have landed at Tientsin and there were reports that Japanese reinforcements have been sent to Tsisihar.

### SEEK TO OUST BANKHEAD

Recommendation will Ask Senate to Deny Seat to the Alabama Senator-Elect.

Washington, Dec. 1.—(AP)—A report recommending that the Senate deny a seat to Senator-elect John H. Bankhead, Democrat, Alabama, is being prepared by Chairman Hastings of the elections subcommittee considering the contest against the Alabama election.

Hastings is cited several hundred cases of alleged irregularities in the election in which Bankhead defeated former Senator Heflin, as grounds for denying a seat to the senator elect.

No efforts are expected to be made to prevent Bankhead from taking his seat when the Senate convenes, however under Hastings' plan, action will come when the committee report is submitted.

### Rioter Jailed



Orlando Spartaco, 28, was sentenced to two years in the county jail on conviction of "inciting to riot" during Dino Grandi's visit in Philadelphia. Grandi asked executive clemency for the man but his plea went unheeded.

### SEEKS PLAN TO HELP JOBLESS

Bush Says Some Permanent Plan Should be Found to Meet Emergencies.

New York, Dec. 1.—(AP)—The present unemployment problem furnishes a challenge to American industry to find some permanent solution to prepare for future emergencies, Irving T. Bush, president of Bush Terminal Co., said today.

"I am an optimist," Mr. Bush said, "I can see indications of improvement in some lines now, and if we were in the same position as we were a quarter century ago we might go on from here.

"However, we are so closely knitted in a financial and business way with Europe that our progress out of the present slump will depend in large measure on Europe's advance. But we will have other periods of unemployment and the time to prepare for them is now."

"There must be something radically wrong with a system such as ours that permits pandemonium, bread lines and soup kitchens and still obviously does not provide relief for all," he said, "except in countries where begging is a recognized occupation. I do not know of any country that has as much of it as we have here.

Bush made it clear that he favors the present nation-wide emergency unemployment relief, but that he feels some permanent plan should be worked out to care for future emergencies.

He believes the plan of Gerrard Swope, already in effect in the General Electric Co., a good one, but pointed out that it takes care of only one industry.

"Mr. Swope's plan might well be taken as a model," he said, "to provide a plan that would cover every field of industry, skilled and unskilled labor and the white-collar workers."

He said that the government should have no part in this enlarged plan, pointing out that government aid provides one of the weaknesses of the European system. Such belief, he believes, is to paternalistic. He believes most of the present troubles are due to the government mixing in matters entirely outside of proper governmental function.

### SAFE ROBBED OF \$400 CASH

### Robbers Make Big Haul from Cannon's Store About 2 Miles from Ayden.

Robbers went to a lot of trouble to steal the safe from the store of T. J. Cannon at Cannon's Cross Roads, about two miles from Ayden last night, but they were rewarded by finding \$400 snugly packed away in one of the boxes on the inside.

While sheriff's officers today were attempting to gain sufficient information to lead to apprehension of those involved in the robbery, nothing of any definite nature had been obtained up to the noon hour.

After breaking into the store the robbers carried the 300 pound safe to a wagon waiting on the outside, hauled it about two miles down the road and started their work of finding out whether or not the safe contained anything of value.

Gaining entrance to the safe was not difficult. After battering off the hinges the door was easily removed giving the robbers access to everything the safe contained.

In addition to stealing the safe, the robbers were also said to have taken the horse and wagon from a farmer's residence in the same community. The horse and wagon were recovered this morning, and the demolished safe was found lying by the roadside.

The robbery was described as one of the most daring reported in the Ayden community in years and netted the robbers probably the largest sum of money so far recorded.

### Private Funeral Held for Walters

New York, Dec. 1.—(AP)—With the same simplicity and absence of ostentation that marked his career as one of the nation's leading railroad builders private funeral services were held here today for Henry Walters.

Walters, chairman of the board of the Atlantic Coast Line Railroad, patron of art, and sportsman, died yesterday at his New York residence after a brief illness. He was 83 and at one time was described as the richest man in the South.

After the services in the Walters home here, the pioneer railroad executive's body was taken by train to Baltimore here, at Greenmount cemetery another brief service was to be held and the body of the man who ranked with Vanderbilt, Harriman, Hill and Moran as a builder of railroads was to be laid to rest this afternoon.

Walters, one of the original organizers of the Atlantic Coast Line, is survived by his wife, Mrs. Sarah Green Jones Walters, who bore her first marriage was a resident of Wilmington, N. C., and prominent in Southern social circles.

### Three Persons Badly Burned as Torch Explodes

Reidsville, N. C., Dec. 1.—(AP)—Mr. and Mrs. R. W. Duncan and their son, Henry, are recovering in a hospital here from serious burns sustained when an acetylene tank exploded in the hallway of their home at Pelham.

Duncan was inspecting the tank by the light of a lantern and the heat is believed to have caused the explosion.

Washington, N. C., Dec. 1.—The First National Bank of this city gave notice yesterday afternoon that it would not be open for business this morning. A paper posted on the door of the bank late in the afternoon stated: "This bank is closed to conserve the interests of the depositors. By order of the board of directors."

The closing of the bank came as a distinct surprise to local citizens, although it had been known that business for the past year or more had fallen off to a considerable extent. Slow but continued decrease in deposits caused the directors to take the action which was decided upon this afternoon. Frozen loans also had their part in shutting up the bank. It is believed that the institution is fully solvent and that all depositors will be paid in full.

The First National Bank was organized in 1891. J. B. Fowle is president of the institution and A. M. Dumay, who for several years also was president, is cashier.

Fayetteville, Dec. 1.—(AP)—David Gaster and John C. Gilmore, who have confessed to various charges of embezzlement in connection with their handling of Cumberland county funds, are to be sentenced by Judge Garland E. Midyett in Superior court here tomorrow.

## REYNOLDS TOBACCO CO. PRESIDENT DISCUSSES LEAF SITUATION HERE

(Continued from Page One)

Farm Board, in talking to a group of Georgia tobacco growers—some what more than a year ago, told them substantially that it would be wonderful—in fact, nothing short of miraculous—in a period of world depression of commodity price tobacco growers alone of all the producers of various things throughout the world should find that the price of their commodity was not depressed.

"Mr. Stone was speaking to the general conditions that affected tobacco along with everything else. If he had been referring to some of the special situations, which were working against the leaf tobacco markets, he would have said that it would have been almost more than miraculous if tobacco prices had not been off. Those special

creased oversupply of leaf tobacco; and for its counteracting it demands a greatly increased consumption.

"But consumption presents the second special situation which works against our markets. Instead of finding a growth in the demand commensurate with the growth in the supply—a situation which would normally stabilize prices—there has developed simultaneously with this enormous increase in supply a very much restricted demand for these tobaccos which ordinarily go into the export trade and which represents the major portion of your crop. That government statement to the effect that 'a little less than half the crop is consumed in domestic factories; the remainder is exported' represents a fact of enormous—even ominous—importance to people interested in the growing of tobacco in North Carolina. Did you realize that with more than half of our crop dependent upon the export trade for its market, the buyers for the export trade have been becoming less, and less active on flue-cured markets, and while buying a very much reduced percentage of the crop are buying even that, naturally, at prices which in many instances represents but a small fraction of what they formerly paid? The world conditions to which they are subject have hedged them about. Starting with a generally depressed condition such as we have in this country, there are other special conditions that further affect the export market. The trade in India and China is reported as very much reduced. In many counties the export, or the threat of higher tariff barriers against American products has served to destroy the possibility of the volume of business with those countries. The disposition of various countries to produce within their own borders everything that they possibly can, instead of importing it, has further affected the export market. Italy is a case in point. Our nearest neighbor, Canada, too, has gone to growing tobacco in substantial quantities, and from an official Canadian government report which I saw a few days ago, it appears that in 1931 they increased their production of flue-cured tobacco by about 60

situations include the fact that in 1929, 1930, and 1931 the production of tobacco was very substantially above the five-year average crop. They include the fact that of this kind of tobacco we grow in this section of the country only about forty per cent is required for domestic consumption, the balance going for export. Let me quote you from an official pamphlet issued by the United States Department of Commerce a few months ago under the title "United States Tobacco and Its Markets":

"The tobacco crop of the United States, during 1930 (according to the December report of the Department of Agriculture) amounted to 1,510,000,000 pounds, an increase of 11.3 per cent, compared with an average crop of 1,357,130,000 pounds produced during the 5-year period 1925-1930. The production of 1929 was also heavy, amounting to \$1-525,000,000 pounds, even exceeding the reported yield of 1930.

"Flue-cured tobacco, used so extensively in the production of cigarettes throughout the world, is the leading type in the United States. This type, which accounts for over half the United States total tobacco production and five-eighths of the total tobacco export, has been in strong demand both at home and abroad since the cigarette came into prominence and particularly since the World War. A little less than half the crop is consumed in domestic factories; the remainder is exported.

"Leaf consumed in the manufacture of cigarettes in 1930 amounted to 338,701,000 pounds—in tobacco and snuff, 306,990,000 pounds."

"A total consumed in the manufacture of all of these products of something above 645,000,000 pounds out of a total quantity of leaf made available during the year of above 1,277,000,000 pounds."

"There is the showing in positive figure, from the United States Government that approximately two pounds of these tobaccos are being grown in this country for every pound that is consumed here. And for our particular section of the country the percentage that is consumed in this country is ever smaller.

"In the light of these facts and figures, there are two particularly unfortunate special phases of the tobacco-growing situation:

"In the first place, North Carolina is the victim of a big expansion of the areas in which types of tobacco competing with its crop are grown. Mr. Woolfer, of the University of North Carolina, in a very interesting book published some months ago on the subject of 'The Plight of Cigarette Tobacco,' points definitely to overproduction as contributing heavily to the present unsatisfactory conditions in the flue-cured districts and specifically calls attention to the big expansion in tobacco growing in South Carolina and to a similar big expansion of that industry in Georgia. Even Florida has taken up the growing of tobaccos competitive with your North Carolina leaf. The sum total of the result of all of this is that our market here in North Carolina, traveling under the burden of an expansion of its own, has also to meet the further handicap of competition from these recently developed, competitive, growing areas. That means a greatly in-

I agree heartily with the chairman of the Federal Farm Board in his statement that it would have been little short of miraculous if, under the circumstances, prices of tobacco had not come down.

Speaking of a statement he made at the beginning of the season that price adjustment was important to the leaf growers because of the purpose which he had in mind, through it, to put something of buoyancy into the price for leaf tobacco this season, and through advertising to help sustain or increase demand for manufactured product he asked "But did this attempt to buoy actually buoy?" "The figures will answer the question better and more effectively than I can with verbal assurances.

"Let's take the Greenville market first. I speak from the figures of November 20, 1930, and of the same date in 1931. At that date in 1930 your market had sold slightly above fifty-four million pounds while, at the same date in 1931, you had sold slightly above fifty-one million pounds. R. J. Reynolds Tobacco Company's purchase sheets of these dates show that up to November 20th in 1931 the company had purchased substantially more tobacco on your markets than it had up to the same date in 1930. By the reports it appears that on November 20, 1930, R. J. Reynolds Tobacco Company had paid for its grades bought on your markets in both of these years more per pound in 1931 than it had paid for its same grades in 1930.

But let's go to wider territory and take the figures for the whole Eastern Belt of North Carolina. I speak from reports as of November 22, 1930, and November 21, 1931. Up to that date in 1930 the Eastern Belt markets had sold two hundred sixty million pounds of tobacco and to that date in 1931 those markets Company had purchased one-third million pounds. Up to November 21st, 1931, R. J. Reynolds Tobacco Company had purchased one-third more in percentage of the total market than it had in 1930 at the comparative date, the actual percentage of that increase being 33 per cent. Likewise, R. J. Reynolds Tobacco Company had paid for its grades bought on the Eastern markets in both of those years more per pound in 1931 than it had paid for its same grades in 1930.

ABOUT TOWN

The largest offerings of the winter season were disposed of at the opening of the new curb market in the old Model School building last Saturday, according to report of sales issued yesterday.

The report was received with gratification by both producers and consumers alike because development of the market is as of much importance to one as the other.

The market has experienced splendid development since its establishment several years ago in spite of the fact that it has been forced to change its home from time to time.

However, as it is permanently established for the winter, it is believed sales will show a pronounced increase as the housewives of the city go about the business of providing themselves with the bountiful supply of country produce brought in by the growers. It is a splendid outlet for the products of the farms, and should play an important part in increasing the earnings of growers who have been hard hit by declining prices for principal crops.

It is a credit to the people of Pitt county that no serious accidents were reported Sunday night as the entire countryside lay under an impenetrable blanket of fog. With fog taking a heavy toll of life in other sections of the country, this section is to be congratulated that it escaped severe accidents during one of the most severe fogs in years.

Highway officers reported that people drove slowly and carefully throughout the long hours while the roadways were practically obscured by mist, and this, it was stated, was responsible for the splendid record Monday morning. Only through education of the drivers to the importance of careful driving under conditions of this kind may the country hope to escape the awful toll of life exacted by automobiles the last several years. It is a big task but one that must be carried to every corner of the globe until the careless destruction of life and property has been reduced.

Communists of the nation are taking advantage of depression to boost the cause of their dangerous doctrine. The latest indication of this was the march on the capital city reported yesterday. The march, supposedly to have been staged in behalf of hungry men and women, was organized by the "red" element recognizing the seriousness of the situation. Washington officials saw to it that the White House was carefully guarded.

It is true hundreds, nay thousands, of people are suffering from lack of jobs in this country, but it should not cause them to join the ranks of an element seeking to undermine the very foundation upon which this great government was founded. Communism and destruction of high principles of government walk hand in hand, and it must be successfully contested upon every side in this country. The unhappiness which spread of the teaching has brought to foreign countries should be a sufficient lesson to American people and cause them to attempt to avoid a similar condition. They may march and march until they wear out their shoes, but followers of Communism will never be able to raise the red flag in a nation composed of liberty-loving people.

Vice-President Curtis has abandoned all idea of running for the Senate and plans to accept the Republican nomination for his old job if he is offered it. Of course he will. So will President Hoover and all other members of the party holding responsible jobs in this great nation. It was not surprising, this decision of the Nebraskan, and it will not be any thing out of the ordinary to learn that President Hoover will be ready to shoulder the

Presidency for another term if he is nominated. But there is one thing both Mr. Hoover and Mr. Curtis may feel sure of—they will be faced by one of the most closely-contested fights of their careers. The last victory was won by a complete landslide, but unless there is a radical change in sentiment between now and election day the landslide may go the other way.

The inability of the party to live up to its promise of prosperity has done more to impair the strength of its leaders than any other thing imaginable, and it may be said with a degree of assurance that a surprise is in store for the party in the next election.

Larceny has hit the milk business here and unless the consumers begin to clear their porches of the morning's supply of milk more quickly than formerly the situation may become more severe.

# EVEN DOZEN TEAMS PLAY FOR CHARITY

New York, Dec. 1.—(AP)—Football, most weeks of inter-collegiate sports, will share with the unemployed this week to the extent of an even dozen games and one round-robin tournament.

So hearty has been the response of the colleges to the appeal for help that an original slate that called for only seven big games on December 5 now lists twenty. Of the charity contest the east, mid-west, south and far west contribute on about equal terms.

The eastern slate will include the battle in the Yankee Stadium here between the unbeaten volunteers of Tennessee and New York university; the round robin tournament at New Haven involving Yale, Dartmouth, Holy Cross and Brown; and the duel at Pittsburgh between Carnegie and Duquesne.

In the south, Alabama will meet Chattanooga, Southern Inter-collegiate A. A. champions, at Chattanooga and South Carolina will face Centri at Columbia, S. C. A picked eleven from Duke and North Carolina will play a team selected from among North Carolina State, Davidson and Wake Forest at Durham, N. C.

The clash at San Francisco between the undefeated Southern Methodist Mustangs and the Gaels of St. Mary's of Oakland heads a far Western charity program that will include as well games between Utah and Oregon State at Portland and Nebraska, Big Six champion, and the Colorado Aggies at Denver.

In the midwest, four other big six teams have contributed their services. Kansas will play Washburn at Topeka; Kansas State will meet Wichita at Wichita; Missouri tackle St. Louis at St. Louis; and Oklahoma battle Oklahoma City at Norman, Okla.

None of these charity games can affect either sectional or national ratings but there is prospect of close action in many instances.

Of the regularly scheduled contests, perhaps most interest will center on Tulane's clash with Washington State at New Orleans and Southern California's tangle with Washington at Los Angeles. Southern California must win to clinch the Pacific Coast title. Tulane's principal incentive against Washington State is a probable bid to play Southern California in the annual Rose Bowl game at Pasadena.

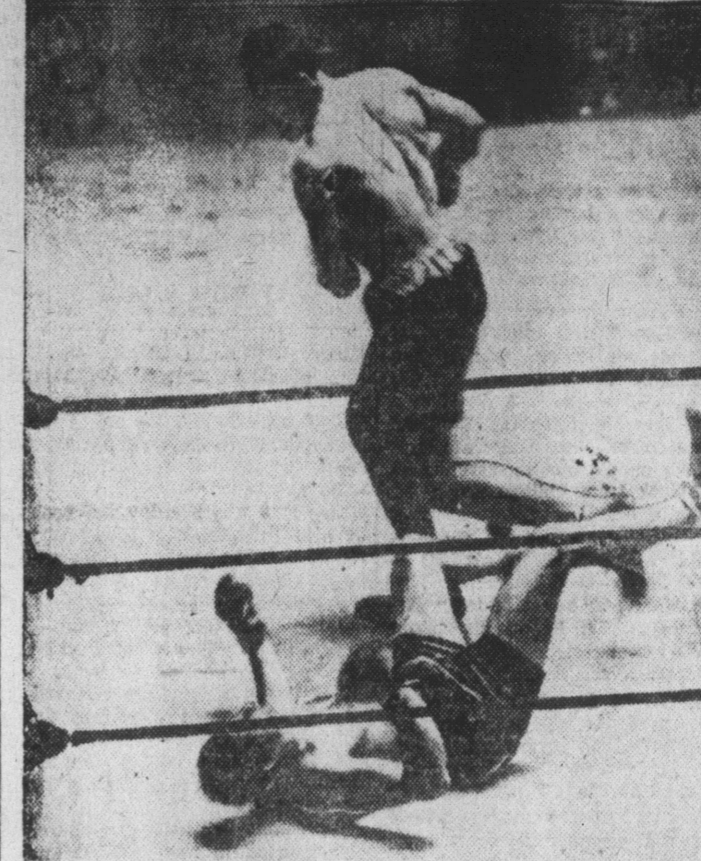

# Market Report

## Cotton--Stocks--Grain

### N. Y. COTTON

New York, Dec. 1.—(AP)—Cotton opened barely steady today at a decline of 1 to 4 points on commission house selling and some selling from Liverpool. January sold off to 6.12.

There was also selling here by brokers with continental and Japanese connections and offerings increased after the call as it stimulated by the weakness of the stock market. January sold off from 6.12 to 6.01, while May declined from 6.45 to 6.35, making the active months about 8 to 12 points net lower by the end of the first half hour. Additional December notices were issued amounting to only 1,500 bales but December eased off to 5.97, making a net decline of 10 points.

Liverpool cables reported local and foreign buying in that market on the weakness in sterling but reported a fair demand for cotton cloth from India and South America.

### GRAIN MARKET

Chicago, Dec. 1.—(AP)—Assertions that Russia was buying wheat for internal needs helped give a sudden hoist today to the wheat market here. The upturn was also stimulated by notably bullish reports concerning the United States winter crop outlook, some experts construing the reports as indicative of a complete change in domestic and world supply conditions next spring. Figures on five leading states suggested a crop only 10,000,000 bushels more than was harvested this year by Kansas alone.

### STOCK MARKET

New York, Dec. 1.—(AP)—After early selling which carried a number of leading stocks down 1 to 3 points or more today, the stock market firmed. Railroad shares led the upturn, more than erasing their early losses. Industrials recovered most of their previous declines.

Railroad stocks came to the forefront of speculative attention because of rumors of an impending wage reduction in Canada. As the market entered the afternoon period net gains of 1 to 3 points on the day were scored by Delaware & Hudson, Missouri, Kansas & Texas, Chesapeake & Ohio, Baltimore & Ohio, Missouri Pacific, New Haven and Union Pacific. The latter leaders like Aitchison, NY Central and Norfolk & Western recovered practically all of their earlier losses.

In the industrial issues, motion picture stocks were subjected to severe early pressure, but when the tone of the general market changed they too shared in partial recovery. Virtually the entire list regained one-half to three-quarters of their earlier losses in later trading, and some issues fully made up their morning declines. Activity centered largely in U S Steel, American Can, International Harvester and Case, among others. Fairly typical of the action of the entire industrial group was National Biscuit which after an early loss of 3 points rebounded 2 points on the rally.

"We must meet again," he said, amid loud applause. "We have put our hands to the task. Let us build well and truly."

The goal, he said, is a federation of autonomous provinces and states but he added that the Indians being unable to agree among themselves his majesty's government has no intention of "forcing responsibility upon those who are not prepared to assume it."

"You must come to an agreement among yourselves," he said, "on problems of the representation of minorities. I beg of you to go ahead."

The prime minister pleaded with Mahatma Gandhi not to depart from the ways of conciliation. "My dear Mahatma," he said, "let us go the way of friendship. It is the best way and you may find it is the only way. It is certainly a way which will enable both of us to take great pride in our work."

Facetiously he referred to the possibility that Mr. Gandhi might be chairman of the next round table conference in India and said, "I might come over to see whether he is an apt pupil of mine."

### Santa Claus Town Grows In Popularity

Santa Claus Ind., Dec. 1.—(AP)—The little five-mile postoffice in this town, five miles from a railroad station, is making plans for the greatest Christmas rush in its history.

Heretofore letters addressed by children to the patron saint of Christmas which found their way here have been the greatest problem of the postoffice staff, but this year outgoing mail will cause unprecedented congestion.

Direct-by-mail advertisers and firms that mail Christmas cards and gifts for clients have notified the post office department at Washington they plan extensive mailing from here this year so the letters and packages will be postmarked "Santa Claus."

As a result, two special mailing machines capable of postmarking 40,000 letters per hour are being shipped here, and special clerks familiar with their operation will swell the postoffice staff.

This development in the growing popularity of Santa Claus Ind., has caused reports that steps will be taken by postoffice officials at Washington to have the name of the office changed.

But this year the officials can only grin and bear it, and arrange for many more than the almost one million pieces of mail sent from here last year by people who first thought of the "Santa Claus" postmark idea.

### November Was Warmest Ever Known in N. C.

Raleigh, Dec. 1.—(AP)—November was the warmest November ever recorded in the United States weather bureau here and was the first Thanksgiving month in which no freezing temperature was listed at Raleigh.

Lee A. Denson, in charge of the United States weather bureau, said that the mean temperature for November was 58.4 degrees, higher than the mean for the same month in any of the previous 44 years for which records are available.

Total precipitation for November was .06 of an inch, which equaled the previous "dry" record for any month, set in November, 1899.

### Fog Disappears as Rain Visits The Southland

Atlanta, Dec. 1.—(AP)—Wind and rain early today began to wash Dixie's skies clear of the fog and haze which has impaired aerial transportation for days.

Shortly after midnight the aerological department of the United States weather bureau here said visibility over most of the south was much improved and planes were resuming their normal schedules.

Low hanging clouds and scattered showers still formed flying hazards in many sections.

Occasional rains were reported yesterday through the center of the south along the whistline from Western Virginia to Southern Alabama, with an eastward movement. Parts of West Virginia, and Tennessee reported precipitation.

The control of forest fires that burned for weeks in sections of the Carolinas and Georgia also has done much to clear the air.

Cloudy and cooler weather was forecast today for portions of Tennessee, North Carolina, South Carolina, Georgia, Florida, Virginia, Kentucky, Louisiana, Mississippi, Alabama and Texas with possible showers over much of the area.

### School Boy Kills Girl Companion

Chicago, Dec. 1.—(AP)—A drama of death was enacted last night by Joseph Wilson, 16, school boy.

He shot to death Constance Thibault, also 16, in an effort to avenge the death of his sister, Ruth, who was killed by a car last week. Wilson, 12, and then himself, shot a 16-year-old school boy by the name of a child's romance which had the parents of the children had tried to break up before it became too serious.

Constance was killed in the Wilson home where she and young Wilson and Constance's sister, Cleo, were discussing the Wicklund-Six trade. She was a student at the same high school attended by Miss Trevaire and Wilson.

"I'm glad I played hooky," remarked Constance in referring to the double shooting of their young friends. "Maybe he would have shot me."

Young Wilson left the room and returned shortly with a pistol to make his demonstration.

"I'm loaded with wooden bullets," he said. "See?" He exclaimed as he pressed the pistol against Cleo, and pulled the trigger. It snapped harmlessly. He then walked over to Constance who was sitting in a chair, put the weapon against her head and pulled. Again it snapped without doing any harm.

There was an explosion, and Constance clumped over in the chair-dead.

The police said that Constance's death was accidental.
