FIRE WRECKS HOSPITAL AND THREE PERISH

Three Hundred Patients at Insane Hospital Driven by Fire Into Biting Cold.

Charlottetown, Prince Edward Island, Dec. 15.—(AP)—The Falconwood Hospital for the Insane burned to the ground early today and three persons perished.

One was trapped by the flames. Two others were killed when they leaped from windows.

Three hundred patients were driven by the fire into the biting cold of the night.

The origin of the fire has not been determined. Flames were first seen pouring from the upper section of the west wing. By the time firemen arrived the entire wing was ablaze.

The water supply was inadequate. Available pressure was not sufficient to send a stream into the burning building. Dynamite was used to sever the west from the east wing, but the supply of the explosive was too small, and the flames leaped the narrow gap and soon were devouring the entire structure.

The property loss was estimated to be between \$250,000 and half a million dollars.

William McGuinn died in the flames.

John MacKenzie, trapped, jumped from a top window. He was killed instantly as his body struck the frozen ground.

William McDonald also jumped. He died of injuries half an hour later.

The hospital staff succeeded in getting the other patients to safety only with great difficulty. They were aided by firemen, policemen, and citizens of Falconwood drawn to the fire by the S. O. S. pointed in the skies by the mounting flames.

The mayor of Falconwood and the city councilors adjourned a session to let the firefighters. Premier Stewart also joined the rescuers, and city physicians and clergymen were their volunteer firemen and first aid workers.

The patients, dazed, wandered uncertainly about in the light of the fire, but there was no disorder. Many patients, after the shock of their narrow escape, assisted in the work of relief to those of their number who had been injured or who faced suffering from the cold.

Bedding, clothing and hospital supplies were provided promptly by requisition from other hospitals, the jail, the armory and stores. The patients were taken to the infirmary and adjoining buildings. Even stables were used, so urgent was the need of getting the patients out of the cold.

Only a few were injured, and the objective of doctors mainly was the forestall illness from exposure.

The west wing of the hospital was built in 1878, the east wing in 1896.

The deceased is the daughter of Mr. and Mrs. Henry Smith and niece of Mr. and Mrs. S. A. Smith of Greenville.

She is survived by her husband and baby daughter; her parents, Mr. and Mrs. H. C. Smith; three sisters, Misses Agnes, Polly and Vivian Smith, and three brothers, Edgar, Alton and H. C. Jr.

Democrats Will Leave Moratorium Open Issue

Washington, Dec. 15.—(AP)—The Democratic joint policy committee today determined that the Hoover moratorium was not subject matter for party consideration and to leave it to the personal views of the Democratic members.

In a brief statement by Speaker Garner and Senator Robinson of Arkansas, Democratic floor leaders, the committee said every possible effort would be made to reduce government expenditures but that no details with respect to the tariff or tax revision were agreed upon.

These matters among others were deferred for future consideration. The committee authorized Garner and Robinson to convene the joint committee at an early date.

The statement came after a seven hours session participated in by ten senators and ten representatives on the legislative policy of the Democratic party in the new Congress.

LARGE STILL IS CAPTURED

Considerable Amount Beer and Liquor Also Taken in Stokestown Raid.

In an effort to curtail the production of liquor being prepared for holiday consumption, Federal officers invaded Pitt county yesterday and captured one of the largest stills probably ever taken in this community. The plant was captured in Stokestown community, but the operators escaped.

Along with the still, the officers captured three thousand gallons of beer, twenty gallons of whiskey and the entire equipment and paraphernalia. The outfit was valued at \$750.

The still was in full operation but the operators, warned by outposts of the approach of the officers, made their escape, leaving hats, coats and dinner buckets behind. The outposts fired one long and two short volleys, which in language of the illicit whiskey trade means, "The officers are upon you—run for your life."

Officers described the plant as one of the finest captured in this part of the state in recent years. The boiler, a tremendous affair, was bricked up, the vats were made out of the heart of juniper, and a tent had been erected over the plant to shelter it from the weather.

The raid was staged by the "wrecking crew" from Kinston.

LIN SIN HEADS NEW NANKING GOVERNMENT

Veteran Member Of Nationalist Party is Chosen to Succeed Chiang Kai-Shek.

Nanking, China, Dec. 15.—(AP)—Chiang Kai-Shek resigned today as president of the Nanking government and was succeeded by Lin Sin, veteran member of the Nationalist party.

He stepped out, he said, in the interest of internal peace in China, and because of the strong criticism to which his foreign policies had been subjected.

Chen Ming-Shu, prominent Nationalist military leader, was made chairman of the executive yuan, Chang, in addition to having vacated his ministerial posts, also resigned as commander-in-chief of the army.

CULBERTSON GAINS AGAIN

Comes Within Fifteen Points of Evening Score With Sidney Lenz.

New York, Dec. 15.—(AP)—Just past the quarter pole in their 150-rubber contract bridge match with Sidney S. Lenz and Oswald Jacoby, Mr. and Mrs. Ely Culbertson were only 15 points behind today.

Victory in six of seven rubbers, played in the sixth session of the match, reduced the Culbertsons' deficit by 4,825 points. They were ahead one time by 845 points.

Of 40 rubbers played in the series Lenz and Jacoby have won 21 and the Culbertsons 19.

After the third hand in the series had been played a week ago, the Culbertsons led by 30 points. Never did they lead again till 217 hands had been dealt. Culbertson regarded the sudden change in the status of the great test of rival methods of bidding as a triumph for his system and felt certain that he and partner would be well in the lead if he had not pulled a few of his usual boners, as he expressed it.

The cards were running with the Culbertsons. They admitted it themselves and they pressed their luck a bit with doubles, and the net result was a loss. They were set twice when doubled. They doubled the enemy four times. On one such double, Lenz, the master, went down five, with a gain of 1,000 points for the Culbertsons. On three doubles Lenz and Jacoby fulfilled their contracts, once being doubled into game on a three-spade bid.

Possibly indicating that the Culbertsons did not get full value out of their cards was the fact that in 13 hands they took more tricks than did Lenz.

They essayed two little slams. Mrs. Culbertson playing each time. Once she was set one undoubled, and the second time she went down two doubled.

Nine Banks Close in Massachusetts

Boston, Dec. 15.—(AP)—Nine Massachusetts banking institutions, with aggregate deposits, according to the latest statements, of \$8,700,000, were closed today. The list included four national banks and five state banks. The central figure in the closings was the Federal National Bank of Boston, which had five city branches and with which all the other institutions were affiliated.

Marion, O., Dec. 15.—(AP)—The Marion National Bank, with resources of \$1,911,422, failed to open today.

The bank, one of the oldest in this section of the country, had capital of \$200,000, surplus of \$100,000 and deposits of \$1,143,094. Frozen assets and a depleted cash reserve was given as the reason for closing.

WBT Looking Up Charlotte.—Plans for expenditure of \$100,000 for new, higher-powered equipment and a new building at its broadcasting plant here have been announced by the management of radio station WBT. The station has been granted an increase in power from 5,000 watts to 25,000 watts.

Stimson Asked To Testify On The Moratorium

Mills First Scheduled to Give Testimony at Inquiry This Afternoon

Washington, Dec. 15.—(AP)—Secretary Stimson has been requested by the House ways and means committee to testify at hearings today on the Hoover moratorium.

Chairman Collier of the committee said: "We have asked Mr. Stimson to appear at a witness and would like very much to have him testify."

He added he had not heard whether the secretary of state would appear.

The Mississippi Democrat said Undersecretary Mills of the treasury was scheduled to testify first at moratorium hearings beginning at 2 p. m. today.

FREE GIVING TO POOR FUND

Campaign to Raise \$5,000 Reported to Be Making Encouraging Progress.

Marked by gratifying response on all sides, the campaign to raise \$5,000 for providing for the poor during the winter months continued here today with as much impetus as that which marked the opening last Saturday.

Workers said the public had responded liberally so far, but that the canvass would be continued until the required amount to carry on the program had been subscribed.

It was stated that approximately \$2,000 had been contributed in cash and food when committees resumed work this morning, but numbers of the workers had not reported and it was impossible to estimate the total contribution.

Prominent business men, it was stated by members of the canvassing committee headed by Ralph Garrett, have contributed liberally not only of cash but of the necessities which are going to play such an important part in driving the wolf away from the homes of the (Continued on Page Four)

JAPS CLASH WITH CHINESE

Fighting Reported at Two Separate Quarters of Manchurian Province.

Mukden, Manchuria, Dec. 15.—(AP)—Japanese troops clashed with Chinese irregulars at two points in Southern Manchuria today, and reports reached headquarters here that a similar local engagement had taken place near Tsitsihar yesterday.

At the same time the Japanese took precautions to prevent attack on two other points in Southern Manchuria where Chinese movements were described as menacing.

The most important skirmish today was a few miles east of Tieling where a company of Japanese met 600 or 700 irregulars. They had been fighting for six hours and the outcome was still uncertain when reports reached headquarters. The Japanese losses were placed at three killed and the Chinese at sixteen killed.

FINAL REPORT ABOUT READY

Young Plan Commission will Present Recommendations Accompanied by Long Summary of Facts Presented So World will be able to Draw Own Conclusions; Committee Already at Work on Document.

Basel, Dec. 15.—(AP)—A recommendation for a further moratorium on Germany's conditional reparations payments will be contained in the final report of the Young plan committee which is studying Germany's capacity to pay, it was learned from the highest authority today.

The recommendations will be accompanied by a long summary of the facts presented so the world will be able to draw its own conclusions.

Sir Walter Layton of Great Britain, Prof. Charles Rist of France, and Dr. Carl Melchior of Germany have been named as a committee to draft the report. They set to work immediately upon the basis for it which was drafted by the "big three" of the committee, Sir Walter Layton, Walter W. Stewart, American representative, and Prof. Rist, in accord with Dr. Melchior.

The outline of the report is to contain these headings:

1. The short term credit situation, enlarging on the Wiggin report of last summer and perhaps opening further suggestions concerning their relations to Germany's public debts;
 2. The extent and influence of Germany's favorable balance of trade since 1930;
 3. The situation of the Reich's budget, including a possible critical paragraph on German expenditures;
 4. The position of the Reichsbank—gold coverage and maintenance of the gold standard;
 5. Possibilities of alternatives in the future German policy.
- This basis leaves ample room for conclusions and recommendations, it was stated.
- A majority of the committee favored cancellation of reparations payments, but in view of the fact that the Young plan denies the right to recommend measures outside the plan itself the committee was said to be practically certain to bow to strict adherence to this provision.
- The experts' conclusions will be extensively discussed in private before the draft is made and it was pointed out that some changes might be made before it is signed.

RAIN, WIND, SNOW IN U.S.

Weather Turns Dizzy Somersaults in Various Parts of the Nation.

(By the Associated Press)

Weather turned dizzy somersaults on the country's meteorological map today.

Streams overflowed their banks in southern Ohio, tornadic winds and heavy rain claimed six lives in southwestern Arkansas and northern Louisiana, snow covered outlying sections of Los Angeles and San Fernando valley, and winds of gale force whistled up and down the Atlantic coast.

Lowlands in southern Ohio bore the brunt of the inundations. Scores of motorists were forced to abandon their automobiles as the swirling waters swept over highways.

One death was indirectly caused by the flood conditions. The Ohio river at Martin's Ferry was rising slowly to the top of its banks.

On the wings of a gale of almost unprecedented force, four inches of snow fell in Los Angeles. A fall of five feet was reported from the higher ridges of the mountainous Big Pine section. Low temperatures prevailed in sections not visited by the snow. Jackson Lake was frozen over with ten inches of ice.

Fuel was being taken to 350 persons snowbound in the Navajo Indian country in Gallup, N. M. A man died from heart disease aggravated by the train of a day's battle against snowdrifts through which he struggled to reach Gallup.

Strong winds and fog hampered shipping on the Atlantic coast. Ferries were not able to operate on schedule yesterday.

Asheville Laid Killed in Florida Starke, Fla., Dec. 13.—Bob Lee, 17, of Asheville, N. C., was killed when he fell beneath the wheels of a freight train on which he was riding.

Missing Woman Found at Tarboro

Tarboro, Dec. 15.—(AP)—Mrs. J. L. Proctor, 86, was found unconscious in a mud hole early today after being missing since early last night when she became lost in the woods.

She left her home to get an axe from a packhouse not far away and became confused in her surroundings. A search was begun and she was found several hours later.

Physicians said her condition was serious but that she would recover if no complications set in.

LaRoque Praises Work Of Building and Loans

Showing the great part which Building and Loan Associations are playing in the rebuilding of the state and nation, O. K. LaRoque, of Raleigh, Deputy Insurance Commissioner in charge of Building and Loan associations of the State, was the principal speaker at the regular meeting of the Rotary club last night.

Speaking of what the associations of the state are doing at the present time, the speaker declared that "during the present month, it is estimated that Building and Loan associations will pay in cash to their shareholders around two million dollars in dividends and earnings."

Because of the absence of speculation there is no fluctuation in stock values even though the investment is of a non-liquid nature it was stated.

He asserted that "when factories and warehouses are closed, your homes deserted, your churches lose their influence, the doors of your schools fail to open to the youth of the land, when government fails, and weeds grow in the streets of our cities, then will the stock in Building and Loan associations lose their value." He said he knew of no material investment based on more solid foundation. (Continued on Page Four)

Two Killed In Train Accident

Shreveport, La., Dec. 15.—(AP)—With the discovery of the body of unidentified white youth half buried under the baggage car today, the list of dead from last night's wrecking of the "Louisiana Limited" Texas & Pacific passenger train, was increased to two.

Another body was believed to be under the wreckage.

L. W. Gorman, 35, engineer of the train, was instantly killed as his locomotive plowed through an open switch.

The train was derailed at a late hour at Hutchison Spur, 18 miles south of Shreveport. Officials expressed the belief the wreck was caused by vandals who had tampered with the switch. The list of injured was placed at 7.

AWARDED NOBEL PEACE PRIZE

ORDER RETURN G. O. P. PAPERS

Judge Hays Says Papers Were Illegally Seized for Probe at Greensboro.

Greensboro, Dec. 15.—(AP)—Judge Johnson J. Hays today ruled in U. S. Court here that E. L. Gavin district attorney, had illegally seized the records of the State Republican Executive Committee and ordered them returned to James S. Duncan, chairman, and W. H. Foster, secretary of the committee. Gavin seized the records last Friday and announced he was investigating reports he had received that Duncan and Foster had solicited contributions for the party's funds from office holders in violation of the corrupt practices act. Duncan petitioned for the return of the records and Judge Hays' ruling was made today on the petition. Judge Hays held that the records were illegally seized and were being held by the district attorney in violation of the constitutional rights of Duncan and Foster.

By his ruling the district attorney was ordered to return all the records together with photostatic copies made of them. Gavin declined to say immediately after Judge Hays' ruling whether he would make a further effort by legal means to secure possession of the records.

Tax Collector Reported Short

Salisbury, Dec. 15.—(AP)—Auditors today announced the discovery of shortage in the special license accounts of Geo. M. Lyster, city tax collector for more than a decade and city treasurer since 1927, who resigned December 12.

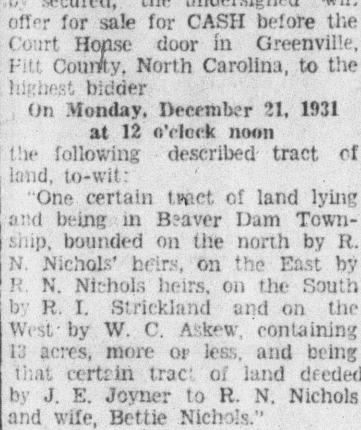

ABOUT TOWN

State automobile license plates went on sale today and thousands of people who did not obtain them direct from Raleigh will cast about in an effort to raise sufficient money to keep the old boats afloat another year.

It will be lawful to use the new plates the first day they are issued and unlawful to use the old ones after December 31.

The plate style has been changed this year to black on yellow instead of yellow on black.

Another important thing in connection with the issuance of licenses this year is the fact that they are based on weight instead of horsepower as in the past. This change was affected by the last legislature.

If the headlights of your car blind the driver coming in the opposite direction, you may be instructed by officers of the State highway patrol to do something about it, according to Captain Chas. D. Farmer of the patrol, who is backed up by a rule adopted by the State Highway commission.

The rule was passed in order to place every motorist on an equal basis as regards the strength of his auto headlights. Prescribing a uniform and proper headlight service, the Highway Department have named several hundred official service stations throughout the State to render assistance to motor owners.

Captain Farmer attributes many highway accidents to drivers becoming blinded by glaring lights. He said, "It would seem that every man now figures on having the biggest and strongest light so as to overcome the glare of the other fellow's lights. A blind man is not permitted to drive a car, yet a man who cannot see through the rays of another's glaring headlights is virtually blind and there is no telling what he will do."

The highway death toll in North Carolina is still going up. It has got to go down. Two of the chief causes of night accidents are blinding headlights and the lack of rear light, and the Highway commission has ruled them from the highway. We have stations set up to eliminate this trouble, and we hope the public will co-operate with us in taking advantage of the service now afforded."

Every organization in this city is contributing its best efforts to mitigate the pain and suffering existing among poor people of the community. In addition to charity football games and such like, civic clubs have gone down into their pockets and contributed liberally, and tonight the Choral club, recently organized to promote interest in the development of music, will give a concert to raise money for charity.

Realizing that every cent possible will be needed to carry relief into the homes of the destitute during the cold winter months, the musical organization hopes to be able to raise sufficient money to give the relief commission fund quite a boost.

Efforts of this kind cannot be commended too highly. The entire citizenship must be brought to a keen realization of the responsibility resting upon them in the monumental task occasioned by unemployment and hard times, and unless they do so suffering will be more widespread than it has ever been before.

The worst part about the situation is the fact that scores of widows and orphans are involved, and their condition, which even at this time is distressing, will become more so as the cold blast descends out of the north, creating an impossible situation unless funds are provided to meet any and every contingency.

Santa Claus, that cheery little fellow with long whiskers, dressed in red and with a pack on his back, is in complete ascendancy in the business district these days and will hold sway until the advent of the holidays when he begins the annual distribution of gifts to carry joy to the hearts of men, women and children alike.

Every store window, every street, and every home bespeaks the spirit

of Old Saint Nick in indisputable terms, and hundreds, nay millions of hearts are filled with joy as they anticipate the countless pleasures which the Yuletide will bring to them.

The weight of everyday life is forgotten as children visualize the magnanimity of Kriss Kringle and men and women go about the serious business of helping the old fellow along with his job of making the world happy and lifting it momentarily, if for no longer, to the exalted heights of unspeakable ecstasy and happiness.

Greenville merchants are aiding the jolly old man too by offering one of the most complete assortments of Christmas goods in years. The public would do well to visit the stores within the next few days and obtain the best of the offerings. That is one of the rewards of early shopping.

"Do your Christmas shopping early," is the plea sent out by postal authorities before the advent of the Yuletide season, and despite the liberal response, the mails are always glutted with belated packages and letters.

The rush has already started in the local postoffice and hundreds of packages, bearing the inscription, "Don't open until Christmas" have passed through the hands of the clerks on their way to the recipients.

Bowling Green, Ky., Dec. 15.—(AP)—Southern Intercollegiate Athletic Association delegates today were en route home following their one-day annual meeting here yesterday during which three major schools withdrew and four others applied for membership.

Yesterday's harmonious meeting was in direct contrast to the fireworks forecast following rumors that many more schools, also members of the Dixie Conference, would resign. Birmingham - Southern, Howard, and Spring Hill withdrew and their resignations were accepted without comment. The other members of the Dixie Conference will retain their membership in the association.

Morehead Teachers College, Union College of Kentucky, Tennessee Polytechnic and Furman University sought admission to the S. I. A. A. The first three were requested to observe the association rules for another year and again apply. Furman, which resigned from the S. I. A. A. two years ago, was given a conditional membership until September 1, 1932, when, if it has observed the rules, the executive committee may accord it full membership.

The association voted to hold next year's meeting at Orlando, Fla., as guest of Rollins College. Dr. J. W. Province, of Mississippi College, who was absent because of automobile accident injuries, was re-elected president.

Presbyterian College, Clinton, S. C., was awarded the track and tennis meets. The basketball tournament will be conducted at Jackson, Miss., the first week in March. Two Florida institutions, Southern College and Miami University, have been asked to report to C. B. Wray, district vice-president, regarding violation of eligibility rules during the football season.

SPORTS SLANTS

Hard though the times may be, or perhaps because of them, we may hear more about Mr. Reggie Meen, of Leicester, Mass.

He is the new heavyweight champion of Great Britain by virtue of scoring a victory on points in twelve rounds over Charlie Smith. The London press reports the affair in much detail and Fred Dartnell, who has peered from the ringside in many countries, including the United States, writes:

"The new champion is a splendidly built fellow and as he carries a really dangerous punch he should be good enough to meet anybody with a fair chance of success. He can box, too, if he likes, but he has beaten and well beaten, too, at this part of the game by Smith."

Tender-Hearted Bioko.

As to some details of the championship match, these may serve: "The fight soon blossomed into fierce exchanges of punches. Meen was not disposed to lead but he found the Londoner's stomach with some short-armed blows and crouched in aggressive style, certainly looked menacing.

"Meen was twice cautioned for lying on his opponent and stung by the reprimand he landed a fine right.

"Meen knocked Smith down with a magnificent punch in the sixth round and had him badly disturbed both physically and mentally. The situation yelled for the workmanlike finish of a beaten man but Meen simply stood off and allowed Smith to recover."

"Some people," adds Dartnell, "say that it is only Meen's tender heart that makes him stand off when he has got his man in bad straits. Well, that may redound to his credit as a man and as a sportsman, but it is sheer folly in a fighter."

"The man who goes into the rings should have the same point of view as that once expressed to me by Jack Dempsey. 'My feeling always is,' said the old champion, 'that if I don't do it to the other fellow he will do it to me,' and while this may seem a complete lack of altruism it is eminently practical. The practical fighter will always beat the sentimentalist of the rings."

The soft sensibilities of Mr. Meen in the ring would, of course, experience a severe shock in the event

he is recruited for the American heavyweight bandwagon.

Somers Calls His Shot.

Before the season is closed for anecdotes about Munn, Manders and Company, of Minnesota, the A.P.'s Mr. Roy Hendrickson of Minneapolis contributes this anecdote of the Gophers:

"Mr. Peter Somers, Minnesota quarterback, was calling signals in the Gopher-Ohio State game and Minnesota which had been driving along pretty well on third down in its own territory, found that it now needed five yards.

"Somers called Clarence Munn, the All-American guard back, which looked like a fake punt. After the huddle and Minnesota lined up, Somers called out: 'Professor Munn will now take the ball through right tackle' for 15 yards."

"Which is exactly what Munn did with Ohio State prepared for a play around the other side. The peculiar part of it is that it was 15 yards to the inch.

"Mr. Somers, notable for his veracity, is prepared to take an oath of this, but further deponent sayeth not."

GEHRIG SETS NEW RECORD WITH HIS BAT

Chicago, Dec. 15.—(AP)—Lou Gehrig, junior member of the celebrated New York Yankee home run twins, was the deadliest of American league species when it came to driving in runs last season.

While the "deader" ball forced a sharp decline in the scoring harvest of the league, the big Yankee first baseman stepped out to drive in 184 of his mates for a new record, official averages revealed today. Gehrig's performance cracked his old American league record, established at 175 in 1927, by nine runs, and made him the most feared batter in the circuit among pitchers.

Babe Ruth, his home run twin-brother, was behind him with 163 runs to his credit, while Earl Averill of the Cleveland Indians ranked third in run production with 143. Only a dozen players drove in 100 or more runs during the campaign as compared with 15 in 1930, the averages disclosed. Gehrig has batted in 100 or more runs six consecutive years, finishing first in '27, '30 and '31.

The other leaders last season in the important business of batting in runs were Simmons, Philadelphia, 128; Cronin, Washington, 126; Chapman, New York, 122; Fox, Philadelphia, 120; Vesperik, Cleveland, 117; Kress, St. Louis, 114; Lary, New York, 107; Goslin, St. Louis, and Webb, Boston, 103.

Principally because of Ruth and Gehrig, the Yankees set a new major league record for receiving free passes to first base. During the season, during which Ruth was walked 128 times and Gehrig 117, the Yankees got 748 bases on balls. Ruth led the league in getting complimentary trips with his 128, and set a new mark for himself by striking out but 51 times.

Jimmy Foxx of the championship Philadelphia Athletics was the easiest man to strike out in the league, missing the third strike 84 times during the season. His closest rival in missing "em was Benny Chapman of the Yankees, a victim 77 times. As a team, the St. Louis Browns fanned 589 times while the Cleveland Indians struck out but 433 times.

There were a lot of bigger targets in the American League last season but "Bing" Miller of the Athletics, was hit the most by the pitchers. He was struck by pitched balls 10 times while Ruth and Gehrig didn't get his once all season.

STOCK MARKET

New York Dec. 15.—(AP)—After several sessions of severe buffeting the securities markets moved into somewhat smoother seas today.

Although further waves of selling were encountered during the earlier hours of trading the stock market was able to make considerable upward progress after midday. Numerous losses of 1 to 2 points were reduced or regained, and some shares registered advances of 1 to more than 3 points.

U. S. Steel dropped 2 points to a new low under 40, then recovered partially. Advances of 1 to 2 points appeared in such issues as American Telephone, DuPont, New York Central, Allied Chemical, Case and Coca Cola. Homestake Mining pushed up to a new high, up 3, and similar advances appeared in Eastman and Auburn.

It was pointed out that tax selling to establish losses in 1931 incomes might continue for the remainder of the month, although some brokers felt that the major portion of this type of selling had been accomplished. Selling of this character, it was pointed out, has been particularly disturbing notably in thinly traded issues, inasmuch as sales are made without any consideration of intrinsic values.

Wall street was inclined to take a more hopeful view of the railroad situation, as eastern executives announced appointment of a committee to "negotiate to a conclusion" the wage controversy, and it became known that bank loans based on the higher revenues to be derived from the increased freight rates may become almost immediately available.

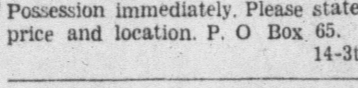
