DAWES TO HEAD DELEGATION TO ARMS PARLEY

President Appoints Ambassador To Go To Geneva in Place Of Fletcher.

Washington, Dec. 22.—(AP)—Ambassador Dawes will head the United States delegation at the Geneva arms conference.

President Hoover announced today that Henry P. Fletcher, had been unable to accept the post.

The president expects to appoint a woman to the delegation. He is negotiating with a lady of qualities and prominence as to whether she could accept a place. It had been expected in some quarters that Secretary Stimson would lead the American representation, but the ambassador to Great Britain was chosen instead. One of the delegates will be Senator Swanson of Virginia.

Asks Reductions of Appropriation Run Government

Washington, Dec. 22.—(AP)—A resolution calling upon the Senate appropriations committee to reduce appropriations for the next fiscal year \$300,000,000 below budget estimates was introduced today by Senator Harrison, Democrat, Miss. The resolution was in line with the program for cutting appropriations agreed upon a week ago by the Democratic policy committee of the House and Senate.

Hoover Welcomes His Grandchildren

Washington, Dec. 22.—(AP)—President Hoover tossed aside the cares of Chief Executivehood for a moment today to welcome just a grandfather, welcoming two blue blond-haired children into their second home—the White House.

Too impatient to await their arrival inside the White House, he stepped onto the open portico as soon as their automobile swung into the grounds. Within a minute he had an arm around young Peggy Ann, with an affectionate kiss for her, and a pat for Peter Hoover, who clung to his leg.

A cold, misty day and heavy falling rain failed to dampen the warmth of that greeting. Nor had it prevented Mrs. Hoover from giving an equally royal and affectionate welcome at Union Station to her son, Herbert, Jr., his wife and the two children when they arrived on an early morning train from the west.

"Hello, granddaddy," cried Peggy Ann, age 7, as she rushed onto the White House portico, and her cry was echoed by Peter.

Postpone McLean Contempt Charge

Washington, Dec. 22.—(AP)—Contempt proceedings against Edward B. McLean, publisher of the Washington Post, were indefinitely postponed in District of Columbia Supreme court today because of failure of any attorney to appear for McLean.

The contempt citation will remain in effect but it was understood no hearing would be held until after the papers have been served upon the publisher, which will be done when he returns to this country from Latvia.

The citation was based on his alleged violation of an injunction forbidding him to prosecute divorce proceedings in Riga, Latvia. A summons calling Mrs. McLean to answer the proceedings was sent her last week disguised as a Christmas present.

Money Survives Wilmington Fire

Wilmington, Dec. 22.—(AP)—L. M. Hobbs, manager of the McLelland Department store here which was one of two destroyed by fire Sunday, today had several hundred dollars in bills that came through the fire with only a soaking.

The currency was in a vault which was not fireproof but the money wet gallons of water kept the money from being destroyed. It was hours before a search for the money could be made.

Today six firemen were recovering from effects of gas, smoke and minor injuries sustained during the fire. All necessitated medical treatment.

Nye Committee Presents Senate With Report On Cannon's Political Fund

Washington, Dec. 22.—(AP)—The Senate was informed by its special campaign funds investigating committee today that Bishop James Cannon, Jr., collected more than \$130,000 in the anti-Smith Democratic campaign of 1928, but reported only \$58,558, in accordance with law.

JAPS ADVANCE ON FAKUMEN

Punitive Expedition is Expected to Occupy Place Today or Tomorrow.

Mukden, Manchuria, Dec. 22.—(AP)—Secrecy surrounded the progress of the Japanese punitive expedition into Southern Manchuria which is advancing along the Yinkow-Kowpanstze railway, while the main Japanese strength would descend the Peiping-Mukden railway.

The belief was expressed that the major action will await the arrival of considerable reinforcements that are now on the way from Japan.

Chinese reports said a Japanese force estimated at 3,000 already is moving northwest from Yingkow but these reports could not be confirmed.

Hoover Assured Quick Action On Relief Plan

Washington, Dec. 22.—(AP)—Assurances by congressional leaders have made President Hoover confident that his current recommendation for a \$500,000,000 reconstruction corporation will be made law after the holidays.

He said as much today in announcing that his efforts for a shortened holiday recess had not been successful. He added he had been told that after the customary recess there would be "amply sufficient cohesion of view" to assure passage of a corporation bill.

Meanwhile, hearing on the proposals continued before a Senate committee with Frederick Ecker, president of the Metropolitan Life Insurance Company, urging that the corporation be set up to give credit aid to both railroads and life insurance companies.

Ecker, a solidly built man with "razing hair, attributed the heavy demand for loans to depressed economic conditions.

He said 32 per cent of the total of \$1,500,000,000 invested by life insurance companies have large holdings of railroad bonds.

He asserted the present "rail emergency is greater than that of 1920" which followed the return of the roads to private operation after the war.

The bill under consideration would permit the government to make loans to railroads and insurance companies as well as banking institutions.

MRS. PINCHOT ENTERS FIGHT FOR CONGRESS

Wife of Pennsylvania Governor Will Oppose Re-Election Of Louis McFadden.

Harrisburg, Pa., Dec. 22.—(AP)—Mrs. Gifford Pinchot, wife of the Pennsylvania governor, will oppose for re-election to congress Representative Louis T. McFadden, who last week charged President Hoover with selling out to Germany when he proposed the debt moratorium.

She announced her candidacy today for the Republican nomination in the fifteenth district in the April primary. In her announcement she did not mention the McFadden incident in congress, but replying to a question said "every one must resent an insubstantiated accusation of treason against the president."

Opposed to Mrs. Pinchot for the nomination, in addition to McFadden, is the incumbent, (Continued on Page Four)

GUARD HOME OF ACTRESS

Police Fear Plot On Life of Marion Davies After Receipt Of Bomb.

Santa Monica, Calif., Dec. 22.—(AP)—Fearing a plot against her life, Marion Davies, film actress, had her house under guard today while authorities investigated the sending to her home of a Christmas package which contained smokeless powder, 20 small lead slugs and matches set against a sandpaper.

At first thought the work of a joker, the package took on a serious aspect late last night when it was fully opened after being immersed several hours in water. Detectives said explosion of the bomb would have caused serious injury.

FIREMEN RUSH TO REPAIR TOY

Public Urged to Give Broken Toys to Laddies to Repair For the Poor.

In a little workshop in the fire station, fire laddies are attempting to go their bit toward carrying happiness to the children of the poor during the coming Yuletide.

They are taking broken toys contributed by the public and converting them into brand new ones—presents that will bring joy to the hearts of youngsters who would know little of the brightness of Christmas without activities of benevolent organizations.

George Gardner, fire chief, stated today that contributions had not been up to expectations since opening of the workshop and renewed the appeal for more gifts for the willing hands of his men to make over as good as new.

After today the firemen had only two more days to work, and they hope to turn over to Old Saint Nick quite a collection of toys to assist him in his campaign of carrying happiness to the homes of the poor.

The gifts will be distributed through the Salvation Army. This organization will have a Christmas tree for the poor at the citadel on Dickinson avenue, and many children's hearts will be gladdened by the things they receive from this source.

Persons who have toys they wish to contribute to the poor through the firemen are urged to send them in at once so the department workshop can be cleared of all gifts in time for Santa's round Christmas Eve night.

Entire Chinese Cabinet Resigns As Party Splits

Nanking, China, Dec. 22.—(AP)—China's fast-shifting political stage underwent an additional shake up late today when the entire national government cabinet, ministers and vice ministers, tendered their resignation as a unit.

While the capital was being astounded by the news of the resignations former President Chang Kai-Shek left suddenly by airplane for his native town of Fenghuang, in northern Chekiang.

The departure of the former president was carried out extremely quietly and even his associates here did not know it. Only this morning he had indicated to party leaders who are convened here to form a new government that he intended to attend the sessions and assist in setting up the new regime.

The reason for his leaving remained a mystery tonight although the belief was expressed in some quarters that a number of the leaders who are slated to come here to assist in forming the new government declined to do so unless General Chiang departed.

Nanking was buzzing tonight with rumors of renewed splits among the party chiefs which, some observers said, might make the likelihood of the formation of a new government remote.

BATTLE OVER MORATORIUM STILL RAGES

Senator Johnson Charges President With Not Giving All Facts on Debt Holiday

Washington, Dec. 22.—(AP)—Charges that then President Hoover not given Congress all the facts about the moratorium were raised today in the Senate.

Senator Johnson of California, an outspoken Republican opponent of the debt suspension measure, said the president failed to tell congress that the original proposal upon which members agreed had been changed at the insistence of France.

The original plan applied to all debt, he said, but France had insisted upon the payment of unconditional reparations. Senate leaders hoped to bring the measure to a vote before adjournment tonight.

RUM CARGO ABANDONED

Thousand Gallons Of Bottled In Bond Liquor Left as Truck Overturns.

Burlington, Dec. 22.—(AP)—A thousand gallons of bottled in bond whiskey was abandoned near Highway No. 10 and overturned.

The overturned truck was discovered at 3 A. M. by a former deputy sheriff who notified county officers.

The truck's tar had been removed when officers reached the scene, but a label on the windshield showed that it was registered in Maryland.

SANTA CLAUS CLUB FORMED

San Francisco Postmaster to provide for Wants of Young Letter Writers.

San Francisco, Dec. 22.—(AP)—Postal regulations and the juvenile belief that Santa Claus lives in Alaska or at the North Pole have combined to shower the San Francisco postoffice with thousands of sticky, scrawly, unstampeted letters disclosing young America's Christmas joys, troubles and desires this year.

So great the flow and so wide the appeal of the letters that Harry L. Todd, San Francisco postmaster, organized a movement which will assure every hopeful youngster of receiving a present or a greeting from Santa Claus. And out of the movement Mr. Todd plans to create an invisible Santa Claus who will respond in future to every such appeal.

The San Francisco postoffice receives a large portion of the Santa Claus mail in the United States because it is the dispatching point for all mail to Alaska and because it is the dead letter office for the western part of the country.

In the rush of Christmas mail distribution, any letter bearing the name "Alaska," "North Pole," or the like quickly finds itself San Francisco bound unless the sorter takes it in his own hands to divert it toward oblivion.

Addressed in everything from almost illegible childish scrawl to typewritten, these letters came from all over the United States, Canada, and Hawaii.

They made an unusual grist of mail this year, even for Santa Claus. Some were regularly stamped, others bore Red Cross Christmas seals for postage. Still others had no stamps at all, but they got here just the same.

Some of them brought tears to Santa's eyes. Others made him chuckle. As a whole they appealed to him so much that Mr. Todd persuaded club women and wealthy men of San Francisco to form the (Continued on Page Four)

HEARS PITT DELEGATION

Promises to "Weigh Carefully" Proposal that Pitt County People be Permitted To Register His Name as a Candidate For Governor; Appeals for Organization To Reveal All Tax Levied on Visible Property for Support of 6-Months' School.

Raleigh, Dec. 22.—(AP)—Josephus Daniels, Raleigh editor, told a delegation from Pitt County today that he would "weigh carefully" its request that he allow citizens of Pitt County to register his name as a candidate for the Democratic nomination as governor next year.

A delegation of 10 Pitt citizens, headed by Judge F. M. Wooten, Sr., presented Mr. Daniels' petitions signed by 300 citizens of the county. The petitions were placed in stores and no effort made to get signatures, the delegation said.

"If I know myself, there is no trace of ambition or desire for public position in my being," Mr. Daniels told the delegation as he read from a prepared statement, "When the suggestion of my name for the governorship, now pressed by your party, was first made to me, my every feeling prompted me to say that my call to duty demanded my complete devotion to the jealous mistress of journalism. Every inclination of my nature, every private interest, and indeed my high sense of the public service I could render told me that I could best serve in the editorial chair. That opinion still remains, and yet I will not still be frank if I did not say that your appeal compels me to weigh carefully the calls, very acutely heeded, so as to wisely determine what is my duty in this serious situation in the life of our beloved commonwealth."

Noting that he had been urged by persons from Morehead to Murphy to run for governor, Mr. Daniels said the calls had come "because it is believed I owe the obligation to lead in the coming campaign in North Carolina to bring about:

"1. Equality in taxation; and economy to the bone during this depression, in public administration; and

"3. The education of the children upon whose training the better North Carolina of tomorrow will rest."

Mr. Daniels praised the last legislature for passing the McLean school law, with its provision for school support from "other sources than an ad valorem tax on property" and appealed to the people to "organize to repeal all tax levied on visible property for the support of the six months' school term."

No man should be nominated, next year, he said, who will not make this pledge:

"I hereby promise, if elected, as the first and supreme duty, to use all my influence to secure the repeal of the tax on land for the six months' school and to obtain the money needed from other sources, and to bring about a modern, scientific and just system of taxation which will make the tax books speak the truth as to every character of property, and to levy sufficient taxes to carry on without a deficit."

He pledged himself with "whole-hearted consecration to the cause" and promised that when he had determined where his duty lies "I will not hesitate to follow where duty leads."

Big Christmas For Prisoners in Alabama Pen

Montgomery, Ala., Dec. 22.—(AP)—This will be a merry Christmas for a large percentage of Alabama's prisoners—outside of prison.

Governor B. M. Miller has given presents ranging from four-day leaves to good behavior paroles to 1,000 convicts. He extended the Christmas leave list yesterday by 142 prisoners, most of whom were serving sentences ranging from ten years to life.

And he now is working at top speed, giving consideration to the most urgent of other matters, in order to pass upon other parole applications in time for convicts to spend Christmas with their families.

Sixty-eight convicts, paroled permanently pending good behavior, got the best Christmas presents. Each was given a suit of clothes, shirt, underwear, cap, shoes, \$10 as a starter from the state, and railroad fare back to their county seats.

The governor has paroled 762 county convicts serving short terms until July 15, 1932, on their agreement to go home, contribute to the winter's work and return to prison in the summer.

Fayetteville, Dec. 22.—(AP)—Content with looting the home of J. R. Luther near here, thieves set fire to it and destroyed it.

Luther and his wife were away at the time but neighbors saw an automobile drive from the home a few minutes prior to the fire.

No trace had been found of the child's slayer. All the city's man hunting power renewed the intensive search for Marian's slayer as such as the body was reported found.

Marian watched him polish the car and then broke out into a hearty little laugh when Servizzi's dog jumped onto the clean fenders with muddy feet.

violations of the Federal corrupt practices act and many unexplained discrepancies between the bank accounts in which the funds were deposited and the reports made to the Clerk of the House.

All the money collected, it said, should have been accounted for under the law. It was this report upon which Bishop Cannon yesterday asked the Senate to withhold judgment until he had had an opportunity to reply.

He: Bishop now is fighting an indictment for violation of the corrupt practices act in the District of Columbia Supreme Court.

The committee said Bishop Cannon himself handled a "large part of the funds" and deposited them in accounts upon which he "alone was able to draw checks."

The committee reported \$18,300 of the political contributions received by Cannon were placed on deposit to the credit of "James Cannon, Jr." or "James Cannon, Jr., Executor," prior to the date of the general election in 1928, and "remained on deposit to the credit of such accounts for considerable periods subsequent to the election."

The committee further stated "it would appear reasonable" from previous testimony of Bishop Cannon that a safe-deposit box in the American National Bank of Richmond, Va., "was used as a depository for some of the large amounts of cash which were received as campaign contributions, a total of \$27,550 in cash having been received from E. C. Jameson alone."

Jameson, New York financier and republican, contributed \$65,300 to Bishop Cannon.

The committee report, submitted to the Senate today by Chairman Nye, recited the refusal of Miss Ada L. Burroughs, treasurer, and the Rev. J. Sidney Peters, secretary, of the anti-Smith committee, to testify. However, it withheld a recommendation of action against them pending a court decision which is to be rendered on a demurrer challenging jurisdiction of the committee.

"Mr. Peters' testimony was particularly desired by the committee," said the report, "in order to establish the facts with reference to the

The cottage was located by detectives who traced a laundry mark on a towel given Mrs. Donnelly by her abductors. She wrapped the towel about her neck, and still wore it when she was released. The mark was traced to Emil G. Buinger, who owns the cottage leased by Scheidt.

Officers said Browning named Marshall De Pew, also of Holliday, as the leader. De Pew, according to a statement released under Browning's signature, suggested two months ago that Browning locate an isolated house in which Paul Donnelly, husband of Mrs. Donnelly, could be held pending the payment of ransom.

After a promise of \$7,500 Browning is alleged to have arranged with Scheidt for the use of the latter's cottage. The building, located near Bonner Springs, is situated in a wooded 20-acre tract, reached by a country lane. Scheidt was declared to have been promised \$1,000 for the use of the house.

CALIFORNIA GETS HIGHEST HONOR OF YEAR

By ALAN GOULD.
(Associated Press Sports Editor)
New York, Dec. 22.—(AP)—By a margin equally as convincing as that gained by Pepper Martin in the individual field, Southern California's sensational football team is credited by the nation's sports experts with the outstanding individual team achievement for 1931 in any branch of sport.

That's how highly they regard the Trojan victory that ended the three-year winning streak of Notre Dame.

"There has been nothing in years to compare with that fourth-quarter comeback and triumph of Southern California against the Irish," wrote one sports editor who voiced widespread feeling. "It was a magnificent team achievement in every respect."

Southern California, in the National poll of sports editors and writers conducted by the Associated Press, received 72 votes out of a possible 131. This was exactly double the total for the St. Louis Cardinals whose feat in overthrowing the world champion Athletics was voted the outstanding accomplishment by 36 experts.

The glamour of college football, still fresh in mind, perhaps swayed the opinions of some observers. On the other hand, many pointed out that the chief factors in the Cardinal baseball victory were three exceptional individual performers—Martin, Grimes and Hallahan—whereas Southern California came through on the strength of its superb team-work in the crisis against Notre Dame moreover, while the vote for the Trojans largely was based on what they did against the Irish, the fact also was pointed out that U. S. C. routed almost every foe after dropping the first game of the season to St. Mary's.

If a clincher is needed to the argument, the majority of St. Louis experts disclosed they had no prejudice or doubt in their minds by voting for Southern California in preference to the hometown Cardinals.

Would Revamp Sally League

Columbia, S. C., Dec. 21.—(AP)—The revamping of the old South Atlantic League, which in years gone by cut a big figure in minor league circles of the south, has been proposed by a Savannah man interested in baseball.

The proposal, which would embrace Columbia, Charleston, Savannah, Jacksonville, Macon and Augusta in the reorganization, was advanced in a letter to the Columbia State.

Its sponsor asked that his name be withheld for the time being, but the State said it would be glad to put anyone interested in the plan in touch with him.

Commenting on the suggestion, the paper said: "That was the South Atlantic lineup in the 'good old days' and no circuit since then has had the compactness, the rivalry and the satisfactory mileage that the circuit had when composed of those six cities."

After a few years of wavering and several changes in members, the old Sally finally went on the rocks just before the opening of the 1931 baseball season.

"We should be much stronger with Burleigh Grimes pitching for us and with some fine recruits coming up," Hornsby said as the Cubs completed the big deal by which they acquired the Cardinal mound ace for Hack Wilson and pitcher Bud Teachout, but championship teams aren't built in a year. The Cubs are building steadily. We may not win the 1932 pennant because of the strong Cardinal opposition but we ultimately will climb to the top and may stay there for six or seven years."

With William Wigley's bankroll attracting a large group of minor league stars, the fortunes of Cub forces for 1932 appear excellent. Grimes should give them one of the finest balanced pitching staffs of the league coupled with Pat Malone, Charlie Root, Guy Bush and Bob Smith.

Hornsby's idea of a great ball club is one of great speed on the bases and afield and he is constructing the club along just those lines.

His most perplexing problems are third and second bases and one position in the outfield. Lester Bell apparently is through defending the third sack because of his sore arm. The Cubs have acquired Stanley Hack, Sacramento star of the Pacific Coast League but Hornsby is worried lest Hack prove too inexperienced.

THINKS A'S BEST OUTFIT IN AMERICA

Philadelphia, Dec. 21.—(AP)—Still boasting the American league's batting champion; a "big three" among pitchers that won 72 games last season, and the best catcher in baseball, the Philadelphia Athletics look forward to the 1932 pennant race with no trepidation.

Connie Mack, who will celebrate his 69th birthday December 23, still regards his A's as the best club in baseball.

The closeness and outcome of next year's competition depends upon how much the New York Yankees and Washington Senators improve.

While Washington seeks more punch and the Yankees better pitching, the three-time American league champions, with one exception, will place the same club in the field that started winning titles in 1929. The only new man introduced to the cast since that time is Shortstop Dibrrell Williams who replaced Joe Boley midway in last season and distinguished himself in the world series.

The Athletics again will be fortified with the presence of the leading hitter of the league—Al Simmons. They will have Mickey Cochrane, who is fully recovered from the ailments that hampered him in the world series.

Lastly they will again present the rotation of pitchers that turned in 72 victories last year. Lefty Grove, George Earnshaw and Rube Walberg, including Roy Mahaffey and his 15 victories, the Athletics had four hurlers in 1931 who produced 87 triumphs. The best of the young pitching prospects is Lew Krause, schoolboy star who made his big league debut last season.

Connie Mack's efforts since the close of last season have been devoted solely to increasing the batting strength of his utility corps. To this end he purchased First Baseman Oscar Roetiger from St.

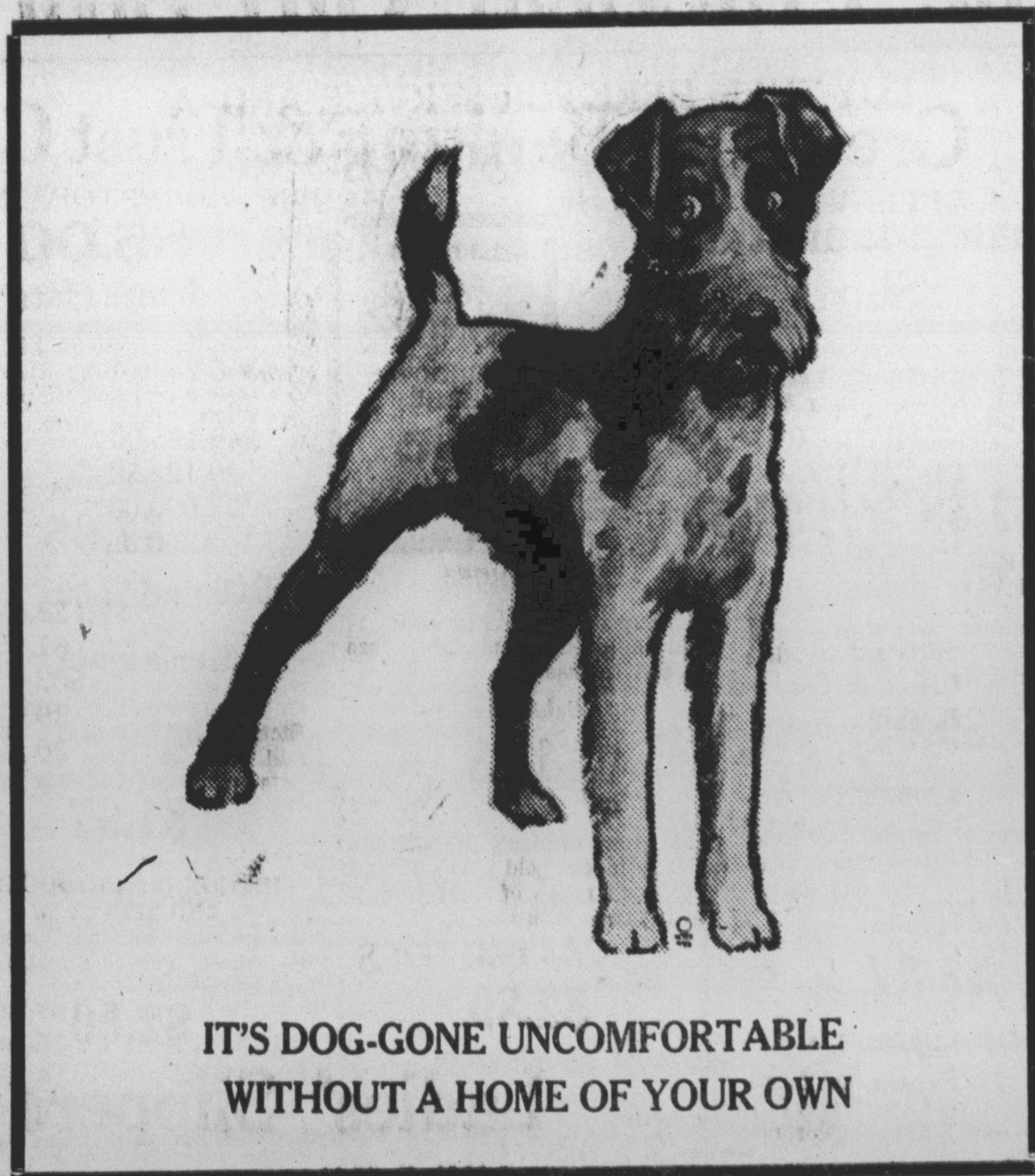

International banking circles were interested in the advance news on the Young plan advisory committee's report, which is expected to recommend a further moratorium on Germany's conditional payments under the deferring of the unconditional payments.

Probe Injury Of Officers By Dynamite Trap

Pearson, Ga., Dec. 22.—(AP)—Circumstances surrounding the springing of a dynamite trap which injured four or five officers raiding a moonshine still in Roundabout swamp near here brought a wide investigation today.

The investigating officers declined to reveal any clues in the case but the incident was described from his bed by Sheriff Louis White who headed the raiding party and received leg and other injuries in the dynamite explosion.

Acting on information supplied by an undisclosed source, the officers, the party went to the swamp yesterday and found the still as described. They had barely gathered about three barrels of mash, ready to be made into liquor, when the explosion occurred.

Probably five sticks of dynamite, he said, went off simultaneously. Three others, which did not explode, were found.

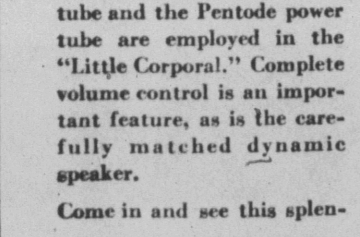
