DILL BOOSTS N.Y. GOVERNOR FOR PRESIDENT

Senator Says Nomination Would Meet Third Party Threat in 1932.

Washington, Dec. 30.—(AP)—Senator Dill asserted today that the "best way for the Democratic party to meet the threat and even the creation of a third party in 1932 will be to nominate Franklin D. Roosevelt for President."

In a statement, the Washington senator said "No other Democrat appeals to the disappointed millions of independent voters in the United States as does Governor Roosevelt."

The Dill statement continued in part: "Recent special news stories in eastern newspapers to the effect that Roosevelt is slipping in his race for the nomination are like the Hoover stories that prosperity will be here in thirty or sixty days."

"The desire is father to the report. The truth is that Mr. Roosevelt's campaign for delegates has not yet started in an organized way. The Roosevelt clubs that have sprung up all over this country might be likened to artesian wells bursting forth from the plains of public sentiment because of the pressure of the dammed up Roosevelt enthusiasm from the common citizens of the country."

"Those Democrats who want their party to seize the opportunity which fate itself seems to have provided should quit speculating on whether or not those who have led them to defeat in past campaigns can stop Roosevelt, and begin boosting for him as the man under whose leadership victory is certain, regardless of whom the Republicans nominate or what may be done about a third party."

Dill said there are "many other big men in the Democratic party, any one of whom would make a great President and restore prosperity to the country," but none with Roosevelt's appeal to the voters.

Predicts Only Single Vote On Amendment 18

Washington, Dec. 30.—(AP)—One vote on prohibition is all that seems likely in the House this session, with wet forces having their choice on a referendum proposal or a light wines and beer ballot. That is the way Representative Rainey of Illinois, the Democratic leader sees it. In his opinion, the House Judiciary committee will not report favorably either on a measure calling for a referendum on the 18 amendment, or one for modification of the Volstead Act. "The wets will have to bring the bill to the floor through the petition of 145 members," he said. "That is the only way in which they can do it. They will have but one vote and that either on a referendum or light wines and beer. They can't have both. The rules of the House will be so interpreted." He said he felt the referendum had the better chance for "getting by" because many dries, himself included, would vote for it.

Luke Lea Trial Is Postponed Until 18th Of April

Nashville, Tenn., Dec. 30.—(AP)—Trial of Colonel Luke Lea, Nashville publisher and financier, and five co-defendants on charges growing out of bank failures was postponed today until April 18. They were docketed for trial January 11, but defense counsel contended the principal defendants are involved in other litigation and that there would be conflicts in dates unless the continuance were granted. The prosecution did not oppose the postponement. Co-defendants with Lea are Luke Lea, Jr., Basil Ramsey, Knoxville banker; W. S. Chappell, former cashier of the closed Liberty Bank and Trust Company of Nashville, and R. B. Moseley and E. P. Charlet, employees of Colonel Lea's newspaper, the Nashville Tennessean. They are charged with defrauding the Liberty Bank and Trust Company of approximately \$150,000. Conviction could carry a maximum penalty of \$500 fine and a county road sentence of 11 months and 29 days.

This Party Talk Gains Sway Among G. O. P. Independents Of West

Washington, Dec. 30.—(AP)—The 1932 political windmill is already whirling briskly with talk of a third party furnishing much of the breeze for its revolutions. This comes from the ranks of the Republican Independents of the northwest who have fought the Hoover tariff and farm relief policies in the Senate. The gusts of report and speculation which have surrounded Democratic Presidential possibilities continue, meanwhile.

Spokesman for Governor Murry of Oklahoma, who makes the front pages regularly, said he would be a candidate for the nomination. Reports that Alfred E. Smith will again be a candidate for the Democratic nomination persist but party (Continued on page three)

FIVE NEGROES BREAK JAIL

Force Way Through Cell at County Jail with Bar Ripped from Ceiling. With the aid of an angle bar ripped from the ceiling of their cell, five colored prisoners succeeded in escaping from Pitt county jail early today.

Although sheriff's officers immediately started a widespread search none of the escaped men had been re-captured at the last reports during the early afternoon. Officers expressed opinion that the majority would be back in custody in the near future and pushed their search to all surrounding communities with this end in view.

All of the prisoners were awaiting hearing at the next term of Superior court on charges ranging from giving bad checks to store breaking and highway robbery. Twelve other prisoners occupying the same cell made no effort to escape and maintained silence concerning the "break" when questioned by officers.

Those escaping were: Fred Pugh, store breaking and robbery; Amos Brooks, bad checks; Leney Woodwood, store breaking; Willie Hardison, highway robbery; Johnnie Phillips, larceny.

The escape was discovered by an attendant who went to the jail shortly after 5 o'clock to begin his day's work. The prisoners had ripped an iron bar from the ceiling and then forced their way through the cell to liberty.

Although prisoners have succeeded in escaping from the jail several times in recent years, officers said that all of them were re-captured with exception of one, and felt confident of the early return of those involved in the latest break.

Finland Begins Second Day Of Dry Law Voting

Helsingfors, Finland, Dec. 30.—(AP)—Finland began the second day of its two-day prohibition referendum today with a heavier vote cast than is usually polled on the first day of regular national elections. Complete figures for the first day's poll in the capital showed that 36.4 per cent of the voters registered their preference yesterday, as compared with 33.7 per cent on the first day of the last presidential election.

ONE KILLED AS BOMB BURSTS

Three Also Injured By Blast in Post-Office at Easton, Pennsylvania. Easton, Pa., Dec. 30.—(AP)—One clerk was killed and three others seriously injured today when a bomb exploded in the parcel post division of the Easton postoffice.

Edward Werkheiser died in a hospital shortly after being admitted. John House is in the Easton hospital with both forearms blown off, one eye blown out and other injuries which may result in his death.

Arlington A. Albert also is in the hospital. His condition is reported as fair. Clarence Keller was taken to his home. His condition is not considered serious.

The entire post office was thrown into confusion. All work was suspended as explosive experts and state, county and city police began an investigation.

The explosive is believed to have been mailed by two young men, described as foreigners. At the same time they mailed five other packages, addressing all of them in the lobby of the post office. The other packages were being examined this morning.

Werkheiser, before he died, told police he and the other clerks were suspicious of the packages and did not believe they contained the merchandise declared, so began to open them.

House had both hands on the package which was resting on a scale when it exploded. The steel scale was twisted like wire and was thrown about ten feet, carrying with it parts of House's hands.

Werkheiser was standing beside House and he apparently had one of his hands on the scale for it, too, was torn off.

Albert was about five feet distant and also got some of the force of the explosion but is not badly hurt. Keller was approximately 20 feet distant and was thrown to the floor against some steel cases. His condition is not reported.

LABOR FEDERATION ASKS FEDERAL AID FOR UNEMPLOYMENT

CANNOT SHIRK THEIR DUTIES

Testifying Before the Senate Committee, Edward McGrady Declares that Many Cities and Isolated Districts Frankly Admit They Can't Meet Demands of Needy.

Washington, Dec. 30.—(AP)—The American Federation of Labor appealed to the federal government today to aid in the relief of unemployment.

Testifying before a Senate committee, Edward P. McGrady, representing the federation—said the government cannot "shirk its responsibility."

Many states, cities and isolated districts "frankly admit they are unable to meet the demands that are being made upon them for relief of the needy," he said. "Is our federal government going (Continued on page four)

HAS FAITH IN STATE BANKS

National Credit Corporation Ready To Back N. C. Institutions To Limit.

Greensboro, Dec. 30.—(AP)—John M. Miller, Jr., of Richmond, director of the National Credit Corporation for the fifth Federal Reserve District, today said here that the corporation had full confidence in the banks of North Carolina and was prepared to go to the full length of its ability to protect them.

Miller's statement was made after conferring with directors of the Fifth District Association. The National Credit Corporation, formed by banks all over the country, has more than a half a billion dollars available.

Miller's statement was issued after he had been advised of the closing of the United Bank and Trust Company here and of other banks in the state.

As an example of the confidence the National Credit Corporation has in North Carolina banks, he said, \$1,000,000 was sent today by wire to the North Carolina Bank and Trust company which has branches in several cities of the state and that an additional \$3,000,000 was being dispatched to it.

FLOOD STILL THREATENING

Recession of Waters, However, is Bringing Hope to Dwellers in Delta District.

Glendora, Miss., Dec. 30.—(AP)—The recession of flood waters brought hope to dwellers of the delta lowlands today but underlined levees remained grave threats. Workers who repaired and strengthened the levee through which the Tallahatchie river burst earlier this week to flood Glendora were transferred to Swan Lake where planters had issued a call for aid as evidences of undermining appeared.

The water was receding rapidly here today and a similar lowering was reported from points in Tallahatchie, Quitman and Panola counties.

Chief fear now is that the receding waters will cut in under the levees and patrols today watched constantly for signs of possible breaks.

The loop levee, constructed around the break here, was in danger of being undermined last night but crews of workers finally stemmed the sand boils, those bubblings of sand and water that indicate a weakening back of the barriers, with sandbags.

Washington, Dec. 30.—(AP)—Another Democratic prohibitionist Senator—Sheppard of Texas—withdraw today from a Senate sub-committee appointed to hold hearings on the dry laws. Senator Sheppard said his reason for withdrawing was lack of time. He added, however, that he agreed fully with the statement made yesterday by Senator Ashurst, Democrat, Arizona, in declining to serve, which was that attempts to modify the prohibition laws are a waste of effort. "They can't get anywhere," said Sheppard, a co-author of the 18th amendment and a Senate leader of the dry cause. The place vacated by Sheppard is on a manufacturers sub-committee designated to hold hearings on a bill by Senator Bingham, Republican, Connecticut, to permit four per cent beer. The vacancy has not yet been filled. Hearings are scheduled to start January 8.

HEARINGS ON DRY LAW SET FOR JAN. 8TH

Friends and Enemies of Prohibition to Be Given Chance to Air Views.

Washington, Dec. 30.—(AP)—The first of the Senate committee hearings on prohibition was set today for Friday, January 8.

The date was decided upon by Chairman Metcalf, Republican, of Rhode Island, of a manufacturers sub-committee to hear testimony on a four percent beer bill by Senator Bingham, Republican, Connecticut. He notified his office by telephone from Providence, where he is spending the holidays.

Both friends and foes of prohibition will be heard. Senator Bingham said Prof. Yandell Henderson, of Yale University, an expert of volatile poisons, had agreed to appear in favor of the bill on the morning of January 8, and Representative William E. Hull, of Peoria, Illinois, on Saturday, also in favor of it.

Care will be taken to allot equal amounts of time to both sides. Committee officials are looking for an extra spacious chamber in which to hold the hearings, expecting a large attendance.

Besides Senator Metcalf, who is regarded as opposed to present prohibition laws, the committee members are Senator Cutting, Republican, New Mexico, and Sheppard, Democrat, Texas. Sheppard is co-author of the 18th amendment. Cutting's position is less clearly defined.

Senator Bingham announced he would introduce on Monday a bill to permit beer of 3.2 per cent by weight alcoholic content, which he said is virtually the same as the 4 per cent by volume provided in the bill before the sub-committee. It differs in that the beer must be manufactured entirely from the products of American farms.

This is intended, Bingham said, to "give the full benefit of the manufacture to the American farmer." It is so framed as to prevent importation of foreign beer ale or porter as well as ingredients. The Connecticut senator added that he is working on a measure to provide for distribution direct from warehouses to homes to meet the possible objection that passage of a beer bill would mean return of the saloon.

Find Body Of Missing Woman in Small Creek

Fayetteville, Dec. 30.—(AP)—The body of Mrs. A. L. McCaskill, 53, widow of the late A. L. McCaskill, who was prominent in North Carolina political circles, was found in a creek near her home here today, several hours after she had been reported missing.

She apparently had drowned and relatives advanced the theory that she fell into the shallow creek as she walked in her sleep.

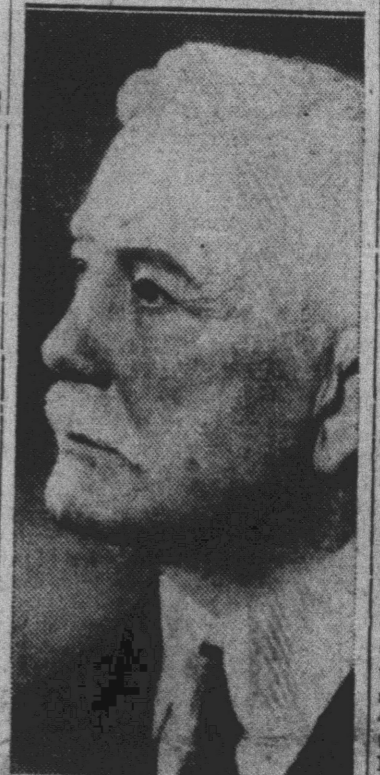
Her home is near Cross Creek and the rear porch juts over the stream. It was believed the wife stepped off this and fell into the water sometime between 5 and 8 o'clock, the times she was reported missing and the hour the body was found.

Her husband was postmaster here 12 years and had served as customs collector at Wilmington. He was several times a candidate for Congress on the Republican ticket. Surviving are two daughters with whom Mrs. McCaskill lived here and one son. No funeral arrangements had been made.

Britain Takes Steps To Call Debt Meeting

London, Dec. 30.—(AP)—The British government has taken the initial steps for summoning the international conference on reparations to meet at Lausanne January 20. Telegrams have been sent to British representatives in ten countries which are expected to participate in the conference suggesting that they approach their governments regarding the time and place. A suggestion also was made to ask the approval of the Swiss government, which amounts to requesting an invitation to hold the conference at Lausanne. No replies to these telegrams have yet been received. The nations participating in the conference are expected to be Great Britain, France, Italy, Belgium, Japan, Poland, Greece, Rumania, Yugoslavia, Czechoslovakia and Portugal. British delegates have not yet been named, but probably will be soon.

SAYS DRY LAW IN 'SHADOWS'

Josephus Daniels Says Prohibition Will Be Forgotten in Next Election.

New York, Dec. 30.—(AP)—The people of America in 1932 will vote for a liberal and progressive Democratic candidate for president, and will be so interested in economic issues that prohibition will be relegated to the shadows, Joseph Daniels, former secretary of the navy, predicted here.

"The situation next year is going to be like that of 1912," the Raleigh editor continued. "Now, as then, the people are going to elect a president who embodies liberal and progressive views."

"No one who is known as a 'standpatter,' or who acquiesces in 'standpatism,' can win in 1932. Nor can we win with a 'pink Republican,' which is another name for a reactionary Democrat."

The Democratic party is fortunate in having available candidates who meet the specifications and who incarnate progressive principles. Particularly, we have Franklin D. Roosevelt of New York and Newton D. Baker, of Ohio."

Referring to prohibition, the wartime cabinet member said: "The country is so eager to find its way out of economic distress that the people won't be interested in prohibition. People are thinking about bread, and the man who talks about booze—whether more or less booze—does not get an audience."

"There is no doubt in my mind that when the Democratic National committee meets next month to select a time and place for a convention it will select a time and place. It will not assume to dictate platforms or policies, prerogatives that are reserved to the delegates of the convention assembled."

Rotarians fell in line the first of the week and contributed to the fund which the relief committee is raising for the poor this winter. The club denied itself the usual weekly dinner and contributed the saving to the poor.

The donation was in addition to individual gifts made by members and shows to what extent the organization is directing its efforts to keep the wolf away from the doors of the unfortunates during the cold days ahead.

Similar action has been taken by a majority of other organizations of the community, and the relief sum has been boosted to no little extent although considerably behind the \$5,000 goal set by the committee.

Persons who have not contributed to this fund are urged to do so immediately and in that way do their bit to make life just a little easier for those whose inability to obtain employment is largely responsible for their condition.

The tobacco market will re-open for business Tuesday, January 5th after being closed since December 18th in celebration of the holiday season. Announcing the date of resumption of business yesterday, K. W. Cobb, supervisor of sales, expressed best wishes for a "Happy and prosperous New Year" to the forty thousand patrons and friends of the market.

Although the bulk of the crop has been disposed of, there yet remains quite a bit of tobacco to be sold and Greenville tobaccoists are expected to be pretty busy after the re-opening, although it will be nothing compared with the first of the season.

Situated in the largest bright leaf tobacco producing county in the world, Greenville is ideally situated as the largest sales center and it is hoped to end the season with that distinction definitely chalked up in the records.

Describing attempts to change the prohibition laws as a "ridiculous waste of effort," Senator Ashurst, Democrat of Arizona, yesterday withdrew from the Senate Judiciary committee named to hold hearings on the question.

"I voted for the 18th amendment, for the Volstead law, for the anti-beer bill, and for all appropriations necessary to enforce same," the Senator said, "and I do not believe I made any mistake in so voting."

"I have no time to waste in aiding those who are attempting to weaken or relax that amendment on those laws. It is a ridiculous waste of effort to attempt to relax or modify the prohibition laws. The people are looking for jobs, not jugs," he said.

That the expression of the Arizona will be received with favor by supporters of the dry laws in all parts of the nation is not to be doubted. It is the most direct and forceful expression recently made in connection with the movement to bring about modification of the prohibition laws and undoubtedly will have its effect.

But the "wets" will not be discouraged by the position of Ashurst. On the other hand, it will only serve to intensify their drive to accomplish their purpose, and Congress will hear much of the question until it has been definitely settled.

Discouraging any attempt to establish a dole system, prominent men testifying before the Senate committee investigating the unemployment situation, have expressed the opinion that the government should provide funds to meet the situation.

The idea seems to be gaining widespread approval, but one thing is sure, nothing will be done until Congress has been firmly convinced that the communities are unable to take care of their own individual problems.

This was the opinion advanced by President Hoover at the outset of the relief drive. He called on all sections to do their best to take care of their own poor, and then if they were unable to do so, they might expect some government aid.

Hampshire Voters To Be First Choose Delegates for 1932

Concord, N. H., Dec. 30.—(AP)—New Hampshire, first of the states due to choose delegates to the 1932 national political conventions promised today to be the testing ground of presidential candidates.

With its presidential primary scheduled for March 8, town meeting day in New Hampshire, the state offers the first opportunity to presidential aspirants to submit their claims to the voters.

State politics, already steaming in the heat of special congressional campaign, warmed up today with word from Oklahoma that its picturesque chief executive, Governor W. H. (Alfalfa Bill) Murray, might be first—at least on the Democratic side—to avail himself of the chance to launch his candidacy.

It was news to Democratic leaders—so they said—but, they added, there was nothing to prevent it, provided the Murray supporters could place in the field a ticket of candidates for delegates under a pledge to support Murray. The presidential primary affords no direct means for the expression of presidential preferences on the part of the voters but it permits any candidate for delegate to have his name on the ballot as pledged to the presidential candidate he favors.

Democratic state leaders, among them State Chairman Robert E. Gould, have been regarded generally as favorable to Governor Franklin D. Roosevelt of New York, although sentiment also has been expressed in some quarters for former Governor Alfred E. Smith of New York.

Two Wilson Banks Fail to Open Today

Wilson, Dec. 30.—(AP)—The First National Bank of Wilson and the Wilson Trust and Savings Bank failed to open for business today.

Notices posted on the doors said the banks were closed by order of the banks were closed by order of protect depositors.

Col. John F. Burton is president of both banks. W. E. Warren is cashier of the First National and E. T. Barnes is cashier of the Wilson Trust and Savings Bank.

The First National Bank in a statement of condition last September listed deposits of approximately \$1,025,000, including \$56,747 of state funds. Its capital was given as \$200,000 with surplus and undivided profits of \$342,355.

A statement from the Wilson Trust and Savings Bank on the same date listed deposits of approximately \$860,000 and gave its surplus and undivided profits as \$132,975. It is capitalized at \$50,000.

The Planters Bank of Wilson did not open yesterday and other banks experienced withdrawals by depositors during the day. Both the First National and the Wilson Trust and Savings Bank met all demands, but the directors of each decided last night not to open them today.

Some withdrawals were made from the Branch Banking and Trust Company here this morning and H. D. Bateman, president, issued a statement telling depositors they would be paid in full if they demanded their money.

He said \$500,000 was brought to the bank this morning and that another \$1,000,000 was on its way here.

Hood Advises Banks to Invoke 30-Day Clause

Raleigh, Dec. 30.—(AP)—Gurney P. Hood, state commissioner of banks, said this afternoon "wherever necessary a bank should not hesitate to invoke the thirty-day clause in the interest of depositors."

Mr. Hood, who is confined to his bed due to illness, telephoned the statement to newspapers after being notified of the closing of six banks in the state today.

Under the 30-day clause, banks can refuse to pay savings accounts on demand, requiring depositors to give 30 days notice that they desire to withdraw their funds.

STOCK MARKET

New York, Dec. 30.—(AP)—Realizing sales and further selling for income tax purposes entered the stock market today, after a morning of rising prices, and erased most of the earlier gains.

Railroad stocks were again leaders during the advance with Santa Fe, Southern Pacific, New York Central and Union Pacific advancing 1 to 2 points before selling developed. The carriers continued to hold better than industrials which were subject to considerable selling during the afternoon. Trading was light.

American Telephone which was sluggish on the advance, dipped more than a point net. Similar losses occurred in American Tobacco, Eastman Kodak and Corn Products. United States Steel and a number of leading industrials fluctuated in narrow price range.

Irregularity also appeared in the bond market. Demand for railroad bonds was relatively good and transportation issues resisted tax selling better than the industrials.

Wall Street received favorably the announcement that a number of Southern Pacific operative had voluntarily accepted a 10 per cent wage reduction. While this was interpreted as indicative of probable action by labor employed by other railroads, union leaders pointed out that the Southern Pacific workmen concerned were not affiliated with the larger rail unions.

Preliminary reports on Christmas retail business indicated that dollar volume of sales was lower than one year ago, but unit sales were as large, if not larger. Department stores had fewer returns of goods during the past Christmas season than in 1931.

Further decrease in production was in line with expectations.

Commenting on the criticism of tax proposals of Representative Rainey, made last night by Undersecretary Mills of the treasury, Garner said: "The trouble with Mills is that he was talking through his hat. It's one of his tricks to set up a straw man and then knock him down."

Washington, Dec. 30.—(AP)—The administration has assailed embryonic tax proposals of congressional Democrat with charge that they are "wholly inadequate to meet the fiscal situation" of the Federal Government.

Undersecretary Mills of the treasury made the criticism of a program outlined by Representative Rainey of Illinois, the Democratic House leader, which advocated heavy surtax levies on the wealthy. In a statement last night Mills said there was "little profit in 'soaking the rich' because 'the large incomes are no longer there'." The program suggested by Rainey has not met with the general approval of other Democratic leaders. Advs. of Mills' criticism of the Rainey program, Speaker Garner said:

"Nobody has been authorized to speak for the Democratic party on a tax program, and nobody has. There is no complete program yet."

The Democrats, however, are in accord on the idea of imposing taxes on those best able to bear them. In addition, they expect to bring about \$200,000,000 into the treasury by stopping loopholes in the existing law.

Rainey advocated repeal of the capital stock gains and losses provision of the present law, levying of a maximum surtax of 60 per cent, and making new taxes effective on the current year's incomes. He opposed the lowering of exemptions on small incomes.

Mills said the program was inadequate to meet the prospective \$2,000,000,000 treasury deficit. A 60 per cent surtax would collect only an additional \$120,000,000, he said, adding "the number of incomes of \$100,000 and over fell from about 16,000 in 1928 to about 6,200 in 1930. There will unquestionably be a further substantial reduction in the calendar year 1932."

He charged the Democrats proposed to operate the government on borrowed money.

(Continued from Page One) China's troops were in full retreat southward from Chinchow to ward the great walled city of China today while two covering Japanese columns pressed toward Kowpangtze preparing to swing down into the walled city which Marshal Chang Kueh-Liang evacuated.

The Japanese division advancing southward from Hsinmintun captured the town of Tahushan this afternoon and the force moving west from the direction of Ying-kow pressed on toward the junction at Kowpangtze.

As the retreat progressed the government at Nanking debated the new situation and in Tokyo reports circulated that Chang Hsueh-Liang had ordered the withdrawal from Chinchow "under the advice of a certain country" which was not named in the dispatches.

Marshal Chang's headquarters at Peiping said the retreat was part of a prearranged plan of defense and "that although most of the armed forces already had started south from the Chinchow area the provisional government would remain there protected by a garrison."
