LARGE CITIES STAGE COSTLY CELEBRATIONS

Chicago and New York Make Whoopee as Old Year Gives Away to the New

New York, Jan. 1.—(AP)—Old 1931 was booted into the wings of time by a Broadway crowd that lingered until dawn today to celebrate the premiere of young 1932. The metropolis welcomed the new year in the traditional manner with noise, hilarity and general merry making.

The crowd in Times Square, under the glare of the white lights, sent up a mighty shout as the old year's hour was struck and there was a din of tin horns, cow bells and other noise making devices.

Revelers flocked to hotels, cafes and restaurants where entertainment was made doubly attractive by general scaling down of cover charges and other prices below those that have prevailed in recent years.

Despite the multitudes that jammed dining rooms, lobbies and the streets, there were other thousands who turned their backs upon frivolity to welcome the new twelve-month in watch services in various churches.

Celebrants who had made reservations at the Royal Box, one of the most ornate of the mid-town night clubs, were obliged to seek entertainment elsewhere, for a squad of Federal agents closed the place before the New Year's celebration began.

Chicago, Jan. 1.—(AP)—Old 1931 tottered out in Chicago last night while thousands of Chicagoans made whoopee in an old-fashioned hilarious manner.

In the Loop alone it was estimated that 30,000 persons celebrated, hotels restaurants, at an average price of \$20 each, a much lower cost than Chicago paid for making whoopee last year.

At this rate one of the Chicago newspapers figured that Chicago had something like \$400,000 to get off of 1931.

The downtown area was jammed with noise-making pedestrians despite unfavorable weather. Among those who helped the mid west metropolis forget all about the old year was Texas Guinan. She greeted the customers as usual at the Planet Mars Cafe, despite the fact the place was raided by Federal prohibition agents the night before.

She escaped an arraignment before a United States commissioner, counsel for the government having accepted her statement that she was just a hostess at the Planet Mars.

"That wasn't a raid," she said. "It was a sorry party. I've been in lots of raids, but I want to say that Chicago has the best looking and the most gentlemanly prohibition agents I ever saw. New York's duds could learn a lot from them."

Meanwhile James P. Allman, commissioner of police, ordered that the police detail attached to the prohibition department be withdrawn today.

Philadelphia, Jan. 1.—(AP)—Secretary of the Navy Adams, in the expressed opinion of Director of Public Safety Schofield, is a "misguided and egotistical little whiffet."

Schofield, whose tenure of office expires Monday, made this assertion last night as he promoted a policeman who was discharged from the naval reserve for wearing a naval uniform to catch a small-time bootlegger.

The policeman, Charles P. Long, was elevated to the rank of sergeant "to show him good police work is rewarded," Schofield said. "He was made a martyr in the navy by a misguided and egotistical little whiffet, whose attitude toward the constitution is best typified by his remarks to newspapermen."

When informed that a large quantity of illicit liquor had been found on his estate, Adams remarked: "I hope I can get some of it."

The liquor seizure referred to by Schofield was made last October. Later information revealed the police was found on property adjoining the Adams' estate in Massachusetts.

Secretary Adams, ordered Lang dropped from the reserves to "dishonoring the uniform." The order precipitated many verbal attacks on the navy by Schofield.

CONSTRUCTION SEES VICTORY SLIGHT HERE OF DEMOCRATS

City, However, Kept Pace With Previous Year in Erecting New Buildings

Greenville people spent practically the same amount of money for new construction in 1931 as they did in 1930, it was revealed today in the annual report on construction by George Clark, chief of police, who was also charged with the responsibility of issuing permits for new buildings during the year.

The total construction program cost \$133,590, compared with slightly over \$100,000 for the previous year and \$500,000 in 1929.

The largest construction project was involved in erection of the new Star Warehouse, which replaced the building destroyed by fire last June. The building and stables cost over \$32,000.

The next largest project was the erection of an addition to the Imperial Tobacco Company's plant at a cost of \$15,000.

The report showed that a dozen residences were erected at a cost of \$32,850. Principal among these were the homes of K. W. Cobb, \$7,000; C. L. Adams, \$8,000; and L. R. Meadows, \$5,000.

Construction of stores, filling stations and office buildings was valued at \$86,850. The only new store was that of B. G. Abeyoums on Evans street replacing the building destroyed by fire last March. It cost \$10,000.

The permits also showed a \$7,000 addition to the plant of R. J. Reynolds Tobacco Company. Two filling stations were erected at a cost of over \$3,000.

Considerable activity was shown in the repair of buildings and the total amount expended in this direction was reported at \$13,890. Twenty-six different projects were recorded during the year, involving numbers of residences and buildings in the business area.

FEW CHANGES ON NEW YEAR IN THIS CITY

D. H. Conley Succeeds R. G. Fitzgerald As Superintendent of Education

No business changes of any importance greeted the coming of the new year in Greenville, it was revealed in a check-up of the various business houses of the city today. The only change of any importance occurred in the educational field where D. H. Conley, former principal of Winterville schools, succeeded R. G. Fitzgerald as director of the Department of Education of Pitt county.

Although announcement of the resignation and appointment was made the first of December, Mr. Conley did not officially assume his duties until this morning.

Mr. Fitzgerald will continue to make Greenville his home and will be connected with Silver-Burnett Co., book dealers of Newark, N. J. The usual number of changes of the field of industry was greatly reduced this year, and no notices to this effect were made public during preparations for the new year.

MAYOR URGES MORE LOYALTY

Says This Should Be the Watchword of the Citizenship During 1932

Loyalty in every phase of human life was stressed by Mayor R. C. Flanagan in a new year message to the people of the community today.

Declaring he was tired of the use of the words "depression, repression and co-operation," the leader of the city government, impressed upon everybody the importance of steadfastness of purpose in meeting the problems confronting the community during the new year.

He emphasized loyalty of the people to one another, and especially to those who have not been as fortunate as others in realization of material blessings.

He also called attention to the necessity of loyalty in organization and government, and the realization of their returns in good citizenship. He warned the people from being away from principles and ideals which have gone into making the nation what it is today.

If the nation is to continue to go forward in the future as it has in the past, Mr. Flanagan declared, there must be a more pronounced spirit of loyalty of industry to employees, whereby every man may be granted the inalienable right of independent thought and action. This must not come only through what the laborer gets from his work but what he does toward development and expansion of industry.

"Above all," said the mayor, "let us not forget the loyalty due our Maker and our churches. They must come first if civilization is to maintain its equilibrium and forge ahead."

City Visited By Heavy Fire Loss The Past Year

The fire loss in Greenville during the past year was over four times as great as it was during the previous year, it was revealed today in the annual report of George Gardner, chief of the Greenville fire department. The report gave the 1931 fire loss as \$223,621.99 compared with \$49,534.28 for the previous year.

BETTER TIMES WATCHWORD OF U.S. OFFICIALS

Hopeful New Year Greetings Mingle With Thoughts of Big Issues at Capital

Washington, Jan. 1.—(AP)—Hopeful new year greetings mingled in the American capital today with thoughts of issues to be encountered, campaigns to be waged, and decisions to be made during the year.

It is the 200th. Year after the birth of George Washington, and as such is to be widely celebrated, but principally it brings forward the lengthy list of problems born of 1811 and its preceding years.

A president must be chosen by the people, either Herbert Hoover again, or one of the long list of candidates, active and potential, who are taking the field. But before that even, an outstanding disarmament conference, the question of foreign debt payments and related foreign issues will combine with the domestic needs of business, agriculture and labor to challenge both President Hoover and Congress.

STATE GREETS 1931 QUIETLY

Unfavorable Weather Prevents Usual Celebration in Various Sections

Charlotte, Jan. 1.—(AP)—With the customary ringing of bells, fireworks and indoor merry-making, but minus the customary outdoor demonstrations which were prevented by rain, North Carolina welcomed the new year.

Charlotte, accustomed to riotous year-end celebrations, was comparatively quiet as bells tolled the death knell of 1931 and ushered in 1932. Few, as compared with the thousands of other years, were the automobiles which raced shrieking through the streets.

From other cities of the state came reports. The rain was too much for the revelers, who confined their activities to dancing and other indoor indulgences.

While housewives laid in supplies of hog jaw, corn pone and black eyed peas for a New Year's Day feast portentous of year-long prosperity, the "resolvers" and prosperity predictors held sway.

Unlike the day before Christmas prohibition activities on the part of authorities were little in evidence yesterday and last night, and no large raids were reported.

JAPS KNOCKING AT CHINCHOW

Troops Lays Siege to Principal Chinese Stronghold in Manchurian Area

Mukden, Manchuria, Japan, 1.—(AP)—Japanese cavalry clattered across the ice on the Taling river today and stopped at the outskirts of Chinchow, China's last Manchurian stronghold.

This was an advance patrol from the main body of the brigade encamped on the north side of the river.

There was no resistance, the Chinese defenders continued leaving the walled city in great numbers and presumably the Japanese intended to take over tomorrow.

KING WINTER HITS AMERICA

Frost, Snow and Rain Stretch From California Across Mississippi Valley

The new year today got the welcome that Santa Claus missed in the western part of the United States with snow lying deep on several states and others bitten by cold.

Warm weather that maintained generally through the Christmas holidays was banished by frost, snow and rains that stretched from coastal California across the upper Mississippi Valley.

Mountain districts were under deep drifts. Some plains regions were without a trace of precipitation; others were buried by heavy mantles of white.

Temperatures ranged as low as 2 below zero in Montana. Lena Haas, 16, froze to death on a trip from her ranch near Cortez, Colo., to obtain headache tablets at the home of a neighbor two miles away.

Furries in the Texas panhandle and Oklahoma led into traffic blocking drifts to the north. Western and central Nebraska was digging out of a heavy snow which damaged communication lines.

A heavy fall in Iowa stopped at 9 o'clock last night with the temperature at 35 degrees. Snow was forecast to follow rain in Missouri and Illinois. Minnesota and Wisconsin had sleet, snow and rain.

NEW ACTIVITY IN PROGRESS

Confidence in Future Boosted by New Construction Program Reported From Various Sections of the State; Hundreds of Dollars Involved in New Construction Projects

Raleigh, Jan. 1.—(AP)—North Carolina today started a new year with many business, industrial and agricultural leaders expressing the opinion that 1932 "will be a better year."

From almost every part of the state came word of new construction projects underway as the year 1931 ended.

Merchants reported that 1931 was "a fair year at least" and that cuts in overhead to meet conditions enabled them to enter the new year on a solid foundation.

From the mountain section of the west came word that the Champion Fibre Company was in the midst of an alteration program at its huge paper factory which will cost more than one million dollars to carry through.

At Greensboro a new postoffice costing more than half-a-million dollars is under construction. Raleigh is erecting a new city auditorium which will cost about \$300,000.

From Wilmington comes announcement from the office of the army engineer that approximately one million dollars is credited to the district for work before the spring allotments are made. Some of this money will be expended soon on the Beaufort-Cape Fear and Cape Fear-Little river links of the Inland Waterways.

Numerous other construction projects involving hundreds of thousands of dollars could be enumerated and in the near future the state is expected to start erection of a new state's prison to cost several hundred thousand dollars.

Some typical comment of business leaders gathered by the Associated Press follows:

J. B. Ivey, Charlotte merchant, says "we anticipate 1932 to be a little better year than 1931 has been, due to gradual increased confidence in the situation. We feel that we see a gradual improvement, although we do not anticipate anything but a very slow improvement in 1932."

Reuben Robertson, president of the Champion Fibre Company, says "we are entering a new era, one which will be on an entirely different foundation from that which we have just passed. It will be based more nearly on those fundamental conditions which existed prior to our post war economic or perhaps better termed uneconomic spree. It will re-emphasize the value of thrift—not miserliness. We are strong and well organized. In the present economic ordeal they will survive and, when the final adjustment is accomplished, will go forward rapidly to renew prosperity."

Stuart Cramer, president of the Cramerton Mills, and a member of President Hoover's unemployment and relief commission, says "if the relief measures recommended by the administration in Washington are adopted and put into effect, I believe they will go far toward thawing out the frozen condition of business."

S. Clay Williams, president of the R. J. Reynolds Tobacco Company, says he "is looking for 1932 to be a year of progress, not only for this company, but for business generally."

Of the farmer, Dean L. O. Schaub of N. C. State College says "farmers are accepting the situation and plan to make the best of it" and "in general they have more food and feed than they have had in a great many years. In every part of the state we find farmers preparing for a better balanced program in the future."

CITY USHERS IN NEW YEAR

Downpour of Rain Put Damper on Celebration in Greenville Last Night

Although hundreds of Greenville people remained up last night to give the infant New Year a joyous welcome, the celebration was reduced considerably by unfavorable weather conditions.

Rain, beginning during the early evening, continued well into the morning hours, and celebrants were forced to do most of their celebrating indoors.

As usual, there was the ringing of bells and blowing of whistles when the old year took the knockout count and the infant entered the arena. Celebrants who in past years found much amusement sending in false fire alarms just to see the trucks speed to various sections of the city, were silent for the first time in years last night, and firemen were able to sit back in their quarters and speculate on the prospects of the new year.

Watchnight services were held at St. Paul's Episcopal church, Jarvis Memorial Methodist church and Immanuel Baptist church. Each service was marked by meditation.

Patrol Will Not Nab Late Buyers of Auto Plates

Greensboro, Jan. 1.—(AP)—By virtue of its discretion in law enforcement, the State Highway Commission will see to it that late buyers of 1932 automobile license tags are not arrested during the next few days. E. B. Jeffress, chairman, announced.

Although no official is authorized to extend the time allowed for purchasing the tags, the commission has discretionary powers over the State Highway Patrol, which is principally responsible for checking on licenses.

Sex Battle Starts In Original Egg

By HOWARD W. BLAKESLEE Associated Press Science Editor New Orleans, Jan. 1.—(AP)—A key to control of sex in the discovery that a battle between sexes starts in the original egg is one New Year's present of the American Association for the advancement of Science.

This discovery was described by Dr. Emil Witschi of the University of Iowa at a symposium where the latest findings on how and why sex originates were presented.

The battle begins the moment the new life starts in the embryo, the outer covering of which tries to become female, while the inner portion demands to be male.

One or the other wins, and that first battle settles whether that individual shall be male or female. Dr. Witschi showed his progress in photographs of frog embryos.

Usually, he explained, the cards are stacked before even this beginning, so that one or the other side is doomed to a futile struggle. The "cards" in this game of life are the sex chromosomes contributed from the parents of the young animal.

But the stacking is not invariably sufficient. Dr. Witschi's pictures revealed that environment may come to the aid of one or the other disputant, and decide the contest.

He photographed extreme cases where environment even overcame heredity and changed a sex already well defined.

He showed low temperatures changing a male frog into female and high temperatures changing a female into a male.

The fact that temperature will fix the sex of certain small animals has been known for some years, and used to produce sexes wanted at will. Dr. Witschi's work explains why cold produces female and heat makes males.

In low temperatures the outer covering, the female side, called the cortex, grows faster than the inner male portion, named the medulla. Soon the cortex cells outnumber the medullas, and the females win.

But in high temperatures the medullas multiply the more rapidly, and have their own way about producing a male frog, even if "he" was a "she" when the hot wave struck.

Kidnapped Girl Returned Home

Columbus, Ohio, Jan. 1.—(AP)—Seven hours after she was kidnapped Ada B. Ruhl, 8, returned dazed, to her home early today. She was taken to a hospital by police who said she had been criminally assaulted.

Officials said the girl told them she was seized while on an errand for her parents, Mr. and Mrs. J. Fred Ruhl, early last night and held captive several hours in a garage by an unidentified man.

After being treated at a hospital the child went with policemen to a point near her home where she identified the garage in which she had been imprisoned and molested.

She told police her abductor was a well-dressed white man. Authorities said the description fitted that of a man arrested several months ago in a similar attempted attack.

World Efforts Hold Hopes For Chasing the Business Wolf Away From Door of 1932

The economic wolf still is scratching at the world's door as 1932 succeeds 1931.

From Germany to Jaapan and from Scotland to Argentina, the boice of unemployment, over-production, dislocated markets and kindred evils have troubled the dreams of statesmen.

World hopes for a more prosperous new year turn to projection national and international efforts. In February at Geneva the nations will seek, in an attempt for a general reduction of armaments, relief from topheavy governmental budgets.

Political problems yielded largely to economic perplexities in the year just past.

U. S. Comes to Germany's Aid Germany's crisis developed swiftly in the spring and summer until in July, President Hoover's war debt and moratorium proposal staved off what German observers declared meant complete ruin.

The solution Chancellor Bruening said, was only temporary, and Germany asked some form of lasting relief in 1932. The Young plan advisor committee started the attack on the problem.

Germany's financial problem gave rise to one of politics. Fascist "Hitlerism" gained enormously among the country's youth and menaced the Bruening government.

Great Britain, faced by its most serious financial crisis in many years, scrapped the labor government of Ramsay MacDonald and replaced it with a national coalition.

The god standard went by the board in the ensuing reconstruction and Japan, the Scandinavian countries and some others followed England's example.

The immediate result for England appeared to be an improvement.

Politically the British year was marked by the inconclusive London Round Table conference, which sought a means of granting self-government to India, and passage of the statute of Westminster, conceding to dominion parliaments freedom from the supremacy of the London parliament.

Airplane Death Toll Reaches 4

Springfield, Ohio, Jan. 1.—(AP)—The death toll in the wreck of the Cleveland - Cincinnati passenger plane rose to four today when W. D. Wieback of Cincinnati, a salesman, succumbed to injuries.

Three men were dead when they were pulled from the smashed ship near here last night. The pilot remained critically injured.

Cause of the fall was sought in an investigation by Capt. Frank McKee, state director of aeronautics, who inspected the wreckage today.

The plane, a single motor craft, en route from Cleveland to Louisville, was flying low when it went into a barrel roll, according to Lewis L. Bowen of Louisville, the pilot.

Those killed in the crash were: A. L. Wenner of Cincinnati, an engineer.

Louis E. Stone, 34, of Cincinnati, personnel director of the Embury-Riddis division of American Airways.

A. C. Mayer, Jr., 38, of Louisville, merchandising manager of the General Electric Company refrigeration division with headquarters at Cleveland.

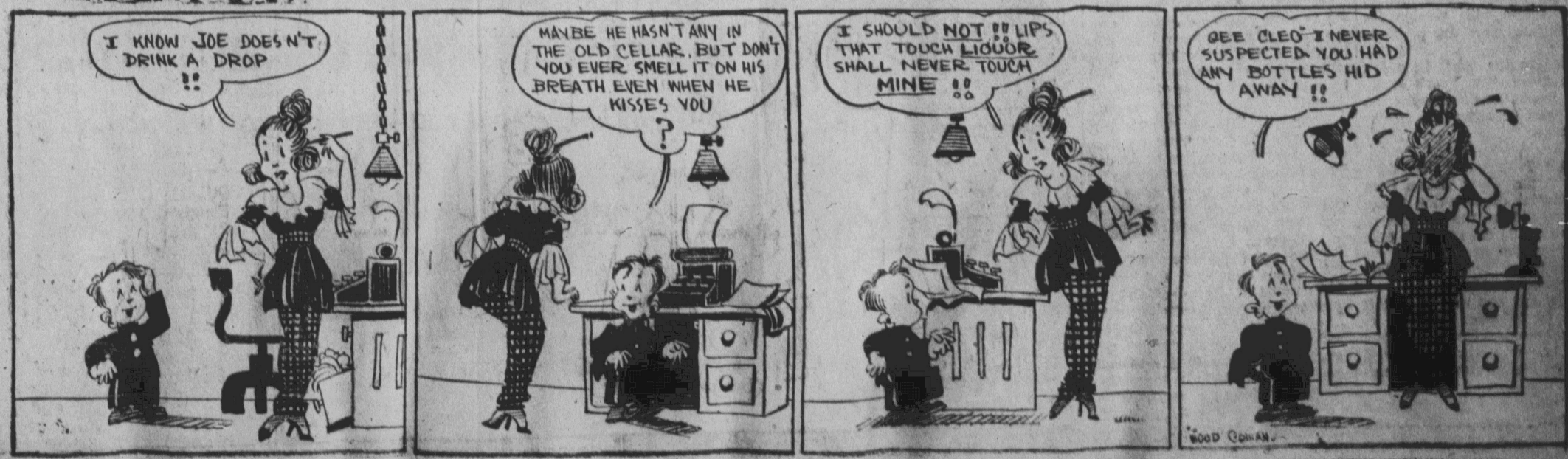

From the opposing coaches came a depressed note. Bernie Bierman said rainy weather would stop whatever chance his Green Wave eleven had to depending on passes and speed for a victory.

"I don't see how we can win," he pined, "but we'll show the Trojans we have a football team."

Coach Jones commented: "Rainy weather always handicaps any team, but I don't believe we will be bothered any more than Tulane. It should be a great game."

The Greenie backers, of whom there are some 3,000, were far more confident than their coach. They pointed to the past record in this classic of teams from below the Mason and Dixon boundary. Alabama won twice and tied one game. Georgia Tech eked out a victory. But the West has yet to win.

Southern Californians said today was the time for rehearsal. No one has stopped the Trojans since last September when Little S. Mary's made twining passes to gain a 13 to 7 triumph. Since then Notre Dame, Stanford, California, Oregon, Georgia, Washington and others have fallen.

FEDERAL OFFICERS BEGIN WIDE HUNT FOR BOMBERS

(Continued from page one) The bombs were delivered by mail or express yesterday in Chicago, Cleveland, D. D. and Youngstown, O., but none of them caused any loss of life or property damage because they were all intercepted in time. Their discovery followed closely upon the heels of the explosion of two bombs in the Easton, Pa., postoffice, which killed two men last Wednesday. A third victim, Charles Weaver, died of injuries last night.

Three packages, one of which is known to have contained powerful explosives, were received in Chicago. One of them, which reached the office of Oscar Durante editor of L'Italia, a pro-Fascist publication and a member of the Chicago Board of Education, was described by Chief of Detectives William Shoemaker as being powerful enough to wreck a whole city block. It was taken by police to an outlying place where it was exploded by rifle bullets.

Others apparently intended victims were: Giuseppe Casaraccio, Italian consul, Chicago; Tony Masillo to whom a package was sent in care of the Associated Press, Chicago; Count Ugo Berni Canani, Detroit; Italian vice-consul, Count Cesare Brandolini, Italian Consul at Cleveland; and Dr. A. Rescaped, Italian consular agent at Youngstown.

The package addressed to "Masillo" at the Associated Press in Chicago and that directed to the Chicago Italian consul are to be traced today to see if they contain explosives. There is no such person as "Masillo" on the rolls of the Associated Press where offices are situated in the Ashland building, which also houses the headquarters of several Italian organizations, including the Italian Chamber of Commerce and the Unione Siciliana.

Like the bomb sent to Durante in Chicago, those in Cleveland and Youngstown were exploded by the police with rifle bullets, with results that indicated they were loaded with TNT and nitroglycerine. The Detroit package, also believed to have contained an internal machine, was intercepted shortly after it was delivered to the hotel residence of its vice-consul.

Meanwhile a special guard of Washington police watched over the Italian embassy at the request of Ambassador De Martino. Philadelphia reported that the office of Judge Harry S. McDevitt of the Common Pleas court had been placed under a guard following receipt of bombing threats. Judge McDevitt sentenced Orlando Spartaco, who was convicted of beheading Foreign Minister Dino Grandi of Italy when the latter visited in Philadelphia. Spartaco appealed.

(Continued from page one) criss-cross the flat black lands of north-west Mississippi were rising steadily after rains which came just at a time when the first high waters started to recede.

Already, water washed over the levee tops in many places along the Tallahatchie valley and new and dangerous breaks in the levee systems appeared imminent. Thousands of acres were inundated and tenants and stock had been hurried to hill rises.

The Yazoo Mississippi delta levee board was called upon to send all available boats to Glendora to care for local residents as danger of a break in the levee in the east section grew hourly. Boats patrolled the flood area to aid marooned refugees and convicts were pressed into service to aid in guarding the levees.
