RASKOB ASKS FOR VOTE ON PROHIBITION

Demands Party to Support Referendum Dry Law During Campaign

Washington, Jan. 6.—(AP)—John J. Raskob, Democratic national chairman, began a series of conferences with party leaders today on his proposal that the Democrats declare decisively for a prohibition referendum and avoid being classified as either wet or dry.

On his list were Senator Robinson, floor leader of the party in the senate and vice-presidential nominee in 1928, and Speaker Garner, whose power in the party is more potent now than Republican control of the House has been overthrown.

Raskob laid his "home rule plan for liquor control" before the national committee in a letter made public this morning three days before the committee meets here to select a convention city.

Already it has aroused widespread discussion. That it will be the principal subject of his talks with party leaders is a foregone conclusion in political circles.

Washington, Jan. 6.—(AP)—The Democratic Party found thrust upon it today the clear determination of Chairman Raskob to keep the prohibition issue to the fore in this year of presidential election.

Under a warning that is virtual destruction would be the alternative, the chairman laid down a pressing demand that the party declare at the convention this summer for submitting the entire question to the people for a new decision.

He was equally emphatic that the party itself keep on the fence, going neither wet nor dry, until the voters have had their say. Raskob made public his views last night in a lengthy letter to the national committee heads, supplementing this with remarks evoked by questioning reporters who surrounded him as he arrived for the committee meeting Saturday.

The stand for resubmission, contended the chairman, will allow the contending elements in the party, both wets and supporters of prohibition, to find common ground. The alternative, as he saw it, was either a party rent asunder, north against south, or a party diminished in importance by the rise of a third political group, a "Liberal" party. The issue, he maintained, must be met by convention time.

With publication of the letter, other business to come before the committee session, such as selection of the convention city and date, faded into the background. To avoid a repetition of the outbreak he precipitated with the issue last March, the chairman intended, he said, to ask the committee to refer his plan to the convention, without declaring itself for or against. But an outbreak seemed unavoidable, nevertheless.

The proposition Raskob wishes laid before the voters does not involve complete repeal of prohibition, but rather a choice between retention of the Eighteenth Amendment unmodified, and his "home rule" plan under which the people of each state could exempt themselves from national prohibition by voting for state liquor control.

At his press conference, the Democratic leader smilingly offered to bet two to one that the country would reverse its prohibition stand within "our lifetime."

ROGERS WINS HOUSE SEAT

New Hampshire Democrat Emerges Victorious in Special Election

Manchester, N. H., Jan. 6.—(AP)—(AP) William N. Rogers, of Wakefield, a wet Democrat, today stood as the first New Hampshire congressional district, nominally Republican and represented by a dry since 1925.

He is the first Democrat to represent the state in congress in 10 years and was the last of his party to serve in the national house.

Former Governor John H. Bartlett, Rogers' Republican opponent for the seat made vacant by the death of Fletcher Hale of Laconia, received 24,505 votes to Rogers' 27,543 at yesterday's special election.

Democratic sentiment had been rapidly growing for several weeks, a number of municipalities in the district either swung into the Democratic column or reported close contests in recent local elections. Yesterday, even Laconia, home of the late Fletcher Hale and a Republican stronghold, gave the Democratic candidate a small majority.

Republicans and Democrats alike saw in Bartlett's defeat a debuff to the administration.

Rogers was born in Wakefield and next Sunday will celebrate his 40th birthday. He has two daughters, Pauline, 18, and Una, 16.

He attended Brewster Academy, making the trip to the farm school each day on a freight train and from Brewster he entered Dartmouth, where he became one of the Big Green's greatest football stars. He played guard on the varsity eleven back in 1911, 1912, and 1913.

Court Drops Charge Conspiracy Against Norfolk Attorney at Wilson.

Wilson, Jan. 6.—(AP)—A charge of conspiracy to obstruct justice, brought against W. Sheppard Drewry, an attorney of Norfolk, Va., was dismissed by Judge Johnson J. Hays in United States District court here today.

Judge Hays ruled the government had not introduced sufficient evidence to sustain the charge.

RASKOB DRAWS LOTS COMMENT

Some Papers Condemn and others Approve Statement On Prohibition Issue.

(By Associated Press) Widely published editorials comment on the report of Chairman John J. Raskob before the Democratic National Committee ranged from warm commendation of his search for a compromise insuring against a party split to sharp criticism of the document as not being representative of Democracy.

The Philadelphia Public Ledger said that if "history repeated itself he would succeed only in arousing their (the dry's) opposition anew, inviting a definite split between the northern and southern elements."

The Enid, Okla., Morning News said the Raskob statement "is not representative of Democracy" and declared that "Democratic contributors are not the Democratic party."

The Kansas City Star remarked about the "deceptiveness of straw votes" and commented that "Chairman Raskob may find the delegates to the national convention in far less agreement on his referendum proposal than the contributors to the campaign fund."

The St. Paul Pioneer Press saw in the report an attempt to keep the Democratic party wet "without breaking party lines in the dry south as they did in 1928."

"It (prohibition) is and will remain a political question," said the New York Herald Tribune. "But it is not and should not be made a partisan subject."

The Boise, Idaho, Statesman saw in the author of the report "a politician clever enough to recognize that the situation demands some kind of compromise acceptable to the south," while the Miami Herald said "he recognized that bread and butter may be the paramount question this year."

The Boston Globe: "There is not much doubt that Mr. Raskob is correct when he says the way to settle this dispute is to obtain a verdict from the voters on the specific question."

The Baltimore Sun said "Mr. Raskob arranges things so that the Democratic party is not wet nor is it dry."

GULF COMPANY SAFE IS ROBBED

Yeggmen Chisel Way Into Vault and Make Way with Between \$300 and \$500.

Yeggmen chiseled and battered their way into the safe in the office of the Gulf Refining Company plant near the cotton mill early today and escaped with a sum of money estimated at between \$300 and \$500. The loss was covered by insurance.

County officers, augmented by fingerprint experts of the police department, began a wide-spread investigation during the early morning, but no arrest had been made up to mid-afternoon. Although no clues as to the identity of the yeggmen had been obtained, they were believed to be members of a gang which has been operating in this community for sometime.

The robbery was discovered by office employees who went to the plant this morning at 7 o'clock to open up for the day's business. The robbers entered the building through a side window, and with the aid of a sledge hammer and chisel, battered and cut out the combination, affording easy access to the contents of the vault.

Office workers were busy this morning attempting to determine the exact amount of money missing but had not completed their work at the noon hour. They believed the loss would reach the \$500 mark and probably exceed that amount.

Officers expressed belief that the robbery was committed by an experienced safe cracker, although no explosive was used, and working on this theory, hoped to pick up some definite clue within the next several hours.

SUCCUMBS TO HEART ATTACK

Enjoyed Excellent Health Until Stricken at 12:30; Died at 1:05 a. m.; Funeral Services to Be Conducted at Goldsboro Thursday.

Goldboro, Jan. 6.—(AP)—Capt. Nathan O'Berry, treasurer of North Carolina and prominent in state educational, manufacturing and political circles, died at his home here early today thirty minutes after being stricken with angina pectoris.

Yesterday he had been in his usual health, which was considered excellent for a man of his age. He was 75 years old. About 12:30 this morning he became ill. He died at 1:05 a. m. He was in excellent spirits a few hours before and his sudden death came as a shock to this community.

Capt. O'Berry journeyed every day from Goldsboro to Raleigh to carry on his duties as state treasurer and (Continued on Page Four)

ADAMS CLAIMS HE IS LOYAL

Secretary of the Navy Fires Back at Critics who Say He's Not in Accord with Pres.

Washington, Jan. 6.—(AP)—A Democratic suggestion that Secretary Adams resign because he is not in accord with President Hoover's naval policies drew a reply today from the Navy Department head that he was "absolutely loyal."

Representative McClintic, Oklahoma, reminded the House naval committee that Adams yesterday had approved a bill for construction of \$616,250,000 worth of new ships to bring the United States up to the London naval treaty allowance. Then came the resignation mention.

The navy head asked permission to reply. With a quaver in his voice he said he knew of "no difference between what I've testified here and the President's attitude. 'I resent the implication that I'm here in any disloyalty to the President of the United States.'"

Adams explained he had endorsed the Vinson bill yesterday "as a personal preference."

Earlier, Admiral Pratt, chief of naval operations, testified that the navy's safety might be endangered if a satisfactory naval program is not authorized by Congress.

FOR VOTE ON PROHIBITION

Majority of Dry Democrats Who Gave to 1928 Campaign, Favor Referendum

Washington, Jan. 6.—(AP)—Eighty-eight per cent of the North Carolina Democrats who contributed to the party's 1928 campaign fund and who responded to Chairman John J. Raskob's questionnaire favor a referendum on prohibition, a recapitulation of the answers here showed.

The chairman did not give the number of replies received from the state. Here is how the Tar Heels who answered voted on the eight questions which the chairman submitted to subscribers to the fund throughout the nation:

In favor of a short, concise platform, 87 per cent. In favor of resubmission of the 13th amendment, 88 per cent. In favor of requiring all future amendments to be ratified by the people instead of the state legislature, 90 per cent.

In favor of submitting the so-called home rule prohibition amendment to the people, 82 per cent. In favor of submitting a straight repeal amendment to the people, 70 per cent.

Those preferring home rule amendment over proposal of straight repeal amendment, 53 per cent. Those believing that the Democratic platform can "successfully ignore the prohibition question with its economic problems by remaining silent or by adopting a law enforcement plank as was done was done in the 1928 convention," 31 per cent.

The chairman went on to explain that many of those favoring a referendum were not necessarily wets.

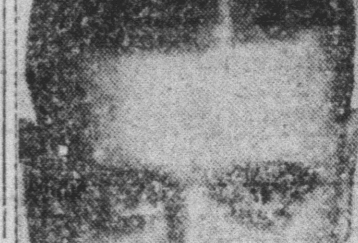
Patman Seeks To Impeach Mellon

Washington, Jan. 6.—(AP)—A resolution seeking the impeachment of Secretary Mellon was introduced in the House today by Representative Patman, Democrat, Texas.

"On my own responsibility," Patman told the House, "I impeach Andrew W. Mellon of high crimes and misdemeanors."

The House sat tense and still as Patman spoke, facing the chamber crowded with representatives who had just answered a roll call.

SIX CASES IN COURT HERE

Majority of Defendants Sent to Roads in Regular Session of County Court

Six cases were disposed of in the regular weekly session of county court yesterday. The docket was the smallest of any single session in months and work was completed during the early afternoon.

The cases involved violation of traffic laws and larceny. Jasper Barnes, colored, convicted of a charge of larceny, was sentenced to sixty days on the roads.

Walter Armstrong, colored, had judgment suspended on payment of one-half cost on a charge of reckless driving.

John Piker, colored, was sent to the roads for 90 days on a charge of breaking and entering.

Convicted of reckless driving, James Boyd, colored, was required to pay one-half cost in addition to \$20 to the clerk to be turned over to Robert Hedgepath for damage to his car.

John Candler, James Ellis and Will Moore, colored, charged with larceny, received sentences of 60, 90 and 60 days, respectively, to the county roads.

Sam Pearce was taxed one-half cost and ordered to pay John Smith \$25 on a charge of driving drunk and assault with a deadly weapon. The deadly weapon charge grew out of damage in an automobile wreck.

Robinson Blocks Move to Probe Bailey's Election

Washington, Jan. 6.—(AP)—A resolution authorizing the Senate election committee to make an inquiry into the contest against the election of Senator Bailey, Democrat, of South Carolina, was blocked from immediate consideration by the Senate today by Senator Robinson, of Arkansas, the Democratic leader.

Senator Robinson voiced no views on the resolution but merely asked that it be considered in the regular order.

The resolution was reported from the audit committee with approval for funds to make the investigation.

The contest was brought by George M. Pritchard, of Asheville, Republican candidate for the Senate in 1930.

MANY INDIAN LEADERS ARE PUT IN JAIL

Practically All Leaders of National Congress Arrested by the British

Bombay, India, Jan. 6.—(AP)—The first stage of the government's drive against organizations of the Nationalist Congress was completed this morning with the arrest of practically all the prominent leaders of the congress.

They were taken in by scores. A number of women were included among those arrested.

The women fired the first "gun" as the weaponless war of the rank and file of Mahatma Gandhi's millions began the fight for independence. The women established pickets in front of stores throughout the country, defying arrest and urging shoppers not to buy British made goods.

The arrest of the leaders was followed by an announcement in the Bombay Government Gazette that the Congress itself and over 80 allied organizations throughout the city and suburbs are declared unlawful associations.

The thoroughness with which the organizations were put down by the fact that even the Prabhat Peries, a small association whose members assembled each day at dawn to sing national songs in the streets has also been banned. All buildings which formerly housed these associations are now occupied by the police and the city is completely quiet.

To add to the prevailing unrest in the country, 5,000 railway workers on the Great Indian Peninsula Line went on strike in protest against curtailment of their working hours.

At least 80 different organizations were outlawed in Bombay. These included the ambulance corps, prohibition committees, anti-untouchable committees and several boys' boarding schools. All were declared menaces to public peace.

While the turmoil as going on, however, Gandhi was peacefully spinning in Poona prison. He said he was greatly relieved to know that India's millions are observing loyalty his most sacred command to refrain from violence.

He still is treated as a privileged prisoner and has the run of several cells usually reserved for Europeans. These are furnished with tables, chairs and beds but these accessories are wasted upon the Mahatmas because he sits and sleeps on the floor, like the humblest Indian subject.

Negro Will Not Die for Theft

Raleigh, Jan. 6.—(AP)—John Moore, who has stood under the shadow of the death penalty for weeks because he stole a pair of shoes in Winston-Salem, is not to die for his offense.

After a hearing, Tyre C. Taylor, executive counsel to Governor Gardner, announced he would recommend commutation of Moore's sentence to life imprisonment. The executive counsel's work is practically final in such matters.

Moore was convicted of first degree burglary, which, under the North Carolina law, consists of entry into a house or room, in which people are sleeping, for an illegal purpose. Moore stole the shoes from a room in which a negro girl slept. The jury which tried him, recommended mercy, but such a recommendation has no legal standing in a North Carolina court, so Moore was perforce sentenced to die in the electric chair.

The executive counsel took under advisement a plea for a commutation for Ernest Herring, Sampson county negro, who is sentenced to die January 15 for the murder of P. F. Newton, aged Kerr, N. C., postmaster.

Herring's brother, Chevris, was electrocuted last month for his part of the crime, and just before he died he swore that Ernest had nothing to do with the slaying.

Old Christmas Noted Today

Today was Old Christmas, but few, if any, in this community, observed it. The majority having completed their celebration during the week of December 25.

The observance of Old Christmas centers around the twelfth night of the year, the night the wise men gave gifts to the Christ-child as he lay in a Bethlehem manger twelve days after His birth. The custom was originated by medieval English ancestors but is no longer observed by the Christian world.

Rodanthe, a hamlet in the eastern section of the state, is the only place in this state where the occasion is observed.

ABOUT TOWN

President Hoover plans to oppose a proposal for reduction of salaries of federal employes despite the fact that he has been talking his head off about economy in government for the last two years.

Secretary Adams favors a ten year naval program so the United States may be brought up to London treaty limitations.

Nobody would seriously object to such a plan but it is difficult to see where the money is coming from. In case the secretary should be able to show the government where it may obtain proper financial assistance to carry out such an idea, he might be able to put his plan through, but otherwise he stands no show at all.

With a deficit, staggering in proportion, starting Uncle Sam in the face, it is hardly probable he will listen to a ten year naval building program, although few will deny necessity for same.

Secretary Adams, the plenty of other people, will still have plenty of recommendations when talk of the enlarged navy has died down, but it will be a long time before he induces Uncle Sam to loosen his purse strings, unless an exigency should occur.

The Red Cross stands ready to distribute the proposed 40,000,000 bushels of wheat among the unemployed people of the nation the minute Congress authorizes such action. This was the message which Chairman Payne imparted to the Senate investigating committee at Washington yesterday.

This organization has always responded to calls for aid and it may be depended upon to continue serving the people in this emergency. Even at this time numbers of Red Cross workers are administering to the flood sufferers of Mississippi, carrying to completion a task any other organization would have found almost too monumental to attempt to handle.

The government would not be able to find a better medium by which to distribute the surplus Farm Board wheat to the poor, and the sooner Congress takes action to make this possible the sooner suffering will be mitigated.

The administration is frowning on efforts of the Democrats to provide a tariff plan superior to the one at present in use, and if frowning counts for anything, the Democrats are going to find it difficult to change things.

The public, however, is watching the battle interestedly, believing that lowering of the tariff would be one of the most effective means of improving business conditions.

As soon as Republicans seized the reins of government they increased tariff rates with the result that other countries retaliated, bringing about virtual warfare along this line. What this government needs is a better foreign market for its goods and it will never be able to get it until it has lowered its own bars and relieved rates which make the purchase of products of the various nations almost prohibitive.

This fact has been prominently brought forward to the people of this nation the last few years, but more especially this year, with markets glutted beyond hope with products that should have gone to foreign countries for consumption. The Democrats have started a movement filed with great possibility and should they succeed who doubts but that the economic situation will show a pronounced improvement in the near future.

The whipping of an American vice-consul by three Japanese in Manchuria apparently is not going to be as easily settled as at first anticipated by the Japs. Although the government of Japan has sent a formal apology to the American government, Uncle Sam is taking his time about acceptance, having been already wrought up by depredations of Japanese forces in Manchuria. The League of Nations, backed by urgent appeals of this government, did everything in its power to prevent Japan from continuing hostilities, but warfare continues, and Japan has shown no disposition to stop it.

(Continued from Page One) enactment of this bill. "There is substantial agreement among those who have been consulted that some step for the consolidation of efforts and the re-establishing of confidence in the underlying foundations of business and finance is absolutely essential.

"Moreover, unless the machinery provided by the bill can be set in motion without loss of time, the opportunity for good, which might otherwise be accomplished, will inevitably be sacrificed and the aid when offered or made available may come too late.

(Continued from Page One) time give definite recognition to a new balance based on the right of every individual to make a living out of life.

While the governor devoted most of his 6,000-word address to recommendations for legislation applicable to the Empire State he also used it as a vehicle for expressing his own opinion of the present day social order and for the outlining of his program for stabilizing the nation.

Referring to the depression, Mr. Roosevelt said "more than two years have gone by and the leaders in government and business have shown us the plans for the reconstruction of a better ordered civilization in which the economic freedom of the individual will be ordered."

Mr. Roosevelt's discussion of the business situation and his recommendations for "remodeling" the social order were increasingly significant because he is considered one of the leading candidates for the Democratic presidential nomination this year.

In his opening sentence, the executive asked for a holiday on politics, declaring the "domestic crisis" calls for a "unity of leadership and action as if we were engaged in war."

"Not since the dark days of the sixties have people of this state and nation faced problems as grave, situations as difficult, suffering as severe. The economics of America, and indeed of the whole world are out of joint; only the most skillful and concerted care will mend them.

"We face the necessity of employing new measures of value for the good reason that many old values have disappeared; new comparisons of property and man's remuneration for his work, for the good reason that many of the old proportions have been proven false"

"We have lost in recent years the economic liberty of industry, agriculture and distribution and has meant that the cog can move only if the whole machine is in perfect gear," he asserted.

(Continued from Page One) RANDON CRACKING LEVEE made the 52-mile trip and return in usual fashion yesterday. Funeral services will be conducted here Thursday and burial will follow but the hour has not yet been designated by relatives. Born in Tarboro January 26, 1856, he grew to manhood during the days of reconstruction, without a college education and with only what public information was available in his home town at the time. He moved to Goldsboro soon after his majority, and organized a corporation to market long leaf pine products. After being appointed state treasurer, succeeding the late Benjamin R. Lacy, he continued to maintain his home here, commuting the 52

miles to his work in Raleigh. Too young to serve in the civil war, Captain O'Berry won his title as captain of the local militia company. In addition to his treasurer's work, he had many other public interests. He was a member of the state prison commission, and of the board of trustees of Peace Institute for young women at Raleigh. He was a director of the state hospital at Goldsboro, and once served as alderman in Goldsboro. Captain O'Berry was in such apparent good health last night that he held a meeting in his home with several business associates and afterwards conversed for a while with his son, Thomas O'Berry. He went to bed, however, at an early hour. A nurse who was in the home to care for Mrs. O'Berry who has been in ill health, heard him get up about 12:20 a. m., and go from his bedroom to the front room. She went in, noticed he appeared to be ill and asked if he were sick. When he replied that he was, she called Dr. W. H. Cobb, Thomas O'Berry and Mrs. Thomas O'Berry. Later Dr. C. F. Strohnside was called also. The two physicians administered hypodermic injections, but Captain O'Berry later Dr. C. P. Strohnside took.

(Continued from Page One) evidence to warrant the charge against Drewry, who was indicted with three other men and a woman. His ruling was issued when the government rested its case. The other defendants, who continued on trial, are Mrs. Margaret M. Ramsey of Norfolk, Alton L. Jordan of Norfolk, R. Clarence Dozier of South Mills and A. J. Davis of Norfolk.

A petition for a receivership for the Home Mortgage Company of Hickory, filed in Mrs. Ramsey's name, led to the indictment which charges there was a conspiracy to secure a receivership for the mortgage company by means of false evidence.

The defense motion for dismissal of the charges as to Drewry was opposed by the government attorneys who contended he was connected with the alleged conspiracy by sitting in at conferences with the other defendants.

Peter M. Bassing, representative of the trust department of the First National Bank of Baltimore, was one of the last witnesses before the government rested its case.

He testified to the delivery of Home Mortgage Company bonds to Davis and West, a brokerage firm of Norfolk, for the Colonial Bond Corporation.

The district attorney announced the government was attempting to show by Bassing's testimony that Mrs. Ramsey did not own any bonds of the Home Mortgage Company at the time the petition for a receivership was filed.

In her petition Mrs. Ramsey said she was the owner of \$3,500 of bonds, that interest had not been paid on them and that the Home Mortgage Company was insolvent and improperly managed.

The petition was filed on October 16, 1930. Bassing said the bonds were shipped from Baltimore on October 18.

C. S. Phillips, assistant cashier of the Norfolk National Bank of Commerce and Trusts, testified the bonds were received there on October 20 for Davis and West.

"He was a true patriot. I would talk to him but he never flinched. He was warned that he was working too hard. The tremendous strain of handling the state's finances during the past three months was visibly telling on Captain O'Berry.

"I am greatly distressed. In my generation, the state has never had a more patriotic or valuable public servant.

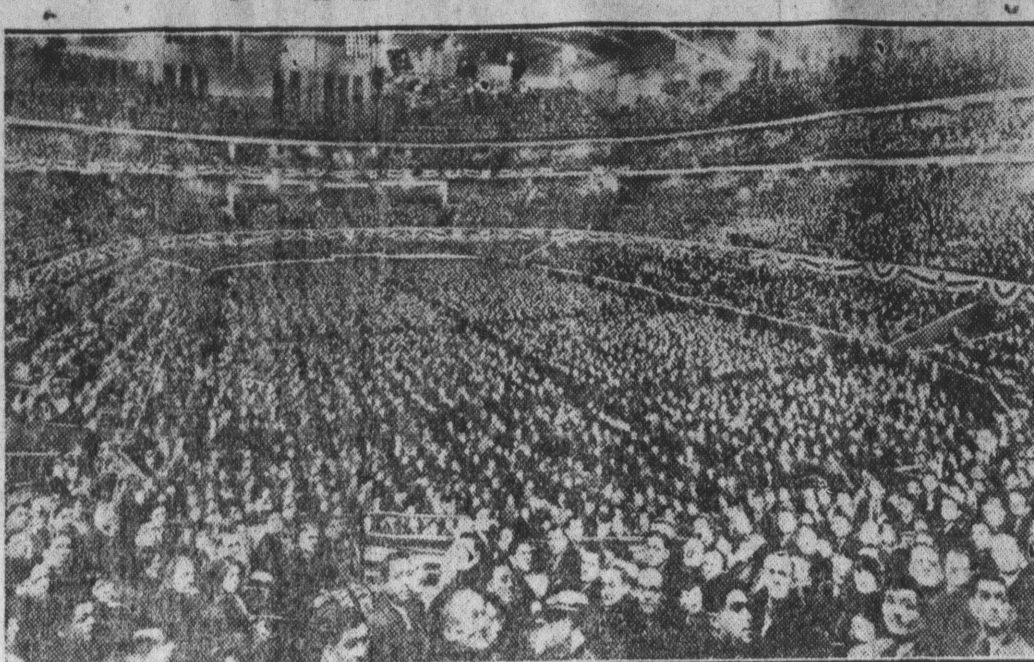
"Captain O'Berry died literally at work. At the meeting of the council of state Monday he asked that the business be transacted as rapidly as possible in order that he might return to his duties. Later in the day, I visited him in his own office and found him at his desk signing state bonds.

"Captain O'Berry was most reluctant to accept the post of state treasurer when I tendered it to him because of his very high sense of duty. It was only on the same considerations that he consented to be a candidate for re-election last year.

"He served the state in most splendid manner in what has been the most critical period of the office of treasurer has ever faced and his place will be most difficult to fill at this time."

Captain O'Berry became state treasurer one day after the death of Benjamin Lacy, who had served the state 28 years. When he finally consented to seek election to the office in 1930, after being "drafted" by the governor, the voters acclaimed him with one of the largest majorities ever given a political

candidate in the state. Of his own accord Captain O'Berry never sought a public office.

Governor Gardner commented recently that one of the outstanding things during his administration would be the work of Captain O'Berry as treasurer in meeting the state's payments on indebtedness.

As the financial affairs of the state, due to economic conditions, are in a rather disturbed state, it was generally believed that Governor Gardner would name a successor to Captain O'Berry at the earliest possible moment. The death of "The Captain," however, came with such shock that no names were under consideration as possibilities.

Captain O'Berry carried a ripe business experience to his office of treasurer and one of the outstanding achievements of his service was the close safeguarding of state funds in banks. Though about 150 banks in the state failed during his administration, the state never lost a dollar of the money it had in scores of institutions as he had all funds amply secured.

One of his greatest accomplishments, he often said himself, was the securing of an interest rate of 2 1/2 per cent for the state on an issue of notes for \$2,500,000 last July. That was the lowest interest rate the state had ever been able to get in its history. Yesterday he was engaged for hours in long distance telephone conversations with New York financiers arrang-

ing for the renewal of those same notes.

Raleigh, Jan. 6.—(AP)—The State Capitol building today was tendered by Gov. O. Max Gardner to the family of Captain Nathan O'Berry, state treasurer who died in Goldsboro this morning, if the family wishes for the body to lie in state here.

Work went on in the capitol building today with all outside wooden doors shut and all windows drawn. The flags on all state buildings were at half mast.

During the funeral hour all offices in the capitol building will be closed. The funeral will be held at Goldsboro Thursday, the hour

WEST SHOWS CAGE POWER THIS SEASON

New York, Jan. 6.—(AP)—On the face of early returns, the middle west seems to be the stamping ground for this country's leading basketball teams.

In inter-sectional warfare against teams from the east, south and far west, representatives of the corn belt have piled up an overwhelming margin. An Associated Press compilation of inter-sectional games played up to and including those of Jan. 4 credits the mid-west with 33 victories and only 13 defeats.

Although the east and far west have been the chief sufferers in this mid-western sweep with 27 losing games between them, the south also has been outplayed, winning only two games in eight. The east has won seven and lost 13; the far west has won four and lost fourteen.

Wisconsin of the Big Ten, Loyola of Chicago, a strong independent, and Butler, newly-named to the Missouri Valley conference, have been the chief winners for the mid west. Each has accounted for three victories in as many inter-sectional jousts.

Creighton, Purdue, Wittenburg and Kansas each has won two games while the other mid-west triumphs are spread over a scattered list of 16 other colleges and universities. Kansas alone has lost two games, the other 11 midwestern defeats being charged to as many schools.

Although badly outplayed in the midwest, the east's inter-sectional record is bolstered by an event split in eight games with the south and a three to one edge over the far west. The University of Pittsburgh, which started the season with an eye on the national championship, has been the chief loser with six defeats but the Panthers also have been the heaviest winners with five victories. Another Pittsburgh outfit, Carnegie Tech, is the only other eastern school which has won more than one inter-sectional game. The Tartans have divided four games with the south and midwest.

Vanderbilt and Kentucky have contributed two victories apiece to the southern record of six wins and ten losses. The far west's poor record of five victories in 22 games can be blamed chiefly on the University of Southern California which can point to only two victories in nine games.

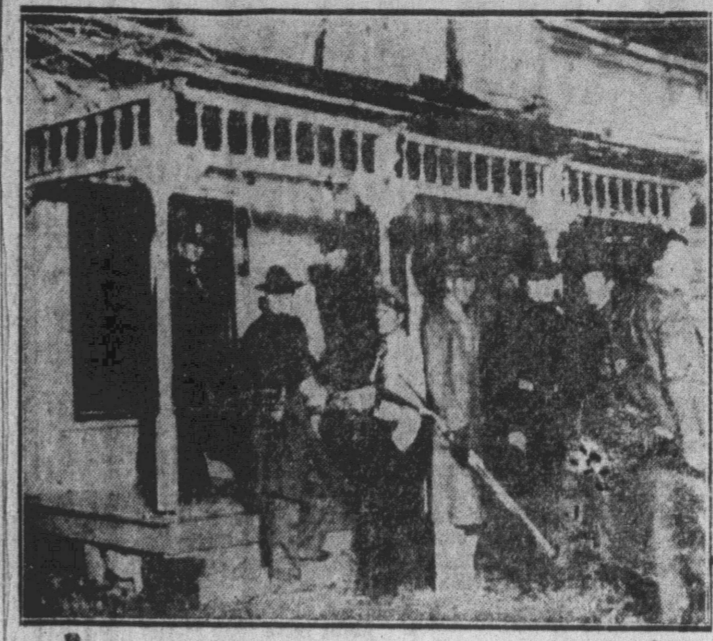
