## CITY SCHOOLS RECEIVE NEW RECOGNITION

Surpass All Other N. C. Towns of Equal Size in Reduction of Retarded Pupils.

The Greenville City Schools have received additional honors today in the announcement by the State Department of Education that Greenville leads all cities of equal size in the matter of reducing the number of retarded children in all of the grades. The average white child in North Carolina is approximately nine-tenths of a year retarded; to be exact, nine hundredths. There are only two cities in the state in all the groups which have any better record. Kinston with six hundredths, and Shelby with three hundredths. Winston-Salem has the same score as Greenville. All other school systems of the state have a higher percentage of retardation. Henderson and Tarboro have the poorest records with a retardation score of eighty and eighty-six hundredths.

This is one of the factors which makes for economy in operation of the local school system, namely that very few children have to spend more than one year in a grade. And the local school system has been able to reduce retardation to a minimum because of the high type of teacher employed, because of good buildings and equipment and because of the nine month term of school which local children have enjoyed since they have been attending school.

## Charles G. Dawes Resigns As Ambassador

Washington, Jan. 9.—(AP)—Dwight F. Davis resigned today as Governor General of the Philippines and his successor will be Theodore Roosevelt, now Governor of Porto Rico.

After conferring with President Hoover, the governor general said there is no understanding as to when this resignation takes effect.

He plans to leave this country shortly to visit his wife and daughter, Alice, in Paris. The illness of Mrs. Davis was one of the reasons given for his resignation.

## Japan To Seek Revision Of 'Nine Power' Treaty

Tokyo, Jan. 9.—(AP)—A conference to revise the nine power treaty, which was signed by Secretary of State Stimson in his recent note to Japan on the Manchurian question, may be sought by Japan, it was learned on good authority today.

The purpose, it was said, would be to secure a more clear definition of the term "administrative integrity" as used in the treaty.

Washington, Jan. 9.—(AP)—Dwight F. Davis resigned today as Governor General of the Philippines and his successor will be Theodore Roosevelt, now Governor of Porto Rico.

## GERMANY NOT ABLE TO PAY

Chancellor Bruening Informs Great Britain of Inability To Meet Reparations.

Berlin, Jan. 9.—(AP)—Chancellor Bruening has informed Great Britain that when the Lausanne Reparations conference convenes Germany will tell the world that her ability to pay reparations is at an end.

He told Sir Horace Rumbold, the British ambassador, that not only for the present but for an indefinite time to come Germany will be unable to pay.

The German delegation to the Lausanne meeting also will argue, he said, that so long as the present reparations policy continues, economic recovery for Germany and the world will be impossible.

This notification was given yesterday but the foreign office announced it only this afternoon after reports had come from other European capitals that Dr. Bruening had said Germany would refuse to accept anything at Lausanne except complete cancellation of reparations.

"It would have been sheer madness for the chancellor to lay down any such ultimatum," said the foreign office spokesman. "If he had there would be purpose in going to Lausanne."

## YOUTH CHARGED WITH SLAYING AT LAURENS, S. C.

Laurens, S. C., Jan. 9.—(AP)—A youth of 21, Ernest Hitt, of Cross Hill, today was charged with the brutal slaying of W. C. Rasor, retired Cross Hill business man and former banker on the night of September 26.

Arrest of Hitt late yesterday by Sheriff Columbus Owens brought to six the number of men now charged with participation in the crime. Rasor was slain when alone in his large Cross Hill home.

The other five men arrested in the case are charged with being accessories before and after the fact of the murder. They are Henry Rasor, 45-year-old son of the slain man; Eugene Crisp, 30, and his brother, Lathan, 26, relatives of Henry Rasor by marriage; and two negroes, Isiah Richards and Lee Aynne. All are Cross Hill.

## Alabama Will Continue Use Of Jail Lash

Montgomery, Ala., Jan. 9.—(AP)—Gov. B. M. Miller is going to continue the use of the lash to maintain discipline in the Alabama prisons "until something better is presented."

He flatly refused to abolish flogging of convicts in the face of demands from a delegation of the Alabama League of Women Voters, the World War Veterans Voting Union and the disabled-American veterans here yesterday.

"Somebody's got to sit steady and see that law and order is maintained," the governor said.

Spokesmen for the delegation asking for discontinuance of whipping charged that James C. Kirby of Jasper, world war veteran, had been "brutally flogged" just a few hours before his recent release from Atmore prison.

Governor Miller replied that he had a great admiration for those who fought in the war "but because a man fought in France gives him no right to come home and steal."

## FIND \$100,000 STOLEN FROM A MAIL SACK

Cash and Currency is Discovered Buried in Ground near Road in Massachusetts.

Lowell, Mass., Jan. 9.—(AP)—One hundred thousand dollars in cash and currency which had been taken from a mail sack here December 31 was found today buried in the ground in a by-path off the Hood farm road in Tewksbury.

The money was uncovered by victor L. Magoon, a Lowell postal clerk charged with the theft, who was taken to the spot by three postal inspectors. His visit to the woods was brought about through a telephone tip that followed closely upon the discovery of the mail sack which had contained the money and mail in the woods near where the money was uncovered.

Louis Skaff, driver of the mail truck which had delivered the pouch containing the mail at a railroad station for transfer to Boston, is also charged with participation in the theft.

## REED OUT FOR PRESIDENCY

Missouri Democrat Sounds Aspirations At Jackson Day Dinner in His State.

Springfield, Mo., Jan. 9.—(AP)—James A. Reed, former United States senator has sounded what was believed by several Missouri Democrats to be his aspirations to the Democratic nomination for President.

Making the principal address at the annual Missouri Jackson day dinner last night, Reed led slip with a single phrase, the signal for cries of "Jim Reed for President," which rolled through the Shrine Mosque here.

"And now I speak for James A. Reed," he said, introducing a program of remedial measures which he proposed for the nation, a program of seven points, the principal of which was a demand for decentralization of government.

Reed, who has said he would consider it a compliment to have the Missouri delegation support him for the Democratic Presidential nomination, was not the usual virilic "Roman," as he addressed the Missouri democracy. He seemed more concerned over economic issues, and treated only briefly of prohibition.

## THREE HELD FOR SLAYING

Americans Charged with Slaying Hawaiian, Held for Attack on Woman.

Honolulu, Jan. 9.—(AP)—A Hawaiian accused of attacking a white woman was killed and today Mrs. Grace Bell Fortescue, wife of Granville Fortescue, noted American author and soldier, her son-in-law, Lieut. Thomas H. Massie, U. S. N., and an enlisted man, were held on warrants charging them with the slaying.

The three were arrested after a ten mile chase in which several shots were fired, police forcing their automobile into an embankment.

In the car police found the body of Joseph Kahahawai, Hawaiian, accused with four others of attacking Mrs. Massie last September. His body was wrapped in a sheet. He had been shot through the heart.

Mrs. Fortescue, who is equally well known in social circles of Long Island, Washington and London was driving the car. She would make no statement, nor would Massie or E. J. Lord, the enlisted man. After being brought to Honolulu, where the charge was lodged against them, they were taken to Pearl Harbor and spent the night aboard a naval vessel.

The slaying climaxed a series of events which in the last few weeks have aroused Honolulu residents deeply. Following an attack upon a school teacher last week, Gov. Lawrence M. Judd ordered all police agencies to "rid Honolulu of vice."

## PLAN SERVICES HERE IN MARCH

Simultaneous Services To Be Held at all City Churches Week Of 20th to 27th.

Simultaneous services will be held in the various churches of the city during the week of March 20-27. It was announced following a meeting of the Ministerial Association yesterday. The services, an annual custom, were held during April of last year.

According to tentative plans worked out by the association, services will be held at each of the churches every evening during the week, and a union service at Jarvis Memorial Methodist Church every morning. The hour of the services had not been decided upon, but this was to be made known at a later date.

The services will be in the nature of the Easter season, always one of the most inspirational of the year, and were expected to be largely attended.

More definite plans for the services will be worked out by the association during the intervening time and the public will be called on to lend all assistance possible in making the week one of real spiritual preparation.

## ATLANTIC CITY LOSES BATTLE

Each City Offered \$200,000 for Honor of National Gathering of Party, But the Windy City Finally Emerged Victorious; Chairman Raskob Denies Story of 'Raskob-Smith-Shouse' Alliance Against the Nomination of Governor Roosevelt.

Washington, Jan. 9.—(AP)—The Democrats will convene in Chicago in June to nominate their presidential candidate.

The Illinois city was chosen by the national committee today, with the result uncertain to the last minute.

Mayor Anton Cermak had raised the Chicago bid to \$200,000 to meet a similar one by Atlantic City.

The other aspiring cities—Kansas City and San Francisco—bid \$150,000 each.

The vote for Chicago was made unanimous after the first call showed 59 for the Illinois city, 59 for San Francisco, 19 for Kansas City and 4 for Atlantic City.

When the roll had been completed, several states started switching their votes to the victor and upon a motion from the floor, Chairman Raskob declared the selection unanimous.

Thus for the first time in years both national conventions go to the same city.

Stories of a "Smith-Raskob-Shouse" alliance against nomination of Franklin D. Roosevelt for President were scathingly denied by John J. Raskob, chairman of the committee.

Soon after opening of the session the committee referred the chairman's proposal for a prohibition referendum to the convention without recommendation.

Raskob made the Roosevelt declaration amid applause. He read a newspaper story saying that the "Smith-Raskob-Shouse" group was behind a candidate in opposition to one supposed to be favored by the Roosevelt forces.

"There seems to be," he said, "a straw man set up saying Smith, Raskob and Shouse combine against the nomination of Governor Roosevelt. There is not one word of truth in it."

## THREE HUNDRED BRIGHT NEW CARS ON DISPLAY AT GRAND CENTRAL PALACE

New York, Jan. 9.—(AP)—Dust covers over 300 bright new automobiles at Grand Central Palace today and the 32nd national automobile show was on.

Rip Van Winkle, in a gigantic wall panel done especially for the show, gazed sleepily down at the scene in an attitude of amazement. Motor car lovers, treading a two-ton, royal scarlet carpet running up to the four-floor display, shared some of his wonder.

Cars, ranging in hue from a hilarious yellow to a high-hat black, nestled against a richly bright background, with eager young men everywhere ready to explain everything.

New departures, such as an extension of free wheeling and striking changes in the frontal aspects of many makes, created interest. Free wheeling, which made its bow last year, has become standard equipment on most models. Many new applications of this feature are disclosed.

Increased stress on bullet-nosed fronts, with some manufacturers favoring the flat radiator with a narrower profile toward the bottom and others the V and the sloping, started a lot of comment in the case of several cars, all you have to do to start the motor is turn the ignition key.

A device to enable the driver to adjust shock absorbers for varying travel conditions without leaving his seat was among the comfort wrinkles. New treatment of tops for the all-weather body was also shown.

The industry, which employs 5,000,000 people directly or indirectly, has taken pains with the show in the hope the new models will give a flip to trade that will bring the country a step nearer prosperity.

Stained glass panels around the richly decorated hall point to the bearing of the industry on national welfare, with pictures bearing such labels as "Our use of 9,000,000 pounds of wool aids the farmer," "Three million car loads of automotive freight carried annually by railroads," and "our gas bill would pay \$2,000 apiece annually to over a million men."

The show continues all next week, except tomorrow.

## SLAYER OF SON KILLS HIMSELF

Shelby, Jan. 9.—(AP)—Jason E. Ledbetter, 55, who killed his 20-year-old son last September, killed himself late yesterday.

He used a shotgun, the same weapon which had taken the life of the boy.

On September 25 the Ledbetter home was visited by a neighbor and his two sons who sought to force Odum Ledbetter to marry a young woman of their family. An argument ensued. The elder Ledbetter, thinking his son would be carried away by force, got his gun and fired from his door into the yard where the quartet scuffled. All four were wounded, young Odum fatally.

## STEALS BANANA, HELD FOR ROBBERY

Greensboro, Jan. 9.—(AP)—A banana Edgar Myers of Reidsville took from W. J. Owens' store for a joke cost Myers his liberty and today he was in jail here under a \$1,000 bond on charges of highway robbery.

Myers, arraigned in court here, told Magistrate S. F. Huffines he and a man, whose name he refused to divulge, held up Owens with "two toy pistols as a joke."

Owens said Myers searched his pockets and found a purse which was returned when Owens pleaded it was a gift. The store owner said Myers selected a banana from a bunch as he and the other man left the place.

Testifying again, Myers said the "hold up" expedition was a prank, but Owens said he failed to see any humor in the situation. Magistrate Huffines held Myers to superior court.

## SALES LIGHT ON TOBACCO MARKET

The Greenville tobacco market sold 353,112 pounds of tobacco during the week just closed for \$19,980.34 at an average of \$56.66 per hundred pounds, it was revealed in the official report of K. W. Cobb, supervisor of sales.

For the season the market sold 64,288,436 pounds of leaf for \$3,105,695.95 at an average of \$9.50 per hundred pounds.

## Rev. W. R. Ware Dies at Gate City

Mrs. Wiley Brown received a message today conveying intelligence of the death last night of Rev. W. R. Ware, superannuated minister of the Western North Carolina conference, at his home in Greensboro.

Mr. Ware was well-known in Greenville and Pitt county, having married Miss Allie Brown, a native of Pitt. He had visited Greenville several times and was held in highest esteem by a wide circle of friends here and in other sections of the state. He had been an active Methodist minister for 50 years prior to his retirement last year.

Funeral services will be conducted from West Market Street Methodist church, at Greensboro tomorrow and burial will be made in Shelby.

Surviving are his widow, who was Miss Allie D. Brown of Pitt county, and the following children:

Mrs. C. A. Kriebbaum, of Baltimore; Mrs. John L. Rendleman, of Salisbury; R. R. Ware, of Greensboro; Henry Ware, of Washington; the Rev. Dwight Ware, of Charlotte, and Spencer Ware, of Albany, N. Y.

A native of Shelby, Dr. Ware was educated at Vanderbilt University and joined the Western North Carolina Conference of the Methodist Episcopal Church, South, in 1884.

At various times during his ministerial career he served as president of the Greensboro, Salisbury, Shelby and Statesville districts. Among his charges as a pastor were the First Methodist church, Salisbury; Centenary, Winston-Salem, and First Church, of Gastonia.

## DAWES WILL RETURN HOME

Resignation as Ambassador to Great Britain Causes Political Buzzing.

Washington, Jan. 9.—(AP)—Charles G. Dawes left politically alert Washington speculating furiously today over a sudden announcement of retirement as ambassador to Great Britain.

The simple and unexpected statement of the former Vice-President that he was going back soon to run his bank at Chicago startled political leaders and close friends here, who are ever mindful of the approaching Presidential campaign.

Dawes left his announcement here, to be given out some time after his departure for Chicago last night, in the surprise manner so characteristic of the picturesque ex-army general, banker and Republican leader.

He said he was going ahead as chairman of the American delegation to the forthcoming Geneva arms conference but that he would only stay there until the "general work which our government has in mind for me" is completed.

He would not remain, he said, to complete technical details.

There was no mention of President Hoover in the statement, and despite the declaration that he was looking forward "to life as a private citizen of Chicago," Republicans in the capital—and Democrats—pondered the idea that the door was open to him so far as the 1931 residential campaign is concerned.

Against this political view of many was the thought by others close to Dawes that he really has intended coming back to his bank for more than a year. They also point out he is vitally interested in the approaching celebration to be staged by Chicago—the century of progress exposition.

With it all was the constant reminder that Dawes is a prominent Republican and was viewed as a potential Presidential candidate in 1928 when his close friend and political associate, Frank O. Lowden, of Illinois, was a candidate against Herbert Hoover for the nomination.

White House officials took Dawes' news almost without comment, but expressions of surprise came from high state department officers and Republican leaders.

## NINE KILLED ON HIGHWAYS DURING THE PAST MONTH

Highways claimed twelve lives during the month of December in Division A of the North Carolina Highway Patrol, it was revealed today in the monthly report of Lester Jones, division lieutenant. Thirty-two persons were injured and the total number of accidents was given as forty.

The patrol handled a total of 1,725 violations of the law and made 100 arrests. Nineteen drunk drivers were nabbed and duly prosecuted. Other facts in connection with activities of the patrol during the month follows:

## ABOUT TOWN

The fire loss in Greenville for the month of December was \$70,000, the heaviest for a similar period probably in history of the city. This of course, was due to the destruction of a warehouse in the tobacco district, involving a major part of the sum, but it was loss nevertheless and brings the citizenship to a keen realization of the necessity to reduce the loss.

The loss for the entire year was above the two hundred thousand dollar mark, over four times as great as the previous year.

There is only one solution to the problem and that is for more widespread regard for fire hazards. The State Department is continually attempting to impress on the public the need of more caution in the handling of fire, especially where hazards are concerned, and if they would only take advantage of the warning the annual toll would not be as nearly as great as next year.

Employment of a woman nurse to do educational work in the venereal campaign among colored people of the county can not be too highly commended, especially in view of the splendid results obtained from the series of clinics conducted under auspices of the Rosenwald Fund and the U. S. Health Service, the last two years.

Pitt county people should be proud of the distinction accorded them in the clinic because it was the only district in this part of the country where similar experiments were conducted.

Realizing the paramount importance of continuing the work, the Rosenwald Fund and U. S. Health Service decided not long ago to contribute a sufficient fund to enable the county to employ a colored nurse to carry on the work. Clinics will be conducted as usual at the County Health Department and in the course of a few years venereal disease should be reduced sharply in all parts of the territory.

The Red Cross is planning to contribute one million dollars to the relief of unemployed miners in five or six states of the union. It was made known in the midst of testimony given before a Senate investigating committee by John Gifford, head of President Hoover's relief committee.

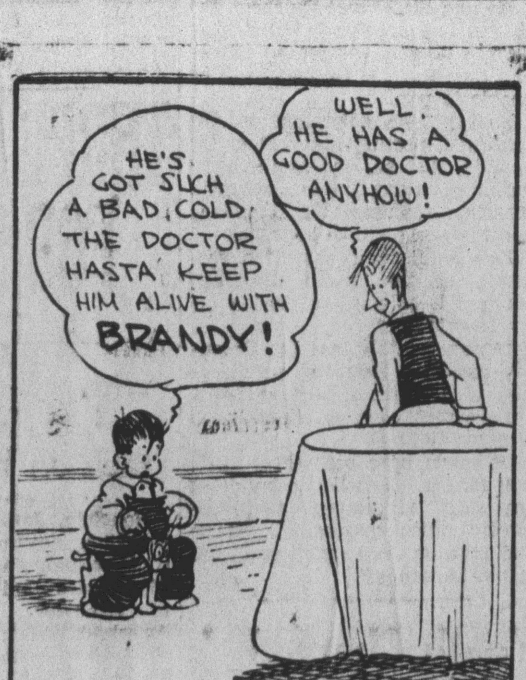
At the same time, it was stated that the majority of the states would be able to take care of the unemployed without federal aid. Gifford discouraged government help because it would tend to cause some of the communities to relax their efforts in the relief program. No doubt the conclusion is right, but it would not be amiss for the government to provide a specific sum to hold in readiness to meet acute conditions which might arise in some localities. Mr. Gifford evidently is not aware of the accentuated situation prevailing in some of the agricultural sections. Some of the farmers are as hard hit as people in the mining districts, and if a million dollars is necessary for five or six states, it is to be presumed that several times that sum would be necessary for the entire nation.

The Pitt County Farm Department is more active than ever in an effort to increase the revenue of farmers in this section.

Through the opening of new market channels through the Mutual Exchange, farmers have a greater outlet for their food crops than they ever had before, and especially in the face of one of the greatest productions in years.

It is realized that a market for the products is absolutely imperative if the growers realize on their extra crops and it is the purpose of the farm organization to provide this as far as possible. The curb market is proving of great help in accomplishing this purpose and numbers of farmers find a splendid outlet on the market every week.

Along with the reduction of minor infractions of the law comes the announcement of increased operations of robbers and thieves of every description. Several robberies in Eastern Carolina recently have

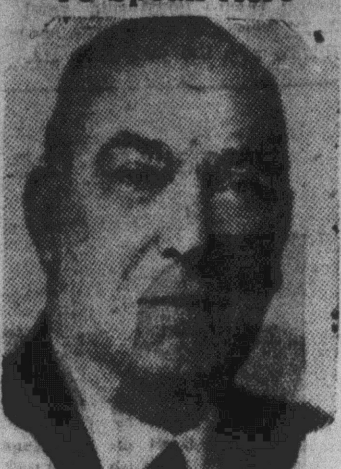

Rocky Mount, Jan. 9.—(AP)—Blood and bits of flesh found on the 5th car of a freight train that passed through today have established the time of the mysterious death of J. H. Daniel, well-known business man, whose body was found on the railroad tracks here.

Meanwhile, Sandy Little, a negro, who had been held in custody, was released. Officers said they believed Daniel standing by the tracks in the warehouse district in an apparently dazed condition around midnight.

Jolice, who discredit a suicide theory, said they believed Little was not connected with Daniel's death.

Rocky Mount, Jan. 9.—(AP)—Authorities here today continued their investigation into the death of J. H. Daniel, well-known business man, whose mangled body was found on railroad tracks in the warehouse district early yesterday.

Statements of witnesses that Daniel had been seen on the street with a bloody face, and the finding of a bloody towel in his store by Willie Jones, his brother-in-law, led to the belief that he might have been murdered and his body thrown before an approaching train to make it appear an accident.

Business associates and the Daniel family, physicians said there was no possible grounds for considering it a case of suicide.

Offsetting the foul play theory, however, was the statement of Dr. H. Lee Large, who examined the body, that blows on Daniel's head could not have been inflicted before he was struck by the train.

In view of the conflicting evidence, Coroner W. C. Guley continued an inquest until Monday in an effort to uncover more concrete details.

Funeral services for Daniel, who is survived by his widow and four children, were set for today.

JAPAN TO SEEK REVISION OF "NINE-POWER" TREATY

(Continued from Page One) ment should have made reservation on Manchuria but it neglected to do so.

The cabinet of Premier Inukai decided to remain in office en bloc today after a bomb attack on Emperor Hirohito yesterday, had been discussed last night.

The government's reply to Secretary Stimson's note will be forwarded to Washington late next week, possibly after the arrival of Ken-ichi Yoshizawa, former Japanese representative at the League of Nations council, who has been appointed foreign minister in the cabinet of his father-in-law, Premier Inukai, M. Yoshizawa is on his way from Paris.

Meanwhile, the foreign office has decided the Stimson note is a formal communication and requires a reply, but the position is being taken that the American secretary of state actually did not invoke the nine power pact, but simply reminded Japan of her obligations under it.

Officials said that after further consideration of the note they determined it contains nothing startling and no threat of drastic measures. It was interpreted as being along much the same lines as the Wilson-Bryan notes of 1915 and the note of 1921 regarding Sashalen, that is to say, "a matter of record."

London, Jan. 9.—(AP)—Great Britain is not following the lead of the United States in invoking the nine-power act in Manchuria, a foreign office statement said today.

While the British government stands by the policy of the open

door for international trade in Manchuria, the statement said, it has not considered it necessary to present any formal note to Japan, since that country recently reiterated its adherence to the open door policy.

The foreign office communique follows: "His Majesty's government stands by the policy of the 'open door' for international trade in Manchuria which was guaranteed by the nine-power treaty signed at Washington.

"Since recent events in Manchuria the Japanese representative at the Council of the League of Nations has stated that Japan was the champion in Manchuria of the equal opportunity and the open door for economic activities of all nations.

"Further, the Japanese prime minister has stated that Japan would adhere to the open door policy and would welcome foreign participation and cooperation in Manchurian enterprises.

"In view of this statement, His Majesty's government have not considered it necessary to address any formal note to the Japanese government on the lines of the American government's note, but the Japanese ambassador has been requested to obtain confirmation of this assurance from his government."
