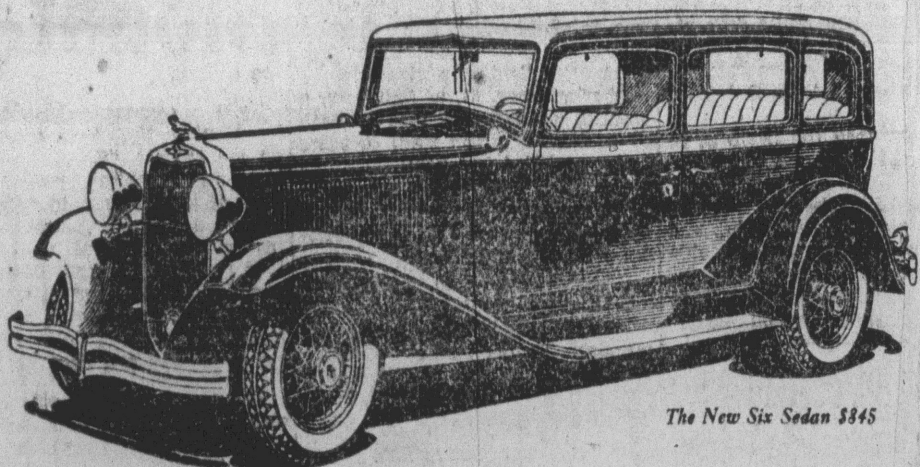

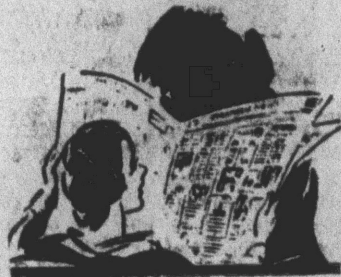

## Prohibit Use Of Short Measure Gasoline Pump

Raleigh, Jan. 11.—(AP)—C. D. Baucom, in charge of the weights and measures division of the State Department of Agriculture, said today that sale of a certain type of gasoline pump which was found to be putting one quart of air in every five gallons of gasoline it measured had been prohibited in North Carolina.

Mr. Baucom declined to reveal the name of the manufacturer of the measuring instrument, saying that he understood the manufacturer was taking steps of remedy the fault.

The pump fixed the gasoline so that it held the air for 10 minutes, allowing the motorist to drive a number of miles before he could possibly know he had been short-measured, Mr. Baucom said.

## Albemarle Man Buried Today

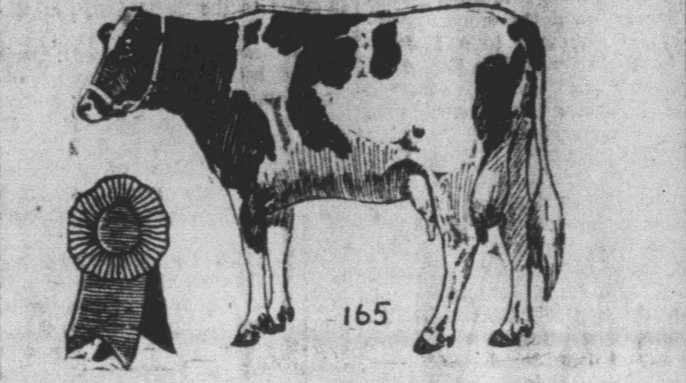

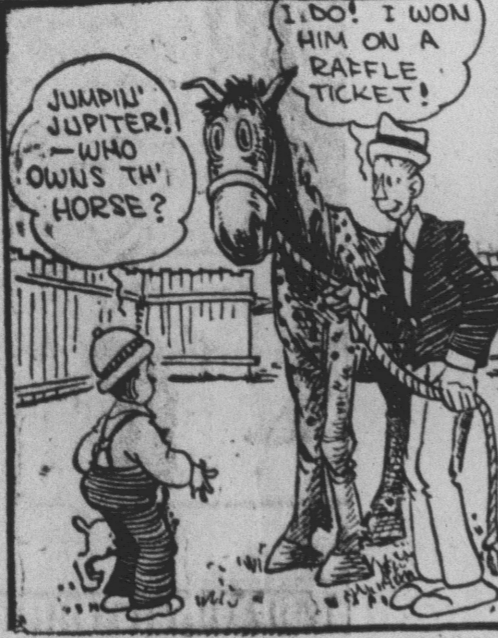

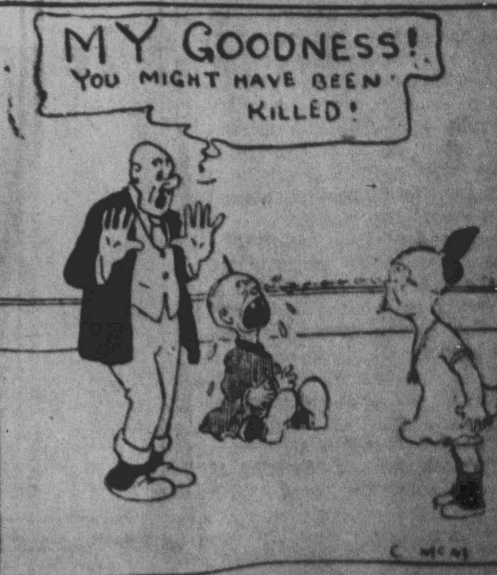

## ABOUT TOWN

Nine persons were killed on the highways of this patrol district during the month of December, it was made known in the monthly report of Lester Jones, patrol lieutenant, the latter part of last week.

In addition, thirty-two persons suffered injuries both of a minor and serious nature. The department handled a total of 1,725 violations and quite a number of the defendants paid fines or either went to the roads to atone for their crimes.

The death toll was the largest reported in this district during the life of the highway patrol, and should bring automobile drivers to a realization of the dangers which confronted them while on the highways. It should also inspire people to drive more carefully, and in that way do their bit toward reducing the toll of injury and death.

The Highway Department, through an intensive educational campaign, is trying to impress upon the people the necessity for complete observance of highway traffic regulations, hoping in this way to reduce the careless waste of life and property.

The loss in this district alone is sufficiently appalling to cause the public to give more careful consideration to their driving and the movement to curtail the heavy toll of life.

A series of simultaneous services will be conducted by various churches of the city during the week of March 20 to 27, in preparation for the Easter season, and the public will be called on to attend and do their bit by the movement to increase interest in the spiritual life of the city.

The services will be conducted under auspices of the Ministerial Association, an organization that has done much in past years to bring to the attention of the people the importance of more complete support of the church and the great mission it serves.

Simultaneous services have become a custom among city churches each spring, and that much good has been derived from them is not to be questioned. They tend to prepare the people for that important season—Easter—when all the Christian world pays tribute to the risen Christ. The services are launched in a wonderful cause and it should be the duty of an appreciative people to fully support them.

City schools received additional recognition from the State Department of Education the latter part of last week when they were notified that they led all cities of equal size in reduction of retarded children in all grades.

In addition to this Superintendent J. H. Rose<sup>2</sup> was notified that the school had again been placed on the list of accredited schools by the Southern Association of Schools and Colleges.

For the last two years the schools have enjoyed the highest scholastic rating of any school in the state, this record being established with a much lower financial rating than some of the other towns of similar size.

Added to this, the girls' basketball team captured the title of the Northeastern Athletic conference, an honor that lifted the school to a much higher position in the athletic circles of the section.

The schools here, like all other institutions of the state, have been hard hit by reduction of appropriations resulting from passage of the State six-month school law, but the faculty is undaunted, and has started out to do its best to maintain the high ranking it has been accorded by the highest educational authorities of the state.

Superintendent Rose and faculty members are to be congratulated upon the last two honors and it is unnecessary to say the public will do all they can to further the work of the schools.

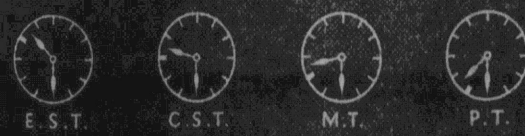

## MITCHELL INSTRUCTED TO BEGIN PROBE OF DISORDER IN HONOLULU TERRITORY

(Continued from Page One) without opposition and without debate. Bingham in offering the resolution said he did so "on account of the very bad news received yesterday from Honolulu." The resolution requested the attorney general to report to the Senate upon the administration and enforcement of the criminal laws by the police, courts and officers. It also asked the attorney general to state whether any changes in the original act governing the island are necessary.

Washington, Jan. 11.—(AP)—Senate investigation of the disturbances in Hawaii was asked in a resolution introduced today by Senator McKellar, Democrat, Tenn. This action was taken after Admiral William V. Pratt, chief of naval operations, had promised a House committee to give it all the information the navy had on the disturbances resulting from attacks on women. McKellar offered his resolution without comment and after consultation with Chairman Hale of the naval committee. He asked appointment of a committee of five to inquiry particular-

ly into the "recent acts of crime committed in Honolulu." The resolution called attention to newspaper accounts of the incident arising out of the arrest of Lieut. Thomas Massie and Mrs. Granville Fortescue on a charge of murdering a native. The resolution asked inquiry into: The character and efficiency of all executive officials from the governor down. "The recent acts of crime committed in Honolulu and in the territory and the attitude of the executive officials of the law in reference to said crimes. "The attitude of the people of Hawaii toward the navy and its personnel."

In his resolution McKellar said it is apparent that "many revolting crimes have recently been committed in Honolulu and no real efforts have been made by authorities to punish such crimes." An investigation along the lines suggested by Senator McKellar would be welcomed by Delegate Houston of Hawaii. At the same time, the territorial representative in Congress said today he is considering protesting against the attitude of naval officials, although deploring the attack by five natives on the young wife of Lieutenant Massie. Houston said the five men who attacked Mrs. Massie were "all plain gangsters." He added, the wife of the naval lieutenant went walking alone late at night in a region frequented by "bootleggers, gangsters and other lawless elements," when she was attacked. Houston said it was not wise for a woman to walk alone in the region where Mrs. Massie was captured by the natives. Houston expressed confidence Governor Judd of the islands could handle the matter, adding "I am opposed to the navy taking over the situation, for it could do no better."

The delegate said "we feel that the moral plane is decidedly high among the Hawaiians and young Japanese." He blamed the "gangster conditions" as a reflection of motion pictures and "of incidents that occur on the mainland. He termed the entire affair a "horrible mess."

**PRESIDENTIAL ASPIRANTS EXPECTED TO SWING IN TO ACTION THIS WEEK**  
presidential primary to be filed before January 22. This is to be used by friends of Franklin D. Roosevelt to formally launch his Democratic quest for nomination. Under its aegis also there may be at last the awaited decision of Senator Hiram Johnson of California to run or not to run against President Hoover in the Republican nominating campaign. Upon his decision rests largely the possibility of an open campaign against the Hoover renomination. Johnson is under pressure to run.

It comes not only from the western independents but also from regulars who are opposed to the President. The big figures among the independents have declined to get in on their own, some holding out to back a third party movement later if they think it needed. North Dakota may not furnish a test of strength between Roosevelt and that other active contestant, Governor Ritchie of Maryland, but Pennsylvania probably will. Both forces are headed for filing in the primary there, the Rooseveltians also pointing for the March primary in New Hampshire.

In the backwash of the Democratic National Committee session last Saturday, Washington's political students see one thing clearly: a definite break between the supporters of Roosevelt and the Smith-Rockeb wing. If they see correctly and if Alfred E. Smith does stand out against the nomination of his successor as governor of New York, things are expected to be harder for Roosevelt. Whether Smith enters the campaign on his own account or not his influence is counted important.

Meanwhile plenty of Democrats are talking other names: Newton D. Baker, James A. Reed, James M. Cox, and Governor Murray of Oklahoma, among them.

## GRAIN MARKET

New York, Jan. 11.—(AP)—Railroad issues provided steam for a further advance in the stock market today.

Prices backed up a little in the first half hour, in continuation of the reaction late Saturday, but soon pushed forward again, as buying came into the carriers. The advance coincided with preliminary meetings of railroad labor heads in Chicago, preparatory to wage negotiations. Trading was dull during the morning, but accelerated on the advance after midday.

Union Pacific pushed up more than 5 points, and issues advancing 2 to 4 included Santa Fe, Southern Pacific, Chesapeake and Ohio, New York Central, Northern Pacific, Rock Island, Baltimore and Ohio, New Haven, Pere Marquette and others. American Telephone advanced 2 points, and Allied Chemical rose 3. Motion pictures were well bought, Radio-Keith rising 3 points, and Warner Bros. 1. Coppers were firm. U. S. Steel sagged more than 2 points in the first half hour, but regained its loss.

The sag in the market in the initial dealings was attributed in part to U. S. Steel's monthly unfilled report which appeared at the close of Saturday's market. The shrinkage of 196,538 tons, to the smallest total in 11 years, was unpleasantly surprising.

While automobile buying of steel is slow in materializing, the comment of leading executives of the motor industry in connection with the New York automobile show indicated a fairly general feeling that 1932 would improve upon the poor showing of 1931.

## STOCK MARKET

Chicago, Jan. 11.—(AP)—Late bulges in grain values resulted today from stock market rallies and from 1,183,000 bushels decrease of the United States wheat visible supply.

The visible supply decrease contrasted with an increase of 1,774,000 bushels at this time last year. Primary domestic receipts of wheat continued to be surprisingly small, and this circumstance more than offset dearth of export demand.

Wheat closed firm 3-8-11-8 up, corn 1-4-1-2 up, oats unchanged to 3-8 advance, and provisions unchanged to a rise of 5 cents.
