LONG SWORN IN AS MEMBER OF CONGRESS

Stormy Louisiana Governor Administered Oath By Senator Robinson

Washington, Jan. 25.—(AP)—Huey P. Long was sworn in today as senator from Louisiana. By taking oath as Senator Long, a Democrat, discharged his title as governor of Louisiana, renewing the dispute over that office. Under normal procedure, Long would have taken his oath as senator last December but preferred to remain at the head of the state government until after the primary by which his successor was chosen. Long's seating brought the Senate membership up to its full quota of 96 for the first time this session.

Contrary to Senate custom, Long was escorted to the rostrum for his oath by Senator Robinson, Democratic leader, instead of his colleague, Senator Broussard. Long and Broussard are bitter political enemies. The new senator had said earlier today he would seek the defeat of Broussard in re-election. It was the second time this session that a new senator has been escorted by some one other than his colleague. Senator Neely, Democrat of West Va., refused to be accompanied by Senator Hatfield, Republican of the same state. As Long was administered the oath his wife and a dozen friends and state officials watched from the gallery.

After shaking hands with Senator Robinson and Colonel Edward P. Thayer, secretary of the Senate, upon receiving the oath, Long went down and picked up the cigar he had left at his desk and moved back to his rear row seat.

Senator Stephens, Democrat of Mississippi, who has been ill, also returned to the Senate today, giving the Democrats their full strength of 47 members for the first time this session.

Jeanerette, La., Jan. 25.—(AP)—Informed that Huey P. Long took his oath in the United States Senate today, Paul N. Cyr, claimant to the Louisiana governorship, said he would have no comment to make until he consults his attorneys.

Previously, Cyr had said he would start a movement to claim the governorship as soon as Long took the oath and replace Alvin O. King, who assumed the duties of acting governor today.

Auto Accidents On Decline Here

No automobile accidents of any consequence were reported in Pitt County over the week-end. Lester Jones, lieutenant of the division Highway Patrol, stated this morning.

Of course, there were the usual number of minor smashups, but no body was injured and cars were damaged only slightly.

No serious accidents have been reported in this immediate territory since the holidays, although several have occurred in other parts of the division, the lieutenant said.

Few Arrests Here During Week-end

Violation of the law was at a minimum in Greenville and Pitt County during Saturday and Sunday and officers were able to rest from their labors more completely than any time since the holidays, although there are other quiet week-ends on record since that time.

No arrests of any importance were made in any section of the county, Sheriff Whitehurst said this morning, and Greenville police reported only a minor number here.

The criminal element has been peculiarly silent for the last several months, and about the only thing the officers have had to deal with were charges of larceny, robbery and drunkenness.

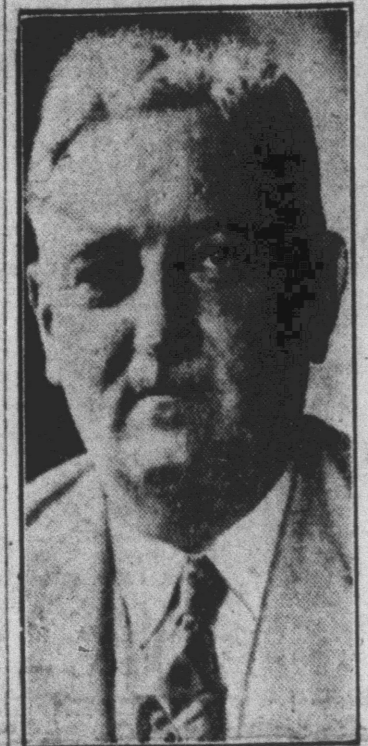

TARIFF BILL HEARING ENDS

Senate Finance Committee Concludes Work But Defers Vote Until Thursday

Washington, Jan. 25.—(AP)—The Senate finance committee today concluded hearings on the House Democratic tariff bill, but deferred a vote until Thursday.

Indications were the measure would be favorably reported with some modifications. The Democrats hope to win a vote or two from the Republican independents on the committee to get the bill to the Senate.

The bill would take away the President's power to proclaim increases and decreases in duties under the flexible provision after tariff commission inquiry. It would restore this power to Congress and if Congress did not reject within 60 days a commission report would take effect.

This 60-day limitation is regarded by Democrats on the finance committee as unconstitutional. They hold it would give the tariff commission rate making power which is reserved to Congress alone under the constitution. The clause was placed in the House bill at the suggestion of Rep. LaGuardia, Republican of New York.

Raleigh Paper Adopts Open-Shop Policy

Raleigh, Jan. 25.—(AP)—The Raleigh Times today changed its composing room policy to an open-shop basis and "locked out" 20 union printers.

John A. Park, the paper's publisher, personally notified the union men when they came to work of the change in policy and the printers refused to start the day. Only non-union men will be employed hereafter, he said.

The action stopped negotiations between the publisher and the local union in regard to a 10 per cent salary cut ordered into effect Saturday. Several months ago the working hours of the union men, who were paid on an hourly basis, were shortened one hour a day in lieu of a 10 per cent cut ordered at that time.

SEABURY HITS AT TAMMANY

Issues 50,000 Word Arraignment of Political Organization

New York, Jan. 25.—Before the New York legislature, which will decide this week whether its investigation of the City of New York is to continue, Samuel Seabury today laid down a 50,000-word written arraignment of the practices of Tammany Hall.

Seabury in his report urges a complete reorganization of the city's government along non-political lines to raise it from "the low and sordid estate to which it has sunk."

He advocated the removal of the police and health departments and the public schools from "political influences," observes there are unnecessary and overlapping departments in the city government, and a large number of employees who should be eliminated, and suggests the possibility of obliterating lines between borough and county governments and some system of proportional representation and preferential voting within the city.

After reviewing at length the testimony against various city officials and Tammany leaders, Seabury observes:

"It is perfectly apparent that what these men did is part of the system in which Tammany Hall exists and expands; that Tammany Hall approves it and is ready to extend its arm to the utmost to protect and perpetuate its sordid traffic in political influence."

Of Mayor Walker, in a discussion of the missing Russell T. Sherwood, he says, "the mayor of the City of New York has not by a single public utterance or act made any attempt to induce the fugitive agent to return."

WOULD TAX BOOTLEGGERS

Plan Also Submitted for Tax on Speakeasies to Cut Federal Deficit

Washington, Jan. 25.—(AP)—Bootleggers and speakeasy operators would be assessed a 25 per cent tax on their gross receipts under a plan submitted today to the House ways and means committee to balance the nation's budget.

The recommendation was made by Joseph J. Klein of New York, associate professor of taxation, College of the City of New York, and a member of a firm of certified public accountants. He made the recommendation personally, he said.

"Regardless of our views of the virtues of prohibition," he said, "it is a source of almost universal chagrin that the profits of the bootlegger and the speakeasy operator appear to be immune from taxation."

"While I have in mind specifically the speakeasy and bootlegging, I suppose that any effort to tax those engaged in this traffic must at least appear to be a general endeavor to tax all sources of income unlawful under the federal statutes such as, in addition to those mentioned, trafficking in narcotics, white slavery, etc."

"I should like to see a special excise tax on the gross receipts from the sources I have in mind, in lieu of the ordinary income tax, but in addition to all criminal penalties (fines and imprisonments) provided by law.

"I suggest that a flat tax of at least 25 per cent be imposed on the entire gross receipts from all sources of the person or organization engaged in such unlawful practices, and that the levy be retroactive to at least 1930."

Grace Perkins Begins Story in Daily Reflector

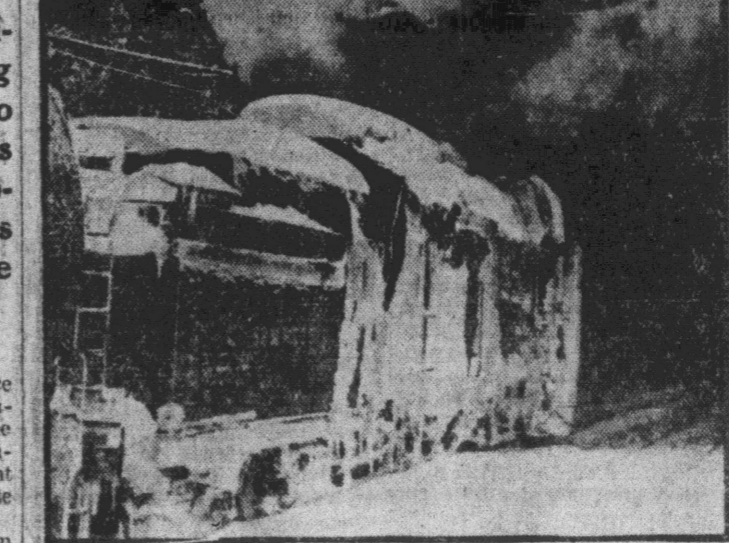

HIGHER TAXES FACE SOLONS CUT INTERIOR SUPPLY BILL

Democrats Plan to Tap Rich Revenue Sources to Relieve National Deficit

Washington, Jan. 25.—(AP)—New and higher taxation, designed to attain in combination with stringent economy, a balanced budget once again, becomes this week the issue of paramount importance in Congress.

Removal of the Reconstruction Corporation from the foreground of the legislative scene, caused concentrated attention to swing to this question, which will affect directly and indirectly every pocket-book, and should have a vital bearing on the speed with which economic recovery is obtained.

A taxation plan, substantially amended from the program offered by the treasury, is promised in the House within a week or so. Even before hearings are ended by the ways and means committee, the leaders of the controlling Democratic side are indicating an intention to tap rich sources of revenue left alone by the administration as alternative to some of the taxes recommended. For instance, electric power production has been suggested as a likely field for levies.

Committee Slashes \$6,273,000 Trimmed by Democratic- Controlled Body

Washington, Jan. 25.—(AP)—A sharply-trimmed interior department supply bill was reported today to the House by its watchful Democratic-controlled appropriations committee.

Carrying out Chairman Byrnes' policy of pruning government recommendations where possible, the committee slashed \$6,273,000 off the budget estimates and allowed the department \$50,431,000 for its numerous activities in the coming fiscal year. This is \$18,911,000 below the appropriations for the current year.

The permanent and indefinite appropriations, which are made automatically by previous enactments, total \$13,921,000 as compared with \$15,952,000 for this year.

In this bill, the agriculture department measure still under consideration in the House, and the first deficiency bill, now in conference, the appropriations committee has shaved a total of \$31,000,000 from the budget estimates. In none has it deviated from its policy of not increasing a single appropriation above a budget estimate or adding a single new item. (Continued on page four)

Two Southerners Named By President To Serve On Relief Organization

LONG BOOSTS REP. GARNER TO NAME THIRD MEMBER SOON

Harvey C. Couch of Arkansas and Jesse Jones of Texas Made Members of Board to Direct Two Billion Dollar Stroke in Behalf of Business; Corporation Await Formalities Before Beginning Work

Washington, Jan. 25.—(AP)—Two southerners were named today to the board that will direct a two billion dollar injection to quicken the pulse of business.

Harvey C. Couch of Arkansas and Jesse H. Jones of Texas were appointed by President Hoover as two of the three Democratic directors of the reconstruction finance corporation. The third short time will be named in a very short time.

Quick confirmation of the nominations is expected of the Senate, along with that of Charles Gable Daves—named to be president of the corporation.

Only these formalities and the passage by the Senate of the measure appropriating \$500,000,000 are necessary to set the corporation ready to function financially.

The other directors are Eugene Meyer, governor of the Federal Reserve Board, Paul Bestor, farm loan commissioner, and secretary Mellon.

Couch, a prominent financier residing in Pine Bluff, is well known in the capital through his connection with various industrial and other activities.

He was especially active in connection with the last Democratic National Convention held in his home city—Houston.

The recommendations of Democratic congressional leaders had a large part in guiding the selection. Speaker Garner is a Texan and Senator Robinson, party floor leader, hails from Arkansas.

White House officials said today, shortly after the president named Couch and Jones, that the Chief Executive now is interested primarily in legislation designed to relieve depositors in closed banks. At the same time, he is very much intent on continued reduction in governmental expenses to strengthen the treasury's position.

Two bills for the relief of depositors in closed banks already have advanced in the congressional machine. One, sponsored by Senator Glass (D. Va.), calls for a revision of the banking system and provides for a liquidating corporation. Senator Thomas (R. Idaho), has introduced a bill sponsored by the president for the creation of a \$150,000,000 organization, with power to expand itself up to \$700,000,000.

Workers are cleaning, painting and patching up space in the old department of commerce building for the Reconstruction Corporation. This probably will be completed this week, after which furniture will be moved in.

Mr. Daves continues active toward the actual making of loans. Within a fortnight the money is expected to be started on its way for aid of business and industry.

Mr. Couch began his business appointment of Angus W. McLean, former governor of North Carolina, as a director of the Reconstruction Corporation, faded into a remote possibility as President Hoover announced the names of two Southern democrats to serve on the board.

McLean had been prominently mentioned as a possible member of the board practically ever since Congress passed the reconstruction measure.

The North Carolinian was endorsed by Governor Gardner, of his home state, the National Grange, and his state's Congressional delegation.

It was pointed out by political observers that President Hoover would not be likely to select three Southern Democrats. The prediction was made that the third Democrat would come from the Northwest.

Despite this however, McLean's friends did not discontinue their active support in his behalf.

(Continued from page one) posts as gestures of protest against the government's repudiation of their forceful policies regarding Japan.

A conference between the Japanese consul general and the mayors of the Chinese cities led to a temporary truce which served for the moment at least to keep 1,700 Japanese marines out of the international settlement, the French concession and Chinese territory.

The league council re-convened in Geneva to take up the Manchurian issue where it left off last month but the proffered resignation of Secretary-General Sir Eric Drummond delayed its deliberations.

A government spokesman in Tokyo let it be understood that the international settlement in Shanghai would be the first to feel the tread of Japanese marines if Chinese authorities did not capitulate to ultimatums demanding dissolution of anti-Japanese organizations.

The war office announced that a number of heavily armed Japanese units would soon be withdrawn from Manchuria in view of the withdrawal of all Chinese regulars below the great wall.

Shanghai, Jan. 25.—(AP)—The threatened occupation of Shanghai by Japanese marines was temporarily averted today as a result of a two-hour conference between the Japanese consul general and the mayor of the Chinese city.

Mayor Wu Teh-Chen informed Consul General Murali that in view of the seriousness of the Japanese demands calling for dissolution of anti-Japanese societies, he could not give a reply at present.

While not breaking off the negotiations, M. Murali told the mayor that the Chinese would be held responsible for any incidents occurring while an answer was being drafted and said he would request further instructions from Tokyo.

Apprehensions were increased by the presence of 500 additional Japanese marines who landed on Chinese soil Saturday from the cruiser Ol. They are equipped with a full complement of rifles, machine guns and ammunitions and increased to 1,700 the number of Japanese forces available for occupation purposes.

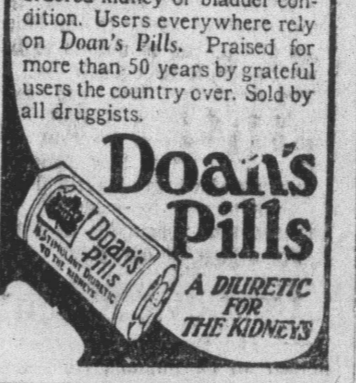

(Continued from page one) Congressional leaders, attach to the other side of the budget-balancing picture—government economy—has been revealed meanwhile in striking fashion through a totally unprecedented move to ascertain in advance the amount of expenditures which will be voted by the present Congress.

Speaker Garner and Floor Leader Rainey for the Democrats, and Minority Leader Snell for the Republicans, addressed to each committee letters asking a report on the money bills it expected to present.

This action was taken in the face of a pile of bills introduced running well above the ten thousand mark, and calling all totaled for billions of public expenditure. The letters stated directly that the aim was to hold off every expenditure not absolutely essential.

ABOUT TOWN

The largest poultry sales in history were reported in Pitt county for the month of January and hundreds of dollars found their way in the pockets of Pitt county producers. The sales were promoted by the County Mutual Exchange, assisting the Farm Department and the results were not only gratifying to officers of the exchange but to growers generally. The producers, it was said, realized six cents more per pound for their offerings than if they had selling does, whether in farming been sold on the streets. This goes to show what organization selling does, whether in farming or any other line of industry. The Exchange, organized only a few months ago, is already showing indications of achievement, and if given proper support by the farmers it should become a vital factor in improving the economic life of the community.

NO MANY people appreciate what policemen are doing for the protection of their life and property, but the fire in Farmville last Friday night brought the people of that town face to face with what proper police protection means to them. Bandits intending to rob the postoffice, started the fire to draw attention from the center of their operations. But thanks to a police man making his rounds, a partly open postoffice door was found in time to prevent the robbers carrying out the purpose.

Suppose that policemen had been in some other part of town? Instead of suffering the \$6,000 fire loss, the postoffice department probably would have been robbed of a considerable amount of money.

It is impossible to estimate the value of an active police department to a community, and when we hear of things like that at Farmville we are impressed with the splendid service which representatives of the law are rendering.

The wets have discovered that the preponderance of dry power in the Senate makes it impossible for them to gain ground during the present session and no doubt will call off their dogs until they get a better representation in Congress.

It was rather discouraging to opponents of the dry law to have their first effort to get a bill thru the Senate asking governors to submit repeal or modification to the people of their states. But being unmistakably wet, they will continue hammering away on the issue until they have accomplished something.

The country has heard more of prohibition the last year than it has heard since enactment of the Eighteenth Amendment and people are getting tired of the wrangle. This does not include the wets, of course, who will continue to talk light wits and beer until they are convinced all of their argument is in vain.

Josephus Daniels told Georgia people he "had no desire to become Governor of North Carolina," but that assertion will not prevent Pitt county people from trying to draft him.

Due notice to this effect was served upon the Raleigh editor by a delegation from Pitt county about a month ago, and they mean to continue hammering away until Mr. Daniels has definitely made up his mind.

He told the delegation that he would make known his decision when he had made up his mind whether he could accept, and action is expected sometime in the near future.

Mr. Daniels is the foremost leader of public thought in the State at this time, and it is believed he would be able to steer the craft of state back to normalcy better than any man available. At least that is the way the people in this section think about it and if he decides to run he will be assured of hearty support from hundreds of people in this section

NOTED CHINESE LEADER QUILTS

Sux Fo Resigns Because Government Refuses Action Against Japan

Shanghai, China, Jan. 25.—(AP)—Sun Fo, president of the executive Yuan, which is a post corresponding to that of Premier of China, resigned today because the government declined to accept his policy of vigorous action against Japan.

Eugene Chen, who resigned earlier in the day as foreign minister, said tonight when he got here from Nanking that he had quit for similar reasons and that "the policy of non-resistance toward Japan was sponsored by Chiang Kai-Shek who is responsible for the present tangled situation."

The government which Sun Fo headed was formed in December with Lin Sen as president. It was made up principally of leaders of the Canton faction, and succeeded the regime headed by Chiang Kai-Shek.

It got into trouble immediately. The Manchurian situation grew worse after its inauguration and the followers of Chiang withheld their support.

It was freely predicted that the government could not last and Chiang Kai-Shek was recalled from retirement. He represents a policy of peaceful settlement with Japan.

A total of \$21,758,000 was allowed, exclusive of tribal funds, a decrease of \$3,231,000 below the current year and \$404,500 less than the budget estimates. The appropriation of \$2,476,780 from the tribal funds, held by the treasury, was recommended. This is \$799,000 less than the current outlay and \$70,000 below the budget.

Long got out of bed to talk with newspapermen and was clad in pink pajamas as he discussed the political situation and national affairs. He pledged cooperation with the president to restore world tranquility and prosperity, and indicated he would favor cancellation of war debts if necessary to achieve that end.

JUDGE CRAMMER RAPS LAW VIOLATORS IN COURT HERE

(Continued from Page One) Carrying his denunciation of the violations of the prohibition law to the bench itself, Judge Cramer, probably one of the best known and

most popular jurists in this part of the country, declared that a judge who drinks should either resign or quit drinking. He said he would do that himself, and any other judge following such practice should do likewise.

He also gave considerable attention to other violations of the law, and urged the grand jurors to keep their eyes open at all times and to attempt to render a high type of service to the community.

Referring to infractions of traffic laws, he brought a severe indictment against the "road hog," declaring that type of person not only capable of taking more than his share of the highways, but of literally taking money out of a man's pocket or resorting to other crimes of a similar nature.

People who take more than their share of the road are not to be trusted, he said, and constitute a menace to the thousands of motorists driving over the highways of the nation.

He scored the different forms of gambling to be found existing in various sections of the country, and described this as just another way of taking unfair advantage of people.

He called attention of the grand jury to guanoans and justices of the peace, and asked them to investigate the reports on file at the courthouse and report to him any persons who have been negligent in the filing of reports as required by law.

A. D. McLawhern is foreman of the grand jury which will serve for the customary period of six months. Other members are A. M. Wooten, J. H. Mills, J. H. Boney, Jasper Taylor, Roy W. Moore, J. O. Ed-

New Orleans, La., Jan. 25.—(AP)—The war of the governors is on again in Louisiana.

Governor Huey P. Long's departure for Washington and his seat in the Senate has left the arena to two men—one his friend and the other his foe—and armed guards today patrolled the capital against invasion by the enemy.

The foe, Paul N. Cyr, the elected Lieutenant-Governor, announced readiness to take up the battle he left off when the Supreme Court decided against him in his attempt to oust Long and take his job on grounds Long could not be

both governor and a senator-elect. Meanwhile, the friend, Alvin O. King, the president pro tempore of the Senate, whom Long appointed Lieutenant-Governor on the contention Cyr's action in taking the governor's oath in his ouster proceeding, held him his elected job, held him acting governor.

Long said Cyr had named himself to the daisy field, and named King his gubernatorial opponent Saturday night when he rode to Washington to become Sen. Long.

Now when Long takes the Senate oath, King expects to take the governor's oath but Cyr says he will never do it.

King has answered Cyr's threats with squads of husky highway policemen with six shooters strapped to their hips, standing on guard in the state capitol at Baton Rouge.

"I'll take care of the highway policemen or else they'll take care of me," Cyr said defiantly at his home at Jeanerette, in Southern Louisiana. "I think a few funerals in this State would help out a lot. I just hope the right persons are in the funerals and I think the people of Louisiana feel the same way.

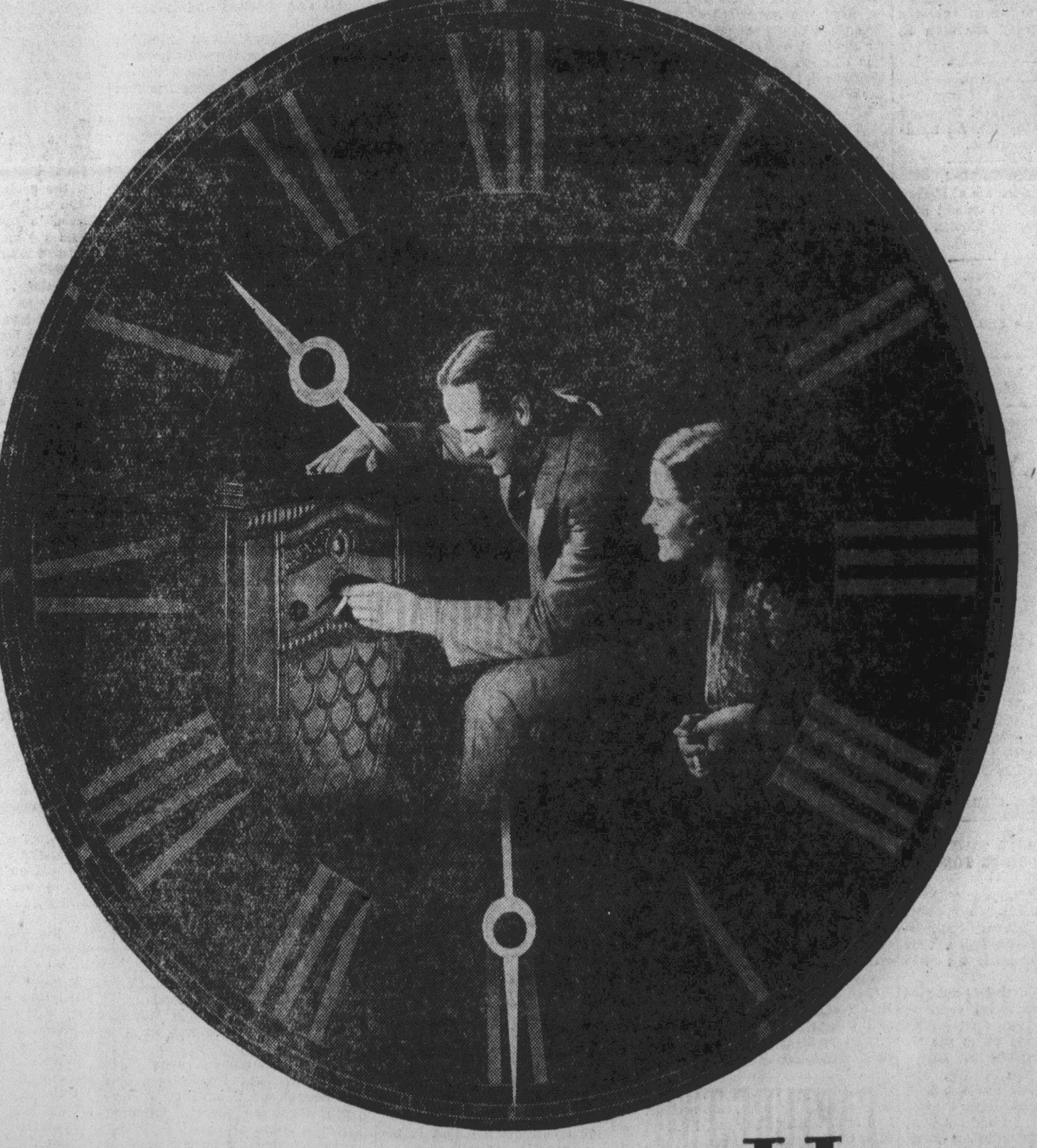
"I am waiting to see what that fellow does in Washington. There will be plenty of excitement as soon as Huey Long takes the oath as senator. I am acting governor if not governor."
