RELIEF BODY NOMINATIONS CONFIRMED

Senate Banking Committee Passes On Dawes, Jones and Crouch as Directors.

Washington, Jan. 27.—(AP)—President Hoover today signed the \$900,000,000 appropriation measure to provide the capital for the emergency construction finance

Washington, Jan. 27.—(AP)—The Senate banking committee today reported favorably the nominations of Charles G. Dawes, Jesse H. Jones, and Harvey C. Crouch to be directors of the reconstruction corporation.

Chairman Norbeck said the nominations probably would lie over a day and come up for Senate confirmation tomorrow.

Meanwhile a forecast that President Hoover will turn to the far west for the third Democratic director of the corporation was made by Senator George.

After a conference with the Chief Executive concerning the lone remaining appointment to the board the Georgian said that although he felt the choice of a man from the southeast is not entirely out of consideration, he was "definitely disposed to think the president will go west for his choice."

George had recommended several men for the post, none of whom he named.

Earlier Representative Tilson (R., Conn.) conferred with the Chief Executive about what he described as "general legislative affairs" including the activities of the \$2,000,000,000 credit organization.

In the Senate committee, a Democratic proposal that confirmation of Dawes, Jones and Crouch be held up until the president has submitted the name of the fourth director, who must be a Democrat, was voted down.

Durham Gangster To Be Executed On Next Friday

Raleigh, Jan. 27.—(AP)—Bennie Griffin, who was described during his trial in Orange county as "Durham's toughest gangster," is scheduled to be electrocuted Friday for the murder of Iver Trice, Orange county blockader.

Tyre C. Taylor, executive counsel, was investigating the case today before making a report to the governor as to whether clemency should be extended.

Griffin was first sentenced to die August 14 but appeals to the Supreme court and Superior court have caused postponements of his execution.

He was convicted of shooting Trice instead of paying him for a delivery of whiskey. He was also charged with two other killings, those of Katherine Mangum and Henry Smith, aged negro cafe proprietor.

Tablet is Dedicated Acknowledging Gift Dr. Laughinghouse

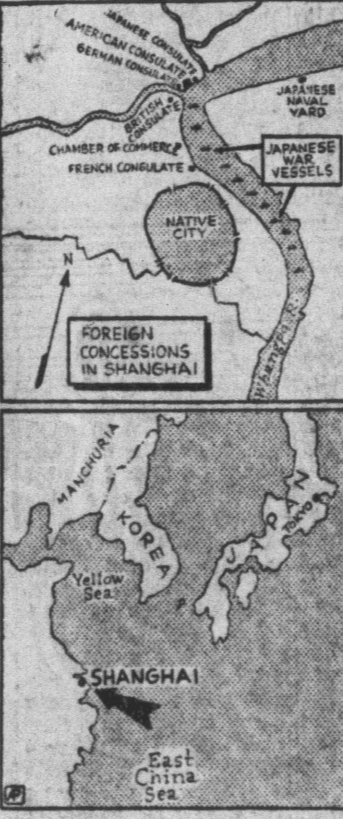

SAYS DEFECTS LEFT IN AKRON OF GLASS BILL

Washington, Jan. 27.—(AP)—The House naval committee was told today that an investigation of the materials used in the Akron which two men had charged were faulty led to the dismissal of the men and that many defects were left in the airship.

E. C. Davidson, of Mount Ida, Virginia, general secretary of the International Association of Machinists, related the story after Rear Admiral William A. Moffett, chief of the Naval Bureau of Aeronautics had said the Akron was far superior to any other airship ever built.

Davidson said reports that defective materials had been used in the ship were brought to him in March, 1931, by W. B. Underwood, of Madisonville, Tenn., and a reserve officer, Lieutenant Colonel E. C. McDonald, of Washington.

Underwood, he testified, was a workman on the Akron while Colonel McDonald was in command.

Gar Wood Claims World Speed Record At Miami

Miami Beach, Fla., Jan. 27.—(AP)—Striking his Miss America IX across placid waters of Indian Creek at an average speed of 110.78 miles an hour today, Gar Wood exceeded by a scant half mile an hour the world's speedboat record of 110.223 miles an hour held by Kave Don of England.

Wood's speed was obtained by averaging his time for north and south-bound runs over the measured nautical mile course. His first run was clocked by electric timing devices at 111.08 miles, with an elapsed time of 37.32 seconds for the 6,000 foot mile. The second run was at a rate of 110.49 miles with an elapsed time of 37.52 seconds.

BRITAIN ALSO TAKES ACTION

INDICT FOUR IN HONOLULU

Mrs. Fortescue And 4 Naval Men Face Second Degree Murder Charge.

Honolulu, Jan. 27.—(AP)—Second degree murder indictments had been returned by the grand jury today against Mrs. Granville Fortescue and three naval men, charging them with slaying Joseph Kahahawai, suspected assassin of Mrs. Fortescue's daughter.

The indictment was returned only after Circuit Judge A. M. Cristy once refused to accept the jury's proffered report and raised the question of anarchy.

The defense immediately seized upon the grand jury's apparent unwillingness to return an indictment.

INDIANA MAN IS KIDNAPPED

Manufacturer is Held for \$25,000 Ransom Following Abduction by Two Men.

South Bend, Ind., Jan. 27.—(AP)—Howard Woolverton, 52, local manufacturer and son of a South Bend bank president, was held for \$50,000 ransom today by two men who kidnaped him while he was on his way home from a theatre last night.

Mrs. Florence Woolverton, 49, abducted with her husband but released two miles from the city, was given a note containing directions for leaving the money in a package on a designated road and setting tonight as the deadline for delivery of the ransom.

She remained at the Woolverton home with her daughter today under protection of a police guard, and in the care of friends. She described one of the kidnapers as a well dressed man, 30 to 35 years old, but said she had no opportunity to view the other one.

Mrs. Woolverton told officers that before they released her, the men made certain of her husband's identity, and asked him if his father, Jacob Woolverton, is president of the St. Joseph's Savings Bank. This fact admitted, she said, the men drove away with Woolverton.

The farmer would cut his cotton crop like grass and sell the whole plant, boll, leaves and stalk—everything except the roots—to be converted into cellulose.

Admiralty Announces No Communication Has Been Received Following Disappearance of Vessel in Dive off Portland Yesterday; Relatives Notified that Men are Missing and Believed to have Perished.

Portland, Eng., Jan. 27.—(AP)—Hope of saving the 56 men in the submarine M-2 which sank off Portland yesterday dissolved with the fading day.

The wives of the crew, most of them watching operations of the salvage vessels from the docks, received telegrams from the commander of the submarine's mother ship, the Dolphin, that he feared the men were lost.

Even the women who had borne up most bravely gave way to despair at this.

A statement from an admiralty official late this evening said hope had not been given entirely up but that chances of a rescue were growing more slender with each hour.

"Everything depends on whether the ship is damaged and has filled up," he said, "if she is not damaged there still ought to be enough air to keep the men alive."

A check of the personnel list tonight indicated that there might have been more men aboard than was thought, including two members of the Royal Air Force in charge of the small seaplane submarine officer and fifty-three men.

With more than half of the 48 hours the men might be expected to live in the sunken ship elapsed since it dived yesterday and failed to appear again, the word of reassurance had come from efforts to establish contacts and efforts were spurred to reach the ship before the sweeping tides of the channel could carry it out to deep water.

The workers were not even encouraged by a certainty that the object they detected on the channel floor was the submarine. All of last night destroyers, mine-sweepers and other naval vessels swarmed around the place of hope, and played their searchlights upon it, while arrangements were rused to send divers down.

All the rescuers knew what that there was something on the bottom there that gave forth a metallic ring when it was struck by drags. On this evidence the navy pinned what faith it had in a rescue.

Along the shore, a crowd strained anxious eyes watching the circles of flickering lights three miles out on Dead Mans Bay. Wives, mothers and sweethearts of the submarine's crew, most of whom live here or at Plymouth, were among the watchers.

The submarine went down at 10:30 a. m., yesterday, during routine practice exercises. The M-2 is a sister ship of the M-1 which was lost in November, 1925, off Start Point, Devonshire, with a toll of 68 lives. It has been popular in the Navy as a "fine diving ship" since it was built in 1920. It carried a small airplane in a water-tight hangar.

An official at the headquarters of the naval commander-in-chief at Portsmouth said the last message reported from the M-2 was at 10:01 a. m. when she reported she was about to begin exercises which would include diving.

POLICE GUARD AGAINST BOMB PLOT IN ALABAMA

Montgomery, Ala., Jan. 27.—(AP)—A heavy guard patrolled Alabama's historic capitol today following a report of a plot to bomb the governor and three other state officials.

The detail, composed of more than a dozen plain clothesmen from the Montgomery police department and Kilby prison, was stationed in the building yesterday after State Auditor John Brandon turned a letter describing the purported plot over to Governor B. M. Miller.

None would comment officially but a state official who wishes his name withheld, explained the letter to the auditor was sent by a Birmingham man who wrote he had overheard four men plotting the bombing in a depot.

Governor Miller, Attorney General Thomas E. Knight Jr., and members of the State Supreme Court have recently received numerous threatening communications demanding "immediate release" of eight negroes sentenced to die from Scottsboro, Ala., for an attack on two white girls.

The governor also received similar letters following the lashing of a war veteran prisoner at the Atmore farm for refusing to work.

(Continued from Page One) Only about a fourth of the venire was exhausted in the selection of the jury composed entirely of Pitt county men, and the case got away to a quick start after this work had been dispensed with.

Three witnesses were put on the stand by the state prior to recess at the noon hour. They were Sheriff Whitehurst, Mrs. Hagan Hodges, and Roy Rollins, cousin of

the defendant. Sheriff Whitehurst, said Myers confessed the robbery and shooting immediately after his arrest Saturday week, and re-enacted the crime. He gave a resume of the negro's confession and the investigation leading up to his capture.

Mrs. Hodges identified a flashlight and keys found in Myers' possession as those of her husband. Rollins told of Myers having visited his home in the Pactolus community the night the robbery and shooting was reported.

There were four or five other witnesses to be put on by the state during the afternoon, after which it was understood the defense would introduce testimony from three or four persons.

J. C. Lanier was appointed by the court to represent Myers and the state was represented by Solicitor D. M. Clark, assisted by J. B. James. The jury is composed of Tom Heath, J. A. Jones, Richard Cannon, O. H. Wilson, E. W. Braxton, G. M. Shirley, Joseph Palmer, J. D. Stokes, Charlie Summerell, Glenwood Cox, J. B. Jolly, Allen Tugwell.

Hodges was fatally shot Saturday night over two weeks ago while leaving his store for home. He died in a Washington hospital four days later, although his injuries at first were not considered serious.

Sheriff Whitehurst said Myers admitted entering Hodges' store and asking to see a pair of shoes. After inspecting the shoes displayed by Hodges, left the store and went down a pathway midway between the store and Hodges' home.

As Hodges came along, the negro told the sheriff he ordered him to throw up his hands, that he wanted money. He said he fired five times at Hodges, one bullet taking effect in the shoulder, obtained \$10 in cash and fled.

He had previously stolen an automobile, it was revealed in the investigation and left it a short distance down the road. The car refused to run and was abandoned. Myers returned to Greenville and was arrested at the home of a relative a week later. He was also said to have admitted two hold-ups to a night watchman here, taking a pistol each time. It was with the first pistol that Hodges was shot.

CELLULOSE COTTON HOLDS OUT RELIEF FOR FARMERS

(Continued from Page One) ingham, North Carolina to learn the comparative cost of a cellulose and a cotton crop.

As a result Dr. Cameron said it is expected this year to raise "cellulose" cotton on a 10 acre patch at a cost of two cents a pound, compared with five cents for cotton. Five thousand pounds an acre are predicted.

Aside from the great variety of profitable articles into which cellulose is converted, the bigger returns to planters are expected to come from the cotton stalk—now all wasted, and the hibernating place of the boll weevil. This stalk, say the North Carolina chemist, is 40 per cent pure cellulose. The cotton boll is 90 per cent cellulose.

Late in the afternoon Japanese consular officials said a representative of Mayor Wu Teh-Chen called at the consulate and stated unofficially that a reply would be issued accepting the Japanese demands in their entirety.

At the same time, however, it was learned that Japanese authorities today began to evacuate their nationals from nearby places in the Yangtze Valley.

The force of American marines

numbers about 1,200 and has been here since 1927 when Chiang Kai-Shek's Nationalist northern drive menaced Shanghai. The British have a similar force.

The United States troops began to erect barbed wire entanglements along the boundaries of the settlement during the afternoon. British and American authorities emphasized, however, that the action was "purely precautionary."

The Chinese forces showed a determined attitude to bottled up the city, and began open efforts to meet a possible invasion. They established military patrols outside the city in a long line entirely surrounding both the foreign and Chinese areas. The line began on the southwest at the garrison headquarters on the Wangpoo river, five miles outside the city limits continuing in a northeasterly direction west of the city and terminating at Woosung where the Wangpoo empties into the Yangtze, enveloping Shanghai between the line of troops and Wangpoo.

The number of troops was not accurately known. Estimates ran from 6,000 to 15,000, but 10,000 was considered more nearly correct.

Authorities of the foreign settlement recommended that foreigners keep away from the roadways where the Chinese troops were patrolling and to stay within the settlement boundaries, feeling such restriction was desirable to prevent possible incidents such as the killing of Albert Forges, American express manager, last Sunday.

A peculiar problem of command arose in the settlement as authorities considered turning the control over to the marines. A mutual agreement places the command in such cases in the hands of the senior foreign defense officer, who at the present time is the Japanese Admiral Shiosawa.

Settlement authorities considered his disqualified, however, because of his concern in the dispute, and hope was expressed that it would be possible to bring Admiral D. W. Taylor, commander of the United States Asiatic squadron from Manila, or Admiral Kelly, commander of the British Asiatic fleet from Hongkong, either of whom is senior to Admiral Shiosawa, and 'hus solve the problem.

Barbed wire entanglements and sandbag barricades were erected throughout the afternoon by the Chinese, along the fifteen miles of their line, and a few patches of trenches were dug.

"In the opinions of these two men the defects were so covered up that the navy investigators could not find them. The investigation, so they say, was not complete and many defects were left in the ship."

Josephus Daniels, Raleigh editor, believes that nomination by the Democrats of a progressive like Franklin D. Roosevelt will mean success for the party. This statement was made by the North Carolina man at Atlanta, Ga., where he has been confined the last several days from injuries received in an automobile wreck.

As he is one of the leaders of the party, what Mr. Daniels has to say on the subject of the presidential race, will be received with interest not alone in this state, but in many other parts of the country where he is well known and admired for his position on national and world issues.

Others are of the same opinion as Mr. Daniels. They believe that a progressive program backed by a man capable of carrying it out will be a big boost for the party and drive the Republicans from office during one of the most critical periods in the nation's history.

Roosevelt seems to be the progressive the party is turning its eyes toward, and the June convention no doubt will result in his nomination.

In less than three weeks after the holdup and fatal shooting of Hagan Hodges, Pactolus storekeeper and postmaster, his assailant is facing trial in criminal court here.

Due to the activity of sheriff's officers, the man charged with the crime was rounded up and placed in jail in ten days after the robbery and shooting. This shows how quickly the law works in spite of those who try to escape from its tolls.

Pitt county officers have been constantly on the alert for the apprehension of criminals over a period of many years, but it is probable the detection and arrest of the principal in the Pactolus case is the most quickly executed in the annals of law enforcement, especially where there was an element of mystery attached to the case.

Officers in charge of the investigation of this case are to be congratulated upon their perseverance. They have rendered the community a greater service, one that should play its part in discouraging crime in the years to come.

Fred Pugh, negro "flew high" a few days after robbing a safe in a store in the Ayden community, but he is on his way to Raleigh at this time to spend two-and-a-half years in State's prison to pay for the crime.

The negro was the ringleader in the jail break here about a month ago, escaping himself and aiding four other to gain their liberty. His freedom was short, however, for he was hounded until caught following robbery of the Ayden safe.

It is the same old story connected with all cases of a similar kind. One may get by with crime for a short while, but the time comes when he must answer to the law for wrongdoing. Pugh will have plenty of time to think over his case and will in all probability be a different kind of citizen when he completes his term.

The death of Eddie Stinson in Illinois brings to an end one of the most colorful careers in aviation in this country.

He was known as one of the greatest stunt fliers of his day, and had been in only one accident for 23 years. His was a record of progress all along the way and his sudden death found him in the midst of development of an airplane that would have played a big part toward bringing the large cities of the nation in quicker touch with one another.

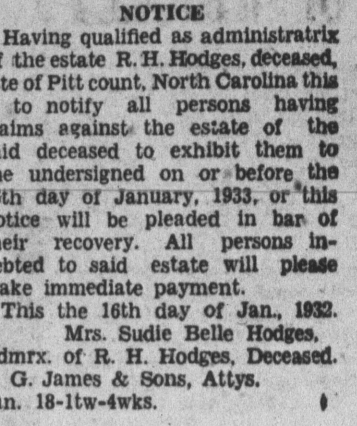

Wrigley was busy just before his fatal illness, planning ways and means of realizing his dream of seeing the Cubs win a world championship, and thus wipe out the memories—bitter ones to him—of the club's failure to win in 1928 and 1929, after conquering the National League.

From the time he became associated with major league baseball in 1915, Wrigley wanted a championship team, and nearly \$6,000,000 was poured into the club toward that purpose. Manager followed manager—Fred Mitchell, Johnny Evers, Bill Killifer, Rabbit Maranville, and George Gibson, until Joe McCarthy was brought up from the Louisville club of the American Association.

McCarthy delivered to the extent of steering the Cubs to the National League championship in 1929. This outfit won only one game from the Philadelphia Athletics, and after the team finished in second place in 1930, Rogers Hornsby became McCarthy's successor.

Wrigley personally had handled the deal which brought Hornsby to the Cubs from the Boston Braves, and it was the most stupendous deal in baseball history. Around \$250,000 in money and players were turned over to Judge Emil Fuchs, owner of the Braves in return for Hornsby's services.

Wrigley was interested in other sports, and became a stockholder in the Arlington Park Jockey club, but his real love was baseball.

Foster, a Madison, Ga., boy, is a junior at Vanderbilt and played end on the Commodore eleven last fall.

NEGRO IS GIVEN MIDDLE TITLE

By CHARLES M. BUNKLEY (Associated Press Sports Writer) Milwaukee, Jan. 27.—(AP)—William "Gorilla" Jones, long-armed 25 year old negro of Memphis, was recognized today by the National Boxing Association as middleweight champion of the world.

Jones won the title last night by defeating Oddone Piazza, sturdy youth of Milan, Italy, on a technical knockout in the sixth round of a scheduled 10-round battle, fought before a disappointed crowd of 3,500. It was the championship bout of an elimination tournament conducted under the auspices of the N. B. A. to determine a successor to Mickey Walker. He gave up the throne a year ago because he could no longer make the weight limit of 160 pounds.

The Memphis negro, backed with five years of campaigning, outclassed, out-boxed, and out-fought his 22 year old Italian aspirant. After a slow start, he battled Piazza to pulp and had him on the verge of collapse, when the bout was ended by the referee. Jones won every round, with the exception of the first.

The battle was a disappointment in gate receipts and attendance. It attracted less than \$5,500 into the box office, compared to the last time Mickey Walker defended his title, when his battle with Ace Hudkins, fought in Los Angeles in 1929, drew \$189,000. Walker was a spectator at the ringside.

Jones is the seventeenth holder of the title. Since the class was recognized in 1867, the division has produced 16 champions, among them the greatest fighters of all time, Walker, Stanley Ketchel, Tommy Ryan, Billy Papka, Mike O'Dowd, Bob Fitzsimmons, and Jack Dempsey, the non-pariel.

Chicago, Jan. 27.—(AP)—Grains scored advances today after receipt of advices indicating that steps were taken to abolish a peculiar method of handling wheat in Argentina.

This method was the "fugar price"—that is, a price to be fixed an indefinite time after the delivery of the grain, sometimes 8 months after. Under this system, the export of grain in Argentina was concentrated in the hands of a few large firms.

STOCK MARKET

New York, Jan. 27.—(AP)—Excessive optimism was dashed in the stock market today by the halving of U. S. Steel's dividend.

It was evident that the action was not particularly surprising, in the light of volume of selling, but a 4-point drop in the shares of the leading industrial imparted a heavy tone throughout the market, and losses of 1 to 3 points were numerous.

U. S. Steel's 4-point loss carried it under 38 to within a couple of points of the bear market low. American Telephone sagged more than 3, Bethlehem lost more than 2, touching a new low, under 17. Others off 2 to 3 included American Can, Eastman, Westinghouse, and Allied Chemical, while losses of a point or more were common, appearing in General Electric, Standard Oil of N. J., Woolworth, American Tobacco, B. Kenecott Consolidated Gas, and North American. Pennsylvania sold off 1 3/4, then recovered on announcement of the 50-cent dividend. Losses of a point or so were common in the rails after midday, although there was a temporary upturn in this group in the morning.

Call money was about steady at 2 1/2 per cent, but there was less demand for federal funds, which were quoted at 1 3/4 to 2 per cent off 1-2 of the per cent from yesterday.

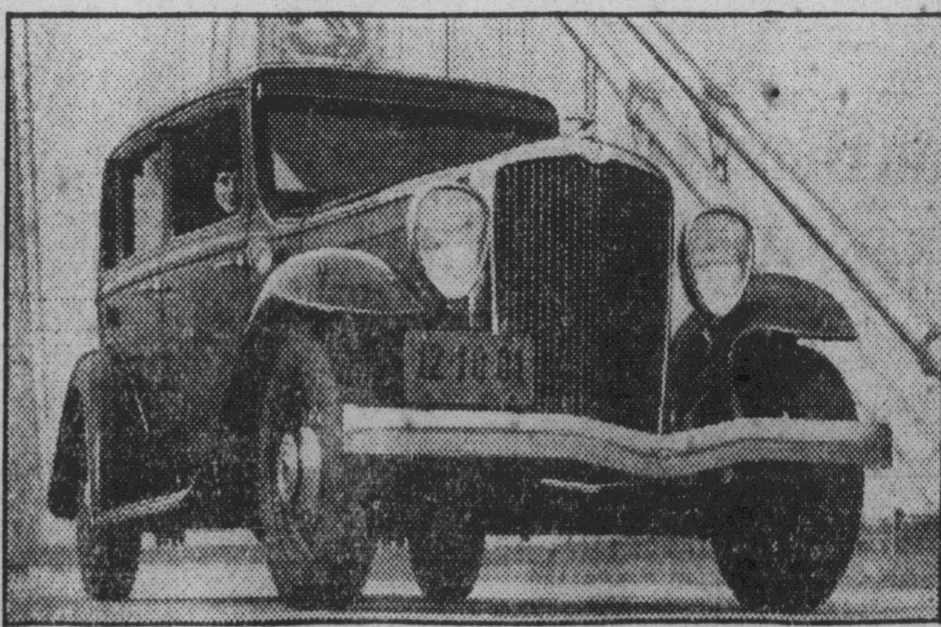
