America Sees Fight to Finish in Orient Japanese Troops Suffer Heavy Losses at Shanghai

Belligerents Must Settle Differences

U.S. GUARDING ITS NATIONALS

Officials Believe there is Little Good Powers Can Do to Stop War Between Japan and China; will Continue Presentations to Japan Against the Danger of Attacks on International Settlement.

Washington, Feb. 10.—(AP)—The opinion is growing in Washington that China and Japan must fight out their differences in the Shanghai area and reach a military decision before further peace overtures can well be made to Japan by foreign governments.

Through fourteen days of fighting the international peace plan and various attempted local truces have failed and there seems little chance that the United States, Great Britain and Italy can do but keep their presentations to Japan against the dangers to the international settlement and the French concession.

The latter which is somewhat protected from the shells from the Chapel fighting zone by the international settlement, has recently been much disturbed by shells, most of which were dud.

While it is clear the United States would not agree to demilitarization of the principal Chinese ports, a temporary establishment of a neutral zone about Shanghai to restore peace pending a permanent adjustment of differences might fall into a different category.

However, if such a plan as this was agreed to it would be stipulated that its character was only temporary and it should not constitute a precedent for dealing with other cities. Such a proposal has been discussed in truce plans.

The navy was informed today that another shift had been made in the destroyer force along the Yangtze river to provide additional protection to Americans and make evacuation easy if that becomes necessary.

The destroyer Smith Thompson has been ordered from Shanghai to the lower Yangtze, probably to stay eventually at Nanking.

Two other destroyers are stationed at Nanking. They are the Parrot and Simpson. They report that 61 Americans remain in that area which at present is quiet. More than 10, mostly women and children, already have been evacuated to Shanghai.

The destroyer Edsall has been ordered from Nanking 70 miles up the river to Wuhu. The Bulmer is stationed at Chienkiang, 30 miles below Nanking.

To Ask Congress for Approval of Warship Measure

Washington, Feb. 10.—(AP)—Chairman Vinson of the House naval committee said today Congress will be asked to approve his \$16,250,000 warship construction bill before the present session ends.

The measure, which would authorize 120 new vessels, already has been approved by the committee. A request for House action however, was delayed because of the depleted condition of the treasury.

MAY RENOUNCE SOVIET TREATY

London, Feb. 10.—(AP)—The British government is considering a renunciation of the trade treaty with Soviet Russia, made by the late Labor government, the Daily Mail said today, to stop the "dumping" of Russian goods on the home market.

The announcement would be made, the paper said, shortly after the return of Foreign Secretary Sir John Simon from the disarmament conference at Geneva. The British trade balance is imperiled under the present condition, it said, with imports of Russian goods exceeding British exports to Russia by nearly \$100,000,000 a year.

Besides, the Mail added, most British goods bought by Russia have been purchased on credit and Russia now owes Great Britain about \$200,000,000 while Russian goods have flooded the home market at prices sometimes 40 per cent below British prices.

The government is also preparing to introduce its wheat quota plan in the House of Commons and to explain to the farmers some points.

Julian Whichard Dies in California

A telegram received by R. D. Whichard of this city announced the death in Los Angeles, Calif., last Sunday morning of his brother, Julian D. Whichard, 40.

The deceased was born in Salisbury and made his home in Atlanta for a number of years. He is an ex-service man, having served overseas during the World War.

He is survived by his wife and two children; his father, J. R. Whichard; his sister, Mrs. Thomas E. Blaney, Atlanta, Ga., and a half-brother, W. D. Whichard, of Chevy Chase, Md.

Burley Market Claims World's Sales Record

Lexington, Ky., Feb. 9.—(AP)—Lexington today claimed again the title of "the world's largest looseleaf tobacco market," lost last year to Wilson, N. C. Sales on the burley market here this season have reached 86,777,335 pounds. Wilson's high record was 86,076,010 pounds.

VOTE BUYING DISCOUNTED

Report to Senate Elections Committee Has Facts on the Alabama Elections.

Washington, Feb. 10.—(AP)—Charges of vote buying and efforts by corporations to influence their employees were discounted today in a report to the Senate elections subcommittee considering the Heflin-Bankhead contest, but testimony on other law violations was stressed.

Chairman Hastings, in a report on the recent testimony taken for the committee in Alabama, cited charges of 50 varieties of law violation in the election of Senator Bankhead (D. Ala.), which is being contested by former Senator Heflin.

He said there seemed to be no dispute that voters were allowed to cast their ballots without appearing in person at the polling places, and reported the testimony showed it was the practice to pay the poll tax for others, though that is forbidden by law.

The report was based on evidence submitted to a commissioner for the committee by witnesses for the two contestants. It was submitted to attorneys for Heflin and Bankhead for their comment before being turned over to the committee.

Hastings said 14 witnesses had testified to the purchase of votes or the offer to purchase.

"I do not think," he said, however, "the testimony offered upon this point is sufficiently satisfactory to make it appear that the purchase of votes was carried on to such an extent as to seriously affect the election. There was no testimony connecting Mr. Bankhead with the purchase of votes."

Hastings said 17 witnesses testified that corporations had endeavored to influence votes of their employees, but he added he was "not greatly impressed with these charges."

Submit Last Proposals for World Disarmament

Geneva, Feb. 10.—(AP)—Foreign Minister Dino Grandi of Italy and Ambassador Tsuneo Matsudaira of Japan presented the last two of the disarmament proposals of the five great powers to the world conference today.

The young black-bearded Italian foreign minister, believed to be the youngest delegate to the conference, brought thunders of applause from the floor as he tolled off in staccato fashion, a long list of war implements Italy stands ready to scrap. The list included capital ships, submarines, aircraft carriers, heavy artillery, tanks, bombing aircraft and chemical warfare weapons.

He also proposed a revision of the laws of war to protect civilian populations. In international quarters afterward the Italian plan was hailed as the first proposal for "real disarmament."

"My country," he said, "happily supports all proposals calculated to make countries of bad faith shrink from the risk of aggression."

WAR BULLETINS

These were today's developments in the Far East: In an old-time cavalry charge, a Chinese squadron was reported to have inflicted heavy casualties in Chapel before being routed by machine gun fire.

The fighting in Chapel and Woosung subsided somewhat while the belligerents appeared to be shifting their lines, the Japanese bringing up new guns for the Woosung attack and the Chinese reinforcing their Woosung unit.

HEAVY GUNS ARE SILENT

Both Sides Shifting Lines and Nobody Knows what to Expect Yet; Action has Subsided at Woosung; Apprehension Increases in International Settlement; Foreign Units Built Additional Sandbag Barricades.

Shanghai, Thursday, Feb. 11.—(AP)—The guns of Chapel were silent early this morning but under cover of darkness armies were concentrating at Woosung and the apprehensive international settlement believed the Japanese were ready to start the big push.

Newcomers from Japan arriving late Wednesday night said the steamers had passed a dozen Japanese troopships loaded with officers. A private message in code received from Tokyo said two divisions—about 20,000 men—had embarked in closely-guarded secrecy.

It was known that some Japanese troops had been landed near the mouth of the Yangtze, ready to join the forces either at Woosung or at Hongkew, base of the Chinese operations.

It was learned also that the Chinese had shifted a strong force out of the Chapel trenches to back up the defense of Woosung. Heretofore there have been three or four lines of trenches fully manned behind the north station sector. Yesterday there were only two. The nearest support lines were half a mile to the rear.

As darkness fell last night trucks were hauling field pieces from the docks on the outskirts of Shanghai over to Woosung to reinforce the Japanese artillery.

Shanghai, Feb. 10.—(AP)—Teaching across No Man's Land in an old fashioned cavalry charge, a Chinese squadron was reported to have inflicted heavy casualties today on the Japanese who have been laying waste to Chapel with artillery.

It was an incident in a comparatively quiet day. The big guns were not firing and although machine guns were in action it was apparent that both sides were shifting their lines and no one knew what was going to happen next.

Over at Woosung, where the Japanese had been trying to blast the enemy hose from the forts at the Wangpo narrow, the action also had subsided somewhat late this afternoon.

Some time in the night the Chinese had hoisted their five-barred flag of red, yellow, blue, white and black. It was on the highest flagpole in town and the Japanese gunners were concentrating their fire on it.

Meanwhile the Chinese were reinforcing the trenches which had been battered by raking shell fire from war craft in the river and by airplane bombs.

The Japanese were working hard on a pontoon bridge across Woosung creek, but Chinese machine guns were not making their job any too easy.

Toward dusk a fleet of trucks backed up to the docks on the outskirts of Shanghai and assisted in the unloading of additional field guns which apparently were to be used against Woosung.

There were indications that part of the Chinese main force had been taken out of the Chapel lines and sent over to Woosung. Foreign observers found that only two lines of trenches were manned in the north sector where heretofore there have been three or four. The nearest Chinese support lines were half a mile to the rear.

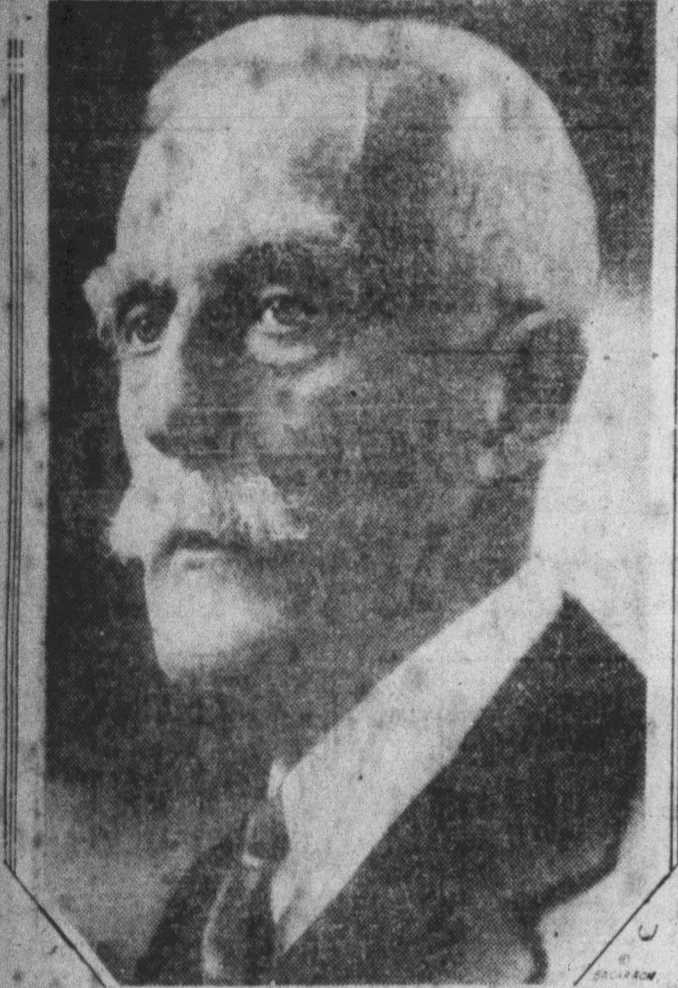
The speaker began by calling attention to the intellectual dignity of religious faith, and the value and utility of natural belief in every-day life. "There are," he said, "two modes of acquiring truth employed by every sane man in every department of his life and every field of knowledge, whether scientific, historical or religious. These two modes are belief and experience. Believing is accepting something as true because a reliable witness has said that it is true. Faith is accepting truth on the word and authority of another. If my witness is man my belief is human, if my witness is God my faith is divine.

Every man believes, one must believe if he is to live. Did you ever stop to realize how much of your every-day knowledge is taken on faith? The date of your birth you take on the word of another; all the facts of ancient history and most of your knowledge of current events you accept on the authority of teacher or writer. Your boy in school or college goes out for himself very few of the facts and principles of science. He relies on the authority of those who instruct and guide him. All this is belief for to accept the truth on the word of another is believing. The daily

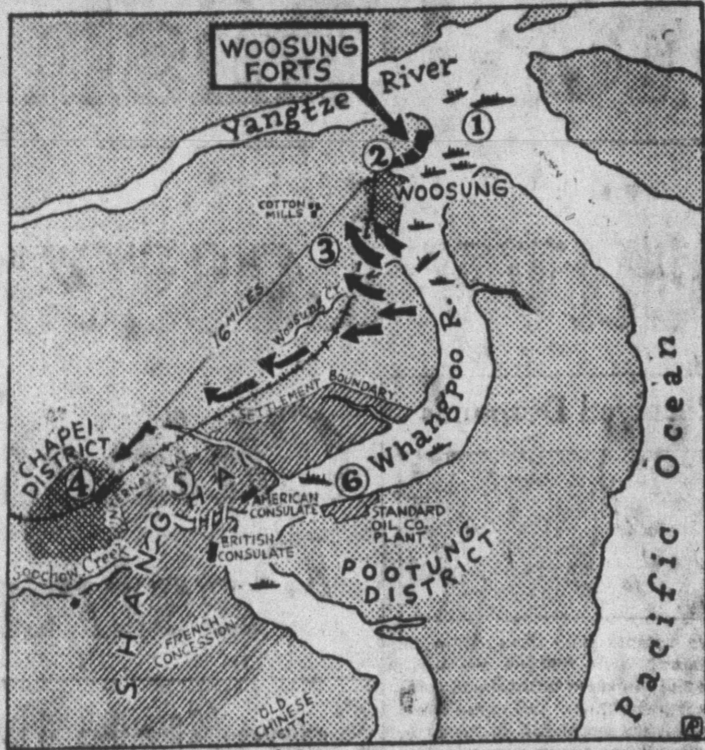

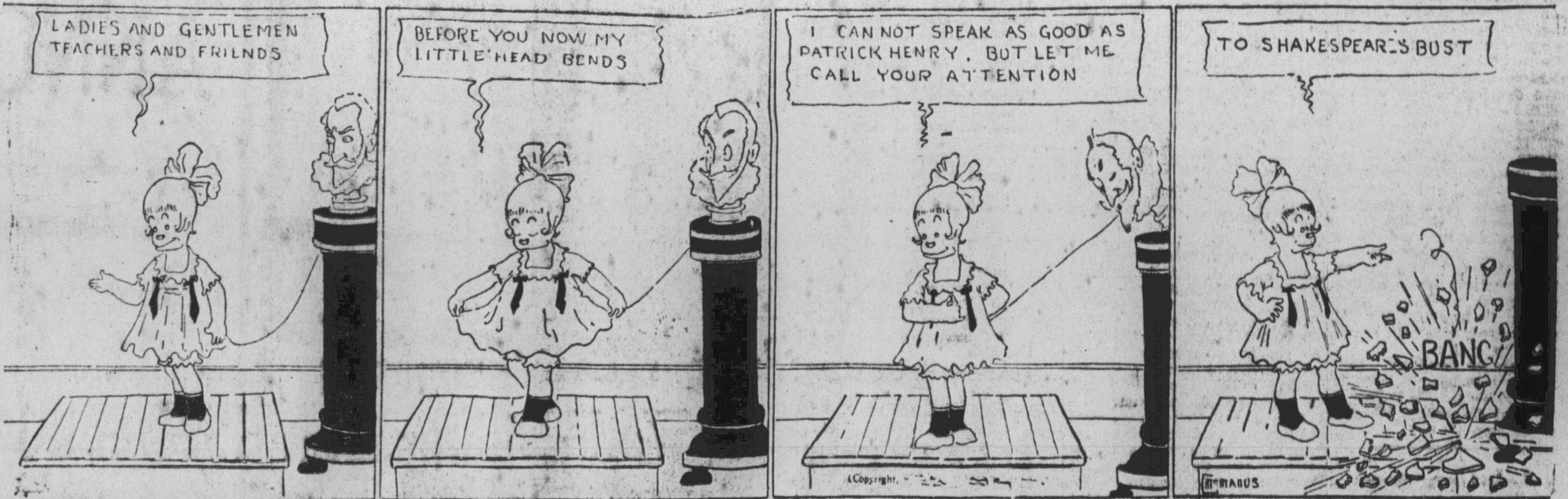

Many of the essential foods are omitted when they are not available in our pantries.

Keeping a canning budget is much more important when money is scarce than when money is plentiful.

It will enable us to eliminate expenses and save for improving home life.

Canning our surplus and budgeting can be made an agency in raising the standard of public health and help promote better living conditions on the farmers of Pitt county.—Mrs. Lonnie Stokes, Ayden.

life of men about us proves the necessity and validity of knowledge accepted on faith. Matters of life and death are decided by men who act on faith, that is on the testimony of others. The verdict of the jury and the sentence of the judge in the case of a man condemned to death by just process of law are both based on faith. Both judge and jury are guided by the testimony of witnesses. This is human belief.

"How foolish, therefore, the boast of the man who says, 'I will not act on faith, I must find out for myself.' If he lived up to his boast he would accept and know a precious little, for no man in the span of an ordinary human life can find out very much by his own unaided efforts. The fact is that our boaster lives by faith, and finds out for himself nothing more than the normal human being is accustomed to do. For the knowledge of things past he relies on the word of parent and teacher and historian; for the news of present happenings he depends on the report of friends and journals. He goes to his lawyer, his physician, his banker and his tradesman for information concerning the most vital matter of his life. He accepts their word, believes it, lives by it, despite his boast that he will not believe. He lives by faith, does business by faith, and is enriched and made happy by believing. It is no exaggeration to say without faith he could not live.

Here is another man who objects to faith because he says, 'I will not accept anything without a reason. I will not live by blind trust.' We reply, Amen, Brother, that is splendid Catholic doctrine taught by the church for about twenty centuries. Every man of genuine faith has a reason and a most cogent reason for his belief. The motive of faith is always the testimony of a witness. The belief of a jury rests on the word of witnesses whom they trust because they are convinced that the witness knows the facts in the case and tells the truth about them. When we have the report of a witness who knows the truth and tells the truth we cannot refuse to accept his word without doing violence to our own reason.

Divine Faith has God for its witness. The Catholics accept as his creed what Christ has taught because Christ cannot be deceived and can not deceive. His knowledge is infinite His veracity is divine. Our faith is, therefore, not blind trust but the accepting of truth on the word of Christ. We believe because God is our witness.

Speaking of religious indifference or the theory that it makes no difference what a man believes the missionary said, "the slogan that one belief is as good as another; it makes no difference what a man believes, is contrary to reason and the Scriptures and if carried into life it is destructive of both the Christian faith and morals. It is contrary to reason because it is equivalent to saying that error is as good as truth. Beliefs differ because one denies what another affirms; one says, yes and another says, no, in answer to the same question under the same respect. For this reason the difference between creeds means the difference between truth and error.

To illustrate that of two contradictory answers to the same question one must be erroneous, let us take the following example. You ask two boys, do two and two make four. One boy answers, yes, two and two make four. The other says no. It is plain the boy who says no is in error. Of this there can be no doubt.

Now instead of two boys we take two creeds. We ask is Christ God? One creed answers, Christ is God, the other creed says, no, Christ is not God. One answer and there fore on creed is in error. Since creeds so differ on such a number of the vital doctrines of Christian truth it is false to say that one is just as good as another. That creed is right and true which teaches all that Christ taught as he taught as he taught it. He prayed that his disciples all believe all that he taught, and that they be one as He and the Father are one. Therefore one is not free to reject Christ's creed that alone is true and good.

Baron Shidehara is Critically Sick

Tokyo, Feb. 10.—(AP)—Tragedy struck the remnant of a once powerful triumvirate of liberal Japanese statesmen, known as especial friends of the United States, twice in little more than 24 hours. It was learned today when physicians of Baron Kijuro Shidehara, former foreign minister, announced he was seriously ill as a result of a fainting spell and an attack of cerebral anemia Monday night.

Former Finance Minister Junnosuke Inouye, second member of the triumvirate, was assassinated last night. A third member was former Premier Yuko Hamaguchi, who died last August from the

effects of a would-be-assassin's bullet.

Baron Shidehara was recovering slowly today, the physicians said, but he was confined to his bed and is running a slight temperature as a result of a cold and bronchitis which followed the cerebral attack. He is 60 years old.

Shidehara, Inouye and Hamaguchi were the powers of the Hamaguchi cabinet which resigned following Premier Hamaguchi's death last August. Shidehara and Inouye continued over into the cabinet of Premier Reijro Wakatsuki government resigned last December when its policy for a milder procedure in China was criticized, as well as the conservative financial policies of Mr. Inouye.

He found the situation had been greatly exaggerated, and that while the food supply was greatly diminished, there was no indication of starvation. Pictures were taken of the game and these were shown last night.

Pictures dealing with prominent sportsmen in action were also exhibited, as well as the general condition of the game situation throughout the territory.

The pictures proved highly informative and indicated the fine work being done by the department in the preservation of game.

TUNNEY WILL NOT RETURN TO THE RING

By ALAN GOULD (Associated Press Sports Writer) New York, Feb. 10.—(AP)—The boys who have been building up the pleasant fiction that Gene Tunney contemplates a fighting come-back may just as well knock down the structure of their imagination.

On the authority of Tunney himself, the former world champion has never had and will not entertain now the slightest idea of returning to the ring.

"When I retired from the ring, I mean it," he told me today. I reminded him of stories that had been printed and recently repeated, predicting that circumstances might dictate otherwise, or that he might yield to some pressure.

"Yes, I know all about that," he replied, "and of course I cannot stop anyone from making a suggestion in the newspapers as to what I may or may not do. Nor do I take them seriously.

"The way I feel now is that I have my own life to lead and work out. I have my private interests. I am happy in what I am doing. I enjoyed writing my life story, yet I am surprised that so much interest is shown in it.

"I still am keenly interested in boxing and always will be. Why not? It was a big part of my life; but what a fool I would be to think of attempting a come-back."

But Jack Dempsey, it was suggested, appeared to be contemplating one.

"Yes, and you know, I hate to think of it," replied the man who twice whipped the great man mauler.

"We all like to think of Dempsey at his best, as a great champion. The reputation he made means something. It means more, I think, than the risk of being beaten now by men he would have whipped easily in his prime. He was beginning to slow up, four or five years ago, and it would be just that much harder for him now to come back.

"Carnera, with that remarkable left and his size, would be difficult for Dempsey to beat. Schmeling, improving as rapidly as he has, would have the advantage of youth and ruggedness. I do not think Sharkey would go down so easily again in a bout with the former champion."

"You know," Gene added, "Dempsey did not want a third fight with me. When Tex Richard proposed it, Jack in effect asked: 'What and take a chance of being punched blind?' No thanks."

SHOUSE FOR FREE HAND

Favors Party Convention Pledged in Advance to any Candidate.

Washington, Feb. 10.—(AP)—Jouett Shouse, chairman of the Democratic national committee, favors a party convention unpledged in advance to any candidate, free to make its choice on the basis of conditions at the time it is held.

He disclosed this view in a statement to the Associated Press, made public today. In it he directly denied having combined with former Governor Smith and Chairman Raskob to block the nomination of Franklin D. Roosevelt. Complete impartiality, he insisted, has been maintained both by himself and the national party headquarters.

Raskob, in New York, yesterday issued a similar declaration of neutrality.

Shouse was asked his intentions in the light of widespread discussion which has followed the declaration of Smith regarding his availability as a candidate. Shouse made no reference to the Smith statement.

This same statement caused the Louisville Courier-Journal to undertake a poll of Democratic national committeemen and women.

Replies received by it up to now accounted for about two dozen of the more than hundred members

of the committee. Coming from all parts of the country they ranged from: "I do not consider Governor Smith a contender" to "His statements make him a candidate." In this partial list was no outspoken support for Smith, while several of the replies confirmed expected stands for Roosevelt, particularly in the far west and south. Some, on the other hand foresaw the chance of a compromise candidate, with the Texas committeeman, Jed C. Adams, of Dallas, declaring: "The situation seems to make the nomination of John N. Garner, the logical selection."

Among the states from which one or both of the committee men were Vermont, Georgia, Montana, Nebraska, New Hampshire, Oregon, and Washington. Many of the committeemen voiced personal admiration for Smith.

Shouse revealed he intends to retire from party management after the convention, which will be held June 27, and that he has no intention of accepting public office thereafter.

He said he had been consulted as to particular candidacies by Democrats all over the country, but had invariably advised it would be wiser "from the standpoint of party and country alike" not to instruct delegates for anyone except where primary laws of the states made it necessary.

Stevens Regains World's Record at Lake Placid

Olympic Bob Run, Lake Placid, N. Y., Feb. 10.—(AP)—Hubert Stevens, of Lake Placid, twice smashed the world record for two man bobs to catch Ryo Capadrut, sensational young Swiss, in the final two heats of the Olympic competition today and retain for the United States the title Jack Heaton won at St. Moritz in 1928.

Going into the final day 4.28 second behind Capadrut, Stevens turned in two almost unbelievably perfect runs of 1:59.69 and 1:57.68, both times smashing the record of 2:03.52 Capadrut set on his first run today. His final total time for the four heats of the competition was 8 minutes, 14.74 seconds. Capadrut finished his last run in 1:59.67 to take second place, 1.54 seconds behind Stevens.

STOCK MARKET

New York, Feb. 10.—(AP)—The stock market met support today in the same area where the decline was checked in early January.

The turn came after several issues had registered new lows in the early dealings, and was accomplished with a run in of short in Union Pacific, in advance of tomorrow's dividend meeting. Trade News was on the whole still rather gloomy, but Washington news to the effect that Senator Glass' bill to revise federal reserve act was being altered met with a favorable reception in some quarters in Wall Street.

Union Pacific pushed up more than 3 points. Auburn fully recovered an early drop of nearly 4 points, which reduced it to 91 1/2, in contrast to last week's high of 137 3/4. Morning losses of 1 to 2 points in prominent issues were generally erased, and net gains of similar extent appeared during the afternoon in such issues as U. S. Steel, American Can, American Telephone, Eastman, Westinghouse, Case, Dupont, Consolidate Gas and New Haven.

The market's ability to rally after price averages had approximated the bear market low of Jan. 5 was regarded as encouraging by market theorists who would have regarded inability of the market to hold at the January resistance levels as indicating that the major trend was still downward. The rally, however, appeared largely dependent upon short covering for its motive power.

The drop of 87,203 tons in U. S. Steel's unfilled tonnage during January, reducing the total to the lowest in more than a score of years had been fully anticipated, and was without appreciable market influence.

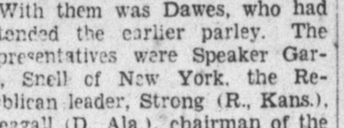
