Japs Launch New Offensive Against Chinese

Spain Presents Views For Abolition Of War At World Arms Confab

WOULD CUT AIR SERVICE

Luis Zulueta, Foreign Minister, Proposes Total Abolition of Military Aviation and Internationalization of Civil Aviation; Joins Other Nations for Outlawing All Arms of Aggressive Nature

Geneva, Feb. 12.—(AP)—China appealed today for a special meeting of the League of Nations assembly to consider its charges against Japan.

Dr. W. W. Yen, head of the delegation, got his request in just under the line for today is the last day on which it could have been filed. The league regulations provide that such a request must be presented within two weeks of the time at which the problem under consideration is submitted to the league council.

It appeared likely, however, that the assembly would not be called for several days and meanwhile the twelve neutral members of the council met to consider the new development.

Dr. Yen declined to discuss the move but it was learned the Chinese delegation had experienced some difference of opinion particularly with regard to the wording of the request.

Geneva, Feb. 12.—(AP)—Luis Zulueta, foreign minister of Spain, proposed total abolition of military aviation and internationalization of civil aviation to the world disarmament conference today, in an address outlining Spain's suggestions.

He also joined the spokesmen of the great powers in urging the outlawing of all arms of an aggressive nature. He asked the conference to amend the draft convention setting out the procedure of the conference by inserting a provision for the limitation of war materials in stock and for publicity for war materials acquired.

The Spanish government, he said, recommends limitation of new war vessels to 10,000 tons, with eight inch guns as the maximum, and the limitation of submarines to 1,000 tons.

The conference, he said, should adopt a treaty for control of international traffic in arms and a treaty for international and national control of private and state manufacture of arms and munitions.

Foreign Minister Edvard Benes of Czechoslovakia accepted the proposals made by M. Andre Tardieu of France last week and endorsed the draft convention as the basis of the conference work.

"We must determine not to separate finally," he said, "until we have signed the first convention for limitation and reduction of armaments."

P. Munch, Danish foreign minister, proposed that equality of armaments between victor and vanquished nations be reached by gradual disarmament and budgetary limitation. He advocated total prohibition of offensive weapons and an armed international police force under the League of Nations.

SEE SLASHING CUT OF COTTON

Substantial Price Increase Foreseen in Case History Repeats Itself

Atlanta, Ga., Feb. 12.—(AP)—There will be no reduction of cotton acreage by law this year, but if history repeats itself there still may be a substantial decrease in acreage and production and an attractive advance in price.

Records of the Department of Agriculture and the New Orleans Cotton Exchange for the past 40 years show that 13 "bumper" crops of cotton have been produced; nine during years of depression; two just before or at the beginning of a depression, and only two in normal times.

The records also show that every large crop produced during a period of depression was followed by a sharp reduction in acreage, a comparatively small crop and a large advance in price. Some of the big crops were followed by a series of small ones and very high prices.

WAR BULLETINS

Loyang, China, Feb. 12.—(AP)—The Chinese government decided today to "continue its present firm attitude toward the Sino-Japanese dispute, especially as regards Shanghai" and also to reject Japanese proposals for demilitarization of the principal ports.

Shanghai, Feb. 12.—(AP)—Japanese authorities threatened this afternoon to take strong measures in Nantao and South Shanghai in retaliation for alleged sniping by Chinese at the Japanese war vessels on the Nantao water front. The population became panicky and began a hasty exodus to the countryside. Should fighting occur at Nantao the international settlement would be encircled on all sides by a battle area.

Tokyo, Feb. 12.—(AP)—The Japanese foreign office denied today that Katsui Dehuchi, Ambassador to the United States had been instructed to return from Washington and also that any decision had been made to send special envoys to the United States Great Britain (Continued on page six)

Robbers Work Hard and Get Slight Return

Rockingham, Feb. 12.—(AP)—Thieves sneaked into the Seaboard Air Line Railway during the small hours of the night with intent to rob.

POSTMASTERS GO ON STAND

Tell of Receiving Notices of Payments on Party Pledges in Foster Case

Greensboro, Feb. 12.—(AP)—Postmasters, called as government witnesses in the trial of W. H. Foster, treasurer of the North Carolina Republican Executive Committee, for violation of the corrupt practices act, told today of receiving notices at their offices that payments were due on their party pledges.

Foster is alleged to have solicited donations for the party from federal office holders in a federal building. In similar cases, the court have held such solicitation is not a violation of the law unless done in a federal building where the employes work.

Ed S. Cox, postmaster at West End, related that Foster called on him and he signed the pledge card in front of the post office. He received a notice that payment was due on July 15, 1931, in the post-office, he said, and opened and read it.

He said he received other similar notices and upon cross-examination insisted he received and read the notices in the postoffice. Walter Hogan, postmaster at Ellerbe, gave similar testimony. He said he signed a pledge card on June 1, 1930, agreeing to pay \$2.50 per month, and received various notices that payments were due on the pledge. (Continued on page six)

U. S. HONORS ABEL LINCOLN

Pres. Hoover to Lead Nation-Wide Observance of Birthday Tonight

Washington, Feb. 12.—(AP)—The House paused today from its duties to pay tribute to Abraham Lincoln and hear of his struggles and achievements.

Representative Chipperfield, tall and vigorous Illinois Republican, told the House that "one lesson taught by Lincoln that may be helpful at the present day was his unflinching determination to stand steadfast before the nations of the world for the rights of America."

Abraham Lincoln's memory will be honored tonight in nation-wide observance of his 123rd birthday anniversary by the Republican party, led by President Hoover. The present Chief Executive will speak on the life of the man who preceded him during the troublesome days of the war between the states, using the radio to carry his words to the rallies of the party faithful all over the country.

Key men of the party will supplement this address at each dinner gathering, and an entire hour of radio time will be taken on a national hookup by prominent speakers. The dinner in the capital, to be attended by several hundred party stalwarts, will be addressed by Senator Watson of Indiana, G. O. P. head in the Senate, by Senator Hatfield of West Virginia, by Secretary Wilbur of the Interior and Mrs. Dolly Gann, sister of the vice president.

The last two named, chose to speak on subjects with a militant campaign application, Wilbur's topic being "64 to be repeated," and Mrs. Gann asserting: "Women have faith in Hoover." Important dinners will be held in all principal cities of the nation.

NEW FIRE BOX IS INSTALLED

Second of Peerless Type Box Placed at Corner of Third and Evans Streets. Continuing its efforts to throw a greater safeguard around life and property, the fire department has completed the installation of an improved fire alarm box at the corner of Third and Evans street. Electricians put finishing touches to the new box yesterday afternoon and it was ready today for instant service in case of need.

The box formerly at this point has been moved to the Riverside community to further increase the safety of property in that section, and the number has been changed from 26 to 45.

The new box is the second of its kind installed in the last two months. The first was placed at five points, in the heart of the business district, and is considered by firemen to be of tremendous value in the handling of blazes in that area. The box formerly located there was transferred to a suburban district.

The new boxes are called the three-fold Perless in that they serve three purposes wherein the months. The first was placed at old type served only one. Senate To Vote Monday On Various Relief Bills

Washington, Feb. 12.—(AP)—Senate leaders agreed today to vote Monday on the various unemployment relief bills now pending.

The decision to defer the vote until Monday was made because many senators found it necessary to be out of town for the week end. The first vote Monday probably will come to the Democratic substitute for the LaFollette-Costigan bill. The substitute would provide for loans to states instead of outright gifts as carried by the original proposal.

Both bills now carry \$750,000,000 to be divided equally between road construction and relief. Another possible compromise is receiving the consideration of those leading the movement for Federal aid. Offered by Senator Wagner (D. N. Y.), it proposed to advance relief funds to the states out of future road appropriations. The Wagner bill would give \$375,000,000 to the states for relief, reimburse the federal treasury by "tapping down highway appropriations beginning with 1937." The Senate approached a vote on the proposals yesterday but there was a renewed outburst of debate which sent the balloting over until today. The agreement to defer the vote again was reached at conferences before today's session. The dispute over whether the Federal Government should make direct contributions to care for jobless has brought several acrid debates with independents seeking gifts from the Federal treasury, and Democrats advocating loans to states.

Washington, Feb. 12.—(AP)—The indictment of Bishop James Cannon, Jr., and Miss Ada Burroughs on charges of conspiracy to violate the corrupt practices act was thrown out of court today but plans were made for an immediate appeal by the government. Associate Justice James M. Proctor of the District of Columbia Supreme court sustained a demurrer. (Continued on page six)

HARWOOD WILL GO TO RALEIGH

To Confer With Governor Concerning Mutilated Records in Daughter's Case

Raleigh, Feb. 12.—(AP)—Judge John H. Harwood, who is holding court in Rockingham this week notified Governor Gardner this morning that he would come to Raleigh "sometime today" to confer in regard to mutilated records in the case of Judge Harwood's daughter, charged with shortage in her accounts as a former state tax clerk.

Gov. Gardner last night asked Judge Harwood to come here "at once" for a conference after Attorney General Brummitt had reported "erasures, substitutions and mutilations" in the records in the case. The report noted that Judge Harwood has had frequent access to the records since the charges were made against his daughter and that he often visited the revenue building before state employes went to work and remained after they had gone home.

Concerning substitutions, the report said that a conference of attorneys here Feb. 1, counsel for Miss Lola Harwood asked that certain letters be produced by the state. This request was based on memoranda furnished by Judge Harwood. Twenty-eight copies of letters requested were found at the wrong places in the office files, the report said, and "the appearance of these copies of letters, their contents, and other indicia which (Continued on page six)

ROOSEVELT FILES IN GA.

New Yorker Enters As Candidate for the Presidency in Cracker State

Atlanta, Ga., Feb. 12.—(AP)—Governor Franklin D. Roosevelt of New York filed his entry as a candidate in the Georgia Democratic presidential preference primary to be held March 23. In a letter to Major John S. Cohen, Democratic national committeeman for Georgia, Governor Roosevelt said, "I gratefully accept the suggestion of my Georgia friends and neighbors that I authorize the use of my name on the Democratic ballot in this primary."

He also agreed to the request of his friends, through Major Cohen, that they pay the \$1,000 primary entrance fee but the New York governor said that he will donate \$1,000 to the Patients Fund of the Georgia Warm Springs Foundation. This donation will be "for the special purpose of giving assistance to the children of Georgia who have infantile paralysis."

Georgia will have 28 votes at the Chicago national convention. Governor Roosevelt is the first candidate to enter the primary. The entrance lists close February 22 at noon. If only one candidate is entered, the primary will be called off and the state convention which meets in Atlanta on April 6 will send delegates to Chicago instructed for the candidate.

LEADERS TALK PEACE TERMS

Guns Blaze Over the Ruins of Chapei as American, British and French Ministers Attempt to Restore Peace; Japs Inflict Heavy Losses in Assault on Woosung Forts as Planes Drop Bombs

Sues Coolidge

Shanghai, China, Saturday, Feb. 13.—(AP)—China is concentrating her manpower and her flying force to combat the expected drive when Japanese reinforcements shall arrive in the Shanghai sector.

This afternoon the first detachment of the Canton air force will arrive with planes ready to go into action against the Japanese who thus far have had the air to themselves.

The second squadron is on the way up from Canton and Friday night had reached Nanchang. A third and fourth squadron are mobilizing and should be ready to start for Shanghai before another week has passed.

On the Chapei front the guns were quiet early this morning after an exchange of artillery fire which kept up until late Friday night.

Shanghai, China, Feb. 12.—(AP)—Guns blazed again across the Chapei ruins tonight while the American, British and French ministers were discussing the possibilities of restoring peace.

They had met at dinner at the invitation of Nelson T. Johnson, United States minister to China, who had been asked by the city's Chinese merchants to mediate with the hope of establishing a permanent peace.

The diplomats had just reached the demitasse stage when the cannonading began, heavier than ever.

From their dining room windows on the tenth floor of the Hotel Cathay, they could see the gun flashes along both the Japanese and Chinese fronts. For awhile they watched from the windows, then mounted the stairs to a tower where they watched the battle through binoculars.

The Chapei shooting began sometime after the Japanese fleet in the Whangpoo had resumed the bombardment of Woosung.

They fired on the village and the forts and both sides had machine gun sections in action on opposite banks of the river. The Japanese said they had inflicted heavy losses.

Japanese airplanes were over both Chapei and Woosung, bombing the latter but flying higher over Chapei and avoiding the international settlement. Thus far they had used none of the 500-pound bombs which have been made available to them.

The British cruiser Berwick was asked to shift her berth from the anchorage near Woosung and this implied warning by the Japanese was taken as an indication that another heavy bombardment was imminent.

Mr. Johnson arrived shortly after noon, soon after the four-hour truce of this morning ended. With him were the British and French ministers and all three had their first experience of the Hanghai campaign when their vessel passed through the Whangpoo narrows near the forts.

They saw the Japanese destroyers open fire and a moment later the cruisers joined in. Mr. Johnson said he saw two shells fall in Woosung and immediately fires started. He also counted four airplane bombs which dropped in the marshes near the fort but did not explode.

The Japanese fleet did not forget its manners when the foreign destroyers carrying Mr. Johnson and the British ambassador passed through the narrows. Mr. Johnson was aboard the U. S. S. Simpson and his British colleague on the gunboat Bridgewater. As they passed the Japanese ships ceased firing and dipped their colors. When they were out of the danger zone the fire was resumed.

ASKS RESPECT FOR SUNDAY

Rev. James Devery Deplores Disregard for Sanctity of the Sabbath

Speaking at the morning services of the mission in St. Peter's Catholic church today, Rev. James J. Devery who is conducting the exercises, deplored the wide-spread and growing disregard for the sanctity of the Sunday. He dwelt on the solemn character of the command to keep holy the Sabbath and called attention to God's generosity in giving us six days out of each week while claiming but one and in reality only a part of that one for himself. Respect for the Sunday he contended is an unerring index of living, generous Christian faith.

At the opening of the services last night, the missionary explained the meaning of the ashes which and distributed in the Catholic church at the beginning of Lent each year. "Ashes," he said, "have always been regarded as a sign of mourning and repentance. Job in his sorrow says, 'I abhor myself, and repent in dust and ashes' (Job, I, 14). Isaiah speaks of sack cloth and ashes as a symbol of penance (Isaiah, 58); and Jeremiah more than once says to the penitents, 'Sprinkle yourself with ashes' (Jeremiah, 48). Remember man that thou art dust, and unto dust thou shalt return," to remind them that they are about to enter into the penitential season of Lent.

"Lent is," he explained, a season of forty days just preceding Easter which the Catholic devotes to increased prayer, fasting and self-denial in an imitation of Moses, Elias, David, John the Baptist and especially our Lord (Ezek XXXIV, 28; 1 Kings XIX, 8; Matt. III, 4; Matt. IV, 2). The forty days was no doubt suggested by the forty days of our Lord's fast; 'And when He had fasted forty days and forty nights, afterwards He was hungry.' A person who fasts according to the rules of the Lenten (Continued on page six)

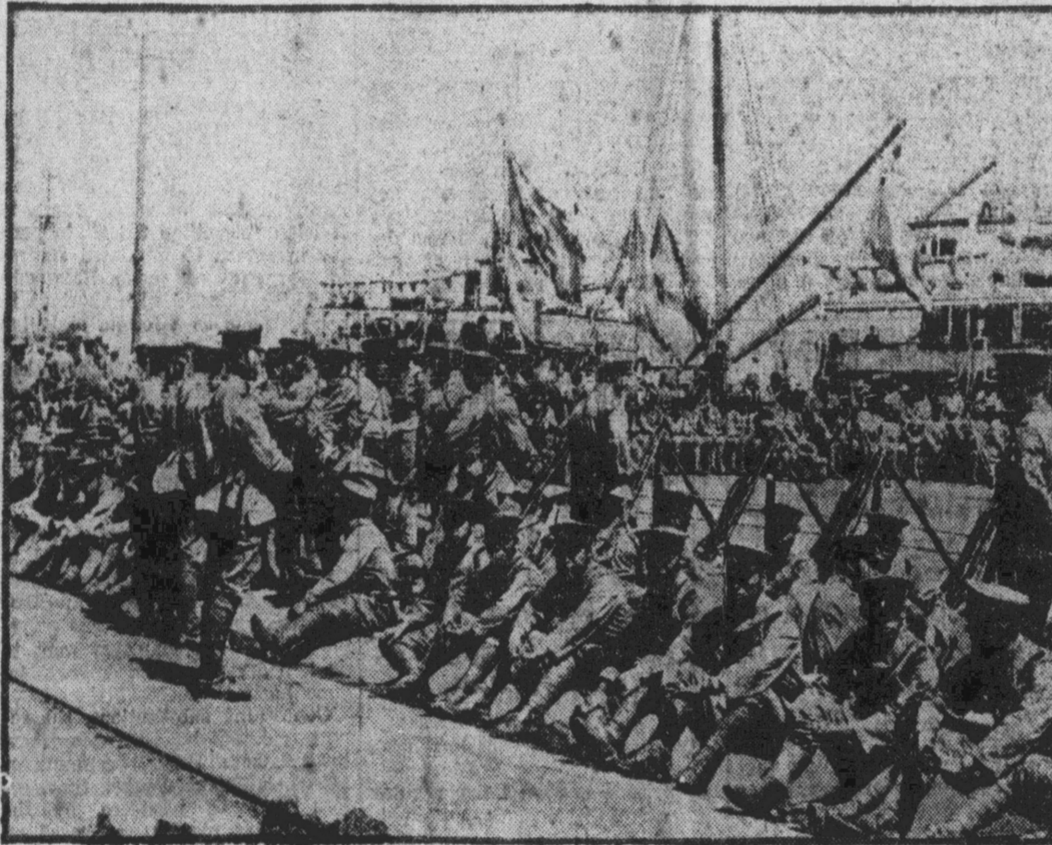

## JAPANESE LAND REGULAR TROOPS IN SHANGHAI



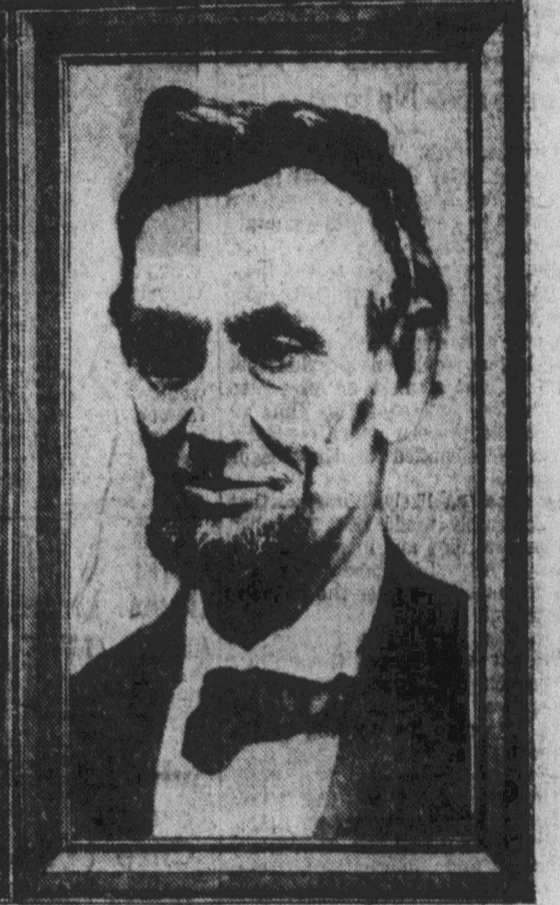
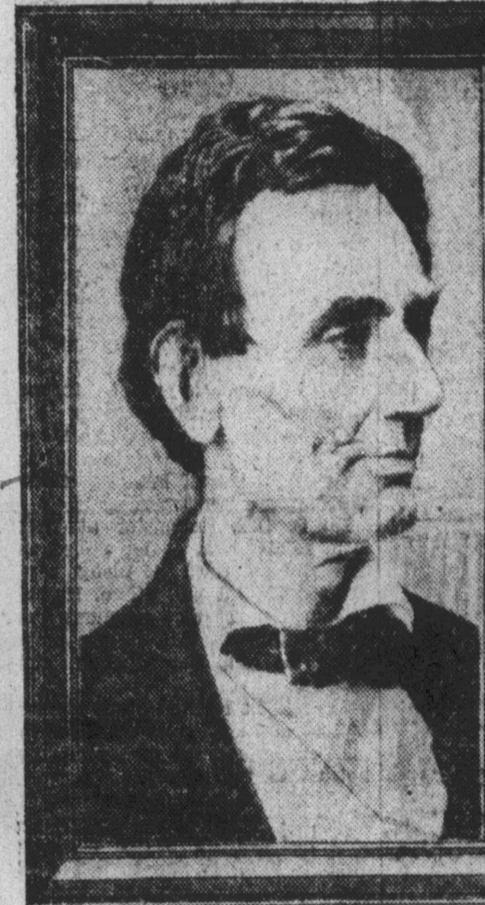

## Lindsay Warren Introduces Bill for Road Aid

The Democratic House received today from Representative Lindsay C. Warren of North Carolina an emergency federal aid road bill calling for an appropriation of \$125,000,000 to be expended by the several states prior to January 1st, 1933. Under the Warren bill, the states would have the right to use their allotments in order to match federal aid funds. Repayment would be made to the federal treasury by deducting \$12,500,000 each year for ten years, beginning in 1938 from the regular annual federal aid appropriations to the states.

The bill is considered by some as an answer to the so-called relief bills now being debated in the Senate providing for direct appropriations to the states in the form of a loan. Mr. Warren stated that he would actively press the measure and would seek to get a hearing on same at an early date. The bill is favored by a large number of State Highway Commissions, who feel that it will greatly aid the unemployment situation in their states.

Should it become a law there would be over \$5,000,000 immediately available in North Carolina for the construction of federal aid projects. A bill is now pending in the House which is also favored by Mr. Warren which would permit an enlargement of the federal aid system by allowing the state to add more roads to same. If the emergency appropriation should go thru road building would get under way in almost all sections of North Carolina.

## Ryland Leaves Carolina Trust

Greensboro, Feb. 12.—(AP)—William S. Ryland, president of the North Carolina Bank and Trust

Company since its organization in 1929, has resigned to become vice-president in charge of finances for the Hunter Manufacturing and Commission Company, New York textile concern.

A. W. McLean, chairman of the board of directors of the bank, which operates numerous branches in the state, expressed regret over the resignation, but said Mr. Ryland was retaining his stock in the bank and would remain a member of the board of directors.

The matter of a successor will be considered at the next meeting of the board of directors and executive committee March 18.

Mr. Ryland came here from Raleigh, where he was president of the Citizens National Bank, which was absorbed by the bank. For many years he was vice-president of the State Planters' Bank and Trust Company at Richmond, Va.

## BAD WEATHER STILL HALTS LAKE SPORTS

Lake Placid, N. Y., Feb. 12—(AP)—The bad weather junk, active here all winter, hovered over Lake Placid and the third winter Olympic games again today.

Rain, which swept down on the Adirondacks yesterday, brought about two postponements of the big features of the games, and right now it looks as if they don't take place until Sunday. The first two heats, originally scheduled for yesterday morning, were put off first to today, then as the rain continued, to tomorrow or Sunday.

This second postponement of the bog races had the effect of jamming the schedule for the end of the meet. Four major championships are yet to be determined. The four-man bob sled, the ski jump, winner to be acclaimed Olympic champion, the pairs figure skating, and one nokey contest—the skating and hockey events can be run on artificial ice of the arena.

It was predicted last night that the heavily-packed snow of the intervals ski jump would be proof against the persistent rain, and the jumpers will go through their stunts late this afternoon as scheduled. Yesterday 62 skiers went down the slushy 60-meter slide and the Olympic hill below and one of them the little Hans Vinjarengen of Norway, made a hill record of 204 feet on his second try. The largest of all Olympic crowds, more than 15,000, sat on wet pine benches or stood watching the jumpers, the cold rain pelting down on the spectators' upturned faces.

Fifteen of those who completed under yesterday's moist and dripping conditions are scheduled to try for the jumping honors today. Yesterday's was a combined event, in which both the 10-kilometer race of Tuesday and the form and distance of jumping counted.

The only other event on today's program is the pairs figure skating event in the arena tonight. Seven pairs, representing four nations,

POPE APPEALS FOR PRAYERS

Ask All People to Join Him in Prayer in Observing Coronation Anniversary

Vatican City, Feb. 12.—(AP)—Pope Pius, celebrating the tenth anniversary of his coronation, appealed today to all the people of the world to join him in a prayer for help from God "at this time of suffering among all the nations."

He expressed the hope that his words would be a "consolation and comfort" to all and that all would be with him "in prayers that the Supreme Lord of all things earthly should cause peace to return to the earth."

The Pontiff was carried in solemn procession from his private apartments to the Basilica on a portable throne borne on the shoulders of 18 stalwart Vatican attendants in red. As he entered the cathedral six silver trumpets were sounded by Swiss guards. Thousands cheered "Viva il Papa!" Priests cried in Latin, "Ad Multos Annos!" meaning "May you live many years longer."

Some excitement was created when the Pope was proceeding up the aisle of the church when an elderly man advanced into the aisle as the Pope neared the great altar and tossed an envelope toward shouting "I ask a grace."

The guards around the portable throne immediately surrounded the man and took him away.

Drys Campaign at Capital City

Raleigh, Feb. 12.—(AP)—A nation-wide campaign for prohibition has been brought home to Raleigh by the addresses here of the "flying squadron" of the allied campaigners for prohibition, which continue today.

Dr. Daniel A. Poling, editor of the Christian Herald, who heads the group, will address a men's luncheon and an afternoon mass meeting. Dr. Ira Landrith, chairman of the National Temperance Council, will also speak, and tonight Dr. Poling will address another mass meeting.

The party arrived here for its 163rd stop on its 567-city tour. The squadron goes from here to Durham, Greensboro, Winston-Salem, Charlotte and Asheville.

State Tobacco Averaged \$6.13 During January

Raleigh, Feb. 12.—(AP)—Tobacco growers of North Carolina received an average price of \$6.13 per hundred pounds for tobacco sold in January compared with a price of \$10.66 during the same month last year. The Federal-State Crop Reporting service announced today.

Sales in January aggregated 35,145,640 pounds by producers, compared with 49,097,523 pounds a year ago in January.

For the season 1931-32 the average is now \$8.93 per hundred, compared with an average of \$13.14 last year and \$18.40 two years ago. Sales this season to February 1st were 458,129,286 pounds, compared with 541,114,498 pounds to the same date last year.

Sales do not represent the full production, the report said, as a considerable amount of low grade leaf was returned to farms without getting a bid in warehouses.

Wilson led the markets of the state up to Feb. 1 this year with sales of 59,327,354 pounds of producers' tobacco while Greenville had sold 58,671,188 pounds.

(Continued from page one) after a bumper crop was 40.8 per cent in 1921, following the 13,000,000 bale crop of 1920. In 1920, the average price received by producers was 13.9 cents, and a high of 22.75 cents was reached in 1921, although the average for 1921 was 16.2 cents. But the average price paid producers gradually slipped to 23.8 cents in 1922 and reached 31 cents in 1923, the highest figure recorded by the Department of Agriculture, except the 35.6 reached in 1919 following the war.

The largest crop produced was the 17,977,000 bales of 1926. The crop following this was 12,956,000 bales, a decrease of 14 per cent. The year 1927 saw the price rise from a low of 11.68 in 1926 to a high of 23.50. That year's average price paid producers was 19.6 cents while the average for 1926 was only 13.9 cents.

The doctrine of the Real Presence and the communion worn Christ conferred on the apostles may be learned also from the teaching of St. Paul who explains the meaning of the Lord's Supper saying: 'The cup of blessing which we bless, is it not the communion of the blood of Christ? And the bread which we break, is it not the partaking of the body of the Lord? And again as if to make doubly clear the fact of the Real Presence in the bread and wine when consecrated, Paul gives us a detailed account of the Last Supper (I Cor. XI, 23). He warns against an unworthy communion which would make the recipient guilty of the body and blood of the Lord. 'Where fore whosoever shall eat this bread, and drink this cup of the Lord unworthily, shall be guilty of the body and blood of the Lord. For he that eateth and drinketh unworthily, eateth and drinketh damnation to himself, not discerning the Lord's body.'

(Continued from page one) they bore seem to exclude any possibility of their genuineness. The copies of letters so found, if genuine, would tend to exculpate Miss Harwood from the charge brought against her.

Criminal, and civil actions were brought against Miss Harwood last June by the state. She was charged with a shortage of \$4,903 but this amount is now estimated at \$4,832 and it is understood the civil action will be settled by a consent judgment soon. The criminal case has been continued several times in Wake Superior court, now being on the March docket.

Raleigh, Feb. 12.—(AP)—Governor O. Max Gardner today awaited the arrival here of Judge John H. Harwood in answer to an executive summons issued last night, regarding mutilated records in the case of Judge Harwood's daughter, charged with shortage in her accounts as former state tax clerk. The governor last night asked the judge to come to Raleigh at once after Attorney General Dennis G. Brummitt had reported "erasures, substitutions and mutilations" in Miss Harwood's records, to which the judge has had frequent access since the charges against his daughter.

SHANGHAI CRAMMED WITH HUMANITY DURING TRUCE

(Continued from page one) tened Chapel for imprisoned non-combatants and sick and wounded, the streets which had been deserted since the outbreak of hostilities two weeks ago suddenly teemed with life.

Scarcely had the clocks of the scared city struck before the rush into Hongkew began. Trucks and taxis streamed into the empty and silent streets in the evacuated districts and thousands of Chinese jostled with them, in rickshaws and on foot. They had come to retrieve the belongings they left behind when they fled precipitately before the Japanese occupation.

Many of the incoming vehicles bore Red Cross flags. These headed direct for the flattened ruins of what was once Chapel, which soon leaped to life as the hurried search for the terrified, embattled inhabitants and the wounded began. For an hour the traffic flowed in and then the exodus began.

Standing on the Szechuen road, two blocks from the war zone, I watched the stream of vehicles and humanity crush past. Truck loads of wounded soldiers came first, guarded by Japanese Bluejackets with bayonets bristling on their rifles. They were whisked off immediately to hospitals.

The stream swelled to tremendous proportions as the morning advanced. The throng consisted chiefly of those who entered the area to rescue their belongings. Many of those who arrived unburdened departed with rickshaws, carts and trucks loaded with household goods and personal effects. Szechuen road was choked with traffic by ten o'clock.

The traffic situation was further aggravated by the presence of large crowds of sightseers, including many foreigners, who were anxious to see at close range the ravages of the fighting. Many of them attempted to enter the Chapel war zone in spite of the sporadic firing which was going on from snipers' guns, but they retreated when they were met, within a block from the sector, by the bayonets of the Japanese sentries, who had orders to pass nobody without authority.

In spite of the truce, the Bluejackets continued to patrol the center district of Hongkew and passing crowds gave wide margin to the machine guns that were set up on almost every corner.

There was an ironic note in the fact that, with these large crowds swarming through the streets every place of business was closed and barricaded.

CHARGE AGAINST CANNON THROWN OUT OF COURT

(Continued from page one) rer of the Southern Methodist churchman to the indictment of himself and his former secretary. The justice ruled that the charges do not allege as fact that Miss Burroughs had knowledge of campaign contributions she was indicted for alleged failure to report. John J. Wilson, assistant United States attorney, prepared for an immediate appeal from the ruling. He will file it Monday in the District of Columbia Court of Appeals. The demurrer is sustained by the Appellate court the district attorney's office is expected to drop the case. A new indictment would be impossible because of the three years statute of limitation. The offenses charged by the indictment grew out of the Bishop's campaign against Alfred E. Smith in 1928.

The churchman and Miss Burroughs were indicted on charges that they had failed to file complete reports of expenditures made in their activities against Alfred

E. Smith in the 1928 presidential campaign.

Their demurrer disputed the constitutionality of the corrupt practices act which requires that such reports be filed with the clerk of the House of Representatives.

In sustaining the demurrer, the court held that it was unnecessary to pass upon the constitutionality of the act, but that the indictment was defective in failing to charge that Miss Burroughs had knowledge of contributions made to the Bishop by E. C. Jameson, a New York insurance man.

The decision of Justice James M. Proctor, sustaining the demurrer nullifies the indictment which grew out of a long investigation by a Senate committee of the activities of the churchman in the 1928 campaign.

The government, however, may appeal from the ruling of Justice Proctor, in which case the demurrer would be regarded. Assistant District Attorney John J. Wilson is considering such an appeal.

Justice Proctor said the indictment was bad in all its ten counts because of failure to allege as fact that contributions of Jameson were reported and accounted for to Miss Burroughs, the treasurer, or that she had knowledge thereof. "The justice said a person could not be held criminally responsible for failure to report a contribution of which he had no knowledge. To do so, he said, would call for an

unreasonable and harsh construction which is neither warranted by the nature of the act, its language nor its intent. "Given such a meaning a treasurer who has filed a statement honestly and correctly, revealing every contribution known to him, would nevertheless be liable to prosecution because of an inevitable omission of a contribution made for the committee to another of which he had no knowledge," he said. "No such unjust purpose can be attributed to this legislation. "Nor can I accept the alternative contention that those counts which charge a willful failure by Burroughs to report contributions made for the committee impute to her knowledge of contributions received by another."
