CHINESE CONTINUE HOLD THEIR GROUND

America Firmly Behind 'Open Door' Policy in China

Dispute Japanese Claim That Nine-Power Treaty Should Now Be Revised

URGENT STANDING BY TREATIES

Stimson Says Observance of Treaties Would Have Avoided Present Sino-Jap Trouble.

Washington, Feb. 24.—(AP)—America stood firmly today behind the open door policy in China and disputed Japan's claim that the nine power treaty should be revised because China was not able to maintain order.

In an open letter to Chairman Borah, of the Senate foreign relations committee, Secretary Stimson said observance of treaties would have avoided the present Sino-Japanese situation and that no evidence had come to this government that compliance with them would have interfered with the protection of all legitimate foreign rights in China.

The secretary of state, in the several thousand word communication filled with detailed background, pronounced America's policy in the Far East difficult as one squarely behind the open door policy and the nine power treaty, under which the policy was subscribed to by the principal powers.

The letter was in response to a request by Borah for an opinion whether conditions in China have indicated the inapplicability or ineffectiveness of the nine power treaty and whether it was in need of modification.

"The treaty was thus a covenant of self denial among the signatory powers in deliberate renunciation of any policy of aggression which might tend to interfere with that development," the secretary said in part.

"It was believed—and the whole history of the development of the 'open door' policy reveals that faith—that only by such a process, under the protection of such an agreement, could the full interest not only of China, but of all nations which have intercourse with her best be served."

The secretary reminded that "on January 7th last, upon the instruction of the President, this government formally notified Japan and China that it would not recognize any situation, treaty or agreement entered into by those governments in violation of the covenants of these treaties (the nine power and Kellogg-Briand treaties) which affected the rights of our government or its citizens in China.

"I am a similar decision should be reached and a similar position taken by the other governments of the world," he continued, "a caveat will be placed upon such action which, we believe, will effectually bar the legality hereafter of any title or right sought to be maintained by pressure or treaty violation, and which, as has been shown by history in the past, will eventually lead to that restoration to China of rights and titles of which she may have been deprived."

He avoided any attempt to place his finger on the sore spot of blame for the Far Eastern troubles.

ON TRIAL FOR DEATH COACH

Football Player Faces Trial for Killing of Statesville High Athletic Director.

Taylorsville, Feb. 24.—(AP)—Garfield Jennings, 23, of Alexander county, was on trial for manslaughter in superior court here today in connection with the death of Ray Perdue, coach of the Statesville high school football team, who died last fall after Jennings struck him with his fist.

Two physicians, Dr. James W. Davis, of Statesville, and Dr. Asa Thurston, of Taylorsville, testified they were unable to give an opinion as to the cause of Perdue's death.

The young coach died almost immediately after Jennings struck him. Perdue's football team was playing Taylorsville high school here at the time. Jennings was headlinesman.

Perdue jumped from the bench to protest official's decision and Jennings struck him. Witnesses gave different accounts of the incident. Several said Perdue and Jennings passed words before the blow was struck while others said no words were exchanged. Perdue fell when struck and never regained consciousness.

SHERIFF TOM FARLEY IS PUT OUT OF OFFICE

Governor Roosevelt Orders Removal Of Tammany Leader As Sheriff.

Albany, N. Y., Feb. 24.—(AP)—Franklin D. Roosevelt, Democratic governor of New York, today removed from office Sheriff Thomas M. Farley, district leader of Tammany Hall's keystone unit.

The governor said he was not satisfied with Farley's explanation of his income and it was mainly on this ground that he removed him. The income, as charged by Samuel Seabury, counsel to the legislative committee investigating the city's administration, related primarily to Farley's "wonderful tin box" in which the huge sum of \$320,000 over a period of a few years.

Governor Roosevelt's action in the Farley case followed a series of startling revelations, the most important of which dealt with the Tammany chieftain's possession of a "wonderful tin box" from which he was apparently able to draw an inexhaustible supply of money.

Farley has long been a power in Tammany but national notice first came to him when he was made one of the targets of Samuel Seabury's verbal fire in the House's legislative committee's inquiry into alleged corruption in New York City.

Under examination by Seabury, who is chief counsel to the committee, Farley testified in New York last October 6 that he had deposited \$362,500 in various banks between 1925 and 1930, although his highest salary during that period was \$15,000. He explained some of the deposits, showing that they were re-deposits of the same money, withdrawn to make loans. But the bulk of the great amount remained unexplained. Farley only saying that he took it out of his tin box.

"That must have been a wonderful tin box," Seabury exclaimed. "A wonderful tin box," Farley agreed, but had no explanation to offer as to the source of its supply.

Farley flatly denied that professional gambling had been carried on in his Tammany District clubhouse. Confronted with evidence of a raid on the club in which several arrests were made, he said that far from gambling, the occupants of the club on that occasion had been winding maypoles for a children's May Day party.

Seabury publicly criticized Farley as a grafter and acting as a private citizen sent a copy of the Farley testimony to Governor Roosevelt with a demand for the sheriff's removal. While the sheriff was framing his reply to Seabury's charges both Farley and former sheriff C. W. Culpkins, Farley's predecessor, were indicted by the grand jury in New York for grand larceny. Trial is pending.

Last week Governor Roosevelt held a public hearing and at that time indicated that he considered Farley's explanation of his large income unsatisfactory.

As soon as Farley returned to New York from that hearing he entered a hospital and his doctor announced that he was suffering from arm and shoulder burns which had

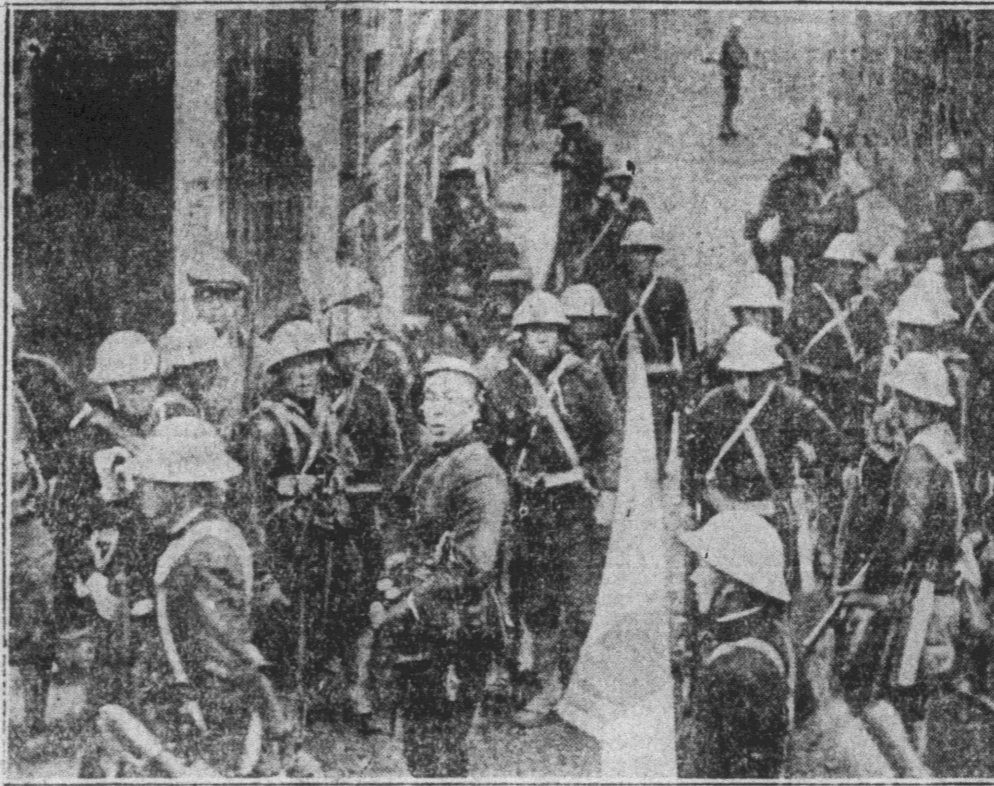

China Not on Offensive Because It Wants Peace

PLAN REOPEN MANY BANKS

State Bank Officials Think at Least \$10,000,000 may be Released as Result.

Raleigh, Feb. 24.—(AP)—Plans now underway to reorganize and reopen state banks which have closed since October 1, 1931 have "good prospects" of eventually releasing about \$10,000,000 of the approximately \$20,000,000 tied up in these banks. C. I. Taylor, state banking agent, said today.

In recent days the Planters Bank of Statesville and the Bank of Blowing Rock have reopened. The institutions had resources of \$233,000.

Gurney P. Hood, state bank commissioner, was in Clermont today and it was expected that the Bank of Coleraine, which tied up \$433,000 by its closing, would open its doors.

The biggest bank to close in the state in 14 months, the United Bank and Trust Company of Greensboro, with branches at Burlington, Sanford and Reidsville, has "good prospects" of being reopened, Taylor said. This institution had resources of \$7,988,000, and some \$5,000,000 on deposit.

Other banks listed as "likely" to reopen and the amount of resources at the last call before they closed are: The Caledonian Savings and Trust Company of Fayetteville, \$315,000; the Wilson Trust and Savings Company of Wilson, \$1,058,000; the Chatham Bank of Silver City, \$434,000; the Bank of Yanceyville at Yanceyville, \$182,000; and the Winton Banking and Trust Company of Winton, \$337,000.

In addition it is understood here that efforts are well underway to reopen the First National Bank of Wilson, the Wayne National Bank of Goldsboro and the First Na-

OLDFIELD TO ATTEMPT NEW SPEED RECORD

Onetime Automobile Race Champion To Return to First Love.

Daytona Beach, Fla., Feb. 24.—(AP)—Barney Oldfield, who had his heyday back in the times when automobile cylinders were big as buckets and the horse still was in good standing, plans to take to the racing road again hoping to win back the land speed record for the United States.

The 54-year-old dean of American race car drivers, one of the most glamorous figures of the history of circular tracks, divulged his plan today while here to witness Sir Malcolm Campbell's scheduled attempt to break the record of 215 miles an hour that the Englishman already holds.

Oldfield said he is planning a car that would surpass any record Campbell might establish here with his big Bluebird racing machine. He hopes to have the car in readiness for trials in February, 1933.

Oldfield, working with Harry Miller, veteran American race car builder, said he already has drawn plans for a record contending machine, powered with two 15-cylinder engines of 1000 horsepower each. He said the chassis probably would be designed to resemble an inverted canoe, and would be streamlined to a degree far beyond that of the machine in which Campbell hopes to break his own land speed record.

Japanese Government Invokes Censorship

By GLENN BABBS Tokyo, Feb. 24.—(AP)—For the second time this month official secrecy has closed over important military developments in Japan, and an active censorship has kept out of the newspapers information concerning preparations for increasing the expeditionary force to Shanghai.

This was by order of the cabinet, the ministry apparently believing that control of the news might disguise the serious view which the government takes of the situation in Shanghai.

A few early editions of yesterday's evening newspapers managed a brief report of the cabinet's decision to send more men to China, but that was the only information most of the people have had.

China To Honor American Flier

Shanghai, Feb. 24.—(AP)—T. V. Mong, former finance minister of the Chinese national government, said today he was telegraphing the mother of Pearl Sh. A. American flier reported shot down and killed at Kotehwa yesterday in an "accidental" crash. Japanese planes, he hinted, had shot her son to be buried in China.

He said the National government wished to give him a military funeral and to grant him posthumous honors within the nation's limits. The National government, he added, would inform Shanghai tonight that it was appreciative of what her son had tried to do for China and regretful of the fact of his death.

Sho's body was recovered although badly burned, according to the information available here and it is understood to be on the way to Shanghai by authority of Chinese officials. The Chinese press here featured the story today as a laudatory tribute to the "great flier" of China, seeking to assuage her anger at Japanese aggression.

TRAGIC STORY OF WAR ZONE

Passengers Arriving from Shanghai Describe Japs as Ruthless Killers.

Victoria, B. C., Feb. 24.—(AP)—Stories of executions of Chinese by Japanese soldiers in the fishery around Shanghai were vouchsafed today by Charles Doyle, who has been a flying instructor for the Chinese army, on his return from the Far East.

The account of Doyle, who lives at Vancouver, was one of several descriptions of the warfare going on between the Japanese and the Chinese among occupants of the international settlement at Shanghai.

"Whenever there is any sniping" Doyle said, "the Japanese attack everyone in the building from which the shots were fired, and execute them instantly."

"As many as 150 persons have been put to death at one time in this manner. The Japanese just put revolvers behind their heads and shot them."

Doyle was compelled to give up his post as flying instructor, he said, he would have forfeited his Canadian citizenship had he remained in Shanghai.

One Killed And Five Injured In Auto Accident

Laurinburg Feb. 24.—(AP)—A 13-year-old boy was killed and five other persons injured in a head-on automobile collision on a busy business street here today.

A heavy machine, loaded with school children, met a lighter car driven by R. C. Kiser, principal of the graded school, and overturned. It. M. Morgan, Jr., 12, was pinned beneath the heavy framework of the car. He was dead when extricated.

Dorothy Morgan, his 15-year-old sister, was seriously injured about the head. She is in a hospital. Pearl Morgan, another sister of the dead boy, was less seriously injured. Nathan and Lon McCormick, sons of J. C. McCormick, received lesser injuries.

Mr. Kiser was badly bruised and shaken up. Blame of the wreck had not been placed several hours later. The children, all members of well known Scotland county families, were on their way to school when the two cars crashed.

Chief of Police D. B. Brown, said there were several witnesses to the crash and that "I hardly believed there will be the necessity of holding an inquest."

He said no charges had been preferred and added that, if an inquest is held, "it probably will be tomorrow."

Hamlet, Feb. 24.—(AP)—Dorothy and Pearl Morgan, badly injured in an automobile collision at Laurinburg today in which their brother was killed and two other children hurt, were rushed to a hospital here shortly after the accident.

Physicians said Pearl Morgan might recover but that Dorothy, 15, had very little chance to live. She is suffering from head injuries

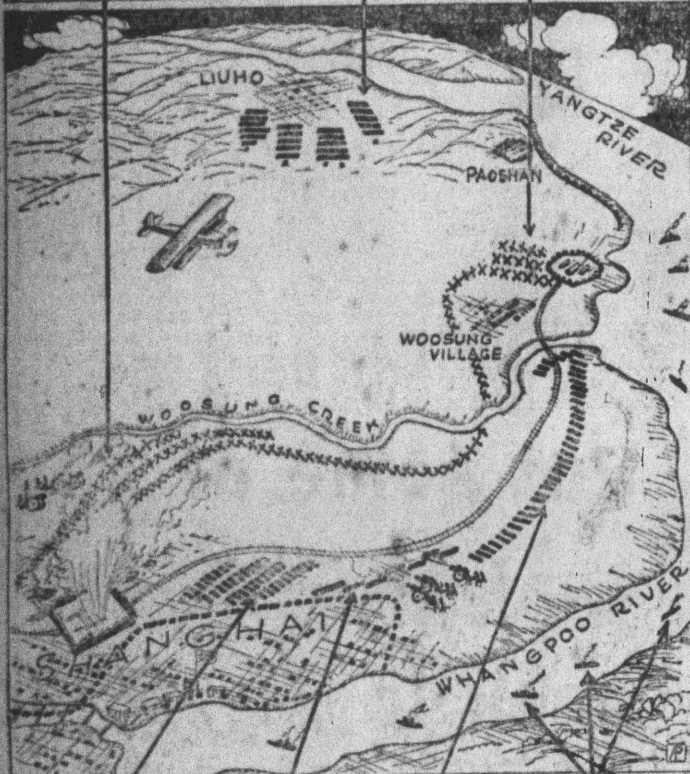

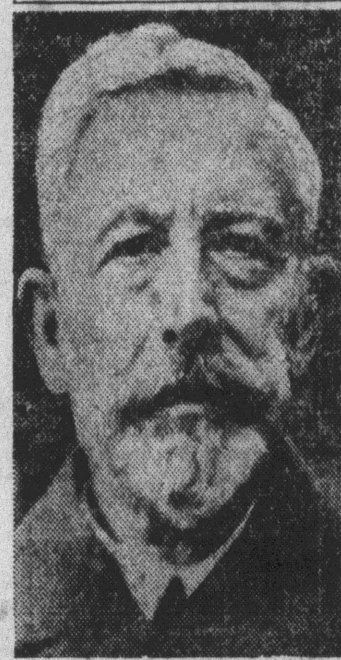

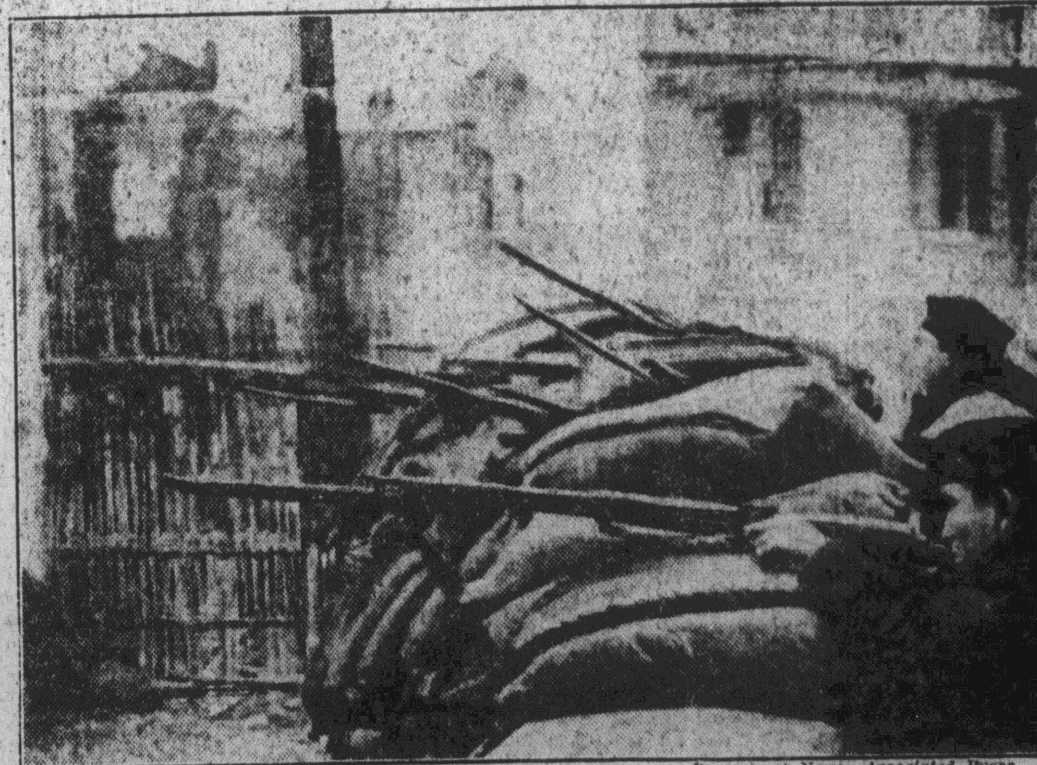

inferred that the Chinese were read an attack on Hongkew before Japanese reinforcements reported on the way from Tokyo could arrive.

Shanghai, Feb. 24.—(AP)—General Ueyeda's Japanese army made another drive against the Chinese at Kiangwan today and when it failed to budge the Chinese the Chinese center of the Japanese attack was suddenly shifted to the Chapel front this afternoon.

Observers said tonight they believed Japanese had virtually assumed a defensive attitude and were waiting for anticipated reinforcements from Japan. Outbursts of machine gun and artillery fire continued but there was no sustained action during the latter part of the day.

A landing force from the Japanese warships in the river opened the attack along the northern section of the battered Chapel sector and severe fighting followed during the afternoon.

The thrust against Kiangwan, where the Chinese have been immovable for four days, was preceded by a heavy bombardment from the air. The blasts of the huge aerial bombs shook the entire countryside but they failed to rout the Chinese who continued to sweep the enemy with rifle and machine gun fire.

Two Chinese airplanes attempted to bomb the Japanese headquarters at Kiangwan, and missed their target by only 100 feet.

The Japanese air attack on the central stronghold of the 16-mile Chapel-Woosung front was followed by a driving ground attack. The assault was covered by Japanese batteries on the Kiangwan golf course, but it ended with no gain.

Eight giant bombing planes delivered the air attack on Kiangwan. They used 250-pound bombs. The raid lasted less than a half hour and caused considerable damage to the Chinese positions even though it failed to budge the defenders.

Reports were circulated through the city today that Japanese reinforcements had already arrived at Woosung, on the northern end of the battlefield but there was no sign of any additional soldiers there at noon. General Ueyeda, Japanese commander, said that he expected reinforcements, but he refused to say how many.

Japanese officials said two additional army divisions would sail from Japan in the near future. There two divisions would comprise 22,000 men, they said.

Inspection of the Woosung waterfront at noon revealed everything quiet. All Japanese warships had withdrawn and none was visible. A small Japanese force of 200 remained on the left bank of the creek. All other Japanese troops had been thrown into the Kiangwan area where the force of the attack has been centered for four days.

General Tsi Ting-Kai, commander of the Chinese 19th route army, said his army during the past four days suffered losses of 1,700 killed and wounded. Since the outbreak of the hostilities here on January 28, he said, the army's losses in killed and wounded were 2,300 and that 5,500 Chinese civilians had been killed and wounded on the same period.

Authorities of the international settlement began wholesale vaccination today to prevent a possible epidemic of smallpox as a result of the inflow of thousands of Chinese refugees from Hongkew, Chapel and other districts.

Municipal physicians were sent through the areas occupied by the refugees, vaccinating all comers. The settlement enlisted the cooperation of the Chinese authorities, agreeing to supply free vaccine to any organization capable of administering it.

It is estimated that 20,000 refugees were vaccinated during the day.

The territory north of Kiangwan, close to Japanese position and around Japanese headquarters, presented a dreary scene. Most of the fires had burned out, leaving nothing but dull gray ashes. Behind the lines the Japanese soldiers crouched in apparent discomfort, having about fires seeking to dry their clothing which was drenched by a heavy rain during the night and trying to cook over smudgy fires.

At Japanese headquarters a spokesman said: "Our men are tired and they want some rest."

ABOUT TOWN

This is one of the most prolific periods for disagreement the world has ever known. Yesterday Rep. McClintock issued a statement saying the Akron, world's largest airship, was irreparably damaged at the Lakehurst air station Monday. Hardly had the assertion been made than high naval officials declared he was wrong. The congressman was a member of a committee to decide on the airworthy condition of the Akron and was preparing to board the ship when it was badly damaged by improper handling. In the face of his statement and that of the "high naval authorities" the public is unable to decide which is right. The next thing we know Congress will be making an investigation committee to decide which is right, and the public after being treated to a lengthy statement after the investigation, will know little more than it does already. Truly this a complex age.

Postal savings accounts would be open to checking privileges, under a bill introduced in the Senate yesterday by Senator Dill. The measure would allow checking accounts up to \$5,000 in addition to the present limitation of 2,500 on pass book accounts.

To be real candid about the matter, Senator Dill wants the government to go into the banking business more completely than before. Not content with absorbing millions of dollars in bonds and postal savings accounts, he would literally rob public banking institutions of what little business they have been able to save following the nationwide bank scare of several months ago.

The suggestion looks all right from the government point of view but to bankers, it looks like doom. The senator said the plan will give the citizen with small deposits which must be continually in use, a place for his money and he will know it is absolutely safe.

The same feeling of safety may be enjoyed by the man with little money if he places it on deposit with his home town bank. All of the weak financial institutions of this country have been virtually weeded out and with the government behind the others with special funds, it is safe to say the future of the financial fabric of this nation is more solid than it has been in years.

The senator will have the pleasure of introducing his bill, but that's about as far as he will be able to go.

Employees in state buildings at Raleigh are being denied any ice water during the remainder of the winter. The action is a means of cutting down expenses, one of several adopted by the state the last few months.

The employees who need ice water in the winter as well as summer will get along all right without it. People are no hotter in the winter now than they used to be and ice water in winter a few years ago was unknown, except the kind cooled by nature.

Ordinary spigot water ought to be cool enough anyhow and people needing it much colder should see a doctor about their temperature.

Metaphorically speaking, the Democrats have taken the "bull by the horns" again in Congress.

Disregarding the plea of President Hoover that he be permitted to begin action on his reorganization of government as a means of reducing expenses, Democrats have made it known that they plan to map out their own reductions. With this end in view a committee has started to work and when they get through it is to be supposed they will have decided on a way to improve what the President has to offer.

It begins to look like the administration and congressional Democrats are departing from the way of harmony so evident during reconstruction program and from now on it is going to be Democrats

this and Republicans that. The line of demarcation has been drawn and Republicans get credit for what they do and not for both Democrats and themselves.

Forget depression and move on to higher things.

This was the sense of a meeting of business, industrial and financial leaders held recently in Charlotte.

The suggestion is a good one and should receive the attention of leaders in all sections. With the economic situation gradually undergoing an improvement, the people who comprise the leadership of each community, should make it a point to try and dispel the gloom which has hovered over the nation the last two years by calling attention to some of the possibilities of the future.

Opportunities have not been lessened by the perilous days of the past and those who put their shoulders to the wheel and attempt to make the best of their condition will find the future much brighter than they anticipated.

Greenville's Unemployed.

I believe Greenville to be as local, as patriotic, and as charitable as any community or town; however wishing to relieve hunger and suffering as much as possible, I am suggesting a plan whereby I believe the town of Greenville can help its unemployed without imposing any hardship or expense on anyone.

I suggest a consolidation of the Welfare Department and the Agriculture Department with the Chamber of Commerce, or the organization which best represents Greenville into a committee the purpose being to supply food for labor.

The money hogs have gobbled up and apparently salted down the money of our nation.

Two of the most wonderful blessings the Almighty has given any people are still ours, a productive soil and a genial climate which are awaiting our labor; the combination of which can produce the necessities which will maintain life as effectively as ever.

Lease some land in walking distance of Greenville, in reach of the unemployed, where they can find work. Devote this land largely to truck farming. Raise some small livestock that can be consumed directly by the people who work there. It will only be a couple of months or so before every laborer can be paid off each day with vegetables and foods that they must have.

I believe enough produce could be sold to defray the running expenses of the farm and clear a profit besides.

People had rather work than beg. This would give the unemployed a better outlook on life, hope, something to look forward to. The morale of our citizenship would be improved. It will lessen crime and encourage thrift.

This will require some vision and a small investment on the part of some good citizens of Greenville. With no more investment than the average farm this farm could be made to supply the vegetables for hundreds of people.

Farming in this manner would be simplified, eliminating the high rate of exchange which makes farming for money so generally unprofitable. For that reason it would be an attractive proposition for both employer and employee.

A practical, successful farmer should be employed to oversee the farm. If the right people are selected to carry out the workings of this organization, those that wish to deal fairly and help their fellowmen, this organization would be a blessing to Greenville.

Dempsey's loss to Levinsky failed to affect the attendance, as the house was a complete sell-out. Several prospective cash customers were turned away just before the bout, the special policeman charged a crowd of would-be gate crashers, flourishing pistols and black-jacks.

After going to Frankfort today to address the Kentucky legislature and receive his colonel commission, Dempsey will go to Chicago to the next exhibition on his tour is at Dayton, Ohio, Monday night.
