Storm Damage On Coast Near Million Dollars

Belated Reports From Fishing Banks Tell Of Hardship And Suffering

MANY HOMES WASHED AWAY

Hundreds of Thousands of Dollars In Fishing Nets Go Into the Sea and Families Destitute and Homeless Depend on Mainland for Relief; Red Cross Rushes Relief to Sufferers.

Manteo, March 12.—(AP)—Residents of the North Carolina fishing banks today surveyed the damage of last week's storm, saw a loss approaching \$750,000 with scores of families rendered destitute.

A tardy winter swept over this section last Sunday, loosing high winds, driving a heavy rain and churning mountainous waves in a storm that was worse, fishermen said, than any here in nearly half a century.

Many homes were washed away as the turbulent sea undermined foundations, hundreds of thousands of dollars went to the sea's bottom as nets were torn to pieces, and today families in a number of communities depended on the mainland to furnish necessities of life.

The loss to the fishing industry was two fold: Equipment was washed away and with it went the means of providing money to purchase new equipment.

Supplies have been taken to 76 destitute families on Harker's Island by the Red Cross and Coast Guard. Necessities also were taken to Rodanthe which had been isolated because of inability of boats to ply between there and the mainland.

From Rodanthe came reports that five houses were swept away and that 15 others were heavily damaged. Six homes were demolished on Duck Island as were several at Nag's Head. At Avon nine homes were reported lost.

No lives were lost but six men were rescued from an oyster boat that sank in shallow water during the storm. They suffered from exposure.

Between midnight and early Sunday morning, a gale swept in from the northwest, then suddenly it changed to the northeast. The change piled waters from the sound high over the islands and at Manteo houses and mercantile establishments were inundated.

Residents fled from their homes as the power house was submerged, plunging the village in darkness. Nets in Dare county alone valued at \$250,000 were carried away and boats were smashed under waves that cut new inlets in the sound. One inlet was cut 250 yards wide and 10 feet deep. The state spent \$200,000 in an unsuccessful effort to reopen the channel at this point.

Highways, boats, terminals, bridges and ferries were damaged and foodstuffs was lost, gardens where freezing weather has hampered trucking to an extent that food returns from that source will be considerably lessened.

The settlement of Colington was marooned and the Oregon Inlet Coast Guard station was isolated by the sweeping waves. Buildings at the inlet were destroyed and the two villages of Frisco and Buxton were in silence until Tuesday. Since then only meagre reports of damage have been available.

The Wright Memorial bridge was closed to traffic when the approach washed away. The State Highway per at Nag's head was destroyed. Mail steamers were forced to stay at their docks more than two days until the seas quieted.

Damage to the causeway approaches to the Roanoke Island bridge were estimated at \$75,000 with about the same estimated to the highway between the causeway and Nag's Head. Benton fishermen had set practically all their nets, looking to the past week as the best of the season which was at its height when the storm struck. Their nets were practically ruined.

Residents from Hatteras reported the tide was highest since 1899. Reports said less than 25 per cent of equipment there and at Stumpy Point was saved from the waves.

State Meets Demands for School Fund

Raleigh, Mar. 12.—(AP)—The \$15,700,000 state appropriation for the six months public school term has been adequate to pay the costs of the schools up to the state standard, Leroy Martin, secretary of the board of equalization, said today.

Practically all six months schools have closed and the six months term has ended. The few uncompleted terms will end next week.

Final payments have not been made, Martin said, but there will be adequate funds to meet all expenses.

GIVE FREELY TO DEMOCRATS

Total of \$555,000 Is Raised for Work of National Committee Up to Yesterday.

New York, March 12.—(AP)—Chairman John W. Davis of the Democratic victory campaign announced today that \$555,000 in cash and pledges had been received or reported toward the work of the Democratic national committee up to yesterday.

The money represented gifts and contributions from 45,817 men and women.

Mr. Davis' announcement followed publication from Washington of the committee's financial report for the two months ending February 29.

Paris, March 12.—(AP)—Aristide Briand received the last tribute of his people today as tens of thousands stood baredheaded under a bright cold sky while his body was borne to Passy cemetery.

Premier Andre Tardieu called him the prince of orators and the friend of peace in the funeral oration to which the representatives of government listened.

The flower of the French army passed in review before his coffin at the foreign office, but this was a civilian funeral. The customary gun carriage was replaced by a horse-drawn coach.

Roosevelt Forces Seek Compromise With Smith

Boston, March 12.—(AP)—Leaders of the "Roosevelt for President" campaign in Massachusetts have set 5 o'clock today as the deadline for any compromise with political leaders backing the candidacy of Alfred E. Smith, for the Democratic presidential nomination.

Efforts at a compromise, encouraged by Louis C. Howe, personal secretary to Governor Roosevelt, and Governor Joseph B. Ely of Massachusetts, leader of the Smith forces in this state, have come to naught.

The Roosevelt organization last night offered to make no contest for presidential delegates in the Massachusetts primary if the Smith group would promise to pledge its delegation to throw its support to Governor Roosevelt.

However, Representative Laguardia, of New York, a leader among the Independents of both parties who style themselves progressives, claims support of the entire group for the amendment which will be offered to shift this part of the tax burden to luxuries higher incomes, and generally to the classes having considerably more than the average wealth.

House to Vote On Wet Bloc's Proposal Soon

Washington, Mar. 12.—(AP)—Speaker Garner told the House today a vote would be had in the House Monday on the wet bloc's resolution calling for submission of the 18th amendment to the states.

Under the rules of the House, the resolution has been forced out of the judiciary committee by a petition of 145 members.

Garner said as "long as I am speaker," when the proper rules of the House are invoked, it will have an opportunity to vote on any subject.

SEE PASSAGE OF SALES TAX

House Leaders Predict Success of The Measure After Turbulent Opposition.

Washington, Mar. 12.—(AP)—Now they have had a chance to size up the turbulent opposition to the sales tax provision in the revenue bill, House leaders are predicting the measure will be passed substantially unchanged.

Numerous Casualties As Japs And Chinese Clash

By MORRIS J. HARRIS (Associated Press Correspondent) Shanghai, March 12.—(AP)—Japanese headquarters said today a brisk skirmish between Chinese cavalry and Japanese troops took place today on the front line five miles north of Kating.

The fighting lasted for an hour, they said, and the Chinese apparently suffered numerous casualties but the Japanese forces lost no men.

Additional thousands of Japanese troops were landed in transports at Wooting and sent to places on the 30-mile front around Shanghai.

Japanese diplomats said they hoped for the best from peace discussions but the army went grimly (Continued on Page Two)

FOUR PERSONS PERISH IN FIRE

Scranton, Pa., March 12.—(AP)—A little old lady, half blind and 80 years of age, gave up her life last night in an effort to rescue her four brothers, all over 70 years old, when fire started in their home in the farming district two miles east of Springville, Susquehanna county.

Three of the brothers also perished in the blaze, but a fourth, badly burned about the body, rushed from the burning building unclad and was saved.

The dead: Miss Mary Fyke, 80; Warren Fyke, 77; Newman Fyke, 74; and Jacob Fyke, 72.

Nelson Fyke, 75, who was the only occupant of the little frame farmhouse to escape, was carried on a bobsled over two miles of snow covered road, then placed in an automobile and removed to Hahnemann hospital in this city. His condition is critical.

Nelson was found in a barn unclad, burned and nearly frozen but still conscious. He told what had happened.

The Fyke family members had been in bed about an hour when Mary Fyke, who slept downstairs, was awakened by the crackling of (Continued on Page Three)

ASK FOR ALL INFORMATION

Official Bulletin Says Police Have Agreed to Treat all Facts Confidentially, But That Freedom For Kidnappers Has Not Been Guaranteed; No New Developments Reported.

Hopewell, N. J., March 11.—(AP)—Police investigating the kidnaping of the Lindbergh baby have promised to treat confidentially information coming to them from any source, but this does not mean they promise immunity to the kidnapers themselves, it was officially revealed today. It was stated that requests sent to every police headquarters in the country appealing for information and promising secrecy had led to interpretation in some quarters that in effect immunity was being extended to the criminals.

This was flatly denied by Col. H. Norman Schwarzkopf, superintendent of state police, who is in general charge of the case at the Lindbergh home.

"Our guaranty of confidence concerning informants," Col. Schwarzkopf said in an official bulletin this morning, "is an expression of our sincerity concerning our efforts to obtain information which would result in the return of the baby."

"The matter of immunity to criminals is beyond our control."

The question of immunity has cropped up repeatedly since the Lindbergh baby was stolen on the night of March 1 and numerous officials, including the governor of the state, have said that it was impossible to make such a promise, which in effect would be to declare crime legal.

The nearest possible thing to a promise of immunity is Col. Lindbergh's own appeal to the kidnapers in which he promised to meet their terms and to maintain complete secrecy if they would return his child.

Col. Schwarzkopf's bulletin continued: "We have no control of supervision over the activities of Col. Lindbergh or his representatives in any respect."

"All police agencies have been active in the investigation of this case and are making every effort possible to accomplish the return of the baby. The investigators will cooperate with any and every enforcement officer or other persons having information of value that may lead to the recovery of the baby."

"Police departments all over the country in their anxiety to obtain information which would result in the return of the baby are exerting every effort possible with the result that numerous independent investigations are being conducted, but which are not reported to these headquarters. Therefore it is impossible to answer all inquiries concerning other police activities."

"We fully realize the importance of these independent investigations and appreciate the fact that when they amount to nothing of importance we are not annoyed by useless messages which would congest our files with records not of a tangible nature. We feel certain that any information of importance or any value accumulated by any police agency will be transmitted forthwith by any police department or agency."

"The status of the investigation has not revealed any information of a productive nature in the past 24 hours. Many of the investigators are at present on assignments which have extended in at least three other states and have not returned. The results of this investigation are not known and will not be known until they communicate or return. If their investigation develops any details of importance or value (Continued on Page Four)

HOOVER AFTER IDLE DOLLARS

President is Pleased With Progress of the Anti-Hoarding Campaign in America.

Washington, March 12.—(AP)—President Hoover is highly pleased with the success so far of the national anti-hoarding campaign, but he wants it kept up until every community in the country has been enlisted in the drive and the last idle dollar has been sent back to work.

Explaining his view of the drive he has likened to war, the president late yesterday told newspapermen that while 2,395 communities have been organized by the national unit under Colonel Frank Knox of Chicago, the work is "only beginning."

He reported no total of the money returned to banks and credit channels, but said the drive already has proved its worth and is contributing definitely to the "dissipation of fear and apprehension and to the restoration of confidence."

The positive results obtained, he said, were evidenced by increased bank deposits and the purchase of the government's special baby bonds.

Mr. Hoover especially commended Curwensville, Pennsylvania, a town of 3,000 which has reopened its closed bank, drawn thousands of dollars from hoarding through a campaign which enlisted the entire population. He gave to the press a letter from the Chamber of Commerce of the community which told how Curwensville had been made, through this drive, "a new place in which to live and do business."

ABOUT TOWN

Large numbers of Pitt county farmers are taking advantage of the loans made possible through the Reconstruction Finance Corporation organized recently through a suggestion of President Hoover.

The farm office placed the number at one hundred yesterday and said scores of others were expected to apply within the next two weeks.

Farmers should make every cent of their loans count for absolute necessities and not be misled into applying it for luxuries.

The government loans open up another opportunity for the farmer to get his head above the water, and if he will live frugally and apply himself diligently to the production of better crops he certainly has a fine chance of forging back to the top of the ladder.

It reports of the anti-boarding committee may be counted for anything the financial situation is much better than it was several days ago.

This information will be received with pleasure by that great mass of people who had no money to hide, and who have been looking forward hopefully to the uncovering of huge sums by those who have consecrated themselves to the bond sale cause.

The government should now launch a campaign to interest the big boys in cutting loose some of the money they have been sitting on for so long.

Haphazard employment, blind alley jobs and long periods of idleness between jobs were important contributing factors to crime and delinquency in 1931, according to the Year Book of the National Probation Association for that year, which has just been published.

The National Probation Association is an association made up of juvenile court judges, probation officers, psychiatrists, criminologists, and others interested in the treatment and prevention of crime in the United States.

Economic stability and security. The Year Book, "are two of the greatest safeguards to orderly life. The experiences encountered in 1931 have not only made social workers, business men and economists conscious of the havoc which lack of security can bring to all classes but have made them realize that something must be done to eliminate widespread unemployment in the future.

The five causes listed in the Year Book as contributing largely to crime and delinquency in the United States during 1931 are: First, lack of a sufficient regular family income to insure health and at least a minimum of decency and comfort.

Second, inefficient and dishonest standards of government. Dishonesty and low moral standards of federal, state, or municipal officials

Centers of commercial amusements where low standards of conduct are tolerated influence and weaken the individual. Supervised and properly directed recreation is needed in every community."

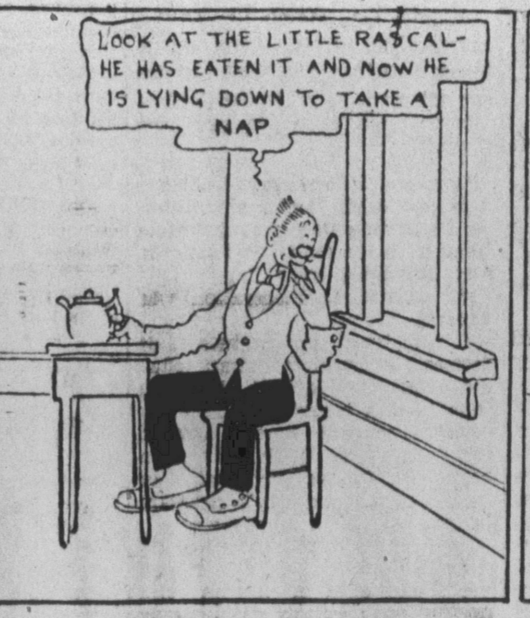

## British Steamer Aids Crippled Boat

New York, March 12.—(AP)—The British steamer **Dakotian** took the crippled **Coast Guard** patrol boat 218 in tow about 400 miles off New York today and started with her toward Nantucket, the Radio Marine Corp. said.

A radio message picked up by the corporation said the seven men aboard the government boat were "all OK." The 218, missing since Monday when she started to the aid of other storm battered shipping, sent out an appeal for aid this morning. She did not disclose the nature of her distress. It was the first word from her in more than five days.

The 218's radio was too weak to communicate with land but the message was relayed here by the **Dakotian**. The weakness of the radio was thought to be the explanation of the government's craft's long silence.

The 218 left her base at Cape May, N. J., after the storm broke over the Atlantic early in the week.

## Will Appear No New Judges At Present

Raleigh, March 12.—(AP)—Gov. O. Max Gardner today announced that for the present there would be no additional Superior court judges appointed.

Numerous recommendations for attorneys who would like to fill the three vacancies existed in the special judgeships are being received. Governor Gardner said, but as the present judges are cooperating in shifting plans so as to hold additional terms of court, no new appointments will be made now.

## SALES TAX FIGHT FELT IN THE STATE

Raleigh, March 12.—(AP)—Reprovisions from the fight in Congress over a general sales tax begun to be felt in North Carolina politics this week with the recurrence with increasing frequency here of rumors that A. L. Bulwinkle's statement he would support the measure had influenced R. Gregg Cherry of Gastonia to decide to oppose him for Congress.

Political talk here during the week centered largely on the gossip that Cherry would oppose Bulwinkle in the new tenth district and that J. Q. Gilkey of Marion would be an opponent of Zebulon Weaver in the new eleventh district primary.

Though R. T. Fountain, A. J. Maxwell, and J. C. B. Ehringhaus, all announced candidates for the Democratic nomination for governor, made speeches during the week, the political interest in the gubernatorial race continued at low ebb.

## STOCK MARKET

New York, March 12.—(AP)—The stock market stiffened a little today, as shorts took their rather meagre profits at the close of the week.

# OHIO PLEDGES HOOVER VOTE

Governor White Also Entered for Buckeye State's Presidential Nomination.

Columbus, O., March 12.—(AP)—Eight names headed by President Hoover and Governor George White were on Ohio's list today as candidates for the presidential nominations.

The time for filing nominating petitions ended at 6:30 p. m. last night with all but three of the state's 55 Republican delegates to the Republican convention pledged to President Hoover.

One Republican delegate favors former Senator Joseph I. France of Maryland, and two pledged themselves to Mayor Jacob S. Coxey of Massillon, who led an army of jobless men to Washington 38 years ago.

Governor White, favorite son for the Democratic nomination, met greater opposition than the president. The governor will be opposed in five districts by delegates giving favor to former Secretary of War Newton D. Baker, and Peter Witt, of Cleveland. Witt's delegates were expected to switch to Alfred E. Smith.

Despite the pledges to Baker, he has repeatedly said he will not be a candidate.

While bidding for delegates, neither President Hoover nor Governor White entered the presidential preference primary which holds only empty honors since its vote is not binding upon the delegates. There will be four candidates, however, who will vie for the state's popular choice.

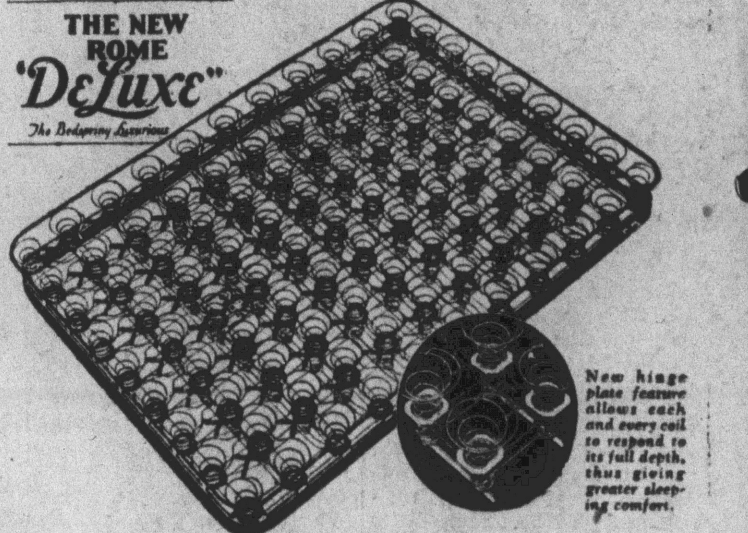
