## House Refuses To Consider Liquor Legislation

### Police Watch Denver Gangsters For Clue In Lindbergh Kidnapping

#### OTHER ANGLES INVESTIGATED

Officers Begin Probe of Activities of Suspicious Gangsters Who Fly from Colorado to New York; Search for Baby Extended to Two New Points—Jackson, Ky., and the Liner "City of Baltimore."

Hopewell, N. J., March 14.—(AP)—Gangsters from Denver, Colo., who have gone east by airplane, are being watched by police in the hope that they may be able to shed some light on the kidnapping thirteen days ago of the Lindbergh baby.

This was revealed today by Colonel H. Norman Schwarzkoff, chief of the New Jersey state police, who announced that the gangsters were engaged "in mysterious activities in and around New York."

Colonel Schwarzkoff disclosed, also, that the search for the child has been extended to two new points—the City of Jackson, in Kentucky, and the liner City of Baltimore, due in Hamburg, Germany, today.

A woman in Jackson sent word to the troopers that she had seen a New Jersey car at a house three miles out of town since March 4 and that the people driving the car had with them a blond, curly-haired baby boy. This superficial description fits the Lindbergh child.

The captain of the City of Baltimore was requested by police, who sent him a radiogram, for information about a report that a baby similar to the Lindbergh boy was aboard in the care of a stewardess.

The Associated Press in Germany was informed by Captain Cross, master of the City of Baltimore, that "an investigation of children aboard shows that the Lindbergh baby is not among them."

Hamburg police, a Berlin dispatch said, were weary of tracking down rumors about the missing child and had declined to send men aboard the City of Baltimore to make an investigation.

A different attitude was taken in Spain. The authorities at Seville announced that every vessel entering the port from the United States would be searched for the Lindbergh child.

In addition to the other phases of the investigation, the New Jersey police worked through the authorities at Sandusky, Ohio, about supposed "important information" available here.

The Colonel's statement, submitted after the usual written questions had been presented to him, follows:  
"Information was received that a suspicious gang from Denver, Colo., had come east by airplane and were engaged in mysterious activities in and around New York. This is to be investigated and to date nothing of importance has been ascertained. This investigation will be continued with a complete checkup of all their movements."  
"Information was received last night to the effect that a baby resembling the Lindbergh baby was delivered to a stewardess aboard the SS City of Baltimore, sailing from New York March 2 and due to arrive at Hamburg, Germany, today."  
"A radiogram was immediately sent to the captain of the SS City of Baltimore to investigate the circumstances and report back his findings. No reply has been received as yet."  
"Information was received of suspicious circumstances concerning a family in Jamaica, Long Island, to the following effect:  
"Early in the evening of the kidnapping a large automobile was driven speedily away from the house by one man about 2 a. m. It returned with two men, a woman and a blonde baby. There has never been a baby in this house before and since that time the baby has been heard to cry, but has not been seen by the neighbors. An immediate investigation was (Continued on page four)

### HINDENBURG LEADS VOTE IN GERMANY

Run-Off Election Will Be Necessary to Decide the Presidential Honors.

Berlin, March 14.—(AP)—Germany began today to prepare for a second presidential election. But the tension over the outcome was lessened by the result of yesterday's vote which gave the veteran Paul Von Hindenburg a lead of more than 7,000,000 over Adolf Hitler, his closest competitor.  
The run-off election will be held April 10. It was made necessary by the narrow margin. The 84-year-old former commander of the German armies missed obtaining (Continued on page four)

### ELEVEN DIE ON HIGHWAYS

Nine Deaths Reported from Virginia, Mississippi and Florida.

### TAX ON SALES DRAWS FIRE

Several Days Expected to Elapse Before Adoption or Defeat of Measure.

Washington, March 14.—(AP)—It looks now as though several days will elapse before adoption or defeat for the general sales tax in the revenue bill can be predicted definitely.  
The leaders of the House Democratic majority and of the administration Republicans believe they are making headway in convincing the membership that this tax at the factory on virtually all finished products, is the fairest means of raising the needed government income.  
But Representative LaGuardia of New York, the Republican independent who has taken the leadership against the tax, predicts it will be defeated and that his substitute plan or an alternative, providing heavy imports on specified industries and an increase in postage rates, would be put in the bill instead.

### EIGHTEEN MEN MAKE ESCAPE

Negro Prisoners Quit State Prison Camp After Blinding A Guard with Lye.

Raleigh, March 14.—(AP)—Eighteen prisoners escaped from three widely scattered camps of state's prison yesterday. It was announced this afternoon, including 11 men who got away from Stokesdale camp in Guilford county after one of the number had blinded a guard by throwing contents of a can of lye in his face.  
Three trustees "walked off" from the Elizabethtown camp in Bladen county and four men escaped from the Troy camp in Montgomery county.

Raleigh, March 14.—(AP)—Eleven negro prisoners escaped from the state's prison camp at Stokesdale, in Guilford county, late yesterday afternoon when one of the convicts threw the contents of a box of lye into the eyes of a guard and blinded him. It was announced at Central Prison here today.

The prison here had not been given full details of the affair today but officials were informed that a guard, whose name was not reported, was preparing to lock the prisoners in their quarters last night when a convict tossed the full can of lye in the guard's face as he marched by.  
Officials of the Guilford camp reported they feared the guard would be permanently blinded as (Continued on page four)

### Grant Moratorium After Death Of Noted Match King

Stockholm, Sweden, March 14.—(AP)—A brief moratorium, following closely on the suicide of Ivar Kreuger, Swedish match king, was extended to business interests by the Swedish parliament today and first applied to Kreuger's own concerns.  
The match king, director of one of the largest financial organizations in the world, shot himself to death in his Paris apartment Saturday.

When the bank most intimately connected with the Kreuger group opened this morning not a single person appeared to withdraw deposits. The same was true of all other banks.  
On request of the Kreuger and Toll Company, the parent firm, the cabinet extended until March 31, a moratorium on the firm's obligations and those of three smaller affiliated concerns, as well as on the liabilities of Kreuger's heirs and four of his associates, including Deputy Director Krister Littorin.

The local stock exchange was ordered closed last night until further notice.

### Rutherford Man Held in Rum Case

Rutherford, N. J., March 14.—(AP)—Henry Allison of Rutherford county was in jail here today waiting a hearing tomorrow on charges preferred by Garrett Edwards, county traffic officer, who said he arrested Allison when he found him transporting four pints of whiskey, a pistol, blackjack and shotgun.  
Edwards also arrested a man driving an automobile carrying an Ohio license plate after that machine had collided with one driven by J. S. Cowan of Marion.  
The officer said the man in the Ohio car gave his name once as R. C. Rogers and again Grady Ham. He said he was from Cincinnati, Chicago and Savannah. Edwards said he found in his car a loaded shotgun, a pistol and a gallon of spikes.  
At a hearing this morning Ham or Rogers, paid a \$325 fine on charges of reckless driving, carrying concealed weapons and driving under influence of whiskey.

### Charge Interests After Shoals For Private Gain

Washington, March 14.—(AP)—The Senate agriculture committee today charged a nation-wide propaganda campaign has been conducted to secure the power at Muscle Shoals for private gain under the guise of cheapening fertilizer for the farmer.  
In recommending enactment of the Norris bill for government operation of the plant, the committee charged those who have been seeking private production of fertilizer at Muscle Shoals to show good faith by accepting the alternative leasing provisions of this measure.

The Norris bill provides for operation of the gigantic \$150,000,000 project on the Tennessee river by the government unless the president negotiates a lease for private operation of the nitrate plants within one year from its enactment. Despite President Hoover's veto of the measure at the last session, it was reported to the Senate again without a dissenting vote.  
"Nation-wide propaganda has been going on more or less continuously during the last eight years, the committee said, 'the object of which has been to deceive the farmer and make him believe that a private lease of the Muscle Shoals property would demonstrate methods of cheapening the production of fertilizer. Behind this propaganda was always the real intent of getting possession of Muscle Shoals under the guise of a fertilizer proposition but with the intent and purpose of utilizing the power produced at Muscle Shoals for the private profit and gain of the lessee.'  
The committee said no fair offer for leasing Muscle Shoals had ever been made "which contained, in good faith, a genuine proposition to use the power there for the primary purpose of making cheap fertilizer."  
"In every bid," the committee said, "has always been discovered—a jobber which clearly showed—the lessee was using the fertilizer proposition only as a blind to gain possession for private profit of the lessee."

#### Consumption Of Cotton Shows Increase In U. S.

Washington, March 14.—(AP)—Cotton consumed during February was reported by the Census Bureau today to have totalled 450,018 bales of lint and 52,764 of linters, compared with 435,337 of lint and 50,241 of linters in January this year and 433,736 of lint and 53,687 of linters in February last year.  
Cotton on hand February 29 was reported held as follows:  
In consuming establishments, 1,633,389 bales of lint and 281,289 of linters, compared with 1,637,139 and 262,226 of January 31 this year and (Continued on page four)

#### RECORD FIRST IN 12 YEARS

Representatives Vote 227 to 187 Against Effort To Change Prohibition Law; Vote Forced Under Liberalized Democratic Rules by 145 Petitioners For The Measure.

Washington, March 14.—(AP)—The House of Representatives voted 227 to 187 today against taking up legislation designed to turn back control of liquor to the states.

The vote, putting the members on record for the first time in 12 years on prohibition revision, was on whether to discharge the judiciary committee from jurisdiction over the Beck-Linthicum resolution for amendment of the 18th amendment.

The roll call showed 114 Democrats and 112 Republicans, with Rep. Kvale, of Minnesota, the lone Farmer-Labor member, in opposition to the motion to consider the wet bloc's proposal.

Republicans favoring bringing up the legislation immediately, numbered 97, and the Democrats 90. The resolution in question, which now must stay rejected in committee, would in effect put up to the states an amendment for replacing national prohibition with a state control plan. Even if today's motion had prevailed, it would be necessary for those favoring the legislation to command a two-thirds majority in both Congressional branches before the proposed new amendment could be sent to the states.

The anti-prohibitionists held no hope of getting such a vote as this and even if they did it would be necessary for the proposed amendment to be ratified by three-fourths of the States before the change could become effective.

It was forced under the liberalized Democratic rules by 145 petitioners after the measure, sponsored by both Democratic and Republican wet blocs, was defeated in committee by 14 to 6. The petitioners numbered 76 Republicans and 69 Democrats.

Two of the foremost Democrats, Representatives Rainey, of Illinois, and McDuffie, of Alabama, the party floor leader and whip, respectively, voted in favor of the discharge motion.  
The 187 votes commanded by the anti-prohibition forces was larger even than many of them expected. Early estimates of their strength ranged from 160 to 180.

Turning upon whether a majority of the members voting wished to consider a resolution submitting to the people an amendment to place control of liquor under the individual states, the issue appeared closer than had been expected.

The leaders of the organized anti-prohibition groups, who have led a long fight to obtain this roll call, predicted they would obtain as many as 180 votes to take out of the judiciary committee the Beck-Linthicum resolution it rejected. It was possible that, if many members not anxious to get their names on this roll call should be absent, this number would constitute a majority and the resolution itself would have to be considered by the House then and there.

Other estimates, however, were that the total vote for consideration would not exceed 160, or 15 more than there were signers to the petition which compelled the House to consider the question. No one voted any expectation that his number could win.

Under the proposed amendment each state would have the choice of remaining bone dry, adopting a modified form of prohibition, or legalizing all alcoholic drink. The federal government would control interstate shipment for the production of dry states. Ratification would be in conventions of the people and not by legislation.

### To Aid Search For Lindy Baby

Raleigh, March 14.—(AP)—Capt. Charles D. Farmer, commandant of the North Carolina highway patrol, said today he would offer his services to negotiate for the return of the kidnapped son of Col. Charles A. Lindbergh.

Farmer said his offer was made "for the sake of humanity—the baby, his parents and womanhood."  
He offered to meet the kidnapers anywhere outside of North Carolina and New Jersey and negotiate for the return of the child.

### SEEK DEATH OF ATTACKER

Assault of Another Woman in Honolulu Brings Demand For Execution.

Honolulu, March 14.—(AP)—The third assault upon a woman on Oahu Island within two weeks brought demands today that the attackers be hanged under a new law providing the death penalty for such offenses.

The victim, Bernice Lum, 17-year-old Chinese girl, identified Joseph Young, burly Korean-Hawaiian, as the man who drove away her escort and assaulted her late Saturday night. Young was arrested yesterday.

The girl's body and throat were bruised.  
Miss Lum said she and Gilbert Halm, another Chinese, had left a private dance near Waikiki and were sitting on some neighboring steps when Young approached and ordered the slightly-built Halm to "scram." When the girl's escort obeyed, Miss Lum told police, Young choked and assaulted her.

### NEW JUDGE TAKES OATH

Benjamin Cardozo Formally Inducted As Supreme Court Justice Today.

Washington, March 14.—(AP)—Benjamin Cardozo today took the oath which made him an Associate Justice of the Supreme Court.

The judicial oath was administered by Charles Elmore Copley clerk of the court.  
The new justice smiled as he was escorted to his seat by the marshal of the court.

Just a few minutes before in the privacy of the robing room, Chief Justice Hughes administered the constitutional oath. In it the New York jurist swore to "support and defend the construction of the United States against all enemies, foreign and domestic."

The small court room was overcrowded for the final ceremony. Many attorneys could not find seats and stood against the wall.

Outside a long line of people awaited admission, among them Senator Coolidge, (D. Mass.), and the wives of many prominent officials.  
Justice Roberts delivered the first opinion after Cardozo took his seat at the end of the bench beside Justice Stone to succeed Oliver Wendell Holmes.

### Negro Held For House-Breaking

Rufus White, negro, alleged to have broken into a house here last October, was arrested by police over the week-end, and bound over to higher court following preliminary hearing this morning. He was remanded to jail in default of bond.  
The negro is charged with entering the home of John Vines, colored, stealing an iron safe and clothing. The safe, however, was left in the yard after the negro failed to break it open.

The rest of the state will sympathize with people along the coast who suffered so severely from the storm which lashed fishing villages and destroyed thousands of dollars worth of property.

This is the first time North Carolina has been hard hit by elemental disturbances in many years, although damage of a minor nature is reported frequently along the coast.

The storm came when the people of the fishing villages were already suffering from the effects of an unprecedented economic situation and their condition became pronouncedly more serious after their fishing nets, main source of income, were torn to pieces and sent to the bottom of the Atlantic.

While the occurrence is regrettable, relief agencies will do everything possible to alleviate suffering and help the fishermen come thru better than at first expected.

Democrats are responding liberally to the national executive committee's call for aid, judging by the report of the secretary issued the latter part of last week.

Over five hundred thousand dollars has already been contributed to the campaign, and it was expected the amount would be swelled considerably by the time for the election race.

The entire amount desired by the committee at the outset was \$1,500,000. This sum, it was said, will return back debts and enable the party to defray expenses of the forthcoming campaign.

Pitt county people have been given an opportunity to contribute to the cause and while the total amount subscribed has not been reported by the county chairman, it was expected it would measure up to expectation.

Democrats realize it is going to take money to put over the next drive for the presidency and it is believed the majority will give what they can to make this possible.

Old Man Winter has stuck steadfastly to this position during his final season of the year, but his life is short now with springtime just around the corner ready to carry cheer and happiness into the homes where fuel and food were difficult to get during the long, cold months.

Springtime is the busy season for this section of the county. It is the time when farmers begin tilling their soil in preparation for new crops—the things from which they derive sufficient income, to make life amenable. It is true they have done nothing big in recent years but if we are to believe those who have kept in close personal touch with the economic situation, better times are in the offing and with them will come improved prices for the products produced by our growers.

Lack of funds to finance farm operation is going to bring about noticeable curtailment of crops, but instead of being detrimental to the welfare of the people this should have a tendency to improve conditions. It will give a glutted market a chance to recover, and that means greater demand for current productions.

Farmers should keep this thought constantly in the forefront and instead of planting normal acreage cut until they are satisfied they have done their part in the general plan to effect an improvement in the field of industry.

Roosevelt forces and supporters of Al Smith were trying to seek a compromise the latter part of last week, and if the best interests of the party are considered, they will not only find a common ground of agreement but will refrain from any discussion which might work against the party's chance to win the race for the Presidency.

Discord at campaign time is the worst thing to be imagined and it is hoped party members will work for complete unity of thought and action and go to the convention at Chicago with a clearly definite purpose of what they are going to do.

This business of constantly arguing over candidates should be cast into the background and the sooner it is done the better the chance of the party to come through with colors flying.

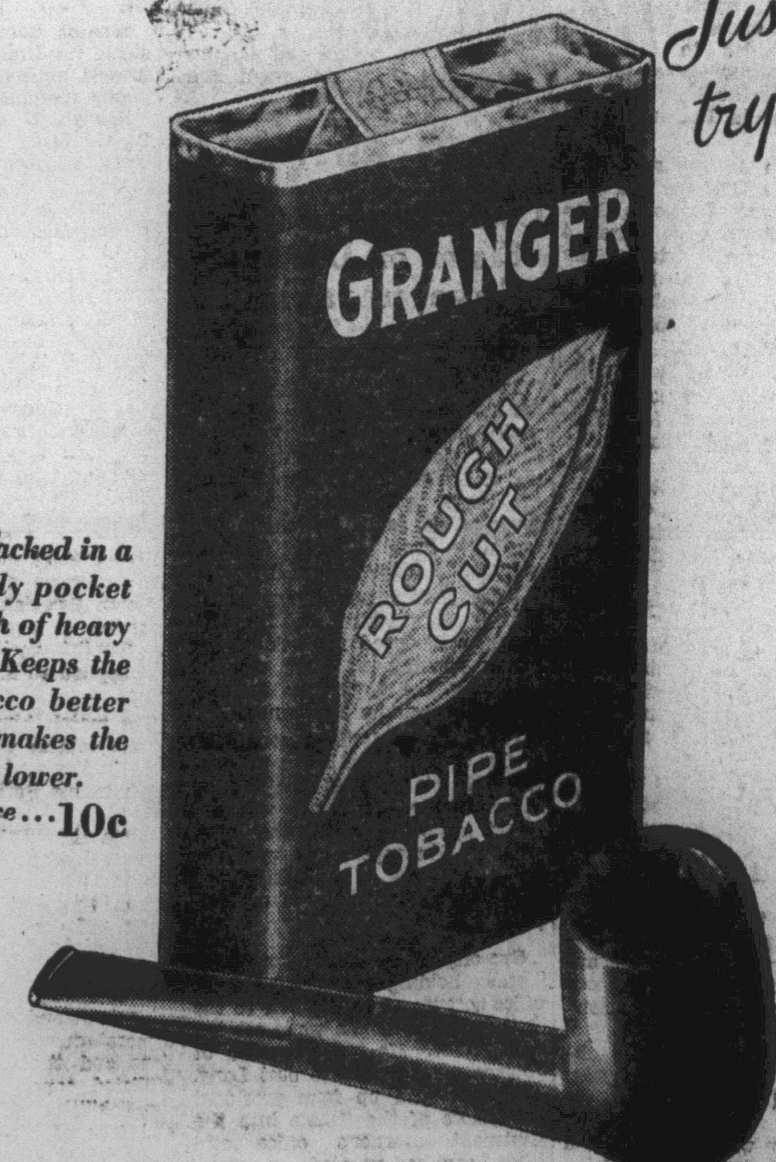

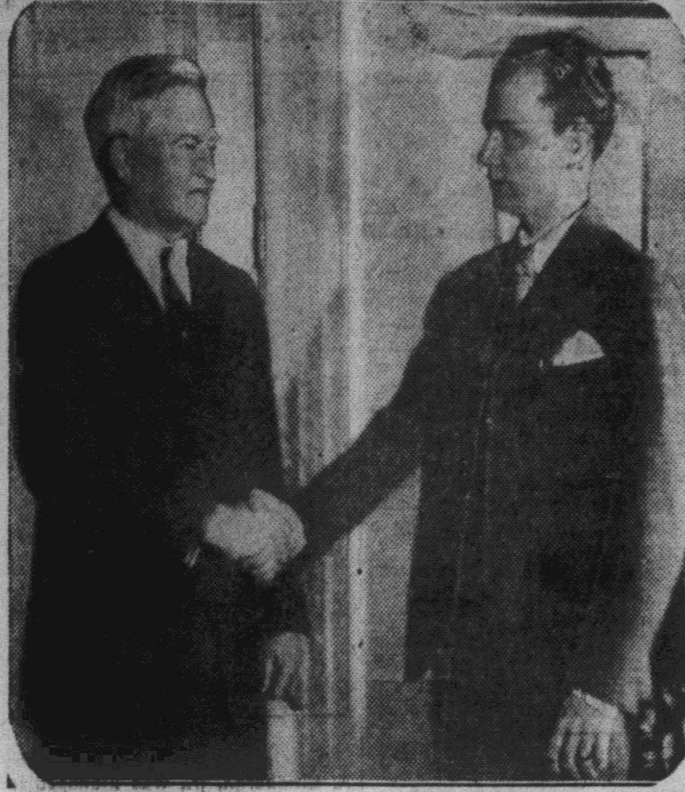

## Urges Return To Old Assessment

Beaufort, March 14.—(AP)—"We must return immediately to our long tested policy of quadrennial assessment," J. C. Ehringhaus of Elizabeth City said in a campaign speech here at noon today as he continued to stress the necessity for tax relief on real property.

Ehringhaus seeks the Democratic gubernatorial nomination. He is opposed by R. T. Fountain of Rocky Mount and A. J. Maxwell of Raleigh.

"The absurdity of any tax imposition which is based on false or fictitious values is apparent," Mr. Ehringhaus said. "Real estate values particularly are not static and to continue to levy taxes on the basis of values fixed under entirely different conditions is to practice not only self-deception, but cruelty and oppression."

"It is essential that we correct this fundamental error which stands at the threshold of our tax levies. The tax books, of course, should speak the truth; certainly the law should not assist in the perpetuation of a falsehood."

Ehringhaus discussed other phases of the tax problem, making the assertion that governmental officials should have the proper regard for the taxpayers' dollar, which is a patriotic contribution of the citizen, often the equivalent of agony and bloody sweat.

Ehringhaus will visit five other Eastern Carolina towns this week. Tonight he will be in Atlantic, Tuesday night he will speak at Kingston and Wednesday at noon he talks at Smithfield. Wednesday night he is scheduled to talk at New Bern and Thursday night he will speak at Goldsboro.

## Soviets Force Down Jap Plane

London, March 14.—(AP)—An Exchange telegraph dispatch from Harbin, Manchuria, today said a Japanese airplane was reported to have crossed the Siberian border at Pogranichnaya where it was surrounded in the air by Soviet Russian planes which pursued the Japanese ship and forced it down.

The dispatch also said that in a riot at Manchuli, on the Siberian border, a number of Japanese stores were looted and a Japanese merchant was killed.

A division of the Japanese army in Manchuria was ordered to the frontier to restore order in what was regarded as a serious situation.

Observers thought, the dispatch said, that this approach by Japanese troops to a point so close to the border as Manchuli might be particularly dangerous in view of the recent mobilization of Soviet troops on the border.
