Leaders Expect Direct Vote on Dry Amendment After an Understanding

NORRIS READY TO MEET TEST

Senator Blaine Announces Hearings Will be Reopened by the Senate Judiciary Committee on Proposals for Repeal of 18th Amendment and Modification of Volstead Act; Half Score Measures Await Action

Washington, March 25.—(AP)—The House ways and means committee today appointed a subcommittee to draft proposals designed to bring in about \$600,000,000 of revenue to replace the amount stricken out of the new tax yesterday when the House rejected the sales tax.

Acting Chairman Crisp announced after an executive session of the committee that it was hoped the sub-group would be able to lay the proposals before the full committee not later than Monday.

"The bridge is off, and the subcommittee can recommend anything it desires including items in the original Hoover-Mellon-Mills program," the Georgia Democrat said.

Representative Ragon, an Arkansas Democrat, was designated as the chairman. Other members are Representatives Vinson of Kentucky and Canfield of Indiana, Democrats; Hawley of Oregon and Treadway of Massachusetts, Republicans.

Washington, March 25.—(AP)—A direct vote on one of the general prohibition amendments proposals offered is expected in the Senate shortly as a result of an informal understanding adopted by wet and dry leaders.

Chairman Norris of the judiciary committee, staunch dry, said he was willing to have one of the resolutions reported from his group, with an aversive report if he need, in order to permit a roll call.

Senator Tyding (D. Md.), indicated he would drop his plan to force a vote on compelling the committee to return the various proposals to the Senate.

This decision hinged on a desire of other anti-prohibitionists to have the vote unprejudiced by external considerations, to constitute a clear record of the membership's stand on prohibition itself.

The Senate is overwhelmingly dry and Tyding's motion is expected to meet a defeat which would prevent the direct vote wanted.

Senator Glaine, (R. Wis.), today announced hearings would be opened on April 14 by a Senate judiciary sub-committee on proposals for repeal of the 18th amendment and modification of the Volstead

There are half a score of measures pending proposing various prohibition changes. Lengthy hearings are in prospect but Blaine gave assurance that the committee would conclude in time to permit a Senate vote.

Chairman Norris of the judiciary committee also gave consent to requests of the anti-prohibitionists for a report on the legislation to the Senate. The report doubtless will be adverse, the prohibitionists claiming full command in the Senate.

Blaine said the hearings will be deferred to April 14 because some of those desiring to testify wish two weeks notice.

Senator Bingham (R. Conn.), will seek action next week by the manufacturers committee on his bill to authorize four per cent beer.

LINDBERGH'S SEE NO HOPE

Little Significance Attached to Reported Negotiations at Norfolk, Va.

Norfolk, Va., March 25.—(AP)—The Reverend H. Dobson-Peacock said today that completion of negotiations for the return of the kidnapped Lindbergh baby are not only hoped for but expected within the next few days by Norfolk men acting as intermediaries.

Neither of the three intermediaries—Dean Dobson-Peacock, Rear Admiral Guy H. Burrage, retired, and John Hughes Curtis—would discuss the details of the negotiations.

Admiral Burrage reiterated his assertion that any information concerning the move to recover the 21-month old infant must come through Colonel Charles A. Lindbergh. Mr. Curtis did not care to discuss the matter.

"We not only hope, but expect the completion of negotiations within a few days," Dean Dobson-Peacock said.

He expressed regret for publicity given to the activities of the Norfolk intervenors and expressed fear that it would "jeopardize a good clue."

Hopewell, N. J., March 25.—(AP)—Police at the Lindbergh home announced today that Col. Charles A. Lindbergh himself had come to the conclusion that information brought by three citizens of Norfolk, Va., had "no specific significance" in the investigation of the kidnapping of the Lindbergh baby.

When Col. H. Norman Schwarzkopf, superintendent of state police was first told yesterday of the report that the Norfolk men had information indicating the baby might be on a yacht in Chesapeake Bay he said it was "absolutely untrue."

In his night bulletin from the Lindbergh home, where he is in general charge of the police search for the kidnapers, Schwarzkopf modified this statement. He said then that the Norfolk men had

Red Tape Blocks Government Help for State Banks

Raleigh, March 25.—(AP)—Gurney P. Hood, state banking commissioner, has lost the hope of speedy aid for closed banks of the state which he at first placed in the Reconstruction Finance Corporation. He indicated here in admitting that government red tape had blocked expected speedy replies to his applications.

He said he feared the state law, allowing sale of bank assets, but not mentioning the possibility of pledging them for loans, might have to be amended before the frozen paper could be turned into dividends for depositors who have \$50,000,000 tied up in the state's closed banks.

Monroe, N. C., March 25.—(AP)—Will McCray, merchant, living near here, is minus \$50 today for violating a custom. Last night he placed the bills in a paper sack with small cash. This morning he distributed his silver and, as was his custom, threw the sack into the fire. He forgot to remove the \$50 in bills.

KIDNAP SCARE HITS CAPITAL

Extortion Notes and Threats Received by Several Prominent Persons.

Washington, March 25.—(AP)—A police guard was removed from the home of Mrs. Alice Roosevelt Longworth today at her request but there was no let up in the watch over the home of Sir Wilmott Lewis Washington correspondent of the London Times, nor in the search for the sender of extortion notes to them.

While the notes to the widow of the former speaker of the house did not contain a direct threat against her daughter, Paulina, the child is being kept under constant watch.

The letters to Sir Wilmott were more direct. They demanded \$1,500 and threatened his five year old son, Wilmott, Jr., if the money were not paid.

Police said about a dozen other prominent persons in the capital had been threatened by similar letters in recent weeks.

Washington, March 25.—(AP)—A kidnap scare swept the capital today after police disclosed that extortion notes, accompanied by threats, had been received by Mrs. Alice Roosevelt Longworth, Sir Wilmott Lewis and London Times correspondent, Ben Lyon of the movies, and others.

Police, however, predicted an early arrest. They were working on the theory that one man was responsible for the notes.

DEAL SPEAKS AT LIONS CLUB

Insurgents Make Offer for Peace

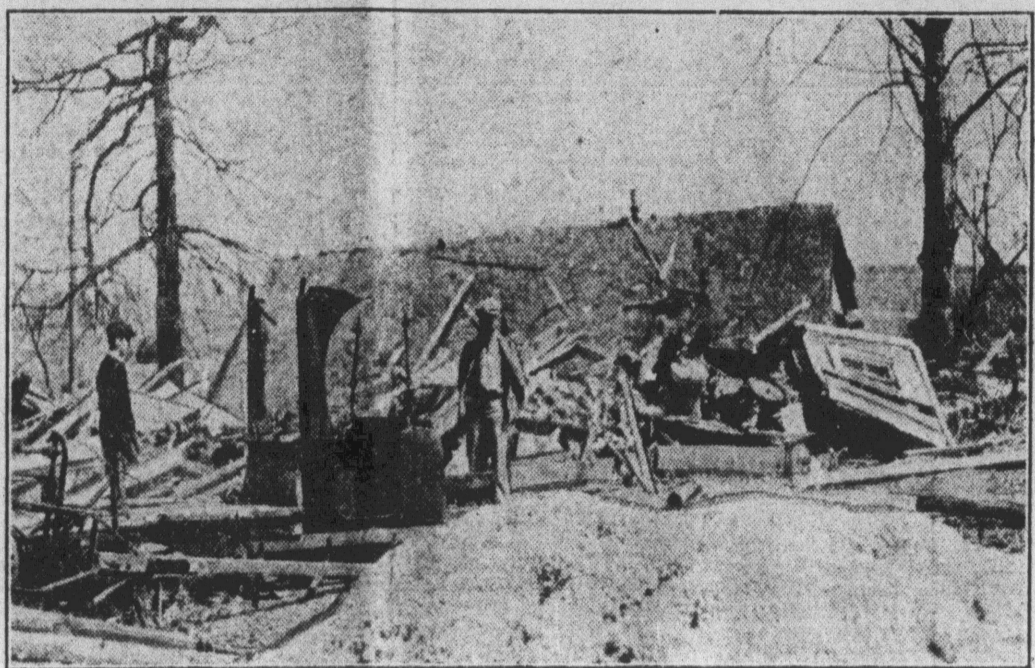
Harbin, Manchuria, March 25.—(AP)—A Renpo (Japanese) News Agency dispatch today said the Kirin province insurgent, General Ting Chao had made overtures for peace just as a converging movement was starting in his forces.

As two contingents of General Jiro Tamon's troops moved on the Chinese irregulars in Eastern Kirin, a group of Ting's men came to Harbin and made an offer to surrender to the Japanese command.

The insurgents, through General Wang Chi Hsu, pleaded that General Ting was en route from Fangcheng to surrender formally with a plan for disarming his troops.

A half dozen clashes between Japanese troops and irregulars had occurred in Kirin this week causing casualties including nearly 300 dead, most of them Chinese.

Manteo, N. C., March 25.—(AP)—Dare county's recently storm-whipped water brought to fishermen this week the best shad catches in 10 years.

Leaders Rush to Repair Damage to Revenue Bill

Washington, March 25.—(AP)—Stripped of its general sales tax by a sweeping vote of the House, the one-time billion dollar revenue bill today was a mere hulk, but the defeated leaders rushed to repair the damage with an alternative program that still would balance the budget.

They fell back on the original treasury proposals for heavy excise on automobiles and radios; for a one-cent tax on gasoline; stamp taxes on checks and drafts; three-cent postage and similar levies. Act (Continued on page six)

NEGRO SLAYER ROTES TO MEET DIES IN CHAIR HERE APRIL 14

John Robert Myers Executed at Raleigh for Death of Hagan Hodges

Raleigh, March 25.—(AP)—Smiling and apparently unafraid, John Robert Myers, confessed negro slayer of Pitt county, died in the electric chair at state's prison today, Good Friday.

Myers was convicted of shooting R. H. Hodges, storekeeper at Pactolus, while he was robbing him.

The 30-year-old negro entered the little octagonal death chamber at state's prison at 10:32 and was seated in the chair. His last words were "good morning, gentlemen," spoken in a clear voice.

After two shocks of electricity, one of 2 minutes and 15 seconds and the other of 1 minute and 25 seconds, Myers was pronounced dead.

He left a note for newspapermen in which he expressed the hope "my fellowmen will profit by my downfall."

The body was claimed by Myers mother, Emily Daniel of Greenville and will be taken there.

Hagan Hodges, postmaster and operator of a store at Pactolus, was fatally shot by Myers on Saturday night immediately following the Christmas holidays.

Myers went to Hodges' store at night and asked to see some shoes. After inspecting the stock, he walked down a path between the store and Hodges' home and waylaid the storekeeper as he started home.

Hodges was shot and robbed of \$10. His injuries were not believed to be of a serious nature at the (Continued on page six)

New Method for Speeding Growth Tobacco Plants

Goldboro, March 25.—(AP)—Here's a new method some Wayne county farmers have found to combat the cold spring that have hindered tobacco planting.

Tobacco beds have been damaged farmers say, by the late cold and so they are soaking seed for new beds in sweet milk before planting.

John Holmes of Indian Springs, explained the process.

"It's too late to plant in the usual way to get good plants in time to set out," he said, "so I soaked re-planting seed in sweet milk for 24 hours. That starts germination and when the plants are put into the ground they start coming up immediately."

PEACE CONFAB LACKS IN CHINA

Japanese and Chinese Armies Engage in Skirmishes Around Shanghai

Shanghai, March 25.—(AP)—Sino-Japanese peace negotiations lagged perceptibly today, while armies of the two nations engaged in sniping and skirmishing a few miles outside Shanghai.

Each blamed the other for a clash between outposts near Kaiting, and neither had an official explanation of sniping between troops in the vicinity of Chiawanmiau, incidents which added to the general uneasiness.

The Chinese defied the 121-2 mile limit ultimatum of the Japanese when they occupied Chiawanmiau recently, and they have shown (Continued on page six)

W. H. COVERT IS SPEAKER

Immanuel Baptist Minister Delivers Sermon at Union Services Today

Rev. W. H. Covert, spoke on the "Comments of the Cross," at the service this morning at Jarvis Memorial Methodist Church.

The speaker took his congregation with him to look again upon the scenes of the cross as he called attention to the many developments on the day of Jesus' crucifixion.

The third comment mentioned was that of despair which was illustrated by one of the malefactors who spoke with no hope in what he said, "If thou be the Christ save thyself and us."

Asheville Man Held for Murder

Asheville, March 25.—(AP)—Liston Hayes, well known Asheville man, today stood indicted as an accessory after the fact in the death of William B. Hough, whose wife is charged with murder.

A coroner's jury held Hough's death was suicide, but an investigation resulted in presentments to the grand jury. Hayes admitted at the hearing that he was in the Hough home when the shooting occurred but said he could only see Mrs. Hough, who did not fire.

Ellis Faces Trial Alone

Mocksville, March 25.—(AP)—Tom Ellis, Jr., 29, continued on trial alone in Davie Superior court today after Richmond Bailey, 19, his original co-defendant had pleaded guilty to manslaughter in connection with the death of Willie Beachamp, 21, and testified that Ellis did the actual shooting.

Bailey, said the shooting, which occurred near Advance in February, took place after a quarrel between Ellis and Beachamp over liquor.

The trial was expected to consume today and most of tomorrow.

With Steady Growth of Delegates for Roosevelt and Hoover, Prohibition and Sales Tax Issues Beg to Receive Spotlight; Nebraska's Primary in April Expected to Furnish Clear Cut Test

Washington, March 25.—(AP)—While the political headlines busily record the steady growth of delegate support behind Herbert Hoover and Franklin D. Roosevelt, events elsewhere also are writing important history in both political parties.

For the Democrats, and particularly for the Presidential aspirations of Speaker John N. Garner, the tax battle in the House has taken on political aspects of extraordinary significance. Among the Republicans, a major under-surface agitation centers about new demands from both sides with respect to prohibition.

Garner's supporters have presented the record of his House leadership, as outstanding proof of his availability for the Presidency. Now his espousal of the sales tax has been accompanied by at least temporary loss of control, and by political reversations or exceeding expectations.

What will be the ultimate effect on his chances among the voters? The speaker's friends declare he will not suffer greatly in the long run, although they plainly are concerned at the embarrassments that have clustered about him just at this stage of the campaign.

The making of a tax bill is a long process. It still is possible, by some sudden stroke, much of the prestige it unquestionably has lost during the past week.

Georgia's sweeping endorsement of Roosevelt at Wednesday's primary is a barometer of disputed reliability in his coming test of strength with Garner, who was brought into the picture by those convinced he was best qualified to head off the fast-moving Roosevelt boom. In Georgia Garner was entered only by proxy, and by a proxy without outstanding popularity in the state. The result was about what both sides expected.

A more clear-cut test—and probably the first—will be furnished by the Nebraska primary on April 12, in which Roosevelt, Garner and "Alfalfa Bill" Murray all are entered.

O course, from Roosevelt's viewpoint, Georgia is important. The primary demonstrated in a southern state the same vote-getting ability New York's governor already had shown in North Dakota and New Hampshire. To that degree it increased Roosevelt's prestige at a critical time, and its effect was accentuated when another southern state, Kentucky, virtually was promised the Roosevelt managers by Senator Alben Barkley.

Roosevelt now has definitely-recorded pledges of 85 delegates out of the 700 and odd he needs. He is sure to pick up a great many more during the coming month, and most estimates of his first ballot strength range from 500 upward. Then it will be a question of the staying qualities of the fifteen or more candidates against him.

Easter Weather Still in Doubt

Washington, March 25.—(AP)—The weather man shook his head doubtfully today when he was approached about the subject of Easter.

"It may be warm and rainy," he said rather sadly. "Or it may be fair and colder."

Smoothing out his weather maps, he bowed that showers will set in tomorrow and continue until tomorrow night over most of the United States.

The doubt in his mind is whether a disturbance now over the Dakotas and Montana will swing eastward rapidly enough to pass over there by tomorrow night, leaving fair skies and cooler breezes for Sunday.

If the colder weather comes, virtually the entire country east of the Mississippi will have fair weather except along the Great Lakes where light rains and snows may fall.

TESTIFIES ON BANKING BILL

New York Banker Says Formation of Credit Corporation Was Not Voluntary

Washington, March 25.—(AP)—A statement that formation of the National Credit Corporation last October by bankers was not "voluntary" but was undertaken on the assurance of President Hoover that the Reconstruction Finance Corporation would be formed to take over its work was made before the senate banking committee today by Percy H. Johnson, president of the Chemical Bank and Trust Company of New York.

The statement was made during hearings on the Glass banking revision bill when Senator Glass (D. Va.) recalled the contribution of leading banks to the National Credit Corporation fund to aid smaller banks and used the word "voluntary."

Johnson who opposed the Glass bill replied that he would not describe the action as voluntary.

"I was in that conference at Secretary Mellon's home" he added.

"President Hoover told us he had talked to leaders in Congress and that as soon as Congress met it would form the Reconstruction Corporation to take us out of this position."

"Then you didn't do it voluntarily?" asked Senator Glass.

"We were asked to do it on that basis as a quick stop gap and we did it," Johnson replied.

Wooten Case Nearing Close in Court Here

One of the longest civil cases heard in the local courtroom in years, that of the Commissioner of Banks against Judge F. M. Wooten, was nearing completion today.

Argument was begun this morning following completion of presentation of evidence by the defense yesterday afternoon.

The Commissioner of Banks is attempting to set aside a deed of transfer alleged to have been made by Judge Wooten prior to the closing of the bank preventing the recovery on a \$6,100 stock assessment.

The commissioner contends Judge Wooten, who was vice-president of the institution when it closed in January over two years ago, was aware of the condition of the bank when the alleged transfer was made.

Judge Wooten contends that he had no knowledge of the bank's weakness and was perfectly justified in the transfer of his property.

The case was begun Monday after court had disposed of a damage suit, and was expected to be brought to a close during the late afternoon. Presentation of testimony by the defense was begun Wednesday morning and was not completed until late yesterday.

Considerable evidence dealing with affairs of the defunct bank was brought into play from day to day, and the battle has developed into not only the longest but the most stubbornly fought witnessed here in years.

Still Captured in Pactolus Area

Federal and county officers captured a steam distilling plant and two hundred gallons of beer in a raid in Pactolus township late yesterday afternoon.

Two white men were said to be preparing the plant for operation when they were warned by outposts of the officers' approach. They jumped into a canal and escaped.

Officers said they recognized the operators and that warrants would be issued for their arrest.

High Prepares for Successful Baseball Year

Rome Observes Good Friday

Rome, March 25.—(AP)—Frenzied at the altars of Rome's 400 churches black-robed Catholic priests today commemorated Good Friday, the anniversary of the death of Christ.

In America, Europe, Asia, and Africa, priests and bishops and churchmen of the highest rank prostrated themselves at that point in the ritual which recurred the death of their spiritual leader.

Professions of the faithful here went this morning to the churches of St. Peter's, St. John's, and Holy Cross, where relics of Christ's passion and death were on display.

Thousands crowded the Holy stairs next to St. John Lateran church. These they believed were the stairs Christ ascended in Pontius Pilate's house after he had been crowned with thorns. Tradition has it that St. Helena, mother of the first christian emperor of Rome, Constantine, brought them to Rome from Jerusalem.

The worshippers ascended the steps only on their knees, stopping on each step to recite a prayer. At the top of the stairs they knelt before a little chapel containing a painting of Christ supposed to have been made by St. Luke on wood.

Organs and church bells were silent today. Principal parts of the masses were announced to the congregations by wooden clappers shaken by altar boys. At one point in the ceremonies, priests took off their shoes, knelt and kissed a large crucifix on the altar steps.

Between noon and 3 p. m., the hours when Christ hung on the cross, Rome was like a dead city, most every one being either at church or at home.

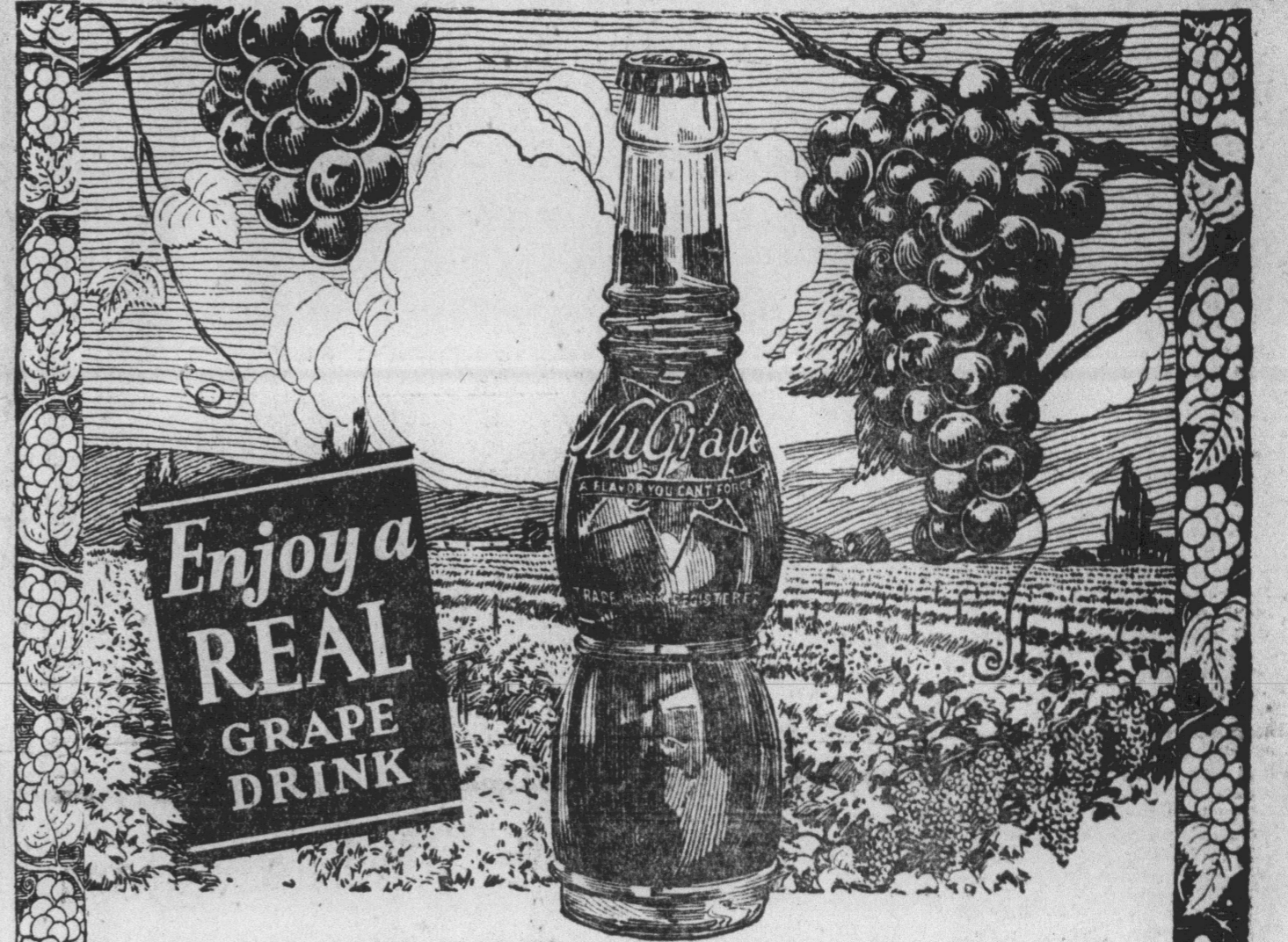

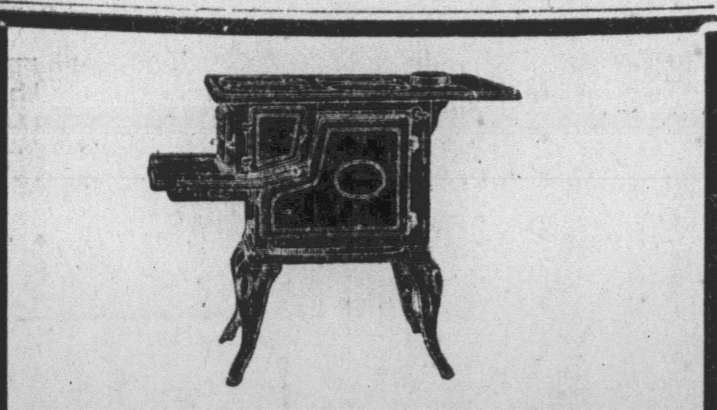

Jacksonville, Fla., March 25. — (AP)—Faith in the New York Yankees, hope in the Washington Senators and a charitable belief in the potency of precedent may combine to make things tough for the Philadelphia Athletics in this year's American league pennant race.

Even so, it is extremely difficult to figure just how Connie Mack's formidable cast can be stopped from making it four in a row, and a league record, unless the opposition has some novel plans, hitherto concealed, to check Grove, Barnshaw, Walberg, Simmons, Cochran and Fox.

So long as the A's have this six-ply backbone, they cannot be regarded otherwise than as strong favorites again to win the American league flag. Their pitching outclasses that of any other club in the league. They have the punch to slug it out with any rival, even the Yankees, and Connie Mack's reserve strength, on which he rode down the stretch last season, looks to be even better.

Mack admits real fear of the Yankees and their "murderers' row" but it is difficult to see how the New Yorkers can displace the A's without big improvement in the pitching corps. The Yanks have picked up a real star in Shortstop Frank Crosetti, who forms a new-keystone combination with Otto Salzgaver and hope to develop some pitching help for Gomez, Ruffing and Pipiras.

Although the rest of the American league clubs manifest improvement, especially the Browns and White Sox, Washington is the only one justifiably considered a pennant possibility. The Senators couldn't stand the pace last year but they have speed, pitching and defensive strength, to which has been added the punch of Outfielder Carl Reynolds.

If Cleveland could combine its best features with those of Washington, this would be a different story. The Indians carry a real sock, which has been especially damaging to the Yankees, but their defensive is spotty and they still lack first class shortstop. Manager Roger Peckinpaugh, however, has acres in Ferrell and Averill.

The Browns, best of the second division clubs, have an outside chance to crash the first four, with the aid of excellent pitching and a fast, aggressive attack developed by Bill Killefer.

The Boston Red Sox, who surprised even themselves by finishing sixth last season, rely on pitching to keep them there, despite the dash of big Ed Morris. To combat them, Detroit and Chicago both have conducted major shakeups.

Bucky Harris pins the Tiger hopes on improved hurling, plus the return to form of Charley Gehring at second base, and fresh outfield punch. The White Sox, newly in charge of Lew Fonseca, depend on a revamped infield, the return of Ted Lyons to a place among the games' great right handers and the conversion of Big Smead Jolley from an outfielder to a catcher.

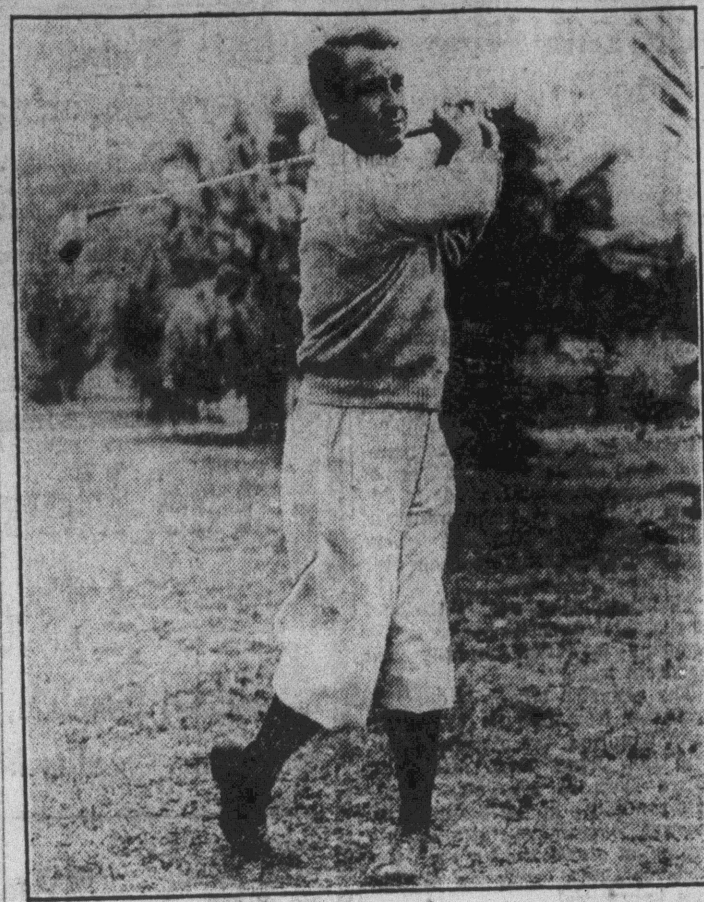

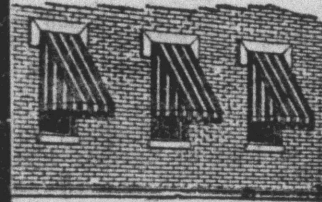

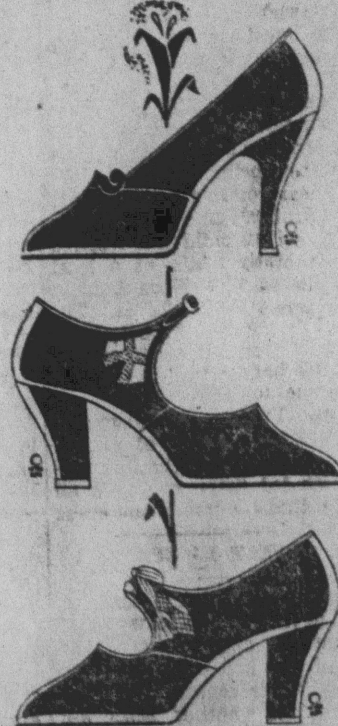

SLOW TO OKAY RAILWAY LOAN

I. C. C. Grants \$12,800,000 to Missouri Pacific With Reluctance

Washington, March 25.—(AP)—The Reconstruction Corporation has caused the Interstate Commerce Commission to approve "with some reluctance" an additional loan of \$12,800,000 to the Missouri Pacific Railroad Company.

The approval will take care of, among other things, half of a loan of \$11,700,000 held by New York banks which J. P. Morgan and Company had notified the carrier must be paid on April 1. Later, however, the banks agreed to carry half the loan until October 1 and the board of directors of the finance corporation voted a loan of \$5,850,000 for this purpose, subject to approval of the commission.

The commission's decision recited in full the resolution of the finance corporation.

"We are taking the action here with responsibility for determining commission. We are not convinced that the Reconstruction Finance Corporation should be expected to take up bank loans of this character.

"We yield our own views to those of that body which, as we construe the law, is charged by Congress with responsibility for determining the question."

Although J. P. Morgan and Co. were named by the Missouri Pacific in correspondence with the commission as having spoken for the holders of the bank loans the decision disclosed that they were held jointly by J. P. Morgan and Company, Kuhn, Loeb and Company, and the Guaranty Trust Company, of New York.

"The bankers who hold the loans are bankers for the carrier," said the commission in commenting. "As such they have profited largely in handling its financing in the past."

"It is often represented to us that the relation of a banker to a railroad is very valuable to it because of the banking assistance so rendered available in time of stress; that a railroad can afford to compensate its bankers well in connection with its regular financing in order to have such support available when it is needed.

"We have heretofore thought that theory to have more merit than this transaction appears to indicate."

On direct examination, Dr. Leonard replied to a question by H. E. Rife, of state counsel, that he believed the girl died of poison.

The fatal dose was administered to her two hours before Elizabeth died last September, Dr. Leonard said he believed.

Markets Closed for Holidays

New York, March 25.—(AP)—Good Friday found most of the world's financial markets closed. In New York security and commodity exchanges suspended operations, although the banks were open. European markets generally observed the day and some of them will not open until next week. The New York stock and curb exchanges will resume tomorrow, but several commodity markets, including the cotton exchange, closed for the entire week-end.

Wall street had to wait until tomorrow to see what effect defeat of the sales tax would have on security prices here. The vote came after the New York close yesterday, but in San Francisco and Los Angeles receipt of the news was followed by a decline in quotations and an increase in trading volume.

no disposition to retire across Soochow creek as the Japanese have demanded.

The delegates—Chinese, Japanese and neutrals alike—emerged from a three hour session of peace negotiations with weariness written on their faces, although the official communique noted, as usual, "some progress was made."

The Chinese insisted there was no advance in negotiations. The Japanese cautiously reiterated that three points were discussed, the remainder of Chinese troops in their present positions, withdrawal of Japanese forces, and the selection of a joint board to supervise the withdrawal.

Japanese military authorities said they "hoped positive measures would not have to be taken," at Chiawangshiao, and announced the continued movement of troops of the 11th division toward Tokyo.

Another disconcerting incident was an attempt on the life of T. V. Soong, finance minister of the Nanking government, the second in recent months.

A bomb exploded in the garden of his former home and a daughter of his gardener there was seriously injured. The planter of the bomb apparently was unaware that their intended victim had departed.

responsible for several if not all of the threats, which involved promise of kidnapping Sir Willmot's young son unless \$1,500 were paid.

A police guard was placed at his home, and detectives also are watching Mrs. Longworth's. She too was told to pay \$1,500 but Pauline, her seven-year-old daughter, was not threatened directly. Definite instructions were received by twice as to how to pay the money.

An agent followed the instructions, driving slowly in a taxi by the chosen spot for depositing the amount, but the promised signal from the extortionist did not develop, and the affair fell through.

The Lewis case bothered police most as the threats have been direct and to the point, with two letters and a telephone call. The notes in this and the Longworth case were taken to the Bureau of Standards for a comparison to determine whether one person was responsible for both.

In the case of Ben Lyon, a note demanding \$500 and threatening the safety of his child was received by him recently while at a local hotel with his wife, Bebe Daniels. The child was in California. The letter was signed A. A. Carpenter, and requested an answer to care of general delivery. A trap at the post office failed to catch anyone.

Washington hospital where he was carried immediately after the shooting, but complication developed and he died a few days later.

Myers abandoned a stolen automobile and fled to Greenville where he was later captured. He confessed the crime after officers found a flashlight and bunch of keys identified as property of the slain man.

Within three weeks after the shooting, Myers was tried, convicted and sentenced to die in the electric chair February 29. Execution was stayed while appeal was argued for a new trial, but this was denied by Supreme court and execution was set for today.

The negro also confessed to two separate holdups of a nightwatchman at a local tobacco plant. A pistol was taken from the watchman each time, and one of the weapons was used in the Paeolus holdup.

been to the Lindbergh house on Tuesday and that their information had been investigated and found to have no "specific significance."

It was generally supposed that this was simply Schwarzkopf's own conclusion, but today the police chief announced that he had been speaking for Colonel Lindbergh, that Colonel Lindbergh had had the investigation made himself, and that Colonel Lindbergh still believed the information from Virginia to have no "specific significance."

"The Rev. Dobson-Peacock and two other citizens of Norfolk are not negotiating for the return of the baby so far as the police authorities at Hopewell know," Schwarzkopf said in his formal morning bulletin today, issued just after his statement that Colonel Lindbergh and not himself was the source of the "no specific significance" conclusion.

"They visited Col. Lindbergh and gave him information which on investigation was found to have no specific significance in this investigation."

"There is no positive evidence of any kind indicating that the kidnapers fled by way of the Delaware river or Chesapeake bay. The coast guard along the bay has made no report to these headquarters."

Although he made no mention of this in his formal bulletin Schwarzkopf told reporters that police were now looking for a third man besides Harry Fleischer and Abie Wagner, who he has referred to as "known kidnapers." He refused to disclose the identity of the third man sought.

In his bulletin Schwarzkopf denied that police had conducted any negotiations with underworld characters. He specifically mentioned Salvatore Spitalo and Irving Bitz, the "go-betweens" named by Col. Lindbergh, saying the police had never had any communication with these men "or other men of this type."

states early this week had been "vastly under-estimated" and announced establishment of central relief headquarters here.

The new set-up, he explained, will handle relief and rehabilitation operations in thirteen Alabama counties, ten in Georgia and six in Tennessee, the states hardest hit. Maurice Reddy, assistant director of disaster relief for the Red Cross, has been called here from Washington to direct the work.

Today the total known dead stood at 362 divided between Alabama with 299, Georgia with 40, Tennessee with 18, South Carolina with 3 and Kentucky with 2.

Unofficial estimates placed the number of injured above 3,000 and the homeless at 8,500. Property damage estimates ranged from \$3,000,000 to \$5,000,000. Numbers of relief workers sent in reports that conditions had been found to be far worse than was realized at first.

Colonel Hartley A. Moon, adjutant general, sent two planes over the storm area to contact relief centers for speedy distribution of supplies where the need was greatest and in Georgia, Governor Richard B. Russell, Jr. issued a proclamation calling on Georgians to rally to the aid of storm sufferers. A similar proclamation already had been issued by Governor B. M. Miller of Alabama.

Most of the dead had been removed from the wreckage and buried and the relief agencies now are concentrating on hospitalization of the injured.

ing Chairman Cris) of the ways and means committee doggedly called his group back to work this morning on the gap-filling assignment. He had sought to turn the job over to someone else after the revolters had smashed his bill but a resounding ovation from the entire House membership compelled him to carry on.

The new taxes will have to produce nearly \$600,000,000 to take the place of the general sales tax and to reestablish financial stability for the government. Several of the proposals offered in the treasury program are expected to meet a hard fight but the leaders of the forces which defeated the sales tax joined in calling for a balanced budget.

From callers at the White House, came word that President Hoover deeply disturbed at the 223 to 153 defeat given the sales tax, believed the bill should be entirely rewritten by the ways and means committee, rather than undergo a patching-up process on the floor. But Cris showed no sign of accepting this plan and the other Democratic leaders were backing him up.

The stupendous victory of combined Democratic and Republican groups which voted to strike the regular leaders, was called a victory by the committee members—spokesmen, LaGuardia (R., N. Y.), Doughton (D., N. C.), and Rankin (D., Miss.).

"Now we have won our victory against the principle of a sales tax," said LaGuardia. "We should cooperate with the committee in selecting sources for taxation to balance the budget."

But he promised no wholesale acceptance of the treasury program and probably will seek to supplant portions of it with plans of his own, including a tax on stock exchange transactions.

A sensation in the finale of the sales tax route was the desertion of the cause by Representative Burns of Tennessee, Democratic chairman of the appropriations committee, who went so far as to advocate abandoning for the present any idea of budget-balancing. His post is that of "watchdog of the treasury," and he heads the special committee on economy which hopes to reorganize the government executive agencies to effect our savings.

Edgfield, S. C., March 25.—(AP)—The Southern Gold Mines Corporation has been organized by a group of western men to reopen the old Landrum Gold Mine, in this county, which has lain idle for 70 years.

An option on the mine was obtained some time ago by Harry W. Ingalls, mining engineer, of Millan, Idaho, who interested other western mining men in the project.

This week, Jerome L. Drumheller of Spokane, Wash., was represented as one of the developers, of the Drumheller Coal Fields in Alberta, Canada, and the owner of the Fern Gold Mine at Willow Creek, Alaska, came to look over the property.

Mr. Drumheller was introduced as the chief financial backer of the company interested in the old Landrum mine.

The Landrum mine was operated profitably from 1853 to 1859 by Dr. John Landrum, the original owner, with Col. James Dorn and Capt. James Dorn as associates. Business conditions at the beginning of the war between the states and the freeing of slaves during the war made continued operation at that time impractical.
