BABY SEARCH SWINGS OVER TO CAPITAL

Col. and Mrs. Lindbergh Expected To Make New Appeal to Kidnappers.

Washington, Mar. 26.—(AP)—A sudden, unexpected tip today swung the feverish search for the Lindbergh baby and his kidnapers into the center of the capital.

As hopes alternately rose and waned from the many clues being followed hither and yon about the country, a man greatly resembling Harry Fleischer, reputed leader of the Detroit purple gang—badly wanted for questioning in connection with the case since he dropped from sight some time ago—sought lodging last night on an obscure Washington street.

It was nearly midnight. Four youths who saw him at another man walk to the door, noted a small car outside. In it sat a woman and a baby. They recalled news pictures of Fleischer and when the men had been turned away for lack of room, called the police.

From the rogues' gallery officers said, they immediately picked out Fleischer's picture. By radio and teletype the authorities sent orders to spot the car or the men and call reserves. Cruising police autos, radio-equipped, carried on an incessant watch through the night.

The police were certain the group had found lodging in the city either in a rooming house or a tourist camp. They warned patrolmen that the men were dangerous.

Hopewell, N. J., Mar. 26.—(AP)—While three Norfolk citizens did their best to restore kidnaped Chas. A. Lindbergh, Jr., to his parents today, his father was believed to be considering issuing a fourth appeal to the persons who stole the child March 1.

Thrice Col. Lindbergh, willing to pay ransom to get the child back, has issued public pleas to the kidnapers to open negotiations, but these have failed to accomplish the desired object. Information from friends of the family was that he might try again. He has pledged himself not to try to injure the kidnapers if they will return the child.

Speculation was rife as to the Lindbergh statement of yesterday that the information furnished by the Rev. Dobson-Peacock and two other Norfolk men was considered to have "no significance."

Observers of the great hunt for the child pointed out that in dealing with kidnapers secrecy was a paramount necessity, and that there might be more behind the official statement than appeared.

This was a matter, however, on which there was no official information.

Police had no doubt the go-between who approached the kidnapers, but authorities believed that the question of substantiating the claim was another matter. This go-between is reported to have said the kidnapers would return the child under certain conditions.

The hunt for Harry Fleischer in Washington aroused interest. This reputed graduate of the "Purple Gang" was in New Jersey about the time of the kidnaping, police have been told, and they want to question him about his movements.

L. V. Morrill Dies at Snow Hill

L. V. Morrill, 75, prominent Snow Hill attorney, and former resident of Greenville, died at his home in Snow Hill this morning. Funeral services will be conducted from his late home tomorrow afternoon at 4 o'clock.

The deceased practiced law in Greenville about twenty years ago and moved to Snow Hill where he had been in the active practice of his profession ever since.

He was a native of Tennessee and moved to this section during his young manhood. He was well known and quite popular throughout this section of the state and news of his death was received with profound sorrow by hundreds of friends.

He was a brother-in-law of W. B. Wiley and James Brown, of Greenville.

Police Get The Wrong Alarmist

Durham, N. C., Mar. 26.—(AP)—A lot of false fire alarms had been turned in here and officials decided to apprehend the guilty persons, so firemen were watching their call boxes.

During the early morning Herbert O'Keefe saw smoke in a downtown basement and, racing to a call box, turned in an alarm.

But firemen were alert and one collared O'Keefe, wanting to know "what the idea" was.

"It's your fire, not mine," O'Keefe said as the firemen started away with him so that he "could explain something."

Just then the trucks arrived. Firemen battled the fire more than an hour.

Lexington, N. C., Mar. 26.—(AP)—The defense rested its case at 11 a. m. today in the trial of Mrs. Lola Pickett, 40, for murder of her daughter, Elizabeth, 6, who died of poisoning last September.

The jury was excused a few minutes while attorneys for the State and defense considered the possibility of sending the case to the jury tonight. Both sides indicated this would be done.

Then the jury was recalled and rebuttal witnesses were brought to the stand.

FINAL UNION SERVICE HELD

Rev. W. A. Ryan Delivers the Concluding Sermon at Jarvis Memorial Church.

President Hoover Makes Appeal For Tax Increase

Washington, Mar. 26.—(AP)—Describing balancing the budget as the "keystone to recovery," President Hoover said in a statement published today that this "must in the main be accomplished by an increase in taxation."

He added that a further reduction of government expenditures is expected but that the potential savings by this means are not sufficient to avoid heavier taxes.

Voicing confidence that both parties intend to see that the budget is balanced, Mr. Hoover said that unless this is done "the several measures for restoration of public confidence and reconstruction which we have already undertaken will be incomplete and the depression prolonged indefinitely."

In a strong appeal to the people to support and not obstruct Congress in its efforts to bring receipts and expenditures to a level, the chief executive asserted that of the \$4,100,000,000 budget, a total of \$2,100,000,000 cannot be reduced and

NEGOTIATIONS FOR ARMISTICE NEAR FAILURE

Delegates of 2 Countries Adjourn Shanghai Peace Parley Until Monday.

By MORRIS J. HARRIS, (Associated Press Correspondent) Shanghai, Mar. 26.—(AP)—Negotiations for a Sino-Japanese armistice were very near a breakdown today as the delegates of the two countries adjourned until Monday in order to refer controversial issues to their respective governments.

The meeting today ended with a deadlock on the issue of withdrawal of Japanese troops and only the possibility of substantial concessions on both sides offered any hope of saving the conference.

FEAR TROUBLE FOR IRELAND

Republicans Expected to Create Disorders in the Celebration of Easter.

Dublin, March 26.—(AP)—Easter eve, the sixteenth since the revolution which flared on "Bloody Easter Week" in 1916, found the republican spirit more active in Ireland today than in years with some trepidation over the possibility of trouble before the morrow passes.

It is the first time in years that republicans, under the leadership of the "Irish Republican Army" have been permitted a free rein for their memorial celebrations in honor of the 1916 revolution and the republican leaders who died for the cause.

On that fact, however, officials of the government today pinned a confidence that the day would be peaceful. Clashes, they said, were not likely to occur when there was no opposition. As a precautionary measure, however, the regular Free State army was ordered confined to barracks over the week-end to prevent any possibility of clashes with the republican irregular forces.

FARM LOANS REACH PITT

About \$20,000 of the \$78,344.75 Applied For Has Already Been Received.

Three hundred and fifty Pitt county farmers have applied for loans through the Federal Reconstruction Corporation, it was revealed by records of the Farm Department today.

The applications, it was stated, represented about \$57,772.75 of which \$78,344.75 has already been approved by the local committee. About forty applications are still on hand and will be acted upon probably tonight.

Eighty growers, among the first to apply when blanks were received two weeks ago, have already received their loans, it was stated, and this places about \$20,000 in circulation for general farm activities.

Loans are arriving daily and it was believed the bulk of the applications would receive final consideration by the government department, sometime next week. Two weeks is required to obtain a loan after the filing of application.

The Farm Department office on the courthouse square was literally overrun with growers the first three days after arrival of the blanks and extra help had to be obtained to take care of the rapid filing of applications.

The Reconstruction Corporation accepts a crop lien as security on the loans and this makes it possible for the tenant as well as the landowner to participate in the government's refinancing scheme to relieve the severe economic strain which has been felt in practically all parts of the world.

Farm leaders said the government loans would aid materially in the production of the next crop and enable many a financially embarrassed farmer to see his way clear to another harvest season. The maximum loan obtainable is \$400 and the minimum \$100.

M. V. Clark, B. F. Buck, M. H. Whitfield, L. L. Jackson and W. A. Hudson, of this county, went to Raleigh yesterday where they witnessed the electrocution of John Robert Myers, colored, confessed slayer of Hagan Hodges, Paclous merchant.

Myers died in the electric chair at State's prison at 10:30 o'clock, leaving a note saying he hoped his fate would prove a lesson to others of his race.

He killed Hodges shortly after the Christmas holidays last year and was captured and sentenced to die within three weeks after the crime was committed.

He said she quit her job in a hotel here without notice and had not been heard from since, and that her mother was seriously ill and he was afraid she would "go crazy" if the girl was not found.

Predict Rain For Easter

Charlotte, Mar. 26.—(AP)—If you have any Easter finery, ladies and gentlemen, the weather man says you can exchange it for an umbrella.

That, though in not those words, was the advice of the United States weather bureau here in prognosticating weather for the two Carolinas tomorrow.

Specifically, he said there would be showers, that it would be cooler in the western portions and warmer in the other sections. The weather man would make no positive forecast for Monday, but he said he believed it would be fair and warmer.

U. S. CHAMBER BEHIND PLAN

Chief Executive Declares Ours is Representative Government and Can Function Effectively Only When the Will of the People is Clearly Expressed; Hope To Increase Vote Fourteen Million.

Washington, March 26.—(AP)—President Hoover today formally endorsed a movement to bring out a record vote at the polls in the coming presidential election.

The chief executive issued a statement this morning, expressing approval of a campaign by the U. S. Junior Chamber of Commerce to increase by 14,000,000 the number of voters as compared with those in the 1928 election.

The chamber hopes for a total vote of 50,000,000.

"I do warmly approve the plan," the President said. "Ours is a representative government and it can function effectively only when the will of the people is clearly expressed at the polls."

Harian Miller of Des Moines, Ia., chairman of the board of the chamber, has called twice upon President Hoover in recent days, seeking his approval of the get-out-the-vote campaign.

In response, Mr. Hoover issued the following statement:

"The United States Junior Chamber of Commerce has undertaken to further a plan very radically to increase the total vote at the national election this year. The united strength of the chamber's fifty thousand members, who are from 21 to 35 years old, is pledged to work for this project for the next eight months.

"State organizations for this purpose have been established. The chamber has asked for an expression of my approval of the purpose of this project, not only as a timely tribute to the memory of George Washington, but even more as a practical and patriotic service to country at present."

Quillen Writes Own Obituary

Fountain Inn, S. C., Mar. 26.—(AP)—Robert Quillen, paragraphing columnist and editorial writer, published his "obituary" in this week's issue of the Fountain Inn Tribune, his weekly newspaper here.

He said he was preparing the copy in advance as his contribution "to help good things along."

"The obituary" said:

"Robert Quillen died last night of a bronchial asthma."

"He was a writer of paragraphs and short editorials. He always hoped to write something of permanent value * * * but never got around to it."

"In his youth he felt an urge to reform the world but * * * decided he would do just well if he kept himself out of jail."

"The funeral service was held at the Baptist church this afternoon * * * Complying with Mr. Quillen's last request his wife had imported a uniformed brass band which marched in front of the procession playing 'The Old Gray Mare Came Tearing Out of the Wilderness.'"

"Workmen covered the grave with a granite slab bearing the inscription 'submitted to the publisher by Robert Quillen.'"

"Mr. T. H. McGee joined the widow to express his sympathy. 'It is a great loss,' he murmured. 'Yes' she served absently, 'but it's fully covered by insurance.'"

Radicals Clash With Police At Washington Way to Leave Raleigh School

Raleigh, N. C., Mar. 26.—(AP)—Dr. Warren W. Way, rector of St. Mary's School for Girls here for 15 years, has resigned effective at the close of the present school year to re-enter parochial work in the Episcopal church.

The resignation has been accepted by the board of trustees, which announced it did so reluctantly, but no successor has been named.

St. Mary's is one of the largest Episcopal schools for girls in the country, and has grown rapidly under Dr. Way's administration.

Automobile Leader Dead

Henry M. Leland, the "Grand Old Man of Auto Industry," Dies at Detroit.

Detroit, Mar. 26.—(AP)—Henry M. Leland, the "grand old man" of the automobile industry, died at 5:30 o'clock this morning in Grace hospital, where he had been ill for several weeks. He was 69 years old.

Leland was active up until a short time before he entered the hospital on February 25. He reportedly recalled with pride that he had manufactured rifles for soldiers in the War Between the States.

Crowds Will Visit Salem

Thousands Expected to Attend Moravian Easter Services Tomorrow.

Winston-Salem, March 26.—(AP)—Awakened from their sleep by marching bands playing the traditional Easter chorales, thousands of people will gather before Old Home Moravian Church tomorrow morning at sunrise to hear repeated for the 200th time here "The Lord is risen."

And floating back from the throng which annually attends this most famous of the south's religious celebrations will come the sonorous chant, "The Lord is risen indeed."

This year the simple opening phrase will be spoken for the second time by Bishop J. K. Pfohel, and there will be lacking the voice of the venerable Bishop Edward Rondthaler, who for more than 50 years intoned the same words which centuries before made known the resurrection to the disciples. He died last year.

After the service before the church, to the joyful tune of trumpets, will begin the procession to God's Acre, where lie, under simple slabs lying flat on the ground, the bodies of the Moravian dead.

In two processions the thousands will move, and all the time will come long-used tunes of rejoicing from the numerous bands, playing antiphonally—that is, one band taking up the air as the strains from another section die away.

Biscuit Contest.

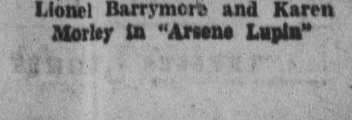

Tonight, if the scenes of other years do not fail of repetition, there will be no unfilled lodging places, and hundreds of cars will fill the streets of Old Salem, their occupants sleeping as best they may until 2 a. m., Easter morn, when the bands begin to tour the town, calling the people to the celebration.

The service is scheduled to begin at 5:30 a. m., although in recent years when traffic has grown so great, it has been a practice to wait until all are assembled.

(Continued from page one) day afternoon about 3 o'clock, and after deliberating all night, announced this morning about 10 o'clock that it was ready to return a decision. Court officials could not be located and the decision was held up until Judge Cranmer appeared after the noon hour.

The case was started last Monday and most of the week was consumed in the presentation of evidence. Argument started yesterday morning and was completed during the mid-afternoon.

The bank commissioner was attempting to set aside a deed of transfer made by Judge Wooten about four months before the bank closed in January over two years ago, claiming the former bank official knew the institution was in an insolvent condition prior to its closing.

Judge Wooten contended he had a perfect legal right to transfer the property as he desired, that he had no previous knowledge of the financial weakness of the bank and consequently was free of all responsibility.

The case was one of the longest and most stoutly contested heard in the courtroom here in years and attracted widespread attention by reason of the considerable amount of evidence brought into play and the prominence of the defendant.

He was president of the Cadillac Motor company from 1902 until 1917 when it became part of the General Motors corporation. At the age of 74, Leland ran the Lincoln Motor company, now a subsidiary of the Ford Motor company. After the World War the Lincoln company became involved in financial difficulties and finally was taken over by Henry Ford.

Purchase of the Lincoln property by Ford resulted in a break in the friendship between the two automobile manufacturers which never was healed. Leland claimed Ford had promised to pay \$5,000,000 to the Lincoln stockholders who lost their investments. Ford was victor in a long drawn out litigation that followed.

Leland was born in Danville, Va. He is survived by a son, Wilfred C. Leland and a daughter, Mrs. Angus Woodbridge, of Detroit.

NEGOTIATIONS FOR ARMISTICE NEAR FAILURE (Continued from page one) late yesterday, it was understood, when Lieutenant General Kenichi Uryeda, chief of the Japanese delegate, informed the conference that the Japanese would not withdraw before six weeks and then only to a so-called secondary defense line, running through Chenin-Tsichang-Tsichang.

The Chinese delegate, immediately prepared to leave the conference. They agreed to remain only after Nelson T. Johnson and Sir Miles W. Lamson, American and British ministers, prepared to use their good offices with the Japanese in an attempt to secure more conciliatory terms. Mamoru Shigemitsu, Japanese minister, also was understood to have agreed to assist in bringing about a compromise.

The Chinese asked today for permission to submit the matters at issue to the Nanking government. Under the Japanese plan to withdraw to a second defense line they would still control the territory for a five-mile radius around the city. Complete withdrawal, a spokesman for the Japanese said, would depend upon circumstances entirely.

TWO HELD IN CHILD'S DEATH (Continued from page one) Physicians said the body was covered with bruises and welts and that an autopsy revealed the child had suffered with an unresolved pneumonia condition shortly before death.

The child's mother, Mrs. Maudie Mashburn, was presented at the inquest but did not testify. Neither did the Brooks.

Witnesses told of the child's "suffering" which they said began about two months ago shortly after she was said to have been given to her father by law. Her mother, divorced from Brooks, had remained.

At the inquest C. C. Baumgardner testified he went to the Brooks home shortly after the death and that Calvin Kutzshaw, who lived with his wife at the Brooks home near Emma, told him Mrs. Brooks had whipped the child only three minutes before death occurred.

Calvin Kutzshaw and his wife are sister and brother-in-law of the Brooks.

Other witnesses testified the child

had been forced to walk from the Brooks home to the highway and back during a hard rain for exercise; that Mrs. Brooks had struck her with a stick of wood because she failed to clean a pot sufficiently while washing dishes; and that she had been struck with the fire wood thrown across the room.

Mrs. Pickett told of the visits of Wiley Spencer and a Mr. Ellington both of Bassett, Va., and said she went on automobile rides with them and to moving picture shows.

She denied Ellington brought any rat poison to the house.

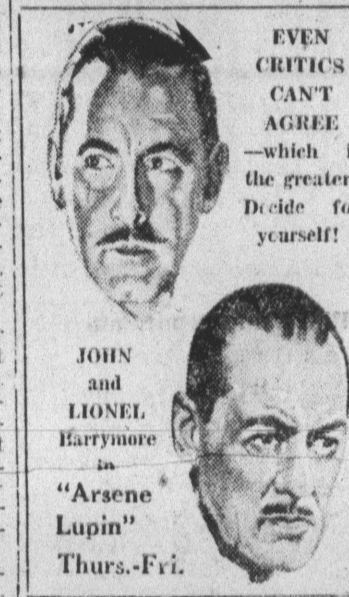

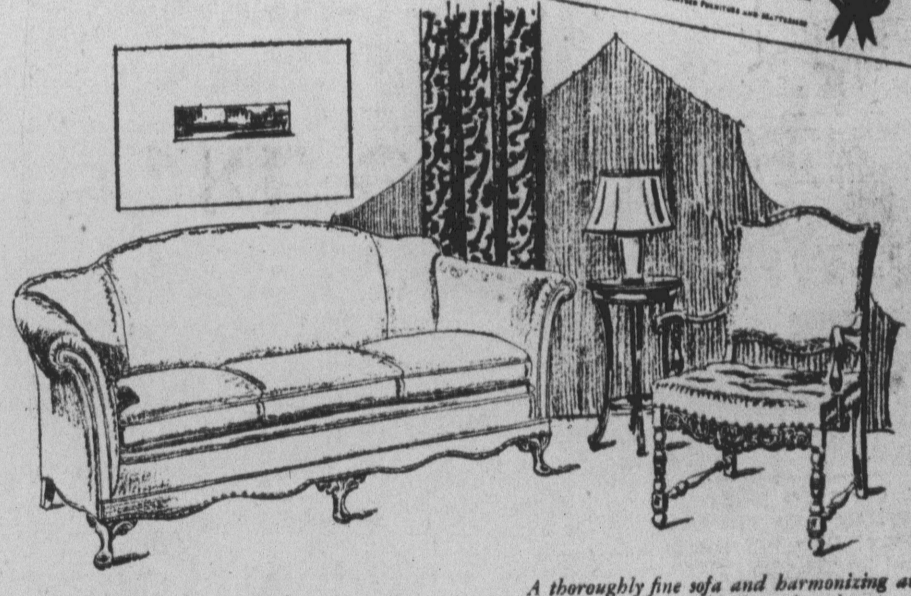
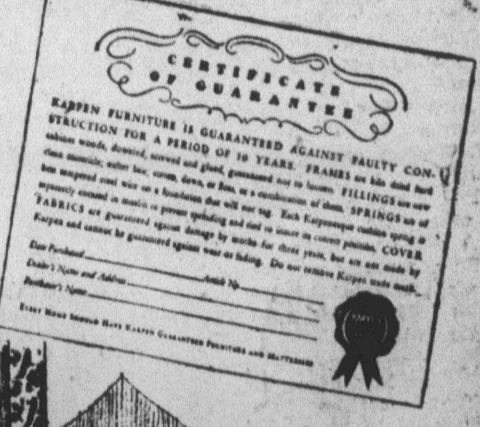
