JUDD SCORES LATE REPORT ON HAWAII

Says Recommendations of Attorney General Would Destroy Rights

Washington, April 7.—(AP)—Governor Lawrence M. Judd of Hawaii, today communicated to Secretary Wilbur vigorous opposition to recommendations of Assistant Attorney General Richardson terming them "a confiscation by Congress of some of our most treasured rights of self government."

Judd said that "to transfer to Washington the appointment of the territorial attorney general and police head would result in divided authority between the governor and these officers with a resultant loss of efficiency and no centralized responsibility."

The Hawaiian governor quoted an editorial from the Honolulu Star Bulletin, published by former Governor Farrington. Which said the Richardson report would have the United States treat Hawaii "as the British treat the people of India or Egypt."

"His report strikes at the very vitals to destroy American self government," it continued. "It is another wedge to make bureaucracy of Federal government triumphant. Its purpose is not to foster self government. Its purpose is to destroy self government."

In another quotation from the Star Bulletin Judd said there was "no more justification for the proposal for the president to name the territorial chief of police of California or New Mexico or to name the chief of the state police of the sovereign state of Pennsylvania or New York."

Judd asserted that self government should be fostered in Hawaii and not hindered and maintained that "the findings do not justify the conclusion that our citizens of many racial ancestries have failed to perform their duties at least as well as citizens of the mainland."

"I respectfully urge," he said, "that Hawaii be accorded the confidence to which she is entitled and that we be permitted to solve our own problems in the usual American way."

Secretary Wilbur made Judd's telegram public without comment. He said yesterday, however, that the Richardson report had shown "a high degree of law observance and capacity for self government" in Hawaii.

Judd said the relations with the army and navy in Honolulu were satisfactory and that the report as a whole revealed the city and islands to be as clean and normal as any mainland community.

S. C. Prisoners Commended for Action in Fire

Columbia, S. C., April 7.—(AP)—Praise from Governor Blackwood and other officials today was heaped on the inmates of the state penitentiary for their "magnificent behavior" during a raging fire that wiped out eight buildings of the prison plant.

Instead of attempting to escape or rioting when the fire broke out yesterday, the prisoners joined with firemen, guards and others in combating the flames. Nine or more of them were slightly injured in fighting or escaping the conflagration.

The prison chair factory, an unused tuberculosis hospital, five warehouses and a shed were destroyed before the fire was brought under control. Col. J. M. Pearman, prison superintendent, estimated the loss at approximately \$200,000, of which something like \$170,000 is covered by insurance.

The origin of the fire had not been definitely determined today. Governor Blackwood, Charles H. Gerald, his secretary, Superintendent Pearman and others were warm in their praise of the behavior of the prisoners. Representative William C. Johnston, of Anderson, who visited the scene of the fire, suggested some of them be given pardons for their heroic work.

The governor said: "I wish to commend the prisoners for their intelligent cooperation. Out of the total number of 981 not one attempted escape, although the situation offered numerous opportunities."

"They deserve the appreciation of good citizens, the management of the penitentiary and the governor's office. I am proud of their magnificent behavior."

REVENUE BILL CAUSING BATTLE

Billion Dollar Measure Becomes Embroiled in Bitter Tariff Fight.

Washington, April 7.—(AP)—The billion dollar revenue bill is getting embroiled in one of the Senate's most bitter tariff fights.

Half a dozen pending proposals to incorporate new import taxes in the revenue measure have stirred a rout of activity such as seldom heralds the arrival of even such an important measure as this.

The finance committee left the door open for tariffs yesterday when it rejected by a 10 to 5 vote a motion to ban new duties on imports from the tax raising measure.

Senators Walsh, of Mass., and Tydings, of Maryland, both Democrats, promptly began a campaign on the Senate floor to mobilize a majority against any and all tariff duties.

CHINA FACES CIVIL WARFARE

COUNTY COURT ENDS SESSION

Over Twenty Cases Disposed of in Two-Day Sitting During This Week

The day and a half session of County court closed yesterday after the disposition of twenty odd cases. It was the first sitting of the court in two weeks due to the two-week term of civil court and the docket was the most congested in some time.

The majority of cases consisted of charges of larceny and violation of the prohibition law. There were also several infractions of traffic laws considered.

In the final session yesterday, Wade Britt, Ayden young man, was given a sixty-day suspended sentence to the roads on a charge of drunkenness and resisting an officer.

Ernest Whitehead, colored, sentenced to 60 days on the roads the day before on a charge of larceny, had sentence continued until next week on a charge of carrying a concealed weapon.

Pres. Hoover Denounced For Neglect Of Navy

Washington, April 7.—(AP)—A new, sweeping denunciation of President Hoover's naval policy was issued today by the Navy League of the United States.

The president was charged with neglect of the navy and with wrongly parading armaments as the "scape-goat" for the great increase in taxation during recent years. This charge was accompanied by an argument to show that other expenditures have played the major part in building up the taxpayers' burden.

The league said Mr. Hoover had done "virtually nothing" to replace vessels which have passed or are reaching the limit of effective age, and that "while Europe smolders and Asia is ablaze, the president insists that we cannot now afford even to start moderate measures for building up our fleet to treaty terms."

Today's attack was the most conspicuous one by the league since last October when its president, William Howard Gardner, issued the seeds of a notable controversy with the White House by a statement charging Mr. Hoover, among other things, with exhibiting "abysmal ignorance" on naval matters.

That incident ended with the verdict of a special board, chosen by the president to investigate the charges, which upheld the Chief Executive and said the league statement contained many inaccuracies, false assertions and erroneous conclusions. The league disputed the finding however. Today's statement also was issued over Gardner's signature, in the form of a printed 17-page pamphlet entitled: "The Treasury Deficit and a Treaty Navy."

COMMUNISM GRIPS CHINA

League Commission Disturbed by Growing Sentiment Throughout Nation

Hakow, China, April 7.—(AP)—The question of Communism in central China absorbed the interest of the League of Nations inquiry commission during its visit here more than anything else except, possibly, the flood relief work.

The closest contact they established with the Communists' activity was when they heard Chinese army airplanes roaring out to the Communists front 40 miles west of here where the planes bombed the Red forces, after reports that the latter contemplated attacking Hankow.

It is estimated there are at least 60,000 Communists in Hupeh province. The most powerful group, government leaders say, is under the command of General Ho Lung, who is feared throughout China.

General Ho's forces are established west of Hankow. The general, though long a member of the Kuomintang (Nationalist party), is particularly bitter against General Chiang Kai-Shek.

General Ho's troops have caused apprehension among government troops for many months. They have plenty of small arms and ammunition, but little artillery and (Continued on page six)

Find Man Dead in Car at Eliz. City

BANKERS MUST GO TO PRISON

Supreme Court Upholds Sentences of Five Bankers in Brevard Conspiracy

Raleigh, April 7.—(AP)—Four former Brevard bankers must go to prison and another must pay \$5,000 fine, for conspiracy to misapply county funds to aid an insolvent bank, the State Supreme court ruled.

At the same time the court yesterday reversed the ruling of the lower court which refused non-suit motions by A. M. White, S. R. Owen and W. T. Talley, and reversed the judgment by which they were fined \$1,000 each.

T. H. Shipman, former president of the Brevard Banking Company, J. H. Picklesimer, former chairman of the Transylvania county board of commissioners, County Accountant G. R. McNeely and County Attorney Ralph Fisher must serve from two to five years in state's prison and pay \$5,000 fines as a result of the decision. J. B. Silverstein, who was chairman of the bank's board of directors, must pay a \$5,000 fine.

A three to two decision of the court held the evidence, although circumstantial, was sufficient to convict the five.

Justices Clarkson, Stacy and Adams held the majority opinion, with Justices Connor and Brogden dissenting.

The Brevard men were tried last summer at the same time Luke Lea and Luke Lea, Jr., of Nashville, Tenn., and Wallace B. Davis, former president of the Central Bank and Trust Company, of Asheville, were being tried and convicted of conspiring to defraud that bank.

Yesterday's decision by the court left only the Lea and other Davis cases pending out of the mass of Western North Carolina bank cases appealed to the court after the financial collapse of 1930 and subsequent trials.

Lloyd George Plans to Retire

London, April 7.—(AP)—Friends of David Lloyd George said today he had decided virtually to retire from the House of Commons.

He will devote his time, they said to writing and farming and only events of outstanding importance will bring him back into the House.

Commentators recently have pointed out that it was hard to see what his place could be in the present political scheme, with his Liberal party split and merged, under new leaders, into the national cabinet.

A suggestion that he cooperate with the Labor party opposition in the new parliament has met with little enthusiasm from either side, and his vigorous attacks upon the national government have left no place for him there.

HAWKS BADLY HURT IN WRECK

Noted Flier Suffers Fractured Skull as Plane Crashes at Worcester

Worcester, Mass., April 7.—(AP)—Captain Frank M. Hawks, famous speed king of the air, and holder of several trans-continental records, was seriously but not critically injured when he crashed into a stone wall while attempting to take off from the Worcester airport. He was planning to go to Boston to gas his plane then to New York.

In an unconscious condition he was taken to Worcester Hospital where he soon recovered his senses.

Hospital surgeons reported at 11:30 that Hawk's face is seriously contused and lacerated, X-rays disclosed jaw fractures, but no skull fracture. He may have facial paralysis as a result of the jaw fracture, the surgeons say.

ASK PRESIDENT TO SPECIFY HIS ECONOMY PLAN

Special House Committee Says all They Need is Specific Recommendations

Washington, April 7.—(AP)—Replying to the demand of the House economy committee that he submit specific recommendations for reducing federal expenditures, President Hoover today invited the committee to meet with him at the White House at 11 o'clock Saturday morning.

The president's letter was addressed to Chairman McDuff of the economy committee. It suggested the meeting with him be held "with a view of taking stock of the progress made by your committee in the development of a program of economy."

The meeting, he said, also would afford "the executive an opportunity to make suggestions."

The Chief Executive recently urged in a special message to Congress that representatives be appointed from both the House and Senate to sit with his own representatives to draw up a comprehensive economy measure. The suggestion drew attack in both the House and Senate, with Democrats charging he was "shirking responsibility."

The president, in a counter attack, said he could see no way to draw up a unified program except through such a committee. In today's letter he asserted he would continue to urge that a Senate group be appointed to deal exclusively with economy measures.

Washington, April 7.—(AP)—In a curt letter to President Hoover the special House economy committee today checked back to the Chief Executive the issue of reducing government expenditures, formally requesting him to submit specific recommendations.

The letter was dispatched over the signature of Chairman McDuff of Alabama, the Democrats whip, with two Republican committee members dissenting. It followed McDuff's assertion, as to the President's suggestion for an economy commission including his own representatives as well as House and Senate members, that: "It is too late to start any new investigation. All we need is some specific recommendations, and we'll put them up to the House right away."

The letter informed Mr. Hoover that the committee recognized, "as you, too, must recognize," that the condition of the country preclude partisanship and demanded political cooperation, and that the committee had a "sincere desire to work in the fullest cooperation with you."

"With this in mind," it continued, "we extend to you an invitation to participate in the task of the economy committee by sending to the committee your specific recommendations, or by sending your representative to present to the committee your views and conclusions as to specific economic policies which might be effected so that the country may have the benefit of a cooperative effort."

Decision to send the letter was announced late yesterday about the time the Senate appropriation committee reported a \$12,000,000 reduction in the Interior Department appropriation bill, already cut by the House considerably below the budget estimates. The House economy committee, ready to report bills for some minor consolidation of government activities and abolition of such services as the army and navy transports, expected to have some savings drafted by the end of the week.

South Leads Country In Construction Activities

Baltimore, April 7.—(AP)—The south's construction awards for the first quarter of 1932 are figured above \$63,000,000 by the Manufacturers Record and the publication says the region's March showing was proportionately better than that of the rest of the country.

Sixteen states were included in the March survey and the quarterly \$63,000,000 total did not include projects costing less than \$10,000. An aggregate of more than \$80,000,000 of building construction was estimated as undertaken in the southern United States during the three-month period.

The total awards for March in the 16 states was \$27,000,000, and although below the 1930 high mark the construction statement released today says this "offers encouragement especially because . . . March awards practically doubled those of February," and the south is maintaining a "higher relative level of construction activity than the rest

Fire Destroys Valuable Horses

Lutherville, Md., April 7.—(AP)—Cause of the fire here late last night that destroyed 26 thoroughbred horses and a stable on the estate of Lewis E. Lambert at a loss of \$350,000 was sought today by Baltimore county officers.

W. P. Barnett, caretaker, who lives less than 200 yards from the burned stable, insists the blaze was of incendiary origin. He told officers that when he discovered the fire flames were shooting up on the outside of the barn from two sides but that there was no fire inside.

The horses were valued at \$250,000 and the stable and its equipment at \$150,000.

The owner, who has exhibited his animals at point-to-point and cross-country races in Maryland in recent years, was away at the time of the fire and did not return until after the stable had been completely destroyed.

The horses, hunters, jumpers and show animals, were mostly all the property of Lambert. A few were owned by his friends.

Biennial Flower Gardens

Schools and garden clubs all over the country are joining enthusiastically in a movement to plant flower gardens this spring as part of the celebration in honor of the George Washington Bicentennial. This is being done in several ways, according to the "information" division of the United States George Washington Bicentennial Commission, which is sponsoring the activity.

Many gardeners will plant flowers which will bloom year after year to remind future generations of this great patriotic, nation-wide celebration. Back yards and small garden plots will bloom with Colonial flowers as an outdoor manifestation of what this year means to Americans. The Department of Agriculture is co-operating wholeheartedly in this movement by preparing lists of flowers and shrubs which were familiar in Colonial days.

It is possible to plant ivy at your own home from slips taken at Mount Vernon. Tourists and visitors to this national shrine avail themselves of the opportunity to purchase little pots of ivy at the entrance gate.

To insure the amateur gardener of the most attractive results, certain seeds may be planted in the open ground where the plants are to grow.

Among those that should be sown early in that way are alyssum, California-poppy, candytuft, cornflower, forget-me-not, nigella, nemophila, Drummond phlox, sunflower, poppy and sweet alyssum.

Among those that should be sown late in this manner after the ground is warm are the castor-bean, corn, geranium, mignonette, Indian corn, garden balsam, portulaca and four-o'clock.

The experts of the Bicentennial Commission have worked out a series of color combinations, some of which follow:

Flowers that are white or with pure white varieties: 4 feet, cosmos; 3 feet, dahlias and sweet-sultana; 21-2 feet, clarkia, cornflower, larkspur and scabiosa; 2 feet, baby's-breath, China-aster, summer chrysanthemum, lupine, balloon-flower, snapdragon, garden balsam and poppy; 11-2 feet, godetia, four-o'clock, rose everlasting and stock; 1 foot, candytuft, Iceland poppy, petunia, ageratum, lobelia, portulaca, sweet alyssum and verbena.

Flowers having varieties mixed with white: 3 feet, dahlias; 21-2 feet, salpiglossia; 1 foot, nemophila, pansy, petunia and pink.

Flowers yellow or with yellow varieties: 4 feet, sunflower, feather cockscomb and dahlias; 21-2 feet, strawflower, sunflower and zinnia; 2 feet, calliopsis, summer chrysanthemum, Aztec marigold, snapdragon and four o'clock; 1 foot, calendula, Cape-marigold, French marigold, Iceland poppy, California poppy, dwarf marigold and portulaca.

Flowers having varieties mixed with yellow: 4 feet, dahlias; 2 feet, calliopsis, rudbeckia, salpiglossia and summer chrysanthemum; 11-2 feet, four o'clock; 1 foot, dwarf nasturtium and pansy.

HIGH COST OF CREDIT HURTFUL TO FARMER

Raleigh, April 7.—The high cost of credit and the fact that the southern creditor usually insists that the farmer plant only cash crops are two factors that make it extremely difficult for the southern farmer to accumulate wealth and raise his standard of living, according to a study made by Dr. G. W. Forrester, professor of agricultural economics at N. C. State College, and published in the March number of The Journal of Social Forces.

The article, parts of which were reproduced in the Daily Digest of the United States Department of Agriculture, stated that the results of the study, made from questionnaires filled out by 129 farmers, showed that one half of the credit wanted was for the purchase of livestock and one third for the purchase of livestock equipment but such credit was not often available.

Creditors instead of loaning money for balanced and diversified farming insists instead of the farmer planting only cash crops so that the creditor may be sure of getting his money back as soon as possible.

In a study of credit in North Carolina it was found that the average annual increase for the farm owner was \$14 and the actual short term credit cost for the owner was \$75 or 18 per cent of the average wealth increase. For the average tenant farmer the average annual wealth increase was \$33 and short term credit cost \$40 per year or approximately 75 per cent of his annual savings.

The article pointed out that credit in the South seriously reduces the chance and opportunity of the tenant to become an owner especially if he must make his way to farm ownership from scratch, and that the interests of the farmer and his creditor, under our present credit system, are often antagonistic and often detrimental to the best interest of the farmer.

Raleigh, April 7.—(AP)—Twenty candidates seeking congressional or state offices have paid their filing fee to the State Board of Elections, one other is expected to pay his fee today and another sent \$50 which an incorrectly filled out blank R. C. Maxwell, secretary of the State Board of Elections, said this afternoon.

All candidates who desire to enter the Democratic primary June 4 must file before midnight April 22nd.

Senator Cameron Morrison, seeking to hold the seat to which he was appointed in the United States Senate, and Tam C. Bowie of West Jefferson and Frank D. Grist, state commissioner of labor, have each paid \$100 to seek the long and short terms.

U. S. MARINE KILLED IN NICARAGUA YESTERDAY

Bluefields, Nicaragua, April 7.—(AP)—Sergeant Charles J. Levon, U. S. Marine Corps, was killed yesterday in a military led by Kisalaya, a native outpost at which he was in command.

His lieutenant, Carlos Reyes, a Nicaraguan, was wounded. The remoteness of the outpost is believed to have inspired the natives to start the mutiny. Kisalaya is located on the Wanks river. Twenty-five men were stationed there with the two officers.

After the officers had been attacked, ten loyal guardsmen joined the nearest garrison while fifteen fully armed men went up the river for Jimotega.

Rock Hill Mayor Passes Suddenly

Rock Hill, S. C., April 7.—(AP)—Dr. J. B. Johnson, 73, mayor of Rock Hill since 1928, died from a heart attack at his home here last night. Funeral services will be held here at 3 p. m. tomorrow.

Dr. Johnson began his business career as a druggist. At the time of his death, his business interests included banking, real estate, ice and fuel and dairying.

Surviving are his widow; two sons, Julian Johnson, of Rock Hill and C. Albert Johnson, Greensboro, N. C., and two daughters, Mrs. E. C. Cawthney, Laurinburg, N. C., and Mrs. W. A. Anderson, New York.

A bus driver testified the young woman "looked sad" the day she came to Eldorado to take a train home to Little Rock for Easter. He described her actions as "strange."

The state introduced a confession made by the tramp, on trial on a first degree murder charge, that he attacked Miss Youngblood in a box car and threw her body in front of a train. Since the man who officials say is mentally deficient, has changed his story.

W. O. Carter, fireman of the train that struck the young woman testified it was his belief she had leaped from a box car on an adjacent track to throw herself across the rails.

The bill had been sponsored by House Democratic leaders—including Chairman Byrnes of the appropriation committee, its author, as something that would save \$100,000,000 a year.

Reports were that since the expenditures committee had defeated the bill, the special House economy committee might take it up.

Cochran, however, who is a member of the economy committee, said he would not press it before that group.

Funeral for Robert Dalton at Greensboro

Greensboro, April 7.—(AP)—Funeral services for Robert F. Dalton, 75, whose business activities touched many parts of this state and extended into Georgia, were conducted here this morning.

Mr. Dalton died at his home here yesterday.

Officiating today was Dr. Charles E. Myers of the First Presbyterian church. Interment was in Green Hill cemetery.

Mr. Dalton was recognized as an outstanding business man in the state. He was the son of the Rev. P. H. Dalton who founded the First Presbyterian church in High Point.

For nearly 60 years he made his home here and during that time was connected with varied interests. He organized with Clark Porter and the Porter-Dalton Drug Company in which Porter's nephew, O. Henry, the famous short story writer, once worked.

He was one of the organizers of the Snow Lumber Company of High Point 44 years ago and was its president at the time of his death. He had interests in the Tallulah Falls Lumber Company in Georgia.

Mr. Dalton was associated with Caesar and Moses H. Cone and the Page brothers of Aberdeen in its founding and operation some years ago. For 12 years he was president of the Greensboro Motor Company and assisted in establishment of the Southern Webbing Mills.

He was appointed chairman of the state building commission by Governor T. W. Bickett in 1917.

Surviving are his widow and two sons, Carter Dalton of High Point and T. S. Dalton of Bayview.

BLUE MOLD SPREADS IN SOUTH CAROLINA

Florence, S. C., April 7.—(AP)—"Blue Mold" or "Downy Mildew" disease in menacing tobacco plant beds throughout the South Carolina tobacco area and in North Carolina border counties.

J. T. Lazar, district extension agent, after a tour of inspection, said today that unless the disease is quickly controlled it threatens to destroy all the beds of the eastern belt.

Coming on the eve of the planting season, it has created a serious situation, he said. He urged all tobacco farmers to keep a close watch over their plant beds.

Ventilation of the beds by removing the covers during the day and spraying with Bordeaux mixture were recommended as means of control. Farmers were advised to seek the advice of county farm agents in preparing the mixture.

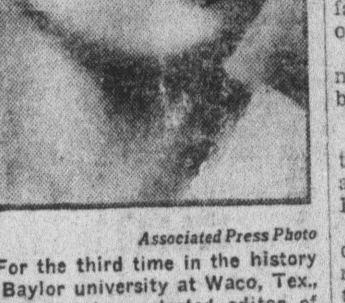

ABOUT TOWN

Three persons were killed and twenty injured in this highway patrol division during the month of March. It was revealed today in the monthly report of Lester Jones, lieutenant.

The death toll was an increase of two over the previous month, and goes to show that instead of improving, traffic conditions are becoming worse in this part of the country.

The twenty-four accidents were the outgrowth of careless driving of persons who congested the highways during the spring-like weather which pervaded this section at frequent intervals the last several weeks.

Instead of improving traffic conditions, good weather seems to add to the toll of life and property. The balmy weather apparently goes to the head causing even level-headed people to drive with undue carelessness even when the highways are crowded and the danger of wrecks more menacing than ever.

With the coming of summer when thousands of cars will clutter up the roads each week-end, the people should make it a point to drive as carefully as they know how and in that way help reduce the toll of life and property. It is the only way to improve the situation.

Eighteen thousand dollars has been paid to Pitt county farmers for their hogs, chickens and potatoes so far this season and a considerable quantity of each remains to be shipped.

This money will help relieve the financial shortage experienced by low prices for money crops the last two years and shows what steps the growers have taken to better their condition.

Had it not been for these extra sources of revenue it is impossible to visualize the seriousness of conditions. As it is the men who confined attention to the production of hogs, chickens, potatoes and other revenue-raising crops will be able to carry over to another planting season in much better shape than the growers who placed all of their faith in two or three crops.

Markets of this kind hold forth great opportunities to people willing to give a little more time to their farming operations and those who try it will certainly come out at the big end of the horn the end of another crop year.

With Blue Mold, tobacco plant disease, threatening to destroy many plant beds in this county, growers have been advised by the farm department to sprinkle their plant beds with bluestone mixture. While this will not stop the disease after it has started, it will prevent infection and this should be a big consideration to those desiring to save their plants.

The disease is most severe in Robeson county but has spread to several other counties in this part of the state and threatens to destroy the remainder of the plants left by the storm and cold weather several weeks ago.

With tobacco plants probably shorter than they have been in years, it is incumbent upon growers to do their best to prevent damage from the disease and it is hoped everybody will follow the advice of the farm department and use the bluestone mixture. It is an inexpensive treatment and may save millions of plans if properly used.

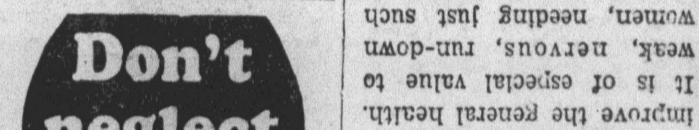

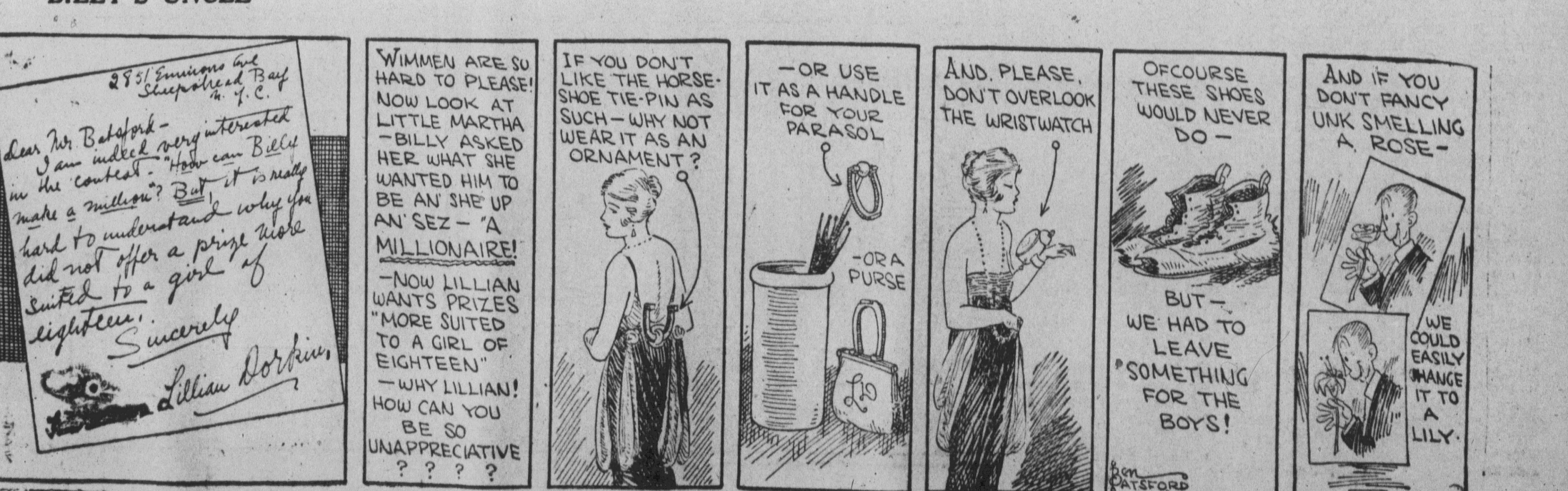

M'GRAW SAYS BASEBALL HAS LOST 'PUNCH'

Kansas City, April 7.—(AP)—White-Haired John McGraw, 59 years old today, believes baseball has lost much of the punch and aggressiveness that he has exemplified during 42 years as a fiery player and manager.

"The ball is the same size, bases are the same distance apart as they were when I first started in baseball," he explains "but the game isn't played as aggressively."

After 30 years with the Giants, McGraw hopes to continue in baseball the rest of his life, but added with a twinkle in his eye, "I don't know how much longer I'll stay. I am not so active physically as I was a few years ago."

STOCK MARKET

New York, April 7.—(AP)—While selling pressure in today's stock market was less severe than yesterday's, important signs of conclusion of this latest phase of the decline were still lacking.

There was a little flurry of short covering in the first half hour, which sent some leaders up 1 to 2 points momentarily, but the list quickly slipped back again, and by early afternoon, there were numerous losses of fractions to 2 points sending much of the list further into new low ground.

Utilities continued to bear the brunt of selling. Losses of 1 to 2 points appeared in such shares as Consolidated Gas, Public Service of N. J., Detroit Edison, Columbia Gas and Electric, Commonwealth and Southern preferred, and California Edison. Among the specialties, Kresge was a weak feature, dropping 4 points. The decline was attributed largely to dividend uncertainties. American Can also encountered considerable pressure, sagging more than 2 to a 5 year bottom. Bethlehem steel, Corn Products, Procter and Gamble and Union Pacific also sagged a point or more. U. S. Steel dipped fractionally to a new minimum. Rails held up relatively better than recently.

This latest phase of the 21-2 year decline has now been in progress for five weeks. During that period the price average has shown a decline for ever trading session save six. The fundamental factor in the slump has undoubtedly been the failure of business activity to show the expected spring quickening. It has been aggravated by such things as uncertainty over federal taxation, the Krueger debacle, and projected public utility reorganizations. But the decline has now worn on to a point where traders are exactly awaiting some sign of a turn.

Conservative quarters in Wall Street have had little hope of anything impressive in the way of a spring upturn in general trade, pointing to next autumn as a more logical time to expect real improvement.

TEXAS LEGIONNAIRES ASK IMPEACHMENT OF STEVENS

 telegram signed by Brown.

Meanwhile, the Veterans of Foreign Wars announced petitions bearing the signatures of more than 2,500,000 former service men and citizens urging immediate payment of the bonus, to be presented to the House ways and means committee. The organization said the petitions were from every state in the union.

Representation of the petitions to morrow will be preceded by a parade of veterans.

The telegrams from the veterans of Bee county, Texas, urging the impeachment of Stevens read:

"We, the veterans of Bee county, Texas, do not approve Stevens' statement of American Legion endorsing Hoover's veto of bonus. Bee county veterans are one hundred per cent for full payment of bonus. Ninety-five per cent are in destitute circumstances. Request impeachment of Commander Stevens."

Oklahoma City, April 7.—(AP)—Oklahoma American Legion officials are leading a move for a meeting of the national executive committee at Indianapolis April 15, in protest against a statement of Henry L. Stevens, national commander, that the Legion supports President Hoover's position against bonus legislation.

Taking issue with the national commander's statement, state legion officers last night messaged 23 departmental commanders, asking that they join in a call for the meeting.

New York, April 7.—(AP)—The commander of Willard Straight post of the American Legion announced today it had sent a telegram to the national commander, Henry L. Stevens, Jr., of Warsaw, N. C., demanding an end to "all attempts to coerce Congress."

"We demand discontinuance of the Washington lobby," the telegram said, "and all attempts to coerce Congress to vote additional bills and special privileges which will thereby degrade patriotism and service, imperil government finances, gouge taxpayers and make the word veteran synonymous with panhandler and grafter."

The commander of the post is Hugh Gallaher, an executive of the Penn Metal Company. The message expressed approval of Stevens' statement against immediate payment of the bonus.

 "The conclusion seems inescapable that in regarding the causes of the evident increase in the 'crushing burden of taxation' we must look elsewhere than to the armaments race—event that Mr. Hoover and the pacifists parade."

Over the past 20 years it said federal military expenditures have increased "far less than three-fold while expenditures for non-military purposes have been allowed to increase eight-fold; and it also appears that, under Mr. Hoover's management, non-military expenditures have gone up 30 per cent while he has reduced expenditures for military purposes by two per cent."

The league blamed upon the president's insistence the shelving by the House naval committee this session of the Vinson bill for building the fleet up to twenty limits over a ten-year period. It argued this was done "allegedly because of the financial situation of the treasury," contending the bill involved only \$19,000,000 expenditure in the fiscal year 1933, and contrasted this with expenditures of hundreds of millions for various emergency purposes which it said were "approved by the president."

 for days with a vague feeling that Charles A. Lindbergh, Jr. would be home long before this, had to save its disappointment today with a message out of the void:

"The baby is well."

John H. Curtis, gone since Saturday from his Norfolk, Va., home to keep rendezvous with a person he looks upon as an agent for the kidnapers, relayed the words of cheer.

He made his announcement on his return yesterday, adding that during his four-day absence he met Col. Charles A. Lindbergh.

This for the first time gave definite indications of a connection between the Norfolk boat builder's mysterious movements and the flights the Flying Colono recently made to Martha's Vineyard and other islands off the Massachusetts coast.

Curtis cryptically said he had made a "contact" and that information he gave the baby's father relieved the latter "greatly."

Rear Admiral Guy H. Burreage, another of the three Norfolk intermediaries, declined to say whether ransom payments had been arranged or whether the infant would be back soon. Col. H. Nor-

man Schwarzkof, head of the state police, declared there was no significance in the fact that lights have been burning in the nursery from which the baby was stolen March 1.

Police finally abandoned any hope that Henry (Red) Johnson, suitor of Betty Gow, the baby's nurse, could give them any clue in the kidnaping. They announced they would turn him over to immigration officials Monday to face an accusation of entering the country illegally.

From the Massachusetts shore, came reports of a vain hunt for a man and a woman. Fishermen said they came short from a small boat at Waquoit, trundling a baby carriage.

Coast guardsmen from New London, Conn., were searching for a "certain white yacht," they said—but they would say nothing more. Colonel Lindbergh was reported to have been seeking a small vessel called Nellie or Saille when he made his airplane trips.

 tory challenges—which require no reason for removing a man from the box—the gray haired leader of the defense predicted there will be no more than three white men on the jury when the case goes to trial.

With a wry smile the grizzled veteran said that, for the first time in his 54 years of law practice, he was a little puzzled when talking to prospective jurors. And one of the reasons is that a lot of the jurymen in Honolulu have slant eyes.

"I can't quite make it out," Darwin said slowly as he tested from his labors of fencing with the prosecution over the completion of the jury. "I've had pretty fair luck with juries, but some of these I can't quite tell about."

"I never tried a case before Chinese jurymen. Probably, though, they are no different than anybody else."

The tentative jurors at the opening of today's session were three Americans, two Chinese, two Hawaiians, a Swede, a Scotchman, a German, a Portuguese and a Chinese-American. All, however, are United States citizens.

While counsel maneuvered for the most favorably jury, Mrs. Fortescue, society leader of New York and Washington, D. C., listened calmly.

Her son-in-law, Lieut. Thomas H. Massie, U. S. N., and E. J. Lord and Albert O. Jones, enlisted men, are the others facing the second degree murder charges.

 General Chiang Kai-shek would no longer remain a part of the Nanking government and that he desired the independence of Shanghai, he has not yet begun any hostile action, however.

Shantung was quiet today, according to dispatches from Sincin and Tientsin. General Yan is now at Tientsin at the head of 70,000 well equipped soldiers who constituted the backbone of his control of Shantung.

Rumors of civil war in the north continue to grow in volume here, and the gist of recent reports is that the Nanking government is destined for an armed clash with the northern coalition which is said to be planning to overthrow General Chiang Kai-shek's regime and establish itself independently from the Yellow River northward to the great wall.

Meanwhile the peace conference between the Chinese and Japanese here continued with the prospect it would go on indefinitely. Little, if any, progress had been made in solving the vital problem of when the Japanese will withdraw from the Shanghai area.

According to a Chinese citizen who was captured and who later escaped, a number of Russian advisers and officers are attached to the Red camps. This General Ho Lung denies.

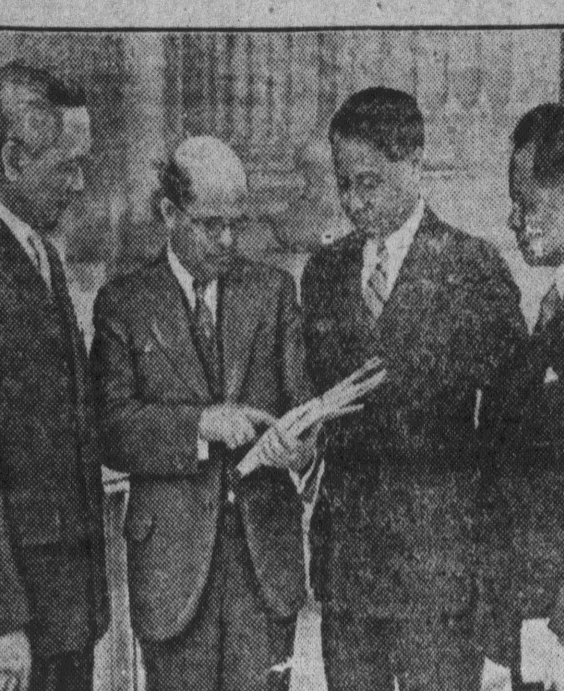
The Communist campaign against the Nationalist government is believed here to be conducted from Chinese Soviet headquarters in Shanghai, but where their money comes from remains a mystery.

 30,000 in the country had "kicked over" by endorsing the legislation sponsored by Rep. Wright Patman of Texas providing for the payment of over two billions of dollars. He also declared that "Legionnaires recognize that as much as they would like to have the money, the government is just not in any position to pay it right now."

Members of the Legion here expressed opinion the statement was not representative of the thousands of members of the organization throughout the country, countless numbers of whom are suffering severely from unemployment and its attendant ills. It was believed Stevens has not fully familiarized himself with the situation and that the government should be able to pay what it owes the soldiers; if it can find it possible to loan millions of dollars to railway and other interests.

The resolutions sent to Congressmen by the local post sometime ago impressed the fact that payment of the remainder of the compensation would aid the nation in recovering from the effects of the financial depression.
