## Whitney Denies 'Bear Raids' On N. Y. Exchange

### GOVERNMENT LEADERS JOIN IN ATTACK ON BONUS LEGISLATION

#### REP. PATMAN FAVORS PLAN

**Rainey and Robinson Declare Proposed Plan to Pay Compensation Economically Unsound; Patman and Owen Give Their Support on the Side of the Veterans.**

Washington, April 11.—(AP)—In the face of a drive before the House Ways and Means committee for full payment of the bonus, the House and Senate Democratic leaders joined today in assailing the legislation.

Hardly had the plan to inflate the currency by issuance of two billion dollars of United States notes to pay the bonus been put before the committee before Representative Rainey of Illinois, the Democratic leader, issued a statement calling it "uneconomic, unsound and destructive."

A little later, Senator Robinson of Arkansas, issued a similar statement in opposition.

The proposal was put before the Ways and Means committee by its sponsor, Representative Patman, (D. Tex.), and drew the support of Robert L. Owen, a former senator from Oklahoma. They said the additional currency put into circulation would help to stir business to new activity.

Still weary from its long task of drafting a tax bill to balance the budget, members of the committee listened to a story of thousands of veterans out of work and in need of the money represented by their bonus certificates.

Representative Patman (D. Tex.) was the first witness.

He said most of the advocates favored paying the certificates in United States notes, though they were not agreed on the exact terms of a bill.

Among those in attendance were General Frank T. Hines, veterans administrator, and John T. Taylor, legislative representative of the American Legion, whose national commander, Henry L. Stevens, has opposed payment of the certificates.

"Unless we can show that payment of the bonus will benefit the country and promote the general welfare," Patman declared, "we are not entitled to have this bill passed."

"If it will be the least bit detrimental to the general welfare, we are not entitled to win."

"There are 750,000 able-bodied veterans out of work. There are 75,000 slightly disabled veterans who are out of work. There are 800,000 veterans working only two days a week."

"There are only 600,000 certificate holders able to borrow who have not availed themselves of that opportunity. This indicates that four-fifths of the certificate holders need the money."

"The question is: Can the payments be used as a vehicle to bring the country back to prosperity? We believe they can."

"We think a bond issue would be detrimental to the country and propose the issue of currency instead."

The testimony began before the committee at about the time Representative Fish (R. N. Y.), was telling a meeting of the American Bankers Association that the proposal to cash the unpaid fifty percent of the bonus "would exhaust our gold reserves and shove us off the gold standard and make the dollar look like thirty cents."

"It is in the last analysis, the same old fight of soft money against sound money," Fish said. "All it requires is a few gallons of lubricating oil and a few sales of paper for printing money."

Acting Chairman Crisp put into the record a telegram from Major General Smedley D. Butler, U. S. M. C., retired, favoring the bonus legislation.

Patman said advocates of the payment were hopeful that "this legislation not only will pay the certificates but it will put sufficient (Continued on Page Six)

### RESUME CASE IN HONOLULU

**Prosecution Ready to Put on Evidence in The Killing of Hawaiian.**

Honolulu, April 11.—(AP)—The prosecution side of the story of the killing of an Hawaiian accused of attacking a white woman was ready to be told in court today.

Selection of a jury having been completed Friday, the prosecution assembled witnesses for the presentation of testimony and evidence, the next step in the deepest drama the "Paradise of the Pacific" has experienced in years.

As the trial resumed after recessing over Saturday and Sunday, Public Prosecutor John C. Keeley had before him the names of 29 persons who professed knowledge on one phase or another of the killing of Joseph Kahahawai, Hawaiian accused with four other men of attacking Mrs. Thalia Massie.

With the pidgin English they speak in court, since most of the prosecution's witnesses are Oriental and mixed blood, Keeley hopes to forge a chain of circumstantial evidence which will send Mrs. Massie's husband, Lieut. Thomas (Continued on Page Three)

### PUSH WORK ON ECONOMY

**Small Group Seeking Solution to Conflicting Views on National Program.**

Washington, April 11.—(AP)—Under the dome of the capitol a small group today sought adjustment of conflicting views to make possible the writing of a "national economy program" in one or more bills which, by changes throughout the government structure, would save the taxpayers at least \$200,000,000 this year.

### CANNON CASE IS APPEALED

**Government Asks Reversal of Decision of Lower Court in Case Against Bishop.**

Washington, April 11.—(AP)—The government today asked the District of Columbia Court of Appeals to reverse the decision of a lower court sustaining a demurrer to an indictment charging Bishop James Cannon, Jr., and Miss Ada L. Burroughs of Richmond, Va., with violating the federal corrupt practices act.

The case grew out of failure to make proper reports of contributions received during the Southern Methodist churchman's fight against the presidential candidacy of Alfred E. Smith in 1928.

Justice James M. Proctor of the District of Columbia Supreme court held that 10 counts of the indictment failed to charge any offense under the corrupt practices act. He declined to pass upon the constitutionality of the act which had been challenged by Bishop Cannon.

A hearing on the appeal is not expected before next fall.

### DR. FLETCHER SPEAKS HERE

**Washington Minister Delivers Sermon At the Memorial Baptist Church Sunday.**

Man can't be appreciated by looking at him through the big end of a telescope, but turn the telescope around and it is found that he is the highest type of creation, declared Dr. Maynard O. Fletcher, of Washington, speaking at Memorial Baptist church yesterday morning.

Shanghai, April 11.—(AP)—Today's Sino-Japanese peace parley failed to materialize when the Chinese asked a postponement as a result of failure to receive instructions from the government at Peking.

Rumors were circulated that further discussions are not likely to be held because the Chinese, feeling further talks here would be useless, planned to refer the whole matter to the League of Nations.

Tokyo, April 11.—(AP)—The Japanese military expedition at Chientao, Manchuria, occupied the village of Ehtaokou, west of Pait-saukou, after a fierce battle with the Chinese rebels in which three Japanese and 60 Chinese were killed, dispatches to the Rengo news agency today said.

### SEEK LEGAL PROTECTION

**Arkansas Collegians Report Being Whipped by Vigilantes on Visit to Kentucky.**

Knoxville, Tenn., April 11.—(AP)—The Arkansas collegians who came out of the Kentucky fields yesterday wearing belts they claimed vigilantes inflicted contrary to Dr. John R. Neal, attorney, here today on plans for re-entry provided they get legal protection against violence.

The delegation of five, representing Commonwealth College, labor institution, near Mena, Ark., came here last night and told of ejection from Harlow county, Ky., into Wise county, Va. They said they were beaten by Bell and Harlan county vigilantes and exhibited switch-strapped backs and other injuries.

Lucien B. Koch, 24, director of Commonwealth college and leader of the five, who had planned to distribute relief to Kentucky miners and copies of the bill of rights to deputy sheriffs in the mine area, said they intended instituting some form of legal action against their assailants.

They wired Roger Baldwin, director of the American Civil Liberties Union at New York, a description of his advice. Koch said they would not decide on their next move until a reply is received. Meanwhile they are the guests of Dr. Neal at a hotel here.

The students were not the only ones who claimed they were roughly treated in the Kentucky mine area Sunday. James Price, 37, of Philadelphia, legal representative of the general defense committee of Chicago, said he was kidnapped in Pineville, Ky., taken into the country, severely beaten and warned not to return.

Price said he returned to Pineville in the automobile of a passer-by and that his attackers accused him of being connected with communists. He is a defense attorney. (Continued on Page Six)

### President Hoover Lauds Devotion Of Red Cross

Washington, April 11.—(AP)—President Hoover today praised members of the American Red Cross in the name of the American people for what he termed a daily demonstration of a fine sense of devotion.

The president stood in continental hall here before the annual convention of the Red Cross and declared it would be "a neglect of duty" if he did not join in the opening of its meeting. He is president of the organization.

Mr. Hoover walked from the White House through misty weather for several blocks to the Red Cross meeting. His decision to address

was unexpected and was not announced until just before he left his executive mansion.

He spoke extemporaneously but with feeling. Before him, as he stood upon the low platform of the hall, was a colorful gathering. In one section a group of Red Cross nurses, wearing white and blue, yellow or gray and white uniforms (formed a solid block of color.

Mr. Hoover was introduced by John Barton Payne, chairman of the Red Cross.

During the past year, the president said in opening his brief address, the Red Cross has carried (Continued on Page Six)

Whitney told him he knew nothing of any such raid except something he had been told by Senator Walcott, (R. Conn.), about operations in United States Steel.

The exchange president also mentioned the stocks of American Telephone and Telegraph, Public Service of New Jersey and Consolidated Gas of New York as among those referred to in connection with the purported bear raids.

He said there had been no "bear raiding," but "great liquidating" in these stocks.

"Whitney read a statement saying: "In view of telephone communications with a member of the Senate Finance Committee on Friday indicating a desire for specific information, I asked members of the exchange to aid in supplying it."

He called attention that the exchange had offices throughout the nation.

"I regret that I cannot assure the committee that the statistics requested can not be provided before Friday noon," he said.

"I assure you of every intent to give all the data requested."

Whitney explained that it had been impossible for him to give voluntarily the facts asked for by Senator Walcott on Friday. He did emphasize, however, the determination of the exchange to cooperate with the Senate.

### HINDENBURG WINS AGAIN

**President Gains Over Two Million Majority For Presidency of Germany.**

Berlin, April 11.—(AP)—Field Marshal Paul Von Hindenburg, second president of the German Republic, settled back in his presidential chair today at 84, for another term of 7 years.

In yesterday's runoff election he rolled up a plurality of nearly 6,000,000 votes over Adolf Hitler, National Socialist candidate, his chief opponent.

The vote, as announced early today, was:

Von Hindenburg, 19,359,642.  
Hitler, 13,417,460.  
Thaelman (Communist) 3,706,388.  
Invalid, 8,204.  
Total, 36,491,694.

Chancellor Heinrich Bruening, at President Von Hindenburg's request, consented to remain in office as chancellor. He offered a formal resignation when he congratulated the president on his victory, but withdrew it later.

The winner will have the satisfaction of knowing he is a majority president. Although he failed to get a majority in the first election March 13, he rolled up a majority of 2,235,974 yesterday over the combined vote of his two opponents.

One National Socialist and one Republican were killed during fights in Hamburg and Bremen. Another man dropped dead from excitement. Three-score persons were injured and hundreds arrested.

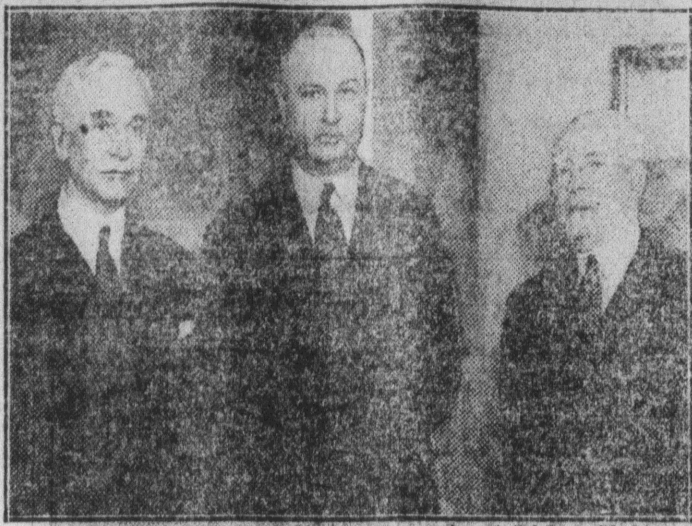

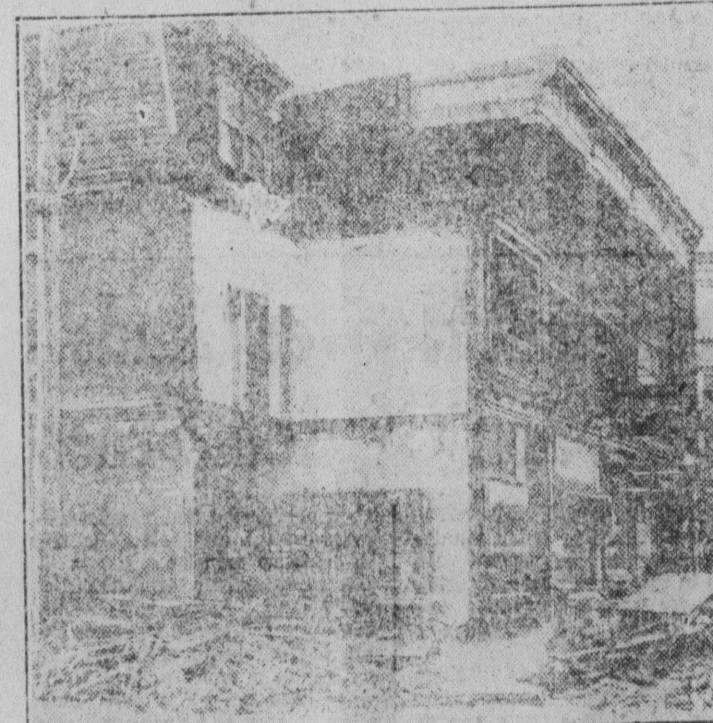

Plan for Control Of the Blue Mold

Keep the beds well ventilated. Keep the covers off the beds as much as possible and still maintain growth of the plants.

The presence of the cover on the beds tends to confine the moisture and keep the plant wet with dew until late into the day. Plenty of sunshine and good ventilation will reduce the moisture in the bed and lessen the damage by the disease. Beds should not be watered unless absolutely necessary to keep the plants alive.

For spraying the beds, use Bordeaux Mixture containing 2 lbs. of Copper Sulphate (Blue Stone) and 3 lbs. of Hydrated Lime (Builders Lime) to 50 gallons of water.

The best way to make Bordeaux mixture where one is planning to carry out the program of spraying tobacco bed is to make a stock solution of Blue Stone. This is done by dissolving the Blue Stone in water so that each gallon will contain 1 lb. of Blue Stone. This should be kept in a barrel or wooden container. This stock solution will keep indefinitely. When ready to spray the tobacco bed mix up the Bordeaux as follows:

For making 50 gallons of spray take 2 gallons of the Blue Stone stock solution and dilute it to 25 gallons of water, now take 3 lbs. of the lime and mix it thoroughly with about 3 gallons of water. After it is thoroughly mixed pour it through a strainer to remove any large particles. Pour the strained lime solution into the diluted Blue Stone solution, stirring the mixture rapidly, then add enough water to make 50 gallons.

The Bordeaux mixture will spread and stick to the plants better if two pounds of soft soap or half gallon of sweet skim milk or one half pound powdered milk is used with each fifty gallons.

Out of their analysis was to come a decision whether to stick to their own plan for a wage and salary rate cut in the federal payroll, or to adopt President Hoover's plan for reducing the working time, and thus the pay, of federal workers, with flat cuts only for the highest officials.

This was the outstanding point of difference in the tentative budget-balancing program worked out by the legislators and the president. Chairman McDuffie voiced personal dislike of some of the other provisions but called for sacrifice of individual ideas by all members in the interest of achieving national financial stability.

It is the president's idea, and Speaker Garner's also, that one big bill should carry all the changes, so as to circumvent the numerous vicious groups opposing individual items in the general program, fearing that if the proposals went in individually, so many of them would be knocked down that the net achievement would be puny. McDuffie, however, favored splitting the items in three groups, one carrying legislative changes, a second covering reduction in appropriations and the third containing plans for consolidating various agencies. By these tactics he hoped to prevent the bloc joining and possibly defeating the whole program.

The issue of salary reductions will confront the House tomorrow in striking fashion. With the appropriation bill for Congress itself before them, the members will have to vote on cutting their own salaries.

Colonel Lindbergh, in another of the rare statements he has authorized since the child was stolen from the Sourd Hills estate March 1, made several more points clear last night.

He disclosed definitely that there was an absolute ransom note, and that this note was such as to provide an absolute means of identifying the kidnapers.

He made clear that the parties to whom he paid \$50,000 in five, ten and twenty dollar banknotes early this month—had convinced him that they were bona fide representatives of the kidnapers, if not the kidnapers themselves.

He went further and reiterated his hope that the kidnapers would make good their promise. It was even reported that Colonel Lindbergh was willing to consider replacing the currency—the serial numbers of which now are in the hands of all banks in the country—with gold coin, which carry no identification numbers.

Colonel Lindbergh's statement last night said: "At the time the baby was kidnapped a ransom note for \$50,000 was left in the nursery. For obvious reasons it was necessary to withhold information concerning the ransom note."

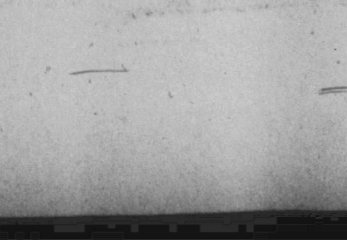

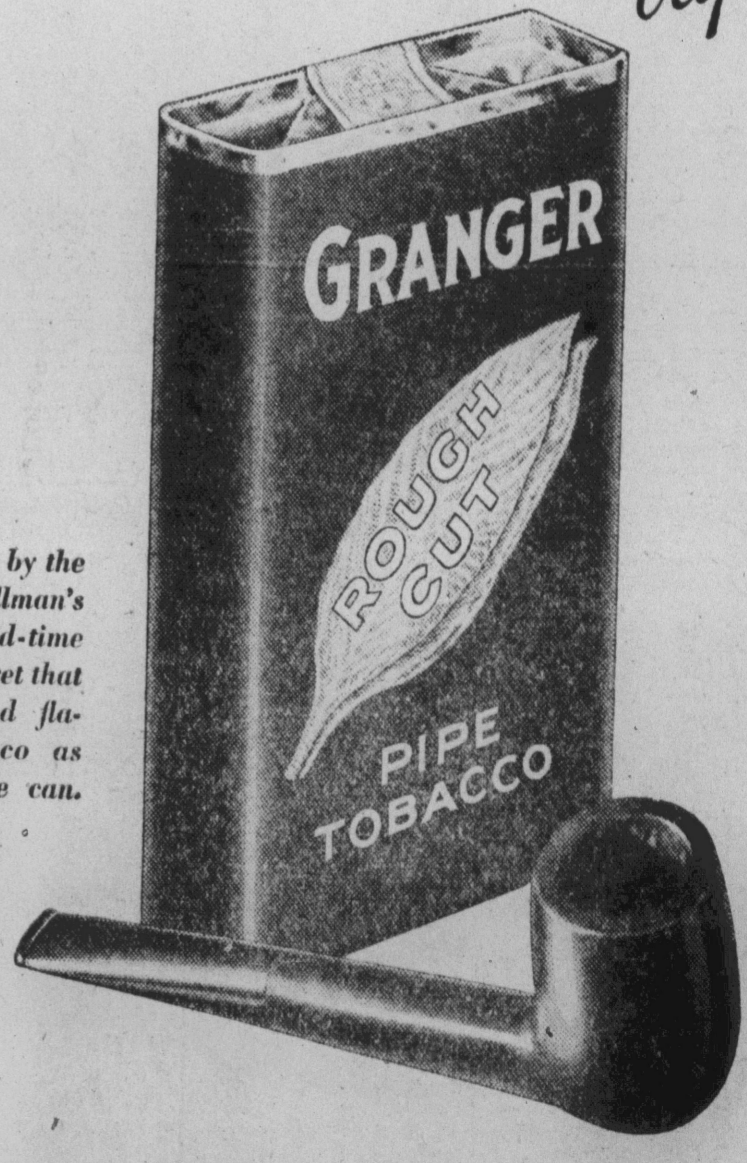

CARDS START YEAR FAVORED TO WIN AGAIN

New York, April 11 (AP)—It will be a rock road that leads to the 1932 National league pennant if shifts in player talent bring about an expected balancing of strength all down the line.

There is no getting away from the fact that the world champion St. Louis Cardinals will start the campaign tomorrow pronounced favorites to wind up in September with their third straight crown.

But there is no expectation that they can make such a run-away race of it as they did a year ago, met with such formidable challenges as the New York Giants and Chicago Cubs in that field.

Since the Cardinals captured the world series from the Athletics last fall they have lost the services of a great pitcher, Burleigh Grimes, and an outfielder, Chick Hafey, who won the league batting title last season. Hughie Critz apparently has conquered the arm ailment that took him out of the game most of last season; the outfield has been improved by the addition of the hard-hitting recruit, Len Koenecke, and Hal Schumacher should prove a help to an already powerful pitching staff.

The Cubs' threat would loom even more dangerous if Rogers Hornsby could bolster an outfield that consists chiefly of Hazen Cuyler. The infield also may be a sore spot now that Shortstop Ellwood English is out for two weeks or more with a broken finger. The comparatively inexperienced Bill Jurges will substitute, flanked by two youngsters, Stanley Hack at third and Bill Herman at second.

Brooklyn seems to have great potentialities that may be realized under Max Carey's guidance. The Dodgers' fate, however, depends upon the recovery of the pitching staff as well as the performance of such "key" figures as Hack Wilson and Glenn Wright. Joe Stripp and Tony Cucinello, obtained in the big deal with the Reds, should strengthen the infield but the illness of Del Bizzette, even with so experienced a substitute as George Kelly on hand, may hurt more than a little.

None of the other four clubs—Pittsburgh, Philadelphia, Cincinnati, Boston—seems to have developed the additional strength needed to boost them into the pennant fight but all should be vastly improved over last year, particularly the Phillies.

Trading was comparatively quiet and the market was within 3 or 4 points of the lowest at the end of the first half hour.

Liverpool cables reported covering with local and foreign buying at that market and said that the Manchester goods market was unsettled with producers losing ground.

### STOCK MARKET

New York, April 11.—(AP)—The opening of the Senate's inquiry into the stock market was accompanied today by a resumption of the withering away of share values which has been in almost uninterrupted progress for five weeks.

Selling was not in particularly heavy volume, and brokerage quarters generally said that short selling was negligible, but steady liquidation fell upon a feeble market. By early afternoon, there were numerous losses of 1 to 5 points, and share price averages indicated another new low for the past decade.

Utility, food shares, and miscellaneous industrials were particularly weak. Detroit Edison dropped 5, and Consolidated Gas and Public Service of N J 3 points to new lows. Rails were under less pressure than some other groups, but Santa Fe and Union Pacific dropped more than 4 points. In the food group, another biscuit, Continental Baking preferred, Beatrice Creamery, and Borden sagged 2 to 4 to new lows. General Motors was a heavy feature, sagging more than a point to a new bottom close to 11, and Dupont was carried down with it. U. S. Steel was off nearly 2 points, going fractionally below its previous minimum. American Can declined more than 2, going through last week's low.

Gears who have been nervous about being called before the Senate banking and currency committee and ordered publicly to reveal their positions in the market gained some comfort from the news that the committee would defer further investigation upon the completion of the examination of Richard Whitney, president of the exchange. Mr. Whitney's statement that the preliminary investigation indicated that the slump late last week was due to real liquidation rather than bearish activity confirmed opinions widely held in Wall Street.

### WOMAN DIES IN SUICIDAL ATTEMPT

Nice, France, April 11.—(AP)—Mrs. Ella Mae Bjorkman, wife of Edwin Bjorkman, of Asheville, N. C., died here yesterday after drinking poison and slashing her wrists. She was 32 years old.

Bjorkman, Swedish author and translator, was quoted as saying she would be buried here, but that later the body might be removed to Asheville, where he now is.

Mrs. Bjorkman gave no explanation of her act.

## Posse Continues Search for Slayer

Abbeville, S. C., April 11.—(AP)—An Abbeville merchant who returned today from Long Cane Creek swamp reported that Tom Wardlaw, negro, accused of slaying Andrew J. Ferguson, Abbeville county farmer, had been captured by national guardsmen and was being rushed to the state prison at Columbia.

Abbeville, S. C., April 11.—(AP)—While a posse and national guardsmen closed in on a section of Long Cane Creek swamp today in search of Tom Wardlaw, negro slayer of Andrew J. Ferguson, Abbeville county farmer, no word was sent out regarding definite knowledge of the negro's hiding place.

Late last night the Greenwood national guards was called out to aid in the search and Captain H. B. Godfrey, of the Abbeville national guard, said the men would begin closing in on the negro's suspected hideout before dawn.

Ferguson, 63, was slain Saturday by Wardlaw, 45, who, witnesses said, cut the farmer's throat following a quarrel and being absent from work the previous day.

The negro immediately fled and a machine gun unit from Orangeburg was ordered to Abbeville to supplement Battery F of the 115th field artillery of the national guard which already had been ordered out.

A number of citizens also were aiding in the search.

money in circulation so that commodity prices will rise.

"Whether the amount we propose to pay out is enough to accomplish this, I don't know," he said. "I don't think this amount is too much. The question in my mind is whether it is not too little."

"We don't expect to start out on any wild program like Germany did. We don't want to put out five times as much money as the country needs. We are willing to tie to a forty per cent gold basis.

"We have \$4,000,000,000 in gold according to treasury statements. That is enough for \$10,000,000,000 in currency. But there is only \$5,500,000,000 in currency in circulation. The trouble with this country is that it's on a double gold standard."

and the other endorsed the meeting to be held at Greensboro tonight for the purpose of crystallizing sentiment in behalf of the cause of the former service men.

The resolutions to be presented to members of Congress today contain several hundred names, including members of the Legion, former service men and others interested in the effort of the soldiers to secure full settlement of the debt which the government owes them.

A. B. Corey presided over the session and scores of people interested in the fight for compensation were present.

Mr. Corey explained the nature of the meeting and declared it was not a loan the men were demanding from the government but actual payment of a debt. He asserted that if the government is able to loan millions of dollars to railroads and other corporations, it should be able to settle in full with the men who sacrificed their all that civilization might be saved.

Other speakers in behalf of the measure were: L. C. Evans, Bill Dupree, D. J. Whichard, Hicks Corey, S. L. Bridgers.

The following committee was named to draft resolutions to Congress: S. L. Bridgers, D. C. Moore, June Rose. The committee drafting resolutions for the Greensboro meeting was: Chester Harris, Lester Jones, L. C. Evans.

The resolutions follow: WHEREAS, the membership of Pitt County Post No. 39 of the American Legion, the ex-servicemen of Pitt county, and the citizens of Pitt County, North Carolina, in a joint meeting assembled on April 9th, 1932; and

WHEREAS, said meeting was of the sense that the remainder of the Adjusted Compensation Certificates issued to the service men and women of the World War, should be paid;

NOW, THEREFORE, be it resolved: 1st, That the members of the United States Senate from North Carolina, and the members of the Congress from North Carolina, be urged to secure the passage of the necessary measure.

weapons can in no sense prejudice any other plan for achieving security.

"On the contrary," he added,

"the very relaxing of tension which would come from a general agreement to do away with these weapons in itself favors further agreement."

"Fundamentally, the demand for security arises from doubts on the part of a government and its people as to their ability successfully to withstand an invasion," Gibson said.

He emphasized that fear as to national safety is not to be dealt with by pure logic or peace established by argument alone.

Basically, the demand for security is founded on fear of invasion," he said. "It may well be asked why this feeling should be more acute today than in times past. I think the answer is rather simple.

"Before technical progress had reached its present proportions there was a certain inherent superiority in defense. A country that puts its faith in frontier fortifications was able to hold up armies of invasion at least until its defense forces could be mobilized and brought into action."

Within the last generation, however, he added, "certain new weapons have been developed to a point where frontier defenses no longer constitute an adequate safeguard against invasion."

Gibson urged that until this fear of invasion is allayed it will be impossible to effect considerable
