SUBMISSION OF RUM ISSUE NOW VERY LIKELY

Leaders of Both Parties May Favor Plank to This Effect at the Conventions.

Washington, April 16.—(AP)—Activity toward resubmission of the 18th amendment showed itself today as an increasing factor in the political preparations for the June conventions of the Republican and Democratic parties.

At the capitol, where hearings are in progress looking to an early vote by the Senate on resubmission, the two Wyoming senators joined in announcing themselves desirous of placing the prohibition question before the people. Both Kendrick, the Democrat, and Carey, Republican, have dry records behind them.

In Richmond, Virginia, Bishop James Cannon, Jr., one of the most active dry leaders, announced himself in substantial agreement with the "basal features" of the plan advanced by former Governor Harry F. Byrd this week's Jefferson day Democratic rally in Washington to make possible a popular vote on prohibition.

Hearing on this, Byrd, said he believed that having extreme dries as well as extreme wets approving his plan, it would be possible to secure quickly the constitutional change he proposed. In New York the Times quoted John J. Raskob, chairman of the Democratic national committee, as considering the Byrd plan better than his own proposal for a "home rule" amendment.

The Democratic committee of New York state, by adopting a resolution for repeal of the 18th amendment, brought to six the list of state organizations in the party which so far have recorded themselves for repeal or resubmission in their preparations for the Democratic convention. The New York action, said Governor Roosevelt, who is now the leading Presidential candidate, was in keeping with his ideas.

A prediction that the Republican national convention would go on record for repeal was made in Chicago in an interview given by Nicholas Murray Butler, who said he would force a roll call on a resolution to that effect and that there would be no "pussyfooting."

In Bishop Cannon's approval of the Byrd plan were a number of highly important qualifications. He opposed vigorously inclusion in either party platform of a plank recommending it. He objected to singling out the 18th amendment for its application, and favored making the direct vote by the people in each state take the place of the present provision for constitutional conventions as an alternative to ratification by the legislatures, which, upon ratification, would provide that future changes to the constitution be submitted direct to the people by Congress for a vote at a date when no other elections would be held, the vote to be counted by states, and ratification being (as at present) by three-fourths of the states.

Announce Foreign Trade Balance U.S.

Washington, April 16.—(AP)—The United States favorable foreign trade balance for March was announced by the Commerce Department today as \$25,000,000.

In a preliminary announcement the department said exports for March were \$156,000,000 compared with \$235,899,000 for March, 1931, and imports were \$131,000,000 compared with \$210,202,000.

Although the value of exports and imports shrank greatly during the period the favorable trade balance was only \$697,000 less than in the same month a year ago.

For the three month period ending March 31, the favorable balance was \$62,409,000 compared with \$141,547,000 for the same period last year.

Exports for the three months were \$459,917,000 compared with \$789,843,000 for the same period in 1931 and imports \$397,508,000 compared with \$568,296,000.

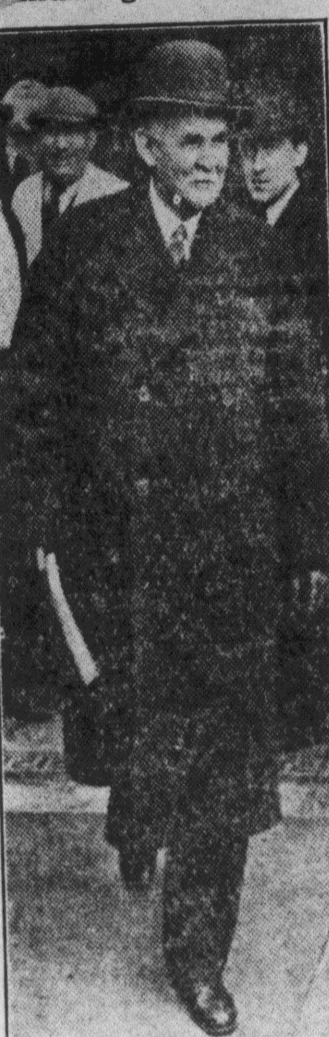
Forest Fires Rage in McDowell Area

AGED WELFARE WORKER DEAD

Julia Lathrop, One of America's Most Useful Women, Dies in Illinois.

Rockford, Ill., April 16.—(AP)—Julia Lathrop, the benign 74-year-old welfare worker whom Jane Adams appraised as one of America's most useful women, died.

Death came to her last night at a Rockford hospital following an operation for removal of goitre and terminated a career devoted almost wholly to the well-being of children.

Miss Lathrop's activities in the field of welfare work had been incessant and the fruits of her efforts she considered a greater reward than widespread recognition.

The government made her the first director of the Department of Labor Child Welfare Bureau. She was appointed to the League of Nations Child Welfare Commission in 1925 and in this connection made several trips abroad to study welfare work and methods.

For 12 years before and after the century's turn, she served as member of the Illinois State Board of Charities, juvenile delinquency and education, juvenile court laws and care of the insane engrossed her most and in these fields she became an authority. On her vast experience she drew to write a veritable library of authoritative reports in welfare work.

Machinery Is Organized For Primary Next June

Raleigh, April 16.—(AP)—Election machinery of North Carolina was organized today for the primary to be held June 4 and for the November general election.

At direction of the State Board of Elections the 100 county boards met at the respective courthouses and organized themselves, after which registrars and judges of election for every precinct in the state were named.

Political gossip in Raleigh in recent days has been comparatively quiet, most interest being evidenced in the fight being waged by four other Democrats on United States Senator Cameron Morrison.

For several weeks politicians here have been expressing the opinion that Robert R. Reynolds of Asheville was made things hot for Morrison with his prohibition modification stand. In usually well-informed political circles the strength of Frank D. Crist, state commissioner of labor, is not being discounted and Tam C. Bowle of West Jefferson and Arthur Simmons of Burlington are also seeking the top.

Reynolds is an avowed disciple of modification of the dry laws and Crist favors a referendum on the question. Morrison and Bowle are staunch dries and Simmons has not announced his stand on the matter. Simmons is a new-comer to state-wide politics.

Evidence that Morrison is feeling the pressure being brought by his four opponents was seen here in his announcement that North Carolina for three campaign speeches next week. Recently he spoke in Charlotte, Raleigh and Winston-Salem.

Reynolds is supposed here to be especially strong in the east and Morrison will speak at Wilmington, Fayetteville and Lumberton.

With no sign that George DePriest of Shelby expects to withdraw his name, there was every indication today that the Republican will be forced into their second state-wide primary in recent years on June 4 with DePriest and J. P. Sewell of Charlotte, nominee of the state Republican convention, listed on the United States Senate ballot.

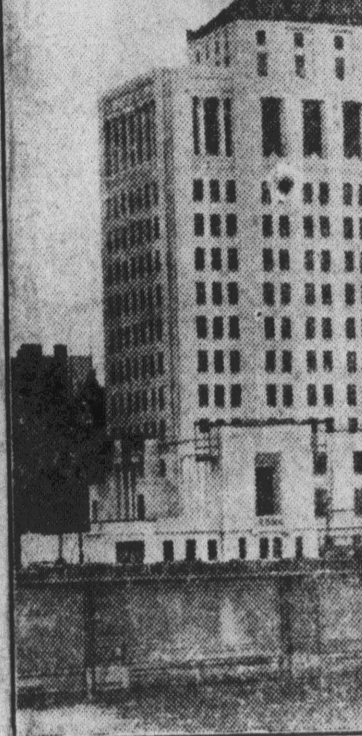

\$6,000,000 BUILDING WRECKED BY BLAST.



The \$6,000,000 State Office Building in Columbus, Ohio, was shattered by an explosion in which workmen were known to have been killed. LAUNCH FIGHT ON BLUE MOLD

Definite Campaign Is Outlined at Meetings Held in Pitt County Yesterday.

A concerted campaign against Blue mold, tobacco plant disease, was launched at two separate points in Pitt county yesterday under direction of agricultural experts from State college.

E. Y. Floyd, state tobacco specialist, and C. H. Brannon, state entomologist, spoke at Greenville yesterday morning and at Farmville yesterday afternoon. They were heard by approximately three hundred growers in both places and much interest was exhibited in the plan to combat the greatest menace the county has had in years.

The following recommendation made by the specialists were mailed out to various farmers from the Pitt County Farm Department today and it was believed that those who abide by them will find their condition greatly improved:

"The Blue Mold is spreading rapidly and will likely do serious damage before the plants are set in the field. The best known control measure is to spray with Bordeaux mixture. Spray every four days and spray thoroughly. If the disease is present, spray every two days. Begin spraying now before the disease gets started in your plant bed.

Use a sprayer that will put out as fine mist and under as high pressure as possible. Direct the (Continued on page six)

MOVE TO BAR ATTACK STORY AT HONOLULU

Prosecution Also Attempts to Force Promise of Name of Slayer of Hawaiian.

Honolulu, April 16.—(AP)—Clarence Darrow, defense attorney announced in court today that Lieut. Thomas H. Massie, one of the four accused of lynching Joseph Kahahawai, killed the young native and that Massie would plea insanity.

Exclusion of testimony relating to the attack on Mrs. Thalia Massie, wife of one and daughter of another of the defendants, which Kahahawai and four others was charged, also was sought by the prosecution.

Before Lieut. Thomas H. Massie resumes the witness stand to continue his story, thus far principally relating to the attack on his wife, attorneys prepared to argue in chambers the admissibility of testimony along that line.

Salisbury, April 16.—(AP)—Educational leaders and delegates from church boards and institutions gathered at Catawba college today for the formal inauguration of Dr. Howard Omwake as its new president.

Dr. Walter Klinge, president of Davidson College, Dr. A. T. Allen, state superintendent of public instruction, John F. Carpenter, of Maiden, representing alumni, and Andrew Rader, of Newton, representing the students, will preside at the ceremony.

The inaugural falls on the 7th anniversary of the laying of the cornerstone for the first Catawba College building at Newton. The college was moved here seven years ago.

Pres. Hoover Declares U.S. Slowly Recovering

Washington, April 16.—(AP)—It is President Hoover's belief that current pessimism on the American economic outlook is not warranted, and that several definite factors point to orderly recovery.

This view goes with the conclusion that the drive for liquidation has spent itself; that the several financial aids of the government to banking and business have conquered the major banking crisis; that alarm over pending legislation such as bonus payment and some of the more severe taxes placed in the revenue bill by the House appears much exaggerated in the light of careful study; and that the one needed factor is widespread confidence, not only among the leaders of business and industry, but down through the ranks.

Mr. Hoover is confident that Congressional sentiment assures speedy passage of the billion dollar tax bill in well balanced form, and that a canvass of Senate sentiment shows it is impossible for the \$2,000,000,000 bonus cashing plan to become law.

He pointed to the economy campaign now underway, in cooperative effort between Congress and the executive branch, as one of the greatest ever undertaken by any government in a single year, and places a high value on the Federal Reserve System's new program for an organized expansion of credit.

This summary of the President's views was given out by a thoroughly dependable source, as the result of a close study of the economic factors.

Coupled with the summary came a definite suggestion that widespread use of the five-day working week is essential throughout industry until a high degree of re-employment has been obtained. The President has been working hard to have this short week instituted in the government service as a standard employment plan, first to secure a needed payroll saving which he believes will total between \$75,000,000 and \$80,000,000, and second in expectation that instead of reducing government employment it will increase it by 25,000 to 30,000 workers.

Seek Slayer Of Mother-In-Law

Canton, N. C., April 16.—(AP)—After an all night search in the mountains near Transylvania county, Haywood county officers said today they believed the apprehension of Tom Justice, alleged slayer of Mrs. Alice Cook, his mother-in-law, was a matter of only a few hours.

Officers said they had covered Justice's trail closely since he fled shortly after Mrs. Cook was shot to death yesterday afternoon, and that they believed he was in hiding somewhere in the mountains either in Haywood or Transylvania counties.

John Kingsland, taxi driver, who was arrested on a charge of being an accessory to the slaying, was still in jail today pending further investigation.

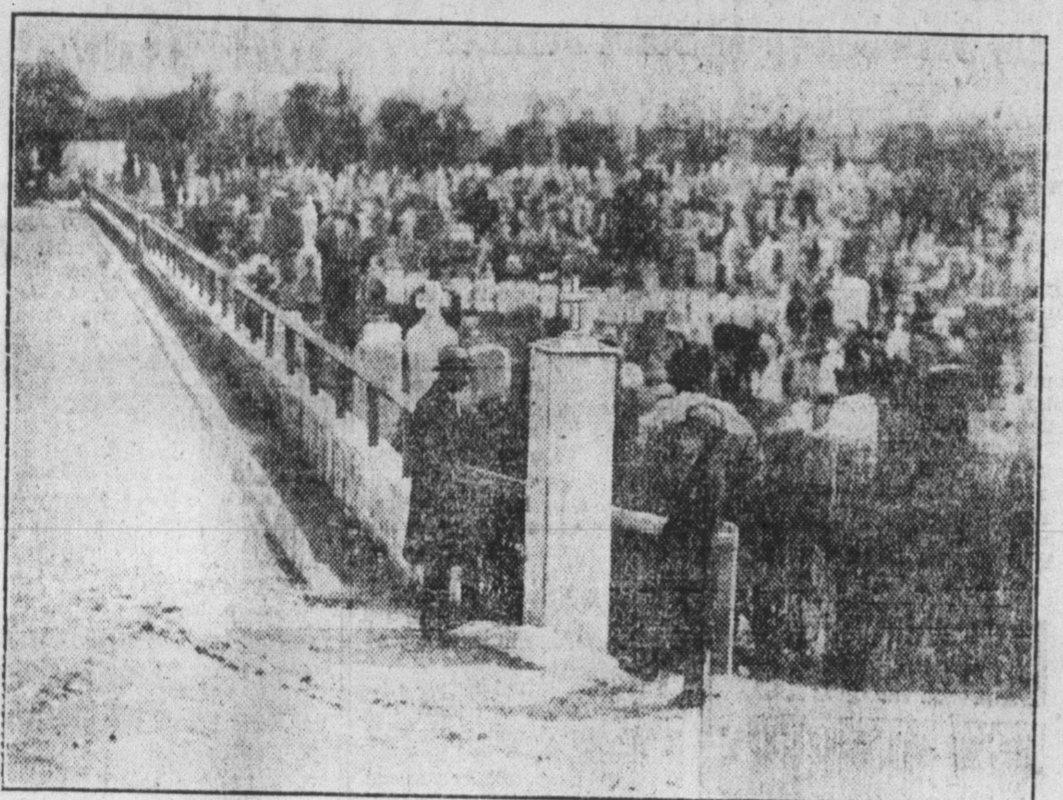

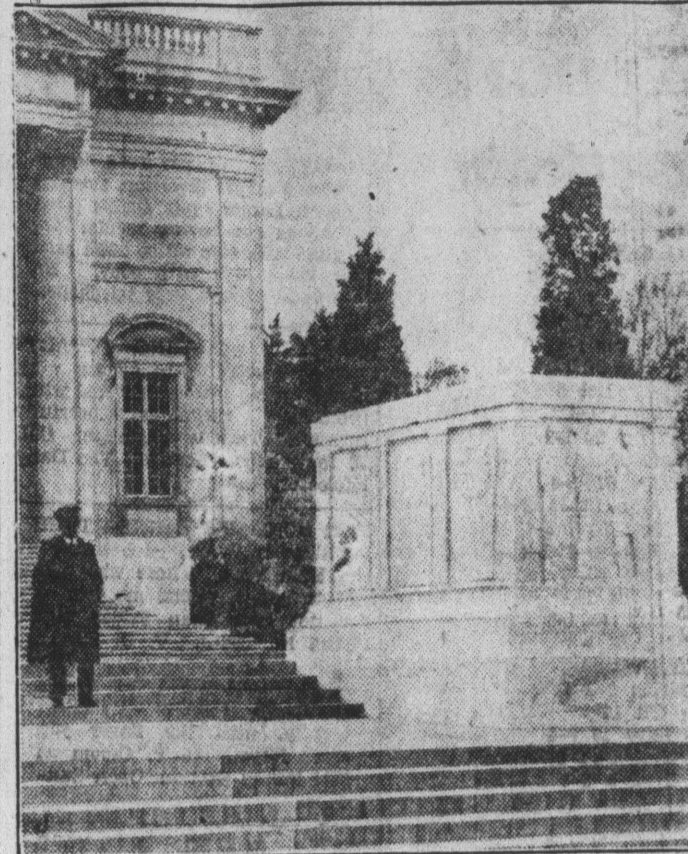

Raleigh, April 16.—(AP)—Declaring he could not perjure himself even to save his daughter, John H. Harwood, former State Superior court judge, pleaded guilty to a charge of mutilating the court record in an embezzlement case against her and was given a sentence of one year in the Wake county jail by Judge W. A. Devin.

The daughter, Miss Lola Harwood, at the same time entered a plea of guilty to a charge of embezzling \$4,823 in state funds while employed by the Revenue Department, and was sentenced to two years in state's prison.

Harwood brought his sensational climax to the case shortly after the jury had been completed for the joint trial.

Harwood, suspended from the bench a few minutes before his arrest, wept as he told how he had sought to change figures in record books to save his daughter. "The only thing in the world I had to look forward to."

But, he added, he knew she could not make a defense unless he went on the stand. "To carry out my purpose would have meant that I would have to perjure myself. I did wrong. I am glad I had the courage to determine not to go on the stand and swear falsely."

Attorneys said Harwood and his daughter reached their decision at a luncheon at court yesterday.

The father said he sought to erase part of his daughter's guilt from records in which he was given an order by a court order after her indictment.

As sentence was passed Judge Harwood showed no emotion, save in his attempt to aid Mrs. Harwood in soothing their daughter.

Miss Harwood's embezzlement was said by defense counsel to have taken place in her effort to recoup 1929 stock market losses in which her fiancé was involved.

Judge Devin, in passing sentence, expressed sympathy for Mrs. Harwood, he said, will feel greater punishment than either of the defendants.

"The fact that Harwood occupied a very high post makes it all the more imperative punishment."

(Continued from Page One) police, got the story. Larry Harwood told the Clines that Jutson had been drunk. The word spread, and Jutson called Cline and his wife to meet him, which they did. Harwood was sent for to confirm the story, and came accompanied by Wiley, his stepfather. A crowd gathered, his members took sides, and words flew thicker, faster and more bitterly.

From that night, various versions differ. Cline said Wiley drew a knife, and he retaliated by starting shooting.

"I don't know what happened then," he said. "I don't remember how many times I shot. After it was all over I went home and sat down."

Meanwhile, somebody rained Jutson down the back with a knife. Witnesses said Brooks did it. He denied he even had a knife, and said he was grappling with somebody else on the ground most of the time.

When officers arrived the community was quiet, and Chief DeWesse said many persons who had participated in the disturbance an hour before stood around discussing the tragedy, but furnished little information.

To make 50 gallons of bordeaux mixture: Dissolve 2 pounds of copper sulphate (Bluestone) in 2 gallons of water. This can best be done by placing the copper sulphate in a thin cloth and surrounding it in the top part of the water. Use only wooden, earthenware, glass or copper vessels for the copper sulphate solution. Next, mix 3 pounds of high grade hydrated lime (Plaster's lime) with 3 gallons of water. After the copper sulphate has dis-

solved, add about 38 gallons of water to the copper sulphate solution. Strain the 3 gallons of lime water through two or more thicknesses of plant bed cloth and add slowly to the copper sulphate solution, stirring well at the same time. Add enough water (about 7 gallons) to bring the entire solution up to 50 gallons. It is now ready to use and should be used immediately. If any is left over, pour it out and do not use the next day as it will lose strength on standing.

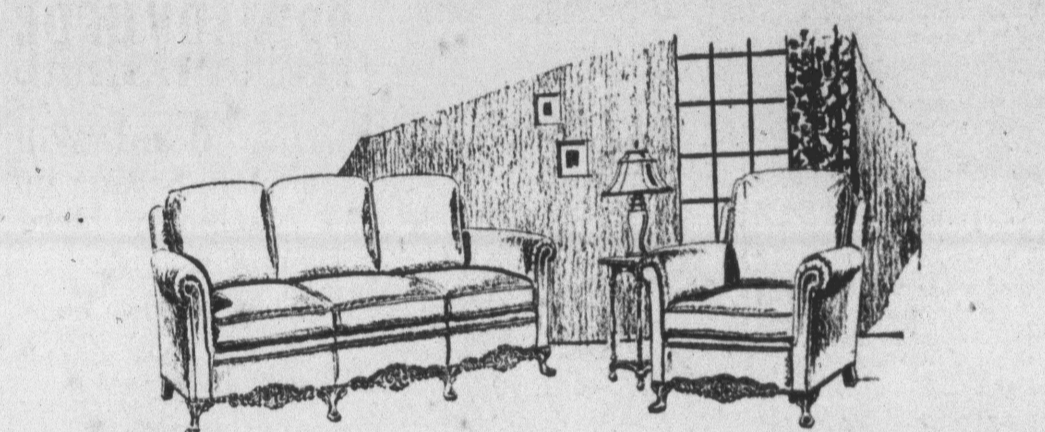
Poison for flea-beetles may be added to this bordeaux solution where needed. Mix together 1-4 pound of Paris Green and 11-4 pounds of Arsenate of lead and add to the 50 gallons of bordeaux. This is the most effective flea-beetle control we know of. Caution: Do not use this poison for flea-beetle more than once per week.

Remove covers from plant beds on warm sunny days to keep the plants as dry as possible. Put covers back on at night if there is danger of frost.
