# Agree To Give President Reorganization Power

## MRS. MASSIE WILL TESTIFY AT HONOLULU

### Assault Victim to Strike Final Blow in Defense of Husband at Lynching Trial.

Honolulu, April 20.—(AP)—Mrs. Thalia Massie, unwilling player in the drama of passion and homicide that has shaken Hawaii politically and socially, was chosen to strike the final blow for the defense in the Joseph Kahahawai lynching trial today.

Clarence Darrow, promising to end his case today, announced he probably would call the blonde 22-year-old assault victim to the witness stand in the effort to free her husband, Lieut. Thomas H. Massie, and three other persons accused of the killing.

A direct story of the brutality suffered by the young woman in the assault of last September was expected as the defense sought to reinforce the testimony of Lieut. Massie, who admitted holding the pistol that killed the young native.

Despite the efforts of a belated prosecution, Dr. J. Thomas Orblson and Dr. Edward Huntington Williams, Los Angeles alienists, insisted in their testimony that Massie was insane at the moment he faced Kahahawai with drawn pistol and heard the athlete allegedly confess attacking Mrs. Massie.

Dr. Williams remained to be cross examined, however, before the defense could take the final step in its case.

The announcement by Darrow, head defense counsel, that Mrs. Massie would be called was taken to mean none of the other defendants, Mrs. Granville Fortescue, mother of the attack victim, Albert O. Jones and E. J. Lord, navy enlisted men, would take the stand.

The defense previously had considered calling Jones because of prosecution hints that he was the real killer of Kahahawai. It was learned, however, the defense had decided to let Lieutenant Massie's story stand as the only direct account of the killing.

Dr. Orblson termed Massie's ailment as "delirium with ambulatory automatism" which he reduced to plain "mental derangement" when Darrow asked him for a simplified definition. The twelve men in the jury box exhibited signs of interest.

Massie told me, "said the alienist, "that in the moment Kahahawai uttered the words 'we done it,' he didn't know what happened. I asked him what he did with the gun and other things and he said he didn't know."

## Brummitt Rules On Lien Question

Raleigh, April 20.—(AP)—Attorney General Dennis G. Brummitt held today that no occasion should arise in which towns and counties cannot determine the priority of tax liens.

R. A. Joyner, clerk and treasurer of Farmville, propounded a question to the attorney general as to which lien would have priority if separate suits were brought by a town and county for taxes.

In such cases, the letter of Mr. Brummitt said, "if the municipality and the county are made parties to each suit and neither took further notice of the other's suit, my opinion is that the first sale which is had fixes both the question of lien and priority."

"But," it continues, "I hardly see how such a state of affairs could exist. There was no necessity or room for two such suits. Whichever sued first, the county or the town, must make the other a party, and in such a suit it would be the duty of the county or the municipality, as the case might be, to intervene when notified and established its lien."

## Killer of Mother-in-Law Shoots Himself to Death

Waynesville, April 20.—(AP)—Tom Justice, sought for slaying his mother-in-law, shot himself to death in Haywood county today.

Justice killed Mrs. Alice Cook, his mother-in-law, at Canton Friday and fled into the mountains. A continuous search for him night and day had been under way since. The hunted man's body was found in remote section of the county. He had left several letters, but officers would not reveal their contents.

## COURT RULES IN HIGH UNIFORM PITT COW CASE

Raleigh, April 20.—(AP)—The State Supreme court today handed down 13 opinions, ruling in a Pitt county appeal that physical presence of a person when something is stolen is not necessary in order to convict of larceny.

The ruling from Pitt was made in the "Whitehurst cow" case in which Pearl Whitehurst, J. O. Manning and Doc Moore were found guilty of the larceny of a cow of Zeb Whitehurst which was valued at \$31.90. The case was bitterly contested in Superior court and the defendant Manning appealed.

Testimony was to the effect that Manning was at his home, three miles from where the cow was stolen and butchered, but Pearl Whitehurst testified he killed the cow and sold it in Tarboro for \$25 "because Oscar Manning asked him to do it."

Justice Brogren ruled in the opinion that "physical presence is not deemed absolutely essential to convict" if it is proven that the defendant "actually advised or procured the crime" or aided and abetted in the commission thereof.

The court found no error in the lower court's decision. In the case of C Stephenson and his wife, Minnie Dhue Stephenson, on the appeal from Durham county of the wife from a court order sustaining a demurrer of Duke University that the feme was not a proper party to a suit for the mutilation of the body of their child, the court held that the father could enter suit for damages but not the mother and sustained the demurrer.

Stephenson filed suit against Duke for damages occasioned by the mutilation of the body of his child in an autopsy performed allegedly without his permission and later his wife was made a party to the suit.

Justice Adams wrote the court's opinion sustaining the lower court in its ruling that the wife could not sue and said that the identical question had never before been decided in this state.

## NEW DISORDER IN COAL FIELDS

Fresh Disturbances Reported in Strike Zone in Ohio Mine District.

Cadiz, Ohio, April 20.—(AP)—Fresh disturbances broke out today in the Eastern Ohio coal fields where miners are on strike in protest to wage reductions.

A mysterious explosion shook the village of Jewett, 10 miles north of here, about 1:00 a. m., but apparently did no damage.

Sixty miles to the south, in Noble county, nearly 200 strike sympathizers, a few hours later, attempted unsuccessfully to prevent 200 non-strikers from going to work at the Caldwell mine near Caldwell. The strikers were dispersed by Sheriff Clayton McKee (Continued on Page Six)

## CRIST BOOSTS SENATE DRIVE

Candidate For Congress Delivers Address at Courthouse Here Today.

Giving his support to cash payment of soldiers' compensation certificates and the lifting of the tax burden from the shoulders of the oppressed farmers, Frank D. Crist of Raleigh, spoke at the courthouse at the noon hour today in behalf of his candidacy for the U. S. Senate.

Declaring the government had granted adjusted compensation to railroads, steel corporations, construction companies and foreigners taking part in the World war, the speaker asserted the time had come to pay off the men who risked their all that civilization might be saved from the heel of German autocracy.

These same interests that received millions of dollars compensation are now throwing up their hands in amazement, Mr. Crist said, because the soldiers are asking for what compensation they have already earned. They call it a "bonus," he said, to cause people to believe the soldiers want the government to give them some (Continued on Page Six)

## COURT PUSHES DOCKET HERE

Several Defendants Given Jail and Road Sentence in Criminal Court Yesterday.

Joe Lancelley and Marsha James, colored, charged with selling whiskey were found guilty in the criminal term of Superior court here yesterday. Lancelley was sent to the road for 15 months and the woman was given 6 months in jail.

Lance Woolard, colored, convicted of larceny, was sent to the roads for 12 months.

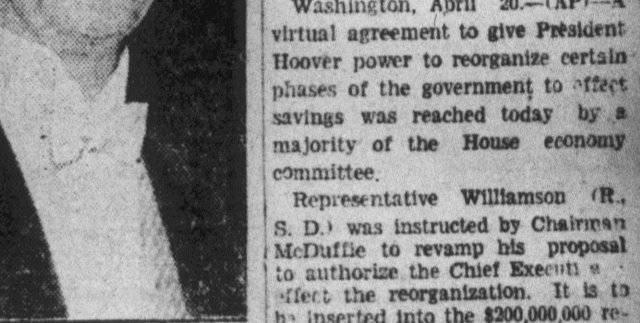

## Committee On Economy Takes Steps To Slash Government's Expenses

### Heads Demos Drive

Rep. Williamson Instructed to Revamp proposal to Authorize Hoover to Effect Reorganization Of Certain Phases Of the Government; Details of Proposal To be Worked Out Later.



Washington, April 20.—(AP)—A virtual agreement to give President Hoover power to reorganize certain phases of the government to effect savings was reached today by a majority of the House economy committee.

Representative Williamson (R. S. D.) was instructed by Chairman McDuffie to revamp his proposal to authorize the Chief Executive to effect the reorganization. It is to be inserted into the \$200,000,000 re-trenchment omnibus bill.

President Hoover has requested Congress to give him this power. Williamson, ranking Republican on the expenditures committee, author of several consolidation bills that have been enacted sponsored the legislation.

Although details of the proposal are yet to be worked out, the committee indicated it planned to direct the president to make certain changes in the government's set up subject to approval by Congress.

Meanwhile, the committee is studying of President Hoover's proposals to reduce by \$23,000,000 benefits to World War veterans. Connor Roberts, solicitor of the Veterans Administration, explained the Chief Executive's proposal.

The committee has proposed a reduction of \$20,000,000 in the veterans administration. A statement issued by the National headquarters of Returned Veterans of Foreign Wars said the president's proposal were too drastic.

They would reduce allowances, pensions and free hospitalization to veterans and place other restrictions on benefits.

Several other proposals were made to reduce the cost of the war. The current moratorium expires in June and despite President Hoover's message to Congress last December 10, asking provision for "temporary adjustment" in the war debts, it has been clear that the administration had every intention of heading the sharp retort of Congress that the existing moratorium was the limit to which American public sentiment would go.

Borah warned the European nations not to come to the United States for debt relief until they have disarmed, settled reparations and revised the Versailles treaty. In his powerful oratorical voice he told the Senate that the world war still goes on, "remorselessly and to some extent more destructively than on the battlefield."

## NEW ATTACK ON WAR DEBTS

### Chairman Borah Turns Smashing Attack on Cancellation Idea in Congress.

Washington, April 20.—(AP)—A series of attacks against the vision or cancellation of the war debts owed this country by Europe has been unleashed in Congress, echoing the declarations of unalterable opposition which rang forth when the one year moratorium was ratified last winter.

Senator Borah, the chairman of the foreign relations committee, from the Senate floor yesterday turned a smashing attack on the cancellation idea, speaking unexpectedly after it became known that Great Britain had made no budget provision for payment of the debt installment due the United States next winter.

The current moratorium expires in June and despite President Hoover's message to Congress last December 10, asking provision for "temporary adjustment" in the war debts, it has been clear that the administration had every intention of heading the sharp retort of Congress that the existing moratorium was the limit to which American public sentiment would go.

Borah warned the European nations not to come to the United States for debt relief until they have disarmed, settled reparations and revised the Versailles treaty. ## British Budget Viewed as Hopeful

London, April 20.—(AP)—Majority opinion on the national government's budget, introduced in the House of Commons yesterday by Neville Chamberlain, chancellor of the exchequer, today appeared to be summed up in the words of one prominent conservative industrialist who described it as "deeply disappointing, but not disheartening—inconclusive, but in some respects hopeful."

Liberal opinion, on the whole, treated the budget favorably, although Maj. Gwynll Lloyd George, son of the former leader of the party, described it as one of the worst budgets in recent years.

Other free-trade liberals expressed themselves as "thankful for small mercies," and commended the impartiality of the chancellor in granting no one relief because he could not ameliorate the condition of the unemployed and other chief sufferers from the government economy program.

## Norfolk Lawyer Faces Disbarment

Norfolk, Va., April 20.—(AP)—W. Shepherd Drey, Norfolk attorney, acquitted in North Carolina of conspiring to obstruct justice in the receivership act against the Home Mortgage Company of Hickory, has been ordered to appear before Judge A. B. Hancel in circuit court here May 23 to show cause why he should not be disbarred.

The proceedings were filed by the Norfolk and Portsmouth Bar Association, following an investigation by it of the activities which led to Drey's indictment in Eastern North Carolina Federal Court.

Alton L. Jordan of Norfolk and Clarence Dozier of South Mills and Durham, N. C. were also acquitted of the conspiracy charge, but Jordan was convicted of perjury and sentenced to two years in prison, from which he appealed.

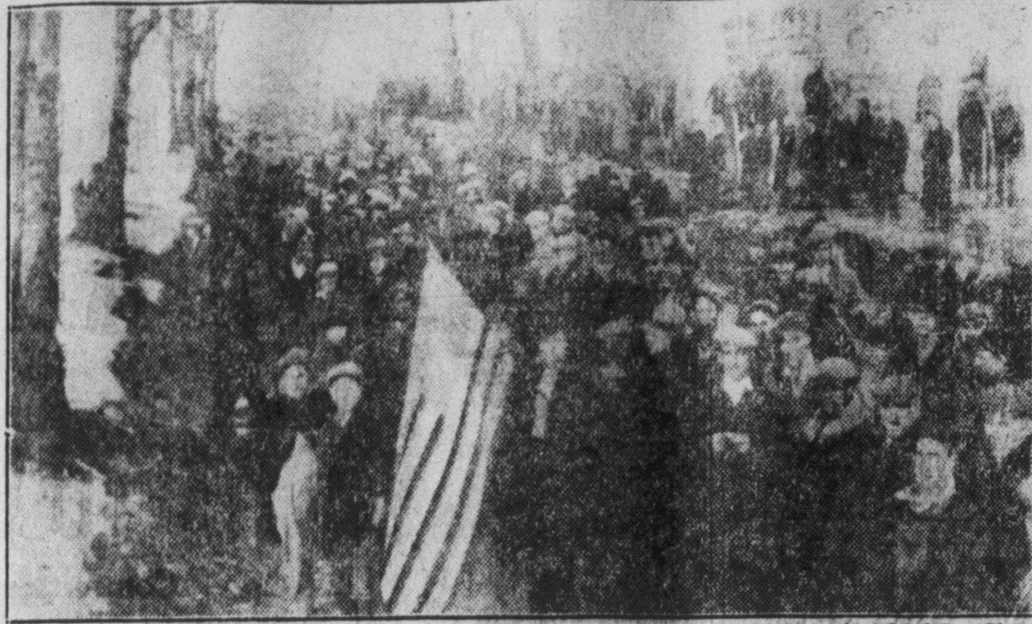

# FIND WITCHES IN CAROLINA

## Children Educated From Babyhood to Be Witches, Found Among Cherokees.

Washington, April 20. — (AP) — "With-children," specially educated from babyhood to be witches, have just been reported by a scientist to exist among the Cherokee Indians of North Carolina.

These 20th century witches are "made not born," says Dr. Frans M. Olbrechts, Belgian ethnologist, in a report issued today by the Smithsonian Institution. Children, preferably twins, selected for a career as witches, are put through an initiation supposed to endow them with supernatural powers.

"If twins are born and their parents intend to make witches out of them," Dr. Olbrechts reports, "no mother's milk is given them for 24 days. They are fed with the liquid portion of corn hominy, which must be given them only during the night. They must be kept rigidly secluded from all visitors during the same 24-day period.

The twin witches, even in babyhood, are supposed to have remarkable powers. The Cherokees believe they can fly through the air, dive underground and walk on the sun's rays. They can assume all kinds of human and animal shapes, and even when they are only a month old "whatever they think happens."

The youthful "witches" according to Olbrechts, are believed by the Cherokees to go and play with the mythical "Little People" although these are invisible to everyone else.

Parents of "with-children" never worry about them. No matter where they go or how long they may be absent, for the children are believed capable of looking after themselves.

"When they are grown up," says Dr. Olbrechts, "they are most annoying individuals to the Cherokees. They always know what you think and you could not possibly mislead them. What is worse, they can make you ill, dejected, love-sick or dying merely by thinking of you in that condition."

# DAIL PASSES OATH MEASURE

## Bill to Abolish Allegiance to British Crown May Yet Meet Opposition.

Dublin, Irish Free State, April 20. — (AP) — President Eamon De Valera's bill to abolish the oath of allegiance to the British crown was passed on first reading without a division in the Dail today.

This had been expected, but a critical vote is looked for when the bill comes up for second reading next Wednesday.

President De Valera contends that by moving to abolish the oath to the crown he is carrying out a mandate from the people who elected him to office.

One of his first official acts after inauguration as president was to signify the British government that the oath would be abolished and that payment of the Irish land annuities to England would be discontinued. England warned him that such steps would be regarded "with the gravest concern."

A more practical obstacle was placed in his way last week when the largest individual employer of labor in Ireland announced that if the Fianna Dail program resulted in Ireland's separation from the British commonwealth his factories would be removed to England and at least 1,500 men would be laid off.

## Man and Woman Slain in New York

Garden City, N. Y., April 20. — (AP) — The bodies of a man who had been stabbed to death and a woman whose head had been crushed were found today in an open field in Garden City Park, Long Island.

The victims of what police described "must have been a terrific struggle" were discovered by K. L. Hulbert, of Rockville Center, Long Island, who was driving down a narrow lane.

The man was tentatively identified as E. E. Brinker Jr., of Jackson Heights, and the woman was believed to be Rose Welk of Flushing. Each was about 35 years old.

The woman's mouth was covered with adhesive tape. Her skull had been smashed open. There were numerous stab wounds in the man's throat and chest.

## Youth Stabbed During Fight

Bakersville, April 20. — (AP) — Carl Hughes, 17, was in a serious condition in an Asheville hospital today and Charles Poteat, 14, was held in jail here following a fight last night in front of the Bakersville-Bowman high school when Hughes was stabbed.

## Man Resentenced In Assault Case

Asheville, April 20. — (AP) — Harry Moore, already serving a state prison sentence for assaulting George Davis with a deadly weapon, was returned here when Davis died, tried for murder, and resented to from 20 to 30 years.

His original sentence was nine to ten years, inflicted almost a year ago.

Court officials said it was the first time a defendant has been tried and convicted in North Carolina in an assault case and then tried for the subsequent death of his victim. Had Davis lived four days longer, under state law, officials could not have construed his death as the result of the assault and brought Moore back for trial.

## ABOUT TOWN

Three carloads of flour to be released by the Red Cross among the poor people of the county should do much toward alleviating the suffering which has existed the last several months.

The flour was made possible by action of the government setting aside forty million bushels of stabilization wheat to be converted into flour for relief work and millions of people will be directly benefited.

While relief work in Pitt county has been conducted in a most admirable manner in the face of the heavy demand from all communities, the flour will enable the forces of mercy to reach out and serve probably more people than has yet been cared for.

The Red Cross will see that the flour reaches deserving homes, and this will enable the people to more successfully span that period intervening between the next crop season.

Greenville people are to be congratulated upon the way they have responded to the appeal for contributions with which to buy uniforms for the high school baseball team.

Within three days after the proposal was made the required amount has been raised and in a short time now the ball team will appear on the diamond all dressed up and with a consuming desire to express their appreciation to the public with additional victories.

The club has fringed into the lead of the conference race for the championship and it would not be surprising to see the boys close the season with the flag in their possession.

The public should attend the remainder of games played on the local lot and watch the youngsters in the splendid battle for conference honors.

For the third time in almost as many weeks the Pitt County Post of American Legion has given public expression to its desire for passage of the bill providing for cash payment of soldiers' compensation certificates.

The last expression came Monday night when the Legion again unanimously voted in behalf of the measure and passed resolutions calling on members to Congress urging them to support it.

The majority of posts of the state have taken similar action, proving conclusively that Henry Stevens of Warsaw, national commander, didn't know what he was talking about when he said only 23 posts of the nation had "kicked over" in favor of the proposal.

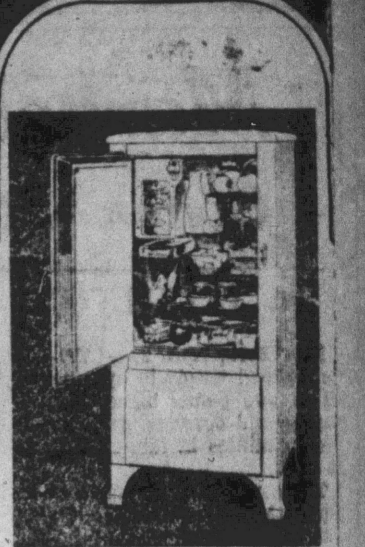

### STOCK MARKET

New York, April 20.—(AP)—The stock market was unable to decide today whether to follow an upturn in the rails, or a moderate decline in a handful of industrials.

Liquidation showed further signs of drying up, but buying interest remained at low ebb. Midweek business statistics were a shade more favorable, but were not sufficiently cheering to interest traders in trying for a rally. The market was sluggish.

In the first hour, advances of about 3 points were recorded by Santa Fe and Union Pacific, and leading rails generally advanced a point or so, including New York Central, Pennsylvania, Southern Pacific, New Haven, Chesapeake & Ohio, and Baltimore & Ohio. These gains were not fully maintained later on, but on the whole, the carrier list held up well. American Can was again a soft spot, sagging 2 points to a new low before meeting support. U. S. Steel common lost only a fraction, but the preferred dipped a couple of points to a new low since 1904. Gillette, Allied Chemical, North American and American Telephone were other issues encountering some pressure.

The ability of the general list to hold up well in face of scattered selling and rather sharp declines in a handful of issues during the past few sessions had been regarded in brokerage quarters as distinctly encouraging. Hangover selling, of one sort and another, however, has prevented any resumption of last week's rally. Some brokers say that this selling in a considerable measure reflects the selling out of collateral loans by banks. Other factors are low earnings and prospective dividend cuts.
