Entrants Democratic Primary Establish New Mark in North Carolina

NEW PRIMARY FACING G. O. P.

Fifty-four Democrats Will Contest for One Senate Seat, 11 Congressional Seats and 13 State Offices; Unless DePriest Withdraws Republicans will be Forced to Name Nominee.

Raleigh, April 23.—(AP)—With 54 Democrats and 26 Republicans recorded when the entry books of the State Board of Elections were closed at midnight last night a new record for entrants in a Democratic primary was believed to have been established and a Republican primary appeared assured.

The 54 Democrats will contest for one seat in the United States Senate, 11 congressional seats and 13 state offices.

Voters will select the nominees in the primary June 4 and unless George D. DePriest, a wet Republican of Shelby, withdraws his name before that date the Republicans will be forced into their second successive state-wide primary in order to select a nominee to the United States Senate. Jake F. Newell of Charlotte, selected by his party's state convention, paid his fee and so did the Shelby man.

The last two filers recorded, their letters being found in the post-office at midnight, were L. P. Dixon of Siler City and B. B. Howell of Tarboro, Republican Congressional candidates in the Fourth and Second Districts, respectively.

Other last minute entrants include R. Lawrence of Winston-Salem, president of the State Federation of Labor, and B. F. Smith of Raleigh, who swelled the number of Democrats running for commissioner of labor to six.

The only surprise in the filers the last day was sprung by D. W. Morton of Beaufort who filed to oppose Dan C. Boney for the Democratic nomination as insurance commissioner.

A check of the mail this morning did not reveal any tardy filings. With the various county boards of election already organized and registrars appointed, the books for registration open April 30, next Saturday. They will be open each Saturday until May 21.

Though the entry list for the state and congressional offices has closed, those for state senator, House of Representatives and various county and township offices are open until May 20.

Sampson Bankers Face \$50,000 Suit

Raleigh, April 23.—(AP)—Officers and directors of the defunct Bank of Clinton, in Sampson county, are defendants in a \$150,000 suit filed here by Gurney P. Hood, state commissioner of banks, which alleges the bank was operated for more than 10 years under a system calculated inevitably to result in utter insolvency.

Major George A. Butler and L. A. Bethune, of Clinton, are alleged in the suit to have made fraudulent conveyance of property held by them and their wives with intent to "defraud, hinder, and delay" creditors and place the property beyond the reach of legal process. The suit asks that deeds involved be declared void.

SAYS SCIENCE AIDS PROGRESS

Dr. Robert Millikan Tells of Three Great Elements in Human Progress.

Chapel Hill, N. C., April 23.—(AP)—The Golden Rule, the theory of evolution and the idea of natural law are the three great elements in human progress, Dr. Robert A. Millikan, famous scientist, told a University of North Carolina audience in his final lecture here on the relationship of science and religion.

"With increasing knowledge," said the California Institute of Technology lecturer, "man's idea of God, the integrating factor in the universe, began to draw to an end, and mankind began to move forward to a finer, bigger, more mature more satisfying conception of God.

"Man's conception of duty, and therefore of religion, also began to change. Under the old conception his chief duty had been to propitiate his God. Hence monasteries, penance, withdrawals from the world and useless lives. Under the new conception duty came to be to try to understand God's laws, and to bring one's life and the lives of all mankind, into harmony with them. That is what brought about the stupendous change in outlook of the past century.

"Religion and science became the two great forces which have ruled and are pulling the world onward and upward. The two are necessarily intimately related, for the primary idea in religion lies in the single word 'ought'—the sense of duty being underneath all religion, while what is duty must be determined by science in its broad sense, that is, a question of knowledge or intelligence rather than of conscience."

In an earlier address at Duke University, in Durham, Dr. Millikan cited figures to show that in the past 100 years, the greatest scientific century in the world's history. (Continued on Page Four)

Armed Guards Stationed Around Tobacco Beds

Destruction of tobacco plants by the Blue Mold has assumed such serious proportions in Pitt county that armed guards have been placed around plant beds to prevent theft, it was revealed by reports reaching the city today.

Not many farmers have resorted to this action, but several in widely separated areas have decided to guard their beds night and day to save what few plants they have left.

The spread of the disease has assumed alarming proportions in practically every community, and experts believe the crop will be reduced at least fifty per cent as result of the destruction.

NEW FLARE-UP MOONEY CASE

States Look to Protection of California Governor as Result of Pardon Denial.

San Francisco, April 23.—(AP)—As Tom Mooney continued his round of humble duties at San Quentin prison today, nationwide debate over his fate flared to new heights and police in other states looked to the protection of the California governor who had denied him a pardon.

At the executive office in Sacramento, a flood of messages poured in, some laudatory and others severe in condemnation of the decision, announced Thursday, which denied the convicted San Francisco Preparedness Day bomber freedom.

Meanwhile Gov. James Rolph Jr., target for the praise and blame, was crossing the continent by airplane to attend a governors' conference at Richmond, Va.

He said he did not fear violence. "I have not received a single letter since I have been in office," he said. "I have been very busy and have not had time to read them."

FIND DEAD MAN AT CHARLOTTE

Body of Man Dressed in Woman's Clothes Found Hanging in A Warehouse.

Charlotte, April 23.—(AP)—Dressed in a woman's frock, bobs in the ears and goggles over the eyes, the body of Albert Rudisill, 24, was found suspended by a woman's silken coat from a frame in a warehouse here today.

The body was suspended from the neck. One foot rested against a pile of cardboard boxes while the other was hanging straight down. Coroner Frank Hovis said death was due to strangulation and that the neck was not broken. He launched an investigation to determine whether the death was a suicide or a murder.

Police were inclined to the suicide theory. Rudisill was employed at the warehouse as shipping clerk. His own clothes were found where he worked.

A search was launched for him last night, but the body was not discovered until today. Mrs. Rudisill said the dress in which the body was clad was not one of hers. She said she had never seen it before.

FLIERS STILL HELD IN JAIL

Investigation Continues in Mysterious Death of Haden Clarke at Miami.

Miami, Fla., April 23.—(AP)—A yellow slip, two suicide notes, correspondence and the wound that cost the life of Haden Clarke, young writer and fiance of Mrs. Jessie M. Keith-Miller, Australian flier, were studied by authorities today in an attempt to determine whether his death was a suicide or a slaying.

Clarke, collaborating with Mrs. Keith-Miller in preparation of her life story for publication, was shot in his bed a few hours after Captain W. M. Lancaster, his roommate and the woman flier's partner for the past five years, heard the plans of Clarke and Mrs. Keith-Miller to (Continued on Page Four)

Convicted Killer Critically Sick

Mocksville, N. C., April 23.—(AP)—John Henry Hauser, 32, under sentence of death for slaying his son-in-law, lay in the county jail here today critically ill of pneumonia.

Dr. S. A. Harding visited the aged Davie county man today and said he was "no better" than yesterday when he was first reported suffering from heart disease and "on verge of pneumonia."

Hauser, oldest man to be sentenced to die in the electric chair in North Carolina, was convicted of shooting to death Fred Styres, the son-in-law, during an argument over whether it was "too wet to plow corn."

Dr. Harding said Hauser might be removed from the flail later today but the prisoner remained there this morning.

Hauser has been in declining health for several weeks and his condition became critical yesterday. The shooting took place at the Hauser home last May and Hauser's appeal to the Supreme court from the death sentence is now pending.

Nothing New Develops From Dees' Autopsy

Concord, April 23.—(AP)—After an autopsy on the exhumed body of Jack Dees, textile worker slain by a shotgun charge fired through a window of his home several weeks ago, Sheriff R. C. Hoover announced "nothing sensational" was found.

Shot which killed Dees were removed from his heart, and it was understood, did not compare with shot in wounds received by Cletus Hudson, brother of Mrs. Dees, who was struck by a second charge fired into the room.

The sheriff said information obtained in recent investigation and the autopsy would be laid before the grand jury.

SEES SIGNS IN LATE OFFERS

Connecticut Statesman Asserts that the Gang Leader's Double Offer to Find Aducted Child Lends Support to Belief the Child was Taken By Gang Members To Effect His Release; New Offer by Gangster.

Washington, April 23.—(AP)—Senator Bingham (R., Conn.), said in the Senate today that the fact that Al Capone has twice offered to find the kidnaped Lindbergh baby if released from custody, lends support to the belief "that the kidnaping has been done by friends of Capone for his very purpose."

The senator said that color also was lent to this belief by "the fact that it has been necessary to turn to gangsters" for aid in recovering the child.

Bingham described Capone as a gangster leader who made his money out of beer rackets and bootlegging. He said, however, he did not believe the Lindbergh kidnaping was entirely due to prohibition but added he felt Congress must "face the fact" that the dry laws "have made enormous profits available to gangsters and racketeers."

"The sooner we repeal the 18th amendment and the Volstead act and permit each state to pass the kind of prohibition law desired by the majority of its citizens," he said, "the sooner will we diminish the enormous profits which are now going into the pockets of crime and helping them to carry out difficult crimes successfully."

He placed in the Congressional Record a resolution adopted by the Los Angeles aviators post of the American Legion which blames the prohibition laws for the gangster activities which it believes responsible for the crime.

Senator Bingham described as "astounding the statement in the morning papers that Capone has again offered to aid in finding the Lindbergh child."

Daylight Saving Time Effective In U.S. Sunday

New York, April 23.—(AP)—Daylight saving time will be upon a large part of the United States and Europe tomorrow.

Canada will come in, too, on May 1 and then the savers of sunlight will number approximately 145,000,000.

France, Portugal, Great Britain and Belgium went on daylight saving time earlier this month. Holland will start May 22.

Not all of the United States will observe the practice. Some states have laws forbidding it. It is not observed in North Carolina and South Carolina.

OPPOSES DEFERMENT OF TAX SALES IN N. C.

Raleigh, April 23.—(AP)—Charles M. Johnson, director of the Local Government Commission, today expressed opposition to the postponement of tax sales until fall and expressed fear that to ignore the law might bring about "serious financial difficulties."

Replying to a telegram of Joe A. Sherrill, chairman of the board of Commissioners of Mecklenburg, Mr. Johnson said there it a matter of people losing their property at this time he would recommend immediately a special session of the legislature, but he pointed out that 16 months must elapse before foreclosure suits can be brought on tax certificates.

In the last four days the big firstbaseman from Memphis has clubbed six home runs, tying the major league record for circuit blows over that period, and has led his mates in driving in runs. He got No. 6 yesterday to help down the Phils, 13 to 8, in a hitting bee. Seven pitchers paraded, four of them for the losers.

The battling Boston Braves took a firmer grip on first place, winning their fourth straight when Bobby Brown, rookie right-hander from Birmingham, made his major league debut by setting Brooklyn down, 4 to 1, on five hits. The victory may have proved costly, however, as Art Shires was knocked unconscious in a collision with Joe Stripp at first base and might be out of the line-up for a time.

Thanks largely to four errors by their opponents, the St. Louis Cardinals broke a six-game losing streak with a 5 to 3 win over Pittsburgh in 10 innings. Lloyd Waner muffed Bottomley's short fly provided the champions with the winning run in the extra frame.

Rogers Hornsby's Chicago Cubs strengthened their grip on second place with their second straight win over the slipping Reds, 5 to 4. They grouped seven of their eight hits in the first three innings off Larry Benton.

Whitlow Wyatt, Detroit's sensational rookie, scored his third victory in as many starts as the Tigers rolled up a 16 to 3 decision over the Cleveland Indians. Five home runs by Wyatt and Stone, the triumph put the Tigers further in front of the American League field, their closest rivals being idle for the day.

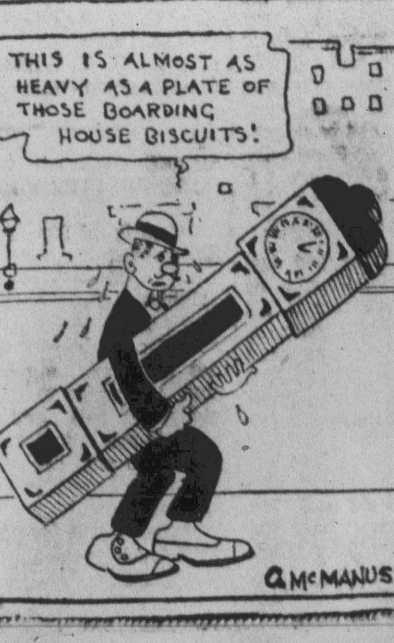
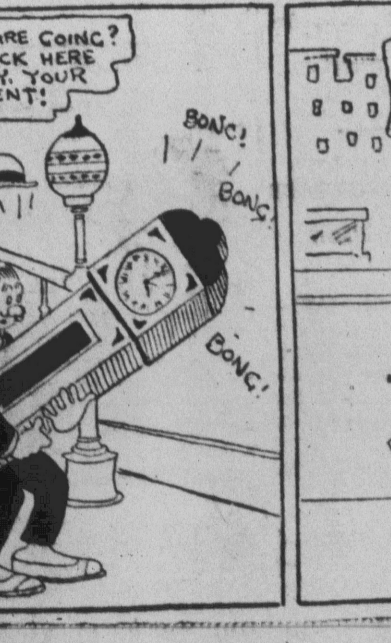

### STOCK MARKET

New York, April 23.—(AP)—The stock market finished a week in which reactionary tendencies predominated with a somewhat improved tone today.
