Senate Orders Full Probe Of The Stock Market

Opponents of Roosevelt Concentrate For Attack In Tuesday's Primaries

LARGE STAKES ARE AT ISSUE

If Roosevelt Wins In Massachusetts And Pennsylvania he will Virtually Clinch the Democratic Nomination for Presidency; If He Loses Tremendous Odds Will be Cast Against Him; Smith Main Opponent.

Washington, April 25.—(AP)—A climatic decision which may virtually clinch the Democratic presidential nomination for Franklin D. Roosevelt or may cast tremendous odds against him, is impending in tomorrow's Massachusetts and Pennsylvania primaries.

In these two states the "stop-Roosevelt" forces—beaten back so far—have concentrated their effort behind Alfred E. Smith in a stupendous effort to halt the New York governor's triumphant piling up of pledged convention votes. The struggle resting with the voters today is square cut. At stake, far more important than the 112 votes to be had, is the moral effect on political leaders and voters in the numerous states which yet have to choose their candidate.

The result, however, may be less definite than the issue. On the eve of the decision a summary of blending of opinion, partisan and neutral, appears to favor a division in the votes of both states, Massachusetts throwing the bulk of its 36 to Smith, Pennsylvania giving a majority of its 76 delegates to Roosevelt.

Without the furor accompanying the Democratic campaign, the Republicans during this week will select 264 more delegates in thirteen states; practically every one of the votes is assured to President Hoover's column which already count 248. To all intents, the nomination is his now.

In place of presidential candidates, issues are taking the Republican spotlight, particularly prohibition. Continued agitation for a referendum plank in the party platform has been bobbing up in the comment of party leaders. Furthermore, the Pennsylvania Republican primary, also tomorrow, will be marked by the fight of Smedley D. Butler, the fiery Marine who is an ardent dry to wrest senatorial nomination from the incumbent James J. Davis, who swung to a wet position at the opening of his campaign.

Coming up to tomorrow's mark, Roosevelt has 261 votes his supporters expect more than 300 additional will be obtained without a struggle from among states and territories still to decide. Another couple of hundred, roughly, will be needed for the nomination. For these, unless the Massachusetts and Pennsylvania verdicts dissolve the strength of his opposition, there will have to be energetic campaigning.

Without a vote yet in his pocket and hardly an outside chance to secure enough to put him personally in the running before convention time, Smith is seeking a block that would make him a controlling voice in the selection of a nominee at Chicago. Beyond the votes which may be given him there is the prospect of 254 more or less tightly assigned votes for favorite son candidates. In some cases the instructions given them have been exceedingly liberal, leading to Roosevelt hopes that they may execute a quick jump onto the bandwagon once the balloting begins. In contrast Garner men in Texas now are seeking to have the state's 46 delegates bound to the speaker of the House for as long as his name remains in nomination.

The Garner forces and those of Smith will clash a week from tomorrow in California, where 44 votes are at stake. Yesterday Roosevelt broke his customary silence on political affairs to observe that "everything looks fine" in that state.

HITLER LOSES DIET ELECTION

Three Killed and Hundreds Injured as Socialists Fight For Ascendancy.

Berlin, April 25.—(AP)—Adolf Hitler's national Socialists are the strongest political party in four of the five German states today, as a result of a sweep of yesterday's diet election, but they still lack a clear road to control of any of them.

Wilhelm Kube, leader of the National Socialists faction in the Prussian diet, demanded today, however, that the Prussian diet resign immediately. "Dr. Braun's successor" (Continued on Page Four)

LOCAL GUARDS ARE INSPECTED

U. S. Officers Begin Annual Inspection of Military Unit here Today.

Annual inspection of the local unit of North Carolina National Guards was in progress here today under direction of Major Harleigh Parkhurst, of Raleigh, assisted by Captain Rumsey Campbell.

The inspection of armory and equipment was made today and tonight members of the company will be formally inspected by the officers. The outfit, composed of 65 men, is commanded by Captain J. C. Lanier, First Lieut. Herbert Waldrop, Second Lieut. C. W. Porter and W. S. Tyson.

The battery is part of the famous 30th (Old Hickory) division which played such an important part in the World War, and is considered one of the best in this part of the state.

The organization has reached a high state of efficiency and has been highly commended by officers who appeared on inspection trips here in recent years.

FINAL ATTACK TO BE MADE IN INSANITY PLEA

Honolulu, April 25.—(AP)—The insanity plea of Lieut. Thomas H. Massie, on trial with three others for the slaying of a native, faced a final attack today by another expert in the workings of the human mind.

To the testimony of two physicians that Massie was not insane when he slew Joseph Kahahawai, whom he was convicted criminally attacked Mrs. Massie, the prosecutor was prepared to add the testimony of a third—Dr. Joseph Catton, Stanford University psychiatrist.

FINISH WORK ON THE TARIFF

Senate Finance Committee Disposes Of This Feature Of The Revenue Bill.

Washington, April 25.—(AP)—In a series of rapid fire ballots, the Senate Finance committee today disposed of the tariff issue in the revenue bill by voting import taxes on oil, coal and copper and rejecting levies on forest products.

The provisions in the House bill for an import tax of one cent per gallon on oil and \$2 a ton in coal were retained. An import levy on copper—the rate to be decided later—was added.

All votes were close. The attempt to remove the oil tax from the bill lost on a tie vote 9 to 9. The lumber duties were rejected 10 to 8.

TWO AVIATORS ARE RELEASED

Probe of Death Flier at Miami Turned Into New Channels Today.

Miami, Fla., April 25.—(AP)—Both Mrs. Jessie Keith-Miller, Australian flier, and her partner, Captain W. N. Lancaster, have been released from custody and authorities turned to other lines of investigation today in their attempt to solve the death of the woman's fiancé, Haden Clark.

State Attorney N. Vernon Hawthorne conferred last night with Peace Justice Thomas S. Ferguson and the two decided to postpone pending further inquiry an inquest that originally was set for today. The two said they wished to go into all possible angles of the case before the inquest is held.

Mrs. Keith-Miller and Lancaster were listed as witnesses for the inquest along with Miss Peggy Brown, pretty young Miami woman who appeared at the state's attorney's office Saturday as a volunteer witness saying she, and not Mrs. Keith-Miller, was Clark's fiancée.

The woman flier was released from jail here Saturday after she convinced authorities she could not aid them in classifying Clark's death as a suicide or slaying. Lancaster also was released only to be re-arrested by federal officers for questioning about a plan to smuggle narcotics into the United States from Mexico by airplane. The federal authorities freed him yesterday saying they were certain he had no knowledge or part in the plot.

Clark was found fatally wounded in his bedroom in Mrs. Keith-Miller's home here several days ago where he and Lancaster were guests. He was shot a few hours after he and Mrs. Keith-Miller told Lancaster of their plans to marry. Both fliers expressed the belief he shot himself.

MRS. SHEPPARD LAUDS WORK NEWSPAPERS

Secretary of Mission Society Makes Address at Christian Church.

Mrs. Ora L. Sheppard, of Indianapolis, secretary of the Department of Missionary Organization of the United Christian Missionary Society, spoke at the morning service at Eighth Street Christian church yesterday morning.

The speaker outlined the work of the church in various mission fields of the world, and stressed the importance of continued contributions to the cause. The address was in line with the denomination's educational program for 1931-32 and was quite informative.

Disputing the claim of some church members that the Bible does not teach support of foreign missions, Mrs. Sheppard said "if the teaching of missions was taken from the Bible there would be nothing left but the covers." She declared a considerable portion of the New Testament was confined to specific references to missions and that people who do not believe in their support do not fully comprehend the full significance of the Bible teachings.

She referred to the progress of religious education at home and abroad, and gave striking descriptions of the achievement of individual units in different sections. She asserted it is impossible to realize the value of work being done among retired ministers, orphans and those blighted millions without God without being in close (Continued on Page Four)

Chinese Communists Are Looting Changchow

Amoy, China, April 25.—(AP)—Advices from Changchow today said the Chinese Communist army had occupied the city and the soldiers were enjoying a carnival of looting which included raids upon the homes of American missionaries, schools, churches and other foreign property.

The Communists raided warehouses, stores and homes, the reports said, dividing the contents among themselves.

The belongings of one American missionary were saved by the quick thinking of the cook. The family had taken refuge here, but the cook stayed on the job. When the looters began hammering their way into the house she opened the door, inviting them in.

Six Killed By Tornado In Tennessee

Memphis, Tenn., April 25.—(AP)—State highway patrol officers here reported that at least six persons were killed by a tornado that twisted through at last three towns in Shelby county about 11 o'clock (CST) today.

Mrs. T. J. Dale, 65, a farmer's wife, died at a Memphis hospital after the roof of her house near Kernville caved in. Her husband, who was working in the fields, was injured, as were three negroes working with him.

A negro, Robert Harris, 65, of Millington, died en route to a Memphis hospital.

It was impossible at first to establish communication with Rosemark, Millington, Kernville and other communities reported in the path of the storms.

The tornado itself, was not felt in Memphis although the wind was high.

A high wind and rainstorm, accompanied by hail, struck here last night but little damage was done.

EMERY RAPS BONUS PLAN

Presents Opposition for The National Association of Manufacturers.

Washington, April 25.—(AP)—The National Association of Manufacturers, through James A. Emery, today put before the House Ways and Means committee an emphatic protest against full cash payment of the soldiers' bonus.

Emery called the \$2,000,000,000 money plan an "experiment" and warned the committee to "avoid experiments, especially those condemned by historical precedents."

"There is no evidence that our difficulties arise from a lack of currency," Emery said.

"We believe the fundamental thing that cannot be overstressed is that confidence is required to restore the equilibrium.

"The fundamental trouble is that we are moving in a fog of political uncertainty. We can't chart our course until the fog lifts."

"What would you have done to lift the fog?" asked Representative Elick (D., Tenn.).

"Action," Emery replied. "First pass the tax bill so industry may know what to expect.

Elick asked if the Reconstruction Finance Corporation were not not an experiment.

"Yes, but it has historical precedent and we approve of it," Emery replied.

To Send Investigators To New York To Check Activities Of Brokers

MAKES PLEA FOR RUSSIA

Rep. Rainey Urges Recognition of The Soviets to Stimulate Business.

Washington, April 25.—(AP)—Recognition of Russia by the United States to stimulate business, was urged today by representative Rainey of Illinois, the Democratic leader.

Referring to the Sabath resolution, introduced last week, which would request the president to direct the secretary of state to begin negotiations with Russia looking to a resumption of diplomatic relations, Rainey said in an interview:

"Our failure to recognize Russia is an economic crime."

Senator Robinson, of Arkansas, the Democratic leader in the other branch of Congress, advocated Russian recognition last week.

Chairman Borah of the Senate foreign relations committee has urged that action for years.

The government, however, has taken the position Russia cannot be recognized until it meets certain requirements, including payment of debts to this country and cessation of propaganda activities.

Rainey said that in 1929 there were 84 ships flying the American flag plying directly between the United States and Black Sea Russia. (Continued on Page Four)

Committee in Lengthy Session Agrees To Appoint Subcommittee To Employ Additional Counsel To Make Study of Short Selling by Brokers; Determined to Have "Inside Story" of the Operations.

Washington, April 25.—(AP)—The Senate Banking committee today ordered a full investigation of the stock market and determined to send investigators to New York.

At a lengthy executive session the committee agreed to appoint a subcommittee, to employ additional counsel and investigators necessary to make the study in New York.

The committee is determined to find out the inside operations of the gigantic pool in stocks which operated on the "bull" side in the 1929 boom and on the "bear" side since the price collapse.

The trial of testimony so far taken, in the committee's investigation of the New York Stock Exchange, has been led to establish existence of these combines, formed to profit by rise or fall of a particular stock, but all have stopped dead when it came to proving what the pool traders did to force prices in the direction by which they planned to profit.

A number of traders and brokers have been subpoenaed to appear before the committee, but they probably will not be heard for several days, as the hearings have been temporarily suspended. Others may be called, including Chairman Raskob, of the Democratic National committee, who participated in a pool described in Saturday's testimony.

The membership of two pools of importance has been described to the committee, and its agents say they had information concerning a score of such combinations, whose affairs are expected to be gone into.

Conspicuous among the points the senators wish to establish is whether the pools have been working with market specialists—brokers, who handle one stock—and know the pending orders and holdings in that particular security.

Saturday's testimony brought into the record that M. J. Meehan, prominent broker, was the specialist in radio stocks and that his wife participated in a pool operating in that line.

For specialists to pass out their confidential information is against the exchange rules and Senator Brookhart, (R., Iowa), after hearing the radio pool testimony said he favored legislation to make such a practice illegal.

Veteran Star Editor Retires

Marion, O., April 25.—(AP)—Stated to have been the only editor ever to direct the operation of a newspaper for a President of the United States, George H. Van Fleet of the Marion Star retired today after an editorial career of nearly four decades.

For 37 years Van Fleet was connected with the Star, formerly the property of the late President Warren G. Harding and now one of a group of eight Ohio newspapers owned by Brush-Moore newspapers Inc. Van Fleet's retirement came just a week after his 68th birthday anniversary.

As an executive of the Star, Van Fleet was Harding's closest business associate. He had complete supervision of the paper during the time Harding was in Washington, beginning with the latter's first term as United States Senator in 1914.

Fayetteville Man Declared Suicide

Fayetteville, April 25.—(AP)—Thomas Jones, 65, former light and water superintendent of Fayetteville and of Lexington, was found dead last night in a gas-filled bathroom in his apartment home here. Physicians said he had been dead about 12 hours when the body was discovered. Officials said no inquest would be held as Jones evidently had taken his own life.

Way of the Law

Marion—Deputy Sheriff Landon McKinney arrested his own son, Guernsey, here after the youth stabbed Lawrence Hensley, 20. Hensley died and the younger McKinney has been charged with murder.

Eight Are Killed In Highway Mishaps

Atlanta, Ga., April 25.—(AP)—Eight persons were killed in automobile accidents in the south over the week-end but traffic mishaps were comparatively few in spite of summer weather that brought out numbers of cars.

Alabama and Florida each reported two fatalities and there was one each in Louisiana, Arkansas, Mississippi and Virginia.

## ABOUT TOWN

The jinx perched upon the bats of East Carolina Teachers college and Greenville High school here the latter part of last week and caused them to drop two games in a single day to visiting teams.

It was the third successive loss of the season for the Collegians and the second loss for the high school out of four conference games.

The losses were rather disappointing to supporters of both clubs, but that better days are ahead is generally conceded. The college has a good team; so does the high school, but they have been getting bad breaks the last several days and it appeared almost impossible for them to win.

The season is young as yet and it would not be surprising to see both clubs capture a majority of games on conference schedules.

Senator Bingham of Connecticut annulled the opinion of numbers of people last Saturday when he expressed belief that friends of Al Capone are responsible for kidnaping of the Lindbergh baby in an effort to bring about Capone's release from prison.

This is one of the worst situations the growers have had to combat in years, and they are perfectly justified in using shotguns to guard their beds against thieves.

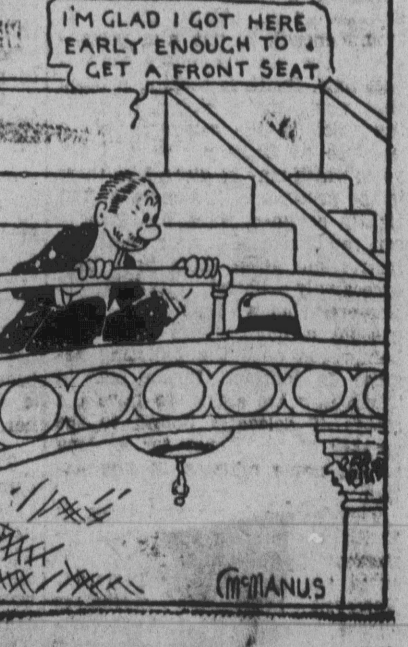

Bicentennial Flower Gardens While it has always been necessary to make certain gardens useful, it is possible to allow the space and time for gardens which contribute chiefly beauty in this land of great open spaces and uncrowded areas. Fragrance has always been a deciding factor in the choice of flowers for home gardens. The sternest and most austere have softened before the incense poured from the heart of rose or carnation. Indeed it is often wondered that flower fragrance had no power equal with the power of sweet sounds to soothe the savage beast. Surely it is to flowers very like the voice to man wherefore, mayhap it is the garden choral.

It is the charm of the old garden, as well as its form and plants, which we are seeking to recall when we make a new one like it; and this charm lies in the ancient estimate of homely, simple things at their true high worth. Old fashioned gardening is not summed up in the planting of a flower garden wherein the walks and beds conform to the lines laid down in some old design.

Many gardens, according to the Division of Botany of the United States George Washington Bicentennial Commission, will suggest the Colonial influence by planting flowers included in the following list:

Mull assumed the name of John Hall after disappearing from his home where he was a well-known contractor. He was convicted of slaying Jack O'Brien in Clark county last September.

The appeal has been brought on technical grounds, the defense contending the case lacked all the elements of deliberation and premeditation to warrant a charge of first degree murder.

Testimony at the trial showed Mull shot O'Brien in the back of the neck as he sat in the rear seat of an automobile O'Brien was driving.

Following his conviction of murdering his associate last September, Mull revealed his name and that he had left five daughters in North Carolina.

Originally sentenced to die in the lethal gas chamber at the state prison during the week of December 6, he received a stay of execution a few days before when his appeal was filed. The court will have 90 days after submission of the case in which to prepare its decision.

Meanwhile, Mull occupies a cell in the main cell block at the prison and is accorded the same privileges as other prisoners. For several weeks prior to the stay of execution he had been confined in a tiny cell directly across the corridor from the death chamber.

To Argue Appeal Of N. C. Slayer In Nevada Soon

Carson City, Nev., April 25--(AP)--The appeal of Everett T. Mull, of Morganton, N. C., convicted of murder of an alleged bootlegging associate after he had deserted his family in North Carolina, will be argued here Thursday before the Supreme court.

Mull assumed the name of John Hall after disappearing from his home where he was a well-known contractor. He was convicted of slaying Jack O'Brien in Clark county last September.

The appeal has been brought on technical grounds, the defense contending the case lacked all the elements of deliberation and premeditation to warrant a charge of first degree murder.

Testimony at the trial showed Mull shot O'Brien in the back of the neck as he sat in the rear seat of an automobile O'Brien was driving.

Following his conviction of murdering his associate last September, Mull revealed his name and that he had left five daughters in North Carolina.

Originally sentenced to die in the lethal gas chamber at the state prison during the week of December 6, he received a stay of execution a few days before when his appeal was filed. The court will have 90 days after submission of the case in which to prepare its decision.

Meanwhile, Mull occupies a cell in the main cell block at the prison and is accorded the same privileges as other prisoners. For several weeks prior to the stay of execution he had been confined in a tiny cell directly across the corridor from the death chamber.

Two Escaped Prisoners Are In Jail Again

Raleigh, April 25--(AP)--Two state's prisoners who found the comparative comfort of the prison hospital only a provocation to escape were in solitary confinement at the prison today after five short days of freedom.

The pair, Hubert Winshaw, 27, of Wayne county, and Bennie Williams, 20, of Cumberland county, were two of five prisoners who escaped from the hospital last Tuesday by sliding down a 90-foot rope made from blankets.

They were captured by Sheriff Paul Garrison, of Wayne county, and a group of deputies yesterday and returned here. They refused to divulge any information about their companions in the escape.

Williams was serving 3 to 5 years for breaking and entering and Winshaw 10 to 12 years for assault with intent to kill.

Both were in the hospital for treatment for a social disease.

The others who escaped were Raymond White, of Craven county, J. White, of Rutherford county, and Robert Calloway, of Buncombe county.

Hopewell, N. J., April 25.—(AP)—The Lindberghs will move back to Englewood this week, probably Wednesday, away from the Soudland Hills home that has been the scene of so much sorrow for them in recent weeks.

There have been no developments in the child hunt for several days. The Norfolk, Va., intermediaries, the aged educator who communicated with the kidnapers as "Jasie," and other independent agencies which have been involved in the baby hunt have made no report of progress.

Norfolk, Va., April 25.—(AP)—Activities of the Norfolk intermediaries in the Lindbergh kidnaping case, which have been speeded up during the last few days, were believed today to be again centered in mysterious movements of the Yacht Maroon.

John Hughes Curtis, chief negotiator, was again absent from his home today, and the sailing of the yacht yesterday afternoon led to the belief that he may have boarded the craft some time last night. Rear Admiral Guy H. Burgess, retired, and the Very Rev. H. Dobson-Peacock, the other intermediaries, kept silent regarding all the details of their negotiations.

The Maroon, owned by Colonel Charles H. Consolvo, of Baltimore, left Little Creek, about ten miles from here yesterday afternoon and headed cut in the Chesapeake Bay. It could not be learned where the boat had gone.

(Continued from Page One) must be a national Socialist," he said, "and Adolf Hitler will choose him."

The election, which followed two Presidential elections in which Hitler's fascist legions fought valiantly to place him at the head of the Reich, resulted in three deaths, many other casualties and hundreds of arrests.

Only in Bavaria did the "Hitlerites" run slightly behind. In Prussia, where the fight was most bitter because of the theory that "whoever controls Prussia controls the Reich," the Hitlerite forces garnered in 162 seats, against the nine they held heretofore.

The coalition which makes up the present government also secured 162 seats. The consensus today was that Premier Otto Braun of Prussia and his government would probably resign but that he would be likely to continue to hold office, while a struggle took place over the formation of a new workable coalition.

The national socialists, with the four minor opposition parties, commanded only 203 of the 433 seats in the Prussian diet. They could form a government only if the 67 members of the Centrist party, which is that of Christian Heinrich Bruening, were to support them.

The rule is that the present government holds over, in any event until a new diet is formed with the support of 51 per cent of the diet. The only other party in Prussia to make a gain was the Communist which now has 57 seats compared with its former 48. The Social Democrats were the heavy losers. They dropped from 137 to 97. Even the Catholic centrists lost four seats.
