HOOVER SAYS ECONOMY NECESSARY TO RECOVERY

MILLS JOINS IN ATTACK ON BONUS ISSUE

Secretary Declares Measure Designed to Pay an Obligation Not Due.

Washington, April 27.—(AP)—Secretary Mills today issued a powerful administrative offensive against cash payment of the soldiers' bonus.

He spoke before the House Ways and Means committee appearing as a witness in its extended hearings on the issue.

In language no less powerful than that which Charles G. Dawes employed before the same committee a week ago, the new Treasury secretary drove home his opposition to the \$2,400,000,000 outlay, whether paid in borrowed money or through inflation of the currency.

"The measure now before you is designed to pay an obligation not due, in money that is not honest," Mills said. "The adjusted service certificates do not mature until 1945. To pay them at their face value today, less the amount that has been borrowed on them, would, in effect, almost double the payment provided for by the adjusted service compensation act and would involve an immediate cost to the government of about \$2,400,000,000.

"In other words the government is to pay almost twice the amount it undertook to pay."

"To select this moment," he went on, "to destroy our hopes of a balanced budget and to deal a smashing blow to national confidence, is to me simply incomprehensible. The proponents of this fully recognize that the cost cannot be borne by legitimate means. They would discharge what they state to be a solemn obligation of the government by setting the printing presses to work printing dishonest dollars.

"For a great, powerful nation deliberately to adopt this insidious and essentially dishonest device would to my mind be worse than an act of financial bankruptcy. It would constitute moral bankruptcy."

Find Hot Trail in Murder Case

Charlotte, April 27.—(A)—Believing themselves on a "hot trail," Charlotte police today redoubled their efforts to solve the mystery surrounding the strange death of Albert Rudisill, whose body, dressed in a woman's clothing, was found last Saturday morning hanging from a beam in a warehouse where he worked.

Frank Littlejohn, chief of detectives, revealed that the questioned five people yesterday, one of whom is still under suspicion. At this house, he said, were found bloodstains; a piece of a box identical with another found with the body; a portion of a woman's dress similar to that which shrouded the body, and other important evidence" which was not made public.

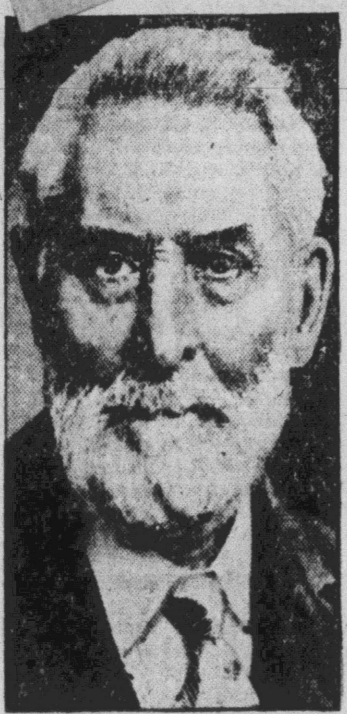
Two other persons, whose identities were not revealed, were believed to have accompanied the suspect to the warehouse about the time when physicians said Rudisill met death, and were being sought. No one had been arrested.

Rudisill's body was found after his wife started a search when he failed to come home last Friday night. In addition to the woman's dress, his ears bore carbide, and cheeks and lips had been vividly colored with rouge and lipstick. A towel which police said bore similar lipstick was found at the home of the man under suspicion. Over the eyes of the dead man had been placed heavy rubber goggles.

START FIGHT WITH MOVIES

Two Actors and Director Suspended After Clash with Studio Heads.

Hollywood, April 27.—(AP)—Two motion picture studios apparently have determined to have settled, by court action if necessary, whether the studio management rules or accedes to desires of stars and directors.

Marlene Dietrich, blonde German born star; James Cagney, actor and Josef Von Sternberg, director who "discovered" Miss Dietrich, are under suspension. Paramount employees Miss Dietrich and the director; Cagney works for Warner Brothers - First National studios.

Von Sternberg left Hollywood for New York last Saturday, declaring he considered the story provided for his next production unsuitable. Miss Dietrich, siding with the director, refused to report for work yesterday under Richard Wallace, substitute director. Salaries of both were stopped with their suspension.

Cagney was suspended yesterday after he demanded a \$2,400 weekly increase in salary. He had been signed under a long term contract at \$1,600 weekly.

The actor refused to appear at a premiere showing of his most recent picture, scheduled for tomorrow night. He said he would leave Hollywood soon on a motor trip through the Canadian Rockies and unless his salary demand is heeded, will quit motion pictures and enter Columbia to study medicine.

The two studios did not reveal whether they would seek to have the three contracts broken or if they will endeavor to enforce the agreements.

Hobbs Elected President Of Social Service

Durham, April 27.—(AP)—S. H. Hobbs Jr., of the University of North Carolina, is the new president of the North Carolina Conference for Social Service, which has just closed its annual convention here.

Other officers and directors are: Justin Miller, dean of Duke University law school, vice-president; Miss Harriet Herring, University of North Carolina, second vice-president; J. S. Holmes, N. C. State College, treasurer; Miss Gertrude Weil Goldsboro, secretary.

George H. Lawrence, U. of N. C.; John S. Bradway, Duke University; W. E. Stanley, Durham; N. C. Newbold, Raleigh; Dean Van Heck, U. of N. C. law school; Rev. W. A. Stanbury, Durham, were elected directors. The conference at its closing sessions, adopted resolutions recommending refusal of marriage licenses to the feeble minded, that the United States prevent further decline in commodity prices even if it necessitates abandonment of the gold standard, and that the task of voting be simplified.

Roosevelt Gains Lead In Pennsylvania Race; Smith Wins Out in Mass.

Philadelphia, April 27.—(AP)—Governor Franklin D. Roosevelt held a slim lead in Pennsylvania's preferential primary today, but the question of how he and his one-time political ally, Alfred E. Smith, would divide the state's 76 convention votes was a guessing game. With 3,071 out of the 8,181 districts in the state tabulated, the vote stood: Roosevelt, 48,160. Smith, 47,647. Meanwhile, Senator James J. Davis, most Republican who formerly sat in the cabinet at Washington, was smashing the senatorial hopes of Maj. Gen. Smedley D. Butler, fiery marine corps veteran and outspoken dry. Governor Gifford Pinchot, who is leader of the independent Republican faction, stumped for Butler. The vote in 4,395 districts out of 8,181 gave: Davis, 532,017. Butler, 279,299. Davis was backed by the Vardine state organization, and carried Philadelphia, stronghold of (Continued on Page Six)

COLD FOLLOWS HEAVY STORM

Eleven Lives Claimed By a Series of Disturbances in Southland.

Atlanta, April 27.—(AP)—The storms that took eleven lives in the south Monday and yesterday left cooler weather behind them today.

Winds, rain and thunderstorms for the most part were supplanted by partly cloudy skies and temperatures a little low for late April.

Monday tornadoes killed six persons in the vicinity of Memphis. Five were killed near Nashville in southern Georgia yesterday. There was damage to communication lines and property over much of the south during the two days of wind and rain.

The aerological department of the weather bureau reported a temperature of 48 degrees at 7 a. m. here today.

BACK FROM BABY PROBE

Intermediary Refuses to Talk Following His Return to Norfolk Today.

Norfolk, Va., April 27.—(AP)—John Hughes Curtis returned to Norfolk this morning from a trip made in the interest of negotiations for the return of the kidnapped Lindergh baby. He would not comment concerning his trip and referred all questions to Rear Admiral Guy H. Burrage, retired, spokesman for the three Norfolk intermediaries.

VOTE HIGHER INCOME TAXES

Senate Finance Committee Moves Up Rates Provided By House in Bill.

Washington, April 27.—(AP)—After rejecting a proposal to boost surtaxes to the wartime maximum of 65 per cent, the Senate finance committee today voted an increase in all income tax rates above the levies written into the new revenue bill by the House.

The committee almost unanimously adopted a schedule presented by Senator Harrison of Mississippi, the ranking Democrat, calling for a maximum surtax of 45 per cent instead of the 40 per cent figure carried in the House bill. Normal income rates were boosted to 3 per cent on the first \$4,000 income; six per cent on the next \$4,000 and 9 per cent on the income above \$8,000.

The present normal rates are 11-2, 3 and 5 per cent. The House voted to increase these rates to two, four and seven per cent respectively.

DeValera Meets Defeat in Dail

Dublin, Irish Free State, April 27.—(AP)—The government of President Eamon De Valera was defeated in the Dail Eireann today in a division of the unemployment issue. The vote was 74 to 66.

VETOES PENSION BILL

Washington, April 27.—(AP)—President Hoover today vetoed a bill granting an increase in pensions to soldiers and sailors and in some cases granting new pensions.

ADAMS FIGHTS CUT IN NAVY

Says Only Few Establishments Can Now be Closed Without Damage to Dept.

Washington, April 27.—(AP)—Secretary Adams told the House naval affairs committee today that only naval shore establishments on the Atlantic and Gulf coasts can be closed without "detriment to the needs of the fleet." The secretary of the navy was appearing on a resolution by Chairman Vinson of the naval affairs committee to authorize the President to close, sell, or lease any shore stations held unessential by the navy head. Adams said: "It is believed that the facilities at New York; Philadelphia and in the Hampton Roads area for the maintenance and the supply of the fleet are in general all that are at the present required for this purpose and for a limited amount of new construction, and that without undue reduction in naval efficiency the remaining fleet facilities on the east coast can be closed."

Textile Chieftain Dies at Charlotte

Charlotte, April 27.—(AP)—Arthur J. Draper, 57, one of Charlotte's most prominent business men and former president of the American Cotton Manufacturers Association, died at his home here yesterday after a critical illness of several weeks. He had been in declining health for several years. Funeral services were held today with leading business and industrial figures as pall bearers.

Joseph Hewes To Be Honored At Edenton

Edenton, N. C., April 27.—(AP)—Tomorrow thousands of persons are expected to gather here as this picturesque little city pays tribute to the memory of Joseph Hewes, one of North Carolina's signers of the Declaration of Independence and virtually the first secretary of the nation's navy. From morning until after midnight a program of entertainment has been arranged. Formal exercises dedicating a monument erected to the memory of Hewes by Congress will be held just before noon. Congressman Lindsay C. Warren was to have been present and preside and Josephus Daniels, of Raleigh, was to have introduced the principal speaker, but neither will be able to attend. Rear Admiral W. D. McDougall, of Norfolk, will make the address of the day.

Stone Gives Three Point Program for Farm Relief

Washington, April 27.—(AP)—To deal effectively with the present emergency in agriculture, Chairman Stone of the Farm Board today recommended before the Senate agriculture committee a three-point program. Continuation of the recently initiated Federal Reserve Board's open market operations to expand credit and increase consumer buying power, was his first recommendation, coupled with provision by Congress for sufficient funds to finance sale of surplus wheat and (Continued on Page Six)

FLEISCHMANN FINISH SIX HEADS ROTES COURT CASES

Pastor of Memorial Baptist Church Named President Here Last Night.

Japs Begin Great Drive To Crush Rebel Forces

Harbin, Manchuria, April 27.—(AP)—Japan's Manchurian military machine opened today the greatest drive since the capture of Chinchow in an effort to suppress a Chinese revolt against the government of Henry Pu-Yi. Three Japanese brigades moved by rail and river boats, in a sweeping "pinners" movement against the rebel forces, estimated at 20,000, along the eastern lines of the Chinese Eastern railway and in the lower Sungari valley. At the same time lesser Japanese forces sought to crush minor revolts in the Tunghua district, 125 miles east of Mukden and in the Tun-liao region, on the Mongolian border northwest of Mukden. The main Japanese force is made up of Major General Murali's brigade, now near Imienpo and Heng-taohote, on the eastern end of Chinese Eastern railway, ready to move northward toward Frang-cheng and Sanhsin; Major General Yeda's brigade of Major General Nakamura.

General Nakamura's brigade, which recently arrived in Manchuria from Japan, departed from Harbin down the Sungari river in twenty-two gunboats. Each carried two field guns. They were escorted by four sunboats which formerly belonged to Marshall Chang Hsiao-liang but now held by the new Manchurian regime of Henry Pu-Yi. They proceeded cautiously because of reports that the rebels had planted mines between Fang-cheng and Sanhsin. General Nakamura hoped to meet Generals Murali and Yeda in the neighborhood of Sanhsin, after crushing the rebels along the way, and then, making Sanhsin the headquarters, continue operations in the lower Sungari valley. A dispatch to the Rengo news agency from Mantung said troops which formerly acknowledged the new Pu-Yi regime had revolted and enveloped Tunghua, where Japan maintains a branch consulate.

PLAN SECRET STOCK PROBE

Senate Banking Committee Perfects Plan for Drive Against "Bears."

Washington, April 27.—(AP)—A secret plan for investigation of the New York stock market was worked out today by the steering committee of the Senate Banking committee.

At the end of a session behind closed doors, the newly-formed committee was believed to have agreed to send secret agents to New York to study stock exchange and brokerage records. Chairman Norbeck said the group was "working in secret on a program that will best develop the abuses of the system that all know to exist but are hard to prove."

DARROW GIVES FINAL APPEAL

Noted Criminal Lawyer to Speak For 3 Hours in Honolulu Murder Case.

Honolulu, April 27.—(AP)—Clarence Darrow, astute criminal attorney, today faced his final attempt to clear four Americans in a murder trial which brought the 75-year-old legal veteran out of retirement. He was to present a 3-hour closing argument before a racially mixed jury which is trying Mrs. Granville Fortescue, Lieut. Thomas H. Massie, her son-in-law, and two navy enlisted men for the lynching of Joseph Kahahawai. The Hawaiian allegedly had confessed (Continued on Page Six)

FIND BODY OF MISSING MAN

Kenneth Hays Found Under Bridge Near Clinton Believed to be Suicide.

Clinton, April 27.—(AP)—The body of Kenneth C. Hays who disappeared several days ago, was found today under a bridge over Six Run creek five miles from here. Sheriff Moore and a party of searchers discovered the body during a search begun yesterday when Hays' abandoned automobile was found near the creek. A note indicating suicidal intent was found in the car. The sheriff said several bruises were found on the forehead and cheek, "indicating Hays struck part of the bridge in his fall." Hays left a widow and one son in Rocky Mount where the body will be sent following the inquest. Hays was about 40 years old.

Woman Faces Murder Trial

Concord, April 27.—(AP)—Mrs. Mary Bennett Widenhouse, who killed her husband at their home near here recently, is scheduled to be tried for murder in Cabarrus county superior court tomorrow. Mrs. Widenhouse said she shot her husband to keep him from beating her when they quarreled after he had stayed away from home all night. The state produced witnesses at a coroner's inquest who said Mrs. Widenhouse was responsible for quarrels, and that she had threatened her husband.

President Also Tells Executives of Necessity of Better Distributed Taxation and Balanced Budget on Part of Government; Declares Intelligent Support of People Imperative in Crisis.

Richmond, Va., April 27.—(AP)—As "the sure highway to national recovery," President Hoover cited to the governors' conference today the "absolute necessity" of reduced expenditures, better distributed taxation and balanced budgets on the part of the government.

"Town councils, county commissions, state legislatures and the Congress agree on these fundamentals," he said, "but to accomplish them we must have the intelligent support of the people themselves, that selfish vested interest and vested habit do not, by their organized sectional and group oppositions or individual action, defeat these high purposes."

Expressing a wish for greater cooperation toward settling governmental problems, he suggested that such conferences as they have been holding here, having the local executives examine their difficulties together, he said, "would help toward a realization that local expenditures and taxes are a part of a great national problem in stability as well as one of local concern."

Stressing the need for adjustments, the President told of federal, state and local government expenditures rising from \$2,900,000,000 in 1915 to \$13,200,000,000 in 1930 and the total outstanding debt of \$4,800,000,000 in the same time. Before the war the total governmental cost represented but 8 per cent of the national income and Mr. Hoover estimated the present proportion at above 20 per cent.

"We can not restore economic stability in the nation by continuing to siphon so large a part of private effort into the coffers of the government," he said. "It's abstraction from the people stifles the productivity, the consumption and the recovery of employment."

Richmond, Va., April 27.—(AP)—Governors from more than a score of states delved into state problems today while awaiting the arrival of President Hoover who this afternoon will address the annual conference on national problems. The Chief Executive will be welcomed by an honor guard and escorted to the conference chambers where his speech will be broadcast over a national radio chain.

The governors will repay the President's visit tomorrow when they visit the White House after a visit to Fredericksburg, Alexandria and Mount Vernon. His visit here will bring the President face to face with several of the outstanding Democratic candidates for Mr. Hoover's job, among them Governor Frank W. Roosevelt of New York, and Governor Albert Ritchie of Maryland. The conference will abide by its rule not to discuss controversial political issues.

While awaiting the President's arrival, the states' executives gathered around the conference table to discuss state problems.

Governor Louis L. Emerson of Illinois told the states' executives that although he advocated the employment of jobless men on construction projects, he believed no state should "increase the public debt for non-essentials."

His speech was made after Gov. Floyd B. Olson of Minnesota had voiced a ringing "No" to the question of abolishing state banks. State banks, he asserted, "are as sound as federal banks if permitted to compete on an equal basis." He added that "the weakness of the state banking system may be removed by state regulatory legislation."

The speaker saw in the independent units "a protection against centralization of credit control, and money monopoly." Scoring bank mergers and chain banks, the speaker asserted that with the passing of the individual units, "the small business man with a financial burden, has a very restricted access to credit and what little he gets he pays for dearly at high interest rates."

MRS. MILNER SPEAKS TO A. A. U. W. AND GUESTS

Mrs. Clyde Milner brought inspirational messages to the groups of girls from the Greenville High School and young women from the college, in her talks yesterday afternoon and evening when the Greenville branch of the A. A. U. W. entertained in honor of the seniors in town and college.

The Y hit in the college woods

was beautifully decorated with woody flowers, crab apple, dogwood and azaleas, and delightful refreshments were served. The bond between the college women of the town, the college seniors, and the high school girls who are facing the decision as to whether or not they will go to college, was strengthened by the social contact both at the afternoon tea and informal reception in the evening.

Mrs. Milner is dean of women and director of personnel in Guilford College, as well as professor of psychology. She is a graduate of Wellesley College, from Ohio, and has had extensive experience with college girls and women. She has a wide reputation as a speaker and club worker.

Her thought-provoking topic in the afternoon, when she addressed the members of the senior and junior classes of the Greenville high school, was "College and Its Honorable Substitutes." She pointed out that only those people who have a real academic interest should go to college. One should decide between a small and a large college according to her own personal aptitudes, the speaker said.

If one is unable to work without close personal supervision, or to say "no" at the proper moments, and to meet people easily, she should not attend a large college. She emphasized the fact that there are many honorable substitutes for college and advised each girl to find her bent and follow it.

The members of the senior class who were the guests in the evening, are already specifically trained for one definite vocation, that of teaching; therefore vocational guidance is not a problem of interest to them. As their need of guidance is within their vocation, Mrs. Milner talked to them on "Aids to Success" in their chosen field. She emphasized three essentials to success: mental alertness, emotional control, and "sartorial smartness," enlarging this last point so as to include personality and appearance. Under each of the headings her illustrations were actual case studies from her own experience, thus making it impossible for her listeners to fail to make practical application on each point.

At the beginning of her talk, she gave a brief summary of the contribution the American Association of University Women has made to the world.

Because of the limited space in the local church, it will be shown in the Capitol Theatre on Sunday afternoon at 3:30. There will be no charges of admission.

CANDLE-LIGHTING SERVICE FOR MOTHER'S DAY

By Margaret Eggleston Owen (In M. E. Church, South) The Service

(Enter the Spirit of Motherhood dressed in white, with two little girls skipping along in front of her, but holding her hand. Each child carries a long-handled basket which she places on the floor by the chair at the front of the room. They group themselves as in the picture "Caritas," in front of the American flag. Lights from a stereoscopic play on their faces for a moment. Then the mother seats herself in the armchair nearby, with one little girl on each arm of the chair.)

The piano plays softly. "I think When I Read That Sweet Story of Old." One little girl leans over and kisses her mother as she rests in the chair listening to the music. Then the mother sings softly the first verse, seeing only her children. The one little girl sings the second verse, and the other little girl sings the third. After the song, the mother stands for a moment and lights the candle on the table near by. While she is still standing, she holds the lighted candle aloft and says, very distinctly: "This is the light of true motherhood. It is the light which God places in the heart of a woman and bids her carry undimmed throughout her days. It is the light of God in the life of a mother. I must pass it on undimmed to these my little ones. I must inspire them and lead them, and teach them the way of truth and life. Are there not those who will help me in this great work?"

A girl in the audience dressed in white and sitting near the front rises and moves forward, carrying a tall blue candle. As she stands by the lighted candle, she says: "From this mother candle, I will light the light of love, for every true home is built on love. If the love of God is in the hearts of those who live in a home, the love of others is there also. Jesus said: 'Love one another as I have loved you.' A beautiful and a true home must have love in it. See, I give to your little ones the light of love." She lights the candle from the mother's candle and places it in a holder near by.

A second girl comes forward with a tall yellow candle. "This is the light of work," she says. "Every mother must work for the home; but every daughter must also work for the home, if the mothers and daughters are to be comrades and partners in home-making. 'Together' is one of the key words of a

happy home. A successful home must have its workers as well as its lovers. I give to your daughters the light of work." She lights her candle and puts it in a holder near the other candles.

A third girl carries to the front a pink candle and says: "And this is the light of dreams—such dreams as a mother has when she bends over the cradle; loving dreams such as a daughter has when she thinks of the future. The growing home must have dreams of work, of love and of the future. The home that sends out great men and women is the one that has taught its children to dream. (To the children): Dream, little girls, dream true. I give you the light of dreams." She lights her candle and places it in a holder next the others.

The Spirit of Motherhood rises and says: "Heard you what these older daughters have said? They would give to my children homes with lovers, with workers, with dreamers. Would that I could wave a fairy wand and send these beautiful gifts into every one of your homes. (To the children): Would you share your gifts with these other mothers and girls in the room? Go then. Give to them from your baskets."

One child has a basket filled with tiny birthday candles. The other has many little squares of cardboard into each of which a hole has been punched to admit the candle. (This will protect the fingers from the wax when the candles are lighted.) They give a candle and cardboard to each mother and daughter. The older girls (more than the original three who have spoken if the audience is large) carry the candles which are on the table. When all are ready, the Spirit of Motherhood speaks: "Mothers of the girls of (town), you are trying to be lovers and workers and dreamers, for the sake of the home folks, light your candles."

She waits until all are ready and then says: "Girls of (town), would you be lovers and workers and dreamers in the homes that you will make in the days ahead? Light your little candles from the light which has been given of my light to your mothers. Light your candles from your mother's with a great longing and a great faith."

She waits for a moment and then goes on: "Now let each mother and her daughter hold their candles together and repeat together the little pledge of loyalty which you have already learned. Let us think, as we say it, what a blessing it will be in our homes if we make every word of it come true."

All repeat: "I do love you truly."

I will work for you gladly. I will try to make your dearest dreams come true."

In preparation for the candle-lighting service a little platform should be placed at the front of the room. On it put a large American flag in a standard, a large armchair, and a small table on which are a tall white candle in a holder and three empty candle holders. The pledge to be used should either be on a printed program or else on a typed slip of paper.

For All Mothers—A Prayer. O God, we offer thee praise and benediction for the sweet ministries of motherhood in human life. We bless thee for our own dear mothers who built up our lives by their love and their prayers; and loved us the more for the pain we gave; who nourished us at their breast and hushed us to sleep in the warm security of their arms. We thank thee for their tireless love, for their voiceless prayers, for the agony with which they followed us through our sins and won us back, for the Christy power of sacrifice and redemption in mother love. We pray thee to forgive us if in thoughtless selfishness we have taken their love as our due without giving the tenderness which they craved as their sole reward. And if the great treasure of a mother's life is still spared us, may we do for her feebleness what she did for ours.

We remember before thee all the good women who are now bearing the pain and weariness of maternity. When their vision that they may see themselves, not as the mothers of one child alone, but as the patriot women of their nation, who alone can build up the better future with fresh and purer life. Bestow thy special grace, we beseech thee, on all the women who have the yearnings of motherhood, but whose lives are barren of its joy. Help them to overcome the bitterness of disappointment and to find an outlet for their thwarted mother love in the wider ministrations to all the lonely and unmothered hearts in thy great family on

ABOUT TOWN

A group of Greenville high school students left today for Greensboro to take part in the state-wide music contest. The youngsters won the honor of attending the conference by taking first place in the district contest held here about two weeks ago. At the time the group captured the major honors of the occasion, and were accorded the honor of actively participating in the state-wide contest. The musicians are headed by Miss Ona Shindler, director of public school music, and Professor Eugene Robeson, band and orchestra leader. Both have put in long hours training the children for the contest ahead and believe they will be able to capture more honors than they did last year. Greenville has won much credit in this field of endeavor the last several years, and members of the faculty and the public generally are proud of their attainments.

That little fellow LaGuardia of New York evidently knows more about conditions on the stock exchange than the "bears" gave him credit for knowing. Speaking before the Senate investigating committee yesterday, he charged President Whitney with allowing conditions to exist on the exchange that would have resulted in his imprisonment had it been in other fields of activity. He also cited publicity campaigns to inflate stocks and produce wide-spread demand, a condition that did much toward bringing up the crash that virtually paralyzed the entire world. The Senate committee will learn things if it should continue hearing evidence like that presented by LaGuardia who has made a long study of the situation and is backing his statements with records of transactions made on the exchange. No action may ever be taken against any individual member of the stock market, but Congress may be able to pass sufficient legislation to reduce practices which have placed the public at the mercy of unprincipled speculators who sent the bulls on the stage only to be chased off by their own bears.

Interest in the municipal election here next Monday is picking up daily and signs seem to point to active competition in the majority of wards. In some of the districts voters have a wide field of candidates to choose from and there will be much head-scratching and cogitating probably before a decision is made. To those in doubt we would suggest that they consider the qualifications of each candidate and then vote for the one they believe will uphold the high standard of government. The city is in the midst of one of the most critical financial annuals known to the present generation, and only those should be sent to office who will support the program of economy enunciated by the administration the beginning of last term. The people have been saved an enormous amount of money through reduction of expenses and wise administration of the various departments of government and if the city is to continue to progress it is necessary that this condition prevail for sometime yet. Thrift should be the watchword of the voters, and they should see that this is embodied by the men they send into office for the next year. Henry Ford, who placed an automobile within reach of the majority of workingmen of the nation, now believes he has hit upon a plan to insure the economic independence of the wage earner. Although the plan has not been divulged, the noted automobile manufacturer, discussed it, while visiting President Hoover at the White House yesterday. He believes he can save the factory worker around \$500 a year through gardens to be operated by plants

But if the big southpaw was ineffective, his support was far from airtight. Joe Boley, shoved back into his old job at shortstop committed two errors. Dibrill Williams, the steady one of the last world series, touched off a six-run Boston rally in the sixth when he juggled a roller.

Eddie Rommel hurled the last two innings for the Macks, allowing four runs.

While the A's were suffering, the New York Yankees were busy moving into second place in the league standing with a 6 to 5 victory over the Washington Senators, the first meeting of the year between these rivals.

The Senators made an uphill battle to tie the count in the eighth after the Yanks had scored five runs off Alvin Crowder in the first two innings, but it was to no avail.

Only the two games escaped another day of rain and cold.

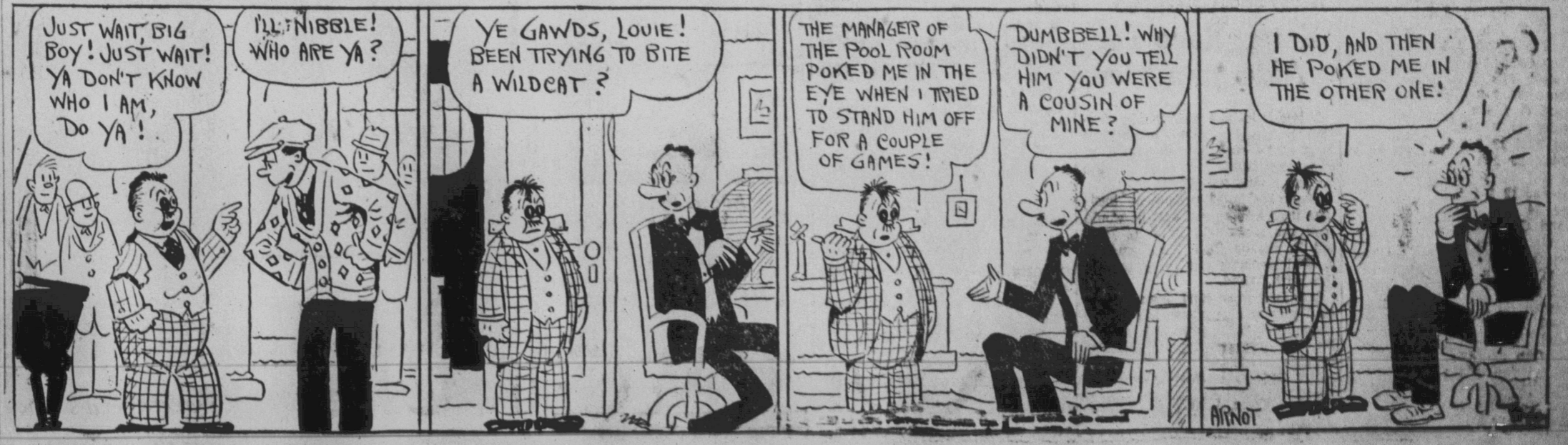
