Court Says Smith Is Entitled To 'Power' Seat

PREPARE FOR NEW TRIAL IN MASSIE CASE

Date of New Trial Is Expected to be Determined Within the Next Two Weeks.

Washington, May 2.—(AP)—A bill to prevent "hung juries" from freeing the four men charged with attacking Mrs. Thalia Massie, wife of a naval officer, in Honolulu was passed today by the Senate.

The measure was approved without a dissenting voice a short while after Representative Crisp (D., Ga.) had introduced a measure in the House to pardon the four Americans convicted of manslaughter in the slaying of a Hawaiian.

Washington, April 2.—(AP)—A congressional pardon for the four defendants convicted of manslaughter in the Massie case was proposed in the House today by Representative Crisp (D., Ga.)

Honolulu, May 2.—(AP)—With a definite promise Mrs. Thalia Massie will testify against the remaining four men accused of brutally assaulting her, prosecuting officials today were to lay final plans for retrial of the case.

Representatives of the Attorney General and the public prosecutor were expected to determine a date for trial—probably within two weeks. They also were to decide whether Prosecutor John C. Kelley, who obtained a manslaughter conviction last Friday of Mrs. Massie's husband, mother and two sailors for lynching the young woman's fifth alleged attacker, will handle the Territory's case.

The four accused of assaulting Mrs. Massie last September are Horace Ida, Japanese; Henry Chang, Chinese; David Takal, Japanese, and Ben Ahakeulo, Hawaiian. Their first trial last November ended with the jury deadlocked.

Also a defendant at the trial was Joseph Kahahawai, Hawaiian, for whose slaying Lieut. Thomas H. Massie, Mrs. Massie's husband, Mrs. Granville Porteus, her mother; and E. J. Lord and Albert O. Jones were convicted of manslaughter.

Whether Kelly would conduct the prosecution has been a subject of speculation. It is widely felt his vigorous prosecution of Lieutenant Massie and his co-defendants would make it embarrassing for him to do so.

The disorders which both naval and civilian authorities thought might follow Friday's manslaughter verdict have not occurred. There have been no disturbances. But commercial reprisals have started.

The service people have begun buying exclusively from the army and navy commissaries, while a group of white women has declared a boycott on the firms employing members of the jury.

Meanwhile, the four convicted defendants of the murder trial were described as "bearing up under it wonderfully well."

Clarence Darrow, veteran leader of defense counsel has regained some of his spirit.

The next defense move in the manslaughter case, said Montgomery Winn, assistant defense counsel, will come Friday when a motion for a new trial will be filed after sentence is passed.

To Investigate Doctor's Death

Lexington, N. C., May 2.—(AP)—An inquest will be held some time this week into the death of Dr. Jacob L. Sowers, 38, president of the ninth district Medical Society yesterday.

Dr. R. V. Yokely, county coroner impelled a jury which viewed the body, but postponed hearing any witnesses until later in the week.

Dr. Sowers was killed when his car collided with that of Tom A. Darr, of Lexington. Darr suffered a broken jawbone and bruises and cuts. The physicians on Tom, Tommy, 8 and Dr. Wade Sowers, a brother suffered minor bruises.

FIGHT SPREADS IN MANCHURIA

Japanese and Chinese Bandits Battle Over a Wide Area in the Northern District.

Tokyo, May 2.—(AP)—Japanese military forces and Chinese rebels battled over a wide area in northern and eastern Manchuria today.

A Japanese brigade under Major General Mural fought a 24-hour battle with 3,000 rebels near Wukimho which resulted in a victory for the Japanese. Reports said there were 30 casualties.

The Chinese retreated northward. They used machine guns and mortars and took advantage of the heavy frost as screens.

A new threat developed at the Unhua end of the Niran-Tunhua branch of the railway when Rebel bands, numbering several thousand men, following General Wang Ter-Lin, threatened to surround the city.

Japanese military reports also said a three hour battle took place northwest of Tungliat yesterday in which several hundred Chinese rebels were killed. The Japanese losses were 6 dead and 16 wounded, the reports said.

Previous reports to the Renzo Rengo news agency from Changchun said a force of 9,000 rebels was operating west of Tungliat and had clashed with Mongolian troops loyal to the Manchurian government.

Eight-Year-Old Girl Is Hacked To Death Today

Memphis, Tenn., May 2.—(AP)—An eight-year-old girl was hacked to death in her sleep, her mother was critically wounded and a negro accused of attacking them with an axe was fatally wounded by gunshot in an exclusive sub-division home here at dawn today.

Audella Puryear, daughter of Mr. and Mrs. Stanley A. Puryear, was slain as she lay beside her mother. The assailant, presumably using an axe, then turned on Mrs. Puryear, striking her about the head and face. She is not expected to recover.

Puryear told police that the attack was made by a negro and that the intruder then came to his bedroom.

THREE PERSONS KILLED IN MAY DAY ACTIVITIES

SCORES ARE ALSO INJURED

Hundreds of Others Bear Sore Heads as Result of Use of Police Clubs; Celebration in all Parts of World Described as the Most Peaceful in Years; Parades of Communists Pre-dominate the Observance.

(By the Associated Press)
Three persons were dead today, scores were in hospitals, and hundreds of heads bore the marks of police clubs as the aftermath of May Day celebrations throughout the world. The disorders were less serious than in other years, however, and the observance was ranked as one of the most peaceful since the world war.

Most large cities saw parades of Socialists, Communists and Workers' groups yesterday. The largest of all was a day-long march at Moscow of two million men and women, soldiers and civilians, past the tomb of Lenin in Red Square.

One man was killed near Madrid, during a clash and two others met death in the coal strike area at Sosnowied, Poland.

New York led the demonstrations in the United States, with a parade in a drizzling rain, of 40,000 Communists, carrying a bearded dragon branded "capitalism."

Police were busier in Spain than strikers in many cities. Paris, London, Berlin and other larger cities.

HIGHER TAXES IN PROSPECT

Congress Must Raise High Tax Bill Still Higher if Budget Is Balanced.

Washington, May 2.—(AP)—Increased telephone and telegraph tax rates were voted today by the Senate Finance committee in modifying the House revenue measure but greater exemptions were allowed.

The committee accepted a motion by Senator Bingham (R., Conn.) exempting all telephone and telegraph messages of less than fifty cents.

The rate was made ten cents on messages between fifty cents and a dollar; 15 cents on messages between \$1 and \$2; and 20 cents on messages of more than \$2.

Washington, May 2.—(AP)—Congress is up against the dismal realization that all its efforts to balance next year's budget may fall short of the mark unless the already high tax bill is raised much higher.

One of 18 men against whom charges of theft have been filed is E. N. Daniels, a deputy supervisor of the State Railroad Commission, which supervises prorated production.

HUNT BANDITS IN CAROLINAS

Officers Seek Five Men, Two of Whom Killed Policeman in Greenville, S. C.

Greenville, S. C., May 2.—(AP)—A manhunt was on in the Carolinas today for five gunmen, two of whom killed a policeman here and were freed by the other three after their arrest.

A. B. Hunt, 27, was the officer killed. He was shot down as he approached a tax last night to question two passengers who had aroused the suspicion of the driver.

His slayers exchanged shots with officers John Corea and Cliff Singleton, but were subdued and under arrest when a third man appeared and opened fire upon the officers. During the midst of the shooting, an automobile drove up and two men in it also fired at the officers.

Corea was wounded slightly by a shot which grazed his head. He and Singleton exhausted their ammunition and the five gun men fled in the automobile.

Push Plan to Pass Bill To Stabilize The Dollar

Washington, May 2.—(AP)—House Democratic leaders plan to throw their full weight behind an effort to pass today the Goldborough bill under which the Federal Reserve Board and Treasury could use \$9,000,000,000 to stabilize the dollar.

Sponsors of the measure have been assured they would have an opportunity to suspend the rules and pass the bill, which is opposed by Eugene Meyer, governor of the Federal Reserve Board.

Under this procedure 40 minutes of debate would be allowed and no amendments would be permitted. The bill would charge the Treasury and reserve system with the duty of establishing the purchasing power of the dollar at the average level it had between 1921 and 1929.

To do this the board could continue to purchase government securities at the rate of about \$100,000,000 a week as it is now doing to increase credit; change the discount rates and issue new currency.

SENATE LOSES BATTLE WITH PRES. HOOVER

Supreme Court Rules George Otis Smith Is Entitled to Chairmanship of Power Commission.

Washington, May 2.—(AP)—The Senate lost its fight with the President today when the Supreme Court declared Chairman George Otis Smith of the Federal Power Commission was entitled to hold that office.

Builders' Strike in New York City

New York, May 2.—(AP)—Approximately 30,000 members of the building trades council went on strike today pending agreement of a new wage scale with the Building Trades Employers Association.

The old agreement expired Saturday. The strike affects not only the 30,000 men who went on strike today but also the futures of 50,000 other members of the council's present unemployed.

Among major building operations affected by the strike were the feller center, the port of New York authority building and a score of other large construction jobs where work was practically at a standstill.

Members of three large building trades unions were still at work despite the strike. They are the electricians, structural iron workers and elevator construction workers, who have separate agreements with the employers.

Foreign War Veterans Talk Business Today

Charlotte, May 2.—(AP)—North Carolina veterans of foreign wars turned to business today in the annual encampment here after opening the three-day meeting with memorial service yesterday.

The dead of all wars this camp has fought were eulogized at a memorial service. Col. T. L. Kirkman, Dr. Luther Little and U. S. man Alexander were the speakers.

Brief talks were made this morning as the business session began with Commander Clarence R. Graham presiding.

Ross and Aross E. Bennett, Winston-Salem were promising for the post of departmental commander for next year when election are held.

A military parade will be staged through the business section of the city tonight and a midnight move will follow.

Reichers On Way Back To Newark

Havana, May 2.—(AP)—L. Reichers, of Arlington, N. J., is off for Miami at 9:0 a. m. (EST) today, and plans to continue on Newark, N. J., without trying a record.

Reichers flew non-stop from Montreal to Havana last week, which he was testing for a transatlantic flight from Harbor Grace, Newfoundland, to Paris as an after May 10 as the weather permits.

The New Jersey flier took 10 gallons of gasoline before leaving his monoplane into a heavy headwind. After clearing the customs at Miami he intends to take on 300 more gallons of the flight to Newark.

Robbers Beat Man At Gas Station

Gastonia, N. C., May 2.—(AP) Roy Carter, 18, filling station operator, was near death today from an attack made upon him in the filling station early Sunday.

With robbery as the apparent motive, his assailants beat Carter upon the head with a hatchet, heavy glass oil containers. He was found unconscious and with his face fractured in three places. The station cash drawer had been looted. Physicians said Carter's recovery was improbable.

Each of the aldermen will be elected for a term of one year. Three other members of the board and the mayor do not come up for election until next year. All members of the present board were elected for a term of one year.

Dry Head Believes Three Rum Runners Held in Norfolk Not in Lindbergh Case.

Norfolk, May 2.—(AP)—T. P. Tolbert, deputy prohibition administrator for the Norfolk district, said today he was convinced that three men arrested here as alleged rum runners from South Carolina had no connection with the Lindbergh kidnaping case. The federal official also discounted the theory that the men might be connected with the purple gang of Detroit.

Federal agents coming to Norfolk to investigate the case, Mr. Tolbert said, were prohibition officials, two of whom he requested to come here in connection with the arrest.

The three men, giving their names as Robert W. Stark, of Pittsburgh; Henry Singleton, of Little River, S. C., and Eddie R. Anderson of Palm Beach, Fla. were said by police to be under bond for their appearance in the United States District court at Charleston, S. C., on charges of conspiracy to violate the prohibition law. The men will be given a hearing here tomorrow on similar charges.

Police said the three were among the 21 men arrested by federal authorities in South Carolina on March 15 on charges of liquor law violation.

STOCK MARKET

WALL STREET..... New York, May 2—(AP)—The wearing away of share prices under slow but persistent selling continued at the start of the new week in Wall street.

Losses of 1 to more than 3 points carried much of the list to new lows for the cycle, although trading was again in meagre volume. Selling was fairly general, but oils held their ground well.

Issues losing about 2 to 3 points included Santa Fe, Union Pacific, Norfolk and Western, American Tobacco "B", American Telephone, U. S. Steel preferred, Bethlehem preferred, Safeway Stores, Macy, Coca Cola, and a few others. Penny and Hershey were soft spots, off more than 5. U. S. Steel common sagged nearly a point, and others. Frisco railroad preferred dropped 1 1-2 points to 1.

European cities also had their clashes, minor and major casualties and hundreds of arrests.

In Mexico City 20,000 paraded in an orderly review. In South American the chief tension was at Santiago, Chile, where 18,000 members of the National Guard dasked about with Machine guns, on the alert for outbreaks, but none occurred.

Parades were held in many of the larger cities of Argentina with out serious trouble. In Buenos Aires large groups of Communists and Socialists paraded.

Havana police rushed a group of 1,000 Communists in a downtown street and arrested a score of them after seizing Red banners bearing anti-government slogans.

Austrian Communists chased the acting premier of Victoria out of Yarrabank during a celebration there, but he and his party were rescued by police and escorted to Melbourne.

At Geneva, home of the League of Nations, several thousand paraded and there was much speech-making. Budapest police jailed 8 agitators.

(Continued from Page One) the nomination will be almost certain of defeat, and the selection of a presidential choice will rest upon the unpredictable action of the Democratic convention.

His victory would virtually eliminate the Garner boom, answer the Smith victory in Massachusetts and send the bandwagon rolling forward with odds favoring it to complete the course.

Before this contest is settled President Hoover, in the Republican camp, will have had it out squarely with the one man who seeks to dispute his otherwise clear road to renomination. In Maryland, former Senator Joseph I. France's home ground.

A preferential primary today will record a popular choice between him and the president. A convention later will select delegates, not bound by the preferential vote.

Also expected that today's Democratic convention in Rhode Island will pick ten delegates friendly to, if not instructed for, Alfred E. Smith. The Maryland Democratic primary will lead to selection of 16 Democratic delegates for Governor Albert Ritchie.

Roosevelt stands to pick up tomorrow 20 to 24 convention votes in Alabama and ten in South Dakota; both states holding primaries.

The New York Times states today that supporters of Governor Franklin D. Roosevelt are considering an attack on the rule which requires a two-thirds vote to obtain the presidential nomination at a Democratic National Convention.

Discussing the move, which may be made at the convention which opens in Chicago June 27, it was said friends of the governor have obtained a legal opinion that the convention may at any time decide by a vote of the majority to abandon the two-thirds rule and nominate by a majority vote.

The two-thirds rule was adopted at the first Democratic National Convention, 100 years ago. Its abolition was suggested by 1924 by supporters of William C. C. Adoo and in 1928 by followers of former Governor Alfred E. Smith.

The economy bill, if not already completely wrecked, is likely to be cut so low before the House is done, that it will fall utterly to bridge with savings the quarter billion gap between expenditures and the revenue which the tax bill has been expected to bring in.

The tax measure, now in the Senate finance committee, also has been cut considerably below the billion dollars estimated yield with which the House passed it. But the redrafting process has not been completed and the committee may decide within the next day or so to write it high enough to make up the shortcomings of the economy bill. But it is clear that stiff and highly unpopular taxation will be needed to do this.

There was trace on the economy bill today in the House. Because of a set rule that all other matters must give way Mondays to secondary legislation on the calendar, the struggle between insurgents of both parties and the leaders sponsoring the bill, the SHR, was postponed until tomorrow.

Then the issue will be joined on provisions which cut sharply into the allowances of World War veterans for a savings to the government of about \$48,000,000. There will be a desperate fight to preserve this section but few leaders are disposed to view the outlook with any real hope. If the section is enacted, with the \$117,000,000 already thrown out by the uncompromising foes of pay cuts and other shaves, the bill will be left at about a quarter of its original figure.
