BILLION DOLLAR TAX BILL REPORTED BY SENATE

Party Chieftains Will Attempt to Supplement Dwarfed Economy Bill

After Refusing to Reopen the Rate Section of the Revenue Measure, Senate Finance Committee Reports It and Bi-Partisan Effort To Press it Through Is Evident.

Washington, May 9.—(AP)—The Big Boy Tax Bill was put on the mark for a sprint toward enactment today, while party chieftains determined anew to supplement its dwarfed running mate—the economy bill.

After refusing 12 to 6 to reopen the rate section of the \$1,010,000,000 revenue measure, the Senate Finance committee reported it and bi-partisan determination to press it through is evident.

Meanwhile, the senate appropriations committee went to work on the vital supply bill and economy bills, determined to bring about savings of more than \$200,000,000 which are necessary to make the new tax bill balance the 1933 budget.

Over in the House, the economy committee which had its omnibus bill shattered, was called to meet this afternoon on plans for other moves to cut government costs.

And far up Pennsylvania avenue, President Hoover worked steadily to a continued effort to rally support in the Republican controlled Senate jointly for the compromise tax bill and a 237,000,000 money-saving program.

The White House showed little sign of activity, following the conference of Saturday and last night, but presidential secretaries confirmed that Mr. Hoover was maintaining contact with the Senate.

He intends to concentrate upon senate affairs principally in coming days, since it now holds not only the tax and economy bills but also a majority of the appropriation measures. He is not planning to call in immediately any additional sizeable groups of Senate leaders. The possibility remained, nevertheless, that Democratic chieftains might be summoned singly or in force.

Chairman McDuffie, in making the announcement of the House economy committee meeting, said: "We are going to try to effect some other economies, if at all possible. We will welcome suggestions from President Hoover or anyone else."

The Alabama Democrat said he hoped "that we might salvage a few millions more if we can get the cooperation of the executive department."

McDuffie said he hoped the Senate would approve the section in the House economy bill giving President Hoover broad authority to reorganize the government departments in order that some reductions in government costs could be made in 1933.

"President Hoover said if given the authority he could make many consolidations within 30 days that would effect economies," he said: "I am in favor of that. In addition, he could make many permanent economies that will help the taxpayers in years to come."

The riddled House economy bill authorized President Hoover to reorganize government activities not created by statute subject to Congressional approval. McDuffie added that he did not believe "Congress will veto any reorganization of the government that will effect savings, without impairing the efficiency of the federal structure."

President Hoover has been assured that a move will be made to hold the Senate in day and night sessions on the tax bill.

Thirty - Eight Persons Buried In Landslide

Lyons, Franch, May 9.—(AP)—Thirty-eight persons were believed buried today under landslides which swallowed up two apartment houses in the outskirts of Lyons.

Twelve injured were removed before rescuers were ordered away by Edouard Herriot, the mayor and former premier, who himself escaped death from another slide only by leaping to safety.

The rescue parties returned to the ruins, however, after cries were heard in the wreckage. At midnight they discovered a woman, pinned by a beam. She said she was not hurt.

SEEK OTHERS IN MEANS CASE

FIRE DAMAGES SALED STORE

Perkins Company Also Suffers Smoke Damage from Early Sunday Blaze.

Fire of undetermined origin did estimated damage of \$8,000 in the heart of the Greenville business district early Sunday morning.

TWO SEEKING DOUMER'S JOB

Election of New President of France to Be Held at Versailles Tomorrow.

Paris, May 9.—(AP)—Two candidates to succeed President Paul Doumer who was assassinated Friday were officially or unofficially in the running today.

The election is to be held at Versailles tomorrow. Paul Painleve, former premier, was being pressed by his friends to be a candidate. Albert Le Brun, president of the Senate, presented his candidacy formally yesterday.

The new President will be chosen by a joint session of the Chamber of Deputies and the Senate. Thousands of partisans filed by the Elysee palace to pay tribute to the dead President. After lying in state until Thursday morning the body will be taken to Notre Dame cathedral for funeral services. (Continued on Page Four)

OFFICER SHOT DOWN AT SPRAY

Clay Fogleman, Escaped Convict, Sought in Connection With two Slayings.

Leaksville, May 9.—(AP)—Clay Fogleman, 28, of Randleman, an escaped convict was sought by police today in connection with the slaying of Deputy J. A. Robinson last night and the killing of W. J. Carter, filling station operator, a week ago.

Robinson saw lights on in the Spray school house last night and started to enter it to investigate, but died from five bullets fired by two unidentified men who stepped from the shadows near the building and shot as he approached the door.

The two men escaped before Charlie Hunter, another officer who was on the other side of the building, could reach Robinson's side.

Carter was killed by two holdup men in his filling station almost a week to the hour from the killing of Robinson. Police expressed belief both were slain by the same men.

An automobile in which Fogleman has been seen was found near the school. It contained a shotgun and ammunition.

Fogleman escaped at Fayetteville last November while being held by Federal authorities for interstate transportation of a stolen automobile. He has been seen in this section at various times, but has eluded capture.

NEW CHURCH IS DEDICATED

Rev. A. W. Fleischmann Delivers Sermon at Stokes Baptist Church.

Marked by a program of inspiration and joy, the new Baptist church at Stokes was dedicated with appropriate services yesterday afternoon at 3:30 o'clock.

The occasion was one of the most important in the life of the denomination of that community and the building was crowded with members of the congregation and scores of people from other communities who gathered to help dedicate the beautiful structure to the cause of Christianity.

The single-story brick structure was completed about a month ago at a cost of approximately \$2,300 and the thing that brings pride to the congregation is the fact that it is all paid for. It required long preparation and sacrifice on the part of the membership to realize this ambition, and congratulations poured in upon them from church workers of other sections.

The dedicatory sermon was delivered by Rev. A. W. Fleischmann, pastor of Memorial Baptist church, Greenville, and the prayer of the consecration service immediately following the sermon was made by Nathan Brooks, of Greenville, young man who is preparing himself for the clergy.

Mr. Fleischmann spoke on the subject, "The Best Location for a Church," stressing the fact that the church should be located in Christ and chosen in him. He emphasized the importance of Christian living and exhorted the membership to keep forever before it the high principles as enunciated by Christ during His visit to earth. 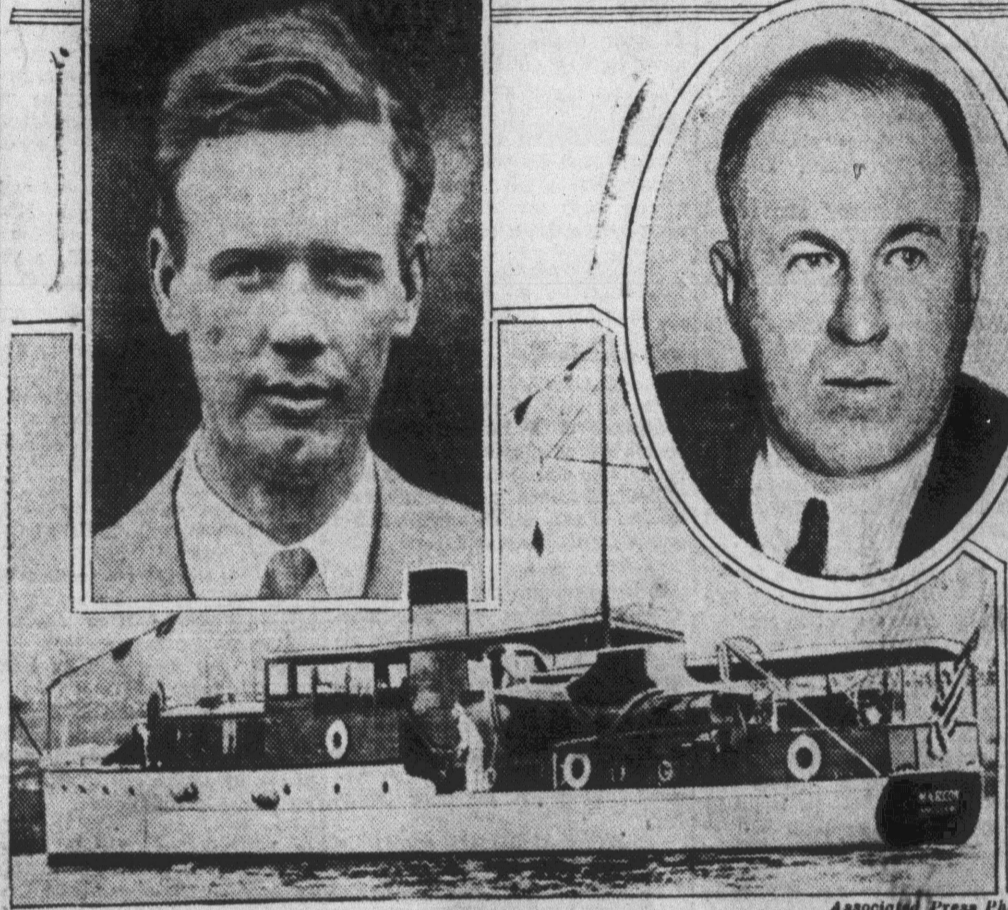
Beaten French Premier Will Resign Tomorrow

Paris, May 9.—(AP)—Defeated by a decisive margin in yesterday's parliamentary election, Premier Andre Tardieu will resign tomorrow night with a request that his successor be chosen immediately.

An official announcement after a cabinet meeting this morning said that the resignation will be presented as soon as the parliament has elected a new President to succeed Paul Doumer, and that it will be accompanied by a request that the present government not be asked to continue in office until the new Chamber of Deputies just elected convenes in June.

Eduard Herriot who was premier in 1924, is the most likely choice to succeed M. Tardieu. With returns practically complete from yesterday's voting, his party of the Left had swept away the Republican majority in the chamber; giving the Left groups substantial control. On the basis of yesterday's vote the Left groups had 358 seats in the new chamber, a majority of 100 seats.

DUNN SUFFERS BIG FIRE LOSS

Business Block Damaged About \$250,000 by Flames Early Today.

Dunn, May 9.—(AP)—Business houses on an entire block here were damaged by a fire which broke out at 3:45 a. m. Sunday and was not brought under control until early today.

Estimates of the damage ranged as high as \$250,000. Two men were painfully burned in fighting the fire which caused local firemen to call for aid from Benson, Fayetteville and Smithfield.

J. W. Thornton, automobile dealer whose garage and 25 automobiles burned, and one of his employees were the men burned fighting the fire. Neither was burned seriously.

After breaking out early Sunday, the blaze destroyed Baer's Department Store, a three-story building; Thornton's garage, and damaged the First and Citizens Bank, the Butler and Lee Drug Store and a number of offices and other stores.

The fire apparently was extinguished, but last night a wall of Baer's store fell and the blaze flared up again. Swept by a high wind, it spread to the Progressive Store, the Carolina Power and Light Company offices and W. H. Adam's store.

Splendid Exercises to Mark Observance of Memorial Day Here Tomorrow.

The men who fought with Lee and Jackson in the memorable struggle between the states will be honored in appropriate Memorial Day exercises here tomorrow.

The observance will be marked by a parade, decoration of the graves of departed veterans and exercises at the high school building. F. C. Harding will deliver the principal address.

Only a few survivors of the titanic struggle against the North remain in this county, but members of the George B. Singletary Chapter, United Daughters of the Confederacy, were planning to honor them just as they were honored in the days when they numbered their ranks by the hundreds of thousands.

FIRE FOLLOWS BLAST; SLIGHT DAMAGE DONE

Consul Attaches No Significance to Explosion; Police Begin Investigation.

Washington, May 9.—(AP)—The American consulate at Nagasaki, was bombed at 11:40 this morning. Henry B. Hitchcock, consul there, sent the State Department a message stating the consulate was set on fire by a bomb of crude manufacture thrown at the office entrance. It was believed, from a passing automobile.

The fire was put out by extinguishers and garden hose before serious damage was done. Hitchcock apparently attached no political significance to the incident. He reported that the police are making an investigation.

Ritchie and White Expected to Gain Strength Tuesday

By Associated Press Two more candidates for the Democratic Presidential nomination will obtain actual delegate strength this week. Albert C. Ritchie, of Maryland and George White, of Ohio.

The two governors will receive the votes of their respective states. White by a primary on Tuesday which is expected to give him almost all if not everyone of Ohio's 52. Ritchie taking Maryland's 16 in convention Thursday without any opposition.

Meanwhile, today the camp of Franklin D. Roosevelt expected a dozen more votes for the New York governor, half from Arizona and half from Wyoming. Both states were choosing delegates in state conventions. To this total Roosevelt hoped also to add another 16 tomorrow in West Virginia's primary, though Governor William H. Murray of Oklahoma is entered against him there.

With very little opposition President Hoover stands to pick 98 votes Tuesday to give him a strength of better than 900. Ohio will name 55 and West Virginia 19 in primaries, while a convention in Tennessee will select 24 more delegates. Three contests in Ohio, one against Joseph France of Maryland, and two against delegates pledged to Mayor Jacob S. Coxey, of Massillon, offer all the opposition to the Hoover drive in the week.

S. C. Plans For Cotton Festival

Anderson, S. C., May 9.—(AP)—Gaitly with a practical purpose will hold sway here Wednesday and Thursday when the second Southern Cotton Festival will be staged in an effort to smooth King Cotton's wrinkled brow and boost the welfare of his kingdom.

For two days representatives of state from the Virginias to Florida and Texas will participate in parades, cotton exhibitions, balls and general elaborate merrymaking intended to further the cause of greater cotton consumption.

File Protest Against Taxes on Automobiles

Washington, May 9.—(AP)—A sharp protest against the new revenue bill's taxes on automobiles, trucks, parts, accessories and rubber was filed with the senate finance committee today in telegrams from the leaders in the auto industry.

The message contended the taxes placed too heavy a proportion of the revenue burden on the industry.

The protests came as the finance committee was assembling to report the revenue measure finally to the Senate after several weeks during which it reversed itself numerous times on different phases of the tax raising program.

A telegram from the rubber manufacturers Association protest the 5 cent a pound tax on rubber imports and said that since more than a year's supply was on hand in the United States, the tax would produce little revenue.

News the committee had voted the tax, the message said, "is a distinct shock" coming when "practically all of the automotive business is operating at a loss."

New York, May 9.—(AP)—Monarch of the three-year-olds today, Burgoo King will lose no time defending the thoroughbred crown when in a sensational victory in the Kentucky derby.

The newest champion of the famous racing establishment of Colonel Edward R. Bradley, of Lexington, Ky., probably will go to the post this Saturday in the rich Preakness at Pimlico, Md., against most of the eastern colts beaten so soundly Saturday by the son of Bubbling Over.

Two records were smashed and a third equalled by Burgoo King's triumph in the 58th running of the derby, which carried a gross value of \$62,875 and added \$52,350 to the Bradley coffers.

It marked Col. Bradley's third victory, thereby breaking the deadlock he shared with three other owners. Likewise it gave his trainer, H. J. (Dick) Thompson, the distinction of saddling a third winner, for another record. Bradley entries ran one-two in 1921 with Behave Yourself-Black Servant and again in 1926 with Bubbling Over-Bagenbaggage.

The "Father-Son" achievement of Bubbling Over and his chestnut offspring, Burgoo King, duplicated the record of Halma, 1895 derby winner, and sire of Alan-A-Dale, victor in 1922.

Having proved the best of the lot at Churchill Downs, Burgoo King will go to the post a favorite in the Preakness but it may prove another wide-open colts that trailed the Bradley star in order—Economic, Stepenfotchet, Brandon Mint, Over Time and Tick On—may benefit from better racing luck or the shorter distance, one mile and three-sixteenths. Tick On, the derby favorite, may redeem himself for the bad behavior that ruined his chances at the barrier Saturday.

Earl Sande, the popular New York rider who piloted Over Time in a vain attempt to capture his fourth derby, will be up on Mad Pursuit in the Preakness.

Burgoo King's time was 2:05 1-5, with a five length margin at the finish.

Burgoo King paid the good price of \$13.24 for each \$2 mutuel ticket, going to the post at odds of slightly better than 51-2 to 1 to win. Tick On was he 5 to 5 favorite.

The betting was the smallest in many years, only \$277,000 passing through the machines on the feature race as compared with \$495,000 last year.

SEES NEED OF DRY LAW VOTE

George Wickersham Believes More Strongly in Necessity For Referendum.

Washington, May 9.—(AP)—George W. Wickersham believes more strongly than ever that a referendum on prohibition is needed. Sixteen months after winding up the work of the notable crime-study commission which bore his name, Wickersham expressed the conviction in an interview yesterday that a vote on altering the 18th amendment through state conventions would do much good by crystallizing what he termed the "sober, informed and deliberate opinion of the people." He knew, he said, that several members of his commission held the same opinion. In this interview Wickersham abandoned the complete silence he had clung to steadfastly in regard to the commission's work. He was asked about the apparent discrepancy between the conclusions appended to the report and the views expressed by a majority of the members in their individual expressions. While the summary set forth that "the commission is opposed to repeal of the 18th amendment," the greater number of the commissioners argued the dry law should be changed in some way. "Six of the members," replied Wickersham, "felt in varying degrees that prohibition was not a success in its form at that time. Four of us felt that it was not being enforced properly but that sufficient opportunity had not been given to judge it a failure. One member (Newton D. Baker) felt that the whole question should be remitted at once to the states. All were opposed to a return of the saloon. "A majority agreed that if the amendment was revised it should be made to read that Congress shall have power to regulate or prohibit the manufacture and transportation within the United States."

NEGRO SLAYS WHITE WOMAN

Mrs. Minnie Barbee Killed by Laborer After Criminal Attack.

Grenada, Miss., May 9.—(AP)—A young negro laborer was hunted today for criminally assaulting and slaying Mrs. Minnie Barbee, elderly widow landowner. Sheriff J. E. Carpenter said a neighbor reported seeing the negro enter Mrs. Barbee's home Saturday, four hours before the 65-year-old woman's body was found by a servant. The laborer, officers said, used several names, one of which was Clarence Williams. Sheriff Carpenter said he learned Mrs. Barbee had been afraid of Williams but had given him work evidently in the hope of preventing trouble. A coroner's jury held that Mrs. Barbee was criminally assaulted and then choked to death. Williams disappeared from his rooming house Friday. WOMAN DIES IN ACCIDENT

Miss Margaret Montgomery Is Killed in Auto Wreck; Four Others Hurt.

Spartanburg, S. C., May 9.—(AP)—Miss Margaret Montgomery, 25, a Spartanburg nurse, was instantly killed and four others were injured when their automobile collided with the guard rail of a bridge near Greer, today. Ralph Green, of Tryon, was the driver of the machine. The other occupants were Miss Hazel Holcombe, of Spartanburg and Harry Justice of Tryon and C. W. Connelly, of Spartanburg. They were rushed to the Chick Springs hospital for treatment. Their injuries were not serious. Details were meagre, but officers were told the impact hurled Miss Montgomery from the machine, breaking her neck. She was a native of Central, S. C., and has relatives there. Dr. T. O. Walker of Greer gave the injured first aid treatment in his office and then took them to Chick Springs in an ambulance. He said the men told him they had no idea how the wreck occurred unless Green simply failed to see the bridge as he rounded a sharp curve. Miss Holcombe received a number of bruises. Justice and Green were cut about the neck and Connelly escaped with a bad shaking up. All left the hospital soon after their injuries were treated.

FOURTEEN DIE IN ACCIDENTS

Spring Storms, Automobiles and Trains Claim Heavy Toll in South.

Atlanta, Ga., May 9.—(AP)—Fourteen deaths attributed to spring storms in the South over the week-end and drowning and train and automobile mishaps raised the total of accidental fatalities to fourteen. Tennessee reported four deaths. Three of them caused by a bolt of lightning that struck into a golfing party during a sudden rain at Nashville. North Carolina had four fatalities. Mississippi two. Georgia two and Alabama and Arkansas one each. Automobiles killed seven, lightning three, a cloudburst one, drowning two and a train one.

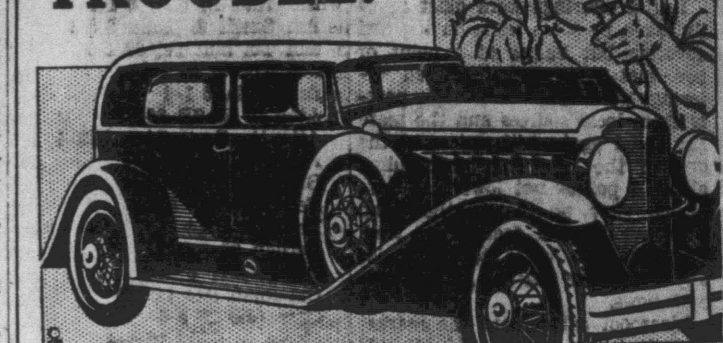

THREE CARS OF HOGS SHIPPED

Pitt County Products Sold on Richmond Market Friday; Curb Market Progresses.

E. F. Arnold, county agent; J. V. Taylor and J. G. Thomas were on the Richmond stock market Friday with three cars of Pitt county hogs. These hogs were shipped by the Pitt County Mutual Exchange and brings the total number of cars shipped to fifteen. There are four or five more cars on feed in the county at this time. It is possible that the farmers will break the record this year in number of cars of hogs shipped from the county.

The Curb Market under the management of the Mutual Exchange since last November, has enjoyed fine support from the buying public. Their sales for this year have amounted to \$952.72 more than they did last, for the corresponding period. Total sales to date since taking over the market in November amount to \$2,374.95. When you take into consideration the fact that produce is selling at least one time cheaper now than at this time last year it means that the market under its new management and in its new location has doubled its volume of business and if this is kept up, the market will enjoy a \$15,000 business this season.

According to Mr. Arnold the campaign is on to control hog cholera, the white plague of the swine industry. Yesterday 85 choats of more than 200 on W. H. Dall's farm, were vaccinated. Also 30 choice registered Duroc Jersey pigs on J. H. Boyd's hog ranch were immunized for life against this dreaded disease. More than 2,000 hogs will be treated during this month.

According to monthly reports from the county agent's office to the county commissioners, 606 farmers secured loans from the Reconstruction Finance Corporation fund amounting to \$146,949.75 to be used for crop production purposes. These loans were made to farmers who were unable to secure cash from other sources to operate their farms.

MASSIE BOUND FOR AMERICA

Others Connected With Slaying at Honolulu Spirited Away From Hawaii.

Honolulu, May 9.—(AP)—Mrs. Thalia Massie and others who became enmeshed in Honolulu's episode of tragedy and crime, have left Hawaii with tumult, tears and anger marking their departure.

With Honolulu police seeking to serve her with a subpoena, Mrs. Massie, her husband, Lieut. Thomas H. Massie, and her mother, Mrs. Granville Fortescue, were put on the liner Malolo Sunday by a naval submarine tender and with the aid of a high naval officer who held police at bay.

The police had sought to serve Mrs. Massie with a formal summons to appear at the scheduled retrial of four men accused of attacking her last September. She was unwilling to proceed with the case in view of the outcome of its sequel, that in which Mrs. Fortescue, Massie and E. J. Lord and A. O. Jones, navy enlisted men, were convicted of the lynching of Joseph Kahahawai.

The attack led to the abduction and slaying of Kahahawai. On the stand Massie testified he fired the fatal shot after the native had confessed aking part in the assault. Mrs. Fortescue and the three navy men were convicted of manslaughter but went free when their sentences were commuted by Governor Judd.

This departure of the principals and their attorneys, Clarence Darrow and George S. Leisure, was perhaps the strangest ever witnessed on Honolulu's waterfront, with its inevitable "Aloha" ceremony for every passenger ship.

The piers were crowded, reports to the police hunt for Mrs. Massie since yesterday having heightened the already intense public interest. The Royal Hawaiian band was playing on the pier and lels of flow ers were heaped high on the departing individuals.

Almost unnoticed the submarine tender from Pearl Harbor naval station 12 miles away edged up beside the big liner. Mrs. Fortescue appeared on its deck. Then came bluejackets with Lieutenant Massie's dog "Chris," an assortment of baggage, Lieut. and Mrs. Massie then emerged, accompanied by Captain Ward K. Wortman, commander of the submarine base, to which Massie had been attached.

The party stepped into a carro port of the Malolo. Subpoena in hand, Dewe Mookini, a Honolulu policeman stood there awaiting, Captain Wortman lowered his heavy shoulder and collided with Mookini while Mrs. Massie darted up a corridor to her stateroom.

"I shall report you to your superior officer," Wortman stormed. "You assaulted me!" shouted the policeman.

Wortman, panting, thrust Mookini against a wall while Mrs. Massie got into her stateroom and Mrs. Fortescue followed. Mookini wriggled away, pushed the door open and tried to read it to Mrs. Massie. The door slammed shut in his face. Then Mrs. Fortescue emerged, eyes blazing.

"Will someone go for Mr. Darrow?" she pleaded.

There was an angry exchange of words between Captain Wortman and the policeman. Massie approached them, extending his hand to Mookini.

"No hard feelings here," said Massie. "I know what your duty is."

Captain Wortman then extended his hand to the policeman and they also made up. The lieutenant then invited Lono McCallum and Arthur Stagbar, detectives accompanying Mookini, into the Massie stateroom. They remained several minutes an dsinged Massie's scrapp book.

PLAN TO SPEED UP ON BUDGET

Members of Congress Optimistic After Conference With President Hoover.

Washington, May 9.—(AP)—Spurred by week-end conferences with President Hoover, leaders of the senate pitched in today for the driving finish of the congressional session and the all-important legislation to balance the budget.

Despite the tremendous size of the task ahead, these men who gathered at the White House Saturday and Sunday nights emerged voicing confidence that an early satisfactory solution of the controversy would be obtained.

Enactment of the remaining vital bills before the session is brought to a halt five weeks hence by the national party conventions, depends now principally on the Senate. Besides the big revenue bill and the economy measure which must be increased by about \$200,000,000, a majority of the government appropriation bills remain to be enacted by that branch. Failure to pass any of them within the brief five weeks might compel a return of congress in July.

Cooperation of non-partisan lines was the watchword brought out by the representatives' conferees. Though all were Republicans, their spokesmen, Secretary Mills placed great emphasis on this point.

"We discussed," he said, "the best methods of assuring cooperation in putting through the economic program and the revenue bill. The effort has not to be to maintain all-around cooperation."

Upon this line today the finance committee met to finish work on the billion dollar compromise tax bill. Its formal report before night fall, with no more changes in rates, was expected, and Senator Watson of Indiana, the Republican leader, said the measure would be taken up probably Wednesday or Thursday.
