HOOVER LAUNCHES NEW MONEY-SAVING PROGRAM

Senate Gets Report On the Tax Bill Committee Proposes Huge Savings If Budget Is to Be Fully Balanced

HIGHER RATES ARE DEFENDED
MEANS BOND IS REDUCED
Belief Expressed That Rates Reported in Billion Dollar Revenue Bill Are Not Undue Burdens Upon Industry and Commerce; Sound Fiscal Policy Stressed for the Future

Washington, May 11.—(AP)—The Senate finance committee, in its report on the billion dollar revenue bill submitted today in the Senate, declared the measure must be accompanied by \$230,000,000 in savings to balance the budget next year.

The committee unanimously favored balancing the 1933 budget, pointing to deficits of the last three years.

Defending the numerous increases in rates and the new taxes provided by the bill, the report asked the nation to consider the benefits of a sound government fiscal policy.

"Your committee appreciates," said the report, "that the industries selected, in common with all other industries, have been and are seriously affected by the depression and consequent decreases in business activity and profits.

"It is realized that additional burdens at this time may seem unjustifiable and almost insurmountable.

"It is not believed, however, that taxes at the rates proposed by the bill as reported by your committee impose undue burdens upon industry and commerce or will seriously retard a return to normal business conditions.

"The required revenues must be raised.

"Benefits to be derived from the re-establishment of federal finances upon an unquestionably sound basis far surpass any possible disadvantages from the burden of additional taxes.

"It has been suggested that no effort should be made to balance the budget in one year, that the process of balancing the budget should be extended over a period of years and that the intervening deficits should be met by borrowing.

Although frequently misunderstood, this is substantially the policy adopted by the House of Representatives and approved by your committee. Last year's deficit was met by borrowing. This year's deficit has been, or will be, met by borrowing.

"We would, by this bill bring our budget back into balance in the third year—that is, in 1933—and even then without covering requirements for statutory debt retirements in the amount of \$497,000,000."

Hopes to Effect Great Saving by Reduction of National Appropriations

HIGHER WHEAT PRICES SEEN
SEES NEED TO CONSOLIDATE
Members of Senate Economy Committee Told of Plans at Breakfast at White House Today; Proposal Similar to That Killed by the House; Expect Saving of \$300,000,000

Washington, May 11.—(AP)—Prospects for higher wheat prices became brighter today with the agriculture department's second report on winter production, placing it at 440,781,000 bushels against 787,465,000 for last year.

Continued unfavorable growing conditions brought the indicated harvest down 18,000,000 bushels from the April 1 forecast of 458,000,000. The May 1 condition was 75.1 per cent of normal.

The prospective 1932 crop, both winter and spring, now is between 650,000,000 and 700,000,000 bushels. Based on average yields, the spring crop has been estimated at about 250,000,000, but the figure is not expected to be borne out as farmers have not followed their intentions to plant.

Such a reduction from the 1931 crop would mean a saving of \$300,000,000 or more through reduced appropriations and governmental consolidations.

Many of the items of the original House economy bill were discussed, including the five-day week and payless furlough plan for federal employees. Secretary Mills was appointed spokesman for the group breakfasting with the President, a role he has assumed following all of the series of recent White House parleys.

Asked what had happened, he stated slowly, apparently picking his words with care.

"We discussed economy along the line of seeing how, through an economy omnibus bill, reductions in appropriations and authority for governmental consolidations, savings of \$300,000,000 or more can be effected for the fiscal year, 1933."

Walter H. Newton, one of the President's secretaries, stood beside Mills on the rain drenched White House portico, as he spoke nodding in affirmation at each phrase.

Others who attended the breakfast conference, which lasted about two hours, long after coffee had been served, were Chairman Jones of the economy sub-committee, and Senators Bingham of Connecticut; Dickinson of Iowa, Republican; and McKellar, Tennessee; Bratton, New Mexico; and Byrnes, South Carolina, Democrats.

J. C. Roop, director of the budget, also was present carrying the bulging brief case from which he is seldom separated.

Roop went to the capital to work with the committee which began its sessions immediately upon leaving the White House.

Mr. Hoover offered alternative suggestions to the senators and left the fixing of a program entirely in their hands.

Mills said the conference had had time only to "outline a general plan" and that Roop would furnish details for the committee as he did during the protracted and often heated meetings of the House economy committee.

Asked if a tendency had been apparent on the part of the Democratic senators present to concur in the plans discussed, Mills hesitated, smiled, and replied:

"It was a very harmonious meeting."

The omnibus economy program, attached to an appropriation bill in the House, was estimated by the special economy committee which framed it there to be capable of saving \$42,000,000 in the piecemeal form in which the House passed it.

The treasury deficit approached the two-and-a-half-billion mark today. On May 9, it had reached \$2,497,262,965.

TRY TO FORCE VOTE ON BONUS

Patman Makes Final Effort to Get Compensation Measure on Calendar

Washington, May 11.—(AP)—A final attempt was launched today to secure a House vote at this session on legislation to cash the soldiers' bonus certificates.

Representative Patman of Texas and other bonus sponsors besought the rules committee, which maps the House program, to approve a resolution giving the bonus bill a place on the calendar. There was no great chance of their succeeding but the action might make it possible for them to employ a discharge petition to force out the bonus bill.

This would be effective only if Congress is compelled to return to work after the political conventions.

TWO KILLINGS STIR TOWN

Youth Commits Suicide Following Slaying of Relative's Wife in Ohio

Wesley, Ohio, May 11.—(AP)—The suicide of a 19-year-old youth shortly after he was implicated in a relative's confession of murder, provided a startling climax early today to an investigation of the slaying of the relative's wife.

The accused youth, Harold Young fired a shotgun charge into his head just as officers arrived at his home near here, to arrest him. His death came less than an hour after Herbert Meeker, a Wayne county farmer, named Young as the actual slayer of Meeker's wife.

Sheriff John Stevens of Holmes county, said Meeker also implicated himself.

The nude body of Meeker's young wife, Gertrude, was found Monday morning lying in a creek near Millersburg. She had been killed by blows on the head.

About a mile away, officers found the husband's automobile with blood on the runny board, wrecked against a tree. Search of the Meeker home later uncovered a

Charlotte, May 11.—(AP)—Reports were trickling in today of extensive damage to crops and property done by a severe wind and hail storm which swept sections of the Carolinas yesterday.

Crop damage estimates running as high as 75 per cent came from York, Cherokee and Dillon, counties in South Carolina, and Mecklenburg, Cabarrus, Columbus and Robeson counties, North Carolina. A number of areas swept by hail stones which in some cases weighed

ORDER TROOPS TO LEAVE CHINA

Japanese Government Announces Withdrawal of Forces Used in Warfare

Tokyo, May 11.—(AP)—The Japanese government announced today it had decided to withdraw all the rest of its troops from Shanghai, ending with an unexpected suddenness a situation which for four months has threatened the peace of the world.

The announcement was made by a government spokesman at midday. He said the cabinet made the decision at a meeting yesterday.

The matter was laid before Emperor Hirohito this afternoon and approved by him, after which the general staff telegraphed orders to General Shirakawa, Japanese army commander at Shanghai, to

Ask Federal Bond Issue To Relieve Unemployed

Washington, May 11.—(AP)—A \$300,000,000 federal bond issue for relief of suffering caused by unemployment was called for in the Senate today by Senator Robinson of Arkansas, Democratic leader.

Such legislation, he said, should be enacted before the end of the present session. Under the plan he proposed, the money would be "advanced" to the states and municipalities for their use in relief activities.

The government, Robinson said, should "receive such assurance of repayment as may be obtainable, including state and municipal securities where the same are available and deductions may be made when necessary from future allotments of federal aid."

Robinson said a bill before the Senate by Senator Wagner (D., N. Y.) "may be taken as the basis for this legislation."

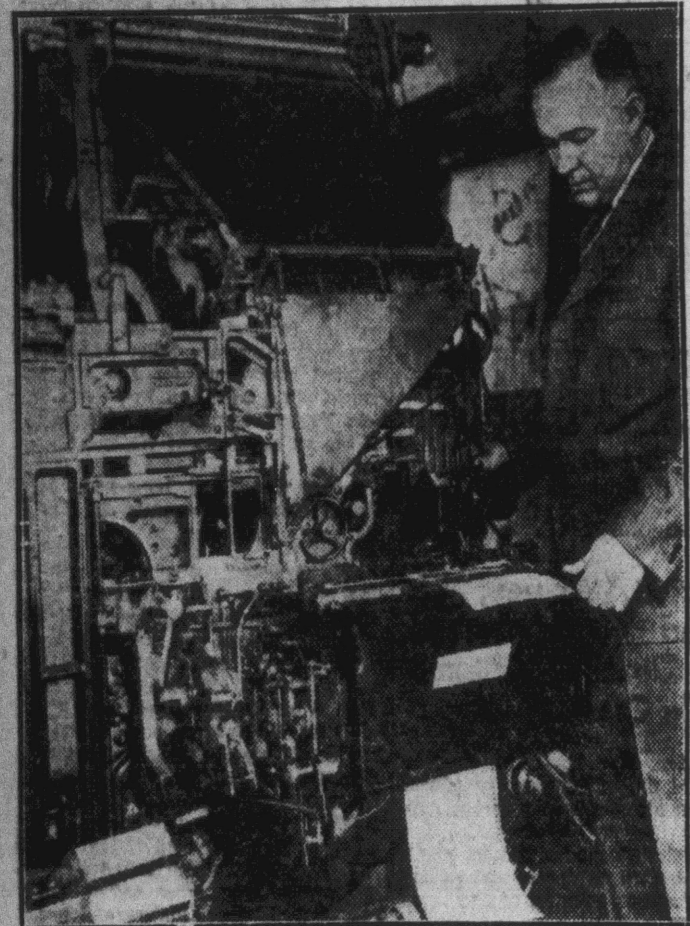

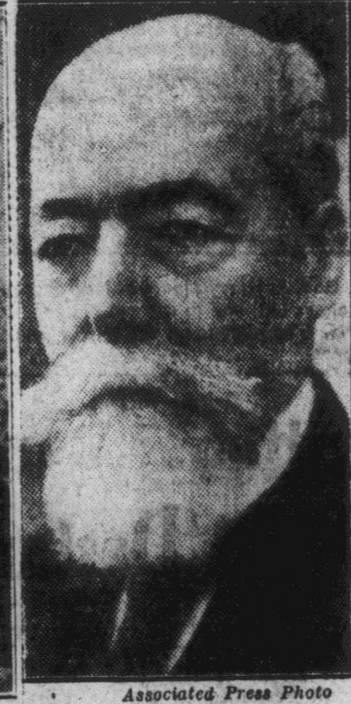

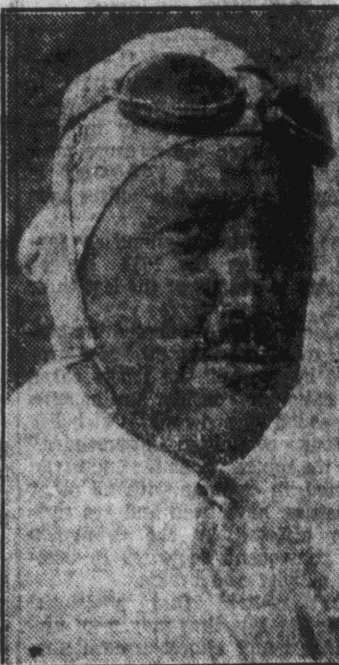

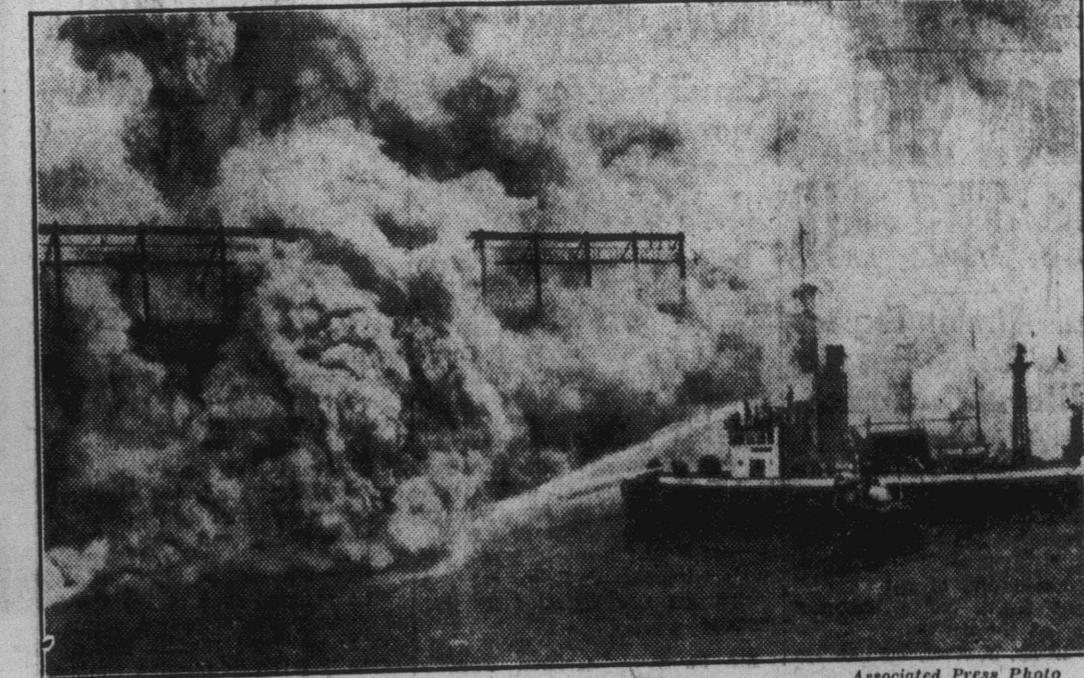

ABOUT TOWN

Pitt county will know more about the political situation in the state and nation as result of the coming of candidates for various offices during this week.

Lots of people who have not been able to determine how they are going to vote will probably be able to make up their minds after hearing the cause of each of the contestants explained, and some will be left in as much a quandary as ever.

The forthcoming primary is one of the most important in which the people are permitted to cast their vote and it is hoped each voter will be given due consideration before the date of balloting rolls around.

We want to put men in office who will fight for the rights of the whole people and not for just a few and if this is done, North Carolina will find herself in much better shape with the coming of another voting period.

The Rotary Club has started a movement for reopening of the swimming pool in the eastern section of the city during the summer months, believing it will render just as much service to the children of the city as it did last year.

The important thing to consider about the swimming pool supported by a group of public-spirited citizens, is the fact that it provides safeguard for children enjoying recreation there each day. It is far better than having children running around to other places of recreation where no safeguard is thrown about them while at play, and the public should give the movement the consideration of which it is so deserving.

The pool proved a great source of diversion for the young people last year and the Rotarians are right in proposing that it be reopened this year to serve the same cause.

Lifting of the tax burden from the shoulders of the oppressed landowners and transferring it to sources able to pay is the idea of the majority of people seeking public office at this time.

The selling of property for taxes has aroused the people of North Carolina as nothing else has aroused them in recent years and it is likely the next General Assembly will complete work started last year in lifting the burden from homes and putting it on sources capable of paying.

The English system of taxation apparently is meeting with considerable favor in this country at this time. The idea of safeguarding the homes through putting the taxes on incomes, franchise taxes and similar sources has given England a foremost place in the economic life of the world, and as it has proven so successful who doubts but that America will adopt some similar policy.

Literally taking away the source of income of the farmers by sale of the property for taxes is not good government, and it is hoped the legislators will give the matter deserving attention and attempt to find some form of relief.

Three officers have been indicted for participation in a giant gambling syndicate in Florida and were removed from office.

That the action will receive the commendation of the public is not to be doubted. Public officers should be the last people in the world to resort to gambling operations and when convicted should be dealt with as severely as any other person found guilty of a similar charge.

Officers are elected to render the highest type of service to the communities and they can not do this by lending their influence to the wave of crime sweeping from one section of the country to the other.

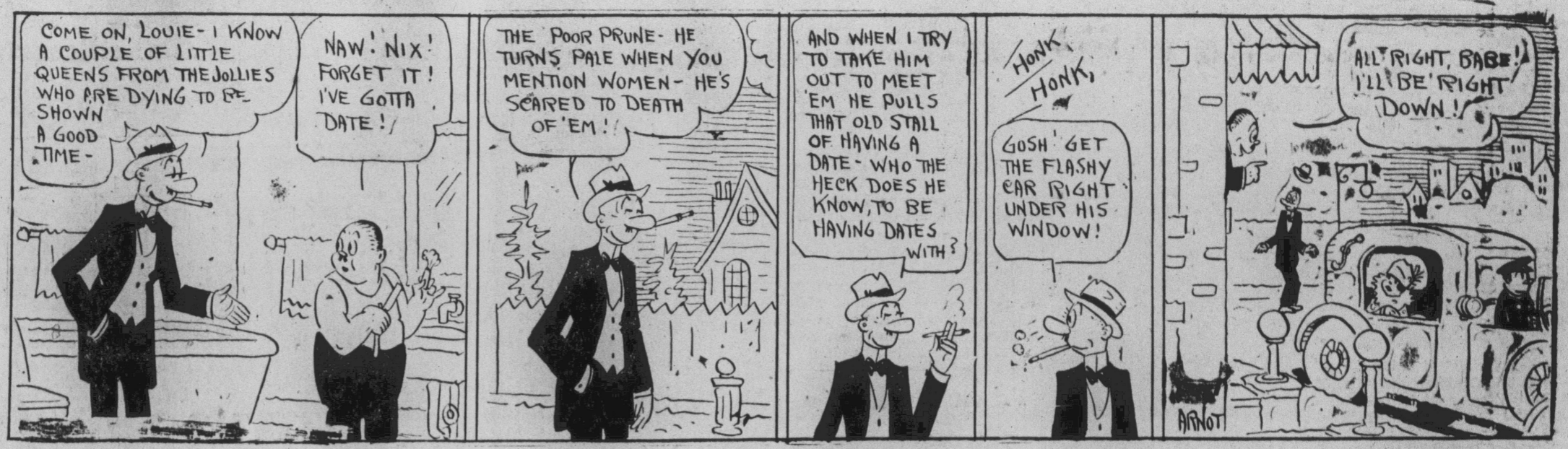

BEAT GIANTS TO INCREASE LEAGUE LEAD

By GAYLE TALBOT (Associated Press Sports Writer). Tearing along three games in front of their closest pursuers today, their great pitching staff mowing down opposing batsmen with relentless efficiency and their hitters thumping in unison, the Chicago Cubs threaten to make a runaway of the National League race.

When young Lon Warneke set the New York Giants down yesterday, 9 to 2, the leaders scored their fourth straight victory over eastern clubs and their thirteenth win in sixteen engagements. Unless Rogers Hornsby's team is slowed down soon, it will pile up such an advantage it will be able to coast through to the flag.

Warneke's sensational hurling has rounded out one of the most formidable staffs in either league. In winning his first five games, in each of which he went the full distance, the 23-year-old product of Mount Ida, Ark., has given up only nine runs, all tied. His work has overshadowed that of such veteran mates as Malone, Bush, Roo and Grimes, and these have done well enough.

The Giants could find Warneke for only five hits yesterday, two of which came after two were out in the ninth and provided their second run. In six of the nine innings he was unhittable. His team-mates whaled three Glat hurlers for 11 safeties every man in the line-up getting at least one. They were helped along by three Giant errors, running the total for McGraw's crew to 42 miscues in 20 games.

The day's only other National League bout saw the Phillies break Cincinnati's five-game winning streak, 4 to 0, behind Ray Benge's effective pitching. Five Red hits were widely spaced. Rain checked the scheduled activities at Pittsburgh and St. Louis.

Vic Sorrell turned in the day's American League masterpiece when he allowed the Boston Red Sox only two hits in pitching the Detroit Tigers to a 11 to 0 victory. Hal Rhyne's two singles knocked Sorrell out of a no-hit game.

Lefty Grove was almost as effective as the Athletics' blanked the Chicago White Sox, 9 to 0. The Great southpaw allowed six hits but bore down in the pinches. Jimmy Dykes knocked in four of the winners' runs with a homerun and a double.

The wildness of Walter Stewart and "Bump" Hadley, who distributed eleven walks, helped the Yankees trounce the St. Louis Browns, 10 to 2, in their delayed opening. Vernon Gomez held the Browns to seven hits in his fourth win of the year and likely would have had a shutout but for weak fielding behind him in the fifth, when the visitors scored all their runs.

Cleveland was rained out at Washington.

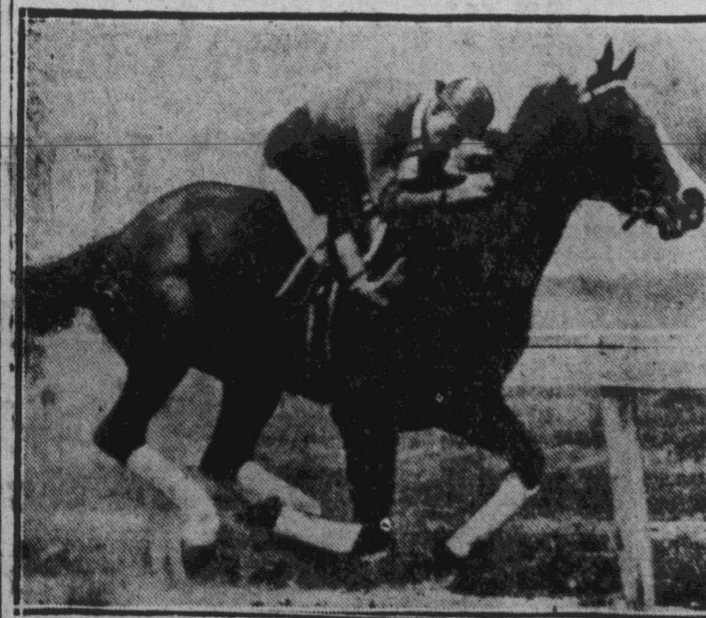

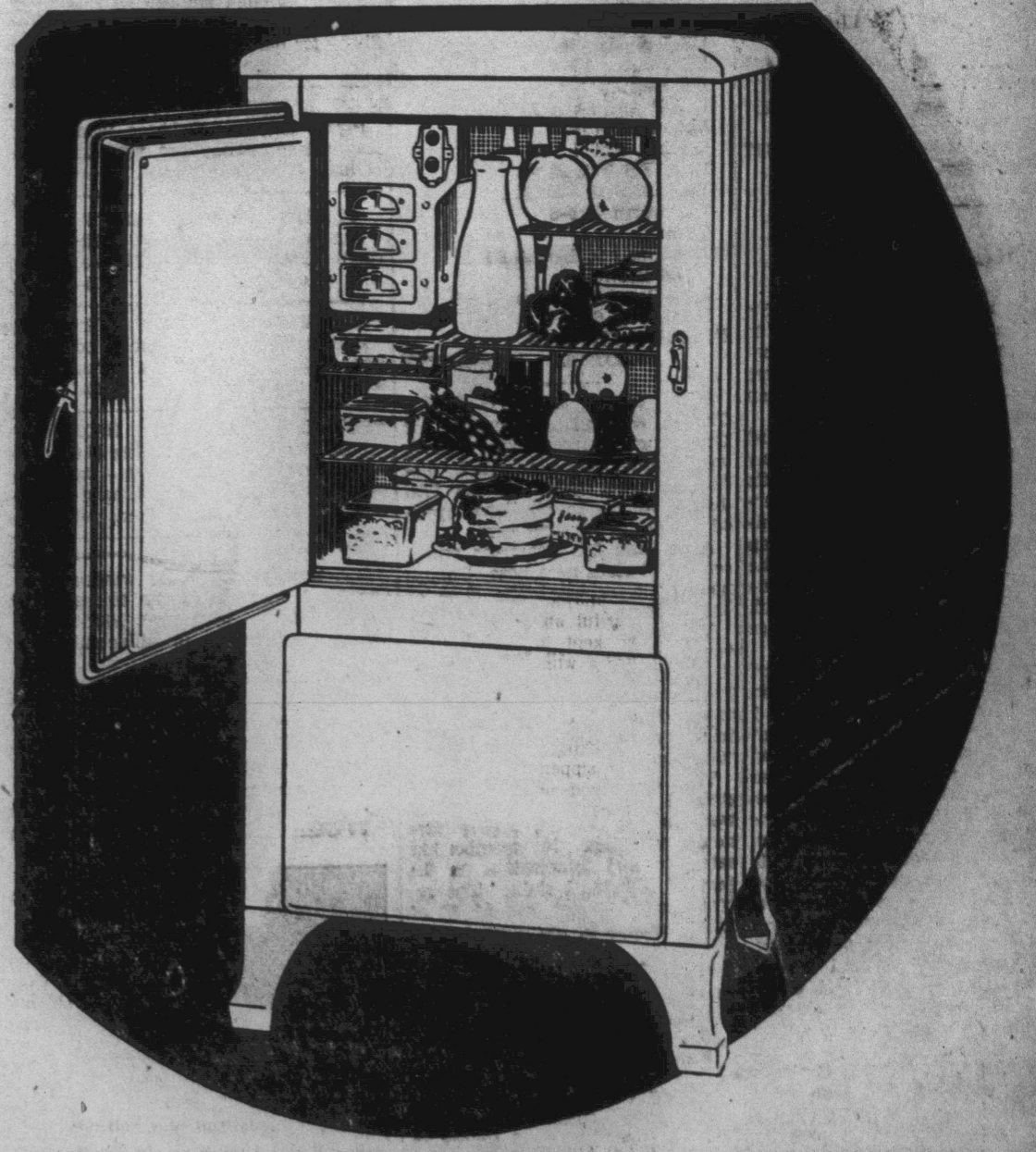

Stock Market

New York, May 11.—(AP)—The stock market was again unable to make consistent or notable progress today, but it still showed more inclination to move forward than to slip back.

During the first hour the list pushed up 1 to 2 points for many of the leaders, but lost much of its rise around noon. By early afternoon, the market was again creeping forward, with leaders mostly up fractions to more than a point. The coalition economy move in the Senate, and the government's bullish wheat crop report, were cited as favorable factors.

J. and California, American Can, DuPont and North American were up fractionally. U. S. Steel and American Telephone were only about steady. New York Central turned rather heavy, losing a point, and Union Pacific followed it down. United Aircraft sagged a point to a new low.

Omission of New York Central's dividend, while it had been overshadowed by deferment of action in the previous quarter, apparently prompted some selling of the carrier issues. Union Pacific's directors meet for action tomorrow and although that road is one of the small group expected to earn their best interest charges this year, a cut in the \$10 annual dividend rate is widely expected, inasmuch as earnings have been running far under that level in recent months.

MEANS BOND IS REDUCED

(Continued from Page One) Washington, May 11.—(AP)—The bond of Gaston B. Means, under indictment for larceny and embezzlement of \$104,000 from Mrs. Edward B. McLean, was reduced today to \$50,000, but whether he could meet the terms remained undetermined.

Justice James M. Proctor, of the District of Columbia Superior court, who received the indictments yesterday, fixed the amount, which originally had been set at \$100,000. Means' lawyer, J. William Tomlinson, presented a bondsman, who he said could meet the terms. But United States Attorney Leo A. Rover immediately objected to the bondsman.

The lawyer then prepared for further conference with the Judge. Rover has said a professional bondsman would not be acceptable. Tomlinson offered Joseph P. McGee of the Public Identity Company of Newark, N. J., as the bondsman. The judge took the offer under advisement.

Rover objected to any security company which would receive a cash premium for the full amount of the bond, saying:

"Though I say it respectfully, I will not take responsibility for any professional bonding company. It is a difference between a civil case, where the district attorney's office does not have responsibility, and a criminal case, where the responsibility rests with the district attorney's office so that if the defendant is not present for trial, there is an open case on the books, and a fugitive from justice."

Justice Proctor then commented that he could see no objection in a criminal case to a bondsman "who accepts a cash security," and announced he would allow time for Rover to investigate.

"I will have an investigation made immediately," Rover said, "and give the results in open court."

Tomlinson insisted that the bonding company should be acceptable. He maintained that any company which is "approved by the treasury and O. K'd. But this court should be acceptable."

Rover asserted that "knowing Means as I do," he believed that four persons individually responsible should be required.

Meanwhile, Representative Fish of New York disclosed today in an interview that it was Means who two years ago turned over to him indirectly a "fake warehouse receipt" which led to a futile search for alleged Soviet documents in Baltimore.

Fish, who was chairman of a special Communist-investigating committee of the House, said it was the receipt which led him to a Baltimore warehouse in quest of "twenty trucks of so-called secret Communist papers."

Means was never employed by the committee, but Fish said the visit to the warehouse followed a conference in which Means produced the warehouse receipt, turned it over to a lawyer and in turn gave it to Fish.

The representative said Means had been working for the National Civic Federation of New York, and that some individuals connected with this organization apparently believed his story that Communist documents had been collected in Mexico and brought into the United States. When Fish arrived at the warehouse, he said, he found nothing at all.

He also expressed opposition to a gross sales tax which he said, would surely come up for consideration at the next meeting of the legislature.

Discussing the bill providing for full payment of compensation certificates to former service men, the speaker said he believed the payment of this money would be the "saving grace" of the country by supplying needed currency in general business life.

The address was heard by the largest crowd attending a political gathering here this year. The courtroom was packed almost to capacity and the speaker, soaring to unexpected heights of oratory, was vigorously applauded at different stages of the address.

The introduction was made by F. C. Harding, who referred to the critical economic situation confronting the nation, and read an article dealing with the low values affecting the nation, and especially in the field of agriculture.

Mr. Fountain said the basic industry of this country was agriculture and that conditions could not be expected to improve until prices for farm products showed an improvement.

He asserted the people have looked to the "big interests" for leadership for years and that they had failed. He charged that the same interests backed by Wall Street bankers, and the government itself, had forgotten the basic fact of life and had almost destroyed them-

self in watching the "desh pils" instead of the rights of the people.

He quoted a Western Carolina farmer as saying that when he took more than half from his hens they failed to produce, out as long as he gave them their share of their production they delivered the goods.

He applied the same principle to government in this country and asserted the rights of the farmer must be realized before prosperity is restored. He said he believed the eastern half of the state was in better shape than the western section and that there was no hope for either until they were able to come back. Consuming goods must be restored, he said, but this cannot be done by big business trying to legislate for business. It must come through recognition of the rights of the little man.

The speaker declared the country needed government closer to the people. He referred to Governor Gardner's commissions, many of which were termed unnecessary, and said they talk about "welfare" but the government must get back under the constitution.

The present administration was dismissed and offices created during the present administration were declared contrary to sound principles of administration.

He stressed the lack of need for the executive council, personnel commission, tax commission, created during the present administration, declaring they could be handled by other departments created previously for such a purpose. He described this as money literally thrown away.

The selling of homes for collection of taxes is not a healthy situation, Mr. Fountain said, and he pledged to use his every effort to relieve the remainder of the burden on land if elected to office.

J. C. B. Ehringhaus was scored for changing his platform and his criticism of Mr. Fountain's campaign. He read the Ehringhaus platform, and caused a ripple of laughter when he professed to be

unable to say "what it was all about" and left his hearers to determine it.

Ehringhaus is Gardner's candidate, and the Democratic committee is supporting him, Mr. Fountain said, as he called on his hearers to see that the cause of the people was protected at the polls in the forthcoming election.

ORDER TROOPS OUT OF CHINA

(Continued from Page One) hold all army forces there in readiness to return to Japan. The spokesman said the movement was expected to be completed within a month.

From then on, the spokesman said, Japan expected the United States and other powers interested in Shanghai to see to it that the terms of the recently signed truce agreement were observed by China.

The troops, once returned, would be held in readiness to return should a "genuine emergency" demand it, he emphasized, but he added that the government in the future would probably be slow to decide such an emergency existed and would not consider minor infractions of the truce by the Chinese reason for dispatching troops.

"The decision is due to the Japanese government's desire to conform to world opinion," he said, "and to prove that Japan had no territorial or other ulterior motives in sending the troops to Shanghai."

The withdrawal will mean a return to conditions as they existed before the outbreak at Shanghai last January which cost thousands of lives, both Chinese and Japanese, and the destruction of millions of dollars worth of property.

Since the withdrawal of the fourteenth division from Shanghai to be sent to Manchuria, announced by the war department yester-

day, only about 15,000 Japanese troops remain there. These are mostly in General Kenichi Uveda's ninth division. They will be withdrawn within a month's time and will return to their original home station at Kanazawa.
