UNCOVER IMPORTANT CLUE IN LINDBERGH MURDER

LINDBERGH'S PLANNING TO GO TO EUROPE

**Reported Colonel and
Wife Will Live in
Chateau Until Baby
Is Born.**

New York, May 14.—(AP)—The New York World-Telegram today states there is a report current that Col. and Mrs. Charles A. Lindbergh will sail for Europe on the Ile de France June 4, there to remain in the chateau of a friend until their second baby is born.

The World-Telegram does not say where the chateau is, but another report is that they have been offered the chateau of a friend in the south of France.

It is generally believed that they will never return to live in the house on Sourland mountain, which had just been finished and not yet completely furnished when their baby was kidnapped.

They had never lived in the new house until after the kidnapping, and had only passed a few weekends there. The site for Colonel Lindbergh's private flying field, near the house, was never cleared. The fact that the mountain is so high that it rises above the fogs that frequently hang over the New Jersey lowlands was largely responsible for their having chosen that lonely site for their home, friends of the Lindberghs have said.

Now that there is no longer any need of their presence at Hopewell, it is generally believed they will leave within the next few days. The only thing that would be apt to keep them there would be the illness of either Colonel or Mrs. Lindbergh, but the official bulletin today indicated that neither was ill.

Through the winter, while their own home was being completed, Colonel and Mrs. Lindbergh and the baby lived at the home of Mrs. Dwight Morrow, in Englewood.

There is a possibility, too, it is said, that they may go to the Morrow summer home in Maine, for the best and seclusion they desire.

MRS. MASSIE IN CALIFORNIA

**Wife of American Naval
Officer Is Given
Welcome by Society

San Francisco, May 14.—(AP)—Mrs. Julia Massie, welcomed by San Francisco society, today hoped to forget in a round of parties and luncheons the recent Hawaiian "honor slaying."

A luncheon was arranged for today by a group of women's club leaders with Mrs. Massie as the honor guest.

Both she and her husband expressed joy at returning to the mainland and said they planned to visit Kentucky relatives if the officer could obtain a leave.

Mrs. Porteus left by train for New York immediately after the steamer docked. She announced she planned to join her husband in the East.

Chapel Hill, May 14.—(AP)—Three alleged members of a bandit gang which tried to rob George Coleman here and then wounded Ashby Penn, University of North Carolina student, were bound over to Superior court after a preliminary hearing here at which Penn identified one of them, Jack Thomas, as the man who shot him.

Coleman identified Elwood Johnson of Siler City, and Thomas as the men who attacked him, and Lawrence Armstrong, the third man arrested, had confessed to being with the band. Robert Thompson former Mount Holly police chief, is still being sought in the case.

The accused men were placed in jail at Hillsboro to await trial when the failed to make bond.

PRES. HOOVER LAUDS MORSE

**Joins in Celebration
Centennial of Con-
ception of the Tele-
graph.**

Washington, May 14.—(AP)—President Hoover, in a message dispatched over the most modern of fast-moving telegraphic instruments, today joined in praise of the memory of Samuel F. B. Morse upon the centennial of his conception of the telegraph.

The chief executive pressed in the White House a gold-studded telegraphic key, itself a part of the telegraphic history, to open a world wide centennial celebration of Morse's invention and its revolutionizing of the world's communication system.

In his special message, the President praised the inventor and his work as "an inspiration to mankind." The message follows:

"I am glad to open this world-wide centennial celebration of the invention of the Morse telegraphic code and of the electrical transmission of these signals.

"It is a source of pride to all Americans that the vast system of instantaneous communications by means of the electrical telegraph originated in the mind of an American, Samuel F. B. Morse, whose culture was an honor to his country and whose character was an inspiration to mankind."

TRACE CLUES AT NORFOLK

**Loose Ends Gathered
in Secret Investiga-
tion of the Lindbergh
Case.**

Norfolk, Va., May 14.—(AP)—Working secretly upon the task of tracing certain clues, the Norfolk police today were joined with other far-flung searchers in the intensified hunt for the murderers of the Lindbergh baby.

Colonel Charles B. Borland, director of public safety said the investigation is being made to gather together "loose ends which the New Jersey authorities feel may have some bearing on the case." Col. Borland and Chief of Police S. W. Ironmonger said they could not disclose the exact nature of the investigation.

COAST GUARD BEGINS WORK

**Patrol Boats Search
Ocean for Slayers of
the Lindbergh Baby.**

Washington, May 14.—(AP)—The Treasury Department today directed the United States Secret Service and the intelligence unit of the Internal Revenue Bureau to do what they could in the search for the kidnapers and slayers of the Lindbergh baby.

Another unit of the treasury—the coast guard—thus far has been unable to locate a vessel that was described by Norfolk negotiators in the effort to return the child to its parents as the rendezvous of the kidnapers.

Treasury officials said the coast guard had searched for it from the Massachusetts coast to the South Atlantic without avail.

While no official would be quoted the impression run through the service doubting the existence of such a boat because it was felt (Continued on page four)

Lou Reichers Rescued From Stormy Atlantic

S. S. President Roosevelt, May 14.—Lou Reichers, Newark, N. J., after, was aboard my ship today, bound for New York, after a thrilling rescue from a stormy sea last night which ended his attempt to set a new record for a flight from Newark to Paris.

Reichers, who took off from the Newark airport at 11:02 Thursday night was picked up out of the sea 47 miles off Fastnet, a rocky inlet near the southernmost tip of Ireland, shortly after 9:30 p. m., Greenwich Mean Time (4 p. m. EST.).

At 9:10 p. m., we sighted his plane as it fluttered down to a landing. The weather was hazy and visibility poor. A strong south wind was whipping up a heavy sea. I maneuvered the President Roosevelt alongside the crippled plane near enough to launch a lifeboat. Chief Officer Manning went over with life boat No. 10 and worked it up beside the plane, finally succeeding, in spite of the adverse conditions, in helping Reichers out of the crushed fuselage into the boat.

Reichers was suffering from a bucked nose and several minor injuries incurred in his landing amid the high waves. He had several (Continued on page four)

BARRED FROM MINING AREA

**Eight Members of Civil
Liberties Union are
Prevented from En-
tering Kentucky.**

Barbourville, Ky., May 14.—(AP)—The American Civil Liberties union delegation was barred from the Bell county coal fields today by officers and citizens.

London, Ky., May 14.—(AP)—Eight members of an American Civil Liberties union investigating expedition decided today to enter the southeastern Kentucky mine area, despite their failure to obtain a federal injunction to protect them and in the face of court testimony bloodshed was likely if they visited the troubled mountain counties.

Several members of the party expressed uncertainty whether they would continue their trip until County Attorney Walter B. Smith of Bell county told them today he and his officers would render "every reasonable assistance" to protect them from danger. Mrs. Carroll King, New York, the only woman member of the party, decided not to go, however.

The eight who planned to go to Pineville today were Dudley Field Malone, Arthur Garfield Hays, Ernest Sutherland Bates, the Rev. Charles C. Webber, Prof. Broadus Mitchell and Jesse C. Duke, all from the East; Robert S. Keebler, Memphis, and the Rev. Eugene Sutherland, Louisville.

The last Presidential primaries of the year will be held next week in New Jersey and Oregon while nine other states will contribute their share of delegates to the national conventions.

With all political selections ended for this week, attention centered today on the events of next Monday when Democratic conventions in Connecticut, Kansas, and New Mexico will pick 42 delegates.

A Smith-Roosevelt compromise is expected to invite the Connecticut vote of 16. Franklin D. Roosevelt is promised Kansas' 20, and New Mexico, with 6 votes, may come into his column also. On the week's succeeding days other states will act to make up a total of 154 Democratic votes, leaving less than 200 to be chosen in the whole country.

Republicans will choose 87 delegates in five states, leaving at the end only 123 to be selected.

INSANE MAN DEFIES COPS

**Wild Bill Sizemore
Holds Officers at
Bay with Gun in Jail
at Charlotte.**

Charlotte, May 14.—(AP)—William (Wild Bill) Sizemore, prisoner who has been adjudged insane, snatched a pistol from a patrolman in the jail today and was holding a force of officers at bay this afternoon despite efforts to subdue him with tear gas.

Wild Bill snatched the pistol from Patrolman John Erwin and forced the officer to leave his cell. Although unable to get out of the jail, Wild Bill defied officers to come and take the weapon from him. ear gas guns were brought into action, but the crazed prisoner seemed unaffected by the gas.

After holding the officers at bay for some time, Wild Bill shouted for them to send up the reporters and he would issue a statement for the press.

"Tell them," he said to the newsmen, who stood a safe distance away, "that they can't get me out of here until 20 doctors say I'm not crazy."

AKRON MOORS AT SUNYVALE

**Governmental Digni-
taries gather to Cele-
brate Coming of the
Giant Airship.**

Sunnyvale, Calif., May 14.—(AP)—The navy's new lighter-than-air craft base here had its first customer today, the Dirigible Akron swinging from a portable mooring mast. Riveters beat a tattoo on the skeleton of the new airship hangar and civic and governmental dignitaries gathered to celebrate the ship's coming.

The giant airship was moored successfully last night after cruising all day around the San Francisco bay area. Circumstances combined to defeat her contemplations of early morning landing on her voyage from San Diego, where the world's largest airship stopped to replenish a fuel supply on a flight from Lakehurst, N. J.

Circumstances were lack of wind, lack of ballast, and a "super heated" condition of her lifting helium which navy men blamed on static electricity.

Lieut.-Com. Charles E. Rosen dahl, master of the Akron, said it would remain here at least for the week-end. He said he was subject to orders of the commander-in-chief of the United States fleet, Admiral Frank H. Schofield, to whom he probably would report Monday at San Pedro, flying there by airplane.

SOIL ANALYSIS WILL BE MADE

**Shovel Found in Bush-
es Near Where Skel-
eton of Child was
Discovered; State
Police Continue Ex-
amination of Morris
Rosner and John H.
Curtis; Grand Jury
to Probe the Ransom
Next Week.**

Hopewell, N. J., May 14.—(AP)—A new and possibly important clue was found today in the Lindbergh baby murder case.

While police were concentrating their efforts to run down the kidnapper-murders on examination of intermediaries who were in touch with the criminals before it was known the baby was dead, a detective found a broken shovel near the spot where the body was discovered.

And the iron scoop of the shovel, which is all that was found, had fresh earth still clinging to it, indicating recent use.

Officials refrained from saying what significance this find might have but the scoop was carefully wrapped and taken away for examination by experts.

Before the scoop was discovered in dense undergrowth a few feet from where the body was found state police scraped a six foot pile at the spot where the body lay and even carried away the top foot of soil for analysis. They also found a burlap bag found near the body to analysis.

Before coming here from a conference at Trenton today District Attorney Erwin Marshall mentioned a possible new clue but later said that no arrests were in sight. The shovel was found while he was here.

As state police at the Lindbergh home were continuing their examination of Morris Rosner and John Hughes Curtis, two intermediaries in the search for the baby, the Bronx county prosecutor in New York City announced that he would present evidence to the grand jury next week about the payment of a \$50,000 ransom by Dr. John F. Condon, another negotiator.

Dr. Condon would be the principal witness, he said, so that they might hear his story of a mysterious figure in a Bronx cemetery. Police here released Dr. Condon after they heard his story, saying there was nothing to implicate him with the kidnapping or subsequent events.

Trenton, N. J., May 14.—(AP)—District Attorney Erwin Marshall, prosecutor of Mercer county, in which the body of the Lindbergh baby was found, said after a visit to the scene today that no immediate arrests were in sight.

He said he was hopeful the kidnapper-murders would be found but made it plain that this was entirely a hope.

Washington, May 14.—(AP)—The view that hanging is too good for kidnapers was expressed today by Senator Patterson, sponsor of a bill to make interstate kidnapping a capital federal offense.

"Death is the only kind of punishment these racketeers can understand."

"They don't mind the prospect of a penitentiary sentence, particularly when they are playing for big money stakes, but when you start talking about their necks they can understand that."

ABOUT TOWN

The slaying of the Lindbergh baby
has aroused the entire nation and
the demand for punishment of the
perpetrators of the crime is the
most insistent in the annals of the
nation.
The crime is staggering in its
 enormity. It is inconceivable that
 anything but a field for the most
 perverted of creatures could have
 killed a defenseless child in such a
 cold-blooded manner and then de-
 manded ransom for his safe deliv-
 ery to the parents.
The sheer audacity of the act
 has completely staggered the imagi-
 nation of the world, and brought
 a widespread demand that officers
 bound the criminals to earth and
 exact punishment in proportion to
 the crime against humanity.

The murder is the crowning fea-
 ture of the wave of crime which
 has swept over the nation like a
 nightmare the last several years,
 and if it goes unsolved, unpunished,
 it will lend strength to the cause of
 the thousands of people who belong
 to the underworld element.
The law enforcement power of
 the nation will be put to a man-
 ual test in finding a solution to
 this case, and the search must
 continue relentlessly until the kid-
 nappers have paid the price.
The Pitt county school system is
 closing this week after a very suc-
 cessful term in spite of the changes
 effected by the passage of the new
 school legislation requiring reduc-
 tion of expenses in all depart-
 ments.
The taxpayers have been saved
 thousands of dollars in taxes, and
 indications count for anything they
 will be saved still more in years
 to come when the remainder of
 the ad valorem tax is lifted from
 land. The burden of course will
 have to be transferred to some
 other source, but it will enable the
 schools to continue efficiently,
 rendering the same high type of
 service to the children of the state.
North Carolina has made remark-
 able progress the last twelve years
 in the field of education, and it is
 proposed to continue going forward
 in spite of the unprecedented eco-
 nomic situation affecting virtually
 every power of the world.
Greenville city schools were not
 able to run but eight and a half
 months, but it is unnecessary to
 say that officials will use their
 every influence for the regular nine
 months' term next year.
Nobody desires to impair the
 efficiency of the schools in view
 of their splendid contribution to
 development in all fields of human
 endeavor, and Greenville and Pitt
 county will be the first to find their
 way back to normalcy in this line
 of achievement.

Hayman was born in Statesville, but his father, the late L. Hayman, moved to Charlotte while Felix was a small child. All his adult life was spent as a resident of this city.

About 25 years ago, Hayman opened a meat market here which has since been in operation continuously. He and Bud Moore, junior owner of the Hornets, took over the operation of the local baseball club in 1919.

The President Roosevelt is due in New York next Friday.

New York, May 14.—(AP)—Capt. George Fried of the United States Liner President Roosevelt, veteran of two of the most thrilling rescues of the sea in the last half dozen years, has achieved another laurel.

The veteran skipper and his equally famous chief officer, Harry Manning, launched a lifeboat 50 miles off the southernmost point of Ireland last night and picked up Lou Reichers, trans-Atlantic flier, out of a raging sea.

Reichers was approximately 180 miles from Dublin, the second stop of his attempted flight to Paris when disaster befell him.

Captain Fried's first great rescue was the crew of the British freighter Antioch in mid-Atlantic on January 27, 1926. It is one of the epics of Atlantic storms.

Captain Fried and his crew were awarded medals by King George and President Coolidge gave the navy cross to the captain.

On January 24, 1929, Captain Fried, then in command of the L. A. M. S. liner America, rescued the entire crew of the Italian steamer Florida just before it sank.

Premier Mussolini and the Italian government sent their thanks to the United States, and later awarded medals to the captain and eight members of the crew.

In November, 1930, Captain Fried brought his ship alongside the Swedish cargo steamer Ovidia, sinking off the Grand Banks of Newfoundland, but the Mauretania, which arrived shortly before the America, took off the twenty-seven men and one woman from the sinking ship.

Wired instructions from Washington started the hunt. They contained a meagre description of the

mysterious boat, but this was withheld.

Coast guard officers were not permitted to discuss the search.
