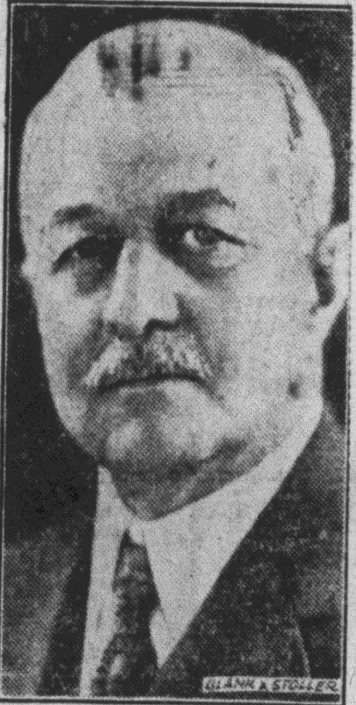

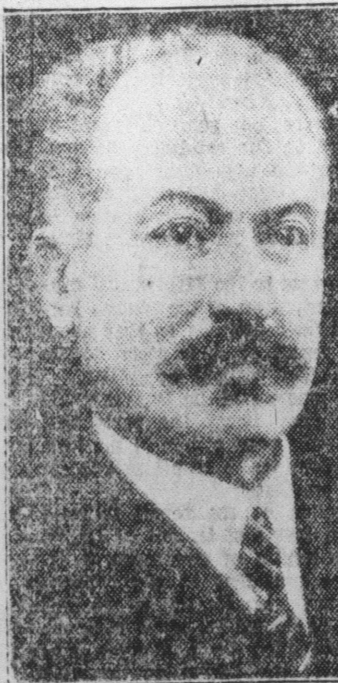

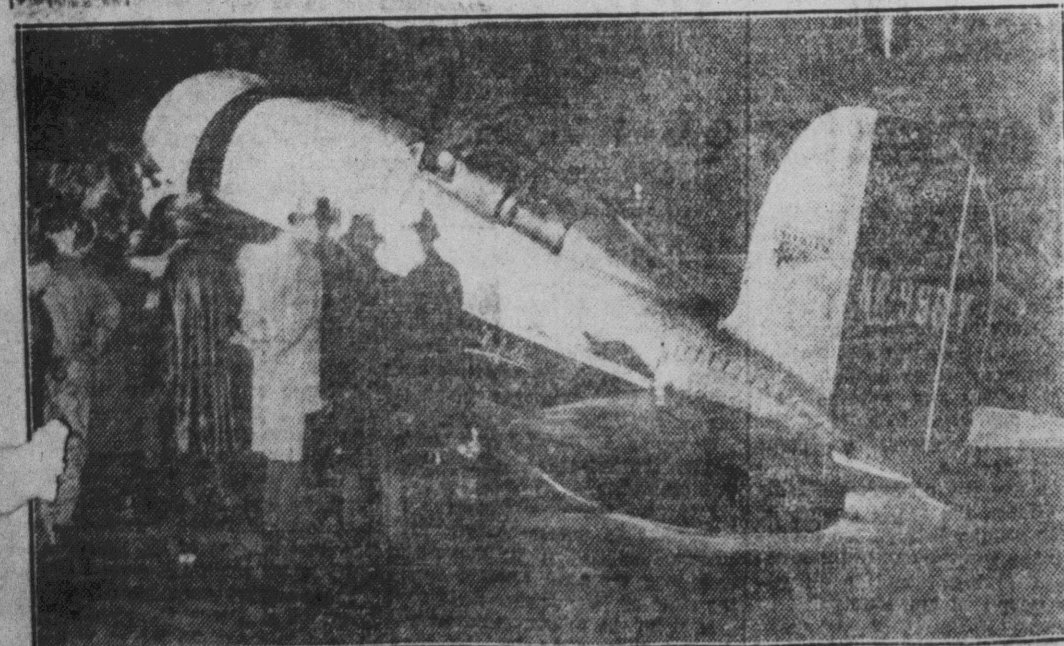

Mass in 31 Languages.

Vatican City-Folks in many countries heard the voice of the church in their own tongue. The Pentecostal ritual of the mass was broadcast in 31 languages from St. Peter's.

Washington's diction in others. Sixty years after the Sparks edition, Wrrington C. Ford brought out another 14 volumes, taken directly from the Washington manuscripts.

But as Washington left a larger number of papers than any other President, those editions, large as they are, contain less than 50 per cent of the whole, represented in 400 folders in the Library of Congress.

As pointed out by Dr. John C. Fitzpatrick, editor of this great compilation and noted authority on Washington's writings, "the lack of a complete publication of Washington's letters has made possible the clauderous belittlement of his character by present-day writers. . . In one way we are indebted to Sparks and Ford for the hundreds of biographies of Washington now available. . . The pity of it is, however, that most of the biographies, so unsatisfactory because of their lack of complete information, have been read with avidity by the American public and so have been responsible for the vast amount of existent misconception regarding Washington. . . It is not surprising, therefore, that one of our present day eminent historians, John Bach McMaster, should have stated that George Washington is an unknown man."

The present Bicentennial edition of the Washington Writings according to Dr. Fitzpatrick, is not only an honor to the first American, but will enable America to understand her own history more clearly, for the formative period of the United States is so enmeshed with the life of Washington that it is impossible to obtain a clear picture without full knowledge of George Washington the man himself, his personal as well as his public life.

The Bicentennial edition will now make this available. It will contain all the papers included in the Sparks and Ford editions, all the papers in the Library of Congress, besides many letters and groups of letters in the possession of various libraries, historical societies, state archives and private owners. In fact Washington papers have been found in every state of the Union and in nearly every country of the world.

The present Bicentennial edition was begun in 1930. The volumes, as ready, will be published by the Government Printing Office on 100 per cent rag paper, durably bound 500 pages to the volume, and each containing about 300 letters. Each volume will be separately indexed and foot-noted with names and records of all individuals referred to. In addition to the four volumes now ready it is hoped to have five or six others completed by the end of the Bicentennial year. . . The editing of this collection has been done by Dr. John Clement Fitzpatrick of the manuscript division, Library of Congress, editor of the George Washington Diaries. Dr. Fitzpatrick's entire life has been devoted to pure scholarship, and he stands foremost among authorities in presenting the facts of Washington's life as drawn from his own hand.

Call Attention to Parking Law for Fire Alarms

Police today called attention to the law requiring the parking of all automobiles and vehicles for five minutes when the fire alarm is sounded. Taking cognizance of the general rush for scenes of fire accompanying the sounding of the alarm, the police said accident and death would be avoided by close attention to the ordinance.

MARKERS ARE BARRED IN PRIMARY ELECTION

Use of markers in primary elections is specifically prohibited under the Australian Ballot act (section 26), stated Attorney General Dennis G. Brummitt in response to an inquiry from J. Crawford Biggs, chairman of the State Board of Elections.

"It is quite clear that markers are not to be appointed in the primary. It is also quite clear that no person should, on his own request, be permitted to assist a voter. Such assistance should be permitted only in and by the voter desiring the assistance," stated the Attorney General, citing the law which permits a voter to obtain aid only from an election official, a member of his family, or a person requested by the voter and approved by a majority of the election officials.

THE WRITINGS OF GEORGE WASHINGTON

The United States George Washington Bicentennial Commission announces that four volumes of the set of approximately 35 volumes of the Definitive Edition of the Writings of George Washington, are now ready for distribution. This publication of a complete collection of Washington's personal, military and state papers has been one of the major activities which Congress assigned the Federal Bicentennial Commission, as part of the nation's honors to Washington during this 200th year since his birth. Nothing like this comprehensive edition of the Washington writings has been attempted heretofore, partly because private publishing houses recoiled at the expense. Fifty years after Washington's death, Jared Sparks, then president of Harvard, issued an edition of 12 volumes, in which he omitted numerous passages and "improved"

Seeks Federal Tax Rebate for North Carolina

Nashville, May 16.—(AP)—Frank D. Grist, candidate for the Democratic senatorial nomination, suggested here today a rebate of 20 per cent of federal internal revenue collections to the state as a means of relieving the tax burden. After speaking here, Grist left for Raleigh where he is to speak tonight. Grist favored drastic curtailment of federal expenditures to meet the loss of revenue. Payment of soldiers bonus as advocated by him would not be a government expenditure because, he said, the process of payment would be that of refinancing an existing obligation so that payments due in 1945 to certificate holders would be made then to bondholders instead.

Fire Destroys Fleming St. Home

The home of Frank Langley, colored, on Fleming street, was destroyed by fire last night about 11 o'clock. The loss was estimated by firemen at \$1,500. The flames had gained such headway when the alarm was sounded that the building was doomed when the firemen arrived. The firemen confined their efforts largely to the saving of nearby property. The origin of the blaze was not determined.

Sustains Broken Leg in Wreck

James Starkey sustained a broken leg when the car in which he was riding collided with an automobile driven by Heber Green, colored fireman, at the intersection of Pitt and Fifth streets last night. Other occupants of the two cars escaped uninjured. The accident occurred as Green and another companion were making their way to a fire in the western section of the city. Both cars were severely damaged by the impact and the occupants suffered considerably from shock.

Island Observes Ancient Custom

Ocracoke N. C., May 16.—(AP)—Ocracoke Islanders today held another of their annual sheep-pennings. The event usually is staged the first Monday in May but this year it was postponed when it was found many lambs were late-born and it is primarily for marking new-born lambs that the penning is held.

But, along with the markings the old sheep are sheared and the two objects serve to make the day a festive one for the 700 inhabitants of Ocracoke Island who were rounding up today between 800 and 1,000 semi-wild sheep and participating in a general outing and picnic.

Captain George O'Neal is "captain of the pen" and he arbitrates any disputes that might arise between islanders over ownership of a lamb. The corral is a community affair, built and reconitioned each year from proceeds received from unmarked sheep which are born after the last penning.

The report will be made formally before the general assembly of the Presbyterian Church U. S., by its committee on closer relations, at Montreat, N. C., May 26. Although there is no difference whatever between the two churches in doctrines or methods of work, the committee report said, the two groups have agreed "to continue the status quo in cooperation till Divine Providence opens the way for still closer relations, in the meantime cultivating mutual esteem and brotherly love for each other in Christian fellowship."

The churches have had committees studying the matter of union for several years and have transferred congregations in sections unable to support two churches. The committee of the Presbyterian Church U. S., said "practical difficulties in the way" made further negotiations for organic union "inadvisable" at this time though there was a growing sentiment for the union between the churches. It was announced it had been found that the Associate Reformed Church had but one orphanage of its own and had some of its children in at least two of the Presbyterian Church U. S. orphanages. The publicity department's announcement said it was hoped that in orphanage work and in mission work the two churches may unite as another step toward bringing them together.

The committee on closer relations of the Presbyterian Church U. S. is headed by Dr. S. L. Morris of Atlanta, as chairman.

New York Cotton

New York, May 16.—(AP)—Cotton opened steady today at a decline of 2 to 4 points on small offerings in response to good weather in the south. July sold at 5.55. Traders were evidently inclined to await further developments in that quarter, while a continuation of the holidays in Liverpool and continental markets also tended to restrict business, and the market remained very quiet during the first half hour. The small initial offerings were sufficiently well taken to steady prices, however, with the market ruling about 3 to 4 points net lower.

Chicago, May 16.—(AP)—Decidedly higher prices for grain late today followed reports indicating that wheat yields in Kansas, Oklahoma, Texas and Colorado would fall much below expectations.

One expert estimated the Kansas wheat crop at 70,000,000 bushels or eighteen million less than the government may return, and compared with 240,000,000 harvested in 1931. A decrease of 4,183,000 bushels in the United States wheat visible supply was an additional bullish factor.

New York, May 16.—(AP)—The relentless wearing away of values in the stock market continued without important interruption today. The list rallied a little in spots after announcement of the reduction in DuPont's dividend, but the recovery soon faltered, as the general list showed no signs of following.

Rails were again conspicuously feeble. Union Pacific sold off four points, recovered two on the rally, but soon sagged again. Santa Fe common declined 21-2, recovered more than a point, then turned downward. The preferred sold at 48, off 7. Such issues as Eastman, Allied Chemical and North American temporarily recovered a point, after declining about 2. Such stocks as American Telephone, U. S. Steel, Bethlehem, National Biscuit, New Haven, New York Central, Southern Pacific lost a point or so. The case of six negroes under sentence of death at Scottsboro, Ala., has been the subject of agitation in quarters of this country and in foreign capitals. Indications today were that the appeal on behalf of the Supreme court was not expected to be filed until after it adjourns for the term on May 31.

Should the petition not reach the court in time for its action before its adjournment for the term, as now seems to be the purpose of counsel for the negroes, the execution scheduled for June 24 would have to be stayed if the court is to have an opportunity to decide when it meets in next October whether it will review the case.

Alabama's attorney general feels the state courts have no power to stay the execution further. That would make it necessary for counsel for the negroes in filing the petition after the term has ended, to try to obtain a stay order from Justice Cardozo who has supervision over the circuit in which Alabama is located. And—in case he should refuse—to attempt to obtain a stay from one of the other justices of the Supreme court.
