### Link Name of John J. Raskob With \$3,000,000 Stock Pool

#### OTHER NOTED PERSONS ALSO ARE REVEALED

#### William Gray, Committee Counsel, Tells of Market Activity at Senate Hearing

Washington, May 19.—(AP)—Profits in excess of \$3,000,000 from a poll in Radio stock in 1929 were ascribed to John J. Raskob, chairman of the Democratic National Committee, and other prominent persons as the Senate banking committee went ahead today with its investigation of the stock market.

Total profits from a 7-day pool in the Radio stock in 1929 were set at \$4,924,078 on an investment of \$12,683,000.

Among the others in the pool were W. F. Kenny, Mrs. M. J. Meehan, Walter P. Chrysler, Charles M. Schwab, Mrs. David Sarnoff and H. B. Swope.

The names of the pool members and their profits were read to the committee by W. M. Gray, committee counsel.

Raskob, Gray said, put up \$1,000,000 and made a profit of \$221,000. He said Schwab invested \$200,000 and made \$58,000.

Mrs. Sarnoff, wife of the Radio Corporation executive put up no money but participated in the profits, Gray said.

Kenny's investment was placed at \$1,000,000 and profit at \$291,000. This evidence was developed for the record while Thomas E. Bragg, Wall street trader, was on the stand.

Gray placed in the record a circular sent out by Meehan and Co., March 7, 1929, announcing formation of the syndicate.

Reading the list of those in the pool dealing through the firm of Hutton, Gray named Mrs. Bragg, as putting up \$300,000 and making a profit of \$116,684.

Percy A. Rockefeller was named as putting up \$75,000 with a profit of \$29,000.

J. A. Stillman was listed as making a profit of \$29,000.

Bragg, Bernard E. Smith and Percy A. Rockefeller were named as having a joint account.

The pool was operated through the firms of M. J. Meehan and Company and W. E. Hutton and Company, said Bragg adding "the actual buying and selling was through Meehan and Company."

Gray said the pool was organized March 7, 1929, and was closed out March 30, 1929, but its actual operation was between March 12 and 20; and "during those seven days they bought 1,493,400 shares for which they paid \$141,424,328."

Gray said \$10,000 was paid to J. P. Tumulty, secretary to the late President Wilson, who was not in the pool.

"Why was that paid?" he was asked.

"I don't know," Bragg replied. "The stock rose to a high of 109 1/4 on March 16. The pool began on the ebb and got out between March 18 and 20."

#### Lawyers Charge Solicitor With Not Pushing Case

Pittsboro, May 19.—(AP)—Charging Solicitor Clawson L. Williams was not cooperating with them, five private prosecution attorneys withdrew from the manslaughter trial of Mrs. J. K. Mason, Jr., in Superior court here and left the solicitor to represent the State alone today.

"We thought the solicitor was not presenting the case in the best light for the state," said A. H. Graham, of Hillsboro, candidate for lieutenant-governor and one of the attorneys to withdraw.

The others were Wade Barber and Dan L. Bell, of Hillsboro; J. Elmer Long, of Durham, and C. P. Hinchshaw, of Chapel Hill.

Solicitor Williams said none of the attorneys discussed the withdrawal with him and added that he was discharging his duty as required by his oath of office.

Arguments in the case were under way today. The charges against Mrs. Mason grew from an automobile collision several months ago in which Miss Stella Womble, of Carrboro, was killed.

#### Speaker Garner Presents Three Suggestions For Economic Relief Of U. S.

Washington, May 19.—(AP)—Speaker Garner today in formal statement made three suggestions to relieve the economic situation in the country and said he hoped the administration would cooperate with congress in enacting them into legislation.

His program called for the issuance of one billion dollars in bonds for a government building program broadening the base of the Reconstruction Finance Corporation to add one billion dollars to its present two billion dollar capital and passage of the Hudcison bill to place \$100,000,000 in the hands of President Hoover to be used in relieving "extreme suffering in any part of the country."

#### Anonymous Letter Gave Location of Baby's Body

Newark, N. J., May 19.—(AP)—The Newark Evening News said today that 10 days after the kidnapping of the Lindbergh baby Chief of police, William Walters of Trenton, received an anonymous letter directing police to "follow the Lindbergh telephone wires" and the baby and "the three other men" would be found.

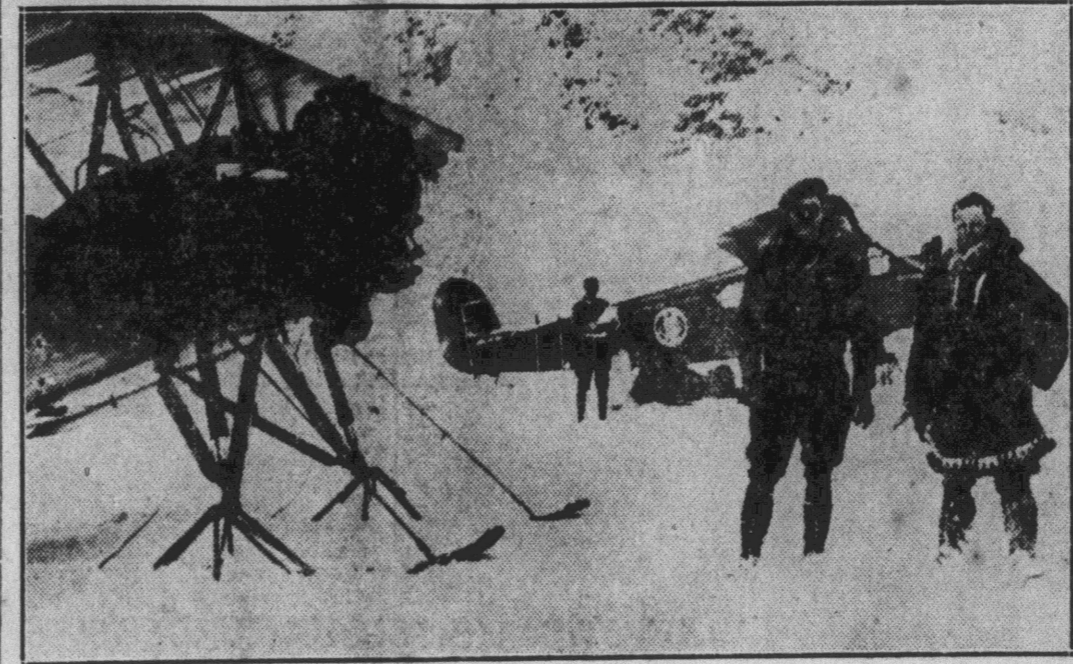
The body of the kidnapped Lindbergh baby was found a week ago today close to the main road from Hopewell to Princeton. Along that road ran special wires laid by police conducting the investigation from the Lindbergh garage.

Chief Walter wrote "attention" across the face of the letter, the paper said, and forwarded it to the police at Hopewell. He never received any report as to investigation of the letter.

The News said Chief Walter favored the theory that the letter might have been written by one of four men who kidnapped the baby. The text of the letter, as published in the News, follows:

"Mr. Chief:  
"I am writing this letter from New York. I am going home to Canada. When I get to Buffalo I will mail it to you. That will give me more time to safely escape. I figured I'm in enough trouble. I got cold feet and the fellows knew it. I promised not to squeal and they gave me money and I'm going home. (Continued on page six)

#### MANY SEEKING PUBLIC OFFICE

Over 2,500 Persons After Political Offices in North Carolina This Year

Raleigh, May 19.—(AP)—With indications that more than 2,500 persons will seek political office in the North Carolina primary June 4, the filing limit for all offices expires at midnight tomorrow.

Filing time for candidates seeking state and congressional offices expired a month ago but county and legislative candidates may file until midnight May 20.

Reports from almost every section of the state indicate the heaviest crop of office-seekers in the memory of oldest residents and the state and congressional ticket for the Democratic primary is the heaviest of record.

Many counties have 10 or more persons seeking a single office, with another filing day to pass, and in Wake county 19 persons are seeking the three legislative seats in (Continued on page six)

#### SCHWAB SEES BETTER TIMES

Steel Magnate Says Cost of Government Must be Cut Before Revival Occurs

New York, May 19.—(AP)—Charles M. Schwab today reaffirmed his optimism for the future but asserted that costs of government must be reduced and existing credit jams broken before business could revive.

In his semi-annual presidential address to the American Iron & Steel Institute Mr. Schwab, chairman of Bethlehem Steel Corporation, said "a most important prerequisite for the restoration of public confidence was the demonstration by federal and local governments that they can and will live within their incomes under stress of necessity."

"The federal budget must be balanced in order to protect our national credit," he said "and in view of the vastly depleted ability of the public to pay, it must be balanced chiefly through the measure of reduced expenditures."

"The steel industry, he declared has put its own house in order and the Federal Reserve System is doing its part.

#### JAFSIE BUSY; TRIES TO REST

Key Man in Lindbergh Case Kept Moving in Spite of Doctor's Orders to Rest

New York, May 19.—(AP)—"Jafsie" spent a busy morning today trying to get started on the rest his doctor has ordered him to take.

With "Al" Reich, former national amateur boxing champion, driving his car, the elderly key man in the Lindbergh baby murder investigation, emerged from his small house in the Bronx in the middle of the forenoon and drove first to the jeweler's store where he frequently stops to have his watch regulated.

Two New York City detectives followed in another car. After a brief stop at the jeweler's store they proceeded to a Bronx police station, where they stayed half an hour (Continued on page six)

#### PREMIER OF JAPAN BURIED

Simple Buddhist Funeral Held for Suoyoshi Inukai at Tokyo Today

Tokyo, May 19.—(AP)—A simple Buddhist funeral service, attended by 500 of Japan's leading public men who crowded into the public hall of the premier's residence today marked the nation's farewell to the late Premier Suoyoshi Inukai, slain last Sunday by a group of young assassins.

The Selyukai party, which the slain premier headed during the last two and a half years of his half century in Parliament, conducted the funeral services.

These consisted merely of the reading of messages extolling the virtues and services of the deceased. The general public did not participate in the funeral ceremonies and there was no procession.

#### Americans Menaced By Bandit Horde In China

Nanking, May 19.—(AP)—The safety of 60 Americans, most of them missionaries, was threatened today at Pengpu by a host of 20,000 Chinese communists which was overrunning northern Anhwei province.

Pitt County Young Women to Face Final Test for County's Healthiest Girl Soon

The four healthiest 4-H Club girls in Pitt county were selected at the Pitt County Department of Health today after which they had their picture taken and returned home to face another contest early in June to determine "the healthiest girl in the county."

The winners today were: Misses Arlene Harris, 18, Stokes; Doris Nichols, 16, Arthur; Melva Nobles, 15, Stokes; Edwina Baker, 17, Farmville.

The winners were among twelve chosen to compete for the final health contest here today out of a field of 533 embracing young women in every section of the county.

The final test was given at the Department of Health this morning under direction of Dr. R. S. McGeachy, assisted by Dr. Louis Skinner, Dr. Tom Watson and Dr. Robert H. Wright Jr.

In view of the fact that the four young women tied for honors, they will be required to return for a final examination early in June, at which time the winner will be decided.

House Rules Committee Postpones Action on Patman Bill Until Monday

Washington, May 19.—(AP)—The House rules committee today deferred until Monday action on the Patman resolution calling for full payment of the soldiers' bonus.

Representative Patman, sponsor of the full cash payment of the adjusted service certificate by the issuance of new money, said he would file a petition to force it out of the rules committee if action was not forthcoming soon.

Patman's bill was reported unfavorably by the ways and means committee and members of the committee have said there was no precedent for it to grant a place on the legislative calendar to measure which had the disapproval of a committee.

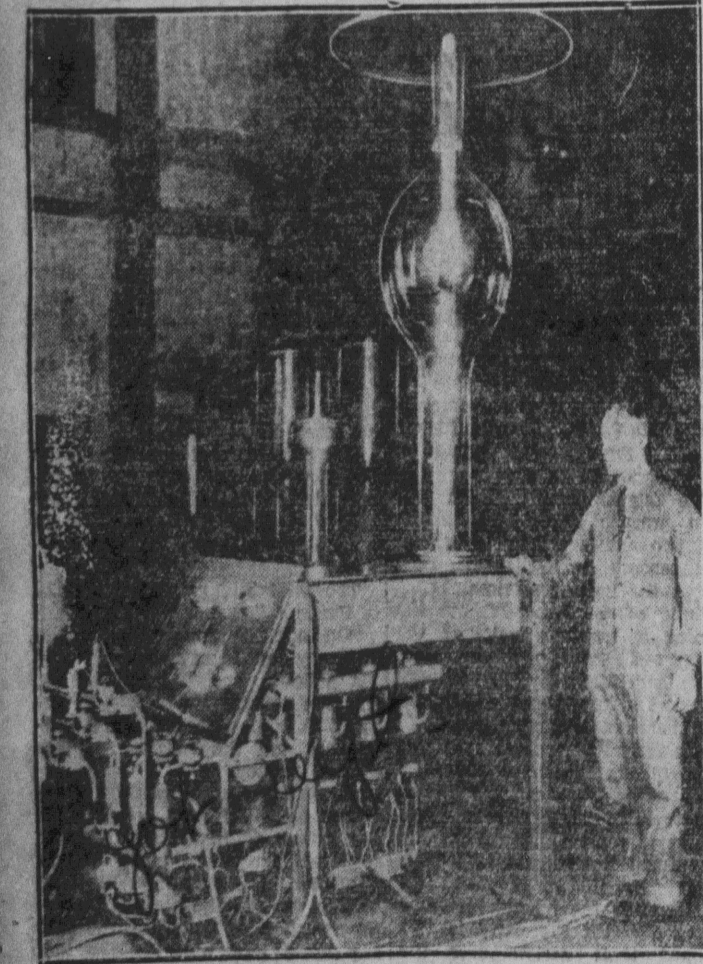

## The Meaning Of the Poppy

In the year of 1918 spring came just as it has come this year. The grass and trees put on their green, flowers pushed up their heads and the world felt a rebirth of life and energy. But that year spring had a different meaning. It means that the vast armies which had been facing each other in entrenched lines in France and Belgium would open great spring offensives. Instead of bringing renewed life, Spring that year brought a renewal of wholesale death.

We doubt if any of you remember that horrible spring of 1918. Those who lived through it can never forget. Our newspapers told us the story of the terrible death and destruction which daily took tremendous toll as the armies staggered back and forth across northern France in the great continuous battle which ended the war. Cable messages from France told us daily of a fresh list of American boys who had given their lives. Our soldiers when they returned did not like to talk about it. It was too terrible, ghastly, ugly. They wanted to forget.

But there was one thing which the men who came back did talk about—one thing of beauty and tenderness which they like to remember. This was the poppy.

Poppies grow wild in France, and Belgium like daisies in this country. They continued to grow wild along the battle front when almost every other form of life was blasted out by the continual pounding of the massed cannon of both armies. They grew over the graves of the dead, the only floral tribute which the gallant young men who laid down life for country received. The poppies still grow about the graves of the American boys who are buried in the war cemeteries in France and each year at the time of Memorial Day paper replicas of the French poppies are worn in this country in memory of the dead.

Memories of the dead always bring thoughts of those men who were not killed but who came back wounded and shattered in health. For many of them fate would have been kinder if their lives had been taken outright. They were strong young fellows when they went out to fight for their country. When they came back they were worn wrecks of men unable to do the work and play which makes life worthwhile. More than 30,000 of them are still spending long, tedious days in government hospitals, struggling to recover their health or waiting for death to release them from their suffering.

The dimes, quarters and dollars which are dropped into the coin boxes on Poppy Day go to help these men and to help their families and the families of the dead. By buying and wearing a poppy you are honoring the war dead and at the same time serving the living victims of the war.

That little flower which pushed itself up so bravely amid the desolation of the battle front in the spring of 1918 has thus become a means of reducing the suffering resulting from the war. Each year the women of the American Legion Auxiliary sell millions of poppies to the patriotic people of America to wear in honor of the dead and every penny of the money received is expended for the welfare of the disabled and the families of the dead and disabled. It is a wonderful thing that this simple little flower which cheered the soldiers in France can bring so much cheer and happiness into the lives which were blighted by the war. When you see the poppy being worn this year remember what it means—a tribute to the memory of the dead and a service to the unfortunate living.

### JUNIOR WOMAN'S CLUB'S GIFT TO LIBRARY

The Sheppard Memorial Library has recently been presented a valuable collection of books as an annual donation by the Junior Woman's Club.

The books are appropriately marked with bookplates bearing the seal of the club. They are exceptionally well chosen, dealing with a variety of subjects of particular interest to women. They were selected by Miss Jesse R. Moye, sponsor of the club.

An extract of a report on these books given by Miss Moye at the Saturday meeting of the Junior Woman's Club follows:

"Historic Gardens in Virginia"—by Edith Tunis Sale, in collaboration with the James River Garden Club—a companion volume to "Interiors of Colonial Homes in Virginia," by the same author, which volume the club has just recently given to the library. These books are exceptionally fine, having great historic as well as literary and aesthetic value. They are handsomely bound in buckram and are printed in large type on a fine quality of paper. They contain over three hundred illustrations.

"Beautiful Gardens in America"—by Louise Shelton—a book that should be in every garden enthusiast's library. It is a rare beautiful volume, bound in pale green linen, with frontispiece and five plates in color, and about two hundred photographic illustrations, which have been chosen with great skill and care. It is an extraordinarily vivid revelation of the development of garden making in America.

"Landscaping the Small Home"—by Edward Oliver—an excellent manual for the small property owner who is interested in creating an outdoor living room for his home. Here will be found in understandable language sound advice on how to frame the front of the home with beautiful trees; how to have a correct foundation planting; how to fence the property with a living screen of attractive flowering shrubs; how to plan the perennial shrubs; how to plan the perennial little rock garden; in fact, everything one needs to know in order to create a beautiful little park within the confines of one's own property, including many complete planting plans to fit varying situations, adaptable to the average city or suburban home.

"Flower and Vase"—by Anne Lamplugh—an attractive blue linen bound book, which deals in a most delightful and helpful manner with the art of arranging flowers. The author has not catered to extravagant tastes that demand rare flowers but rather to those who arrange flowers which grow in their own gardens or who spend modest sums in purchasing flowers in season. This book should be of great interest and benefit to all who like to have flowers about the house. There is one chapter on the "Art of flower arrangement in Japan," where priests and philosophers, as well as young ladies of the aristocracy, have been taught the art as a serious occupation. Professor J. Sukuki is the 18th hereditary head of the Soami school of flower arrangement (founded in the fourteenth century).

"The Poems of Emily Dickinson"—a centenary edition of the works of the reclusive New England girl (1830-1886). Mr. Conrad Alken in his recent anthology of modern American poets calls Emily Dickinson's poetry "perhaps the finest by a woman in the English language." An extract from the conservative "London Spectator" says: "Some of the greatest poems written since Sappho. They are extraordinary as biography, magnificent as literature! The more I read them the more unreserved is my enthusiasm." Interest in her work on both sides of the Atlantic is greater than ever before.

"A Few Figs From Thistles"—by Edna St. Vincent Millay—a book that will give lasting pleasure to all who care for real poetry. No living writer occupies a position comparable to that held by Miss Millay, in the affections of a great reading public and in the esteem of critics of literature. Thomas Hardy said not so long ago, that there were two and only two great things in the United States—the poetry of Edna St. Vincent Millay and our "recessional buildings."

"Great Pictures of Europe"—by Thomas Munro—a selective guide and critical survey of the main types and traditions in the history of art. It is arranged according to the countries, cities, galleries and churches, where important pictures may be found. It contains one hundred full page illustrations. Each of these is critically analyzed in detail, as well as other paintings not illustrated. Examples not only of the European masters and schools, such as the Florentine and Dutch, but of the less familiar primitive and exotic types, as ancient Roman, Byzantine, Chinese and Persian are included—all distinctive and important for a broad appreciation of art.

"Elements of Public Speaking"—by Ruth Bryan Owen. From the foreword by William Lyon Phelps: "This book is the result of much observation, much reading, much experience, and much reflection. Its suggestions are eminently sensible, its illustrations from history, impressive and its style clear and forceful. Mrs. Owen has had prolonged and varied experience as a public speaker. She has lectured to

hundreds of audiences in every part of the United States. She has mastered her art by practicing it. The public platform has become an integral part of the life of America. Public speaking, no longer confined to a limited number of orators, has become the property of business men and women, fraternity brothers and club women. ABOUT TOWN

The Senate turned a cold shoulder to the proposal for legalized beer yesterday and the measure was voted down by an overwhelming majority.

The vote shows conclusively that advocates of beer might as well turn their attention to other plans for forcing the adoption of their proposal. If the Senate should refuse to adopt beer as an aid in settling the short tax bill it may be said with certainty that chances of getting it through by other means are slim indeed.

The Senate members realize that the preponderance of opinion in this country is for continuance of prohibition and that the legalizing of beer would be the first step toward the denaturation of the body in turning down the beer proposal was in accordance with the desire of that great mass of people who believe that sobriety is the salvation of the nation and hope to be able to prevent the wets from gaining the slightest foothold.

Upward revision of tariff dates would work a great hardship on countries suffering from the effects of money shortage, in the belief of Robert O'Brien, member of the Tariff commission.

He might have added that it will also work a great hardship on this country already suffering from the effects of loss of trade from foreign countries because of the tariff barrier.

The administration may plan for the return of better conditions as much as it likes but this will not occur until the tariff wall is lowered and other countries are given a chance of buying our products as they did when no such barrier had been placed in their way.

The House Judiciary committee has approved the Cochran bill providing the death penalty or life imprisonment for kidnapping, and it is believed it will complete the ride through congress in short order.

A few states have enacted legislation to this effect, but others, having never been troubled with this kind of crime, deal in varying degrees with cases of the kind.

If the proposed legislation is passed by Congress it will become nation-wide and persons convicted of kidnapping will have to pay the penalty.

This kind of crime is gaining ground at this time and if drastic action is not taken to improve the situation it is impossible to determine the scope which it will assume.

After being defeated in every game of the season, East Carolina Teachers college baseball club managed to nose out a close decision over William and Mary Tuesday.

The victory was greeted with joy by members of the student body who have supported the club in an admirable way during the first season of baseball in the college's history.

With their appetites whetted, the Collegians are expected to make a more determined try for honors next season and fans are assured of a brand of ball they will be proud of.

Coach Ralph Deal didn't expect to "set the woods afire," at the beginning and in confidence his boys will come out with greater honors to their credit next season. Some of the losses this season were attributed to hard luck, and barring the jinx, there is every indication that the school has a good future in the offing.

The state fire loss dropped off perceptibly during the month of April compared with the same period last year and it is hoped the same condition will prevail during May.

While a few cities showed a gain over the previous year, the majority reflected a decided reduction and this no doubt will cause them to cling to the record during the remainder of the year.

State firemen are doing everything in their power to improve the

situation and if the public will take advantage of the advice sent out from time to time regarding the elimination of hazards it will be reduced.

Greenville's loss last year was the largest in several years by reason of two warehouse fires, involving loss of nearly \$200,000, and while the loss is gradually rising firemen believe the situation will be more favorable this year.

The public should make an effort to co-operate in every way possible and aid the firemen in their effort to safeguard both life and property.

POLICE PRESS PLANS FOR QUESTIONING MINISTER AS TO HIS PART IN THE CASE

(Continued from page one) see any of the actual ransom notes, nor the signature on them. In fact it was the request of Col. Lindbergh for actual truth of his contacts with the kidnapers that, to have Mr. Curtis bring from his alleged kidnapers, a letter of communication bearing the signature known to be that of the kidnapers."

New York, May 19.—(AP)—Assistant District Attorney Ralph K. Jacobs of Kings County, Brooklyn, announced today he had sent out two detectives to find Mrs. Mary G. Ford, Brooklyn public school teacher, and "bring her in for questioning in connection with the Lindbergh kidnaping and ransom payment."

Mrs. Ford, Jacobs said, was absent today from public school 67, Brooklyn, where she teaches. He said he told the detectives to proceed to 33 Riverside Drive, Manhattan, where he said she rented an apartment two weeks ago.

Jacobs said he was informed Mrs. Ford paid \$100 for a month's rent, in advance, with \$20, \$10, and \$5 bills.

He sent for her, he said, on information given him by the public school authorities and after questioning the principal of the school where she teaches.

Jacobs said he questioned Frederick Schoedel, principal of the school this morning, and that Schoedel made the following statement:

"Several weeks ago a telephone call for Mrs. Ford came to the school. A man asked for her. We said we couldn't call her to the telephone during school hours, whereupon the man said:

"This is Jafise, of the Lindbergh case."

"Our clerk said he didn't believe him. The man insisted, saying: 'This is Dr. Condon, I'd like to speak to Mrs. Ford'."

"We broke the rules and called her to the phone. We heard her speak of a meeting. When she hung up, she turned around and said:

"That was my sister's doctor. He wants to make an appointment with me."

Jacobs said Mrs. Ford on Tuesday was held in \$3,000 bail on a charge of having attempted to swindle Mrs. Ann Laughlin of Richmond Hills out of \$1,800. School officials investigating this matter, he said, started an investigation of Mrs. Ford along other lines.

"It was found," he said, "that two weeks ago she had announced she was ready to settle a \$40,000 action that was pending against her."

"They said they checked on her absences from school and found she had been away from February 25 through March 1.

"We also found that in 1914 she pleaded guilty to grand larceny in Brooklyn and was given a suspended sentence."

Flemington, N. J., May 19.—(AP)—Rumors were current today that attempts were being made to secure bond for John H. Curtis, Norfolk jailed yesterday for hoaxing the bereaved Lindberghs.

No confirmation of the rumors could be obtained. The bail under which Curtis is held is \$10,000.

New York, May 19.—(AP)—Reference in the Lindbergh confession of John Hughes Curtis to two men not fully identified were cleared up today.

In explaining his claim he had been offered money for his "knowledge of the Lindbergh case or pictures of the baby," Curtis said:

"Mr. Twin and Fox offered me money."

Although the identity of the Mr. Twin was not known immediately, the "Fox" reference was generally interpreted as referring to the Fox Film Company. The Fox Film Company is in no way involved and this correction is emphasized.

Today Sam Fox, a Norfolk photographer, said he had acted for a news photograph syndicate in offering Curtis \$2,500 for exclusive pictures of the Lindbergh baby, or enabling him to photograph the baby before anyone else.

To which, he said, Curtis re-

plied: "It is hard for me to say at this time what I can do."

P. E. Turin, manager of the advertising board of the Norfolk-Portsmouth Chamber of Commerce said he had made no offer to Curtis, but that the shipbuilder had broached to him, as manager of the Norfolk-Portsmouth news bureau, suggestions of remuneration for information concerning his negotiations.

Princeton, N. J., May 19.—(AP)—Edwin B. Bruce, friend of John Hughes Curtis who frequently appeared on the scene during the Lindbergh baby negotiations which Curtis has confessed were a fake, left for his home in Elmira, N. Y., today.

Before he departed, he remarked to a clerk in the hotel where he and Mrs. Bruce have been staying: "While this kind of business makes me feel sick, I am glad I was able to be of some assistance to Col. Lindbergh himself."

He did not explain the statement.

Philadelphia, May 19.—(AP)—The Philadelphia Bulletin today says that although there is no proof that he knew John Hughes Curtis, who confessed to hoaxing in the search for the Lindbergh baby search, federal agents are searching for Samuel Vernekoef, of this city, for questioning in connection with the case.

Curtis in one of his statements relating to the search, later branded untrue by him, mentioned the name of "Sam" as the man who first gave him information about the kidnapers.

The Philadelphia man who the federal agents are said to desire to question was not at home when inquiries were made there, the Bulletin says, but was in New York, according to his wife. She said that so far as she knew, he never had any dealings with Curtis, and said she felt certain he did not know Curtis.

Seeks Removal of S. C. Sheriff

Union, S. C., May 19.—(AP)—The county grand jury, asserting Sheriff John C. Greer failed to keep a promise "to reform," has again signed a petition asking Governor Blackwood to remove the county peace officer.

The first request was made in April when the grand jury charged the sheriff with "habitual drunkenness," "grossly immoral conduct," and with ill fame.

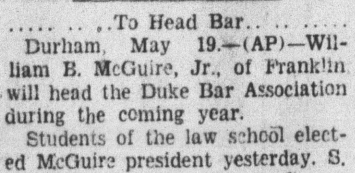

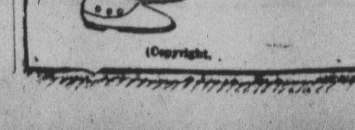

# Yanks Beat Cleveland And Gain American League Lead

## BRUINS GRAB FIRST PLACE IN NATIONAL

Returns from the year's first inter-sectional strife were at hand today, and the only outstanding beneficiaries of the movement appeared to be the Chicago Cubs in the National League, and the New York Yankees in the American.

By sweeping all nine engagements with the invaders from the west, the Yankees had passed Washington and are in first place. The Cubs, winning eight of twelve from the National League's eastern delegates, likewise entrenched themselves at the top.

Cincinnati's Reds, with nine wins and five losses at home, and the Philadelphia Athletics, with seven victories against four defeats, were the only other teams to show a substantial profit.

Washington failed to attain its standing at the expense of the visiting western clubs. Losing their last four straight to St. Louis, the Senators wound up with an even break in ten games and a game and a half out of first place as they faced the Yanks in a double-header at the stadium today.

The Yankees terminated their remarkable streak of nosing out Cleveland, 3 to 2, on the strength of Babe Ruth's smash into the bleachers in the tenth inning in so doing, they became the first team in American League history to capture 14 straight games at home.

Washington bowed to the Browns 11 to 7, in a slugfest that produced 3 hits and used up four Washington pitchers.

Lefty Grove's pitching and home runs by Fox, Dykes and Simmons featured the Athletics' parting gift at Detroit. The score was 8 to 2.

Smead Jolley's hittin helped the Boston Red Sox break a six-game losing streak at Chicago's expense 13 to 10.

Bill Clark, Brooklyn southpaw, checked in with the day's best performance in the National League when he beat the Pittsburgh Pirates 4 to 2, on four hits. Lefty O'Doul smashed a triple, a double and a single for Max Carey's crew.

A big seventh inning in which they scored seven runs and knocked St. Johnson from the park gave the New York Giants a 9 to 3 victory over Cincinnati. Bill Terry topped off the seventh inning up-rising with his ninth homerun of the season.

Charley Grimm continued his batting rampage as the Cubs took their final from the Phillies, 6 to 4. Three singles ran the veteran first-sacker's record to nine hits in the last three games. Chuck Klein gave the Phils three of their runs off Guy Bush when he drove one out of sight with two on base.

Led by Wally Berger, who walloped a double and three singles, the Boston Braves defeated St. Louis, 5 to 3. The veteran Tom Zachary held the champions to five hits.

Atlanta, Ga., May 19.—(AP)—Several southern conference track and field stars will try for "double" victories in the annual meet here Friday and Saturday but it is unlikely any will approach the triple clean-up effected by Ed Hamm of Georgia Tech in 1928.

Hamm, later an Olympic star and now coach at his alma mater, set conference records in the 220-yard dash and the broad jump and equalled the 100-yard time. He ran the furlong in 21.4 seconds and the century in 9.2 seconds and broad jumped 25 feet 6.3-4 inches. His jump mark has never been threatened but it is possible that his times for the dashes may be bettered this season. Several sprinters have shown faster times in the spring dual meets.

Charlie Farmer of North Carolina has been credited with a 21-second furlong and a 9.8 second hundred and Bronie of Duke has stepped the shorter race in 9.6 seconds and the furlong in around 22 seconds.

New York Cotton

New York, May 19.—(AP)—Cotton opened steady today, unchanged to 4 points off on selling promoted by the easiness in cables.

Offerings were not heavy but there was some scattered selling or liquidation which was absorbed by a little trade buying and covering within 2 to 3 points of yesterday's closing quotations on the more active positions.

The weather map attracted favorable comment as it showed rains in eastern belt sections supposedly in need of moisture, but trading continued quiet with July contracts ruling around 5.67 and December 6.05 at the end of the first half hour.

Liverpool reported an inactive market with prices lower under hedging and Bombay selling. The Liverpool market will be closed from today until next Monday morning, owing to the Whitsunday holidays.

Grain Market

Chicago, May 19.—(AP)—Increased strength in wheat values developed today, especially in the late dealings and after reports of enlargement of crop deterioration, effecting Indiana, Illinois and Missouri.

Urgent need of heavy general rains followed by cool weather was emphasized by crop authorities. Hessian fly damage reports from Nebraska tended also to stimulate wheat buyers.

Stock Market

New York, May 19.—(AP)—Inertia continued to rule the stock market today, with prices maintaining a fairly good undertone.

Tobacco and utilities, along with a few miscellaneous issues, had a period of heaviness in the morning but the list recovered substantially after midday. The market was sluggish, however, that price movements were not regarded as of much significance.

In the tobacco's, American Tobacco "B", Liggett and Myers "B", and Lorillard lost a point or two, and failed to recover appreciably. In the utilities, North American, Consolidated Gas, Pacific Gas and Electric, and Consolidated Gas got down a point or so, then recovered partially.

Charles M. Schwab's analysis of the steel industry before the American Iron and Steel Institute, in which he pointed out that the five leading companies fell about \$25,000,000 short of earning bond interest and other charges in the first quarter, was rather gloomy, but he pointed out that companies have substantial business on their books which await only the necessary financing.

Trial of Means Set for June 6

Washington, May 19.—(AP)—The trial of Gaston B. Means on charges of larceny after trust and em-bezzlement of \$104,000 in an al-leged Lindbergh ransom fraud was set today for June 6.

The former Department of Jus-tice agent is accused of obtaining the money from Mrs. Edward B. McLean, estranged wife of the Washington Post publisher, on false representations that he could re-trieve the Lindbergh baby from his kidnapers.

Justice James M. Proctor decided on the date after Leo A. Rover, U. S. attorney, asked for trial on the day previously set—next Monday—and after Means' lawyer urged June 20.

Means was not in court. He is at liberty under \$50,000 bail.

(Continued from page one) ing home. "Maybe I won't get caught. We all thought we could make some easy money. We got a place near Elizabeth, N. J., and one of the fellows who is pretty smart runs a wire to this place and listens to everything the Lindbergs say.

"He must be smart because every time the telephone rings he picks up the receiver and never talks. When he hands up the receiver he always says 'I never knew I was so smart.'

"The Lindbergh baby is taken very good care of and is feeling fine when I left the fellows only it cries too much and the fellows are afraid somebody will hear it. Nobody will hurt it because they all like it. The baby has lots of toys and a small black dog. The fellows don't want no more ransom.

"They are all sorry and afraid. There is three more left now. We already stayed in this place eight weeks. I must soon catch the train. I love the Lindbergh kid. I don't want to see him hurt.

"I don't know where is the name of the street or the road, but not far from Elizabeth, N. J. When we took the crib we road 55 minits and not very fast because somebody would see it.

"I quit the fellers because they don't agree. Follow the Lindbergh telephone wire and you will find the baby and the three fellers. The fellers were pretty nervous.

"If I did not like the baby I would not write this, but if you want the baby and the fellers you must keep this secret. These fellers have a radio and read plenty news-papers. If you catch the fellers and the baby will you let me go free."

The letter was signed simply "Thank You." It was printed with pencil. The paper was blue-lined and of a cheap grade. The letter was postmarked Buffalo, N. Y., March 10 at 6:30 a. m. he printing was similar to that on a postcard mailed from Newark a day or so after the kidnaping.

AMERICANS MENACED BY BANDIT HORDE IN CHINA

(Continued from page one) Pengsu said they doubted the com-munists would be able to capture the city, but the apprehension was acute.

The Chinese government rushed troops to Pengsu last Monday at the request of the American legation. Three thousand troops were sent from here and another division from Soochow. Apparently it was this force which was reported sur-rounded by the greatly superior force of communists.

The communists, who have been plundering wide areas in Anhwei, Honan and other provinces in central China, caused a general exodus of foreigners and Chinese alike from these territories.

Most of the missionaries al-ready have left northern Anhwei province and only one of them, H. S. Ferguson, a Canadian attached to the China Inland mission, was captured. He was taken at Cheng-Yangkuan, 60 miles southwest of Pengsu May 16.

W. W. Moore, of Charlotte, N. C., an American member of the same mission had not been captured as late as yesterday when he tele-graphed from a village near Cheng-Yangkuan saying the situation was precarious but he was remaining to assist Ferguson, his Canadian colleague, although he did not know where the latter was being held.

I continue to have hope and belief in our future because I have lived so long and have seen our people work their way out of so many trying situa-tions. In this country we have great resources and a great heri-tage. We are all of pioneer blood, whether recently or generations back. The pioneer spirit is daring, devout and industrious. Such a combination cannot permanently be downed. Not fearing the future, ready to face every issue, and de-termined to fight for what we be-lieve, we are on the path toward equilibrium."

The desire to see his wife and home again became overpowering. He returned to Pennsylvania and early this month sent Mrs. Fague "ransom letters" from Reading, Bloomsburg and Plymouth. Tuesday he decided to go home, he said, and taped himself up to give credence to his story of having been kid-napped. Authorities said no charges would be made against him.

(Continued from page one) "They're trying to get him to go and look at some more rogues gal-ery pictures, but he doesn't want to," Reich said. "The doctor wants him to take a little vacation, and we're trying to get him started on it."

A messenger boy with a telegram awaited him when the tall, scowp old man—known as Dr. John P. Condon in the Bronx, but as "Jaf-sie" to the rest of the world—en-tered the driveway of his home.

His daughter knocked on an up-stairs window and then came run-ning out to talk to him, as he scanned the telegram. He accompanied her back into the house.

Fifteen minutes later he emerged again and, after apparently driving about aimlessly for a few minutes, his car and the car containing the detectives returned to the police station.

"Mrs. Condon is half dead with worry over this business," Reich remarked. He did not say whether Mrs. Condon was "Jafsie's" wife or a daughter-in-law. She has not been mentioned before, and it was gen-erally believed Dr. Condon was a widower.

Norfolk, Va., May 19.—(AP)—Di-rector of Public Safety Charles B. Borland today said full investiga-tion revealed that John H. Curtis reached Norfolk on April 2, the day "Jafsie" paid a \$50,000 ransom to the supposed Lindbergh kidnap-ers in a Bronx cemetery.

Borland said Curtis left New York four days later in an automobile for Philadelphia, where he was met by Lieut. George L. Richard, naval pilot, who was frequently used by the Norfolk "negotiators," on aero-plane flights during the "enormous deception" which Curtis carried out. Richard flew Curtis to Norfolk.

The Norfolk official declined to say whether he attached any sig-nificance to the information he had gathered. New Jersey police an-nounced today that there was nothing that would in any way link Curtis with the actual kidnapper of the Lindbergh baby or the collection of the ransom money.

Garner said he was "unalterably opposed to the dole, but it must be apparent that before congress ad-justs some real effort must be made toward taking care of the unemployed situation as well as the people who are in physical dis-tress as a result of lack of food and rainfall."

"Ever since Congress met in December," Garner said, "it has

been discussing and undertaking to pass legislation that would be help-ful in relieving the present dis-tressing economic conditions. Some far reaching legislation has been placed upon the statute books.

"I have been hopeful that these legislative efforts would tend to bring about better conditions, but the facts are that the unemploy-ment and distress of the people are greater now than when congress was organized last December."

(Continued from page one) in the party convention. He had today 428 votes exclusive of 100 from New York and Penn-sylvania which, while disputed, his managers expect him to receive.

Tomorrow and Saturday forty more delegates will be chosen in Ten-nessee, Oregon and Nevada, with prospects he may get them all. This would run his claimed total of delegates selected by the end of the week to 538, ten shy of the ma-jority. This does not mean nomi-nation as a two-thirds vote is re-quired.

President Hoover's walkaway candidacy gathered 23 more dele-gates yesterday from Alabama and Vermont, taking him to within six votes of the Republican nomi-nating mark on pledged votes alone, excluding hundreds of unattached but friendly delegates.

Two states in the party conven-tions yesterday acted on prohibi-tion. Vermont Republicans sought resubmission before the year's end. Vermont Democrats declared for repeal, with light wines and beer in the meantime. South Carolina Democrats defeated a referendum proposal by the closest vote had in that state since prohibition be-gan and declared for a campaign on "economic issues" alone.

So far Democrat groups of a dozen states have spoken for re-

peal or resubmission in some form: New York, Iowa, Maine, Minnesota, Washington, Michigan, Illinois, North Dakota, Rhode Island, Wy-oming, Montana and Vermont.

Five have lined up for enforce-ment or have defeated wet plans: Georgia, Missouri, Nebraska, Kan-sas and South Carolina. Seven states avoided all mention: Ken-tucky, Arkansas, Oklahoma, Louis-iana, Arizona, New Mexico, and Connecticut.

Six Republican groups have called for repeal or resubmission, ten have taken the dry side or have defeated wet plans and 17 have made no mention of prohibition.
