Mystery Sources Probed In Baby Murder

Norfolk Preacher Says He Will Not Make Trip To Hopewell For Quiz

GANGSTER TO BE QUESTIONED

Man Who Said Before Body was Found that Lindbergh Baby was Dead Sought by Police for Aid in Running Down Murderers; Dr. Condon Appears Before Grand Jury Again; Relatives Seek Bond For Curtis.

Hopewell, N. J., May 20.—(AP)—State police disclosed today that they are still investigating the whereabouts of John H. Curtis, jailed Norfolk hoaxer, on the night of April 2, the night that Dr. John F. Condon paid a \$50,000 ransom in futile hope of obtaining return of the Lindbergh baby.

It is known that Curtis came to New York from Norfolk on April 2 but his actions and whereabouts at all times on that day and night have not been definitely established. The statement that the investigation of this phase of his case was still going on came as a considerable surprise, however, as Col. H. Norman Schwarzkopf, head of the state police, announced yesterday that Curtis had been absolved of any connection with the kidnapping or collection of ransom.

Col. Schwarzkopf, in his bulletin today also took cognizance of a published report that Curtis' activities might have been part of a run-running plot.

Col. Schwarzkopf said that all of Curtis' associates, including those with whom he was associated prior to the Lindbergh baby kidnapping, will be questioned by investigators.

Hopewell, N. J., May 20.—(AP)—Balked in renewed efforts to induce Rev. H. Dobson-Peacock to come here for questioning, police hunting the kidnaper-murderers of the Lindbergh baby sought help today from two mysterious sources.

One of these was a "known gangster" who was understood to have said in Maryland before the body was found that the baby was dead.

The other mysterious matter under investigation to determine if there was any connection with the Lindbergh case was "the recent attempted King kidnapping," not more specifically described by police for fear of hindering the investigation.

While these investigations were going forward, Dr. John F. Condon who as "Jafsie" paid a futile \$50,000 ransom to supposed kidnappers of the Lindbergh baby, told a Bronx county, N. Y., grand jury how he handed the money through a cemetery hedge in a suitcase.

John Hughes Curtis, confessed Norfolk hoaxer, remained in jail at Flemington, N. J., as relatives in Virginia prepared to obtain his release by raising the \$10,000 bail in which he is held for grand jury action.

Police let it be known that they were still very anxious to confront Curtis with Dean Dobson-Peacock, who was associated with him in negotiations for return of the baby which Curtis admits were all faked.

In his morning bulletin Col. H. Norman Schwarzkopf said he would gladly pay the minister's traveling expenses but the dean replied in Norfolk that he had been advised by counsel not to come here.

MECKLENBURG DAY OBSERVED

Charlotte Celebrates the Signing of the Declaration of Independence

Charlotte, May 20.—(AP)—Charlotte's school bells failed to toll today, and the wheels of industry stopped turning, in memory of a band of pioneers which 157 years ago gathered on what is now Independence Square and defied the authority of King George III.

It is Mecklenburg county's Fourth of July. May 20 is the reason why Charlotte is the only town in America which does not celebrate July 4. The descendants of those pioneers ask "why celebrate the Philadelphia Declaration of Independence when we had one a year before?"

And then tales are told of how the Mecklenburgers dispatched word of their action to the Continental Congress asking it to do likewise, and of how the courier, after his weary journey, was rebuffed with talk that their act was premature.

But the Caldwell, Davidsons and Alexanders today claim their Scotch ancestors were not premature, but merely ahead, of their Puritan and Dutch countrymen to the North, who waited more than a year to follow the lead.

This evening the event will be commemorated with ceremonies at Independence Park, two miles from the site of Old Mecklenburg courthouse, in the heart of Charlotte, where the declaration was signed.

In addition to the May 20 drills and speeches, Dr. A. R. Newsome, secretary of the State Historical Commission, will deliver an address in observance of the George Washington bicentennial year.

To Recommend Jonas' Successor

MAKE REVISED CROP ESTIMATE

Cotton Production for 1931 Given by Agriculture Department as 17,096,000 Bales

Washington, May 20.—(AP)—Revised estimates of the 1931 cotton crop announced today by the Department of Agriculture place production at 17,096,000 bales of 500 pounds gross weight, and 500 bales of 17,095,594 equivalent 500-lb bales, as reported by the Census Bureau, compared with 13,932,000 and 13,931,597 for the 1930 crop.

The area in cultivation July 1 last year was 41,189,000 acres and the acreage was 40,693,000 acres, compared with 46,078,000 and 45,091,000 for the 1930 crop.

The yield of cotton picked per acre was 201.2 pounds, compared with 147.7 pounds for the 1930 crop. The acreage and yield estimates for the United States are each about one-half of one per cent above the preliminary estimates made last December, an adjustment of one per cent in total production being necessary to make the estimate conform with the total quantity ginned.

The yield per acre of 201.2 pounds is the highest realized since 1914 when the yield was 209.2.

The department said deficient moisture or drought was responsible last year for only 8.3 per cent reduction in yield. Boll weevil damage in 1931, while somewhat greater than the previous year, was less than average and relatively unimportant.

The total reduction from a full yield of cotton from various causes was estimated at only 27.8 per cent of a normal or full crop. In 1930 this was reported at 47.1 per cent.

CIVIL COURT OPENS MONDAY

Three Hundred Cases on Calendar for Two Week Term of Superior Court

A two weeks' term of Pitt county Superior court, for the trial of civil cases, will convene in Greenville next Monday morning with Judge E. H. Cranmer, of Southport, presiding.

The calendar contains approximately three hundred cases of more or less importance to people throughout the county as well as in other communities. Two hundred cases which have been hanging fire for several months will be called the first day, and those failing to answer will probably be non-suited. It is an effort on the part of the court to relieve the congestion which has held sway the last several years, and will be the first time in history that such a large number of cases have been called in a single day.

The action is expected to bring about considerable activity among plaintiffs who have been slow in pushing their cases to completion and the courtroom was expected to be crowded the first day.

OWEN YOUNG HEADS BODY

Committee Hopes to Meet Demand From Many Quarters for More Drastic Action to Stimulate Recovery of Prices; Possibility of Extending Credit to Farm Loan Banks to Aid Agriculture

New York, May 20.—(AP)—A new move to put hundreds of millions of idle dollars to work was started today by a powerful committee of bankers and industrialists under the chairmanship of Owen D. Young.

The group was called together by George L. Harrison, governor of the New York Federal Reserve Bank, to make the Federal Reserve's policy of credit expansion effective and in answer to a demand in many quarters for more drastic means of stimulating a recovery in prices.

It was pointed out that in spite of the fact that the Federal Reserve System has purchased \$725,000,000 of United States Government securities, releasing funds capable of supporting \$7,250,000,000 of bank credit, the deflation of bank loans and investments has been unchecked. Fear and uncertainty on the part of banks and the investing public alike have prevented the Reserve's policy from taking its full effect.

By the formation of the new committee, financial authorities hope to find the means for bringing together the vast surplus of idle funds in the banks and the many worthy projects in need of credit that exist throughout the country.

Members of the group said after their organization meeting yesterday that nothing sufficiently definite had been arranged for them to be able to comment upon their program. Financial leaders suggested, however, that one possible avenue of credit expansion lay in loans to building and loan societies by the large commercial banks, answering a demand for credit for financing of small homes.

Another possibility suggested was the extension of credit to farm loan banks in order that these institutions might more freely grant accommodation to the agricultural districts.

Washington, May 20.—(AP)—Secretary Mills said today the formation of committees of bankers and industrialists in all Federal Reserve districts similar to that announced in New York to secure more active cooperations between bankers and industry and business is considered an outcome of the New York movement.

GARNER PLAN GETS PRAISE

Three Point Suggestion for Economic Relief Warmly Commended by House

Washington, May 20.—(AP)—Hundreds of communications poured into Speaker Garner's office today endorsing the three point relief program he proposed yesterday and which was warmly received by both Republican and Democratic members of the House.

Indications are the \$2,100,000 program will be incorporated into one bill and referred by Speaker Garner to the House ways and means committee.

Colleagues of the Texas Democrat believe that he plans to expedite House action and lay the bill before the Senate in less than two weeks.

Buried under dissenting ideas as to how the government should go, the proposition had been more or less stalled until Speaker Garner yesterday advanced his plan.

Garner called for two billion increase in reconstruction funds and \$100,000,000 appropriated without strings, for the use of the president in relieving sharp distress wherever it might exist.

Besides this being a gift proposal, opposed by Mr. Hoover in principle, it appeared unlikely he would care to take on the task of apportioning the sum among clamoring states and cities. However, Representative Snell, Republican leader, was favorable to the Garner plan as a basis to getting something "worked out."

ARREST FOUR BANK BANDITS

Men Who Robbed Ipswich, S. D., Bank of \$21,000 Captured in St. Paul

St. Paul, May 20.—(AP)—Four men who robbed the Bank of Ipswich, S. D., Wednesday, shot the president, kidnapped the cashier and fled with \$21,000 loot, were arrested and confessed to the police today.

The quartet was apprehended yesterday after an automobile accident in St. Cloud, Minn. Chief of Police Thomas A. Brown said the men described themselves as Reinhold Engel, Sidney Raycraft and Phil Ray.

WOMAN ACQUITTED ON MANSLAUGHTER

Pittsboro, May 20.—(AP)—A Chatham county jury has acquitted Mrs. J. K. Mason, Jr., of Durham, of a charge of involuntary manslaughter which grew out of the death of Miss Stella Womble, of Carrboro, in an automobile accident.

A \$100,000 damage suit is pending in Orange county against Mrs. Mason for the death and injuries received by others in the wreck.

The jury reached its verdict yesterday after 30 minutes deliberation. Five members of private prosecution counsel withdrew from the case at the conclusion of state's evidence, claiming Solicitor Clawson L. Williams was not cooperating with them. They were A. H. Graham, of Hillsboro, J. P. Long of Durham, C. P. Hinchshaw, of Chapel Hill, Wade Barber and Dan L. Bell of Pittsboro.

Rocky Mount Man Found Dead in Gas-Filled Room

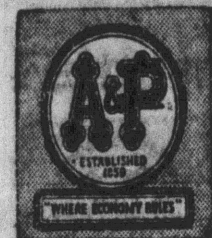

Cotton Spinning Shows Decline

Washington, May 20.—(AP)—The cotton spinning industry was reported today by the Census Bureau to have been operated during April at 70.7 per cent capacity, on a single shift basis, compared with 90.1 per cent in March this year and 94.3 per cent in April last year.

Spinning spindles in place April 30 totaled 31,945,758 of which 23,409,246 were active at some time during the month, with the average on a single shift basis being 22,591,689, compared with 31,024,032; and 23,843,808 for March this year and 33,057,118; 29,405,404 and 31,172,123 for April.

Washington, May 20.—(AP)—For the first time in American cotton spinning history Massachusetts has relinquished her supremacy in the number of cotton spindles in place in her mills.

North Carolina was shown today by the Census Bureau's monthly spinning report to have 1,653 more spinning spindles in place on April 30 than Massachusetts. North Carolina had 6,192,323 as compared with Massachusetts' 6,175,664.

Massachusetts has shown a decline in the number of her spindles since 1922 when her high point was reached with a total of 11,998,216. To April this year there has been a loss of 5,822,552 spindles.

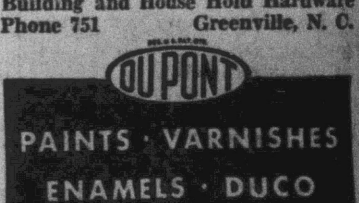

The four young women who tied for the honor of being the healthiest girls in the county here yesterday are to be congratulated upon their splendid showing.

Three are bound to lose in the final examination in June to determine the winner but the rest should be consoled in the fact that thousands of people throughout the world would give everything they have to be accorded such an honor.

Health is the best possession in the world, and the over five hundred young women who took part in the first elimination series should do everything possible to protect their physical being in future years.

It is to be hoped the Pitt county queen of health will be able to capture honors at the district contest in Washington in June for she will then be awarded the distinction of going to Raleigh to compete for state honors.

Pitt county is proud of the showing made by the representatives of the 4-H clubs and hopes they will enjoy the splendid physical condition throughout life.

Greenville firemen have been praised for their assistance in the Grimesland fire Tuesday night. The mayor and board of aldermen of the town expressed their appreciation of the quick response to the call for aid when three homes were destroyed and the entire town was threatened with destruction.

Greenville always stands ready to respond to appeals for aid of this kind and surrounding towns may rest assured of the best of service when they are threatened by the fire demon.

Much destruction has been wrought by fire in this county the last two years and the public is urged to take every safeguard possible in cutting down the toll during the remainder of the year.

This can be done by elimination of hazards both in business and residential districts, and it should be the object of the housewife and business man to see that this is attended to.

With over 2,500 candidates running for office in North Carolina in the forthcoming primary, the people will have the largest field to choose from in the memory of the oldest inhabitants.

The severe financial situation affecting the country is believed to be largely responsible for the influx to the political arena and it should result in the choosing of some mighty able men for the hundreds of posts to be voted on.

By causing a great demand for certain kinds of stocks they boost prices as high as they can and then sell out leaving the bag for the small investors to hold. This is a condition that should be remedied. It is not fair to the people and will do more to cause the public to lose confidence in market values than anything else to be imagined.

(Continued from page one) a quarter with the Bronx grand jury, telling in detail of this ransom payment. Before testifying he signed a waiver of immunity.

New Jersey detectives assigned to stay with him had expected to visit more roguish galleries in Jersey this afternoon but when he came out of the grand jury room the aged educator told them he had to go to New Rochelle, N. Y., to conduct an examination of teachers. The name of Mayor James J. Walker was injected into the case today in a story in the Evening Post. The paper quoted an advertisement in a morning paper reading "Citizen—Guarantee absolute confidence, Jimmy." It said it had learned on high authority that Mayor Walker had received a letter promising information about the Lindbergh case if safety for the writer could be assured.

Previously the minister had said that he did not have time to make the trip and that incident had been advised not to go. After a telephone conversation with Col. Schwarzkopf, in which he said he told the New Jersey official that he could not leave for a day or two and probably not at all, Dean Dobson-Peacock sent a telegram in which he revealed his decision not to make the trip. He expressed willingness, however, to be questioned here.

The telegram follows: "Replying to your telegrams of yesterday I stand ready at such time as you may select, to meet at Norfolk your Governor Moore's accredited representative, and will fully and freely give all information in my possession pertaining to the subject."

Dean Dobson-Peacock, who has stated that he is willing to be questioned, but will not go to New Jersey for that purpose, spoke emphatically in refusing the offer from Hopewell. "Colonel Schwarzkopf has my answer to that already," he said. "I have my legal advisers, and I have been advised not to go to Hopewell. I have already given my answer to Colonel Schwarzkopf."

Judge's Calmness Prevents Panic

Hertford May 20.—(AP)—Recorder W. H. Oakley's calmness during court here probably saved a number of lives when the floor of the room began to give way during a session.

The court room was crowded when, in the midst of a trial, the floor began to creak and sag. Many of the crowd rushed out and made for the lower floor but Judge Oakley kept his seat admonishing the spectators to file out slowly.

When the room was cleared, inspectors found two braces had broken under the floor of the room being used temporarily for court while the main courtroom is undergoing repairs.

Judge Oakley continued all cases until Tuesday when the old room is expected to be completed.

Caldwell Must Face Court Again

Nashville, Tenn., May 20.—(AP)—Rovers Caldwell, former investment banker, must show cause in Federal District court here why he should not be removed to Louisville, Ky., for trial of Federal charges in connection with failure of the National Bank of Kentucky.

The order making the provision was part of a decision handed down by U. S. District Judge John J. Gore yesterday. No date was set for the hearing. Caldwell's conviction for fraudulent breach of trust in David son county criminal court recently was reversed by the State Supreme court.

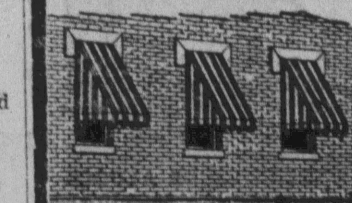

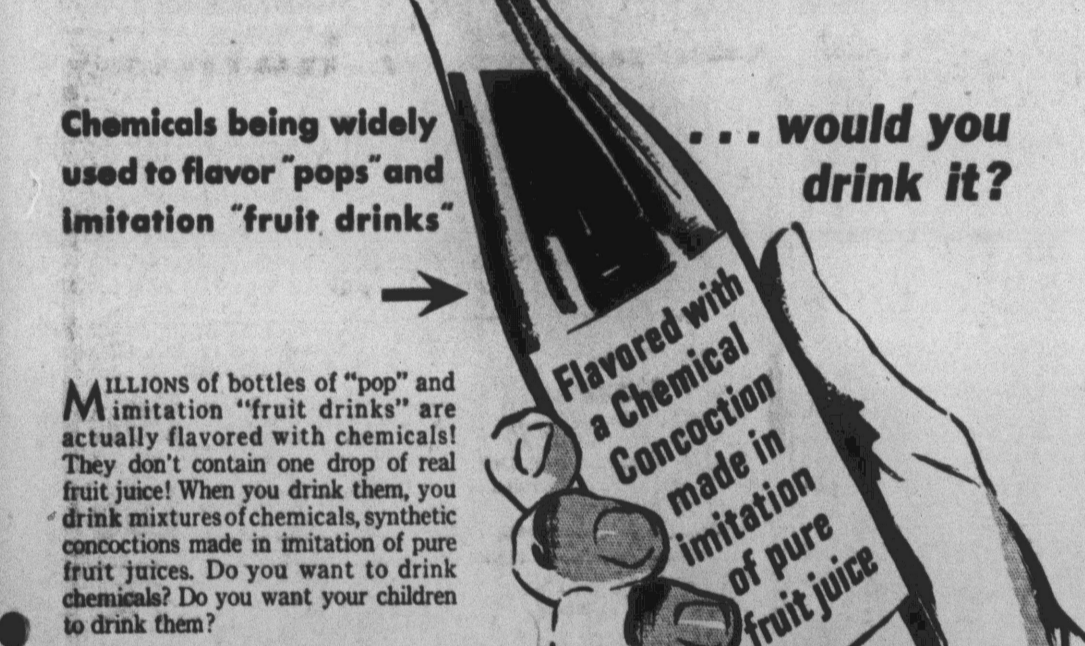

Smith Will Not Seek Old Post

Montreat, N. C., May 20.—(AP)—Dr. Ebert W. Smith, for the last 20 years executive secretary of the Southern Presbyterian church's committee on foreign missions, announced that he will not be a candidate for re-election at the meeting of the general assembly here next week.

CURTIS' HOAX CONFESSION

Statement of John Hughes Curtis, 704 Hedge Avenue, Norfolk, Va., made by my own hand and own free will.

Referring to the two statements I made previously by me in regards to the Lindbergh Case.

At the present time I am sane, but I honestly believe that for the last seven or eight months I have not been myself, due to financial troubles.

I was apparently brought back to my senses by my telephone conversation with my wife this afternoon when she told me of the troubles she was having and how the children missed me, also by my conversation with Inspector Barry W. Hale.

I desire to state that my remarks about the newspapers are true and can be verified, this is in reference to my story about Mr. Haskell and Mr. Hillier of the World Tribune, Mr. Lee of the News and Mr. Turin and Fox, offering me money of my knowledge of the Lindbergh case or pictures of the baby.

Whenever I was brought to my attention during a conversation and due to that I now believe was a distorted mind by brooding over it, I became sane on the subject for the time being, which caused me to create the story in its entirety, which were untrue in every respect.

I never knew such people that I named as Colonel Lindbergh and they were creatures of a distorted mind, with the exception of Morris Truesdale, who had no connection with the crime.

I exceedingly regret that I caused Colonel Lindbergh and others many inconveniences and wish it were in my power, to correct my wrong.

In justice to my wife and two children I trust that it is in the power of Colonel Lindbergh to forgive the inconvenience, worry and injustice I did him in his time of grief.

This statement has been brought about by the realization of the wrong I have done.

ported favorably today by the Senate agriculture committee.

The committee made only minor changes in the wording of the measure as presented by the National Grange, the National Farmers Union, and the American Farm Bureau Federation, which agree upon the measure.

The measure authorizes the Farm Board to put into effect any one or combinations of the three plans when considered necessary to assist agriculture.

The vote was not announced by Chairman McNary.

Assurance of production costs of the portion of crops domestically consumed is the basic aim of the bill.

The Farm Board would be charged with employing any or all of the three plans and would continue until it considers its operations no longer needed.

The measure provides for marketing agreements with cooperatives to permit withholding of commodities from market on payment to those organizations of the cost of impounding.

After estimates of probable losses, costs and charges to be met under these agreements, the board would fix the equalization fee, which would be collected as prescribed by the board either on processing, sale or transportation of the commodities.

The expert debentures would be issued by the treasury to farmers, cooperative or other producers on shipments abroad and would be one half the duty on imports, except on the following which the bill fixes:

Corn or maize 7 1/2 cents a bushel; cotton two cents a pound; tobacco two cents a pound.

To prevent increasing the production of debenture's commodities, the board could reduce debenture rates.
