MRS. AMELIA EARHART PUTNAM LANDS IN IRELAND

First Woman To Cross Atlantic Alone Forced Down By Gas Leakage

WAS IN AIR BUT CAPT. ENDRES DIES IN CRASH

Red and Gold Monoplane Landed in A Field at Culmore, Ulster, Ireland, at 8:30 A. M., (E. S. T.); "I've Done It!" Wife of New York Publisher Exclaims As She Steps From the Plane; Wires Husband of Safety.

Culmore, Ulster, Ireland, May 21.—(AP)—Amelia Earhart Putnam brought down her red and gold monoplane in a field on the Donegal side of Lough Foyle this afternoon and thereby became the first woman ever to fly the Atlantic alone.

She landed on this side of the ocean five years to the day after Colonel Charles A. Lindbergh arrived at Le Bourget, France, successfully completing the first solo flight across the Atlantic.

"I've done it!" Mrs. Putnam exclaimed when she got out of her ship.

She had intended to go to Paris but it was necessary to cut the flight short because her exhaust manifold had burned out and the gasoline gauge was broken, causing a gas leakage.

The 17th blonde flier, who took off from Harbor Grace, Newfoundland, at 4:51 p. m., (EST) yesterday, got a lift by motor to Londonderry, five miles away, where the first thing she did was to get on the telephone to report her success to London in order that her husband, George Palmer Putnam, New York publisher, and her friends back home might know that she was safe.

Her plane was not damaged in the landing and she was unhurt. "For a lot of the way," Mrs. Putnam said, "I was flying through storms—mist, rain and a little fog. To my friends in New York I want to send this message:

It was 2:30 p. m. (8:30 a. m. EST) when Mrs. Putnam landed here. She had made the trip of 2,028.5 miles in fifteen hours and thirty-nine minutes.

All Britain and France had been waiting eagerly for news of her, special interest centered on the fact that today was the fifth anniversary of the flight of Colonel Lindbergh, to whom attention had been directed anew by the tragic death of his child.

When Mrs. Putnam had reported that she was safe, she got into an automobile and left Londonderry for an unannounced destination.

"I am very glad to have come across successfully, but I am sorry indeed I did not make France. "I am going to speak to my husband as soon as I can by the Atlantic phone."

It was the flier's second airplane trip across the Atlantic. Back in June, 1928, before her marriage to Mr. Putnam, she made the crossing that time as a passenger.

"There is no comparison," she said in reply to a question about which trip she liked better. "On this I was flying low the whole time and had to rely on myself. "I am afraid I am a bit deaf after the terrible roar of the engine in my ears all the time, but at any rate I have done it."

AFTER COTTON SALES UNITY

George Sloan Says Co-operative Sales Effort Necessary To Success of Industry.

Atlanta, Ga., May 21.—(AP)—Sales cooperation is recommended to the cotton industry by George A. Sloan of New York, president of the Cotton-Textile Institute, Inc., as a way out of its business wilderness.

He spoke here last night before the American Cotton Manufacturers Association and predicted the cotton industry would be among the first to "enjoy the light of day."

The speaker described development of 900 uses for cotton from road building to clothing and interior decoration.

Merchants, he said, have made strides in promoting use of cotton but the manufacturer should offer every cooperation since he has a larger interest at stake than his customer.

ROOSEVELT IS TRY TO SPEED UP CONGRESS FOR HARMONY

Friends of New Yorker Attempting Now to Bring Tranquility to Party.

Warm Springs, Ga., May 21.—(AP)—The friends of Gov. Franklin D. Roosevelt, increasingly confident a majority of delegates will be pledged to his nomination as the Democratic Presidential candidate at the Chicago convention, are stressing party harmony.

Tennessee Democrats yesterday pledged their full twenty-four votes to the New Yorker and reports of this action along with assurances South Carolina and North Carolina were likely to fall in line has resulted in added optimism at the Roosevelt vacation cottage here.

Governor Roosevelt gave no direct comment, but it was made known that party harmony still was considered a most vital factor in pre-convention activities. "There has been a definite movement toward effecting such an end.

Assurances regarding South Carolina's eighteen votes were brought to the Roosevelt cottage by Claude N. Sapp, of Columbia, chairman of the state committee, who headed a visiting delegation. It was he also who forecast North Carolina likely would support Roosevelt.

PRES. HOOVER BOOSTS CREDIT

Hopes to Ease Up Financial Situation Among Worthwhile Enterprises.

Washington, May 21.—(AP)—President Hoover has started a country-wide movement to get business bankers, industrialists, and others together to start credit flowing once more into constructive enterprise.

The program is to apply the New York banker-businessman committee plan to each federal reserve district. The governors of the reserve banks have been asked to step out in organizing the groups.

When all are formed it is Mr. Hoover's intention to call the chairman to Washington so as to coordinate the entire program "on a national basis."

Bank Receiver Sues Bondsman

Winston-Salem, May 21.—(AP)—Charging that Taylor M. Simpson, cashier of the now defunct Peoples' National Bank here, loaned H. W. Spough more than 10 per cent of the bank's capital, in violation of federal statute, W. H. Spradlin, receiver for the bank, has filed suit against the United States Fidelity & Guaranty Company, Simpson's bondsman, for \$25,300.

The complaint alleges Spough obtained a loan of \$29,800 when the bank's capital was not more than \$175,000.

TWO FILE FOR COUNTY BOARD

T. E. Joyner and R. T. Cox Seek Seats On the Board of County Commissioners.

Two men prominent in the business life of the county have filed notice of their candidacy for the Board of County Commissioners, subject to action of the Democratic primary in June.

They are T. E. Joyner, of Farmville, present member of the board, and R. T. Cox, of Winterville.

Mr. Joyner was appointed to the board three years ago to fill the unexpired term of the late Dr. W. W. Dawson, of Grifton. He was then re-elected to serve for the usual term of two years. He is one of the best known business men of Farmville, and prior to entering county affairs had served as city clerk of Farmville, which eminently fitted him to carry on in administrative affairs of the county. He has gained the reputation as one of the best commissioners the county ever had during his term, and is seeking re-election on his record of service.

Mr. Cox is head of the Cox Manufacturing Company, for years the main enterprise of the Winterville community. He is the son of the late A. G. Cox and has been prominent in the affairs of his community and county for many years. He is well qualified for the office to which he aspires, and promises to render the highest type of service to the people if elected.

Big Crop Of Candidates Set For N. C. Primary

Raleigh, May 21.—(AP)—Two weeks from today thousands upon thousands of North Carolinians will cast ballots to nominate public officers to serve them for the next two, four and six years.

From every part of the state comes word of an unusually large number of candidates listed for almost every office at stake.

MAN THOUGHT TO HAVE HAD PART IN PLOT

Object of Search Has Long Been Connected with Liquor-Running Activities in the State of Maryland.

Hopewell, N. J., May 21.—(AP)—Search was intensified today for the mysterious gangster, believed to be connected with the Lindbergh baby kidnapers, who recently said in Maryland before the baby's body had been found that the tot was dead.

Col. H. Norman Schwarzkopf, superintendent of state police, disclosed for the first time yesterday that this gangster was being sought and today he gave him first mention in his morning bulletin.

"Investigators who are seeking the whereabouts of the gangster reported in Maryland and thought to be connected with the case," he said, "have been unable to locate him as yet and are continuing their investigation."

That part of the morning bulletin dealing with matters other than the search for the gangster, follow: "Dr. Condon (the Jaisie who paid a \$50,000 ransom for return of the murdered baby) was taken to New Rochelle (yesterday) by our investigators to look over the criminal rogues gallery in an effort to identify the man known as John, but failed to make any identification."

"Joseph Perrone (the taxi driver who took a note from the supposed kidnapers to Dr. Condon instructing him about ransom payment) had formerly looked over the criminal rogues gallery in New York City and failed to identify anyone and yesterday he went over the gallery at the central bureau of identification at the state police headquarters in Trenton, but failed to make an identification. He will be taken to another police department today.

"The King kidnapping case (a mysterious case thought to have possible connection with the Lindbergh case mentioned for the first time by Schwarzkopf yesterday) was gone into by our investigators yesterday, but no information of value could be ascertained."

Baltimore, Md. 21.—(AP)—A man long identified with New Jersey liquor running activities was disclosed today as the "mysterious gangster in Maryland" sought for questioning in the Lindbergh kidnaping case.

The man who remained unnamed, informed Arthur Mills, identification expert at the Maryland hours of correction, that the body of the kidnapper child would be found within five miles of the Lindbergh estate two days before it actually was discovered.

Mills, formerly a member of the Maryland state police, said the rum runner further informed him that the baby had been killed by blows on the head, and that the body had been hidden near the flier's home.

"I didn't pay any attention to it at the time," Mills said, "but later when I read that the body had been found, I communicated by information to Colonel H. Norman Schwarzkopf of the New Jersey police. Two officers came here yesterday to investigate.

Miss Clarkson to Wed Virginian

Charlotte, May 21.—(AP)—Miss Margaret Clarkson, daughter of Associate Justice Heriot Clarkson of the North Carolina Supreme court, and John Garjand Pollard, Jr., eldest son of the Governor of Virginia, will be married in St. Peter's Episcopal church here tonight.

The Right Reverend Joseph Blount, Bishop of North Carolina, will perform the ceremony assisted by the Rev. Thomas Simons Clarkson, brother of the bride.

Miss Clarkson will be attended by Miss Fannie Bryan Alken, of Brunswick, Ga.

WHAT'S IMPORTANT BUSINESS

With the time for the coming primary expired, all speculation as to who will be running has been definitely removed and from the list of those registered the people of our county must choose those men who are to fill our public offices and administer our public affairs during the next two years.

While all of our elective offices are important and should be filled by the best possible men, in our opinion at this time the most important offices to which our county must elect men this year are our three seats in the State General Assembly and our Board of County Commissioners. It is the General Assembly that enacts the laws governing this and other counties in the state and that body should be composed of men with ability and farsightedness to recognize that their job is one of great importance to our people and to fill their offices with the view to taking care of the welfare, present and future, of our citizens as a whole.

Even more important, locally, is the Board of County Commissioners, for it is this branch of our government that must administer the affairs of our county to the best interest of all our people. In selecting men for this important body our people should consider our county as a business with an actual money value in property of more than forty million dollars and the men chosen should be qualified to administer the affairs of the county as much so as if they were being selected for directors of a forty million dollars business corporation. Men chosen for this important post should not only be good citizens of highest character but should possess recognized business ability to administer the county affairs.

With just two more weeks before the day on which the citizens of our county must choose at the polls the men for these important posts we bring this matter to their attention, feeling that at such critical times as these we should not be dealing in cliques, clans or personalities, but should each as individuals pick out from the available candidates the best possible men according to their recognized ability to carry on our public affairs.

ABOUT TOWN

A three-fold plan for relief of agriculture has been approved by a Congressional committee, and if it ever gets any further it may be the farmers will eventually be able to get a few dollars from the government.

The county has heard more about farm relief the last two years than it ever heard before, but the more they talk about it at Washington the poorer the farmer seems to get.

What we really want is not quite so much talking and planning but actual results. The nation is over-run with plans for aiding various branches of industry, and about the only good that has been done came through the Reconstruction Corporation, and that isn't anything to brag about in public.

Had it not been for the Democrats in Congress, prominent members charge, the farmer would not have received any relief from the measure. President Hoover was wild about relieving industry, but the only form of industry he has ever been able to see is that directed by the "big boys" sitting behind glass-topped desks in New York, raking millions off of every attempt they make in behalf of the "poor working man."

In an effort to improve its services in this community, the Salvation Army from time to time is bringing some of its leading workers here to assist in the extended program.

Bootleggers are becoming more wary of the law in and around Greenville and not as many are falling into the hands of enforcement officers. Several arrests, however, for violations of this kind have been made recently and they will continue to be made as long as men and women remain in the business.

All candidates for governor are against sales tax proposals such as those considered by the last General Assembly, and apparently are ready to fight any effort tending to inflict such a burden upon the people.

The new plan to put millions of idle dollars to work will be received with general satisfaction, but what the people want more than all else, is to see the circulation get in motion. The nation has heard lots about easing of the monetary situation the last several months, but if that has been accomplished not many people know anything about it. What the nation needs is money within reach of every individual willing to work for it and when this condition occurs, the prosperity Mr. Hoover has been talking about so long but which has never come, will surely begin to show its face around the bend in the road.

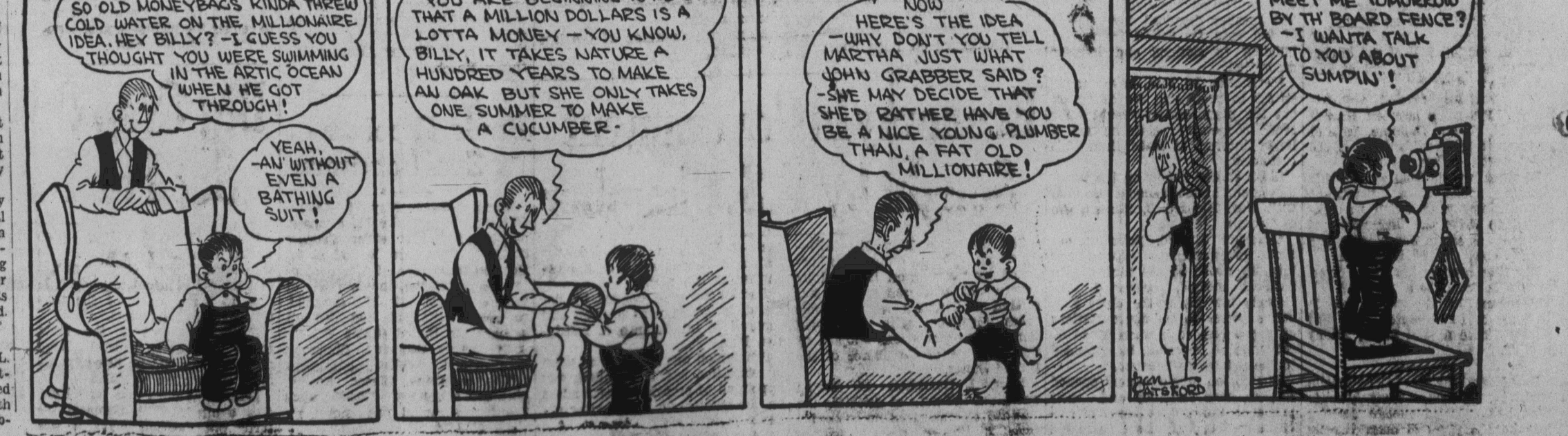
