Washington, May 31.—(AP)—Representative Snell, minority leader in the House, today told newspapermen that he was certain the prohibition plank in the Republican platform would be "liberal." Snell said he was expressing his own opinion but that "if anybody tells you the plank won't be liberal don't believe them." Asked what he meant by "liberal," Snell, who has consistently supported dry measures, said it would be "satisfactory." He did not explain further.

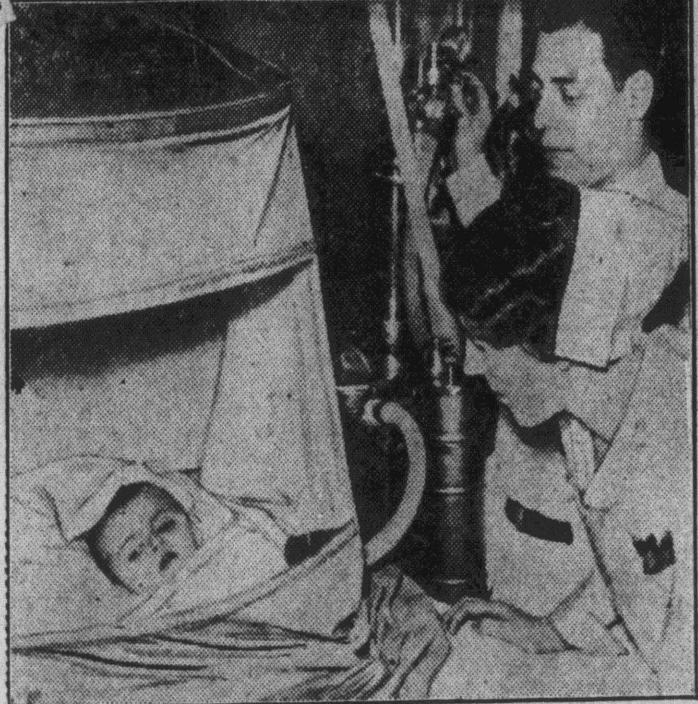

SIX PERSONS HURT BY BOMB

Atlanta, Ga., May 31.—(AP)—Six patrons of a downtown theatre were injured here last night when a real bomb exploded and furnished realism for a screen comedy involving the explosion of a case of dynamite. The theater was thrown into confusion and women screamed and fainted as the crowd rushed the theater manager from Miami, Fla., shouted a warning against stampede and the stenciled was quenched by announcements from the stage that there was no danger. Officials of the theatre said they believed the bomb had been planted as a result of recent labor troubles. A police investigation was ordered and officials said the bomb apparently was made of a glass container and photographic flashlight powder or some similar explosive. The injured, none seriously hurt, were burned, bruised or cut by flying glass.

Subscribe Fund for Opening Bank

Henderson, May 31.—(AP)—Here is another bright spot to shine thru the dark clouds of depression. At a mass meeting, Henderson citizens subscribed a needed \$12,000 stock for a \$100,000 capital and \$20,000 surplus to re-open the First National Bank in July after it had closed December 31. The bank will pay in full all deposits under \$20 and 10 per cent on all others. The remainder is promised in one, two and three years.

Four Bandits to Be Hanged in La.

New Orleans, May 31.—(AP)—Four bank bandits—three white Chicago hoodlums and a New Orleans negro—are to be hanged tomorrow in the New Orleans jail. The four will pay the death penalty for killing Raymond Rizzo, a driver, during a gun battle between the bandits and police after the robbery of the Rochelave market branch of the Canal Bank & Trust Company Nov. 30, 1931. Under the law of Louisiana, the code Napoleon, all four of the bandits were declared equally guilty as conspirators to murder although the state held that only one of the bandits fired the fatal shot, a stray bullet.

Socialists Turn Backs On Stop Gap Governm't

Berlin, May 31.—(AP)—Adolf Hitler's national Socialists today turned their backs on participation in the German government until the verdict of the people has been obtained by general elections following dissolution of the present Reichstag. A spokesman for the Nazis informed the Associated Press that party leaders were certain new elections would give them a clear majority, and in the meantime they would have nothing to do with a stop gap cabinet. This statement came while President Von Hindenburg, who forced the resignation of Dr. Wilhelm Bruening's ministers, was conferring with party leaders in an attempt to provide the nation with a new government. Dr. Ludwig Kaas, in behalf of the Centrists, told the President that in view of the dismissal of Dr. Bruening his party was not interested in the formation of the cabinet. (Continued on page five)

Washington, May 31.—(AP)—The senate made a dramatic drive for new taxes today as Secretary Mills in a room just off the chamber warned that the government credit required that 285,000,000 more be written into the revenue bill. ACCOUNTANT DECLARES \$75,000 PAID TO UNNAMED PERSON FOR MAYOR WALKER

New York, May 31.—(AP)—Just before J. Allan Smith, New York representative of the Equitable Coach Company, took the stand at a hearing of the Hofstadter legislative committee today, an accountant testified that Russell T. Sherwood had paid out more than \$75,000 for the benefit of an unnamed person to whom Mayor James J. Walker said on the stand last week he had authorized payments. Documents in which the unnamed person figured were not introduced in evidence, neither today nor last week when they were submitted to the mayor for identification. The Texas born flier, and his volunteer parachute jumper assistant in refueling, Frank Brooks, were rescued from Puget Sound without serious injury. Brooks said the weighted nozzle of the hose of the refueling plane caught the "Lone Star's" stabilizer, lifted the tail, smashed the rudder and threw the ship into a steep dive which ripped off a wing. SAYS WILL POWER IS BIG FACTOR IN LIFE



Education must come from the inside and not the outside, Dr. Malcom McDermott, of the law department of Duke University, told members of the graduating class of Greenville high school last night, as he stressed the importance of will power in moulding the destiny of men and women.

DUKE LAW HEAD IS SPEAKER AT HIGH CLOSING

Dr. Malcom McDermott Tells Graduates Will Power is Determining Factor

Describing human will power as the most vital force in moulding the destiny of men and women in all walks of life, Dr. Malcom McDermott, director of legislative research and drafting of the School of Law of Duke University, delivered the annual literary address before the graduating class of Greenville high school in the campus building of East Carolina Teachers college last night.

Branding as fallacious the old theory that greatness is inherited, he handed down from one generation to another, the speaker vigorously asserted that by the exercise of will power man can make of himself exactly what he desires because God gives everyone the power to determine what kind of a man he will be. The address, heard by a crowd that packed the spacious auditorium almost to capacity, was described as one of the most masterful delivered at a school closing in years, and fired the imaginations of the 79 young people who left the school this term to go out into the world to seek their fortunes.

NEGROES GET NEW HEARING

Seven Men Condemned to Die in Alabama Granted New Hearing at Capital

Washington, May 31.—(AP)—The Supreme Court today decided to review the sentence of seven negroes convicted of assaulting two white girls near Scottsboro, Alabama. The negroes were being executed on June 24. The action of the highest court today probably will have the effect of postponing the executions. The cases will be taken up by the court after it meets next October. At that time counsel will be heard in oral argument and the court will decide whether the facts will require the setting aside of the convictions.

After awarding of diplomas by J. L. Little, chairman of the Board of Trustees, assisted by Mr. Reza, the exercises were concluded with the singing of "Star Spangled Banner," during which colored flags were thrown upon the senior class group on the stage. The speaker was introduced by Mr. Rose as one of the leaders of his profession, having long occupied an enviable position in the educational field of the nation. Dr. McDermott said the American people had been too busy chasing big business to give the attention to the most important thing in life, the production of young people of character and ability to produce a higher standard of living.

"Take this main purpose of the education cannot be maintained without high-thinking young people capable of carrying on the burden of the world. The destiny of America, he asserted, must be determined by her children. "What will determine the young folks' destiny?" he asked. Answering the question he disputed the old theory of inherited greatness, the handiwork of the germ of aristocracy and revolt, declaring that only through the application of will power can any group of people determine their destiny. God gives us power to determine our destiny, the speaker pointed out. The pages of history are lined with demonstrations of this fact because it applies to all people. (Continued on page three)

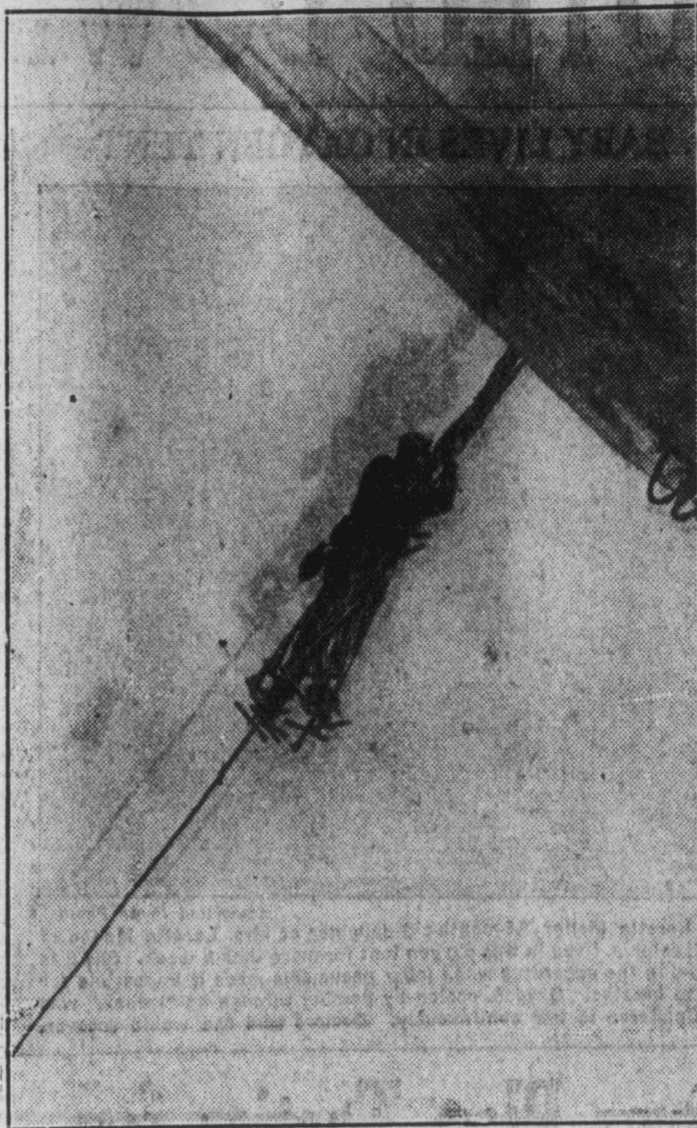

He asserted that the aristocrats are busy shifting responsibility to their ancestors and Socialists are trying to shift it from themselves to the people. He described it as the most popular indoor game of the present generation, dating back from the time of the Garden of Eden when Adam attempted to shift blame to Eve and Eve to the serpent. The serpent didn't make any effort to deny the charge, the speaker said, because he was not human and didn't know anything about responsibility shifting.

Education must come through internal development and not external application, he stated. Ostentation and large buildings are not representative of learning, of progress, but tend to detract from the main thing which they represent. The same thing, he said, applies to religion and other fields of human activity.

Discussing the inherent weakness of the country for legislation, he declared laws do not make character or morality. People go to the gutter of their own free will and accord but let them will the other way and there is no limit to their achievement.

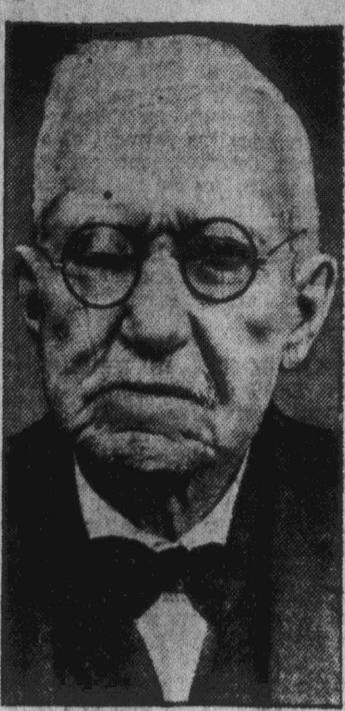

Madrid, May 31.—(AP)—One man was killed and at least ten more or less seriously injured during 24 hours of syndicalist riots in Spain up to early this morning.

At Ceuta the strikers ransacked food stores. Civil guards fired into the air and dispersed the strikers, arresting the leaders. Authorities closed three syndicalist headquarters and cordons of police were placed about all public buildings and churches.

A powerful bomb exploded early this morning near the city hall at Cadiz, damaging some of the municipal offices and nearby buildings. One man was wounded and six arrested during two gun battles with police during the night.

At Seville 40 were arrested when strikers fired upon street cars.

Mother Testifies At Sensational Trial in London. London, May 31.—(AP)—That much discussed photograph of an almost nude young girl posing with the Rev. H. P. Davidson, 62-year-old rector on trial before church authorities on immorality charges was intended for publication in the United States, it turned out today.

The mother of the young girl in question so testified before the ecclesiastical court at Church House Westminster. Photographers had told her, the mother said, publication in America "might mean a lot for her daughter."

The photograph is an issue in the trial because the prosecution contends it is proof that the rector was somewhat indiscreet, and he avers that he was trapped into posing—belief which the girl's mother shares with him.

"It was just a disgusting trap well worked out from the beginning," the mother testified.

She had stipulated, she said, that her daughter was not to be photographed in the nude, and to make sure the stipulation was obeyed she placed the girl in the rector's care.

Another witness today was the Bishop of London who told of Mr. Davidson's work for outcast and said that until the present accusations he never heard an attack on the rector's moral character.

The prosecution announced that all charges against Mr. Davidson involving unknown women would be dropped.

Fugitive Back To Face Charges

Littleton, May 31.—(AP)—Henry Gurkin, for years a fugitive from justice, has returned here to settle charges against his name in connection with a 19-year-old murder. Gurkin, indicted as an accessory before the fact in the murder of Thomas Shaw living 12 miles from here, surrendered to Roanoke Rapids police after fleeing years ago while under bond on the charge.

On May 3, 1913, Shaw, a well known farmer and country merchant, was shot down as he sat on the porch of his home. He lived several hours but was unable to say who shot him.

Police said robbery was the motive, but the slayers fled without obtaining any loot.

Soon after, Kid Cobb and Gurkin were arrested and charged with the killing. They were tried. A jury convicted Cobb and exonerated Gurkin.

Cobb was sentenced to be electrocuted and just before he died, implicated Gurkin who was rearrested, charged with being an accessory before the fact and allowed bond.

He disappeared and nothing was heard from him until he surrendered in Roanoke Rapids.

Bond of \$500 was fixed for his appearance at trial at the next term of Halifax county court.

A'S TROUNCE WASHINGTON TWO TIMES

By GAYLE TALBOT (Associated Press Sports Writer) The Detroit Tigers, still getting better pitching and hitting than any of their western neighbors, had slipped back into second place in the American League today, a half game ahead of the faltering Washington Senators.

The fact, almost unnoticed in the turmoil of yesterday's Memorial Day double headers, is eloquent of the fighting qualities of Bucky Harris' team. The Tigers set a hot pace in the opening weeks of the campaign and were leading the league until they made their first trip east.

Unable to maintain their fast clip, the Bengals tumbled down to fourth place and the consensus was they had shot their bolt. But they started another drive a week ago, have won seven of their last eight games, and today Harris' crew looks like anything but a false alarm.

Heavy hitting won yesterday's first game from the St. Louis Browns, 12 to 9, and tight pitching by an Bridges took the second, 4 to 0.

It took the assistance of the Philadelphia Athletics to plant the Tigers in second place. The Mackmen trimmed Washington twice, 13 to 10 and 8 to 6, before 40,000 fans at Shibe park. Jimmy Foss' seventeenth homerun with two on base Alvin Crowder in the afternoon.

The Yankees dedicated a Memorial to their former leader, Miller Huggins, and fattened their league lead with a brace of victories over the Red Sox, 7-5 and 13-3.

Completing the series of clean sweeps in the American League, the Cleveland Indians beat Chicago twice, 12 to 6 and 12 to 11. A four run rally in the last of the ninth gave them the night cap and stirred up a round of fistfights between several of the White Sox and Umpire George Moriarty.

The Boston Braves' pennant hopes suffered a severe jolt as they dropped two decisions to the Giants. Carl Hubbell stoppawped them into submission, 6 to 2, in the opener and a two-run Giant rally in the tenth decided the nightcap, 4 to 2.

Rogers Hornsby helped the Chicago Cubs divide their double bill with St. Louis. After the Cardinals had driven Burrell Grimes from the box to win the first till, 6 to 4, the Cubs took the nightcap, 6 to 2.

Two Brooklyn pitchers, Watson Clark and Young Van Mungo, turned in sterling games as the Dodgers swept their bill with the Phillies, 13 to 4 and 5 to 3. Each allowed but four hits and Mungo struck out twelve.

Cincinnati and Pittsburgh broke even, the Reds taking the morning encounter, 4 to 2, behind Eppa Rixey's pitching and the Pirates grabbing the second, 2 to 2, as Bill Swift allowed but five hits.

A few minutes after the gun fire started Chief of Police R. B. Talbert and Policeman W. T. Neal captured Shemwell. He was taken to hospital with a dangerous wound in the abdomen. Physicians said they doubted if he would live.

Witnesses told Chief Talbert that Shemwell entered Sink's store this morning and that an argument followed over foreclosure of debts held by Sink on property owned in Asheville by Shemwell.

Boase and Johnson were in the store at the time and they said Shemwell, apparently becoming enraged, reached for his hip pocket.

Boase drew a pistol and covered Shemwell while Johnson disarmed him, the two told Chief Talbert.

The dentist and auto salesman then took Shemwell from the store, placed him in his automobile and, after watching him drive off, returned to the store.

A few minutes later, they said, Shemwell returned, parked his car across the street and stepped from the machine firing with a rifle.

Boase took cover behind a parked automobile and returned Shemwell's fire. He soon emptied his pistol and fled.

Shemwell then crossed the street and broke the glass in the front of Sink's store in an attempt to reach Johnson, Chief Talbert said.

As Shemwell battered at the front of the store, he continued his fire which was returned by Johnson.

Boase told Chief Talbert that he, Boase, had fired the bullet that wounded Shemwell.

In a secret session of the finance committee, the treasury chief presented alternative proposals for raising the \$200,000,000 more. One alternative was the disputed sales tax and this recommendation immediately threw the committee into argument.

The alternative advanced by Mills was a federal gasoline tax and the strengthening of the admissions levy.

This was the first time the administration had recommended the sales tax which is still to be voted upon in the senate but against which five members were pledged yesterday.

Seeking a prize of nearly \$30,000 for the first flight from Seattle to Tokyo before the time limit of the 5-year offer expires at midnight, June 1, Browne had elected to re-fly in mid-air after Sunday's difficulty in getting the heavily loaded ship off the ground. Forced to return after 71-2 hours by an oil leak, he discovered, after landing that a stabilizer wire had been broken in grazing a tree at the takeoff.

Browne was shot into the air by the disintegrating plane as he attempted to stay with it and nose it up. Brooks, who leaped with a parachute, was unhurt except for swallowing gasoline when the tank split open in mid-air.

"When the plane dove," Browne said, "I opened the throttle wide in an effort to pull out of it. The wings crumpled. The plane came to pieces."

"I made no effort to jump. I didn't need to. I was thrown clear of the cockpit about 300 feet above the water and my parachute opened."

New York, May 31.—(AP)—Cotton opened steady today at a decline of 5 to 8 points on selling orders, promoted by easy cables. July sold at 5.44.

The July position sold down to a new low for the life of the contract at 5.42 while December and January also made new low levels at 5.32 and 5.31 respectively. The Liverpool cables were lower than had been indicated by the action of the market and a feeling of nervousness over the German political situation seemed to bring selling orders from abroad while the Washington news on the apparent abandonment of the manufacturers' sales tax and a decline in the stock market caused selling through commission houses.

The decline uncovered some fairly substantial trade buying orders which served to hold the market within a narrow range but new buying was lacking. Liverpool cables that the market there had been influenced by covering, hedging and liquidation and that the Manchester market was unsettled with sales below production.

Stock Market

New York, May 31.—(AP)—After one of the sharpest declines of recent months, the stock market recovered partially for a short time today, coincident with President Hoover's message to congress, urging balancing of the budget through adoption of the manufacturers' sales tax and government economies.

The list slumped 1 to more than 3 points in the morning trading, as financial quarters manifested considerable disappointment over the apparent shelving of the sales tax in the senate, the fall of the Brüning government in Germany and weak end trade advices, particularly those from the steel industry.

U. S. Steel recovered most of a decline of 1 1/4 points, which had carried it down to 26. American Telephone, after declining 2 to 3 3/4, recovered a point. Allied Chemical, American Can, American Tobacco B, Consolidated Gas, and Union Pacific, recovered about a point, after selling of 1 to more than 2 points. These recoveries, however, were mostly short lived. Foods, chain store, chemicals and utilities bore the brunt of the early selling. Declines of 2 to 3 points appeared in such issues as Borden, Corn Products, Peoples Gas, Dupont, Drug, Penny, Norfolk and Western and others. Issues losing 1 to nearly 2 points had included General Electric, Standard of New Jersey, North American Socony-Vacuum, Loews, Liggett and Myers "B", Sears, and many others.

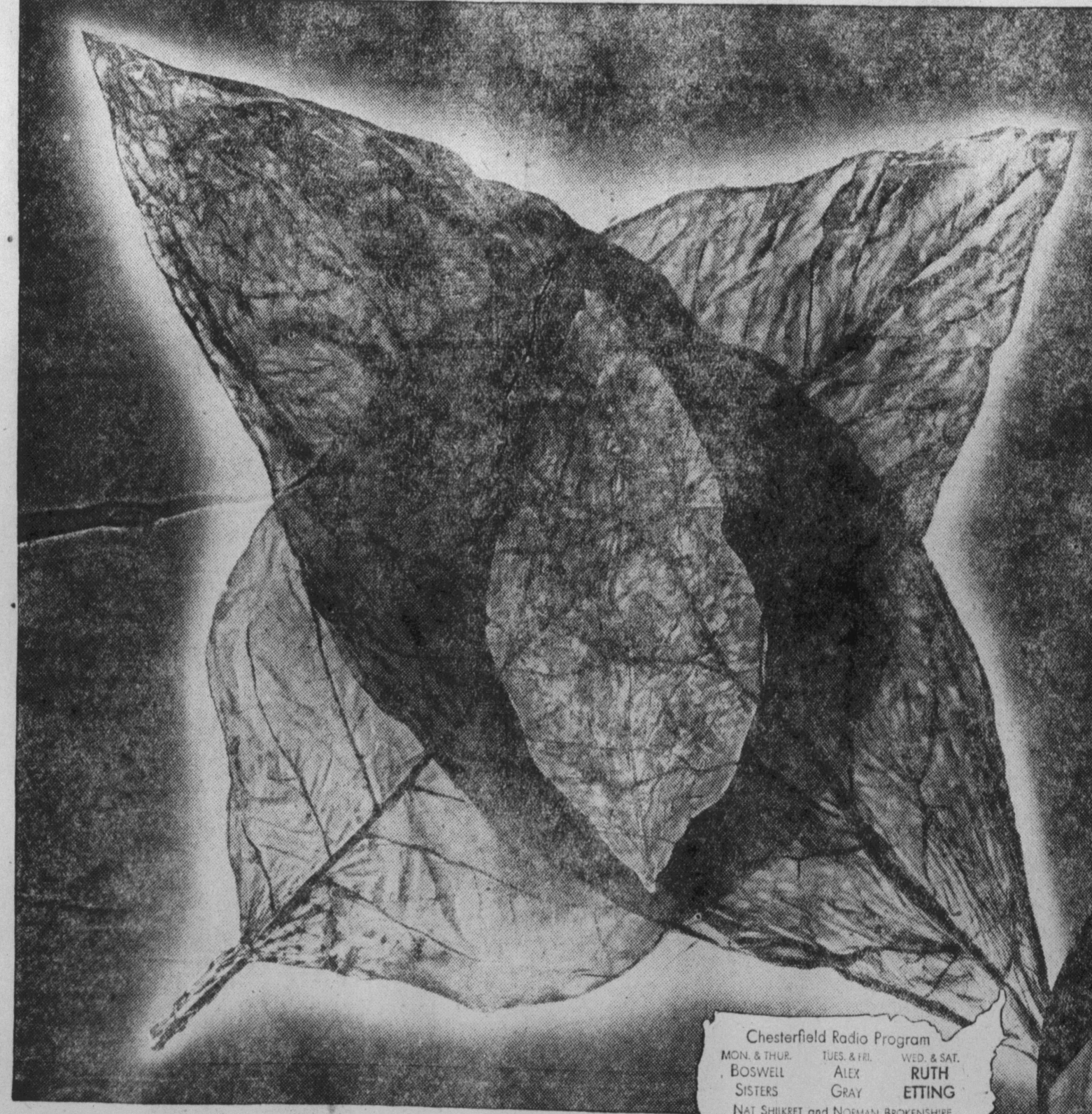
