CONGRESS GETS ADMINISTRATION RELIEF PLANS

Civil Actions Against Ballards Are Settled

Judge Cranmer Orders Release Of Money Held In Box In Wilson Bank

WHITLEY WILL GET DAMAGES

Defendant in Highway Robbery Suit Will be Paid \$2,200 for Defamation of Character; Two Concerns Paid Accounts, While Lawyers for Whitley Will Get \$2,200; Criminal Action Still Pending

Several civil actions brought against Mr. and Mrs. G. H. Ballard, principals in the sensational highway robbery case which has held the limelight in this community for over a year, were definitely settled in the civil term of Pitt County Superior court yesterday afternoon by an order of Judge E. H. Cranmer.

Completion of the cases followed compromise among the plaintiffs, attorneys involved in the case and Mrs. Ballard, and writes the final chapter in one phase of the eventual court career of the defendants in this community.

By the court order, the writ of attachment for \$6,000 held in a safe deposit box in Wilson in Mrs. Ballard's name was dissolved, and the money was ordered turned over to former Judge Albion Dunn for settlement of the claims brought against the defendants.

The most important of the settlements was that of Elmer Whitley, who with Rodney Cox, was convicted and later granted a new trial for the holdup and robbery of Mrs. Ballard during the Christmas holidays over a year ago. Whitley, who filed suit for defamation of character growing out of the criminal action, will receive \$2,200 damages under the compromise agreement. His wife was denied a similar claim.

Others involved in the settlement with amounts received were: Garris Evans Lumber Co.; \$150 for debt; Forbes Hardware Company, \$150 for debt; Harding and Lee and Gaylord and Harrell, attorneys for Whitley, \$2,200; S. O. Worthington, attorney for Forbes Hardware Co., \$150.

The money held by the bank in Wilson was placed in the custody of the sheriff of Wilson county immediately after the filing of the suit by Whitley, and the key to the box was held by J. F. Harrington, clerk of Superior court, pending completion of the case.

The settlement did not affect the criminal action against Whitley and Cox, who were granted a new trial by Supreme court shortly after being sentenced to from 7 to 9 years for alleged robbery of Mrs. Ballard. This case is still pending and was expected to come up for hearing probably during the present year.

Neither does it have any connection with charges of incendiarism, violation of the prohibition law and promiscuous firing of a firearm brought against Ballard here early last Saturday morning.

The defendant's forfeited bond of \$500 when he failed to appear for hearing in police court yesterday morning. An order was issued for his arrest but police so far have been unable to locate him.

Ballard disappeared shortly after being seen on the streets early yesterday morning, and in spite of every effort made by police to locate him, his whereabouts remained as much a mystery today as ever. He was believed to have gone to some other part of the country to remain until the present trouble blows over, but nobody seems to

GET DAMAGES FOR INJURIES

Levi Pierce and Blaney Sumrell Are Awarded Damages Against Turnage

Blaney Sumrell and Levi Pierce were awarded damages against Lloyd Turnage, prominent Ayden business man, for injuries sustained in a automobile wreck in the Kinston community several months ago, in yesterday's session of civil court. Sumrell received a verdict for \$1,000 and Pierce for \$750. They were suing for \$10,000 and \$7,000 respectively.

The jury, which came mighty near setting something of a record for endurance, considered the case for a total of 27 hours. The case was received about the noon hour the day before and a verdict was reported shortly after 3 o'clock yesterday afternoon. One man, it was stated, brought about the deadlock, and this was not broken until instructions were sought from Judge E. H. Cranmer about the noon hour.

Predict Virtual Military Dictatorship in Germany

Berlin, June 2.—(AP)—The possibility of a virtual military dictatorship in Germany during the life of the new cabinet of Count Franz Von Papen was seen by some political observers today. These observers pointed out that the new cabinet, which was framed yesterday, would, in all likelihood, be unable to secure a vote of confidence in the Reichstag if it were convened. They predicted that President Von Hindenburg, therefore, would not call the legislature together, but would continue to function under article 48 of the constitution which grants almost autocratic powers in an emergency.

Reputation of the cabinet by the Centrist party, to which Count Von Papen himself belonged, and by the Baccarian people's party last night, was taken as indication of what the Reichstag would do if a vote of non-confidence were proposed. QUASH CHARGE AGAINST FALL

Conspiracy Case Against Sinclair and Dohenys Also Dismissed by Court

Washington, June 2.—(AP)—Criminal charges against Albert B. Fall, Harry F. Sinclair, Edward L. Doheny and Edward L. Doheny, Jr., were dismissed today by Justice James M. Proctor in the District of Columbia Supreme Court.

The pending case charged Fall and Harry F. Sinclair, a wealthy oil man, with conspiring to defraud the government through the lease of the Teapot Naval Oil reserve to a Sinclair company.

Because of Fall's ill health, Sinclair was tried alone on the conspiracy charge and was acquitted. Later, Fall was tried on a charge of accepting a bribe from Edward Doheny, another oil magnate, and was convicted. Fall was released a few days ago after serving a term in the New Mexico state penitentiary.

URGES PEOPLE TO VOTE EARLY

Chairman of Elections Board Asks Public to Help Speed up Work at Polls Sat.

With the statewide primary one day away, candidates were today making last minute appeals to their constituents while election officials prepared to take care of what is expected will be the heaviest vote in the history of the county.

F. C. Harding, chairman of the Pitt County Board of Elections, in a statement issued this morning, urged the people to vote as early as possible throughout the county, and especially in Greenville where pollholders will be forced to work at top speed to take care of the large vote cast here.

Mr. Harding particularly urged people living in the city to go to the polls early to make way for voters coming in from other sections of the township.

While congestion is not expected to be as great in other sections of the county as in Greenville, the elections chairman said he hoped everybody would make it a point to go to the polls as early as they can and in that way do away with terrific last minute rushes.

The polls will open at sunrise, 4:58, and close at sundown, 7:26, in the fourteen precincts of the county. The early opening will give early birds a chance to cast their votes before town people even think about getting out of bed, and if this rule is followed throughout the county, it was hoped that congestion usually attending statewide primaries would be relieved.

The seventy-five candidates in this county went into the highways and hedges today in a last minute effort to round up their constituents, and the final touch will be added to the campaign to

PRIMARIES ON SATURDAY

Democrats to Hold Township Precinct Meetings at Three O'clock

Democratic precinct primaries will be held in the various townships of Pitt county Saturday afternoon at 3 o'clock, and people interested in the success of the party were urged today by W. E. The purpose of the primaries is to name delegates to the county convention to be held at the courthouse here June 11, a 12 o'clock, and to select township executive committees of five members.

At the county convention delegates will be chosen to the State convention at Raleigh June 16th in addition to other matters of business.

Mr. Hooks, who was in Greenville today on business, stated he had mailed out letters to all party chairman in each township of the county impressing upon them the importance of the township gatherings.

Newspapers predicted ouster charges would be laid before Gov. Franklin D. Roosevelt soon, possibly next week.

Because Gov. Roosevelt is a candidate for the Democratic presidential nomination and Mayor Walker is in adherent of Tammany Hall, the possible effects of the Walker case on the national political picture have come more and more to the fore.

FORT FISHER MILLS SCORES DEAD HONORED PUBLIC WORKS

Monument Unveiled With Appropriate Exercises at Old Confederate Fort

Fort Fisher, N. C., June 12.—(AP)—An ocean breeze, bullet-free, ripped the Confederate flag here today for the first time since Fort Fisher fell in 1865 under Northern gunfire and while the flag fluttered a moment was dedicated to the fort's dead defenders.

The monument, an imposing monolith erected on Battle Acre, is in memory of those slain in the first and second battles of Fort Fisher where Federal and Confederate forces waged one of America's greatest land-naval conflicts.

With dignitaries from the state attending, military units and bands playing martial and patriotic strains present, the Southern flag was again run up for the first time since Federal guns silenced the fort, and forced the defending Confederates to retreat.

Governor O. Max Gardner was the principal speaker at the exercises. A motorcade of those participating in the program started from Wilmington, 17 miles away, an hour before the dedicatory exercises began here. The group included the governor and his escort, the Wilmington Light Infantry, prominent United Daughters of the Confederacy, who were instrumental in erecting the monument, several bands and hundreds of citizens.

As the calvacade arrived here, the hour's program was begun and the \$12,000 monument was officially recognized.

Following a band selection and the invocation by the Rev. Thomas C. Drist, Episcopal Bishop of Eastern Carolina Diocese, Governor Gardner was introduced. In his address, the chief executive lauded the heroic deeds of the defenders of Fort Fisher which he called the "Gibraltar of America."

Then the Confederate flag was raised by three children—Julian Gaither, Jr., Mary Scott Symmes and Hector McLean.

Following this, Mrs. Glenn Long of Newton, president of the North Carolina Division of U. D. C., spoke in honor of the veterans who held Fort Fisher under devastating fire from land sea for more than a month.

The monument was then unveiled by four children of U. D. C's, they were Ethel McDonald, Jane Emmer (Continued on page three)

J. W. Thomas of Fort Smith, train fireman, and Cecil Allen, 27, driver of the truck, died instantly. Allen was burned beyond recognition.

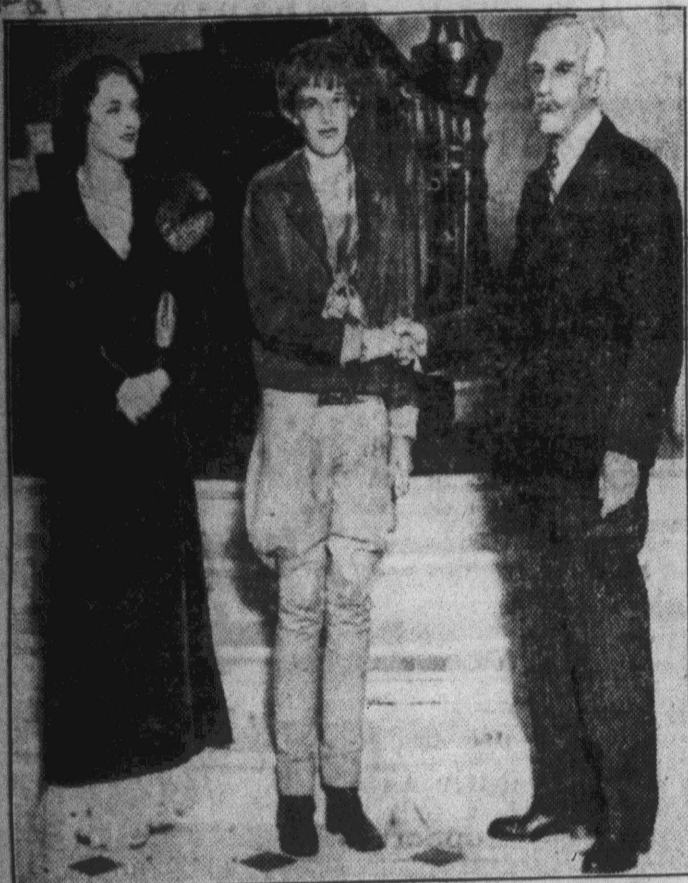

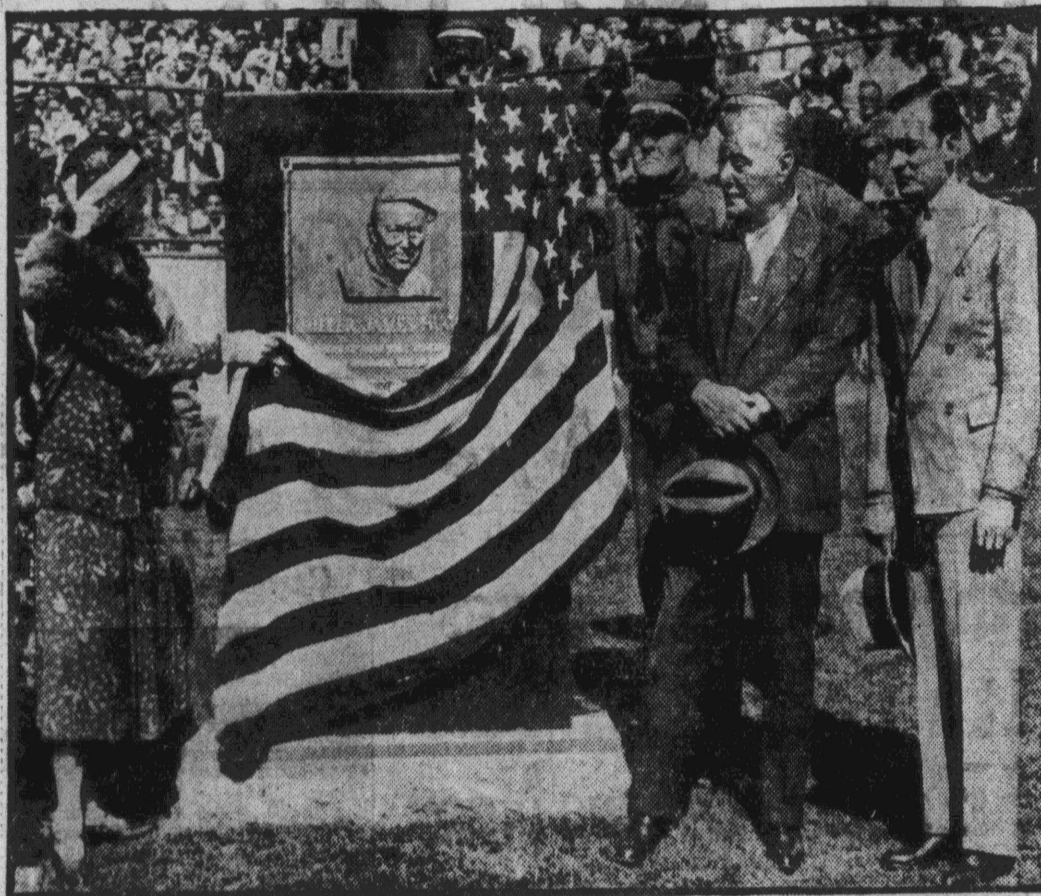

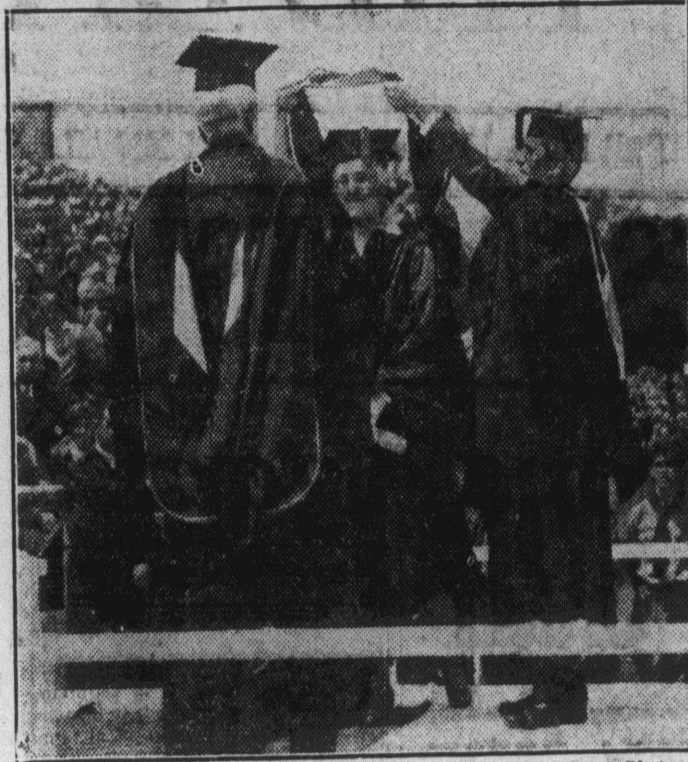
YANKEES UNVEIL MEMORIAL TO MILLER HUGGINS

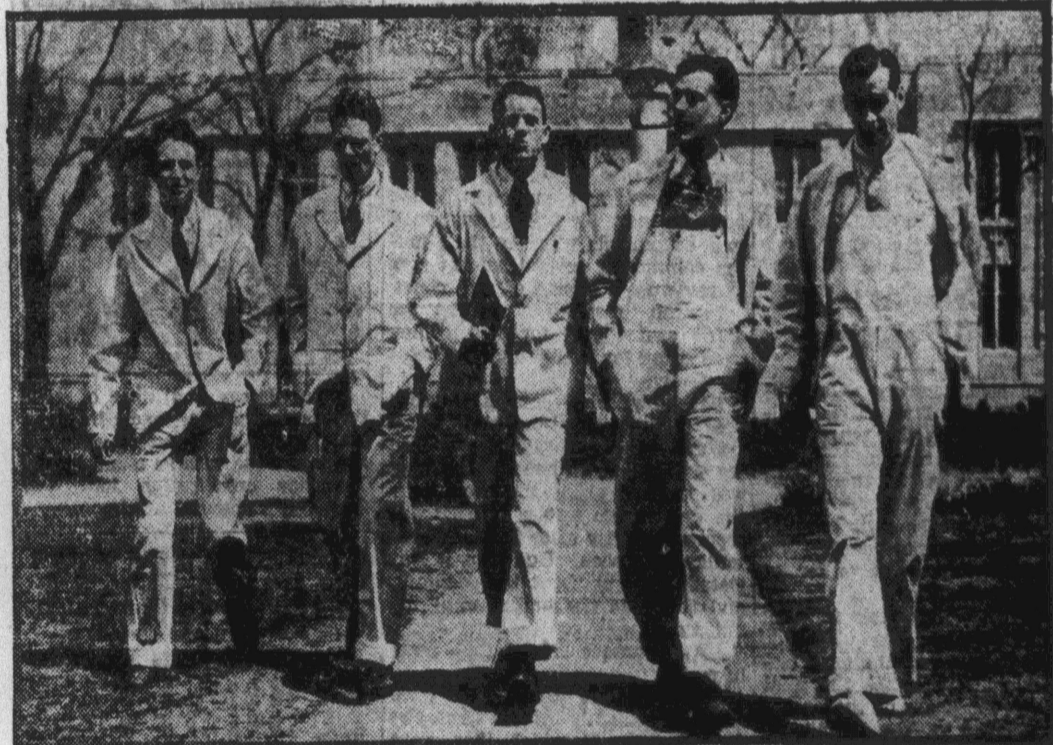

Seabury sought to show that Russell T. Sherwood, who handled almost a million dollars before he disappeared was the mayor's fiscal agent. The mayor denied it.

Militantly dry Alabama, prohibiting the sale of anything that looks like, tastes like or foams like beer, has two senatorial candidates in a run-off who favor referendum.

Both, the incumbent Senator Hugh Black who was endorsed in the first primary by the state Anti-Saloon League and his opponent, former Governor Thomas E. Kilby who signed many of the state's dry laws, have explained they are personally dry but believe it is time to permit the people to express themselves. Black says they will retain prohibition.

In Florida, Congresswoman Ruth Bryon Owen, the daughter of the great dry campaigner, the late William Jennings Bryan, says she will vote to re-submit the 18th amendment to the states "because I believe it to be the will of our people" and "because I myself believe it to be in the interest of public good."

The platform of her opponent, Mark Wilcox, Palm Beach attorney, calls for repeal.

The veteran Florida dry, Congressman Herbert J. Drane, has announced likewise his readiness to support referendum legislation.

North Carolina has on a five corner senatorial race between the incumbent Senator Cameron Morrison, commissioner of labor, Frank Grist who favors referendum, Robert R. Reynolds, Asheville lawyer, who announced on a wet platform, Judge Tam Bowie and Arthur Simmons.

Five Virginia congressional members, Representative Drewry, Montague, Tucker, Smith and Lankford (R) have endorsed the idea of submitting the prohibition question to the states. Henry Wise has announced against Representative Bland in the first district on a wet platform.

The second Tennessee district has a Democratic candidate for Congress who recently successfully defended in Federal Court in Knoxville his own case under charge of possessing a still. He is Tom Fowler, lanky war veteran and farmer, running on a repeal platform. In the third district of Tennessee, Judge Walter Cameron of South Pittsburgh is running on a referendum platform against the incumbent Representative Sam D. McReynolds who recently opposed referendum.

Raleigh, June 2.—(AP)—E. B. Jeffress, chairman of the state highway commission, asserted today that "any statement or insinuation by Leut. Gov. R. T. Fountain or his campaign managers that the state highway commission has discharged or threatened to discharge any employe for supporting him is a deliberate falsehood."

Mr. Jeffress issued a formal statement replying to speeches

Stock Market

New York, June 2.—(AP)—After an early shower of selling orders, the solids over the security markets suddenly lifted today and a rather active rally got under way, more than cancelling losses of 1 to 2 points.

Utilities, rails and a number of industrials plunged to new lows in the first hour, but selling quickly wore itself out and a substantial rally appeared. Stocks which turned early losses into net gains of 1 to 3 points included Santa Fe, Union Pacific, American Tobacco and Liggett and Myers, Lambert, American Causi, Eastman Kodak, Borden and Allied Chemical.

United States Steel, after duplicating its 1932 low at 251-4, was strongly supported and went forward for a net gain of a point or so. American Telephone broke over 2 points to a new low, but more than recovered that loss. Westinghouse Electric and other stocks identified with the utility industry likewise showed a better tone.

Market interest centered largely on fiscal legislation at Washington and Wall Street appeared encouraged at the prospect of fairly early agreement. Leading bankers express the view that a balanced budget, regardless of how the additional money is raised, is the pressing need of the moment.

Analysis of the proposed tax on electric power distribution, which would lay a 3 per cent charge on production, has caused some selling of utilities. This charge when translated into common share earnings would range from around 10 cents a share to as high as \$1.69 on the common stocks of different utilities.

The American dollar showed generally to better advantage in the foreign exchange market. Price changes were narrow with sterling fractionally higher and some of the continental gold currencies a shade lower.

ing Brigadier General Glassford, superintendent of police, indicated today that more than 5,000 now are enroute via trucks, automobiles and freight trains or are about to start. They are coming from the four corners of the nation.

Glassford said the new arrivals would be taken to Anacostia Park, some distance from the capitol, and housed in tents.

Police estimated that between 1,000 and 1,500 former soldiers are now here. More than 600 are billeted in two vacant buildings.

Efforts to learn how the movement started have been unsuccessful. Glassford said those now under way have been attracted by the publicity of free housing and the chance of a free ride.

Walter W. Waters, "commander-in-chief" of those now here, said the idea originated with a group of Oregon soldiers. He emphatically denied that Communists or the Workers Ex-Service Men's League, an affiliate of the Communist organization, inspired it.

"We are Americans and we want nothing to do with the Reds," he said.

On the other hand, police say 200 known Communists are in the city. One Emanuel Levine, said the Ex-Service Men's League claims credit for starting the movement in 30 strategic points. The league is planning a mass demonstration here June 8.

Glassford has about \$400 to feed the campers, now being fed at a cost of six cents a day each. They get two meals. The police superintendent appeared before a Senate committee yesterday and asked for a federal appropriation of \$75,000.

A mid-night show will be given in a local theatre tonight to raise additional funds.

When funds are exhausted, Glassford threatens to evacuate the veterans within 48 hours. As long as food is available they probably will be permitted to remain until congress adjourns. Picked leaders of the veterans now are lobbying in congress for the bonus.

Articles of Association

And By-Laws of The
Pitt Mutual Burial Association
Of Pitt County, N. C.

Officers:
J. R. MOYÉ, Pres. J. G. MOYÉ, V.-Pres.
A. A. ELLWANGER, Sec. & Treas.

These articles of Association are made, adopted and signed for the purpose of forming an association to provide for the payment of funeral expenses for the members thereof.

Article 1. The name of this Association shall be "The Pitt Mutual Burial Association of Pitt County, N. C."

Article 2. The object of this organization shall be to provide a plan for the payment, by assessment, of the funeral expenses of each member of the amount of \$100.00 for each member ten years of age or over, and \$50.00 for each member over one year and under ten years of age.

Article 3. Any person in good health, between the ages of One and Fifty, may become a member of this Association by paying an initiation fee of Ten cents. All members over one year and under ten years of age are not assessed. Any member over ten years of age may become a paid up member for one year by paying \$1.50 and then would not be assessable for that period.

Article 4. All members are liable for their assessments until they return certificates and ask for withdrawal. Failing to pay does not release what you already owe. When you wish to withdraw you must pay up back dues. After this is done and proper notice is given no more assessments will be made.

Article 5. The officers of this Association shall be a President, Vice-President, Secretary and Treasurer, the duties of the Secretary and Treasurer to be performed by the same person, unless otherwise ordered by the Association, and these officers shall constitute a Board of Control, which shall have power to direct the affairs of the Association but always in accordance with these articles, and the orders of the Association as a body. The Secretary and Treasurer shall keep a correct record of the membership of the Association, deaths, assessments made and collected, moneys received and paid out, and all other matters in connection with the business of the Association and those books shall be open to the inspection of the members of the Association.

Article 6. The officers of the Association shall be elected annually, if necessary; and for the purpose of electing officers or transacting other business of the Association, every adult member shall be entitled to one vote.

Article 7. On the death of a member of the Association every member over ten years of age shall be assessed the sum of 12 cents, 10 cents of that to be used as funeral expenses and two cents for paying for collection and other expenses. A failure to pay any assessment within 15 days after second notice shall forfeit membership.

Article 8. If the membership of the Association shall not prove sufficient at any time to yield the benefit above provided, then such benefits shall be paid, or such services furnished, as the assessments above provided levied on the total assessable membership shall justify, and if the membership shall be such that the assessments as above provided shall exceed the benefits above provided, the excess of each assessment shall be converted into the treasury, and when such excess shall equal one or more full benefit, the next assessment shall be skipped and such excess applied to the payment of the benefit or benefits.

Article 9. In case of the removal of a member to such a distance as shall render the service of the Association's undertaker impracticable, such member shall notify the Association's undertaker of such place of removal and the undertaker preferred at such place of removal in case of death so that the Association's undertaker can so arrange with the said undertaker preferred to conduct the funeral of said member, and if said member fails to notify the Association's undertaker as hereinbefore provided, said member shall not be entitled to the benefits of this Association.

Article 10. It shall be the duty of the Secretary and Treasurer to collect all assessments, but no compensation shall be paid him for such services except what is allowed by these articles, nor shall any salary be paid to any officer.

Article 11. The fund arising from the initiation fees shall constitute an expense fund, out of which all expenses of organizing this Association shall be paid, and such subsequent expense as may be incurred.

Article 12. Meetings of the Association may be called by the President when by him deemed necessary, and he shall call a meeting whenever requested to do so by one-half of its membership.

Article 13. No person shall become a member of this Association who at the time of his application to become such a member is not in good health.

Article 14. The benefits herein provided are for the purpose of furnishing respectable funerals and burial services for deceased members and the benefits provided are to be paid to Williams Funeral Parlor, Greenville, N. C., or their heirs or assigns, and they are hereby designated as the only official undertakers of the Pitt Mutual Burial Association.

Article 15. Each member shall be entitled to receive a certificate of membership as follows:
