REYNOLDS GRABS LEAD FROM CAMERON MORRISON

Seabury Charged With Violation Constitution Of State Of New York

CHARGE MADE BY HASTINGS

Friend of Mayor Walker Says Prosecutor Guilty of Accepting Free Transportation or Discrimination in Passenger Rates On Trip to Bermuda.

New York, June 6.—(AP)—Investigator Samuel Seabury himself was on the receiving end of charges today as he summarized the record of his case against Mayor James J. Walker.

The counsel for the legislative committee investigating New York was accused last night by State Senator John A. Hastings of violating the state constitution.

Hastings a friend of Mayor Walker, wrote District Attorney Grain that Seabury traveled to Bermuda and back in accommodations worth \$1,010 but paid only \$460.

Hastings declared Seabury is amenable to a prohibition against acceptance of "free transportation or discrimination in passenger rates."

Grain was asked to present the facts to the grand jury or to a magistrate.

Meanwhile Seabury analyzed 700,000 words of testimony relating to the Walker administration. He expects to submit his analysis to Governor Roosevelt by the middle of the week.

The city affairs committee, thru Dr. John Haynes Holmes and Rabbi Stephen S. Wise, issued a statement denouncing Governor Roosevelt for the representations of his views, expressed through an unidentified spokesman, that Seabury was "playing politics."

The statement said "this is the traditional Tammany Hall policy of attacking venomously when cornered."

Commenting on the charges made against him to the District attorney by Senator John A. Hastings, that he traveled to Bermuda and back in \$1,010 accommodations but paid only \$460, Seabury today said an officer on the ship had moved his baggage to a larger suite without asking his permission and told him he might as well occupy it since the ship was carrying few passengers.

Seabury said he was not a public official and that, therefore, the section of the constitution to which Hastings in his letter to the district attorney referred did not apply to him.

Six Republicans Race for Primary Favors in Iowa

Des Moines, Ia., June 6.—(AP)—Six Republican candidates for United States senator raced for primary favor of the Iowa electorate today, among them the incumbent Senator Smith W. Brookhart, foe of "Wall Street and big business."

Thirty-five per cent of the total vote cast is required in Iowa for primary nomination; otherwise the nominee is picked by the state convention. On this political foe of Brookhart based their hope of replacing him in congress.

Due to the six-cornered Republican contest and five candidates fighting for the Democratic senatorial nomination, campaign managers predicted an unusually large vote; 400,000 Republican and 200,000 Democratic votes would be cast, they estimated.

In addition to the senatorial race, Iowans also expressed their preference for candidates for congressmen and for governor and other state officers.

BEGIN MOVE TO OUST SHOUSE

Roosevelt Forces will Try to Place Walsh as Chairman of Democratic Convention.

SEES DELAY IN CONGRESS

Watson Says Work Will Not Be Finished in Time to Attend Convention.

Washington, June 6.—(AP)—With only a week remaining before the Republican national convention, Senator Watson of Indiana, the Republican leader, told newspapermen today it would be impossible for the senate to finish its legislative duties in time for members to attend.

Watson also said definitely it is not planned to recess for the conventions.

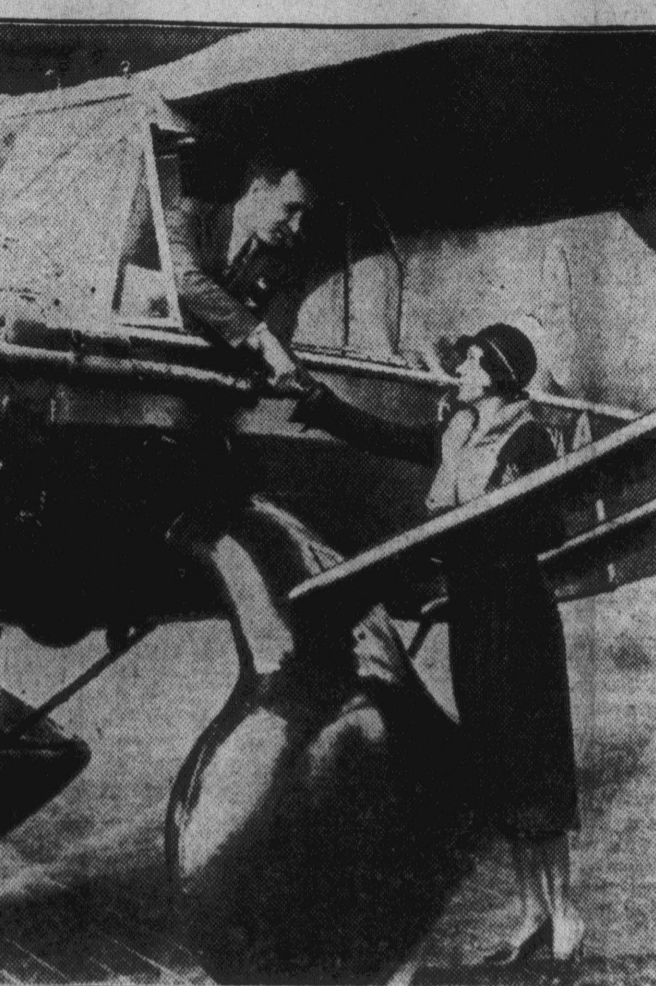
MRS. SAVAGE LAID TO REST

House To Begin Battle Over Relief Tomorrow

Washington, June 6.—(AP)—The struggle between the administration and the Democrats over relief legislation—one of the prime controversies to be settled before adjournment—will burst forth in the House tomorrow over the two billion dollar measure sponsored by Speaker Garner.

By an 8 to 4 vote, the rules committee agreed today for the bill to be brought up under drastic procedure with debate limited to three hours. The Democrats are pledged to support it. (Continued on Page Four)

E.C.T.C. HOLDS FINALS TODAY

Rivers D. Johnson, of Warsaw, delivered the literary address before the graduating class of East Carolina Teachers college this morning.

Speaking on the subject, "Education and Democracy," Mr. Johnson reviewed North Carolina's record through the last century in its fight for education and public schools, emphasizing two high peaks sixty years apart, an expressing faith in the future because of the great spirit of democracy that always conquers in this state.

He launched forth on his theme by referring to the recent unwillingness of the state of Aycock in the nation's Hall of Fame, filling the "second and last niche in that circle of glory," while Vance filled the other niche, the latter standing for the man of action while the former stands for the man of vision.

He went back to a hundred years ago, when North Carolina was still branded as the "Rip Van Winkle" state when great leaders such as Caldwell and Swain, led the state to see that transportation and education were the great needs of the people, and through violent opposition established both a system of railroads and of public schools that (Continued on Page Four)

Says G. O. P. Will Ask For Vote On Prohibition

Washington, June 6.—(AP)—A definite prediction that a prohibition resubmission plank will be in the Republican platform issued from a campaign conference held yesterday by party strategists.

The clearest statement was made by Senator Moses of New Hampshire as he emerged from the luncheon conference at the Congressional Club. But he added that no details have been agreed upon.

James R. Garfield of Ohio, chosen to direct the platform drafting task as chairman of the resolutions committee, was the center of the conference, absorbing the views of the several members of congress who are to hold places on that committee, but who may be kept here by protracted sessions. Postmaster General New, pre-convention manager for President Hoover, sat in also.

NEW REVOLT GRIPS CHILE

Counter Movement is Started Against Socialist Regime in the Southern Section.

Santiago, Chile, June 6.—(AP)—A counter-revolution directed against the Socialist regime which set itself up here on Saturday has broken out in southern Chile.

It was understood that the army and navy support the movement. Reports from the south this morning said that the military and naval garrisons at Concepcion and Talchunao had joined the counter-revolutionary forces.

General Puga, minister of the interior in the new government, said he had expected some such incident, but he did not believe the counter-revolution would be very serious. If necessary, he said, (Continued on Page Three)

HOOVER MOVES TO AID JOBLESS

President Outlines his Complete Program for Relief of Unemployment Situation.

Washington, June 6.—(AP)—Sighting the early end of Congress and seeking to direct its final steps, President Hoover had outlined to the country today his complete program at this time for federal aid employment, agriculture and business.

Beyond expansion to \$3,000,000,000 of the Reconstruction Finance Corporation's capital, with its scope extended to give wide benefit to agriculture, the Chief Executive declared for immediate enactment of legislation creating the home loan bank system; country-wide extension of the industry and finance committees organized by the Federal Reserve; and strict holding of government expenditures to a pay as you go basis.

This summary was given out in a statement from the White House last night. It was the result of extended week-end discussions at the Rapidan camp between the president and the directors of the reconstruction unit, which is the mainprong of his plan. No mention was made of how Mr. Hoover intended to go about getting the program through Congress, this apparently being left to later conferences with political leaders. Mr. Hoover remained in the mountains until today.

In disregard of the administration plan, House leaders meantime were seeking to push Speaker Garner's \$2,300,000,000 relief program, which is largely objectionable to the president. The speaker and his aides sought recommendation to the House from the rules committee for special procedure under which the bill is to be taken up and passed tomorrow.

FOIL PLOT TO KILL PREMIER

Young Italian Arrested for Attempt Take Life of Mussolini at Rome.

Rome, June 6.—(AP)—Premier Benito Mussolini as outlined another bomb plot against his life. The fact became known yesterday with the announcement that police had arrested a 25-year-old Italian, armed with a pistol and two bombs, outside the premier's office in the Palazzo Venezia.

The arrest was made Saturday. The announcement said the man, Angelo Sabardello, confessed he intended to kill the premier during the celebration Saturday in honor of General Garibaldi, Italy's liberator, and his wife, Anita. The time was chosen, the young man said, because Garibaldi was a symbol of liberty in Italy.

The police identified Sabardello as a member of an organization called "Justice and Liberty," pledged to violent action.

The bombs were intended for the premier and the pistol was to be used to kill himself, the prisoner told police.

He carried a forged Swiss passport and he was believed to have come here from Cannes, France. He was arrested when he attracted the attention of a detective near the Palazzo Venezia.

Five Thousand Footsore, Hungry, Bonus Petitioners Headed Toward Washington

By The Associated Press Five thousand men, some footsore, some shabby and many hungry, moved on Washington today from all over the country.

They hitch-hiked, commandeered freight trains as they could, rode in trucks and went on foot—any way to get to Washington and join the 2,500 already bivouacked there to demand payment of the soldiers' bonus.

REPORTS ON PRIMARIES

Five Townships Give List of Delegates To County Convention Saturday.

The names of executive committee and delegates selected by the various townships of the county in Democratic precinct primaries Saturday continued to trickle into Greenville today, and more were expected during the remainder of the week.

The primaries were held for the purpose of electing delegates to the county convention at the court house here Saturday, June 11, at 12 o'clock, and the naming of executive committees of five members.

Much interest was manifested in the precinct meetings, and good attendance was registered in virtually all townships.

The five precincts reporting their action over the week-end were: Winterville, Arden, Carolina, Swift Creek and Chicod.

WADE IN LEAD OF HARTNESS

Wet Candidate's Lead Over Morrison Goes Near 5,000 Mark As Votes Continued To Trickle in This Afternoon; Fountain Is Ahead of Maxwell in Race for Governor.

Charlotte, June 6.—(AP)—Lead of R. R. Reynolds, of Asheville, over Senator Cameron Morrison in their race for the United States Senate neared the 5,000 mark today as late returns from Saturday's primary were posted.

With all but 275 of the state's 1832 precincts heard from, the Asheville attorney, who made his campaign on a wet platform, had a total of 127,320 votes as compared to Morrison's total of 123,077. The Reynolds lead was 4,243.

The other three candidates for the senate failed to gain ground as the returns trickled in. Judge Tim C. Bowie, of West Jefferson had 27,498. Frank D. Grist, of Raleigh, commissioner of labor and printing had 23,696 and Arthur Simmons, a Burlington poultry man, trailed the field with 2,549.

J. C. B. Ehringhaus, of Elizabeth City, continued to gain in the three cornered race for the gubernatorial nomination. With 1,450 precincts reported, Ehringhaus had a total of 142,938. Lieutenant Governor Rocky Mount, T. Fountain, had 96,861 votes and A. J. Maxwell, of Raleigh, commissioner of internal revenue, had a total of 89,844.

In the race for nominations for the state ticket, 894 precincts gave for lieutenant-governor: Graham, 96,985; Dellinger, 28,442; Giles, 20,229.

Threatens To Bolt G. O. P.

Chicago, June 6.—(AP)—Raymond Pitcairn, of Philadelphia, vice-chairman of the Republican citizens' committee against national prohibition indicated today the committee might launch a third party here should the G. O. P. convention fail to adopt a repeal plank.

Pitcairn advised Seymour Wheeler, local vice-chairman, a "wet" rally called by the committee for June 13 would be adjourned sine die to give the G. O. P. liberals attending it an opportunity to observe what action the national Republican convention starting on June 14 will take on prohibition.

"The mass meeting," Pitcairn declared, "was not organized with the idea of a third party in mind," but "should the platform builders pussyfoot on the prohibition issue the committee can reconvene for such action as they deem necessary to return this country to prosperity."

The committee against national prohibition is composed of former contributors to the party campaign funds who claim to have donated \$4,500,000 to the campaign of 1928.

The information was taken to mean that the new Socialist regime, under Carlos Davila, former ambassador to Washington, intends to proceed more slowly with foreigners than with domestic capitalist enterprises, in fulfilling its pledge to establish socialism.

The revolutionaries are moving swiftly today to set up its proposed Socialist regime. It prepared a number of decrees enabling the "First Socialist Republic of Chile" to take over immediately the productive forces of the country, to redistribute wealth by the imposition and confiscation of taxes and to seize various privately capitalized interests.

Loans to states unable to handle their own distress relief work limited to a total of \$300,000,000; loans to states, counties, cities, public or private corporation for starting self-liquidating or income-producing constructions; loans on agricultural commodities to assure carrying normal stocks and stabilize values and price levels; loans to the farm board for further financing of farm cooperatives and export of farm supplies.

Under this plan separate farm relief legislation would not be necessary but one bill would do the work, a material help with adjustment approaching. There was a possibility seen also that creation of the home loan discount bank system, described as a "necessary complement to the Reconstruction Corporation" might be put in the same measure. It is now before Congress separately, facing uncertain action.

The other points of the Hoover program required no legislation beyond the economy and appropriations bills now in the mill.

BOARD BEGINS BALLOT COUNT

Elections Board Closes Pitt County Returns from Saturday's Primary.

A canvass of election returns from the primary held in Pitt county last Saturday was started at the court house this morning by the Board of Elections. It was impossible to say when the canvass would be completed owing to the unusually large vote compiled throughout the county, but it was expected from two to three days would be required for the county.

Unofficial returns compiled from the fourteen precincts indicated a second primary from three different fields, namely, the House of Representatives, Board of County Commissioners and Constable of Greenville township.

Although E. G. Flanagan, incumbent, won out in the seven-cornered race for House of Representatives, neither Jack Edwards or J. W. Holmes, second incumbent, failed to obtain a majority. Whether Holmes would ask for a second vote was problematical but he was expected to make known his desire in the next few days.

The vote for the office was: Flanagan, 3,750; Edwards, 2,951; Holmes, 2,675; W. H. Laughinghouse, 2,102; C. K. Blalock, 265; D. S. Spain, 2,456.

With ten men running for the Board of Commissioners only Cox, Williams and Dudley obtained a majority, and this left the other two seats in doubt with four candidates, McLawhorn, Smith, Sumnerell and Joyner involved.

The vote was: Cox, 4,329; Williams, 4,288; Dudley, 4,209; McLawhorn 3,566; Smith, 3,513; Sumnerell, 3,508; Joyner, 3,291; Harris, 3,078; Porter, 2,629; Venters, 3,123.

Richard King led Gus Stokes, incumbent for the office of constable of Greenville township and Stokes stated emphatically today he would ask for a run-off to determine the race. More candidates were entered in this contest than any other race in the county. The vote follows:

King, 836; Stokes, 725; Fleming, 436; Jones, 138; Crawford, 9; Baker, 9; Savage, 53; Dixon, 241.

Bolling the heaviest vote ever cast in the county, other candidates won by clear-cut majorities, on the basis of complete but unofficial returns.

Fountain was given a tremendous majority over Ehringhaus and Maxwell in the race for governor. Fountain's vote was 5,247; Ehringhaus, 1,504; Maxwell, 648.

Reynolds also scored an outstanding victory over Morrison for U. S. Senate. Reynolds' vote was: short term 3,382, long term 3,421; Morrison, short term, 2,176, long term, 2,038.

A. B. Corey won over F. M. Woolen for state senate with a vote of 4,581 against 2,548 for Woolen.

Sheriff Sam Whitehurst emerged winner in the four-cornered race for sheriff. His vote was 4,290 Tucker, 1,962; Jackson, 594; James, 752.

Dink James captured the judgeship of county court from Chester Harris by a comfortable majority. The vote was: James, 4,471; Harris 2,548.

Jack Spain was victorious in the three-cornered contest for solicitor of county court. The vote was: Spain 3,771; Brown 829; W. J. Bundy 2,885.
