REPUBLICANS STAGED DEMONSTRATION FOR HOOVER

Delegates At Chicago Convention Engage In Fifteen Minute Rally

SNELL BOOSTS G.O.P. RECORD

Delegates March thru Arena as Great Pipe Organ Peals Out, "California, Here I Come;" Prohibition Repeal Advocates Oppose Administration Re-submission Proposal.

Chicago Stadium, June 15.—(AP)—With a new show of confidence, the Hoover helmsmen steered the Republican convention unflinchingly today through a second session which raised enthusiasm to the peak of a twenty minute demonstration for the President.

In old-time fashion, delegates from every state paraded their banners to the tune of "California Here I Come," singing and clapping their hands, laughing and yelling, determined, it seemed, to leave no doubt that this is a Hoover convention.

Then they got through some routine business, and adjourned until 8 p. m., when the battle over a prohibition plank is to go to the floor and probably sweep on far into the night.

It was a mention of the President's name by Congressman Snell of New York, in his inaugural as permanent chairman of the convention, which set off the Hoover fireworks. After quiet was restored Snell went on with a speech hammering the Democrats in picturesque phrase, and praising Republicanism in rounded periods that broke the big stadium crowd into repeated cheering.

The only actual business of the short morning session was ratification of the work of several committees. It all went off with dispatch. Even a credentials report settling the explosive controversy over southern leadership, and excluding the veteran "Teles Joe" Tolbert of South Carolina from the convention, was adopted without a word of debate or a roll call.

The vice-presidency remained as much up in the air as ever, though the second renunciation by Charles G. Dawes started at least a momentary upturn in the stock of Vice-president Curtis.

Plan Funeral For Judge Johnston

Franklin, June 15.—(AP)—Funeral services were planned this afternoon for Judge T. J. Johnston, 58, outstanding Macon county barrister, who died yesterday at his home here.

Judge Johnston acquired the title of judge when he served in an emergency on the bench of the Superior court. He was once mayor of Franklin and had been attorney for both the town and county for several years.

Warren Praised by Capital Newspaper

The following reference to Congressman Lindsay C. Warren, of the First North Carolina Congressional District, appeared in the June 9th issue of Stars and Stripes, a National veterans' paper, published in Washington, D. C.:

FIND NO ERROR IN LEA CASES

Supreme Court Upholds Decision of the Lower Court in Trial of Leas and Davis.

Raleigh, June 15.—(AP)—The North Carolina Supreme court today found "no error" in two cases involving Luke Lea, Tennessee publisher, his son, Luke Lea, Jr., and Wallace B. Davis, Asheville banker, which grew out of the failure of the Central Bank & Trust company of Asheville.

The decision meant the elder Lea and Davis must go to State's prison to serve terms for violation of the state banking laws and Lea, Jr., must pay \$25,000 in fines and costs or serve a prison term. (Continued on page three)

GATHER FOR DEBT CONFAB

Statesmen from Dozen Countries Meet at Lausanne to Talk of Economic Recovery.

Lausanne, Switzerland, June 15.—(AP)—Statesmen of a dozen European countries began arriving here today in preparation for the opening of the international conference tomorrow which will make this Swiss city the center of much of the world's hopes for economic recovery.

The first problem to be discussed is relief for Germany from the burden of reparations payments, more than \$300,000,000 of which will fall due on July 15 unless a new arrangement is arrived at here.

The eve of the conference showed the whole problem shrouded in uncertainty. The most hopeful sign was the result of the conference last week-end in Paris between (Continued on page four)

Thousands of People Gather at Asheville for Fifth Rhododendron Festival.

Asheville, June 15.—(AP)—The fragrance of mountain laurel hung over thousands of people here today as a huge floral parade opened the fifth rhododendron festival.

This year more informality was planned with more beauty and mirth to dominate the three-day mardi gras of the Western North Carolina hills.

Today's parade approached two miles in length and more than 1,000 persons were here to take part in a mammoth pageant tonight. In the pageant, less of a thread of story will be followed. Instead, grace and beauty through dances and pantomime will be the object of those taking part.

Ten sponsors of Southern states were here to lend their aid in building a network of beauty around the events planned for today, tomorrow and Friday.

YOUTH SHOOTS DAD; IS JAILED

Albert Ludlum, Bladenboro, probably Fatally Injured by His 14-Year-Old Son.

Lumberton, N. C., June 15.—(AP)—Albert Ludlum, of Bladenboro, was taken to a hospital here early today with a probably fatal bullet wound said by police to have been inflicted by his 14-year-old son, Alton.

The boy was placed in jail by Chief Vance McGill, pending the outcome of the elder Ludlum's wound.

Police said the shooting was the outcome of an attempt by the boy to prevent his father from beating his mother.

After the family dispute, Alton came to Lumberton and stopped at the home of his sister, Mrs. R. A. Milligan. His father followed him, and the shooting occurred about midnight.

Mrs. Milligan suffered a slight hip wound from the same bullet that penetrated the elder Ludlum's abdomen. Physicians said he had little chance of recovery.

MISS SHARPE BURIED TODAY

Funeral for English Servant who Committed Suicide, Held in New Jersey.

Englewood, N. J., June 15.—(AP)—Attended by Gerald Shepherd, acting British consul general, who brought a wreath of red roses to be placed on the casket, funeral services were conducted today in an undertaking establishment for Violet Sharpe, English servant, who committed suicide at the home of Mrs. Dwight W. Morrow Friday.

Arthur Springer, one of Mrs. Morrow's secretaries, represented the Morrow family. Mrs. Morrow and her son and daughter, Dwight Morrow, Jr., and Constance, sailed for England on the Europa early today to join her eldest daughter, Miss Elizabeth.

Servants from the Morrow estate also attended the funeral. Among them was Septimus Banks, the butler, whose statements to police after Miss Sharpe's suicide, helped to establish an alibi for Ernest Brinkert.

House Puts Stamp Of Approval On Measure To Pay Off Veterans

Washington, June 15.—(AP)—Immediate cash payment of the \$2,400,000,000 soldiers' bonus certificates—demanded by 20,000 former service men bivouacked in the capital—was approved today by the House. The measure now goes to the Senate where leaders claimed enough votes for rejection. President Hoover has promised a veto if the legislation reaches the White House. The Patman bill passed by the House would redeem bonus certificates at their face value in new (Continued on page three)

VARIED CASES HEARD HERE

Sixteen Charges Disposed of in Regular Session of County Court Yesterday.

A variety of charges, ranging all the way from chicken stealing to violation of the prohibition law, featured the regular session of County court here yesterday. The docket was probably the heaviest in several weeks but work was completed during the late afternoon.

Jim Holloway, colored, charged with possessing more whiskey than the law allows, was sentenced to six months on the roads.

William Andrews, John Harris and Rufus Stancill, colored, charged with raiding more chicken coops than is advisable during a period of depression, were given terms on the roads. The first two received four months each and Stancill was given two months. (Continued on page four)

DOLLAR STILL HOLDS GROUND

America Successfully Meets All Foreign Demands On Its Supply of Gold.

New York, June 15.—(AP)—The dollar glistened in victory today while the financial metropolis hailed the end of Europe's long drain on American gold.

The Bank of France converted the last of its dollar balances into gold yesterday for eventual shipment in its own vaults. That meant America had successfully met all foreign demands on its gold supply, bankers said, and that the dollar had emerged a winner from the severest pressure ever imposed on a currency.

Thereupon there occurred in the foreign exchange market the strongest bull movement in dollars seen in many weeks. Bankers expressed satisfaction, seeing the removal of one of the principal factors leading to a lack of confidence in business and financial circles.

The Bank of France's withdrawal from this market yesterday of \$55,000,000 balances ended what was described as one of the most remarkable achievements in financial history. (Continued on page four)

Democrats Shape Repeal Plank At Capital City

Washington, June 15.—(AP)—Mindful of Republican prohibition worries in Chicago, a group of Democratic leaders here is shaping a repeal plank they confidently hope will win unqualified approval in the Windy City two weeks hence.

It still is rough-hewn. But in keeping with the entire 1932 platform 1,000 words, this plank uses just a few more than 50 to dispose of the liquor issue.

It declares for "immediate submission to state conventions" of a repeal amendment. This amendment would be so drafted as to assure state control of the manufacture and sale of intoxicating liquors. (Continued on page four)

J. P. FLEMING DIES SUDDENLY

Prominent Agriculturist Succumbs to Attack of Heart at His Home Early Today.

Julius P. Fleming, 54, prominent planter, died suddenly at his home here this morning about 4 o'clock as result of a heart attack. Funeral services will be conducted from the home at 400 Summit street Thursday afternoon at 4:30 o'clock. Rev. A. W. Fleischmann, pastor of Memorial Baptist Church will officiate and burial will be made in Greenwood cemetery.

Mr. Fleming, a native of this county, lived in Pactolus township until about four years ago when the family moved to Greenville. He operated a general store in Pactolus for many years but for the last several years had confined his attention almost exclusively to agriculture.

He was considered one of the foremost planters of the community and did much toward development of agriculture in the Pactolus section where his farm property is located.

He was a member of Memorial Baptist Church and the local Masonic lodge. He evinced much interest in church work and activities of the fraternal organization of which he had been a member for many years.

Mr. Fleming was of a kindly and genial disposition and was held in high esteem by many friends throughout the county. His death was received with profound shock, although he had not been in the best of health for some time.

He was the eldest son of the late R. R. and Sallie Perkins Fleming. Surviving are his wife, Mrs. Lydia Fleming; two daughters, Misses Nina and Margery Fleming, his step-mother, the widow of the late R. R. Fleming; one brother, Sugg Fleming; two nephews, Bob (Continued on page four)

PUSH WORK ON ECONOMY BILL

Congress Seeking Solution from Two Directions in Muddled Struggle.

Washington, June 15.—(AP)—A solution to the bewildering economy muddle was sought in two directions today by Congress as a means of hastening adjournment.

Conclusion of the conference between Senate and House on the national economy bill was anticipated although signs of discord pointed to a likelihood that disagreement would be reported on the important pay cut section. This would require new instructions from one or the other branch of Congress before a final solution could be obtained. Apparently the conferees were in agreement on virtually all else in the bill, and predictions were it would emerge carrying \$130,000,000 to \$150,000,000 in savings.

A reply from President Hoover was awaited by the Senate to its resolution, adopted yesterday, asking specific suggestions for further cuts in expenditures. This resolution was the outcome of reports that the President did not expect a balanced budget out of the enacted tax bill and the pending economy legislation in its present form. Many believed, however, that a substantial balance would be reached.

Meanwhile the Senate sought to dispose of its controversial farm relief bill, and to take up the navy appropriation measure, which Senator McKellar (D. Tenn.) sought to have cut by a flat ten per cent, like several other supply bills previously acted on.

The House worked to get through with the Patman bill to pay the soldier bonus, a measure on which an immediate vote is to be demanded in the Senate.

FILES NOTICE OF APPEAL AT CAPITAL CITY

Former Detective was Charged with Swindling Mrs. McLean in Lindbergh Kidnaping Case.

Washington, June 15.—(AP)—Gaston B. Means today was sentenced to 15 years imprisonment for swindling Mrs. Evalyn Walsh McLean of \$104,000 in an alleged plan to return the kidnaped Lindbergh baby.

Justice James M. Porter in the District of Columbia Supreme court sentenced the former Department of Justice investigator to ten years on the larceny of \$100,000, ransom money and five years for larceny of the \$4,000 expense money. The latter sentence is to begin after the ten year sentence has been fulfilled.

T. Morris Wampler, one of the Means' defense counsel, noted an appeal.

Justice Proctor, in addressing Means, said "the verdict reveals that the defendant capitalized not only on the sweetest and tenderest emotions of the human heart, but also on the basest in his devil and adroit plan.

"The Lindbergh case brought out all the best in the hearts of men but also gave the opportunity to some to display the weakness and wickedness of human nature."

Chadwick Faces Extradition To Jacksonville, Fla.

Raleigh, June 15.—(AP)—Governor O. Max Gardner having honored requisition papers for the return of David N. Chadwick Jr., from Wilmington to Jacksonville, Fla., on check forging charges, a possible habeas corpus writ today was the only hope the former Wilmington city commissioner had of escaping extradition.

In Wilmington, Chadwick said he did not know what step would be taken by his attorneys, who had not reached there after attending the extradition hearing here.

Chadwick is under bond awaiting trial in Richmond, Va., for attempting to dispose of \$90,000 worth of bonds which were part of the loot of a Philadelphia bank robbery. He is also charged in Richmond with attempting to bribe a detective investigating that case, and (Continued on page three)

Davis, individually, was convicted in another case and was sentenced to five to seven years.

Service of sentences in the two cases will probably not start until next month.

The Supreme court, under its usual procedure, certifies its opinions down to a lower court the first Monday in each month and the sheriff of the county in which the case was heard then issues warrants for the defendants.

Chief Justice W. P. Stacy wrote the opinion in the case involving the three men, with Justice W. P. Brogden dissenting.

Justice George W. Connor wrote the opinion in the Davis case.

Judge Stacy, in regard to the contention of defense attorneys that conviction was gained on circumstantial evidence, said:

Ragon said he thought it fitting that since Representative Eslick (D. Tenn.) died in the midst of the discussion yesterday that all debate should be ended with his remarks.

Passage of the legislation within a few hours was predicted by House leaders.

Aubrey L. Brooks of Greensboro, a leader in the fight for Roosevelt in this state, said he was ready to try and have the delegates to the National convention formally instructed for the New York governor.

W. H. S. Burgwyn, of Northampton, said he would try to have the delegates from the Second Congressional District pledged to Mr. Roosevelt.

Latest interest in the Reynolds-Morrison fight here was centered on the fact that Reynolds and his State manager, David L. Strain, have been riding over part of the state in the automobile of Frank D. Grist, who announced his support of Morrison within a few hours after he joined Strain his automobile and agreed to confer with Reynolds on the Senate race.

Grist ran fourth in the five-cornered senatorial race in the first primary. After the result was known, Reynolds said Grist had assured him of his support and D. M. Blankenship, Mecklenburg county manager for Grist, said the Commissioner of Labor was actively working for Reynolds.

Monday afternoon Grist issued a blistering statement, flaying Reynolds' record in war times and urging that voters cast their ballots for Morrison.

At the time this statement was being issued from Morrison's state headquarters here, Strain was en route to Greensboro in Grist's automobile to meet Reynolds and expected Grist to join them in the Gate City for a conference that night. Strain says he had been assured the support of Grist.

When Strain and Reynolds arrived in Chapel Hill yesterday in Grist's car, which bears the license number "17," showing it belonged to a State official, quite a sensation was caused in view of Grist's announcement for Morrison.

WARREN IS PRAISED BY CAPITAL PAPER. (Continued from Page One) years old, black-haired, and good-looking, serving his fourth term as a member of the House representing the "stormy district" around Cape Hatteras, is perhaps the most colorful.

Garner has called on him to "sit in" on two of the most important pieces of legislation before this session of Congress. He was in the chair when the House voted to create the gigantic Reconstruction Finance Corporation. And he held the gavel during consideration of that perhaps most troublesome bill of all—the economy proposal.

Youthful in appearance, Warren rules with an iron hand, has no patience for quibbling and long harangues on parliamentary tangles.

Frequently, when a point of order is raised and members prime themselves either to defend or oppose it with long speeches, Warren will break in even while a member is speaking to say firmly:

"The chair is ready to rule."

He rules right then and there, too. And the House's best parliamentarians seldom contest one of his decisions.

Actually, he was given ovations both at the conclusion of the Reconstruction Finance Corporation debate and that on the economy bill. No less a parliamentary expert than Clarence Cannon, of Missouri, admittedly about the best in the House, when the economy bill had been disposed of, provoked cheers on the floor when he said:

"Mr. Speaker, I trust it will not be amiss to refer at this time to the ability and impartiality of Mr. Warren * * * during consideration of the most difficult bill this session."

Warren is one of the wheelhorses of the Democratic organization. They turn to him when there is placating to be done, when some unruly Democrat gets off the reservation, or when there is need of compromise.

His humor, diplomacy, and tact have made him a main cog in the organization machinery of the House.

Stock Market

New York, June 15.—(AP)—Financial markets pushed quietly but steadily forward today, in response to banking advices that the drain upon American gold stocks was virtually at an end.

Stocks registered numerous gains of 1 to 5 points or so, as bonds went ahead under leadership of U. S. Governments, and bank stocks were strong over the counter. Principal commodity markets also developed a better tone.

Shares up about 2 to 3 included such issues as American Telephone, American Can, Case, Allied Chemical, American Tobacco, Liggett & Myers, B. Santa Fe, Macy, Union Pacific, Eastman, National Biscuit, Public Service of N. J., and others.

People's Gas and Detroit Edison rose about 4 and 5, and Auburn pushed up several points. Kansas City Southern pfd gained 4.

The midweek business and trade statistics were if anything somewhat more encouraging than last week. Electric power production in the week ended June 11 was off 11.1-2 per cent from last year, as against a shrinkage of more than 13 throughout April. "Iron Age" said steel production was off a point to 19 per cent of capacity, but spoke of a possible summer upturn, should political and financial uncertainties be lifted. The weekly petroleum statistics showed slight gain in crude output, but further shrinkage in gasoline in storage. International banking quarters were not much concerned over the Lausanne conference, feeling that permanent solution of the debt problem may be postponed to autumn.

Among individual shares, Auburn continued to gyrate rather wildly, despite Prof. Ripley's characterization of the market performance of that issue as "outrageous," before the senate committee yesterday. Macy advanced sharply on ordering of the regular dividend, and Kansas City Southern, pfd, was helped by halving of the common dividend.

Dawes Declares He Will Not Be Able To Accept Republican Nomination

Washington, June 15.—(AP)—Charles Gates Dawes, in a formal statement today, said he could not accept the Republican nomination for the vice-presidency if it were offered him.

The former vice-president, who concludes today his tenure of office as president of the Reconstruction Finance Corporation, said he had given the question of the vice-presidency "considerable thought."

He made the statement at his home in the Willard Hotel personally telephoning it to the Associated Press.

"The situation in the convention as to the vice-presidential nomination, as reported by the press this morning, would seem to call for a more explicit statement of my attitude," Mr. Dawes said. "To have been considered for this nomination is a high honor and I appreciate the proffers of support. I have given the question considered thought.

I could not accept the nomination, if made."

Chicago, June 15.—(AP)—The flat statement Charles G. Dawes in Washington that he would not accept the Republican vice-presidential nomination inspired followers of Charles Curtis today but did not entirely quench the fervor of Dawes followers.

His own state delegation of Illinois, voted in the face of warnings by its leaders, to support Dawes for the nomination.

It remained to be demonstrated, however, whether the movement against the vice-president had gained sufficient strength to swing to one of a half dozen other prospective candidates.

While the Dawes tide was rising, supporters of Curtis have been trying to raise ramparts to resist any other attack that might be made.
