G. O. P. ADOPT PROHIBITION RESUBMISSION PLANK

President Hoover Renominated by Republicans at Chicago State Democrats Pledge Support To Roosevelt

New Yorker Receives Unanimous Favor From Convention At Raleigh

IS ACCORDED RISING VOTE

North Carolina's 26 Votes to National Democratic Convention Are Pledged to Governor Following Rousing Address By George Freeman; Resolutions by Daniels Accepted Unanimously.

Raleigh, June 16.—(AP)—North Carolina's 26 votes in the National Democratic Convention were pledged to Governor Franklin D. Roosevelt by the state convention here today.

At the conclusion of his address, the Raleigh editor moved that the resolution be adopted by rising vote. Scarcely a delegate retained his seat when the motion was put.

Consideration of the Shuping resolution came upon the heels of the keynote speech by Col. George K. Freeman of Goldsboro, who lauded the Gardner administration in North Carolina, and declared that the welfare of the country demanded defeat for the Republicans in the coming national election.

The platform committee was busy at its task of drawing up a draft of principles to be submitted to the convention. Nine delegates at large to the Chicago convention were elected, to cast four votes.

STATE G. O. P. SEEK DRYNESS

Says Republican Prohibition Plank Not Dry Enough to Suit Them.

Chicago, June 16.—(AP)—The Republican administration prohibition plank recommending submission to the people for a vote on the 18th amendment is not dry enough for some leaders of the North Carolina delegation.

While they prefer this to the substitute offered in the minority report, both Clifford C. Frazier, Greensboro attorney, and Jake Newell, senatorial nominee of Charlotte, say they will not support it in the campaign against the Democrats.

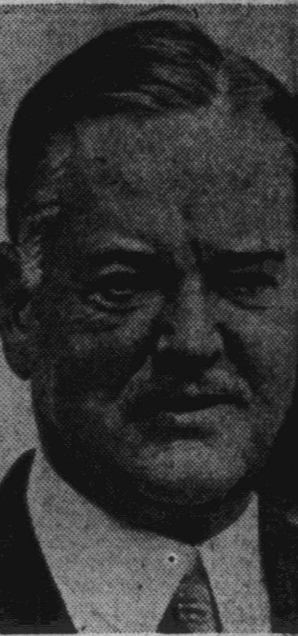
RESCUE CREW OF GREEK STR.

Rocky Mount Man Files for Second Primary Against J.C.B. Ehringhaus.

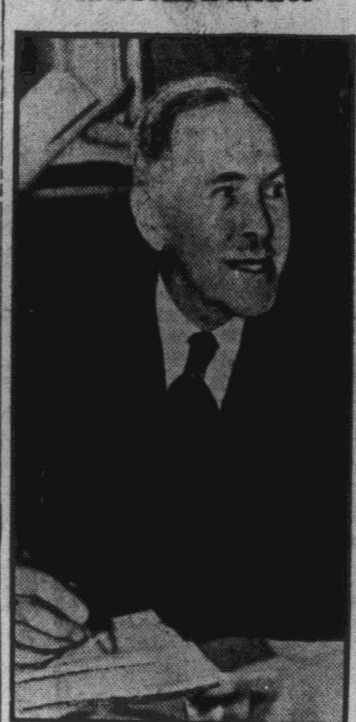

RECTOR MUST DIE JULY 1ST

Supreme Court Dismisses Proceedings Against Condemned Rapist.

Raleigh, June 16.—(AP)—While Willie Rector, Burke county mountaineer and convicted rapist, lived "forgotten" for nearly eight months on death row at state's prison, he had hopes for life but the Supreme court "remembered" him and now he must die.

Rector was placed on death row and apparently forgotten when an appeal from his death sentence was not perfected. Recently his case came to light and the Supreme court looked over the case in an attempt to straighten it.

Checking the case, the Supreme court dismissed the proceedings and set the date of his death as Friday, July 1. He will be electrocuted then unless Governor Gardner intervenes.

HOOVER BOOST IN PLATFORM

Hoover's Personal Lieutenants Beat off Spectacular Attack For Prohibition Repeal, But Attempt to Gauge Its Effect; Idaho Defiantly Oppose Administration Plank.

By FRANCIS M. STEPHENSON (Associated Press Staff Writer) Chicago, June 16.—(AP)—Republicans embarked on the 1932 campaign today anxiously pondering the effect of the unparalleled wet and dry set-to-over adoption of the party's new prohibition revision stand.

A militant drive for repeal stirred the national convention to its most spectacular platform battle of years last night and showed more than a third of the delegates for this position. There were 472 votes for such a stand and 681 against.

President Hoover's personal lieutenants who beat off this attack from the convention floor were not exulting over victory but were attempting to gauge the reaction of the prohibition forces who passively helped them down the repealists.

It was the prohibition plank, declaring against flat repeal of the 18th amendment but calling upon Congress for a statute providing federal control of the liquor traffic which made everything else unimportant to most of the delegates for the time being.

Wary from almost 36 hours of constant work on the party's policies for 1932, the bespectacled James R. Garfield, son of the late President, read the planks to the restless convention. Loud cheers and loud boos interrupted announcement of the resubmission declaration.

Democrats are beginning to shape a prohibition repeal plank at Washington, according to latest reports received down this way. It is believed such a plan will win unqualified approval of delegates to attend the convention in the Windy City, and a big part of the public.

The saloon is frowned upon, it is reported, and declarations for promotion of temperance and suppression of liquor traffic in the states desiring to remain dry are also included.

Just what the convention will do with a plank of this kind is problematical, but it is certain some step looking to improvement of the present conditions in this country will be taken in view of the widespread and insistent demand from powerful organizations and personalities.

The insertion of this plank in the platform represents a tremendous undertaking and the best brains of the party will be tested before the matter is finally concluded.

Greenville has been placed on an important tourist route and as a result of this action the city and community may enjoy some of the tourist trade passing through this section of the state.

The route through this city is designated in red on important highway maps, and advantages of the community will be set forth through the same medium.

Action looking to placing the city on the route has been contemplated for some time but was not actually decided upon until recently when a group of prominent business men made it possible.

The business men here are taking advantage of every opportunity to bring Greenville to the attention of the outside world and this latest stroke should accomplish much in this direction. Time alone will judge of Bill Terry's ability to handle a big league club, but there is no denying the big first baseman has made an imposing start as Major Domo of the Giants.

When he took them off John McGraw's tired hands less than two weeks ago, the New Yorker was running eighth in the National.

All Terry did after he took charge—for publication, at least—was to abolish the 11:30 "curfew" rule and appoint a new club doctor. But it hasn't looked like the same team.

Today the Giants stood in fourth place, only four games from the top, after winning eight out of ten games played under their new foreman. A costly error by Bill Herman Chicago second baseman, gave the "Terryers" five runs in the eighth inning and a 6 to 3 victory over the Cubs in their opener yesterday.

Two were out and the bases filled when Herman let Lindstrom's grounder get away. Then the deluge. Up to the eighth Pat Malone had given the Giants only three hits.

The defeat did not cut into the Cubs' lead over the field, however, as the second place Boston Braves were dropping a 5 to 2 verdict to Pittsburgh, largely the result of Tony Piet's triple with two on in the eighth.

Floyd Caves Herman had a happy homecoming at Ebbets Field as the Cincinnati Reds trimmed Brooklyn 5-1. The Babe hit a homerun, a triple and a double and drove in three runs against his former mates. Reliable Red Lucas yielded seven hits in winning his eighth victory. The Phillies took a shortened contest from the Cardinals, they went back at it last night 7-4, rain stopping play in the 7th.

The American League's three top teams encountered defeat at the hands of western rivals. The Yanks dropped a close one to the Chicago White Sox, 2-1. Lou Gehrig's 14th homerun averted a shutout for the leaders.

Earl Webb, playing his first game in a Detroit uniform, teamed up with Gerald Walker to defeat Washington 7-6. Each bagged two doubles, and between them they scored

three runs and batted in five. The St. Louis Browns shaded the Athletics, 9-8, when they scored twice in the ninth.

Cleveland made it a clean sweep for the west as Wes Ferrell turned back the Boston Red Sox 9-3 for his 12th triumph.

(Continued from Page One) ten per cent cut in salaries, but was bound to uphold the furlough idea. A decision on further procedure was sought today.

Except for this legislation so vital to the balanced budget aim of the administration and Congress, things were moving fast. Pending a vote on the bonus bill passed by the House yesterday, the Senate prepared to deal with the navy's appropriations. It got rid of the farm relief question, probably for the session, by sending back to a committee the combination fee-allotment debenture - equalization bill, whose constitutionality was challenged in stormy debate.

Prospects were that by the end of this week or beginning of next the delegate unemployment relief question would come to a Senate vote. There will be a struggle to cut out the provisions in the Senate bill for a \$40,000,000 public works bond issue which most Democrats and Republican independents favor.

The House took up today the Fulmer bill for enlarging the Red Cross stock of wheat for relief purposes while its rules committee debated whether to bring out farm relief legislation.

After passing the bonus bill yesterday, the representatives approved, and sent to the Senate the final item in the President's reconstruction program—a bill to set up a huge system of home loan banks. Already approved by the Senate banking committee, the bill is expected to go to the White House before end of the session.

The irregularity was regarded in some quarters as indicating rather an easier technical position after the rallies of some 30 to 35 points from the recent low records.

Liverpool cables reported continental buying and covering in that market influenced by the reports of increasing weevil infestation in the South and said there was an improved cloth demand for South America.

Stock Market

New York, June 16.—(AP)—The stock market encountered some resistance to its advance as it approached the peak of the upturn of a fortnight ago today, but after early hesitancy, the list managed to creep higher under leadership of the rails.

Factors making for hesitancy may have been the opening of the Lausanne conference, and the appearance of the bonus bill in the Senate, but further pronounced strength of the dollar in the foreign exchange markets, and a good tone in bonds, helped to maintain a fair degree of cheer.

A few early declines, amounting to a point on American Telephone, Case and Eastman, were recovered, and issues selling at net advances of 1 to 2 points by early afternoon included New York Central, Chesapeake and Ohio, Southern Pacific, Santa Fe, Union Pacific, Norfolk and Western, American Tobacco B, National Biscuit, Dupont, Allied Chemical, and others. Sugars remained firm, with Central Acquires up nearly 2. Such issues as U. S. Steel, American Can and General Electric were up fractionally.

The adverse report of the Senate Finance committee on the bonus measure was soon followed by a better tone in stocks, but this seemed to have been largely a coincident, since financial quarters have not expected enactment of the measure. This has been evident in the good tone in U. S. governments and in the dollar. The sugar stocks continued to improve in response to the betterment in the statistical position in that commodity.

The renomination over with, the delegates had only to select a Hoover running mate before going home. It looked more and more like a renomination for Vice-president Curtis, too, as the vote approached.
Herbert Hoover was pictured as the "ideal standard bearer of the Republican party" by Joseph L. Scott of California in nominating his old friends for the presidency.
Scott told the delegates to the convention that the President was a "past master in that greatest of all branches of engineering that I like to think of as 'human engineering'." Mr. Hoover was described as a "man who has given and is giving his time, his energy, his whole be-

MacDonald Says Europe Must Have U. S. Support

Lausanne, Switzerland, June 16.—(AP)—Europe cannot act alone but must have the help of the United States in solving the world's economic trouble, Prime Minister Ramsay MacDonald of Great Britain arrested today as the delegates of thirteen nations opened a conference on reparations and war debts here.

"The United States," said he, "has encouraged us to believe it will cooperate in some of the wider problems and join us in devising a policy for the encouragement of trade and the enrichment of nations."

This address, after his election as chairman of the conference, was the only one of major importance in a session which lasted over an hour. The continuing crisis, he said, is the worst with which the world has ever been

afflicted. It amounts to a "world catastrophe."
"We meet under the shadow of the most ominous economic crisis which ever afflicted the world in time of peace." Mr. MacDonald said, "the whole world looks to us as it never has looked to an international conference before."
"The world looks on not only in need but in impatience. My appeal to you is to fear nothing but weakness; to issue bold proposals which by their very character will command the support of the whole world."
"In these times there is no Italy, no Germany, no America, no Britain apart from the rest of the nations. There is nothing smaller than a world, nothing less than a system which is crumbling around our feet. None of us can stay out of the miseries which are gathering about us."

Chicago Stadium, June 16.—(AP)—Dr. Joseph I. France of Maryland was forcibly ejected from the speaker's platform at the Republican convention today as he sought to get the floor.
His name had just been placed in nomination, and his plan had been to make a nomination himself in behalf of former president Coolidge.
"They will have to carry out a presidential candidate to stop me," France had told newspaper men. Police did practically carry him out a few minutes later.
