Debt Conference Halted As Deadlock Continues With France - Germany

ARGUE SCOPE OF SESSIONS

Reported That M. Herriot Has Compromise to Offer as a Solution of The Franco - Germany Difficulty; Tomorrow's Session Postponed to Permit Private Negotiations.

Lausanne, Switzerland, June 20.—(AP)—The international debts and reparations conference was delayed today because the French and German representatives were deadlocked in committee over fundamental differences as to the scope of the meeting.

The Germans insisted the open session scheduled for tomorrow should permit debate centering about total cancellation of reparations.

The French demanded that Germany admit she can pay something. This was in line with Premier Herriot's assertion on the opening day that cancellation of reparations is secondary in importance to action on removing tariff barriers.

It was reported this evening that M. Herriot had a compromise to offer as a solution of the Franco-German difficulty. Tomorrow morning's session was postponed indefinitely to permit private negotiations.

Six northern European states were prepared to introduce the question of reduction of tariffs into the conference on war debts and reparations.

They are Belgium, Luxembourg, Holland, Denmark, Sweden and Norway. Fortified by a letter from King Albert of the Belgians the foreign ministers of six states, all signers of the Asio protocol of 1930, passed a resolution at a meeting yesterday proposing tariff reduction as one means of erasing the world economic crisis.

"Since the end of the war," King Albert wrote Premier Jules Renkin of Belgium, one of the delegates, "all experts consulted by the governments have invariably expressed the opinion that prosperity of dependent upon freedom in the circulation of goods, capital and labor."

"Unfortunately these grave warnings were not listened to. Consequences of the policy of restriction have been fatal."

Under the Oslo protocol these states agreed to respect, as far as possible their reciprocal interests and to act in concert with a view to general improvement of trade. The necessity of remedying the disorganization of monetary systems and of reestablishing international credit was urged in the foreign ministers' resolution. The six countries are agreed, the resolution said, that "the erection of new tariff barriers and various other restricted measures has contributed in great measure to aggravate the present crisis."

Three Killed As Car Plunges Off N. C. Mountain

Micaville, June 20.—(AP)—A car which plunged 200 feet off a precipice of Flat Top Mountain, just over the line in Tennessee, carried three Yancey county men to their deaths in Spivey Creek before the eyes of a party of campers.

The bodies of Dewey McIntosh, 27, and Ivan Roland, 28, were recovered immediately by the campers, but a deep pool had to be drained before authorities could find that of Claude McIntosh, 21, Dewey's brother.

The accident occurred on the Burnsville-Erwin highway.

Robbery Victim Improving.
Rutherfordton, June 20.—(AP)—Leonard Austin of Charlotte, who has been in a hospital here a week, most of the time unconscious, was reported better and physicians said he soon would be able to give an account of himself. He was found unconscious near Lake Lure apparently having been kidnapped and robbed.

WOMAN FLIER REACHES N. Y.

Amelia Earhart Putnam Given Welcome to Nation's Metropolis Today.

New York, June 20.—(AP)—Amelia Earhart Putnam, the first woman to pilot an airplane across the Atlantic, returned home today to receive the plaudits of her fellow countrymen.

A crowd estimated by police at 5,000 was gathered in Battery Park as the flier stepped back onto American soil from the city boat Riverside, which had transferred her and her husband, George Palmer Putnam, from the liner Ile De France at quarantine.

Harbor craft saluted the woman flier as the Riverside moved up the bay under escort of fire boats shooting streams of water into the air.

After leaving the Riverside the woman flier and her husband and official welcoming party entered automobiles and the parade was begun to City Hall where several thousand persons were already massed in the plaza.

SPEED PLANS ON DISARMING

U. S. Joins Tri-Power Effort for Success of Conference At Geneva.

Geneva, June 20.—(AP)—The United States joined in a special three-power effort here over the week-end to reach some plan by means of which the world disarmament conference might be brought to an end with a measure of success.

With President Hoover in communication, over the trans-Atlantic telephone, with the American delegation, representatives of the United States, Great Britain and France laid the plans of each country on the table and sought to find some common denominator for them.

CHOIR SINGER FACES TRIAL

David Hutton, Husband of Aimee Semple McPherson, In Breach Suit.

Los Angeles, June 20.—(AP)—Investigations, threats and counter-threats having marked the warning up stages of the trial, David Hutton, choir singer-husband of Aimee Semple McPherson Hutton, the evangelist, was called into court today to defend himself in a \$200,000 breach of promise action which was brought by Myrtle Joan St. Pierre, a nurse.

The evangelist, who announced she "intends to stick by Dave through thick and thin," will be unable to attend the court sessions. She is in a sanatorium with an illness she developed during a recent tour of Central America. So serious is her illness regarded, plans are to keep all details of the trial from her.

Suit was filed by Miss St. Pierre last September after the marriage of the singer to the evangelist. The nurse was moved to file the suit, she said, after hearing a radio broadcast made by Hutton during a wedding breakfast following his elopement with the evangelist in which he referred to Mrs. Hutton as "the best little wife in the world." Miss St. Pierre alleged she was betrayed under promise of marriage.

SIX PERSONS FOUND DEAD

Canton, Ga., Man, Believed to Have Slain Wife, Four Children and Then Self.

Canton, Ga., June 20.—(AP)—Paul Hardin, his wife and their four children were found shot to death at their farm home ten miles southwest of Canton today.

Police believe Hardin shot his wife and children and then committed suicide.

The bodies were discovered by Hardin's father, John Henry Hardin, who went to his son's farm for a visit this morning.

He saw the bodies through the windows and notified police.

Believing one small girl was still alive, physicians hurried her to a hospital here but an examination proved she was dead.

An inquest was under way.

NEGRO JAILED FOR STABBING

Jasper Cherry Held for Court After Fatally Cutting Lonnie Waddell Here.

Jasper Cherry, colored, was held in the county jail today on a charge of murder following the fatal stabbing of Lonnie Waddell, 30, also colored, on a lot in the tobacco district on Dickinson Avenue Saturday afternoon.

Given a preliminary hearing in mayor's court this morning, Cherry was remanded to jail without bond to face trial in the next term of criminal court.

The attack was reported to have occurred when Waddell drove his car to the back of a store, got out and asked Cherry, who was lounging around with several other colored people, to give him a cigarette. Apparently resenting the request, Cherry was alleged to have cursed with extreme violence, pulled a knife and drove it through the other's heart.

Appalled by the ferocity of the attack, Waddell bleeding profusely from the wound, jumped into the car and sped away. About four blocks away, he turned to a companion and said: "I am dying," and collapsed at the wheel.

NEW TAX BILL EFFECTIVE 21

Measure Placing Two Cents Tax on Checks to Go Into Effect Tomorrow.

Beginning tomorrow, the new Federal Revenue Act, which places a tax of two cents on each check drawn in this county, will become effective.

Under the legislation before the end of each month the banks of the nation will be required to go over each depositor's account, tally the number of checks paid through the banks, and must charge the account with two cents apiece tax on each check and remit this

QUIZ CAPONE IN BOMBING

Brother of Gang Head Questioned after Explosion at Home Of Chicago Mayor.

Chicago, June 20.—(AP)—Another Capone figure in the newspaper headlines today—Albert Capone, third of four surviving brothers, two of whom, Al and Ralph, have made gangland history in Chicago.

Albert was questioned by police in suburban Cicero in connection with an attempt early yesterday to bomb the home of Mayor Joseph G. Cerny, whose election last April was hailed as a death blow to the rule of the Capone gang in Cicero's affairs.

The bomb, hurled from a passing automobile, failed to strike its intended mark, but ripped a hole in the sidewalk in front of the mayor's residence. Mayor Cerny and his wife were spending the week-end in South Haven, Mich., at the time and the only occupants of the place

Roosevelt Looks To N. Y. To Decide Nomination

Chicago, June 20.—(AP)—New York with her 94 votes became the sudden focal point of Democratic pre-convention skirmishing here today as leaders of Gov. Roosevelt looked to the empire state to make a choice for him in the quarrel with Alfred E. Smith.

The Roosevelt captains say the New York decision, expected to be announced soon after the arrival of the delegation heads here Wednesday, will put their man "over the top."

James A. Farley of New York, head of the newly established Roosevelt camp here, won't comment on the probable decision in his state but he smiles and insists "Roosevelt will win on the first ballot—I mean that."

But there are about as many claims as there are candidates in Democracy's swiftly gathering convention conflict on this historic battleground and a lot of milling around is in prospect before the gavel falls next Monday.

FICKLEN BACK FROM EUROPE

Prominent Tobacconist Predicts Better Prices for Some Leaf Grades This Year.

The short tobacco crop in prospect this year should result, in improved demand and somewhat better prices on certain grades of tobacco, it was predicted today by James S. Ficklen, prominent Greenville tobacconist, who with Mrs. Ficklen, returned Saturday from a three weeks' trip to Europe.

In the face of upset conditions throughout the world and the decrease which has taken place in the consumption of tobacco the last six months, Mr. Ficklen said, it seems unreasonable to hope for any material improvement in the general price situation, although the prospective shortage of this year's crop should be conducive to improvement on certain types.

While in Europe Mr. Ficklen conferred with representatives of his concern in France, Holland, and England. He said his observation was that the depression which has afflicted this country, still prevails throughout Europe.

However, he stated, there is a feeling in some countries, particularly in England, that their own crisis has been successfully passed.

Mr. Ficklen stated that gradual improvement had taken place in England the last few months, and it is expected this upward trend will continue with the possibility

Washington, June 20.—(AP)—Dr. Sidney E. Goldstein of New York, today urged a Senate committee to pass unemployment relief legislation, warning its members that Congress dare not adjourn without meeting the situation.

He told the Senate manufacturing committee that "despair leads quickly to a state of desperation, and outbreak and explosion are nearer than our leaders realize."

Smithfield, June 20.—(AP)—Nine Durham persons are in a hospital here seriously injured as the result of the wreck of a large passenger bus on highway 10, two miles east of here, early today.

J. D. Simpson, a negro of Smithfield, was struck by the bus as it ran into a ditch. He was in a critical condition and physicians expressed doubt he would live through the day.

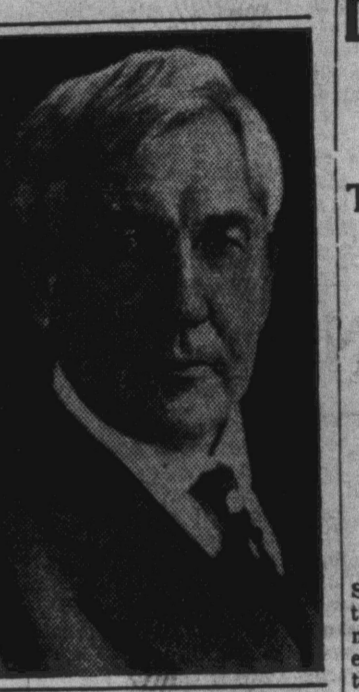

SEEK 'RATS' IN SLAYING

New York Police Attempt to Apprehend Slayers of Gangster Higgins.

New York, June 20.—(AP)—Vannie Higgins, who got careless, is dead, and the police are hunting "rats."

"The rats!" said Vannie Higgins, who was one-two-three among the big names of gangland until guns erased him yesterday. "They even tried to wipe out my family."

There wasn't much time to talk, for he had been shot four times. One bullet passed through his abdomen; but just before he died yesterday several hours after he was fired upon by mobsters, he said:

"I ain't saying who did it. I'll take care of them." But he died, and the police are trying to "take care of them."

They sought three men today for questioning. One of them is Salvy Spitala, whom Col. Charles A. Arny in the baby case. The others Lindbergh named as an intermediary (Continued on page three)

TWO NEGROES HURT IN FIGHT

Sam Carr Dangerously Cut by Elias Taft at Grimesland; Taft Also Injured.

Sam Carr, colored, was confined in the local hospital today suffering from dangerous wounds which he received in a fight with Elias Taft in front of a filling station in the Grimesland community during the week-end.

Taft, who was also badly injured when he was hit over the head by Carr with an automobile crank, was recognized by officers and ordered to appear here for preliminary hearing as soon as his condition permits it.

The two negroes, with several others, were returning to Greenville from Aurora on a truck. When the machine halted at a filling station, Carr was said to have attacked Taft with the crank. Taft, after being hit on the head twice, pulled his knife and slashed his assailant in the neck and under the arm, ripping long, jagged wounds in each place.

Carr was rushed to the local hospital for medical attention and was described as dangerously injured, although hope was entertained for his recovery.

The negroes were said to have been drinking heavily.

BEGIN DRIVE ON BIG SCALE

Tentative Overtures Made to Democrats as Disappointed Bonus Seekers Begin Organizing for Action Election Day.

all Democratic Presidential Candidates to be Queried.

Washington, June 20.—(AP)—Stripped of an immediate objective by defeat of the bonus-payment bill, leaders of the vast veterans army camped here concentrated today on organization day action, making tentative overtures to the Democratic party.

Finding the sixty-two senators who voted down their bill a rather diffuse target, the legislative committee of the army aligned itself against President Hoover and the Republican party.

Las, night it voted to query all Democratic Presidential possibilities or their views about the bonus and other veterans' questions, at the same time directing letters to all past or the American Legion and other ex-service men's organizations, informing them that an effort to place a bonus plank in the Republican platform, was laughed down and filed in the waste basket. "Think it over, man."

"Remember November," was the significant slogan line attached to those letters. Bearing in mind the possibility that neither the Democratic convention nor the nominee chosen there might give them any comfort, these political sappers of the ex-soldiers started formulating a "platform" of their own.

Still rather nebulous today, the platform had one definite plank: Repeal of the 18th amendment. Two Obians, William S. Keyser of Cleveland, and M. Bernstein of Dayton, proposed it, and the legislative group, composed of representatives of such major contingents or regiments in the army, approved it without difficulty. The general idea is that falling Democratic support, the soldiers should give their vote to some third party movement.

The exact size of the army, somewhere around 20,000, was much in doubt today. Many "veteran" members were taking French leave, but new contingents were pouring in and an aggressive recruiting drive aided by the wide-spread word that the army was gathering an abundance of food, appeared to be bearing some results.

The lack of an immediate objective, however, was helping stir friction in the ranks. A disgruntled former commander, George Aman, of Portland, Oregon, was seeking support from the men against his ouster from the post of billeting officer because of a quarrel with police authorities.

Walter W. Waters, the present commander in chief, late last night asked police to arrest Richard Lamb, 35, of Dallas, leader of the Texas contingent, saying his status as an ex-service man was questioned. He was held on an "investigation" charge.

Gets Drunk And Returns to Jail

Goldsboro, June 20.—(AP)—Wiggs apparently celebrated his third week of a six months' sentence for larceny, robbery and assault by getting drunk.

Wiggs, whose sentence ordinarily calls for a roads sentence, was assigned to work on public property and remanded to Wayne county jail.

He had been working about the courthouse grounds until police found him on Goldsboro street drunk, they said.

They took him back to the public property he had been assigned, but this time they enclosed him in a cell.

ABOUT TOWN

Pitt county's health queen did not win out in the district contest held recently at Washington, but she will always hold the honor of having one time been declared the healthiest young woman in the county.

These health contests should prove an inspiration to the various communities of the state and forever be an incentive to young people to strive to keep their bodies in the best physical condition possible. Nothing impels one quicker along the path of success than the vim, vigor and vitality accompanying the good health, and it should be the purpose of our young people to strive to keep their bodies as near perfection as they can and enjoy that buoyancy and optimism to be found in those who have lived cleanly and given themselves an opportunity to blossom forth in the glory and splendor of health.

Nicholas Murray Butler, advocate of repeal of the prohibition law, believes the Republican party is doomed to defeat if the resubmission plank adopted at the national convention in Chicago is not changed.

He described the plank as one of the greatest mistakes the party had made in years and predicted the defeat of President Hoover if this part of the platform was not denounced before election.

The distinguished educator was one of those who sought direct repeal of the dry law, but it is questionable if the party would have been more successful had this plan been injected into the platform. This is one of the most controverted subjects of the day and it is to be believed that the party seeking repeal would not get as many votes as the one standing for direct enforcement of the legislation as it exists.

Josiah William Bailey has called on the Democratic party to attempt to work along harmonious lines in the forthcoming campaign, believing this absolutely necessary to success.

The same opinion has been voiced by other leading men of the country, and if the party is not able to carry out its program in an harmonious way then it might as well stop and start over again.

The Republicans know they are up against one of the greatest problems of the day in attempting to convince the public of their ability to carry on successfully after such a defeat, and if the Democrats strike swiftly and concertedly their chance of victory is brighter than it has been since Hoover rode into the White House on such a tremendous landslide.

It is to be hoped the delegates to the national convention regard the unceasing plea for unity of action and in that way increase the chance of the party to regain the reins of government.

European statesmen are preparing a final reparations settlement without an American guarantee of cancellation or revision of war debt payments due the United States because such action would likely interfere with the coming presidential election.

That, at the least, is considered of the powers, but they might as well carry out their plan for anything they do at this late date will not likely be passed upon until the ballot fight has been completed.

It is not to be thought that Republicans would commit themselves on this question with such an important thing as a presidential election in the offing, and the boys at Luasane have no cause to worry about eventualities resulting from their action.

The Hornets, who won five of their seven games last week, climbed over Greensboro's shoulders back into the first division, half a game below the Twins and Tourists. The difference will be settled today and tomorrow, Charlotte opening the week with Asheville. After the mid-week stand with Raleigh the Hornets go to High Point.

The Lacy men fattened their batting averages considerably last week gleaming 53 hits out of 163 times at bat for a percentage of .325. Next in that department came the lowly Durham Bulls, who continue to bat above .300 for the season, although they have won and have a strange hold on last place.

Wilmington, which lost seven of its eight starts last week, takes on the Durham Bulls today, entertains Greensboro the middle of the week and then takes to the road to close the week at Asheville. The best the Pirates seem to be able to do is, with the cooperation of Durham's poor pitching, to stay out of the cellar. Yet a few weeks ago they were knocking first division clubs right and left, and for several days stood within striking distance of the top. A series of mishaps that cost them Noonan, shortstop; Galvin, catcher, and other players seem-

ed to provide a disruption which has not been overcome. Big Tom Wolfe, Durham outfielder, hit in 23 consecutive games—a league record—before being stopped in the tilt with Winston-Salem on Wednesday. NEW TAX BILL EFFECTIVE 21

(Continued from Page One) amount to the Federal tax collector.

While this places extra clerical work on the bank, it relieves the drawers of the check of the necessity of having to secure stamps or other instruments in connection with the new legislation.

A ruling recently handed down by Judge Paton, representing the American Bankers Association, was to the effect that depositors who wish to withdraw from the bank from time to time amounts to take care of petty cash items and small bills can call at the bank personally and give a receipt for the amount of money they wish to withdraw without being subject to the tax.

The ruling follows: "If, however, the withdrawal is made by the depositor personally and a receipt given therefor, doubtless the same ruling would be made as under the Revenue Act of 1898, that any receipt used for withdrawal of funds standing to the credit of depositors is taxable unless presented in person to bank from which it is to be withdrawn. In such case it is exempt. We quote from the ruling of G. W. Wilson, Commissioner of Internal Revenue, under date of April 12, 1899 (published in Treasury Decisions 21-20) as follows:

"A receipt must be presented personally by a depositor in order to be exempt from taxation. If sent by mail or through a third party it must be stamped. Therefore, any receipt used for the withdrawal of funds standing to the credit of a depositor must be stamped unless presented in person by the depositor at the bank from which the money is to be withdrawn."

Washington, June 20.—(AP)—Today is the last tax-free day for matches, automobiles, candy, radios, face powder, yachts, and all the tremendous list of articles brought into the Federal Government's revenue raising net by the new emergency tax law.

Anybody who has been waiting to buy, perhaps expecting prices to drop some more, had better do some hurried shopping, for a nice percentage probably will be found added to all price tags on taxed items by tomorrow.

After tonight the movies (except those you get in for 40 cents or less) will cost more, so will telegrams and long distance calls, while bank checks will cost two cents a piece.

It will not be necessary, however, to stick three cents stamps onto letters until next month.

(Continued from Page One) the discussions, extending them to representatives of other governments, especially Japan, Italy and Germany.

Those who participated in yesterday's conferences said they felt a useful preparation had been made. The Americans said they particularly got the impression the Europeans could "really determine to face realities and do business."

Senator Swanson asked that the American plan, which provides for a percentage reduction for all countries, after determining their defense needs by adding police needs to colonial defense requirements, be placed on the agenda of the informal talks, which will be resumed tomorrow.

Prime Minister Ramsay MacDonald of Great Britain, who came here from Lausanne for the week-end, explained the British plan for qualitative disarmament by means of a long holiday on certain arms of offensive character, and Joseph Paul-Boncour presented the French plan for a global cut in defense budgets.

The opinion was expressed in American and other quarters that some agreement would have to be reached within the next few weeks or the conference would have to admit failure.

Higgins was knifed in a brawl several months ago. Since then he has seldom ventured out without a bodyguard. Saturday night, in response to his daughter's pleading, he went with her and Mrs. Hig-

gins to an affair at the Knights of Columbus club in Brooklyn, leaving his bodyguard free. It was the opportunity his enemies had awaited. Two men loitered near his parked car. As he strolled toward it, the child at his side, he was halted. He turned and the guns of the men opened upon him. An automobile drew up, and several men in it opened fire. Higgins fell. He lived several hours, his conscious moments being given over to threats of what he would do. Higgins was in his early thirties.

Police held two theories. One was that Higgins had attempted to grab some of the beer business on the Jersey side of the river and had been killed for it. The other linked the murder with earlier crimes in which were the murders of Angie Pisano and others robbing back to the Frankie Yale colerie of several years ago.

Police did not say how they thought Spitalo, McCabe or William Bailey were expected to help.

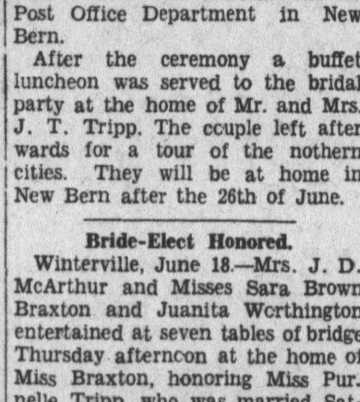

Man Injured As Tree Burns Down

Asheville, June 20.—(AP)—When Ed Thomas, of near Hot Springs, goes hunting again he won't build a fire against a tree and then go to sleep.

That's what Thomas did in the mountains near here when he became tired after tramping about for a while. After building the fire and going to sleep, he awoke, he said, with a feeling the mountain had risen up and sank down on him.

Fully awake, Thomas found the fire had burned the tree which had fallen on him. He was brought to a hospital with two broken legs.

Hold Doctor For Illegal Operation

Denver, June 20.—(AP)—Arrested on a murder charge in connection with an alleged illegal operation on a nurse, Dr. Guy W. Townsend, 48, Denver surgeon, was released from jail long enough to operate on another patient arranged for before his arrest.

Later Dr. Townsend was freed on \$5,000 bond to await action in the murder case.

The nurse, a young woman attached to the Army service at the Fitzsimmons General Hospital, died last Tuesday.

Dr. Townsend said he operated on her as an emergency measure, believing her life at stake, and described her condition as the result of a previously "bungled" operation of a similar nature. He said he attempted to reach other physicians for a consultation but was unable to do so and decided immediate action was necessary.

District Attorney Wettengel declared he was not satisfied with the surgeon's story. Officials were attempting to establish the identity of the person responsible for the alleged "bungled" operation.

NEW TROUBLE IN MANCHURIA

Powers Protest The Seizure of Chinese Customs by Pu-Yi Government.

Tokyo, June 20.—(AP)—The question of confiscation of the Chinese customs revenues in Manchuria by Hen Pu-Yi's government has been called to the attention of Japanese Ambassador Debuchi at Washington by Secretary of State Stimson. It was learned from an official quarter here today.

Secretary Stimson, this source said, called the ambassador's attention to American consular reports from Manchuria describing efforts of the Pu-Yi government to establish a customs autonomy there and assume control of all Chinese customs offices, including that at Dairen, which is on Japanese leased territory.

The British ambassador, Sir Francis Lindley, also visited the foreign office here and discussed the same situation. It was understood the powers fear the matter threatens the integrity of the Chinese maritime customs, by which a large portion of China's foreign indebtedness is secured.

The foreign office here takes the attitude that the situation does not justify the powers in reproaching Japan in any way. Japan disclaims all responsibility in the matter and all intention of interfering.

Japan, like America and Great Britain, is a creditor of China, a government spokesman said, and is interested that the service on its Chinese credits be secured on the customs. But she is confident, he said, that the Pu-Yi government, although claiming a customs autonomy, would continue somehow to pay Manchuria's share of the

debt services.
The question reached a crisis because the Pu-Yi regime demanded that all customs collected at Dairen be remitted to Changchun instead of to Nanking, where they were paid in entirety up to May 31. The Changchun regime charged that the refusal of the Chinese government at Nanking to negotiate the question made the compromise which Changchun offered impossible.

Colored Men Held for an Attempted Criminal Attack

John Fleming, colored, was held in the county jail here today charged with attempted criminal assault on Willie Mae Sneed, 7-year-old negro girl, in Skinner's ravine, yesterday evening.

Charges were brought against the man by the child's mother. Several neighbors were said to have seen Fleming while the attempted assault was in progress. He was reported to have been drinking heavily at the time.
