GARNER ADVOCATES REPEAL OF PROHIBITION LAW

Federal Employees Are Warned to Stay Out of Politics

Texan Declares Dry Law Has Never Been Sound Or Workable in America

PREPARES FOR COMING FIGHT

Returning to Washington After Being Confined with Illness Speaker of House Tells Newspaper Reporters that Altho He Has Not Solicited Support for Presidency He will do His Best to Serve His Country.

Washington, June 21.—(AP)—John N. Garner, speaker of the House and one-time Texas cowboy, swung his political larriat toward the Democratic presidential nomination today with a statement urging repeal of the 18th amendment.

Returning to the capitol after being confined at his hotel several days by illness, the Speaker handed newspapermen a statement saying: "When the prohibition amendment was proposed, I, as a member of Congress, voted against it. I have never believed it sound or workable and it should be repealed."

Garner added that although he had not solicited support for the Democratic presidential nomination he is "willing to serve my country and my party to the limit of my capacity."

This latter statement was interpreted by Garner's friends as a guarded announcement of his availability for the Democratic presidential nomination.

The Democrats of California and of my native state, Texas, are sending delegations to the national convention instructed to vote for my nomination for the presidency.

"This has been done without my solicitation. I appreciate the spirit of my friends and am willing to serve my country and my party to the limit of my capacity."

His statement follows: "Many of my friends, not only those residing in my own district and state, but throughout the country, have asked me repeatedly to express myself on various public questions."

"I have maintained the position assumed when I was elected as Speaker of the House of Representatives that I would not indulge in the discussion of controversial issues not immediately under consideration by the House."

"Moreover, during the thirty years I have been a member of Congress, practically every principle involved in the problems of the nation today have been before the House and my views thereon are a matter of record."

"This country has erected tariff barriers that are practically excluding the products of foreign nations. This makes it economically impossible for these nations to buy from us the products of our farms and our factories, thereby aggravating our industrial depression."

AUTRY HELD FOR SLAYING

Desperado Protests His Innocence in the Slaying of Prison Steward at Cary.

Raleigh, June 21.—(AP)—Still protesting his innocence, with the corroboration of a witness, James Autry was held without bond today on a charge of murdering prison steward B. H. Brantley when he and two others escaped from the prison farm at Cary, June 7.

"Cook will admit the shooting when he is caught," Autry said yesterday after he had said before Coroner L. M. Waring, sitting as magistrate in preliminary hearing, that Bob Cook, who escaped with him and Dud Travis, fired the shot that killed the steward.

Two honor grade prisoners testified, however, that Autry killed the steward. Two other prisoners, one a trusty, described the three men's break for freedom, but said they did not know who killed Brantley. The trio are alleged to have used the steward as a shield as they fled from the camp, and Brantley was shot to death as they commandeered an automobile on the highway.

H. E. Jones Jr., who was in the automobile taken by the three prisoners, two of whom are still at large, testified that Cook handled the deathgun. The prisoners are charged with having taken the pistol from a guard whom they had knocked in the head with an iron rod.

Police Convinced that There is Nothing to Report of Plan Blow Up White House.

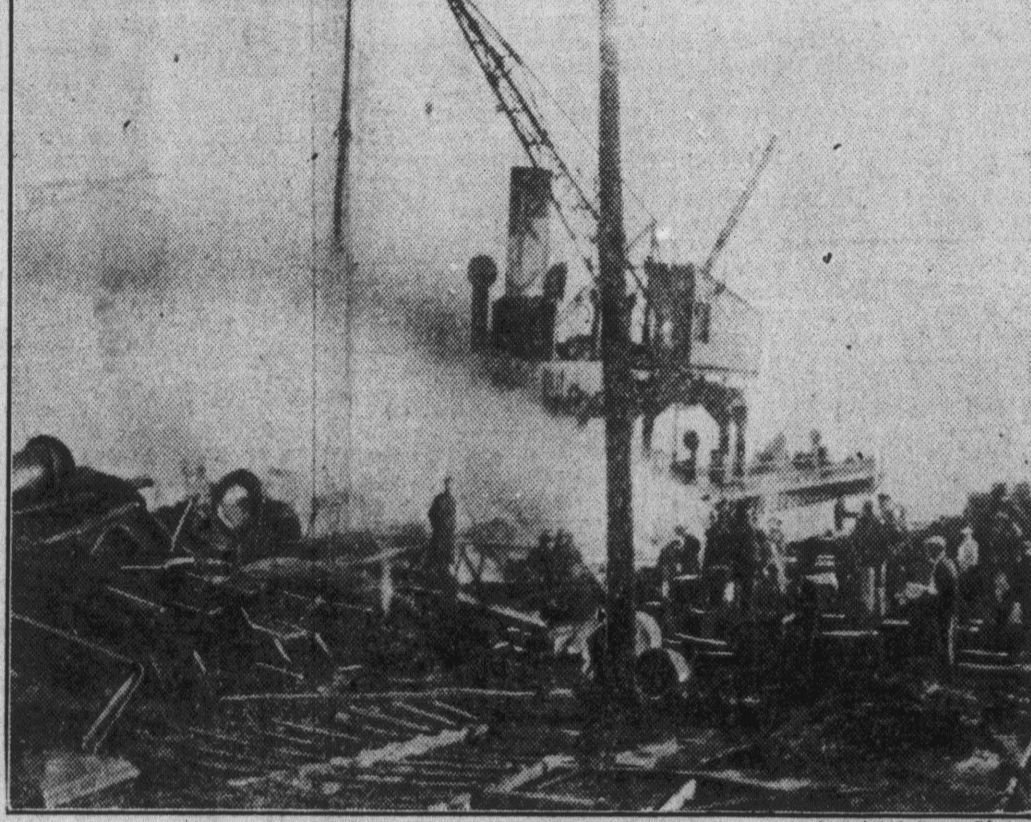

Exonerated In Auto Accident

Pittsboro, June 21.—(AP)—A coroner's jury's verdict today had cleared Captain A. L. Fletcher of Raleigh, deputy insurance commissioner of North Carolina, of blame in the death of Add Pendergrass, Chatham county farmer, fatally injured in an automobile accident.

Pendergrass was crossing the road near his house when Fletcher's machine struck him, it was shown at the inquest. The farmer was said to have been somewhat deaf and apparently did not hear the approaching car. The jury held the accident was unavoidable.

New York, June 21.—(AP)—Racket men shook their fists at the Fresh Meadow Country club today and muttered under their breath: "Foiled!"

Policemen guarding each green at the club and patrolling the boundaries of the club itself thwarted whatever intentions the racketeers may have had to destroy the greens with acid and thus prevent play, starting Thursday, in the national open tournament.

Forty officers watched outside the links, 18 were assigned to the greens and 17 others were distributed about the course last night. GIBSON TALKS WITH BRITISH

Says America Will Not Help with Debts if spending for Arms Continues.

Lausanne, June 21.—(AP)—Hugh Gibson, head of the American delegation to the disarmament conference, hurried up from Geneva this afternoon and talked for half an hour with Prime Minister Ramsay MacDonald and Sir John Simon, the British foreign minister.

He came with Norman H. Davis, another member of the American delegation, at a time when reports were circulating through Lausanne that the United States was ready to participate in cancellation of the war debts if Europe would cut down its outlay for armaments.

When they started back for Geneva with Sir John, Mr. Davis said that the talk with the British representatives had not gone into the debt issue and that his visit with Mr. Gibson "does not mean that we have entered the financial field."

But their presence here encouraged speculation, particularly in view of a midnight conference last night at Morges attended by Mr. Gibson, Premier Herriot of France and Joseph Paul Boncour, Mr. Herriot's cabinet associate.

COMMISSION IS AROUSED

Political Activities Of Groups of Federal Employees Prompts Civil Service Department to Take Drastic Steps to Stop Participation; Political Activity Declared In Direct Violation Of Civil Service Rules.

Washington, June 21.—(AP)—Federal employees were warned by the Civil Service Commission today to obey its rules not to take an active part in political campaigns or face the possibility of losing their jobs.

The commission, aroused by political activities of groups of federal employees, called to the attention of all of them long standing rules prohibiting participation in politics and told them each individual would be held responsible for the activities of any organization to which he or she belonged.

"To make a public attack on a candidate for public office is to take an active part in a political campaign," the commission said in its statement. "Such action is a violation of civil service rule 1 and may subject the offending employee to separation from the public service. If the attack is made by the joint action of several employees, the guilt is still personal and attaches to each employee separately and severally for the purpose of the administration of the civil service law."

At the commission it was said that one organization of federal employees had sent a circular letter to other associations of government workers and the American Federation of Labor urging the members to work against reelection of congressmen they believe to be unfriendly to their cause. This case now is under consideration by the commission.

The rules of the commission have been in effect for years, the statement said, adding that it was childish to assume that the protective provisions of the law could "outlive the full and impartial enforcement of its restrictive provisions."

The North Carolina Democrat yesterday assailed the President "for his abandonment of the dry cause" and said he should apologize to Smith for the campaign of abuse waged against him on the prohibition question "four years ago."

Washington, June 21.—(AP)—Senator Cameron Morrison thinks President Hoover owes former Gov. Alfred E. Smith of New York, an apology.

The President, Morrison charged before crowded galleries and an attentive chamber, had "taken the leadership of forces in the country opposed to revision of the prohibition amendment only how to surrender without a single solitary protest" in behalf of those who supported him in 1928.

ABOUT TOWN

Increase the buying power of the American people and the economic situation will undergo one of the most pronounced changes of the last two years, in the opinion of experts on economy.

The trouble with the country is not a lack of desire to buy, but an acute inability to do so caused by shortage of funds. Make it so more money will be available and the sluggish business world would be completely transformed.

Congress has attempted to improve conditions from time to time, but they started at the wrong end and have been operating from that inauspicious viewpoint all along.

By pouring out billions of dollars to railroads and other big corporations no relief was made possible except for the organizations and the few money interests which they represent.

Circulation of funds among the masses is the crying need of the times and not until some way has been devised to make this possible may the nation expect the recovery which President Hoover predicted some time ago, but which can't be found with a microscope even at this late date.

The curb market here is a source of pride to the people. It has increased its service until it has become one of the most vital mediums of exchange between the grower and the consuming public of the vicinity.

The only way to effect an improvement in the general business trend of this part of the state is to see that the buying power of the farmer and the laborer is improved, and the only way that can be done is through employment and market for his produce.

The curb market offers a splendid outlet to the growers, and also provides a direct means whereby the thrifty housewives may obtain the best the growers have to offer at proper prices and while the products are fresh and in fine condition.

Liberal support of the market is imperative because it means money in the pockets of the growers, who now as always, are the backbone of this great section of the state.

JINX STILL PURSUES THE BOSTON SOX

In all that has been said and written of records broken and records threatened in the current major league baseball race, one of the most interesting of the lot has been overlooked almost completely. The Boston Red Sox stand a fine chance of cracking the all-time American League mark for games lost in a season.

With the season well past the one-third post, the Sox have won just all contests, against 47 defeats for a percentage of .190 in the American League. Back in 1899 a Cleveland club of the old National League won only 20 games while losing 134. The Sox might not equal that mark, but they should have little difficulty bettering the next lowest record of 36 won and 117 lost set by the Philadelphia Americans in 1916.

By way of proving they could lose as gracefully for their new manager, Marty McManus, as they had for John Collins, the Bostonians dropped their opened to Detroit yesterday, 6-4. Three runs off Paul Andrews, late of the Yankees, in the first inning sewed it up for the Tigers. McManus became a full-fledged member of the managers' association when he was chased for arguing a decision.

The Yankees kept intact their 11-2 game lead over the field by beating St. Louis 3-1. Lefty Gomez held the Browns to three hits in achieving his 13th victory in 14 games.

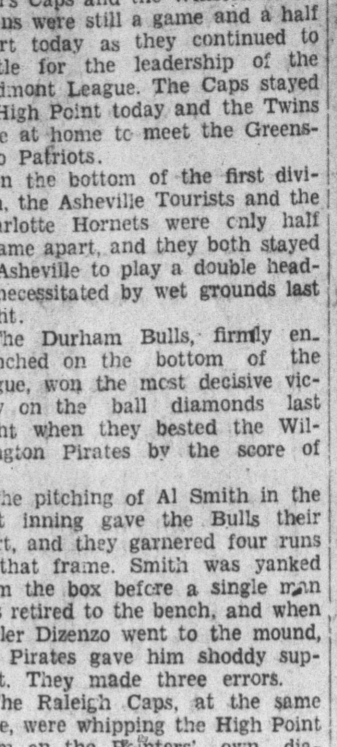

FARM NOTES

By E. F. ARNOLD, County Agent
The hog cholera control campaign closed last week. There were 3,408 hogs immunized for 239 farmers. In addition to the above, sixteen farmers have 300 hogs listed for vaccinating at a later date. For one reason or another, they were unable to have the work done during the campaign.

Pitt county has at the present time one of the largest hog populations it has enjoyed for a number of years. The farmers of the county are giving decidedly more attention to feeding, sanitation and breeding of hogs than heretofore.

The fact that a large number of farmers vaccinated hogs has prevented cholera outbreak in this county which has proved so destructive to the industry in past years.

The total for daily sales on the curb market continues to increase. The farmers are offering an increased variety of fresh produce for local shoppers. Greenville now has one of the best located and equipped market houses in the state.

The buying public of Greenville can find each morning on the market the following list of produce: beets, carrots, cabbage, collards, cauliflower, corn, garden peas, kale lettuce, mustard onions peppers potatoes, radishes, squash, spinach, snap beans, turnips, strawberries, huckleberries, dewberries, peaches, plums, shelled walnuts and pecans, meal, molasses, cakes, candies, pies, pickles, preserves, jams, jellies butter, cream, skim milk, buttermilk, eggs, chickens (live and dressed) meats, flowers and plants. All of these products come direct from Pitt county farms and when purchased, every nickel spent by the purchaser remains in Pitt county and will again be spent for the purchase of articles offered for sale by merchants and dealers of this section.

If the merchants of Greenville and the surrounding towns are to experience better times, the buying power of the farmers must be increased. The purchasing of his products is a direct way of increasing the farmers' buying power. Therefore, your patronage of the curb market is solicited as one means of bringing better times to Pitt county.

The dairy industry in Pitt county is increasing. John T. Thorne of Farmville is installing a modern equipped milking barn along with a milk house. When this is completed, he will be able to pass inspection and sell whole milk on any market.

W. H. Dail, Jr., on his farm north of Greenville also has established in the past two or three years a herd of dairy cows from which he sells sour cream and retail milk in Greenville.

J. H. Boyd, Jr. has established a herd of cows east of Greenville. A. R. Barnhill, east of Greenville, has been milking cows for some two or three years now.

J. C. Galloway, Grimesland, is milking ten or twelve cows and delivering cream to Greenville and any surplus cream he ships to the Pomilio Creamery at Washington. There are also a large number of farmers who have from two to five cows who supply their own families and at times ship some surplus cream.

Along with these dairy herds you will usually find the development of a nice flock of poultry and a well bred herd of hogs. These farmers are not only increasing their income by the use of livestock but are receiving income at a time of the year when most of our cash crop farmers are borrowing money. In this way, they are able to pay as they go, thereby reducing the overhead expense of cash crop farming. Farmers this year experienced a very difficult time in securing sufficient cash to operate their

"Before genuine and permanent relief can be accomplished, the finances of the basic industries of this nation must be placed on a sane basis thereby removing the spectre of receiverships and foreclosures and restoring their buying power and ability to employ labor."

MAKE PAPER FROM PINE

Discovery that White Paper Can be Made from South's Timber Reported in Ga.

Savannah, Ga., June 21.—(AP)—A discovery that white paper can be made from virtually all the South's pine, opening vast new commercial fields for its forests, has been announced here by the Georgia State experimental paper mill.

Exhibits of white paper chemical pulp, made for the first time from long leaf and loblolly varieties which comprise eighty per cent of the Southern pine timbers, have been prepared for display before the Georgia Forestry association at Rome, Ga., tomorrow under supervision of Dr. Charles H. Herty, of New York, director of research, and former president of the American Chemical Society.

The new method of making paper is a development of Dr. Herty's earlier discovery that white paper and news print, contrary to a fifty-year-old belief of scientists and paper experts, can be made from slash pine.

Slash is confined to approximately 10,000,000 acres, chiefly in Georgia, Florida and a strip of the Gulf coast, but the new white paper pin—loblolly and long leaf—cover approximately 100,000,000 acres, constituting the bulk of the Southern forests through Virginia, North Carolina, Georgia, Florida, Mississippi, Alabama, Louisiana, Arkansas, Missouri, Tennessee, Texas and Oklahoma.

(Continued from Page One) submission plank, rejected the entire platform as inadequate and unresponsive to the demands of the people, and then, asked if he would support the President on that platform, he delivered his bombshell: "I will not."

The importance of the utterance lay in that Borah's driving campaign for Hoover in 1923 has been regarded as one of the greatest individual contributions to the President's election. A split between the two has been in evidence for some time, magnified by the senator's refusal to attend the party convention when the party trend on prohibition showed itself running counter to Borah's dry views.

Yet, in the belief of many, the senator's utterance yesterday bore an unspoken invitation to the President to write his own platform, with a strong personal prohibition stand, in the address accepting the nomination which Mr. Hoover is to deliver later in the summer.

Newspapermen who sought more explicit statements after the Senate speech, drew information that Borah had no intention of going into a third party movement. The idea developed that his thought was to ignore the presidential campaign and limit himself to stumping for dry members of Congress.

It is common gossip in the rapidly filling corridors about convention headquarters at the Congress Hotel that the anti-Roosevelt strategy is to give the governor his maximum strength on the first ballot. It is figured that cutting him down after the first ballot will be destructive.

The Roosevelt men have accepted that challenge and James A. Farley, spokesman for the governor, says he will go over the top on the first ballot.

Jones, of Atlanta, who are now suing the governor for money they say they expended in his behalf.

Callahan, running unpledged as a supporter of Alfred E. Smith in the Wisconsin primaries, was defeated by Roosevelt delegates. In an "open letter" accompanying the copies, he said "with such damaging information in circulation, it will be impossible to win the election in November unless another candidate is selected at the convention in Chicago.

The attitude of the Roosevelt camp has been that neither Summers nor Jones has been connected with the Roosevelt movement for several months and that any implications that the governor was aware of their alleged dealings with the Ku Klux Klan are too ridiculous to be dignified by a denial.

Hertz refused. A few days ago a man named O'Neill called on Hertz and said the greens would be destroyed by acid unless the club permitted the syndicate the privilege of operating gambling machines there. O'Neill asked for money in return for exposing the plot.

Hertz asked him to return the following day. O'Neill did not show up but Smith did. Smith said O'Neill was a "chiseler" and had tried to "shake down" the club, but that the syndicate itself was "on the level" and would operate outside the club's property.

Not quite certain whether O'Neill or Smith was telling the truth, the club decided to take no chances, and called out the police.

In some cases they will filter down to the general public immediately as they are charged upon the sales of manufacturers of importers to retailers, and therefore stocks on hand today remained clear of tax. Many charges, however, became directly effective on the consumer at the stroke of midnight.

Long distance calls, telegrams, cable and radio messages are now subject to various charges, generally ranging up from ten cents.

The two cents tax on bank receipts is in force, exempting only receipts in place of counter checks. So are a ten per cent charge of rental of safe deposit boxes, and stamp taxes on security issues, transfers and conveyances.

Admission tickets to theatres and all entertainments are now subject to the new tax, which begins at ten per cent on all those above 40 cents.

As soon as existing retail stocks are gone, the consumers will meet the one-cent tax on gasoline and four cents on oil, and other taxes on tires and accessories, automobiles, trucks, radio sets, mechanical refrigerators, sporting goods, cameras, matches, candy, chewing gum soft drinks toilet preparations, furs and jewelry.

Altogether these levies are to produce \$654,000,000 of the new tax law's \$1,118,500,000 expected revenue during the fiscal year which begins July 1. The income and corporation taxes are in effect for the entire current calendar year, that is since last January 1. A tax on the use of boats will go into effect in July.

New postage rates, beginning with three cents for each first class letter, will not go into force until July 6.

New York, June 21.—(AP)—Cotton futures opened steady, 2-4 higher in response to steeper Liverpool cables and on buying of near positions by spot houses and the trade. July 5.23; October 5.46; December 5.62; January 5.70; March 5.86; May 6.02.

Except for a further evening up of July contracts, business was comparatively quiet and fluctuations somewhat irregular. July liquidation was again readily absorbed by the near month sellers bought later deliveries and the scattering demand increased somewhat after the call on prospects for showery weather in the eastern belt, and early firmness of the stock market.

According to the New York Cotton Exchange service it now appears probable that world's consumption of American cotton this season will be 12,400,000 to 12,500,000 bales as compared with earlier indications of 12,750,000 or 13,000,000. These estimates would imply a world carry-over at the end of this season of about 13,250,000 to 13,350,000 bales.

Liverpool cables reported local buying and covering in that market and said there had been fair sales of cotton cloths to India.

Stock Market

New York, June 21.—(AP)—The stock market all but good still again today.

A handful of stocks were bid up a little in the first hour, but these gains were soon lost, and a slightly heavy tone developed after omission of American Smelting's preferred dividends. Bonds maintained a good undertone, but this market has not developed sufficient strength to help shares.

At the start, a few issues such as American Telephone, Union Pacific, Santa Fe, and Air Reduction rose about a point and U. S. Steel pushed up 1-2, but these advances were about lost. Telephone actually sold somewhat under yesterday's close. American Smelting common lost a point, as did Western Union, and American Smelting 7 per cent pfd. dropped a couple of points. The bulk of the list was virtually unchanged.

The cessation of important liquidation during the past fortnight has led some market theorists to believe that the March-April-May cycle of liquidation, the seventh of the bear market, has been completed, and that a rally cancelling roughly half that loss should be in order.

The Lausanne conference and the Democratic convention are probably attracting more attention in financial quarters than anything else at present. What effect either may have on the markets, however, remains problematical.

Custom Stays Death of Negro

Raleigh, June 21.—(AP)—Nord Donnell, Guilford county negro, was sentenced to die four months ago. Today Assistant Attorney General A. F. Seawell was trying to find out why we was still alive. Donnell did not appeal his case and has not been granted a reprieve by the governor.

Apparently, the negro benefited by custom. Donnell and Leroy Lee were convicted jointly and Lee appealed. His case was dismissed by the Supreme Court last Wednesday, automatically fixing July 1 as the date of his execution. Donnell, however, did not appeal.

Seawell said it was customary in case of a joint conviction where only one of defendant appeals, to preserve the life of the other by reprieve until the appeal is disposed of, in order for the non-appelling prisoner to be available as a witness if the appealing defendant is granted a new trial. Donnell, however, has had no reprieve.

It was said here last night that apparently technicalities would preserve the life of Donnell until after Lee is executed.

"I had just parked my car and was preparing to get out," Austin was quoted by the Observer as saying, "when a man jumped in the front seat with me, pressed a gun against my side, and ordered me to drive him to Danville, Va."

After the statement that Austin revealed that he drove out on the Concord highway and that his passenger told him to stop and drink a bottle of soda water which he took from a pocket, Austin is quoted as having said: "I did drink it and must have fallen unconscious immediately after. I don't remember anything else."
