LAUNCH MOVE TO BOLT ROOSEVELT AT CHICAGO

BAKER STICKS TO TWO THIRDS PARTY'S RULE

Joins Ranks of Those Fighting to Retain Voting Standard at Chicago.

Cleveland, June 25.—(AP)—Newton D. Baker, often mentioned as a possible Democratic presidential nominee, today joined the ranks of those fighting to retain the party's rule requiring a two-thirds vote for the nomination.

"Every member of the Democratic party who knows its traditions and is proud of its history has a duty to protest against the proposed abandonment of the two-thirds rule at Chicago," the former secretary of war said in a statement.

"Our representatives at Chicago have no right to change that rule after we have instructed our delegates."

Baker asserted "A nomination procured from a majority riding rough shod over the established traditions of the party would be deeply embarrassing both to the party and the candidate.

"Sensitive men would find it difficult to defend a candidate who started out with a moral flaw in his title."

Steward Heads Finance Body at Charlotte

Charlotte, June 24.—(AP)—Ivey W. Stewart, vice-president of the Commercial National Bank of Charlotte, was the new chairman today of the Reconstruction Finance Corporation Agency at Charlotte.

Mr. Stewart was appointed in Washington to succeed Word H. Wood as the chairman, and Terrence E. Hemby, executive vice-president of the American Trust Company, was named to succeed Mr. Wood as a member of the loan committee.

Mr. Wood, who is president of the American Trust Company, announced last night his resignation from both those posts. He said he had devoted seven months to the work, and he felt at this time that the work was well established and did not require his services any longer.

Probe Death Of Unidentified Man

Asheville, June 25.—(AP)—Police were investigating today the death of an unidentified white man whose body was found in the driveway of an Asheville residence, with a bullet through his heart and another through the head.

A flashlight was in his right hand and at his left side lay a .38 calibre revolver which had been fired twice, when the body was found shortly after midnight last night.

Police described him as being 28 or 30 years old, and extremely well dressed. The initial "M" marked his belt buckle, and on his ring was engraved "SM."

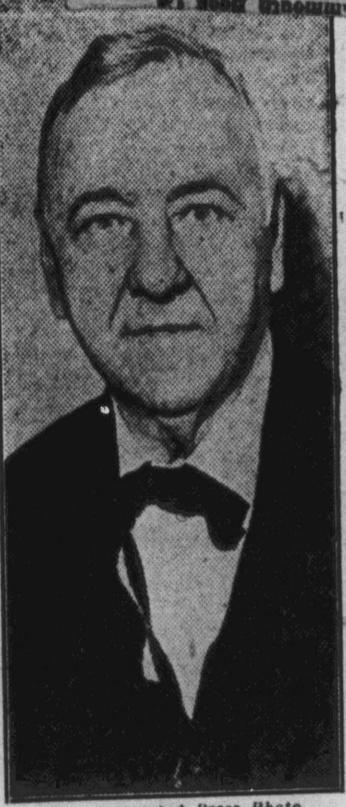

DANIELS AT WINDY CITY

N. C. Editor Will Not Oppose Vote on Prohibition if Majority of Folks Want It.

Chicago, June 24.—(AP)—Joseph Daniels, "the man who dried up the United States navy," is still a dry, and believes the rest of the country is, but if a majority of the citizens of the United States want to vote on the prohibition question, he will not oppose the plan.

Mr. Daniels, secretary of the navy during the administration of Woodrow Wilson, and publisher of the Raleigh News and Observer, is here as a delegate at large from North Carolina to the Democratic national convention.

He said on his arrival that he expected the party platform to speak "briefly but plainly" on prohibition.

The prohibition question is secondary, however, he believes, to economic problems. "The great overshadowing question is to get jobs for folks who are out of jobs," he said.

Mr. Daniels, whose opinion was backed by other leaders of the North Carolina delegation, does not consider that the North Carolina delegation's instructions to back Roosevelt for the presidential nomination means that they will be for the New York governor "to the bitter end," nor until Roosevelt releases them.

He also is of the opinion that although the state Democratic convention in Raleigh adopted a majority report favorable to prohibition, that there will be a division of sentiment among the Tar Heels on this question.

Regarding his own stand on the dry law, the publisher said: "As a dry who advocated dry laws and the right of the people to vote them, I could not oppose the right of the people to express themselves again if they see fit. Personally, I feel that a referendum would show sentiment just as strongly dry as it ever was, but there is no doubt that if the American people are given a chance to register their sentiment, this country will see a great fight."

Lenoir Suffers Fire Damage

Lenoir, June 25.—(AP)—Officials today probed the origin of a \$125,000 fire that last night swept through a warehouse, a storage plant and several smaller places before Lenoir and Hickory fire departments brought it under control.

The Subbs Veneer Company warehouse was destroyed and three gasoline and oil tanks were destroyed at the Atlantic Refining Company storage plant as the flames swept on from the veneer plant.

A combined store and filling station was destroyed but several residences near the scene were saved. Explosions of gasoline and oil helped spread the fire.

Smith Says Efforts To Kill Two Thirds Rule Is Doomed To Failure

Chicago, June 25.—(AP)—Alfred E. Smith declared today that those seeking to abrogate the two thirds rule in the Democratic convention were "as good as licked already."

"How is the two thirds fight getting along?" Smith was asked as he opened his morning press conference. "It's a bit grimy," he said with a grin, as he shifted his cigar to the corner of his mouth, "but it's still in the ring."

Then the 1928 standard bearer looked over the room and added: "They're as good as licked already, but they're still talking about it." (Continued on Page Four)

VETERANS GO TO CAPITOL SEES SUCCESS OF ROOSEVELT

Richmond, Va., June 25.—(AP)—The Confederates were evacuating Richmond today.

The gray-lad veterans who seventy years ago were forced to leave the city under entirely different circumstances after heroic but futile efforts to save the southern stronghold, carried with them today the plaquards of the convention city.

They were moving on to Washington—an objective they never reached during the four-year war between the states, but today they were assured of their goal.

They knew too that they would find no hostile force to meet them at the national capital where Abraham Lincoln presided.

PAYS TRIBUTE TO MORRISON

Mrs. Lyman Cotten Lauds Senator In Speech at the Court House Last Night.

Holding up Cameron Morrison as one of the leaders of progress which this state has made during the last thirty years, Mrs. Lyman Cotten, of Salisbury, spoke at the court house here last night, in behalf of the North Carolina senator's re-election to the U. S. Senate.

The address, which literally bristled with facts dealing with the life of Senator Morrison, was heard by a gathering composed of both men and women—about two hundred and fifty in number. It was the first time a woman had spoken here during either the first or second campaigns and considerable interest was attached to the coming of Mrs. Cotten, who married a native of this county, and who is well known here because of the time which she spent at Cottontown, near Bruce, in recent years.

Labor Given Attentive Ear By The Democrats

Chicago, June 25.—(AP)—Democratic platform makers today gave organized labor an attentive and inquisitive hearing.

Not content with hearing firm faced William Green, president of the American Federation of Labor, present demands for the resolutions committee questioned him closely.

Green proposed federal loans to cities and states and federal appropriations for relief.

Mayor Walker of New York, who took his place on the committee only today, asked, "If the federal government gave aid to municipalities for public construction would that be just as satisfactory as a federal building program?"

"Yes," replied Green.

William G. McAdoo, former secretary of the treasury, asked Green if labor had taken any position on proposed payment in full of veterans' bonus certificates.

Green said this had not been done by labor which took the position the issue was up to the American Legion.

"I just wanted to know," replied McAdoo, who is a member of the special subcommittee to draft the platform.

TWO MEN HELD IN EXTORTION

Parker Moore and J. J. Furlong Bound Over in Preliminary Hearing at Wilmington.

Wilmington, June 25.—(AP)—Parker Quince Moore, former mayor of Wilmington, was free today under bond of \$7,500, and J. J. Furlong, Sr., former police chief and county recorder, under \$1,000 bond for appearance in Superior court here to answer charges of attempting to extort money under pain of great harm and the life of the intended victim.

The two defendants were bound over to Superior court by Judge H. A. Grady yesterday at the conclusion of a preliminary hearing in which Furlong placed entire blame for the alleged plot on Moore.

Accused of attempting to extort \$25,000 and then \$20,000 from Mrs. Jesse Kenan Wise, wealthy philanthropist, Furlong took the stand in his own behalf and said that while he did engage a negro to go to a filling station seven miles from here (Continued on Page Four)

EHRINGHAUS TO VISIT CITY

Candidate for Governor to Make Final Speech of Campaign Tuesday Night.

J. C. B. Ehringhaus, of Elizabeth City, candidate for governor in the run-off primary to be held in this state next Saturday, will bring his campaign to a climax with an address at the court house here next Tuesday night at 8 o'clock.

Tentative plans for the final drive of the campaign were arranged at a meeting of eastern managers for Ehringhaus here last Saturday night, at which Mr. Ehringhaus and several other leaders of his fight were present.

J. C. Lanier, manager of the Ehringhaus campaign in this county, said today that arrangements had virtually been completed for the appearance of the gubernatorial candidate in his final address and that he was expecting a large crowd.

OHIOANS VIGOROUSLY OBJECT TO MOVEMENT TO DO AWAY WITH PARTY RULE AS ROOSEVELT FORCES CARRY THROUGH THE FIGHT AGAINST CENTURY-OLD STANDARD; COALITION MOVE SPRINGS FROM THE SOUTH.

Chicago, June 25.—(AP)—Word of an effort to align the strong Illinois delegation with the Roosevelt forces in the rules and chairmanship fight came today as the opponents added recruits and started a coalition movement to bolt any nominee who does not receive the two-thirds convention majority.

Vincent Dahlman, chairman of the Illinois delegation, said an attempt was being made to throw its 58 members behind the Roosevelt move to abrogate the two-thirds rule and elect Senator Walsh of Montana, permanent chairman of the convention.

A fight appears in prospect, however, before the stand of the Illinois delegation is determined.

Chicago, June 25.—(AP)—Baker and Cox joined the foes of abrogation today and a coalition began to form to bolt Franklin D. Roosevelt if he were nominated without the customary two thirds, but the determination of Roosevelt forces to carry through their fight against the century old rule remained unshaken.

From two different sections of their home state, Ohioans gave their views in statements.

Newton D. Baker, favorably regarded by many as a compromise candidate, said "sensitive men would find it difficult to defend a candidate who started out with a flaw in his title."

James M. Cox, the party's nominee in 1920, called the proposal to change the rule "an unfortunate error."

The move toward a coalition of Roosevelt opponents to pledge themselves not to support any nominee who did not obtain the two thirds majority began to take form in conferences. It sprung from the South.

In the face of the hurrying developments, however, James A. Farley, sat swinging his legs over the corner of an ornamented table and said:

"The vote on both (the permanent chairman and abrogation of the two thirds rule) will be substantially by the Roosevelt pledged and instructed support. I expect 600 on both."

How far the movement for pledging members of the party against the nominee selected without the two thirds vote will get is problematical but it is under way.

Senator Glass of Virginia already has taken the lead along this line, announcing "I can't support any candidate who takes the short cut to nominations that way."

Meanwhile friends of Governor Roosevelt were standing pat on their determination to do away with the two thirds rule and were making an intensive check-up of delegates to make certain of their ability to carry out the program.

Ayden, June 24.—(AP)—Tripp's garage on Railroad Street, which caught on fire Wednesday night, was badly damaged before the fire department succeeded in getting the flames under control. The blaze caught from a defective wire over the office and the stock room in which there were many auto accessories was almost destroyed.

The estimated loss is around \$1000. The building was insured but the stock was not. The garage is owned and operated by N. C. Tripp.

Seeing Through My Windshield

Canning Clubs.
The home demonstration clubs of Winterville, Falkland and Grifton held meetings this week. In each meeting both vegetables and fruits were demonstrated. For water bath and the pressure cooker methods were used. Each club is planning to sponsor canning in at least one unorganized group this summer.

Indications are that much more canning is being done than last year. Just one other county in the state canned more than Pitt county club members last year. We must keep up the pace. There was much suffering last winter but those who had full pantry shelves were not in that group. Not one pint of vegetables or fruit should be allowed to go to waste. Pickles, jam, preserves, etc., all help and should have their space in the canning budget, but they are not the essentials. Get first 57 pints of vegetables and 4 pints of fruit for each adult member of the family. This will give you ten servings of each daily during the winter months. Then each adult needs 4 pints of preserves and 2 pints of jelly. So many of us start at the wrong end of the canning budget.

More Pressure Cookers.
Several more home makers are using pressure cookers for the first time. The merchants of Greenville are lending valuable assistance when they buy these cookers and let the women pay for them in the fall. In this way the cooker can pay for itself. This method of canning saves time, fuel and patience.

Greenville Cannery.
The Greenville Cannery is filling a real need in the county. They are canning more green beans than anything else at present and will take the different vegetables as the season advances. They hope to concentrate on one or two at a time as more can be done in this way.

Gardens.
There are more and better gardens all through the county which indicates that our folks are "living at home" and not merely talking about it. Last spring several packages of seeds were provided through the welfare department for some who could not have had gardens otherwise. Those gardens are being observed—most of them are in splendid condition.

Needles Busy.
Several crochet books are flying throughout the county. Miss Eugenia Thomas of Greenville, has taken the agency for a firm in New York. Through Miss Thomas several women have received thread, patterns and needles for crocheted counterpanes. A variety of patterns are being made. In two months they must be finished and then comes the reward. There will be a place for every dollar.

PHILLIES GO ON RAMPAGE, BEAT GIANTS

With the Boston Braves beginning to show distinct signs of the "crack" that the experts have been predicting for them ever since they shot up into the high places of the National League standing, early this season, the Phillies have become the current "wonder team" of the elder circuit.

Although Boston took a severe pushing around during its home stand against the West and has shown few signs of improvement in two games since then, the Braves still are second, only two games behind the lead. The Phillies, meanwhile, have come up with a tremendous rush in the past two weeks, climbing from seventh place on June 12, when they journeyed to Cincinnati for a one day stand, to a good fourth today.

That overnight trip apparently was the turning point for the Phils, who boasted some terrific hitting power but hadn't made much use of it. They won that game and since then have clouted out eight more victories in eleven starts.

The Phils' "murderers row," Dick Bartel, Chuck Klein and Don Hurst, led a 15 hit attack on Jim Mooney and Sam Gibson of the New York Giants yesterday to gain an 11 to 0 decision and keep Philadelphia only a half game behind Pittsburgh, Bartel and Klein made four hits apiece and Chuck became the first National leaguer to pass the 100 hit mark, stopping at 103. Hurst contributed his tenth home run and a single to drive home three tallies.

Pittsburgh had a rather rough road as they clung grimly to their hold on third place. The Bucs blew a brief early lead over Cincinnati in a duel between Heinie Meine and Eppa Rixey and then won out in the seventh inning when Lloyd Waner hoisted a home run with none aboard, to make the final count 4 to 3.

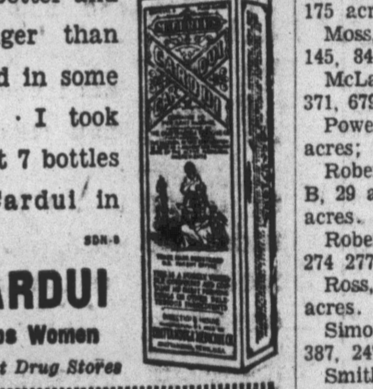

ABOUT TOWN

The movement of the Pitt County Post of the American Legion and the Water & Light Commission baseball team to raise funds for the tubercular wife of an unemployed veteran of the World War is to be highly commended and the public should make a point to attend as many games as convenient and help boost the fund.

This woman, mother of several children, will be forced to remain in the hospital several months before her condition becomes sufficiently improved to permit her release, and as she has no earthly way of raising money to defray her expenses, she is entirely dependent upon the liberality of people back home.

This is one of the most worthy causes coming to attention of the public this year, and it is hoped appreciative people will attend the games arranged by the Water and Light Commission and help swell the fund for providing for the sick woman.

The big fight is on at the Democratic campaign grounds in Chicago and the public will watch the forces of Smith and Roosevelt as they attempt to gain ascendancy prior to the opening of the convention which promises to be equally as picturesque as that four years ago, probably more so.

Al Smith has done exactly what members of the party hoped he would not do. He has taken charge of active opposition to Roosevelt's forces and if somebody doesn't watch him he will throw the convention into the greatest turmoil in history.

Why he could not have remained out of the picture for the sake of party harmony is hard to understand. But he has a big following and his activity at this time undoubtedly is the result of the insistence of members who don't know what harmony means and never will know.

The party stands on the verge of victory if leaders should be able to find some common ground of agreement, but this cannot be achieved with dissension and strife such as that now developing in Chicago.

Congress in a few days will make it possible for the Farm Board to release fifty million bushels of wheat for relief of the unemployed in this country. This will be converted into flour and distributed through the American Red Cross.

The Red Cross should fully investigate conditions in the thousands of communities into which this flour will go and see that only those in dire need and distress are benefitted.

From some parts of the country reports have been disseminated charging that the flour was given to people capable of providing for themselves. This is difficult to believe in the face of the efficiency of the Red Cross but if such has been the case those in charge of distribution should look more carefully into the situation and see that the benefit goes through the right channel.

Thousands of people are finding it difficult to keep the wolf away from their doors at this time and the government gift should play a vital part in their relief if those deserving of aid actually receive it.

Cotton on ship-board awaiting clearance at U. S. ports was estimated at 74,000 against 73,000 last year and 67,000 two years ago.
