

## GOVERNOR ORDERS PROBE OF HIGH POINT STRIKE

### Wilmington Assured Of Next Annual Convention Of the American Legion

#### JOE DANIELS IS SPEAKER

Raleigh Publisher Calls on Former Soldiers to Again Use Their Influence to Save Civilization; Durham and Other Cities Bid for Next Meeting; Officers to Be Elected This Afternoon

Asheville, July 19.—(AP)—Bryce Parker Beard of Salisbury, was elected commander of the North Carolina Department of the American Legion by acclamation at the closing session of the annual convention here today.

Wrightsville Beach, Wilmington, was picked as the 1933 convention city.

Fred Wyrick of Greensboro, was the only other candidate for commander.

Before the vote was completed, Wyrick rose to his feet and called upon the Legion to make Beard's election unanimous. This was done with enthusiasm.

Durham and several other cities were after the 1933 convention city, but the nominating committee recommended Wilmington and the others withdrew.

The convention adopted a resolution requesting the resignation of Dr. W. P. Herbert of Asheville, consulting physician at the veterans' hospital at Oteen.

The resolution was adopted upon the recommendation of the C. W. Francey post of Oteen which informed the convention that Dr. Herbert by a recent paper and speech on bonus and veterans' legislation had destroyed his usefulness as consultant for Oteen patients.

The resolution charged that Herbert had "caused much unrest among the patients of Oteen" by his "antagonistic attitude towards veterans as shown in his recent speech."

### Dr. J. B. Ficklen Church Leader, Dies in Hospital

Atlanta, Ga., July 18.—Dr. J. B. Ficklen, executive secretary of the synod work committee of the Synod of Georgia of the Southern Presbyterian Church, and one of the most widely known Presbyterians in Georgia, died about 8:45 a. m. Friday at the Georgia Baptist Hospital, Dr. Ficklen underwent an operation and was said to have died while still under the influence of the anesthetic.

Dr. Ficklen had been in failing health for the past four months, but his death came as a great shock to his family and friends. He resided at 704 South McDonough street, Decatur, with his sister, Mrs. Elizabeth Myers. He maintained offices at 701 Columbia avenue, Decatur.

A member of an old and prominent Virginia family, Dr. Ficklen was born at the old Ficklen home, Redhouse Estate, Buckingham County, Virginia. He was a graduate of Hampden-Sidney College, which presented him with the honorary degree of Doctor of Divinity in 1928. He later was graduated from Union Theological Seminary at Richmond, Va.

Dr. Ficklen began his work as a Presbyterian minister in Rome, Ga. From there he became pastor of the Woman Park Presbyterian Church in Atlanta. He later became pastor of the First Presbyterian Church at Covington, Ga., and then took up his work as executive secretary of the Synod of Georgia.

Surviving him is a son, J. B. Ficklen, Jr., a student at Davidson College, in North Carolina; a daughter, Miss Miriam Vannerson Ficklen, student at Decatur High School, and five sisters, Mrs. Hunter Mar, shall of Charlotte, N. C.; Mrs. L. C. Arthur, Mrs. B. W. Moseley and Mrs. G. C. Jeter of Greenville, N. C.; Mrs. Elizabeth Myers of Decatur.

#### BOARDS TALK SCHOOL TERM

Final Decision on Extended Session to Be Made at Meeting on August 1st.

Yesterday the Pitt County Board of Education, Board of County Commissioners, commissioners-elect members of the legislature, and members of the local school boards in special tax districts, met in the courtroom to consider the extended school term in Pitt county for next year.

Statement of the financial condition in each special district was read and explained by the auditor, J. T. Clifton. Some of the districts are in fair condition in the collection of taxes and payment of current bills, while others are very much in arrears.

In the face of this situation, it was the decision of the meeting that unless 1931 and prior year levies could be collected, it did not seem at all practical to impose additional levy this year for current expense of the extended school term. The debt service levy of course will be levied as of last year. The question concerning the operation of school in a few districts where the financial situation is better than the average was not decided. The general opinion was that, if any of the county schools are to close at

#### CHICOD WOMAN DIES SUDDENLY

Mrs. M. E. McLawhorn Succumbs to Heart Attack in Chicod Community

Mrs. M. E. McLawhorn, 29, died suddenly at her home in Chicod Township last night at 7:30 o'clock. Death was attributed to a heart attack.

Mrs. McLawhorn apparently was in her usual good health and assisted members of the family in harvesting tobacco during the day. After cooking supper she went out on the porch and sat down, complaining that she had a pain in the region of her heart. She collapsed a few minutes later and died before aid could reach her.

Funeral services were conducted from her late home this afternoon at 2 o'clock by Rev. M. A. Woodard, of Winterville, and burial was made in the Lewis McLawhorn graveyard.

Mrs. McLawhorn was a faithful member of Reedy Branch Free Will Baptist Church, and was active in the work of the congregation up to the time of her death. Her sudden demise was received with profound sorrow throughout the community where she was held in high esteem by a wide circle of friends.

She is survived by her husband and two children, Elen, age 11, and Elmer, age 7.

Mrs. McLawhorn was the fourth member of the Pitt Burial Association to die since its organization several months ago.

#### CAPONES MAY BUY 101 RANCH

Negotiations in Progress for Gangsters' Purchase of Show-Place of West.

Ponca City, Ala., July 19.—(AP)—When Al Capone completes his sentence in the Atlanta Federal Prison he may become overlord of Oklahoma's famed 17,000 acre 101 Ranch.

Col. Zack Miller, last of the pioneer family which built the vast ranch into a Western show place and virtually a dominion unto itself, today confirmed reports negotiations were in progress for sale of the property to the former Chicago gang leader, his brother, Ralph, and associates.

Miller said he planned to leave for the South tomorrow, but declined to say whether the purpose of the trip was to confer with Capone. Two Pawhuska, Okla., real estate dealers, E. E. Beech and Horace J. Smith, said Miller would accompany Louis (Diamond Jack) Allerie, Capone representative, to Atlanta to hear Capone's offer.

Miller beset by financial difficulties which started when the ranch's Wild West show became stranded in Washington, D. C., last season, added that he had "no idea" the transaction would be consummated.

#### RELIEF BILL ABOUT READY

Hoover Expected to Make Tremendous Measure for Unemployment Effective

Washington, July 19.—(AP)—A \$300,000,000 fund for emergency unemployment relief loans to states and municipalities is expected to be available today with President Hoover's signature of the giant jobless bill passed by Congress in its closing hours.

The loans will be available to states on application by the governors, certifying the necessity for them and their unavailability elsewhere. The law provided:

"The governor of any state or territory may from time to time make application for funds under this section, and in each application so made shall certify that the necessity for such funds and that the resources of the state or territory, including moneys then available and which can be made available by the state or territory, its political sub-divisions and private contributions are inadequate to meet its relief needs."

The funds advanced to states will be administered under the government.

In Albany for luncheon with the candidate, James A. Farley, national chairman, and Louis M. Howe, Jr., Roosevelt's political adviser brought reports of their accomplishments during the governor's brief vacation.

Because of the pressure of state business, the luncheon hour was the only time Mr. Roosevelt could find for the campaign conference.

Mr. Roosevelt arrived in Albany last night, after an all-day motor trip from Rye Beach, N. H. There were conferences along the way with Colonel Edward M. House, wartime adviser to President Wilson, and Leopold M. Gouldston, a close adviser of Governor Ely, of Massachusetts.

#### POSSE AFTER ESCAPED MEN

Capture of Ten Escaped Convicts Expected Momentarily in Hickory Section

Hickory, N. C., July 19.—(AP)—A posse of officers spread through a wooded section near here just before noon today expecting an almost immediate capture of four of ten convicts who escaped from a State highway camp near Mocksville Saturday night.

Police were informed by James Yount, 17, that he saw William Burns, 23, one of the escaped convicts, talking to his parents at their home on the city limits here this morning.

With Burns, said Yount, were three other men whom he subsequently saw hiding in a patch of woods near the home of Burns' parents.

Yount said three of the quartet were wearing street clothes while the third was dressed in overalls.

Police expressed belief that four were all convicts who escaped from the camp and immediately thirteen officers and deputy sheriffs rushed to the scene and began a systematic search of the area.

Attorney for John H. Curtis Seeks to Obtain Freedom of His Client.

Flemington, N. J., July 19.—(AP)—Lloyd Fisher, attorney, announced today that he would apply immediately for an order to show cause why the verdict of guilty against John Hughes Curtis, who was convicted of hindering capture of the kidnapers of the Lindbergh baby, should not be set aside.

He said he would charge in his application that Prosecutor Anthony M. Hauck had been guilty of contempt in permitting members of the jury to be followed by detectives.

Curtis, who was sentenced to a year in prison and a fine of \$1,000 was released on bail yesterday pending appeal action.

#### NEW DEATHS IN HOT WAVE

A Dozen Additional Lives Claimed by Intense Heat Sweeping Over America.

(By The Associated Press) A dozen additional deaths from heat and drownings left an irate sun unopposed yesterday.

Warmer weather for most of the area west of the Rockies was forecast, although some relief was in store for sections of the South and Northwest.

Two fatal heat prostrations and a drowning at Alva, Okla., were the Southwest's victims to a heat which reached a maximum of 110 degrees at Phoenix, Ariz., and touched 108 at Altus, Okla. Numerous communities in this region sizzled under temperatures of 100 degrees or more, but thundershowers cooled Texas somewhat.

Federal crop authorities said generous rains were needed in Kansas within the next week if the corn crop was to escape damage.

#### MORE MILLS JOIN WALKOUT

One Hundred Additional Plants Closed Down by Strikers at High Point and Thomsville Today; Six Thousand Men Take Part in Protest Against Reduction of Wages Announced Yesterday

Raleigh, N. C., July 19.—(AP)—Adjutant General J. Van B. Metts, commander of the North Carolina National Guard, was sent to High Point today by Governor Max Gardner to investigate strike conditions there.

Governor Gardner declined to discuss the situation beyond revealing that he had asked General Metts to proceed to High Point at once and report to him on conditions there.

Following a strike of some 400 hosiery workers yesterday at High Point bands of strikers today caused the closing down of some one hundred manufacturing plants there and at Thomsville nearby, and thus threw about 6,000 workers into idleness.

The Governor said he expected a report from General Metts this afternoon.

ABOUT TOWN

Mrs. Jane S. McKimmon, home demonstration worker of Raleigh, finds money scarce in some sections of North Carolina but trade plentiful. The shortage of money is very pronounced in all parts of the State, but in the farming communities farmers are acquiring a habit of their forefathers—the bringing of goods to town to exchange for products of the stores. Of course, automobiles can't be bought with small amounts of farm produce, but the things that keep body and soul together—clothing and food—are obtainable under this old system of exchange, and if they never get another cent, these people of the thrifty farming areas will continue to live and prosper. Many of them have had to abandon their automobiles for horse and buggy and mule and cart, and this medium of transportation has become quite evident in recent months. It is a slow way to travel compared with the speed in the automobile, but it is a sure way to get where they have started, and some day they hope to be able to hop into their cars again and tear down the road to prosperity and better times. The lack of coin has caused many a man and woman to do things he thought he would never do again, and while it goes rather hard, the acid test of denial is having a salutary effect and probably will strengthen the fibre which has caused America to stand out in undisputed leadership of the world the last several years.

Governor Franklin D. Roosevelt, Democratic Presidential nominee, is in Massachusetts conferring with leaders of the Al Smith group. By the time the governor gets through with that part of the country he ought to have the old machine clicking in a way that will mean disaster to the Republicans in the forthcoming election. In spite of the plan of the Republican party to make whisky the paramount issue of the campaign, it is believed the Democrats are going to succeed in their efforts to emphasize economic issues. The lamentable condition of the business fabric of this country readily furnished an inescapable argument of attack for the Democrats, and by the time they prepare to go to the polls the nation as a whole will know exactly why conditions are not more favorable. President Hoover made lots of rash promises at the beginning of his administration, but if he has referred to prosperity the last several months nobody has found any record of it. He knows he has been swamped in the backwash of his own argument and naturally party members would like to swing the issue to prohibition or something to sidetrack public attention. Roosevelt stands better chance of reaching the White House than any Democratic nominee since the day of Wilson, and if public sentiment continues to swing toward him in the future as it has done in the past, the Republicans will be swept out of power more pronouncedly than they were ever swept out before.

When people go to their knees something is bound to happen. This was demonstrated quite forcefully during the recent drought when prayers were offered for rain in many communities. In the Black Creek section rain descended within an hour after prayer had been offered by a congregation of that community, definitely breaking the drought and carrying relief to both animal and vegetable life. 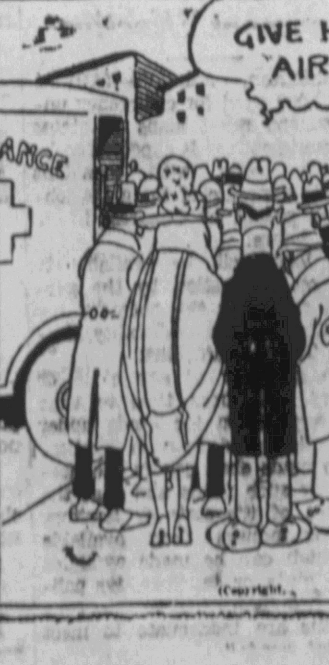

Economy Drive Meets Success. New York, July 19.—(AP)—The task of enlisting approximately 300,000 employees in a drive for economy has been completed by the American Telephone and Telegraph Company and affiliated enterprises, with what appears in the eyes of its officers to be marked initial success.

With a monthly pay-roll of \$40,000,000 the Bell system was obliged to turn to this side of its ledger as its most fruitful field for paring down costs.

Out of every telephone company dollar 65 cents go into wages. After careful study, the company decided against adopting a straight cut in the wage scale. Instead, it adopted a five-day week. He effect, so far as company expenses are concerned, was the same, but in return for a somewhat smaller envelope, each employee received one day a week more leisure and his hourly pay rate was untouched.

The plan called for "spreading" the work among a greater number of employees. To accomplish the same goal, the company would have been obliged to let out 25,000 or more men.

Through adoption of the five-day week about \$3,500,000 a month was saved in the pay-roll.

The coroner's jury also ordered Snipes held, charging him with being an accessory before the fact of murder.

Body of Colored Boy is Recovered From Tar River

The body of Bert Leggett, Jr., 15-year-old colored youth, who was drowned in Tar river yesterday afternoon about 1 o'clock, was recovered about two hours later.

The boy was swimming with several companions when he stepped into a deep hole and drowned before aid could reach him.

This was the third person drowned in the upper river area during the summer, and swimmers have been warned of the danger of attempting to swim in the treacherous cross-currents of that part of the stream.

Detroit, Mich., July 19.—In a statement issued Thursday, Mayor Frank Murphy commended the Hudson Motor Car Co. for its enterprise in producing a new car which will soon be put on the market.

## Stock Market

By CLAUDE A. JAGGER  
New York, July 19.—(AP)—Haphazard speculation by floor traders gave the stock market a semblance of activity today as the list steadied after yesterday's setback.

A somewhat better tone in principal commodities, notably wheat, was encouraging, but buying powder in the share market was rather feeble, and prices with few exceptions made scant progress. Further encouragement from the bond market was lacking, although prices there were well maintained.

The list pushed up somewhat in the late morning, dipped at midday, and stiffened again in the early afternoon. Tobacco was pushed forward, gains of around a point appearing in American Tobacco B, Reynolds B, and Lorillard. Yesterday's selling in Dupont seemed to have dried up, and that issue improved fractionally. Slight gains also appeared in such issues as American Telephone, American Can, Allied Chemical, Coca-Cola, Consolidated Gas, Santa Fe, and Union Pacific. U. S. Steel was about steady. Public Service of New Jersey was a soft spot. General Foods dropped a major fraction, and Homestake Mining lost a couple of points.

While some commentators thought the old lows, last touched on July 8, might be due for another testing, there was nothing in the day's developments to indicate an immediate return to those levels.

Reports of scattered upturns in industrial activity were read with interest, but were scarcely regarded as conclusive, as there are usually some early resumption of activity soon after mid-years. More general signs of seasonal pick-up are not expected until August or September.

The fresh boost for the tobacco was apparently in a further effort to get a speculative following on the strength of satisfactory unofficial estimates of the first half year's earnings. While Wall Street is making dark forecasts of second quarter and first half showings for many companies, tobacco, oils and a number of specialties are said to have done relatively well.

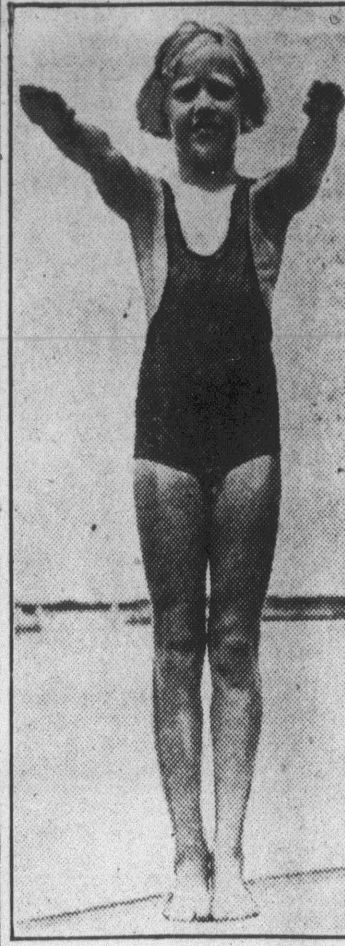
Arising shortly after daybreak, the president left his camp about six o'clock.

assured of the 1933 convention of the North Carolina Department of the American Legion.  
The committee on time and place reported today, recommending the invitation of the seaport city be accepted. Durham and other cities also were bidding for next year's meet.  
Official action on the recommendation will be taken this afternoon. Josephus Daniels, Raleigh publisher and former Secretary of the Navy, addressed the Legionnaires this morning, calling upon the former soldiers to again save civilization.  
Election of officers was to come this afternoon.  
The Raleigh publisher who was Secretary of the Navy in the wartime Cabinet of President Woodrow Wilson, told the Department of North Carolina of the American Legion, in session here:

"If we had failed civilization in that crucial testing time, America would have been as false as if Thomas Jefferson or John Hancock and Benjamin Franklin had failed to sign the declaration because they feared they might be signing their own death warrant."  
"You saved civilization" in the World War Mr. Daniels told the Legionnaires. "It calls upon you again in its present extremity with the confidence born of your former achievement that brought deliverance."  
He told the ex-service men that they, in ending the World War by breaking the Hindenburg line, saved Europe from vassalage under the imperial German crown and America from becoming a military colony of Germany, "every worker with a soldier on his back."  
Answering critics of America's participation in the war and the results of it, the former chief of the navy described his last visit to his "chief and mentor," President Wilson.

The President told him, Mr. Daniels said, "in answer to my expressed dejection at the outlook for the realization of our hopes, 'Do not trouble about the things we fought for. They are sure to prevail. They are only delayed.'"  
As for the actual results of the war already discernible, Mr. Daniels pointed to the present-day type of conferences held among the nations of the world. Before the war, he said, these international parleys discussed the strengthening of alliances and ententes, whereas now their purpose is to "mobilize the nations to prevent war."
