FORECAST ELEVEN MILLION BALE COTTON CROP

Yield Expected To Be Six Million Bales Less Than The Previous Year

FARM OFFICE MAKES REPORT

Forecast of 11,306,000 Bales as Compared with 17,096,000 Last Season, follows Investigation by Agriculture Department; Figures Based on Condition of the Crop August 1st.

Washington, Aug. 8.—(AP)—Cotton production this year was estimated today by the Department of Agriculture in its first forecast for the season at 11,306,000 bales of 500 pounds gross weight as compared with 17,096,000 bales ginned last year.

The forecast was based on the condition of the crop Aug. 1 which was 65.6 per cent of a normal, as compared with 74.9 a year ago and 66.4 the 10-year average.

The indicated yield of lint cotton was announced as 149.6 pounds per acre, as compared with 201.2 pounds last year and 151.4 pounds the 10-year average.

The estimated total production was determined by application of the indicated acre yield to the acreage in cultivation July 1, which was 37,190,000 acres less the 10-year average abandonment in each state after that date. The average abandonment for the country for the ten years was 3.1 per cent. The acreage after deduction of the average state abandonment, is placed at 36,151,000 by the department. The acreage this year is the smallest planted since 1922.

The Census Bureau announced today in its first ginning report of the season that 70,978 running bales counting round as half bales and excluding linters, had been ginned prior to Aug. 1 as compared with 7,307 for 1931 and 78,188 for 1930.

Cotton Prices Jump \$5.00 Bale

New Orleans, Aug. 8.—(AP)—Cotton prices on the local exchange soared fully \$5 a bale over Saturday's close today when the government's report indicating a yield of 11,306,000 bales proved about a million bales under expectations.

New York, Aug. 8.—(AP)—Cotton prices soared more than \$5 a bale on the New York market today following publication of the government crop report estimate forecasting a crop of about a million bales smaller than had been expected.

FOUR KILLED IN ACCIDENTS

Six Also Injured in Series of Mishaps in Northwestern North Carolina.

(By The Associated Press)
Northwestern North Carolina today counted four dead and six injured as a result of week-end airplane and automobile accidents.

Harvey Apple 27, Winston-Salem garage man, an unlicensed pilot, and Millard Shutt 24, assistant golf professional at the Twin City-Forsyth Country Club were killed at the Winston-Salem municipal airport when their airplane crashed shortly after take-off.

Wives of both witnessed the tragedy. The ship was not licensed. F. M. Lenter of Charlotte, aviation inspector of the Department of Commerce, was on the scene.

STRIKE OVER AT HIGH POINT

Last of Striking Mill Workers Return To Work During Morning Hours.

High Point, Aug. 8.—(AP)—High Point's industrial areas hummed in unison for the first time in nearly a month today as the last of 6,000 textile and hosiery strikers went back to work.

Approximately 1,200 workers at the Adams-Mills Full Fashioned Hosiery Mill and the Highland Cotton Mill marched back to their posts following a wage settlement effected Friday between mill owners and the idle workers.

Today's resumption of activities brought to a close a strike without parallel in the state's history.

It began with a strike of some 400 employees of eight hosiery mills, and spread in two days to every industry in the city when revving bands of strikers and unemployed cut off all electric power. Manufacturing High Point thus was paralyzed for a few days but finally all returned to work except 6,000 hosiery workers who remained.

Springfield Man In Hospital Suffering from Loss of Blood and Exposure.

Springfield, Ill., Aug. 8.—(AP)—Near death from loss of blood and exposure, his body bruised and lacerated, John B. Colegrove, aged president of a defunct Taylorville, Ill., bank, lay in a hospital here today and related how he had been attacked in his home, kidnaped, bound and gagged, and taken to a boat fire, two by two.

HOLD CLERIC IN WIFE DEATH

Tangled Romance of Aged Preacher and Young Bride to be Aired Before Jury.

Muskogee, Okla., Aug. 8.—(AP)—The tangled romance of a 52-year-old minister and his 19-year-old bride was to be laid before a grand jury investigating the death by poison of the preacher's first wife, today.

Prominent in the evidence which county attorney Phillip K. Oldham had prepared for the jurors' examination were passionate letters and verses which Oldham said the minister had written to his wife.

Stocks Storm Upward Again On N.Y. Market

New York, Aug. 8.—(AP)—With a buoyancy comparable to the prosperity mad days of 1929 stocks stormed upward in tumultuous trading on the New York Stock Exchange today.

Sweeping aside profit taking and forcing the badly bitten bears into still tighter traps, the market exultantly stamped its way through all opposition. The throttle was wide open, and the bulls seemed to have plenty of gas in the tank.

By early afternoon hundreds of leading shares were showing net gains of \$2 to \$8. Saturday's boisterous two hours it appeared had only been a primer for this wild market; certainly the fact that prices had appreciated 60 per cent from their June lows and therefore might normally be facing a technical setback proved no detriment. A setback appeared after the strong opening, but it was only a lull in the storm and traders who sold short found themselves in a tighter predicament than ever.

Sixteen Persons Killed By Accidents In South

Atlanta, Ga., Aug. 8.—(AP)—Week-end accidents in the South cost sixteen lives with automobiles accounting for half of the number. Two were killed in an airplane crash, two in a boat fire, two by collapse of a building shed, one by a train and one was drowned. Virginia reported five deaths, North Carolina four, Louisiana, Alabama and Georgia two each and Florida one.

MAN HELD FOR KILLING NEGRO

Ollie Hodges Jailed Here for Slaying Of Walter Hardee, Colored, Saturday.

Charged with fatally shooting Walter Hardee, colored, in an argument near Grimesland Saturday night, Ollie Hodges, World War veteran, was being held in the county jail today awaiting preliminary hearing on a charge of murder.

With his right thigh shattered from a load of gunshot said to have been fired by Hodges, Hardee died in the hospital here last night at 6 o'clock.

The shooting, officers said, occurred Saturday night about 11 o'clock. Hardee was said to have cursed Hodges while the argument was at its height, whereupon Hodges brought his gun into play and fired twice at the negro.

The first charge missed the mark but the second struck the negro in the right thigh. He was said to have been in such weakened condition that his constitution could not stand the shock and subsequent loss of blood and died in spite of every medical assistance.

Although officers were unable to say when Hodges would be given preliminary hearing, it was believed this would take place sometime during the week. In the meantime Sheriff Whitehurst said Hodges would be allowed bond, if he should make application for it.

Hodges saw services over sea during the World War and was a member of the 113th Field Artillery. He has been living at Grimesland since the end of the war and had been engaged in farming and other occupations.

Will Attempt Orderly Marketing Of Cotton

Peace Remote Between Paraguay And Bolivia

Asuncion, Paraguay, Aug. 8.—(AP)—Prospects for peace in the dispute between Paraguay and Bolivia over the Gran Chaco appeared more remote today following the shooting down of a Bolivian airplane over the Paraguayan lines on the frontier. The plane was shot down as it attempted to land.

MRS. MILLER ON THE STAND

Woman Flier Tells the Jury She No Longer Loves Lancaster Or Clarke.

Miami, Fla., Aug. 8.—(AP)—Mrs. J. M. Keith-Miller testified at the murder trial of Capt. W. N. Lancaster today that she had become "completely disillusioned" and no longer loved Lancaster nor the memory of Haden Clarke, her writer fiancé whom Lancaster is accused of killing.

She said she is still very fond of Lancaster, to whom she was once engaged, but that she has not loved him for two years.

"Even if you have said you would die for Captain Lancaster?" State Attorney N. Vernon Hawthorne asked her.

"Yes."
"Would you lie for him?"
"No," she hurried back.

"Weren't you a traitor to him, if you have not loved him for two years, when you wrote him constantly of your love while he was on his western trip to get all the money he could for you?"
"You don't understand our situation," she answered.

Mrs. Keith-Miller wept on the stand as she attempted to show Hawthorne how she could be very fond of Lancaster and still not be in love with him.

She had told Haden many times before they were engaged she never expected to marry anyone, she continued, but she always felt that when Bill should be free from his military service she would marry him.

GUARD CROP OF GINSENG

Firearms used in Georgia and Carolina to Protect Precious Roots From Thieves.

Blue Ridge, Ga., Aug. 7.—(AP)—Isolated backlands of the Georgia and Carolina mountains, whence once romances of travel made perilous for strangers by picketing moonshiners, are bristling with guns these days or another reason—a \$7-a-pound crop in the making.

Back in the times when mountaineers made livings with rifles instead of with plows and hooked ricks for tourists, a few used to pick up extra change by gathering "sang" roots.

These came from wild Ginseng plants, were dried and sold to buyers in the north and eventually shipped to China where they brought high prices because of supposed medicinal properties. There was a time when commercial Ginseng (the Chinese named it) brought as high as \$17 a pound.

The building was the property of Richard Gorman and was occupied by the families of H. L. Corey and Mr. Brown, who were away from home. The origin of the blaze was not determined.

TO SEEK BOND IMMEDIATELY

"Torch Singer" Is Charged with Death of Millionaire Husband and Expected to Surrender to Officers at Wentworth During Mid-Afternoon; Will Go Before Judge Stack to Seek Release on Bail; Ab Walker Freed Over Week-End.

Wentworth, N. C., Aug. 8.—(AP)—Libby Holman Reynolds, missing torch singer widow of the late Smith Reynolds surrendered to North Carolina authorities here at 2:50 p. m. today.

Wentworth, Aug. 8.—(AP)—Solicitor Carlisle Higgins said this afternoon he did not believe he would oppose bail for Libby Holman Reynolds, expected to surrender later today to answer charges growing out of the fatal shooting of her millionaire husband a month ago.

Wentworth, N. C., Aug. 8.—(AP)—A crowd of several hundred people milled about the little Rockingham county court house this afternoon as the hour neared for the surrender of Libby Holman Reynolds.

Attorneys for the former theatrical favorite, sought in connection with the fatal shooting of her husband a month ago, had promised she would give herself up to North Carolina authorities at 3 p. m.

Two hours before the time set for the surrender, Wentworth, a town of only a few hundred inhabitants, was filled with visitors. They came from all parts of this and adjoining counties for a glimpse of the girl who was a Broadway toast until she married young Reynolds only a few months before his death.

Two hours before the time set for the surrender, William Graves, of Winston-Salem, one of Libby's attorneys, drove into town in an automobile, accompanied by William E. Church, clerk of the Forsyth county court.

Graves noted the crowd of curious people. Then he called at the postoffice, directly across the street from the courthouse, and made arrangements with the postmaster for Mrs. Reynolds to do any necessary waiting in the postmaster's office.

There she would have comparative privacy.

Shortly afterwards, two Forsyth county deputy sheriffs arrived. One of them was Guy Scott, brother of Sheriff Transou Scott, the man behind the investigation into the shooting of young Reynolds.

As soon as possible after her surrender, habeas corpus proceedings will be argued before Judge Stack during which attorneys will request that Libby be admitted on bail.

Political Leaders Gather to Discuss Fate of Germany

Berlin, Aug. 8.—(AP)—Germany's most powerful political leaders began to gather in Berlin today for a series of conferences likely to determine the ultimate position of Adolf Hitler in the new government.

Chancellor Von Papen returned yesterday from a brief holiday and Hitler himself, General Kurt von Schleicher, minister of defense, former Chancellor Heinrich Brüning and Alfred Hugenberg, Nationalist leader, are due to arrive in the next day or two.

President Paul von Hindenburg will return from his summer estate at Neudeck on Constitution day, August 11.

ABOUT TOWN

It was commendable on the part of aldermen and the school board to attempt to provide the city with a nine months' school term this year.

The officials wish to impress upon the public a very definite fact and that is the nine months' term will not become an actuality unless taxes are paid.

Patrons of the school should consider this fact and emphasize it at every opportunity. Unless they do so, it is impossible to say what will be the outcome of the present session.

A reduction of 11 cents in the city tax rate of the present year is another stroke by the aldermen of which the citizenship should be appreciative.

It is an unusual achievement in the face of a three-quarter million dollars shrinkage in valuations and indicates that the aldermen were forced to cut everywhere possible to accomplish their purpose.

The reduction was obtained by cutting teachers' salaries to the state level, the cutting of appropriations to various governmental departments, and last but not least, the paying of salaries of officials.

Mayor Flanagan, wishing to set a fine example for the city at a time when it is difficult to obtain sufficient revenue to insure governmental operation, voluntarily cut his own salary, and the mayor is to be highly commended for his sacrifice in behalf of the community.

It is to be hoped the British economist, one of the foremost economic and financial publications of the nation, knew what it was talking about when it said the economic crisis had passed in America.

We never notice the development of vegetable or animal life until we go away and return, and maybe this is the case of our not being able to distinguish the changes in our economic fabric referred to by the British publication.

After the most pronounced period of depression the nation has ever experienced a return of prosperity will be mighty acceptable, and the sooner it comes the better everybody will like it.

We hope that what the British authority sees will become evident to homebodies during the fall and winter months so that much of the suffering experienced the last two years will be definitely relieved.

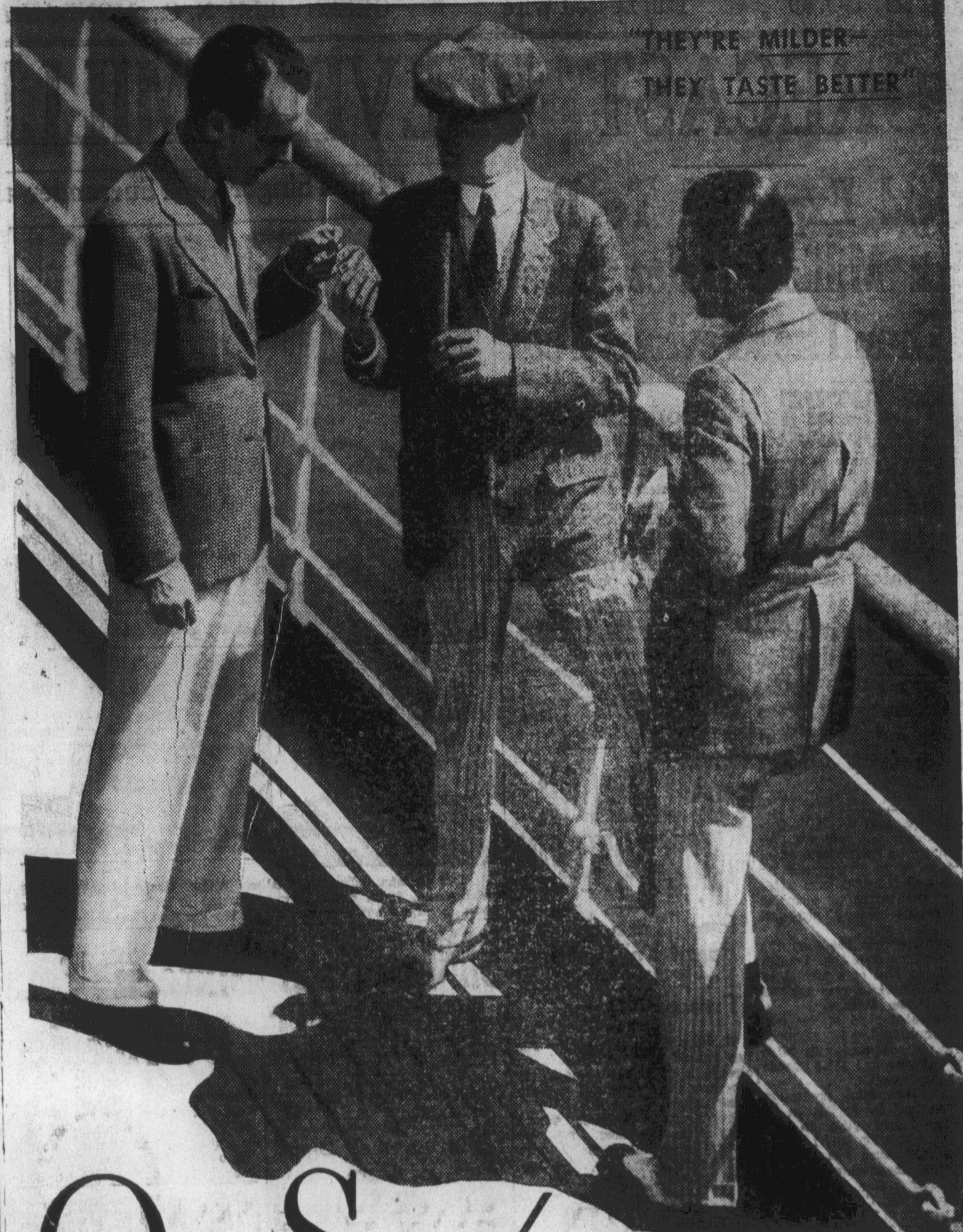

TWO HELD IN DEATH PROBE

Man and His Housekeeper to be Quizzed in Slaying of Natchez Recluse.

Natchez, Miss., Aug. 8.—(AP)—Richard H. Dana and his aged housekeeper, Octavia Dockery, eccentric neighbors of the slain Jane Surget Merrill, 68-year-old recluse, were brought into the center of the investigation of the strange killing today by a tentative report of fingerprint experts.

Sheriff Clarence P. Roberts said J. E. Chancellor, berrillon man of Jackson, Miss., had informed him fingerprints bearing "marked resemblance" to those of Dana had been found on articles in the Merrill home and asked for new prints of Dana's fingers.

The sheriff planned to grill Dana and his housekeeper again despite their stubborn insistence that they know nothing of the killing. Sheriff Roberts contended Dana had a motive for the killing because of ill feeling that had existed between Miss Merrill and Miss Dockery on deprecations of the Dockery goats that ran at large.

Officers spent Sunday afternoon searching the two ante-bellum estates "Glenburney," the well kept home of Miss Merrill and "Glenwood" once a show place of Natchez but now a near ruin occupied by Dana and his housekeeper and adjoining the Merrill property.

When the sheriff reached the Dana home he had to drive goats, chickens and ducks from the high ceilinged rooms of the one time fashionable home of the aristocratic Danas.

Near the close of the last century both the Merrill and Dana families occupied prominent social positions in Natchez but some years ago "Miss Jennie Merrill," a belle of the 70's and Dick Dana retired from the world on their adjoining estates and refused to receive visitors.

Dana carried his life of seclusion to such an extent that he was declared incompetent by a court and his housekeeper, Miss Dockery, was named his legal guardian.

Now the sheriff is running out clues, which he said indicated that Dana entered the home of Miss Merrill last Thursday night and after a furious struggle shot her to death and then carried her body out to a thicket two hundred yards away and dropped it.

Natchez stood aghast today over the turn of events for two of its ancient families, the Merrills and Danas, who have sent from their plantations statesmen, soldiers, authors and ministers to take prominent places in human achievement.

Reynolds Talks New Chairman at the Capital

Raleigh, Aug. 8.—(AP)—Robert R. Reynolds, Democratic candidate for the United States Senate, conferred with friends here today, preparatory to the meeting tomorrow night of the State Executive Committee at which a chairman will be named.

Reynolds said he would confer with J. C. B. Ehringhaus before the meeting. He expressed hope they would agree on selection of a chairman.

Ehringhaus and Gov. O. Max Gardner have endorsed J. Stanley Winborne of Marion for the post.

Hold Youth for Store Robberies

Raleigh, Aug. 8.—(AP)—Raleigh police detained a ten year old boy today, who claimed he had robbed five stores, breaking into some of them at night.

"I'd just as soon sleep here as anywhere else" the lad said as the police provided special sleeping accommodations for him.

The father of the boy, Charles Bryant, is dead. His mother said she would not object if he were sent to a training school "where some learning would be forced on him."

Negro Receives an Invitation To Dine with Pres.

Natchez, Miss., Aug. 8.—(AP)—Charlie Isaacs, negro delegate to the Republican national convention, says he has received an invitation to lunch at the White House on August 11, the date when President Hoover is to be notified of his renomination by the Republican party.

The negro is a member of the Mississippi "Black and Tan" Republican state executive committee and was appointed to represent Mississippi at the ceremonies.

Sweden Gives Greta Garbo Big Welcome

Stockholm, Sweden, Aug. 8.—(AP)—A hundred straining policemen reinforced by strong-armed dockhands were required to restrain thousands of ardent admirers of Greta Garbo when the liner Gripsholm arrived here today.

True to the legend of elusiveness Garbo did not make an appearance until long after the gangplank was lowered.
