## LIBBY HOLMAN PULLS DRAMATIC "FADE OUT"

### Stimson's Address On Kellogg Pact Produces "Irritation" In Tokyo

### GENEVA SHOWS SATISFACTION

Dispatches indicate that Japanese officials interpret Stimson's speech as an implication that Japan was aggressor in Manchuria; Government asks for a complete copy of remarks.

(By The Associated Press)

Irritation in Tokyo and satisfaction in New York last night of Secretary of State Henry L. Stimson on the Briand-Kellogg pact.

Secretary Stimson speaking before the council on foreign relations, cited events in the Far East last winter as indicating how effectively the pact may be employed in putting a peaceful end to hostilities by mobilizing public opinion against them.

He recalled that the assembly of the League of Nations supported the United States in an assertion that it would not recognize any situation, treaty or agreement brought about by means contrary to the obligations and obligations of the pact.

"Moral disapproval, when it becomes the disapproval of the whole world, takes on a significance hitherto unknown in international law."

In Tokyo today the Japanese foreign office asked its embassy in Washington to send a detailed report of Secretary Stimson's speech.

Dispatches stated Japanese officials interpreted Secretary Stimson's remarks as an implication that Japan was the aggressor in Manchuria, an aggressor against whom the whole world was organized and mobilized as never before.

In Geneva satisfaction was expressed in League of Nations circles over what was described as "a guarantee that in any future call for action by the League the attitude of the United States will be known in advance and possible cause for embarrassment removed."

Stimson's comments on the co-operation between his government and the League in the Sino-Japanese situation were interpreted as a basis for cordial, though independent, co-operation by the American government with the League.

In Washington the speech was accepted as pointing the way to the American government's policy in the East—apparently an open door policy.

### Hoover Praises Dead Republican

Washington, Aug. 9.—(AP)—James Francis Burke, counsel for the Republican National Committee, who died here last night, was praised today by President Hoover as "an indefatigable worker" who "labored for the country he loved up to the hour of his death."

The death of Burke leaves a major vacancy to be filled in the previously nearly completed party organization.

### TWO HELD FOR KILLING WOMAN

Hermit and Housekeeper Jailed in Mysterious Death of An Aged Recluse.

Natchez, Miss., Aug. 9.—(AP)—A man and woman who strangely abandoned bright social careers in the days of duels and chivalry on the Mississippi were charged today with murder of a contemporary, Miss Jane Merrill, aristocratic belle of the 70's who likewise chose seclusion.

Formal charges were read to the couple, Richard Dana and Octavia Dockery, last night after Bertillon experts reported they found a fingerprint identified as that of Miss Dockery and others showing "marked resemblance" to those of Dana in the lonely old mansion where Miss Merrill was slain last Thursday night.

Positive identification of Dana's fingerprints was withheld pending further study. It was the fingerprints, added to conflicting stories told by Dana and Miss Dockery, that resulted in the murder charges filed against 61-year-old Dana and his 60-year-old housekeeper, who lived on an acreage adjoining the estate of Miss Merrill.

Dana told officers he was outside "watching the sky" when he heard shots and a woman's scream in the vicinity of the Merrill home. But Miss Dockery said he was in his room. They also disagreed as to the time of the shooting.

In his cell today Dana was reported by officers as having blurted: "I did not throw the coat over her head."

They said he was referring to an overcoat found in the Merrill home in the midst of broken and blood splattered furniture.

For years Dana has been regarded as a recluse. (Continued on Page Four)

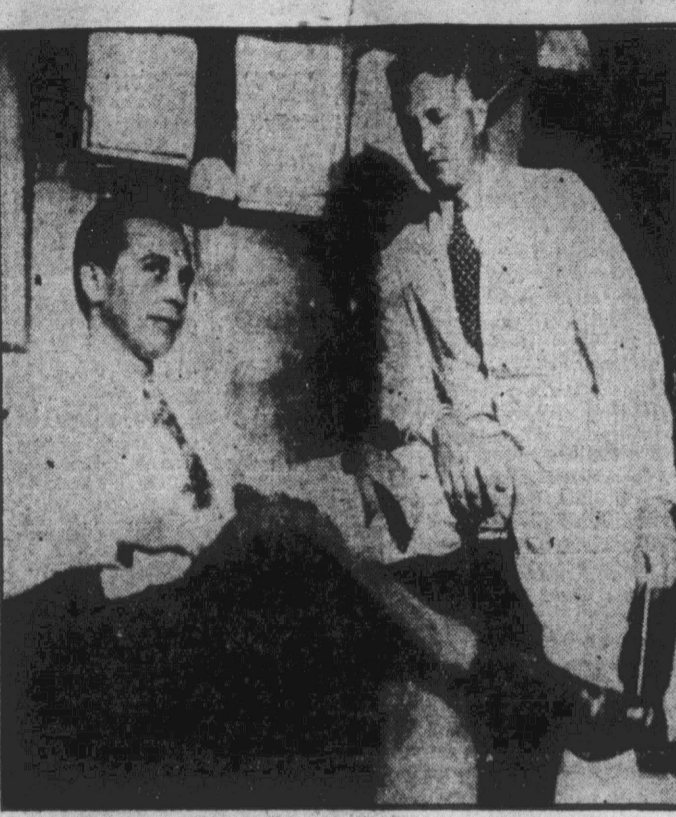

### MRS. KEATON GETS DIVORCE

Wife of Famous Film Comedian Granted Petition of Separation, Los Angeles.

Los Angeles, Calif., Aug. 9.—(AU)—The asserted nocturnal habits of Joseph F. (Buster) Keaton, solemn-faced film comedian, which kept him away from fires several times a week, have cost him his wife.

Accompanied by her sister, Constance Talmadge Netcher, Mrs. Natalie Keaton came to court and quietly testified at a divorce hearing of the neglect, the worry and the trouble she had been caused by the antics of her husband.

"My husband was impossible," testified Mrs. Keaton. "He would stay away from home, many times all night, and would not tell me where he had been. It upset me terribly. I could not sleep and would pace the floor for hours."

Mrs. Netcher corroborated the testimony of her sister, declaring that Mrs. Keaton frequently telephoned her in the middle of the night asking her to come over and stay with her because Buster was not at home.

The incident of the airplane ride on which Buster took his two sons, Joseph, 10, and Robert, 8, was related by Mrs. Keaton as having caused her worry.

"We had quarrelled all night," she said. "I had gone to my mother. He got the children up at 5 o'clock in the morning. The nurse called for them." (Continued on Page Three)

### Ask Federal Farm Board To Hold Cotton Off Mart

Atlanta, Ga., Aug. 9.—(AP)—The South jingled new money in its pockets today and figured it was several million dollars richer, at least on paper, as a result of the \$5.00-a-bale upswing in cotton.

As the rise in price increased trading, appeals came from several sources for the Federal Farm Board to withhold the stabilization cotton controls from the market.

Governor O. Max Gardner, of North Carolina, urged the Farm Board to announce it would hold its cotton until the price reaches ten cents a pound, and Congressman Charles R. Crisp wired the Board an appeal "to make public announcement that its cotton holdings will not be disposed of during this crop year."

### PLAN STEPS TO STOP RIOTING

German Government to Take Drastic Action to Bring Disorders to an End.

Berlin, Aug. 9.—(AP)—The German government, goaded by two months of rioting, bombing, shooting and knifing, prepared today to swing its mailed fist and "brutally wield" its authority to put an end to political disorders.

Returning from a holiday to find the local bloodshed and sabotage still going on, Chancellor Franz Von Papen called his cabinet together to map a campaign to use the sternest measures, possibly including the death penalty, to restore peace throughout the Reich.

As he prepared to go into action, Chancellor Von Papen, whose manner usually is nearer breezy than belligerent, assumed a new role. In a brief semi-official communique issued last night after riots had taken two more lives, he declared the government would take the most drastic measures, and added: "Our authority must be wielded brutally."

Since his government took office June 2 well over one hundred have been killed and nearly 1,500 seriously injured in political battles.

Today's action followed urgent pleas from every part of the Reich seeking relief from the reign of terror. In the press today, however, there were complaints that the banks be established.

### TWO YOUTHS AID GET-AWAY

Wife of Smith Reynolds, Slain Millionaire, Goes into Complete Seclusion Eight Hours After Being Granted Bond At Wentworth; Whereabouts Shrouded In Mystery; Her Father Confers with Attorneys at Winston-Salem.

### Campaigns for Dad

Reidsville, Aug. 9.—(AP)—Eight hours after she had made another spectacular dash into seclusion, the whereabouts of Libby Holman, torch-singing widow of Smith Reynolds, tobacco heir, was as much of a mystery as ever today.

A "fade out" as dramatic as any in her theatrical career again removed Libby from the public gaze to which she returned yesterday for the few hours of swift activity necessary to obtain her freedom under bond on a charge of killing her millionaire husband a month ago.

The former Broadway blues singer called on all her knowledge of theatrical effects, of swift changes of roles and costumes for the stage setting of her 2 a. m. dash to a retreat, such as she has occupied since the inquest at which a coroner's jury held the heir to the Reynolds tobacco fortune came to his death at the hands of a person or persons unknown.

Yesterday it was a grief-bowed widow, ill from the strain of recent weeks, who appeared before Judge A. M. Stack at Wentworth, near here, after surrendering to the North Carolina law at a roadside filling station.

Today mourning was not in evidence as the young widow, flanked by two young men, appeared in the lobby of a hotel here and after making sure there was "nobody around" hurriedly entered a large sedan and sped away into the dark.

Instead of yesterday's sombre black gown and heavy veil, Libby today wore a snappy sports outfit of tan, with a comparatively short skirt and a matching sweater close-fitted to her figure. Yesterday's small black hat gave way to a light colored beret. The veil was gone, too, but in its place were heavily rimmed dark glasses.

Her companions were Alfred Holman Jr., her brother, and another youth, as yet unidentified.

The get-away was carefully planned and timed.

After the Wentworth hearing, the Holman party returned to Reidsville and rented rooms at the Belvedere Hotel. Mrs. Reynolds remained in the room during the early part of the evening and veiled herself even from the bellboys and waiters.

Soon after dinner, her father, Alfred Holman, left for Winston-Salem with Benet Polikoff and William Graves, Libby's attorneys.

As he left Holman announced no further news. (Continued on page three)

### SEES AID FOR HOME OWNERS

All members of the board, appointed by President Hoover Saturday, gathered for their first meeting at the Commerce Department and after being sworn in by F. W. Lathrop, chief clerk of the Commerce Department, planned to call on the President to pay their respects.

Fort explained the first job before the board is to determine how many districts will be created. The act provides that not more than 11 banks be established.

**ABOUT TOWN**

The government estimate of an eleven million bale cotton crop this year had a pronounced effect on the cotton market yesterday and prices surged up to an increase of \$5.00 a bale.

While the report was based on the condition of the crop August 1, it is believed by some that it will fall under this amount in view of the toll taken by the boll weevil since the first of the month when wet weather improved conditions for the boll weevil.

The estimate is almost six million bales less than last season, and about play an important part in the world situation despite the fact that the market has been congested for years.

It is impossible to say what the final outcome of the situation will be but the reduced estimate and accompanying rise in prices is the best news growers of the south have had in many a day, and everybody will hope that the climb upward will continue.

Nothing should be allowed to go to waste in Pitt county during the present harvest season, in the opinion of Miss Ethel Nice, writing on the subject, "Food Conservation" in the columns of this paper today.

Miss Nice as hundreds of other leaders of farm women in this country, is advocating the canning of all surplus fruits and vegetables in order that sufficient foodstuffs may be laid aside to take care of demands of the various communities during the winter.

Considerable attention was given to this movement last year, and had not Pitt county people responded admirably it is impossible to say what would have become of the hundreds of poor people who were cared for by the liberal stocks laid aside by the farm folks.

Although it is hoped conditions will be some better this season, the people are urged to can as much food as possible and be prepared for eventualities. With prices for the main crops fluctuating precariously from day to day it is impossible to say how the price situation will be and if it continues low the people will be able to live at home through the medium of the foods canned during the harvest season.

**Upshaw Would Put Women in Cabinet**

Asheville, N. C., Aug. 9.—(AP)—William David Upshaw, the national prohibition party's candidate for President, plans if elected to put women in his cabinet, kick drinking public officials out of office and wage war on wet newspapers.

Chairman Stone said today, however, that he and his colleagues participated only because of their interest in higher prices for the commodity and because they wanted the benefit of any knowledge the board might possess on the cotton situation.

The board said that the Cotton Stabilization Corporation would not sell more than 650,000 bales of the approximately 1,300,000 it controlled during the year beginning August 1. Since then Congress has taken 500,000 bales to be distributed for charitable purposes by the Red Cross. This and the 450,000 will virtually dispose of the stock the board has acquired through stabilization operations.

 Walter Johnson perhaps has few visions now of winning an American league pennant with his Washington Senators this season but at least he has uncovered the most effective pitching rookie in the circuit.

Monte Weaver, who quit mathematical calculations to cast his lot with baseball, now leads both leagues in games won and lost with 18 victories and only five defeats. His only rival among first-year men seems to be Lon Warneke of the Chicago Cubs.

Weaver has beaten every club in the American league at least once. He has whipped the Philadelphia Athletics five times; Boston and St. Louis twice and Detroit Chicago three; New York, Cleveland once. Of his five defeats, three were handed him by St. Louis.

The others are credited to New York and Chicago. What makes Weaver's record all the more remarkable is that he suffered three defeats in one five-day period and now has not lost a game since June 14.

 in by Eugene Meyer, governor of the Federal Reserve Board, looked toward disposal of a part of the approximately 13,000,000 bale carry-over.

Chairman Stone said today, however, that he and his colleagues participated only because of their interest in higher prices for the commodity and because they wanted the benefit of any knowledge the board might possess on the cotton situation.

The board said that the Cotton Stabilization Corporation would not sell more than 650,000 bales of the approximately 1,300,000 it controlled during the year beginning August 1. Since then Congress has taken 500,000 bales to be distributed for charitable purposes by the Red Cross. This and the 450,000 will virtually dispose of the stock the board has acquired through stabilization operations.

Miss Hoyt, tall, dark-eyed and dark-haired, said she wanted terribly to return to America now, but her friends advised her to rest and recover from her illness and shock.

She is a sister to the late Elinor Wiley and a daughter of the former United States Solicitor-General.

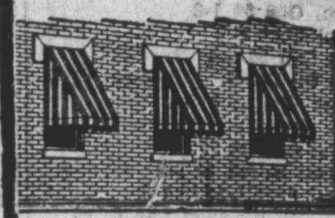

New York, Aug. 9.—(AP)—Cotton futures opened barely steady, 17 to 21 points lower on heavy overnight selling partly for Southern account and profit-taking and on disappointing Liverpool cables.

Except for relatively easy Liverpool cables and belief that yesterday's advance had weakened the technical position, no particular factor was mentioned in connection with the decline which carried prices off to 7.01 for December, or about 27 points below the yesterday's high. Houses with Liverpool connections were among the heaviest sellers, presumably on the differences. There was some scattered Southern selling and considerable realizing. However, contracts were taken by the trade, by further covering and by a broadening commission house demand and there were partial rallies. December was holding around 7.12 at the end of the first half hour, or about 25 points net lower. Liverpool cables reported Continental and Bombay selling. Some selling locally was believed to be for Continental account.

### Stock Market

New York, Aug. 9.—(AP)—The stock market followed a zig-zag course between alternate waves of profit taking and fresh buying today, and closed with a fairly steady tone, with changes in pivotal issues largely narrow. The turnover approximated 2,800,000 shares.

New York, Aug. 9.—(AP)—The bull campaign in the stock market found the list less responsive today, and while prices were given a sharp boost occasionally, advances were not well maintained.

Trading continued in large volume, but substantially under yesterday's. A brisk advance in the utilities in the late morning failed to attract an impressive following, and the list generally balked at exceeding yesterday's highs. By early afternoon, a number of issues were a point or two under yesterday's close. A sell-off at the opening had been quickly checked.

Extreme gains of 2 to 3 points were registered around noon in such issues as American Telephone, American Water Works, North American, Public Service of New Jersey, Stone and Webster, American and Foreign Power, American Power and Light, American Can, Allied Chemical, Safeway Stores, Coca-Cola, and others. This advance was substantially reduced, however, as U. S. Steel Common and Eastman reacted to show losses of about 2 points during the early afternoon. Case, Union Pacific, Santa Fe and American Telephone slipped a point or so under yesterday's close.

A morning setback in wheat tended to take some of the edge off the bullish enthusiasm, this may have been in part due to indications that the plan proposed by Eugene Meyer to aid in financing the movement of commodities to fabricators was apparently directed toward cotton and some other lines, at the start at least, rather than wheat. Bar silver joined the sharp advance of 1 cent an ounce to 28 1/8 cents.

**ASK FEDERAL FARM BOARD** HOLD COTTON OFF MARKET (Continued from page 1) The surplus stocks approximate 3,300,000 bales, of which 1,300,000 are held by the Board and 2,000,000 by co-operative agencies.

Federal Farm Board's decision to market the cotton it acquired in its stabilization efforts is viewed by Governor Gardner as a "serious threat to advancing cotton prices."

The governor, here on vacation, issued a statement denouncing the Farm Board for "dumping its holdings upon the present market."

He urged instead that the Board announce it will not sell any cotton until it reaches 11 cents a pound.

"If we are to have a semblance of prosperity," the governor said, "the cotton market must be relieved of the threatened and constant menace of the Farm Board cotton."

"This cotton," the statement continued, "controlled by the Farm Board, belongs to the taxpayers of the nation. It was purchased and paid for with their money. When every effort is being made by the government to pump currency into the arteries of commerce and business for economic recovery it is nothing less than a national and social crime for the Farm Board, an agency of the government, to dump daily 10,000 to 20,000 bales of cotton on the depressed market."

He cited, as others have done, competition from other coal producing fields and from other competitive fuels. He said freight rates show that some coals are given preference in certain localities, but insisted this is no fault of the operators.

Evenson said the Appalachian Coal producing area supplied 68 per cent of 3,215,337 tons of coal used annually by North Carolina; 33.4 per cent of 4,880,098 used by Georgia; 96 per cent of 2,400,025 used by South Carolina; 84 per cent of Georgia's 3,024,614 tons; 57.8 per cent of Tennessee's 5,582,419 tons; 56.4 per cent of Kentucky's 4,428,463 tons; 34.8 per cent of Ohio's 45,847,298 tons; 44.3 per cent of Indiana's 6,484,137; and 23 per cent of 32,254,255 tons bought in the Chicago area.

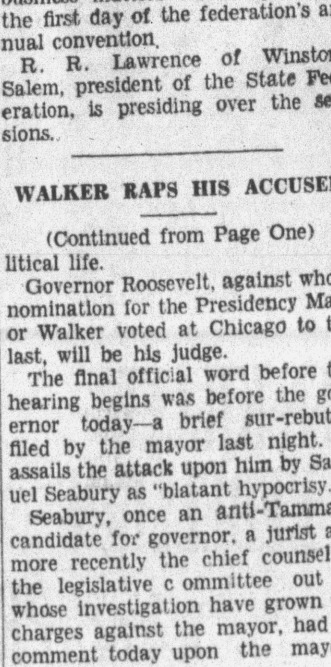
