# TWENTY-TWO KILLED BY TROPICAL HURRICANE

## Mayor Walker May Get Opportunity to Face His Accusers In Probe

### WITNESSES TO BE EXAMINED

Freely Reported At Today's Hearing that Gov. Roosevelt Will Call Upon Seabury Produce Some of Those Who Testified Against the N. Y. Mayor; Mrs. Walker May be Permitted to go on Stand.

Albany, N. Y., Aug. 15.—(AP)—Mayor Walker of New York, demanding the right to face his accusers, may have that opportunity early in this week's executive investigation of his fitness to retain the office to which he twice was elected.

As today's hearing opened it was freely reported that Governor Roosevelt, conducting the public investigation of charges against the mayor, would today or tomorrow call upon Samuel Seabury to produce some of those who testified against the mayor.

Mrs. Walker, who has recovered from her illness of last week, and Edward L. Stanton, former secretary to the mayor, may also be permitted to testify.

State Commissioner Walter B. Herrick, whose testimony before the Hofstadter committee contradicted that of his friend, Mayor Walker, was here today, at the request of Governor Roosevelt to testify at the hearing.

Herrick told the Hofstadter investigators that he bought 300 shares of Interstate Trust Company stock with the understanding they were for Mr. Walker.

The mayor denied he had Commissioner Herrick to purchase the stock. He urged Mr. Roosevelt to call Stanton, his former secretary, and Mrs. Walker to corroborate his testimony.

## Desperado Will Be Tried At a Special Court

Reidsville, N. C., Aug. 15.—(AP)—Clay Fogleman, desperado charged with murder of two men, will be tried at a special term of court to open at Wentworth on September 3. It was announced today.

Fogleman is accused of killing W. J. Carter, a filling station operator near Leaksville, who was shot in a hold-up last May. He also is alleged to have killed a deputy sheriff who was shot to death a week after Carter was killed.

Fogleman was captured in Cincinnati here he wounded a detective in a gun battle.

## Red Shirt Leader Dies In Robeson

Lumberton, N. C., Aug. 15.—(AP)—William Austin Smith, 62, a warehouse of the Robeson County Democratic party since "Red Shirt" days, died today from pleurisy and complications.

He was a deputy sheriff and county jailer at the time of his death, and formerly served as a deputy revenue commissioner and rural policeman.

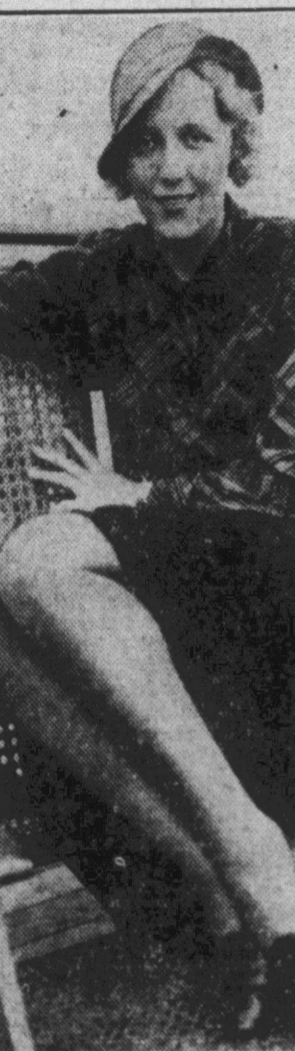
## State Gives To Democratic Fund

## PROBE SLAYING IN PERQUAMINS

## Officers Attempt To Link Killing of Boy with Three Other Murders.

Edenton, N. C., Aug. 15.—(AP)—Officers investigating the apparent slaying of Joe Burch, 17-year-old youth in Gates County near here, today sought to determine whether there was any connection between it and three unsolved slayings in Perquimans county two weeks ago.

Burch was found dead on a highway Saturday morning, and several hours later his uncle, Collie Burch, middle-aged Bertie County farmer, and his son-in-law, Walter Chappell, were arrested in connection with his death. Confined in separate jails, they professed innocence.

Chappell, officers said, is a first cousin of Linford Chappell, who was shot and beaten to death near Hertford two weeks ago, just before Sheriff Whit Wright planned to arrest him as a suspect in the slaying from ambush of Mr. and Mrs. Clyde Elliott, of Hertford.

The ambush of the Elliotts and the killing of Chappell have not been cleared up, and no arrests have been made.

## RESOURCES OF BANKS DECLINE

Decrease of \$22,891,128.06 Shown By State Banks for Six Months' Period.

Raleigh, Aug. 15.—(AP)—Resources of 294 North Carolina state banks decreased by \$22,891,128.06 during the six months' period ended June 30, 1932, when the semi-annual call was made, the State Banking Department reported today.

A \$15,456,456.43 decrease in loans and discounts was reported and deposits subject to check decreased by \$9,920,977.59. Deposits due public officials showed a gain of \$2,953,504.06.

The total resources of the banks, including 78 branches, was given at \$199,927,812.26 compared to \$222,818,940.32 on December 31, 1931. A year ago resources were \$252,179,489.89. For 356 state banks, including 87 branches.

Loans and discounts as of June 30 totaled \$108,208,853.51 compared with the December 31 figure of \$123,865,509.84. Deposits subject to (Continued on Page Four)

## Department Urges Vaccinations For Smallpox and Diphtheria Before School

Dr. R. S. McGeachy, director of the Pitt County Department of Health, issued an appeal to parents today to have all children vaccinated against smallpox and diphtheria before the opening of schools next month.

Although the department is continuing typhoid clinics in different parts of the county, Dr. McGeachy said due attention would be given to immunization of children against smallpox and diphtheria and urged parents to co-operate with him in eliminating the danger of epidemics while school is in progress.

The vaccination of children before the opening of school is highly important, Dr. McGeachy said, as it does away with the danger of (Continued on Page Four)

## Striking Farmers Of Iowa Picket Highway

Le Mars, Ia., Aug. 15.—(AP)—More intensive picketing of highways and boycotts were reported today as farmers in this section of Iowa attempted to enforce their edict against marketing of farm products during a thirty-day "strike" designed to raise prices.

From Kingsley came reports that 400 farmers had visited all produce dealers of that town and warned them not to open for business today under penalty of having all their goods thrown into the street if they disobeyed.

At Sioux City hundreds of farmers and their wives improvised barriers with their automobiles drawn across the highways and effectively bottled part of the city against trucks bearing farm produce. Stock yard officials reported that no livestock truck traveling to the city from the north had reached its destination.

Although dozens of trucks were stopped, no violence had been reported.

Other farmers acting as pickets on the highway were reported to have stopped a milk truck from Cherokee and poured one hundred gallons of milk into the street. Another truck load of milk was reported dumped near Kingsley.

## Border Tobacco Markets Swing Open Tomorrow

Florence, S. C., Aug. 15.—(AP)—Dixie's tobacco growers today awaited opening tomorrow of markets in the bright leaf belt of Eastern South Carolina for their first definite indication of 1932 prices.

The sing-song chatter of the auctioneers will be heard in warehouses in nine South Carolina towns. Six markets in border counties of North Carolina, included in the belt, also will open.

It was a birth befitting the tiny descendant of a line of powerful kings.

The Princess was attended by two queens, her mother, Dowager Queen Marie, and her sister, Queen Marie of Yugoslavia. His father also was in the household.

## CROPS RUINED IN WIDE AREA

Shipping Suffers Comparatively Slight Damage but Loss of Crops will Exceed \$1,000,000; Galveston Beach, Parade Ground for International Beauty, Stripped of Bath Houses and Concessions; Galveston and Houston Escape.

## May Head W. C. T. U.

The death list mounted to 22 today as faming communities near the gulf coast surveyed widespread damage from the tropical hurricane that raked the vicinity of Houston and Galveston Saturday night.

Most of the fatalities were in villages, or on farms about 30 miles southwest of Galveston, where the greatest force of the storm apparently centered as it whistled inland from the tumbling waters of the Gulf of Mexico.

Crops were ruined over a wide stretch of the coastal country; the heaviest loss being in cotton.

Galveston, protected by its sea wall, and Houston escaped damage of major proportions, although windows were smashed, some buildings unroofed and bath houses and small frame structures demolished. The wind rose to 70 miles an hour here.

While shipping interests reported comparatively light damage, G. C. Ellisor, Harris county agricultural agent, said the damage to the cotton crop alone would exceed \$1,000,000. Rice and corn crops also were ruined.

The death toll was expected to rise higher as communication was reestablished with smaller communities. Red Cross aid was sought by Freeport and Eagle Lake. W. E. Welford, mayor of Eagle Lake, said the families of hundreds of tenant farmers in that section were destitute.

The Galveston beach, parade ground for international beauty contests, was stripped of its bath houses and concession stands. Wharton, known as the "forest city" was virtually stripped of trees.

## Mrs. Jackson Dies At Tarboro

Mrs. Addie T. Jackson, 27, died suddenly at her home in Tarboro last night, according to information reaching relatives here today. Funeral services will be conducted tomorrow afternoon and burial will be made on the J. R. Dixon homeplace near Robertsonville.

She is survived by her husband, C. F. Jackson, three children, and a brother, J. E. Dixon, of Greenville, and a sister, Mrs. L. E. Williams of Newport News, Va.

Mrs. Jackson has several relatives in this county who received news of her death with sorrow.

## Parent-Teacher Institute Opens

CHAPEL HILL, N. C., Aug. 15.—The Annual Institute of Parents and Teachers opened here today with delegates attending from all sections of the State.

The institute is sponsored by the North Carolina Congress of Parents and Teachers and by the University of North Carolina Extension Division.

After today's opening ceremonies Miss Nora Best, assistant professor of library administration, addressed the institute on "The School Library and Its Opportunity," in the first of a series on State problems to be delivered at each morning session.

"State Leaders" and "Parent Education" hours will be held in the afternoons daily, with civic and educational leaders as speakers.

## New Fighting Reported Over Boundary Dispute

Asuncion, Paraguay, Aug. 15.—(AP)—Another battle between Bolivians and Paraguayans was reported in the disputed Gran Chaco region today, but with it came new encouragement for peace.

Eusebio Ayala, whose term as president began today, issued a pre-inauguration statement last night in which he said he considered war over the Gran Chaco "an absurdity," although he added Paraguay would not capitulate without a struggle if such were necessary.

An official communique said the Bolivians attacked the Paraguayan on Falcon with machine guns, but were driven off by the garrison. Fort Falcon is twenty-five miles south of Fort Boqueron, the attack on which, several weeks ago, caused the new eruption of the age-old feud between the two countries over the wild Chaco.

The new president pledged his first act would be to ask the Chamber of Deputies to ratify unreservedly the conciliation treaty at Washington in 1921 and Paraguay's adherence to the World Court.

ABOUT TOWN

News of a reported investigation into the heavy selling on the New York stock exchange last Saturday was received with interest throughout the country in view of the attention which short selling has received the last several months.

Probes of this kind should be conducted in the wake of every heavy selling spree and those responsible for them should be treated in such way that they will not be disposed to take advantage of the public again.

Playing the stock market is risky business under normal conditions, but it becomes a menace when short sellers get busy and clean up the little fellows who have been hanging on, spending their ill-gotten earnings in an effort to get themselves in the clear again.

The plan of home demonstration clubs of the country to get each housewife to set aside at least five cents of foodstuffs for relief purposes next winter should do much toward improving the condition of the indigent population.

This movement along with that started in Greenville to get each civic organization to donate a certain number of cans to the relief campaign ought to result in sufficient supplies of foodstuffs to carry the poor through the winter in better style than all former years.

Conservation of surplus food crops has been conducted upon a more extensive scale this season than ever before and there is no reason for anybody getting hungry long at a time with the immense quantities of food stored away in parlors for consumption this winter.

The plan, although not as extensive as this year, brought good results last season and the relief committees may be assured of being able to deal with the situation with greater facility this season.

People who were wondering what the President planned to do after concluding the dry plank in the Republican party, are no longer in the dark since announcement of the preference of big business men to deal more completely with economic recovery.

Realizing that the Democrats are entering their attack on his inability to deal with the most severe depression the nation has experienced in history, Mr. Hoover is going to call on the nation he has favored throughout his administration in an effort to put himself in the line with those who have suffered so keenly from hard times.

That the Chief Executive has attempted an almost impossible task in the short time before the election, and should be able to effect the transformation in the business world, he will have accomplished an apparently super-human feat.

A failure of the monetary interests to act and act hurriedly will mean the destruction of the President's ambitions to regain his seat in the White House and defeat of his party's charter to hold the reins of government over another four year period. The prospects are not inviting in any sense of the word, but Herbert Hoover is a fighter, and will bring all of his strategy into play to yank prosperity from the corner it has crouched behind for so many years.

The advantage of paving the road from Bethel to Oak City is realized most keenly by the people of this district who keep in close touch with northern areas and it is hoped the highway commission will act favorably on the petition for paving.

U.S. EMERGED BIG WINNER IN OLYMPIC

Los Angeles, Aug. 15—(AP)—The athletic forces of the United States emerged today from sixteen days of unprecedented Olympic competition with the greatest collection of victories gained in this quadrennial carnival in at least twenty years.

They won no less than eight of the seventeen separate and distinct competitions where, unofficially, team championships were involved.

Italy, with three titles to her credit, was the nearest rival the U. S. A. had in the all-around race for medals and points, although there were thrills of triumph for most of the other big nations participating.

Eastern stalwarts like Leo Sexton and John Anderson asserted their supremacy in the weight-tossing duels, besides the contribution of Philadelphia's oarsmen to the nation's rowing triumph.

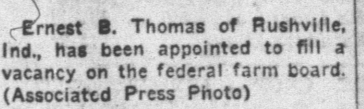

BARNHILL IS ALLOWED BAIL (Continued from Page One) Although no definite action had been taken toward obtaining bond, officers stated it was expected something would be done to bring about Barnhill's release during the week. He will face hearing in the next term of Superior court.

Barnhill was jailed at Williams, on about two weeks ago and later brought to Greenville, given preliminary hearing and remanded to jail without bond. Attorneys immediately asked for habeas corpus hearing before Judge Harris with the idea of obtaining the liberty of their client until the date of trial and this was granted after brief consideration of the case.

The body of Jesse Barnhill, who was reared in the home of the Bethel farmer, was found shot to death on the highway near Flat Swamp church in April. Two bullets had been fired into his body and investigators expressed belief that death had been instantaneous. Barnhill stoutly denied complicity when arrested by Sheriff White, a jurist. Evidence produced in the preliminary hearing here last week indicated that he was seen with his ward shortly before the shooting was believed to have taken place and expressed fear that he had been killed.

It was learned that young Barnhill's life was insured for \$20,000, half of this being made payable to his benefactor and the other to his estate. Since the death Barnhill has filed suit against the insurance company which halted payment of the claim pending further developments in the case.

Officers expressed belief that Barnhill, complicated by debt and pressure from other sources, killed the young man to obtain sufficient money to put him in the clear financially, but the prisoner vigorously denied that he had anything to do with the shooting.

BORDER TOBACCO MARKETS TO SWING OPEN TOMORROW (Continued from Page One) last year. For one thing, South Carolina's crop is estimated at but 36 per cent of normal. Likewise, North Carolina's crop is much smaller, estimates said.

Heavy sales or a big "break" tomorrow were predicted by experienced warehousemen. Farmers claimed the crop is in good condition, despite the fact that it was reduced by drought and mold.

Many farmers have been curing the crop. Dry weather, they said, has added to the value of their product, which annually brings millions of dollars into the section. With sales of the section's most important product to begin, other business was expected to pick up.

Most of this section's tobacco goes into manufacture of cigarettes, for which higher types are demanded. A price of approximately 12 cents per pound for most grades was predicted by one tobacco man here. This is about twice last year's opening average.

Farmers of both states were made optimistic by the prediction of the state-federal crop reporting service that North Carolina's crop this year would be the smallest since 1913.

Markets opening in South Carolina are at Mullins, Kingsree, Lake City, Pamlico, Timmonsville, Darlington, Loris and Conway.

In North Carolina, warehouses will operate at Chadbourn, Fairmont, Lumberton, Whiteville, Tabor and Fair Bluff.

ATLANTA, Ga., Aug. 15.—(AP)—South Georgia tobacco markets will open Thursday with growers hoping for improved prices because of a short crop and higher quality leaf.

The Georgia production was estimated by the Department of Agriculture at between fifteen and thirty million pounds this year as compared with 59,000,000 pounds last year and the grade of cured tobacco was reported as much better.

Growers anticipated a seven-day selling season, one of the shortest on record, and looked to the opening of South Carolina markets tomorrow to indicate a price range.

West and Middle West during his campaign. A person close to Governor Roosevelt indicated the Governor did not agree with suggestions that Mr. Garner devote himself wholly to the West and Middle West, but wished Mr. Garner to do some talking in the East also.

Mr. Roosevelt visited a troop review at Camp Smith yesterday when Mr. Garner drove up and stepped into the governor's machine. "Hello, Governor Roosevelt, you look fine," said Garner.

"Hello, Jack, how is my running partner?" Roosevelt responded. "I'm fine, and you look like you've been training for a prize fight," the Speaker answered.

"It's all right. Everything is all right. Sit down and we'll talk." And they did, far into the night. The traveling conference continued to Krum Elbow, the governor's home at Hyde Park, and then to the executive mansion here, where Garner was an overnight guest.

The Speaker arranged for a conference today with James A. Farley, the National Chairman. There was no announcement concerning the outcome of the Roosevelt-Garner conference, but it was understood the two men agreed they would push an active campaign, reaching as many states and larger communities as possible.

Garner voiced his attitude by saying: "Governor Roosevelt, I came here to get orders from my boss. When you give them, I'll carry the load." The Speaker, it was understood, believed he should not go to the hustings before the middle of September. Roosevelt opens his road speeches next Saturday night at Columbus, Ohio.

September 12 he will entrain for the Middle West, the Pacific Northwest and California, returning through New Mexico and Arizona. That trip will continue until October, ending at Buffalo, which has been tentatively chosen as the State Democratic Convention.

Demand deposits due banks decreased by \$99,912.38 from \$15,661,162.36 on December 31 to \$15,261,249.98 on June 30. Bills payable increased to \$12,727,114.38, a six months' gain of \$575,014.89.

The banks decreased their holdings of United States bonds by \$1,502,704.59, but increased their ownership of North Carolina bonds by \$800,859.88. On June 30, the amount invested in government bonds was \$15,784,216.27 compared with the December 31 figure of \$17,286,920.86. State bonds increased from \$11,279,367.01 to \$12,080,226.68.

County and municipal bonds were increased by \$394,684.88 from \$4,102,513.34 to \$4,487,198.22. The resources of 45 industrial banks on June 30 were \$15,828,587.32 compared with \$19,599,072.15 on December 31, a decrease of \$3,770,484.83.

The two, who lived on a rundown plantation near the Merrill estate, were arrested on the finding of a Jackson, Miss., expert that their fingerprints resembled some found in the Merrill home.

Last night before leaving for Chicago, Sheriff Roberts explained an old negro, had told him to search a St. Catherine Street house for evidence. He did so and found a trunk belonging to Pearlie. In it was a quantity of cartridges similar to those from which bullets were found embedded in the walls of the Merrill mansion.

The date, usually August 18, was advanced three days in order to permit the attendance of members of a congressional commission sent to this region to report upon the advisability of federal participation in a projected celebration in 1934 of the 350th anniversary of the founding of the "lost colony."

For hours yesterday, the commissioners visited Fort Raleigh, and observed the various points of interest connected with the Raleigh colony, which disappeared and whose fate has never been determined.

After their visit to this spot, the commissioners went to Kill Devil Hill, on the sand dunes of the coast, where in 1903 Orville and Wilbur Wright made the first successful airplane flights in history.

He said the department had received suggestions from "those who should know better" that "because some changes in the prohibition system are under discussion and may be adopted, the Department of Justice should relax its efforts to enforce the existing laws."

Mitchell's memorandum adds that a federal easing up "without substitution of any lawful state control would produce chaos. The head of the prohibition organization commended the President's stand in the dry law as indicative of public "demand" for a change.

Dr. Poling said 187 of 205 national committee members and supporters of all committees had voted to endorse the bill, but his election "will safeguard the gains made under prohibition."

He added that the allied forces "will conduct an aggressive campaign for the election of senators and representatives, whether they be Democrats or Republicans, who are against repeal and reestablishment of the old liquor traffic."
