Tobacco Prices Swing Upward on Border Markets

AVERAGES GO OVER 10 CTS.

Price Situation Shows Drastic Change At Darlington, Where 75,000 Pounds Leaf Sells at Average Of 10 Cents; Lake City Reports Average Of 12 1-2c on 100,000 Pounds

Florence, S. C., Aug. 22.—(AP)—Tobacco prices took a decided upswing today as South Carolina and border belt markets opened their second week.

Darlington—The Darlington tobacco market changed drastically today, after several days of discontent by growers, with prices advancing to an entirely new level. Estimates placed sales at 75,000 pounds at an average of 10 cents per pound. Sales were lively, and not a tag was turned.

Lake City—Prices on the Lake City tobacco market showed a decided upturn today as the second week of sales began. Estimated sales totaled 100,000 pounds at 12 1-2c a pound.

Fairmont—Tobacco sales were estimated at 500,000 pounds, at an average of 10 to 10 1-2 cents per pound. Primings showed high color, but were lacking in body. In the better grades prices advanced \$8.79 per hundred over Friday's quotations.

Lumberton—Tobacco prices strengthened here today, with an estimated 300,000 pounds selling for an average of 10 cents per pound.

Atlanta, Aug. 22.—(AP)—Georgia farmers received \$228,834.91 for 2,254,058 pounds of bright leaf tobacco sold at auction during the first two days of the 1932 season, the State Bureau of Markets reported today.

The average price during the first two days was \$1015 per hundred pounds as compared with an average of \$733 per hundred pounds for the first two days of the 1931 season when 6,756,171 pounds were sold for a total price of \$4,954,314.44.

Where 21 markets with 52 warehouses operated in the state last year, only 16 markets with 37 warehouses were opened this season.

The Nashville market received the highest average price for sales for the first two days—\$12.03 per hundred pounds. Other high prices were \$11.66 at Moultrie, \$11.09 at Tifton and \$11.05 at Adel.

Total sales in 1931 were 60,881,696 pounds which brought an average price for the entire season of \$8.41 per hundred pounds. The tobacco growers last year received a total of \$3,901,841.56 for their crop for the entire year.

Yesterday they completed a week in the air. There was some expectation that they would land this afternoon, based on their statement before they took off that they intended to attend the National Air races at Cleveland.

JAPS AGAIN ON WARPATH

Reported Pushing Military Thrust On Jehol, Province Bordering China

Shanghai, Aug. 22.—(AP)—Sensational Chinese dispatches from Peking and other North China points today said the Japanese forces in Manchuria had launched a strong military thrust into Jehol, the province that borders on China proper.

The dispatches said fighting was going on along a "broad front" of the Jehol eastern border, with the Chinese falling back before Japanese artillery, airplanes, and machine guns.

Japanese bombing planes were reported as spreading terror among the helpless border populace, which was streaming into the open country seeking safety.

EXTEND SCOPE OF FARM WAR

Striking Farmers of Iowa Detain Railway Traffic to Prevent Food Deliveries

Sioux City, Iowa, Aug. 22.—(AP)—Striking farmers in their "war" for higher agricultural prices have begun to detain railway traffic to keep farm produce out of Sioux City, meanwhile seeking an extension of their battle lines to Omaha and Council Bluffs.

Two freight trains bound for Sioux City were stopped last night. It was the first attempt of the strikers to prevent rail shipments of farm commodities, all of their previous picketing having been concentrated on motor trucks.

One of the trains was detained at Moultrie, Iowa, by a group of approximately 200 farmers who stopped a freight consisting of eleven cars of livestock bound for Sioux City packing houses. None of the stock was removed, and after a (Continued on Page Four)

COUNTY COURT DERBY PLANES ENDS SITTING IN AIR AGAIN

Winston-Salem, Aug. 22.—(AP)—Entrants in the handicap derby to the national air races in Cleveland began taking off on the second leg of their journey at 10:05 a. m. today, led by J. F. Tuohy, of Olean, N. Y.

The 27 entrants were taking off in the same order in which they left Washington yesterday. They are to make a noon stop at Spartanburg, S. C., and spend tonight in Atlanta.

The second plane to leave was that of Fred Dorset, of Augusta, Ga., winner of yesterday's first leg from Washington here.

Due to the handicaps, figured prior to the derby's start to make each day's first finisher the winner, it takes about an hour and ten minutes for the entire aerial cavalcade to get in the air at the start of each day's flight.

Cleveland, Aug. 22.—(AP)—Two fleets of racing airplanes, one from the Atlantic, the other from the Pacific, nearly a hundred in all, today entered the second lap of the Cord cup transcontinental air derby.

Their spectacular 2,369-mile contest will end at the Cleveland airport Saturday as one of the main events of the national air races.

Hoboken, N. J., Aug. 22.—(AP)—The liner George Washington, which carried President Wilson to France for peace negotiations at the close of the World War, was towed from pier 6 today by three naval tugs, to be taken to the graveyard of ships off Solomon's Island, in Chesapeake Bay.

For the last year the ship, once of the North German Lloyd Line fleet and later one of the old United States Lines fleet, has been tied up at the pier with the liner America, another old German liner seized during the World War.

ABOUT TOWN

The Democratic national campaign was launched last Saturday when Governor Franklin D. Roosevelt delivered the opening address at Columbus, Ohio. He charged members of the Republican party with being responsible for the present economic situation and said the only way to improve the condition was to put the Democrats in power again.

The entire campaign will be centered around the unusual situation confronting the nation at this time and when the campaigning is over the people will know more about the actual condition of the nation than they ever knew before.

With the Republicans absolutely without any strong talking points except a promise to improve conditions in the future, the Democrats have one of the best advantages of years and that they are going to make good of it is not to be doubted.

Roosevelt will visit many important sections of the country from now until November along with other prominent members of the party and what they will have to say should go a long way toward including public sentiment in view of the abject failure which the Republicans have made of running the government the last four years.

The Home Demonstration Department is exerting every effort to get farm women to put up as many cans of vegetables this fall as possible believing that the movement will play a tremendous part in improving the economic situation during the winter.

The drive for more canning has been quite successful the last two years, and if indications count for anything the present year will see the largest supplies of food conserved in the history of the country.

Conservation of surplus food last year aided materially in providing for the poor, and tenant farmers who suffered acutely from the effect of hard times would have fared more seriously had it not been for the canned products of farm owners.

The movement should be emphasized every year until it becomes a habit with farm women. If this is done it will not be many years before this section will be financially independent and money stringency will be a thing of the past.

Jimmy Walker, dapper mayor of New York City, thinks the ouster charges launched against him by Samuel Seabury are the result of a Republican fishing party.

That being the case he should have no trouble convincing Franklin Roosevelt or the courts of his innocence. The thing the people want to know is that he has not been guilty of using his public office for purposes of graft and when he has convinced them of that he will not find it difficult to hold his popularity.

Questionably, he is one of the most popular men in the mighty city in which he lives and rules and his administration must have been mighty satisfactory to the masses or there would have been no such tremendous demonstrations in his behalf when it was learned he faced ouster proceedings following the Seabury investigation.

It is impossible to say what the final outcome of the Roosevelt fishing will be, but nobody doubts that Walker will be able to convince the Governor of the lack of foundation of the charges.

Wesley Cheek Ferrell, tall, husky North Carolinian, has chalked up his 20th victory of the season, the first pitched in major league history to win 20 or more games in his first four full seasons in the big leagues.

The Cleveland right-hander won 21 games and lost 10 in his first full season with the Indians in 1929; won 25 and lost 13 in 1930; and 22 and 12 last year.

His 20th triumph of the current campaign was gained yesterday over the Washington Senators 11-5, in a loosely played game in which 15 passes were given. Ferrell went the route although he was walked for 11 hits and gave six walks. Brown and Edeken, Senator hurlers, handed out nine free tickets.

The New York Yankees stretched their American League lead to ten and a half games over the Philadelphia Athletics by beating the St. Louis Browns 3-1, each team made only three hits but the Yanks bunched all of theirs in the third inning for two runs.

Detroit and Boston split a double bill. Bob Welland gave the Tigers only four hits in the opener which the Red Sox won 3-1. Vic Sorrell limited the Red Sox to seven blows in the second battle and won 4-2.

Chicago's Cubs strengthened their hold on the National League lead, beating the Phillies 2-0, while their closest rivals, the Brooklyn Dodgers and Pittsburgh Pirates, both were beaten.

The Cubs had the benefit of four-hit pitching from the sensational rookie, Lon Warneke, who hung up his 18th victory of the season. A single by Warneke, doubles by Herman and Cuyler and a long fly by Jorges gave the Cubs both their runs in the fifth.

Three Dodger pitchers were pounded for 17 hits as the New York Giants whipped Max Carey's pennant hopefuls 9-3. Eppa Jetha Rixey, 41-year-old left-hander of the Cincinnati Reds, tamed the Pirates for the fourth time this season, scattering eight hits in a 2-0 victory.

The Boston Braves battled 14 innings to achieve a 7-5 verdict over the St. Louis Cardinals and then darkness halted the second game of a scheduled double header with the score tied at 2-2 in the sixth. Dazy Dand relieved Bill Hallahan in the ninth inning of the opener and struck out 10 men in six innings only to lose in the 14th on a walk to Maranville, a triple by Urbanski and a single by Jordan.

NOTED ACTOR DIES IN N. Y.

Wilton Lackaye Dies At Age of 70 After Illness of About Five Years

New York, Aug. 22.—(AP)—Wilton Lackaye, famous actor who made theatre-goers from Maine to California shudder at the villainy of Svengali, died early today at his home here in his 70th year.

Lackaye, a towering personality who for nearly 40 years made his force felt on and off the American stage, succumbed to a heart ailment, after illness had kept him in "involuntary retirement" for most of five years.

The list of his roles occupies several columns in "Who's Who in the Theatre," but it was his Svengali role in "Tribly," from Du Maurier's famous novel of the Paris studios, that was the cornerstone of his national distinction.

Born in Loudon county, Virginia, he studied for a time for the priesthood, and then for the law before turning to the stage his first wife, the former Alice Evans, died in 1919, and in 1928, when he was 65, he secretly married Miss Kathryn Alberta Riley, who had nursed him through an illness. She survives, with his son, Wilton Lackaye Jr., also an actor.

Lackaye was famous for occasional truculence. Broadway still talks about a difference of opinion between him and John J. McGraw, former leader of the New York Giants, during which Lackaye was thrown downstairs and suffered a fracture of the ankle. McGraw, denying that he did the throwing, was suspended from the Lambs Club for a while after the incident.

Lackaye first appeared in New York in 1883 as Lucentio in "Francesca da Rimini" and soon he was playing with Fanny Davenport's company in "Much Ado About Nothing."

He was a founder of the Catholic Actors Guild and was instrumental in organizing the Actors Equity Association, afterward conducting a famous losing battle with John Emory for leadership in that society. Of late years he threw himself into a movement to clean the stage.

days in various spot of dead calm. They are William Drew, New York; William L. Crow, New York; Slandish Backus, Detroit; Ashley Hardy, Boston; and Robert Keilde, Baltimore.

Here is the story of the adventure from Drewrey:

"We sailed from New York July 2, reaching Marblehead five days later. We made the Azores July 28, leaving for Tangiers July 31, and arriving there August 16. We reached Gibraltar Saturday for provisions.

"Although we were inexperienced when we started the cruise, we had no trouble navigating our ketch, The Stortebeker, after the first few days.

"A gale struck us on the fourth day after quitting Marblehead, and we had to heave to and drop the sea anchor for 18 hours. Two days later we encountered a storm which carried away five sails, and held us up for five days.

"In all that blow, our 21-ton craft was never in danger of sinking.

"We met plenty of headwinds, but the so-called 'prevailing southwest' winds were conspicuously absent. We also encountered many calms, totalling about 14 days. These we spent swimming, reading, playing games, and listening to radio concerts.

"After leaving the Azores, we hailed the British steamer 'Pacific President,' and went alongside to check our navigation position."

The vessel sailed yesterday for Malaga, Spain. It will follow the coast to Marseilles, where the craft will either be sold or stored until next summer for the return journey.

CRITICS HOP ON ROOSEVELT

Political Foes Score Utterances of Governor in Campaign Speech at Columbus

Washington, Aug. 22.—(AP)—A barrage of criticism from political foes descended today upon Franklin D. Roosevelt for utterances in his campaign address of last Saturday at Columbus.

Prominent Republican spokesmen were joined by Norman Thomas, the Socialist presidential candidate, in pressing upon Roosevelt inquiries as to why, as governor of New York, he had not already instituted the reforms in stock exchange and bank regulation which he espoused at Columbus.

In addition, the State Department accused him of insinuating the department has "assisted the bankers in the past" by passing on or approving foreign loans. It again denied this activity and said "It would be interesting to know whether Mr. Roosevelt intends to revive this long since discredited story."

Roosevelt's speech had promised that if he were elected it would no longer be possible for international bankers to sell foreign securities in this country "on the implied understanding" that they had been passed upon at Washington.

Representative Snell, Republican leader of the House of Representatives, himself a New Yorker, issued through the party's national committee in Washington a driving attack upon the Democratic candidate. It accused him of having facts wrong in his speech, of joining unrelated incidents and of possessing a "congenital inability to think clearly."

He followed this by piling up queries as to the lack of New York State action during the time Roosevelt has been governor to secure the control of security issuance and banking advocated by the candidate as a national measure.

Senator Moses of New Hampshire gave out in New York a statement to the effect that Roosevelt's address was worded in terms of childish intelligence, while "the presidency is a man's job."

Thomas, addressing a Socialist rally in Providence, Rhode Island, said he agreed with most of the things Roosevelt said about President Hoover but "they sound funny from the lips of a Democrat."

"You can't take the Democratic party away from Wall Street—Wall street has bought and paid for it, as it has the Republican party."

Albany, N. Y., Aug. 22.—(AP)—Returning to the executive mansion after delivering the first stump speech of his Presidential campaign at Columbus, O., Saturday, Governor Roosevelt was manifestly gratified by the sight of a great pile of commendatory telegrams received from all sections of the country.

Some few of the messages, however, were not of a flattering nature, Mr. Roosevelt said.

On Saturday, the second stump speech of the national campaign will be made by the governor at Seagirt, N. J., where a meeting of Jersey Democrats has been arranged.

Reynolds Heads for Winston-Salem

Miami, Fla., Aug. 22.—(AP)—Richard J. Reynolds, Jr., was reported by an official of Pan American Airways as back in the United States today and headed for Winston-Salem, where his brother, Smith Reynolds, died of a mysterious bullet wound.

The authority for the report said he had been Reynolds' fellow-passenger on a trip here by air from Havana and that the pair to tobacco millions was traveling under an assumed name.

Reynolds was in Africa when his younger brother was shot to death July 6 after a party at his estate.

The Pan American official said the elder Reynolds heir used the airplane's transportation from the seaplane base to downtown Miami on his arrival here yesterday but there was no further report of his movements or plans other than he was en route to Winston-Salem.

Two Hoboes Meet Death Atop Train

Salisbury, Aug. 22.—(AP)—A hobo trip to their homes at East Flat Rock ended fatally here for James Cannon and Troy Ward, young textile workers.

Both were killed by a low bridge crossing of the Southern Railway's tracks in the city limits here as they stood on a freight car. Apparently both died instantly as the speed of the train carried them smashing into the bridge.

Ward's body was knocked to the ground, but Cannon's remained on the car and was not discovered until the train reached Hickory. It was removed at Morganton.

Cannon had been working in a High Point hosiery mill while Ward recently was employed in a Hendersonville hosiery mill.

Hyena Attacks Marion People

Marion, Aug. 22.—(AP)—The mysterious animal which has attacked people, dogs and other animals in this section for weeks, has been classified by two persons who saw it as a laughing hyena.

The men saw the animal lacerate a bull dog, they said. It was reported that a hyena escaped from a Winston-Salem zoo some weeks ago and some persons subscribed to the theory it was this section's marauder.

New York, Aug. 22.—(AP)—Cotton future opened steady, 2-6 advance on higher Liverpool cables and reports of heavy rains along the Atlantic coast over Sunday, Oct. 7.60; Dec. 7.76; Jan. 7.83; March 7.96; May 8.08, July 8.18.

Otherwise there was little criticism of weather conditions, but offerings were light and the market showed increasing firmness after the opening. Reports that a firmer tone had developed after a somewhat irregular start in the stock market, probably encouraged buying and prices worked up to 7.81 for December and 8.02 for March or about 10 to 11 points net higher.

Houses with Liverpool connections were buyers here after the call, while there was trade and commission house buying as well as covering and the market was within a point or two of the best at the end of the first half hour. Liverpool cables reported general buying and covering in that market on unfavorable weather reports, but said that cloth buyers were cautious with a moderate business.

Chicago, Aug. 22.—(AP)—Grain traders were "standing by" today, awaiting the effect of the Empire Trade conference at Ottawa on United States markets. Announcement that all wheat not growing in the British colonies would be taxed 6 cents a bushel brought trade in Chicago almost to a standstill and operators tried to analyze the effects of the tariff on future dealings of the United States with the world's biggest market for wheat, the United Kingdom. The supplies of wheat afloat for Europe decreased 925,000 bushels last week and were now 23,552,000 compared with 47,472,000 a year ago, but this was ignored and trade lagged.

Stock Market

New York, Aug. 22.—(AP)—The stock market resumed its advance, under leadership of the rail today. Traders were encouraged by the drying up of selling late last week, and the cheerful tenor of week-end trade surveys. Bull forces succeeded in getting the list back to within striking distance of the peak levels of the recovery, touched nearly a fortnight ago. Advances of 1 to 4 points appeared throughout the list in moderately active trading.

Indexes up 2 to 4 points included Union Pacific, Santa Fe, Norfolk and Western, New Haven, Atlantic Coast Line, Chicago and Northwestern, U. S. Steel, Youngstown Sheet and Tube, Allied Chemical, DuPont, American Can, American Telephone, American Tobacco B, United Fruit, Liggett and Myers B, Eastman, Johns Manville and others. General Electric, General Foods, Bethlehem, National Biscuit, and a wide assortment of rails, utilities, foods, merchandising issues and specialties, gained a point or more.

The share market and some of the principal commodities, notably cotton, moved forward together. Cotton reached new highs for the recovery and wheat acted better. The conclusion of the Ottawa conference, at which it was tentatively agreed to favor Canadian and Australian wheat over the American product in England, failed to have any particularly bearish effect upon that staple.

Rails were helped considerably by Saturday's report on freight car loadings for the week ended Aug. 18, which showed an increase of more than 16,000 cars over the previous week, of which a substantial portion was accounted for by the movement of miscellaneous merchandise, which was accepted as a good sign.

He denied emphatically that he had given up the idea of flying back. In two or three days, given good weather, he will take off, he said for Harbor Grace, where he will refuel and head for Croydon, England.

"You can't miss it on the eastern trip," he said nonchalantly. "The weather and winds are more favorable all the way."

His little craft, first plant of its lightness ever to cross the Atlantic, had to be rescued from souvenir hunters after he landed. He waved his hand in thanks when a woman leaned over a fence and shouted in Scotch accents: "God bless you, Capt. Mollison."
