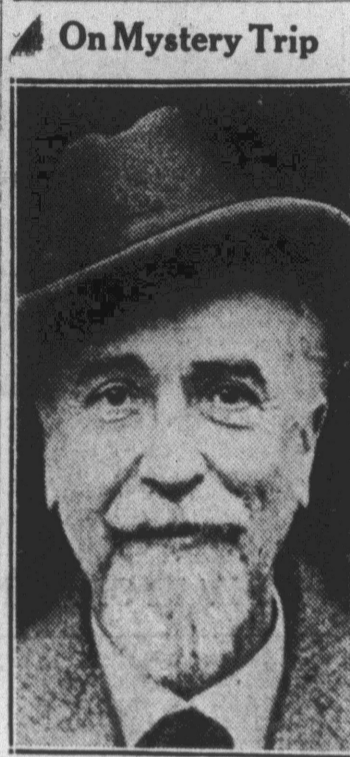

## HOOVER SAYS NATION IS OVER FINANCIAL CRISIS

### Strikers Force Closing Of Rockingham Textile Mill; Furniture Workers Quit

#### HUNDREDS OF MEN INVOLVED

Several Hundred Striking Employees Turn Back 400 Workers to Entwhistle Mill and Force Closing; Thousand Employees of Thomsville Chair Factory Fail to Return and Work is Suspended; Strike Follows Meeting of Workmen Last Night



On Mystery Trip

Rockingham, Aug. 26.—(AP)—Several hundred striking employees of the Hannah Pickett Cotton Mill... massed at the entrance to the Entwhistle Cotton Mill No. 1 here this morning and succeeded in turning back to 400 workers and forcing a close-down.

The sheriff hastily organized a force of deputies to maintain order at the scene, and there was no great disturbance, but civil authorities expressed considerable apprehension as the large forces, officers and Entwhistle employees on one side and strikers on the other, maintained their lines.

Mill officials shortly after 6:30 a. m. announced the plant was closed and would not operate today.

This, the first strike in Rockingham's 97 years of manufacturing, began at the Hannah Pickett Cotton Mill early this week, where employees demanded return to the wage under which they worked prior to two recent reductions.

W. B. Cole and other officials of the Hannah Pickett mill announced the plants had been closed "indefinitely" but the company's number two plant re-opened, and was operating today, although the strikers announced it would be forced to close as soon as a smaller group of pickets could handle the situation at the Entwhistle plant.

About 50 girls and 500 men and boys formed the eordon about the Entwhistle mill this morning. After seeing the mass of people before the gates, Sheriff McNair abandoned any intention of opening a path for the workers, fearing an outbreak of violence.

Mill officials announced no effort would be made to open the plant today or tomorrow. Whether it will open next week depends, officials said, on the ability of peace officers to provide ample protection for those who wish to work.

Burlington, Aug. 26.—(AP)—Approximately 50 employees of the strike-closed hemp mills failed when they came here and attempted to persuade the West Burlington mill employees to walk-out.

Thomsville, Aug. 26.—(AP)—The Thomsville Chair Company, employing approximately 1,000 persons, did not open today, following a strike called by 150 workers in one plant.

Following a meeting of workers last night at which their leaders demanded recall of a wage cut announcement, the company officials locked all plants. Several hundred workers gathered at the seven plants this morning at working time, and mill officials asked if they desired to work. There being no affirmative reply and the plants remained closed. Employees were told paymasters would give them their wages at the various plants tomorrow, the regular pay day.

The strike was begun by 155 workers in plant "A."

At last night's meeting strikers decided to picket the plants today and this was believed to have had a bearing on the company's decision not to open today unless a fair proportion of its employees expressed the desire to work.

At the meeting plans were laid for organization of a local union of the American Federation of Labor. A meeting for this purpose has been called for tonight.

### FAVOR CUT OF UTILITY RATES

#### Members of Commission Indicate Reductions in This State Warranted

Raleigh, Aug. 26.—(AP)—Contentions by representatives of the Durham Public Service Company that it was not getting a "fair return" on its property valuation under present rates were contradicted today by representatives of the City of Durham who asked the State Corporation Commission to reduce electric rates of the service company at least 30 per cent.

The Durham company was the second major utility operating in North Carolina to have representatives appear before the commission for a conference regarding possible rate reductions.

Members of the commission continued to indicate they believed reductions in rates should be made, a position which became evident after representatives of the Carolina Electric and Power Co. (Continued on page six)

### PARTY GIFTS ARE REPORTED

#### Frank Walker Says Contributions Are Arriving at Democratic Headquarters

New York, August 26.—(AP)—Frank C. Walker, Democratic campaign treasurer, reported today that Governor Roosevelt's appeal for campaign funds had resulted in contributions beginning to arrive at national headquarters.

Dr. M. Collier, a dentist, was waiting in the Baltimore hotel when the headquarters were opened this morning to the first to answer the appeal. He had a \$1 bill in his hand, and said he hoped to make additional contributions later.

When the mail at headquarters was opened this morning a silver half-dollar minted in 1830 was discovered in a letter from J. S. Forgrave, Democratic county chairman of Van Buren county, Iowa.

"I am enclosing some Andrew Jackson money for Governor Roosevelt," Forgrave wrote.

Senator Alben W. Barkley, of Kentucky, who was temporary chairman of the Democratic National convention, arrived at headquarters today to confer with Jas. A. Farley, National chairman, and (Continued on page six)

### NEGRO KILLER IS EXECUTED

Nord Donnell Goes to His Death Professing Innocence of Killing Merchant

Raleigh, N. C., Aug. 26.—(AP)—Nord Donnell, Guilford county negro convicted of the murder of A. B. Andrews, a merchant of Sedalia, was electrocuted at State's prison today still professing that he did not kill the storekeeper.

Donnell contended to the end that Leroy Lee, who was jointly convicted with him, shot and killed Andrews. Lee asserts that Donnell did the killing.

As Donnell was led from his cell to the little octagonal death chamber, which was crowded with witnesses from Guilford county, he stopped in front of Lee's cell to tell him goodbye and added that Lee was responsible for his (Donnell's) electrocution.

### PERJURY CASE AT JURY STAGE

#### Closing Arguments Resumed Against George Younce, Former District Solicitor

Lexington, Aug. 26.—(AP)—A Superior court jury is expected to deliberate a charge of perjury against George A. Younce, former district solicitor, here some time today.

Attorneys resumed closing arguments this morning, which were to be followed by the charge of Judge W. F. Harding.

No witnesses were offered by the defense but it contended that the coroner's jury, before which Younce is alleged to have committed perjury, was not properly empaneled on several grounds. #### Rev. F. C. Mitchell Charged With Theft of Automobile at Winston-Salem

### RAPS CRITICS OF U. S. LOANS

#### Atlee Pomerene Declares Return of National Confidence is Here to Stay

Washington, Aug. 26.—(AP)—Atlee Pomerene, the Democratic Chairman of the Reconstruction Corporation, voiced belief today that "this return of confidence is here to stay" and assailed critics of corporation loans.

Addressing the group of financial and business leaders assembled for the President's Economic Conference, Pomerene said 37 per cent of the bank depositors in the United States had been benefited by the loans made by the corporation.

In the six months before the corporation began its work, he said, a total of 1,860 banks failed. In the six months after it began work, he added, only 604 such institutions have closed their doors, with a total of fifty-nine banks failing during the present month.

He said that in towns of 5,000 or less 69.8 per cent of the corporation's loans to banks have been made.

### NOTED WOMAN PASSES AWAY

#### Mrs. McCormick Dies At Chicago After Lingering Illness From Cancer

Chicago, Ill., Aug. 26.—(AP)—Death, near the close of her sixtieth year of life, has ended finally the career of Mrs. Edith Rockefeller McCormick—social dictator, linguist, patron of arts, who once was acclaimed the richest woman in the world.

She died peacefully after a lingering illness with cancer, the end coming in her Drake Hotel suite at 3:30 p. m. (Central Standard Time) yesterday. About her were her reunited family and Edwin Krenn, her faithful friend and business associate who tossed his personal fortune of more than \$1,000,000 into the market in an attempt to bolster the declining fortune of John D. Rockefeller's younger daughter.

Brief bulletin from the physicians brought the word of her death, as serene as was her life, filled as it was with romance, social eminence, bitter personal disappointments, business successes, family unhappiness, and, near the end, financial losses.

The bulletin said: "Mrs. McCormick died at 3:40 o'clock (Central Standard Time). Death came peacefully. All members of her family were at her bedside."

In the group as the end came was Harold F. McCormick, whose devotion to the dying woman attested the friendliness he has always shown since their divorce in 1921. There, too, was Mrs. McCormick's only son, Fowler, who alone had never completely broken the family ties. Present also were her older daughter, Muriel, now Mrs. Elisha Dyer Hubbard, of Middletown, Conn.; her third and youngest child, Mrs. Max Oser, the former Mathilde McCormick; Mrs. Fowler McCormick, the former Pitt Stillman; Mrs. Stillman's son, Alexander Stillman, and Major Hubbard, Muriel's husband. ### UNCLE SAM TO THRILL RACES

#### Expert Fliers of the Army, Navy and Marine Corps Will Show off in Ohio

Cleveland, Aug. 26.—Many of the biggest thrills of the national air races, opening here tomorrow, will be provided as in previous years by "Uncle Sam's own"—the crack fliers of the Army, Navy, Marine Corps and National Guard.

It's a sight that never fails to convince the aviation skeptic of the wonderful ability of Uncle Sam's airmen, and of the stability of their craft.

The largest fleet of the military planes will be sixty-three Boeing fighters from Selfridge Field. Possibly the group most familiar will be the "Leathernecks" of the Marine Corps, represented by their nine Curtiss "Hell D" vers.

A distinguished group of European fliers will provide some of the best of the aeronautical acrobatic and "comedy flying." The foreign team includes Flight Commander A. L. R. Atcherly of Great Britain; Lieutenants (Continued on page six)

### SEEKS TO AID AGRICULTURE

#### Speaking at Gathering of Distinguished Bankers and Business Men, President Proposes Extension of Credit to Vital Points; Would Also Shorten Working Hours and Wider Distribution of Jobs; Promises Every Co-operation of Government Agencies

Washington, Aug. 26.—(AP)—President Hoover today told America's business chieftains the nation has successfully weathered "the major financial crisis" and asked that they assume new initiative and responsibility to restore labor and agriculture to higher levels.

Speaking to an audience composed of the most inclusive gatherings of national banking and business leaders in history, the President proposed specifically that credit be extended to vital points and that arrangements to be made between employer and employee for shorter hours and wider distribution of jobs.

He promised every co-operation of the government in the new endeavor and cited new agencies available for fresh economic attack, but he emphasized it was now time for the bankers and business leaders to go to work in earnest.

"The reason for calling this conference at this particular moment," said Mr. Hoover, "is that we are convinced that we have overcome the major financial crisis—a crisis in severity unparalleled in the history of the world—and that with its relaxation confidence and hope have reappeared in the world. We are now able to take further steps in solution of the industrial and agricultural problems with which we are still confronted."

"What I wish is that banking and industry and business generally should in this new setting assume further initiative and responsibility, and they should co-operate with agriculture and labor and the government agencies to organize and develop every possible avenue of coordinated effort on the economic front."

Beside the President on the platform of the Commerce Department auditorium platform were Secretary Mills and Owen D. Young, New York financier and Democrat, who have worked out a program designed to aid in carrying out the plan for new jobs and credit.

Henry M. Robinson, of Los Angeles, introduced Mr. Hoover. The generals of American business listened intently and gave courteous applause at the finish.

Mills then outlined the program of action, including a plan for creation of a central business committee to direct united action by the twelve banking and industrial committees of the nation.

The Secretary of the Treasury emphasized the central committee was not to be an economic council directing the economic policies of the nation, but rather an organization to bring about co-operation between the government and private business.

Then, one by one, the heads of the government agencies directly involved in the new economic drive for jobs and credit spoke to the meeting, including such financial and business leaders as Myron Taylor, of the United States Steel Corporation; Daniel Willard of the Railroad World; Edsel Ford, Detroit automobile manufacturer; and Melvin Traylor, Chicago banker.

Atlee Pomerene told the hopes and purposes of the gigantic Reconstruction Finance Corporation.

Franklin Fort, chairman of the New Home Loan Banking Board, explained this set-up and announced the decision of Comptroller of the Currency pole to abandon for (Continued on page six)

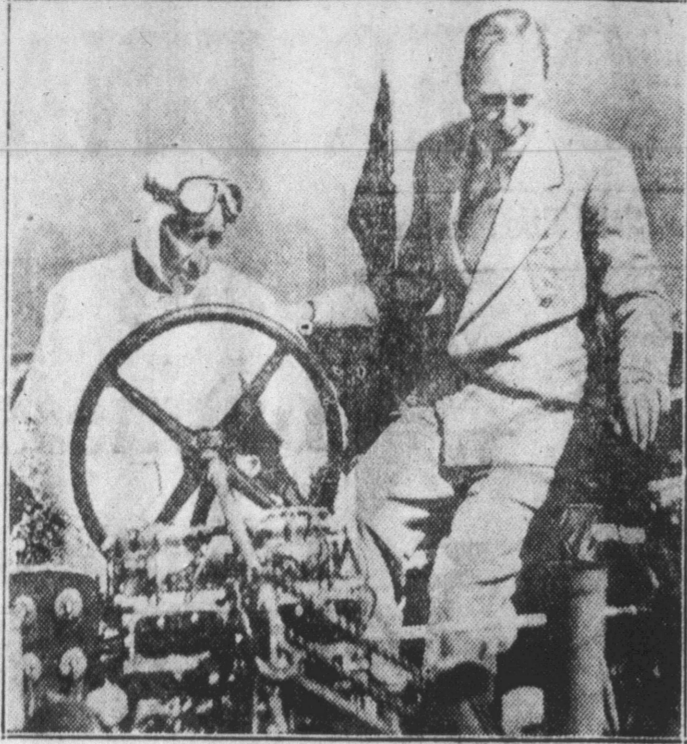

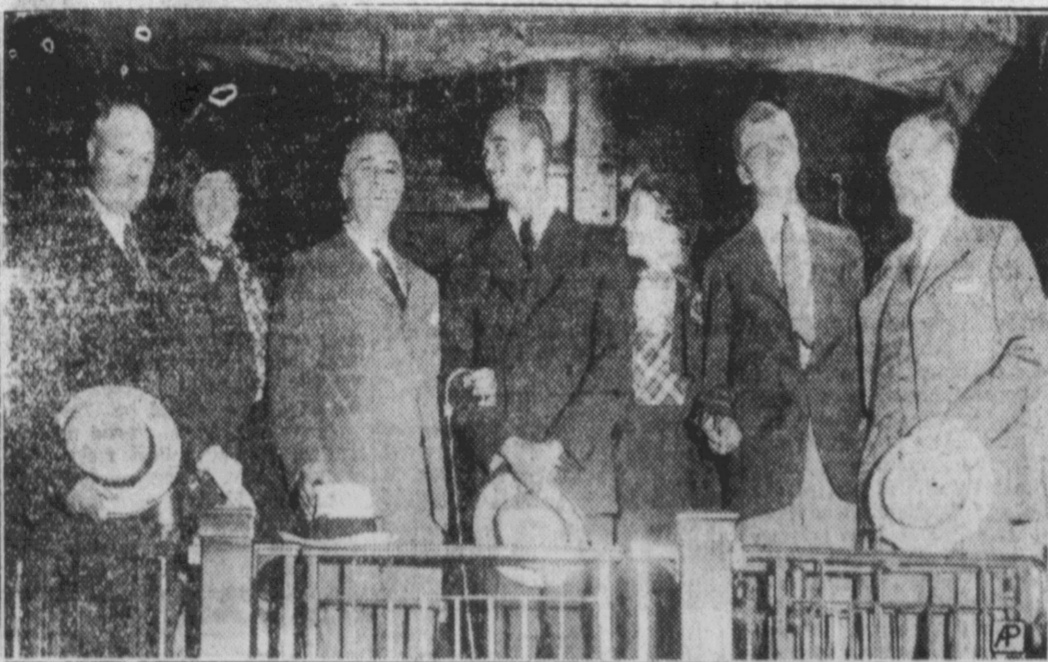

Berlin, Aug. 26.—(AP)—Nationalization of several key industries and further taxation of German capital to finance a gigantic labor creation scheme were discussed today as possible projects of chancellor Franz Von Papen's government.

Aroused by these reports, leading industrialists have called on the chancellor, it was learned today, to talk over his forthcoming economic policy, which will be disclosed in an address to Westphalian farmers at Muenster Sunday.

It has been estimated that plans are afoot for "systemized economy" which might mean nationalization of key industries for economic purposes.

There were also hints that the government is contemplating a plan to finance a labor creation scheme by general tax of three per cent against German capital, or by a three per cent compulsory plan from private citizens of the government.

## Order Banks to Halt Foreclosure Action 60 Days

Washington, Aug. 26.—(AP)—Chairman Fort of the Home Loan Board announced today that comptroller John W. Pole of the currency has ordered every national bank receiver to suspend foreclosure proceedings for 60 days.

Fort made this announcement to the National Economic Conference meeting here today.

"We are today wiring," he added, "every state superintendent authorizing requesting action. We want your help to see not only that receivers generally grant this 60-day suspended respite, but that other lenders do likewise. There are times when forced liquidation of indebtedness is indelible—certainly if any other means of procuring funds exists."

"It would be shameful if, with relief in sight so soon, the courage and hope of our men and women should be extinguished by taking away their homes and their life savings."

## Japan Criticized For Her Plan to Recognize Nation

London, Aug. 26.—(AP)—Japan's announced intention to recognize the government of Manchoukou was roundly criticized by several of today's newspapers, but official comment was reserved.

In government circles it was said that any statement on the issue is unlikely prior to action by the League of Nations on the report to be submitted by its commission investigating affairs in the Far East.

The report is not expected at Geneva before September 20, probably too late for action at next month's meeting of the League assembly.

## Delays Action in The Davis Case

Harrisburg, Pa., Aug. 22.—(AP)—Governor Gifford Pinchot's demand that Senator James J. Davis be asked to resign his candidacy for reelection because of his indictment by a Federal jury for participation in an alleged national lottery, will remain unanswered for at least a week.

The resignation, sought in a letter to State Chairman Edward Martin, demanded that the Republican State organization ask the Senator to withdraw as a candidate in the November elections.

Senator Davis said last night in Cleveland, where he is attending a convention of the Loyal Order of the Moose, of which he is director-general, he would make no statement, in any event, until sometime next week. Martin could not be reached for comment.

In asking Davis to quit, Governor Pinchot's letter said "the whole country is aroused against racketeering in all its forms. Davis stands indicted as a lottery racketeer."

"Ever since he first became a candidate for the Senate, and even before that time, James J. Davis, junior Senator from Pennsylvania, has been under suspicion," the governor stated.

"The charge is a particularly unpleasant one," he added. "It is alleged that he not only browbeats the law by engaging in an illegal lottery, but that he also received at least \$100,000 from the proceeds of the lottery, and thus converted to his own use funds that should properly have gone to children and other in need."

The governor was careful to point out "it is not enough to say that Davis has not yet been proven guilty... the Republican party cannot afford to run a candidate who is under suspicion."

## Tells How Blonds Spring Into Being

Ithaca, N. Y., Aug. 26.—(AP)—The first blond to appear in a race of brunettes resulted from a process much like changing water into gas, it was revealed today by a scientist's new picture of how evolution works.

A new idea of what happens inside genes, the microscopic units of heredity that carry such traits as blond hair, blue eyes or snub noses from mother to daughter, was presented before the International Congress of Genetics by Dr. N. Timofeef-Resovsky of Germany.

He said experiments show a gene is probably a large molecule, or bundle of atoms, a single physico-chemical unit like a molecule of water. The change, or "mutation," such as would be necessary to produce the first blond in a race of brunettes, would be a rearrangement of the atoms in the gene-molecule, just as atoms in a water molecule are rearranged when the water changes to gas.

Rejoicing continued among the farmers of the nation with reported advances on the cotton market yesterday.

The good news was not confined to the cotton growers, however, as wheat advanced two cents and stocks showed their heels in different fields.

The improved activity in the financial markets has been looked forward to hopefully by the people of the world for the last two years, and it is expected to have a vital part in the ultimate recovery from deflation.

Better prices for farm products to increase our buying power along with more jobs will bring back prosperity quicker than anything imaginable. In fact it is the only thing that can help the situation unless gold mines should be discovered in every vicinity, providing efficient revenue to increase the buying power.

Everybody familiar with tobacco grown in this part of the country knows it is the best there is, but they like to hear somebody else express the same opinion.

This was particularly true in the case of representatives of Japanese government who declared the tobacco grown in this district was considered the best in the world.

People have been saying this for years but it was the first time a direct expression had been received from Japan and it brought a feeling of optimism to people here interested in development of the industry.

With the market opening during the early part of September, the public will have an opportunity to witness the operation of one of the greatest sales centers of the world, and it is expected that the same advance reported on other markets economic conditions will be better than they have been the last two years.

A final effort to boost business before the election in November was being made by President Hoover in the conference with business leaders today.

What the outcome of the conference will be is a matter of speculation at this time, but if there is any chance of improving conditions it is safe to say the President and his cohorts of industry will do it to win votes for the party which they represent.

With the Democrats charging his party with responsibility for prevailing economic conditions, the President is cognizant of the fact that it is either relieve the financial strain or prepare to evacuate the White House next year.

# Rotarians Protest Baseball 'Classic' With Kiwanians

## Claim Violation Of Agreement In Contest Played Here Yesterday

### ASK RE-PLAY OF THE GAME

Scorebook Gave the Kiwanians 16 to 2 Victory, But Rotes Claimed it Should be 52 to 16 as Result of Agreement Regarding Use of Players Before the Game; Spectacular Playing Marks Annual Contest

Persons who failed to witness the annual baseball classic between the Rotarians and Kiwanians club at the Street school grounds yesterday afternoon probably will have opportunity to see a re-play of the game sometime in the near future.

Although the score book gave the Kiwanians a 16 to 2 victory over the Rotes in yesterday's clash, Rotarians contended today the score should be 52 to 16 in their favor because the Kiwanians violated an agreement regarding the use of players.

K. W. Cobb, president of the Rotary club, all dolled up in a gray uniform with green stockings and cap, accompanied by Captain Martin Swartz, halted the game in the third inning yesterday and had Umpire Percy announce that play would be continued under protest.

Explaining grounds for the protest today, Cobb, fully supported by his club, announced that the Kiwanians violated the agreement providing that every member of each club be permitted to take part in the game with the penalty for violation being five runs for each player not used. Basing his claim upon the agreement, he declared the score should be 52 to 16 in favor of the Rotarians in view of the fact that the Kiwanians failed to use ten of their members.

The Kiwanians attempted to make no defense and practically agreed to meet their ancient rivals on the diamond again in the near future, although no definite day was decided upon.

The contest yesterday held thrills for the two or three hundred people gathered to witness it. The first three innings both were played as good ball as one generally sees in a minor league, but in the third frame the Kiwanians used a terrific batting attack for which they became famous in two victories over Wilson, and showed over seven tallies. The score was augmented from time to time until the seventh inning when the game ended by agreement.

Both teams provided some spectacular playing at times, while at others errors marred what might have been a perfect game. Julian "Bubber" White, playing short for the Rotes, made two miscues which proved costly to his teammates, but he was not alone. Dr. Barrett apparently had it in for "Bubber" for the hit two sizzling line drives to short which simply would not stick in White's glove. The short-stop was not discouraged by his failure to handle the drives, however, as he had sufficient company to prevent humiliation simply from dropping the ball.

The Rotes placed their faith in the mighty right arm of "Bull" Bullard, who pitched deservingly at times, but who was unable to stop the bat barrage of the Kiwanians, who hit freely when hits counted for markers.

Fly, elongated field: of the Kiwanians, rapped out a double but got out attempting to stretch it for extra bases.

The Kiwanians connected for a total of 16 hits and had three errors charged against them. The Rotes connected for five hits and committed six errors.

Cobb's three-bagger was the only extra base hit obtained by the Rotarians, Overton, Parrish, Overton and Clifton accounting for singles each. The only two runs scored by the club came in the fourth inning by Swartz and Roebuck.

By GAYLE TALBOT (Associated Press Sports Writer) Mark Koenig, veteran shortstop of the Chicago Cubs reclaimed from big league oblivion three weeks ago to steady their infield, fast in proving himself the biggest \$10,000 worth of baseball player to appear on the scene this season.

His eyesight completely restored, by an operation, Koenig has come back to the big show to play magnificent ball for the Cubs in their drive for the National League pennant. He never was a great hitter but they claim he is fielding even more brilliantly than in 1927 when he was with the champion New York Yankees.

With Koenig in the lineup, a steady influence on the youthful Billy Herman at second base, the Cubs have won 9 of their last 10 games. The veteran who was brought back from the Pacific Coast League where he had been sent to finish out his playing span, has won several games with his bat, but his fielding has been of the greatest value.

He handled 10 chances perfectly yesterday as the Cubs repulsed Brooklyn again 9-3, and extended their lead to five and a half games. In addition, he contributed a pair of singles to a 13-hit attack on three Dodger pitchers. Guy Bush just about paralyzed Brooklyn's flag hopes by yielding only 7 hits.

The Pittsburgh Pirates also dropped further behind when the Phils bombarded them twice 11-3 and 6-5, the latter going 10 innings. Roy Hansen led the Pirates to eight scattered hits in the first game, while Bengie and Jim Elliott tamed them in the second.

In the only other National League game, the Giants socked Bill Hallahan and two other St. Louis hurlers for 17 hits and a 6-5 win. Eddie Marshall hit a double and three singles.

Lou Gehrig's 28th home run of the year with none out in the ninth inning clipped Cleveland 4-3, and gave Lefty Gomez of the Yankees his 21st victory. Babe Ruth previously had belted his 36th homer with Combs on base. Earl Averill hit one for Cleveland.

## WOLFE AFTER BATTING LEAD IN PIEDMONT

Charlotte, Aug. 26 (AP)—Tom Wolfe, the robust young Durham baseball wallpaper, has a good chance of checking in at the end of the season the best batting average the Piedmont League has seen in four seasons.

Hot after what promises to be his first batting crown in the loop, Wolfe is hovering around the .380 mark. Frank Packard of Charlotte, led the loop last year with a .366 record, but Wolfe will have to hit a little harder to beat the mark of .385 hung up by old Dan Boone in 1930.

Boone also led the loop in 1929 with .372 and in 1928 he established what now stands as the highest batting mark ever made in the Piedmont 419. The High Pointer led the league three years in succession and is the only man to lead it more than once.

Boone is gone now, and Wolfe's closest threat is Culbreth of Charlotte, who is some 20 points to his rear.

The Piedmont pennant is all but in the bag for the Charlotte Hornets, what with the club clicking at top form. The Bees added another game to their already considerable lead over Greensboro last night, and today six full games separated the clubs.

With the season's end but two weeks and one day away, the Greensboro fan who expects his club to win is looking at the world through rose colored glasses.

Wilmington gave the Hornets a hard battle and they entered the tenth inning all square. A group of errors enabled Lacy's charges to shove over four runs and win 8-4.

In one of two shutout performances of the evening, Bob Durham allowed the second place Pats but five hits and the Pointers won 2-0.

## SPORTS SLANTS

This being a year for major upheavals, it hasn't been so inconsistent to have Nurni and the Finns take the same downward path that big George Earnshaw and the Athletics, Gabby Street, and his world champion Cardinals, also have been traveling.

It may be some time before any of these combinations sounds upward again in the general scramble to get up from underneath the pile-up.

Meanwhile Japan has served notice, via the Olympics, that it has made the most sensational forward strides in sports of any nation.

After Four Years  
Four years ago, at Amsterdam, Japan scored 19 points in the track and field sports, did pretty well in the swimming and won her first individual titles.

This year the little orientals finished with 35 points, in fourth place, trailing only the U. S. A., Finland and Great Britain in the final team standing, and thereupon turned loose one of the greatest collections of young aquatic stars ever seen in Olympic waters.  
A Japanese, Shuhei Nambu, now holds the world records for both the broad jump, at 26 feet, 21-8 inches,

and the hop, step and jump, 51 feet, 7 inches. Another, Shehei Nishida, is the first amateur athlete outside of the United States to clear 14 feet in the pole vault. Three of the first nine finishers in the Olympic marathon wore the colors of Japan. Even in such sports as rowing, boxing and field hockey, comparatively new to them, the Japanese have made tremendous strides toward approaching the competitive level of nations long familiar with these branches of competition.

**Beaten, Holds Record.**  
Glen Hardin, Louisiana boy who placed second in the 400-meter hurdles, is the first beaten athlete to get his performance on the books as an official world record.

Because Hardin's conqueror, Robert Tisdall of Ireland, knocked over a hurdle, his time of 51.8 was not allowed but Hardin's record of 52 seconds, equalling the world record, was stamped with the approval of the I. A. A. F.

An effort was made to bracket Ralph Metcalfe with Eddie Tolan at 10.3 seconds for 100 meters in the record list. They finished only two inches apart in the Olympic final and were caught in identical time, but the I. A. A. F. declined to sanction this extraordinary proposal.

Threats to place 1,000 men along highways leading into Spencer, Iowa, unless farm produce dealers in that city suspend business were made by holiday leaders.

Addison Parker, counsel for the Des Moines Cooperative Dairy Marketing Association, conferred with Don C. Howard, Polk county holiday chairman, in an attempt to learn if picketing was imminent about Des Moines. Parker said there was some indication that picketing might possibly begin today with men from Boone on the roads.

Donnell was pronounced dead at 10.40. He was given on shock of electricity of 204 minutes and another of 104 minutes.

The negro made no statement after he was seated in the electric chair. Donnell shook hands with Lee before being led to the lethal chamber.

"Goodbye, Nord," said Lee. "Goodbye, Lee, you're bringing me to my death, but I forgive you."

(Continued from page one) Arrangements for Mrs. McCormick's funeral had not been completed today, and it was considered extremely unlikely that John D. Rockefeller, now in his 93rd year, would be able to attend the last rites for his daughter, because of his advanced age.

His son, John D. Rockefeller, Jr., who visited his sister recently, was notified immediately of her death, and he is expected to come from his father's summer estate near Pocantico Hills, New York.

Had Mrs. McCormick lived until next Wednesday she would have been sixty years old.

Her death marked the close of a social dictatorship in which Mrs. McCormick held sway with a stern but quietly hand. Her position in the social world of this Western metropolis was as definite and as absolute as was that of the first Mrs. Potter Palmer in her day. To the end it remained unchallenged.

It was the opinion of Krenn, Mrs. McCormick's business adviser, that financial worries contributed to her breakdown. Once La Salle Street, that thoroughfare of Chicago's high finance, estimated that Mrs. McCormick's wealth exceeded \$40,000,000. That fortune, the gift of her father, is now but a fraction of that sum. Falling stock prices and decreased values of real estate were blamed for vast Chicago and suburban real estate holdings, and with the decline in values she sacrificed much of her Standard Oil and other stocks to aid those who had purchased property from her.

REPLIED DONNELL
