Farmers Start Annual Trek To Greenville For Opening Tobacco Mart

NEW SEASON BEGINS TUES.

Six Sales To Swing Into Action Simultaneously Next Tuesday Morning at 9 O'Clock; Warehouses and Factories in Best Condition of Years to Receive Offerings; Thousands Expected To Attend

The annual trek of farmers to this city for the most important event of the year—the opening of the Greenville tobacco market—was under way today and was expected to continue daily until the golden crop has been disposed of.

The market will be thrown open for the 1932-33 season next Tuesday morning at 9 o'clock, and thousands of people from all sections of the country were expected to be present and witness the initial sale of the greatest industry in this part of the state.

The market is all set to take care of the enormous demands expected from day to day. Eight warehouses and nine factories were ready for business and were probably in the best condition of all previous years.

Five sales will start simultaneously at the following warehouses at 9 o'clock Tuesday morning: Gorman's, Farmers, Star, Forbes and McLean, Dixie. Hard hit by blue mold and unfavorable weather conditions this year the crop has been cut about fifty per cent, the shortest in years.

In the face of this condition and improvement of prices on the South Carolina, Georgia and North Carolina border markets, growers were looking forward hopefully to improvement in the price situation.

The market on the opening last year averaged \$7.55 per hundred pounds, and \$9.40 per hundred for the entire season.

The market, always one of the largest in the world, sold more tobacco than any market in the belt last season, government figures revealed at the end of the season, and tobaccoists were anticipating good offerings this year through the drawing from a larger territory.

The first load of tobacco arrived here the latter part of last week and several more loads have been added since that time. By Sunday the pilgrimage will have reached great proportions and tobacco town will be a beehive of industry as hundreds of tobaccoists and farmers prepare for opening day.

Raleigh, N. C., Sept. 3.—(AP)—Eastern North Carolina tobacco market, as which last year handled more than half of the golden weed in the State, will open for the 1932 auctions Tuesday.

With a much smaller crop this year and with better prices prevailing on the South Carolina border belt markets, farmers of the State's great tobacco-growing section were hopeful as they prepared to carry their tobacco to warehouse floors.

There, the auctioneers will move from pile to pile of tobacco and in their peculiar chant, will sell it to the highest bidder.

All of the large tobacco companies and export companies will have buyers on the floors, ready, with a wink of the eye, nod of the head, or raising of a finger, to make an offer.

The Eastern North Carolina tobacco belt, which last year had seventeen markets, including such tobacco centers as Wilson, Greenville, Kinston, Rocky Mount and Farmville, is by far the largest in this tobacco-growing State.

The belt last year sold more than 250,000,000 of the 466,000,000 pounds auctioned in the State on the floors of more than 145 warehouses.

One reason farmers of the section were particularly optimistic this year is the United States Department of Agriculture's report indicating production of only 147,300,000 pounds for the belt—more than 100,000,000 pounds less than were sold in 1931.

The indicated production for the whole State is only 266,560,000 pounds compared to 479,536,000 pounds produced in 1931.

Middle North Carolina tobacco belt markets open September 27 and old belt warehouses will swing into action October 4.

The State charged that Williams, finding his wife in the way offered to pay Wilson and Simmons \$100 to kill her. They started to carry out the plot, but lost their nerve.

Williams denied he knew anything about the plot, and that his wife had not been harmed. The case was begun Thursday afternoon.

Supt. Rose Announces Faculty Members for Various Schools This Term

The Greenville city schools will open for 1932-33 session on Monday, Sept. 12th, at 8:25 a. m. Indications now are that the enrollment this year will exceed the enrollment last year. The enrollment last year was 2,931. All work preliminary to the opening will be done next week, and most of this has already been done.

All high school freshmen are asked to meet in the high school auditorium on Friday morning, Sept. 9, at 9:00. All upper classmen who desire to have a change made in their choice of subjects will report to the high school building at 10:00 Friday morning. All pupils who have never attended the Greenville schools are asked to report to the office of the superintendent Saturday, September 10th. There will be very few changes in the faculty of the elementary grades for the coming year. In the high school there are more changes. The schools will operate with one less primary teacher, while there will be one more grammar grade teacher. Miss Eva Keeter returned as supervisor of elementary grades and principal of Third Street school; Miss Frances Wahl will again be principal of the Training school; Mrs. George Gardner will return as principal of West Greenville school. C. M. Epps will again be principal of the two negro schools.

RAIN RELIEVES HOT WEATHER

Parching Temperatures Broken in Some Sections by Welcome Showers

(By The Associated Press) Wind and rain in some places and predictions of similar visitations for others today appeared to have brought at least temporary relief to North Carolina and South Carolina, parched for six days by excessive heat.

Heavy rains were reported in several sections of North Carolina last night, and strong winds swept virtually the entire State, after a day which saw the thermometer above the 100 mark in numerous sections.

Greensboro, hardest hit of all the cities during the past week, which did not see a day go by without a temperature of 100 or better, was drenched for three hours, and the mercury took a tumble after climbing to 102, two degrees below the records of Wednesday and Thursday, and wind brought relief last night to those places which had not yet been touched by rain.

In South Carolina the heat was no so extreme, nor was the prospect of relief so imminent. Orangeburg and Spartanburg led with highs of 98.

Promised rains failed to arrive throughout the State, but clouds blew up during the night to lead to some hope that a thice-postponed rain forecast would not be much longer in fulfillment.

Plant Involved in Strike May be Closed Forever

High Point, N. C., Sept. 3.—(AP)—A threat that the Stehli Silk Mills here "may be closed forever" today hung over the heads of striking employees who yesterday blocked all efforts of mill officials to carry material into the picketed plant.

The threat came from W. C. Reich, general superintendent of the plant, who said he had received from the strikers a draft of terms upon which they were willing to go back to work, but had given it "no consideration."

"The plant is already closed for an indefinite period," he said, "and it may be closed forever."

His statement came after an attempt to drive a truck of material from the Harrisonburg, Va., branch of the company into the plant had been thwarted by pickets.

The truck, accompanied by police and about ten automobiles occupied by Stehli Foremen, drove up to the mill gates and attempted to enter. The strikers stood their ground as the motorcade headed into them and the effort to enter was given up.

The 400 employees walked out last Tuesday in protest against a wage cut.

RENEW FARM STRIKE AGAIN

Farmers Attempt To Blockade Sioux City Despite Truce Recently Declared.

Sioux City, Ia., Sept. 3.—(AP)—The agricultural war is on again.

Despite the truce recently declared by the leaders of the farmers' strike for higher prices for their products farm pickets in this section renewed their attempt to blockade the city. Gov. E. B. Olson of Minnesota gave aid to the movement in general by urging farmers of his state to withhold non-perishable produce from the market until after midwest governors meet in Sioux City Sept. 9.

The conference is designed to settle the controversy between producers and buyers over prices paid for agricultural products.

Pickets in the vicinity renewed their blockade attempt following the arrival yesterday of five truckloads of livestock, and announced they would keep it up until the governors' conference is held, continuing it indefinitely if no farm relief program is formulated. (Continued on Page Four)

HOPE TO SAVE HOMES OF U. S.

Federal Home Loan Banks to Extend Aid to Homes in All Parts of Country

French Lick, Ind., Sept. 3.—(AP)—The Federal Home Loan Banks were invincibly at the end of second mortgages by the United States Building and Loan League today.

This outlook was given at its 40th annual convention here by Senator James E. Watson of Indiana, last night in a address in which he said the primary purpose of the law creating the banks was to save homes already partly purchased and the secondary one was to build new homes.

"If this law works as we think it will," the Republican leader predicted, "the second mortgage will soon become a thing of the past and that specter will no longer confront the man who desires either to buy or build a home...."

Speculation Surrounds Resignation of Walker

New York, Sept. 3.—(AP)—Three little words—James J. Walker's "I hereby resign"—echoed perplexingly today down the political corridors of New York.

The immediate meaning was obvious enough; Walker was through, for the time being at least, with the mayoral chair. What people were wondering was what effect his resignation might reflect in November.

Uncertainty as to Walker's political intentions continued. Tammany Hall, one of whose favorite sons he has been, remained close-mouthed. Governor Roosevelt, who presided at the hearing on Walker's conduct of the mayor's office, had nothing to say.

Samuel Seabury, direct descendant of the Puritans John and Priscilla Alden, and generalissimo of the investigation which was the basis for the charges involving Walker, is enroute to Europe for a rest. Of the principals in the case he alone made an extended statement last night.

He said it was not surprising that Walker resigned because he (Walker) "simply could not explain." He praised Governor Roosevelt's conduct of the hearing.

CLUB HOST TO TOBACCO MEN

Kiwanians Observe 'Tobacco Night' with Fitting Program last Evening.

Optimism concerning the future of the Greenville tobacco market marked talks at the celebration of "Tobacco Night" by the Kiwanis Club last night.

Several buyers and warehousemen of the city were guests of the club during the evening and were treated to a program dealing almost exclusively with the bright leaf question but which was liberally interspersed with delightful musical numbers.

K. W. Cobb, supervisor of sales of the Greenville tobacco market, delivered the principal address. He presented statistics from the government crop reporting service showing that this market sold more tobacco last year than any other market in the belt.

Referring to the necessity for concerted action to hold the market's splendid reputation on this season, the speaker said it was not only incumbent upon the business men to support the industry, but that employees working under them be impressed with doing the same.

SEES CHANGE IN VOTE TREND

Says Polls Throughout The Country Show In Every State that Twenty to Sixty Percent of Those Who Voted Republican in 1928 Will Change Their Party Support This Year. Addresses Young Democratic Convention

(Associated Press Staff Writer) Schenectady, N. Y., Sept. 3.—(AP)—Governor Roosevelt's Democratic Presidential Candidate, speaking here at the State Convention of "Young Democratic Clubs" today called upon members of the Republican party to discard, disown and disavow a leadership that has proved bankrupt.

"Our quarrel," Mr. Roosevelt said, "is not one with the millions of fine living, clean, straight thinking persons, who, on paper, belong to the Republican Party."

The candidate asserted that "polls throughout the country show in every state that twenty to sixty percent of those who voted Republican in 1928 will change their party support this year."

Mr. Roosevelt remained at the convention only 30 minutes. He spoke extemporaneously. He returned to Albany for luncheon before proceeding to Bridgeport, Conn., where he will deliver a prepared campaign address tonight.

Governor Roosevelt told listeners that he had not come to Schenectady "to make a political speech."

"I came over here," the governor said, "not to make a campaign speech but to say howdy to old friends of mine from 262 counties of the state. I am glad I say I can."

"It means we are bringing in from the bottom those we are losing from the top."

"This fall we are going to win all down the line. Party ties rest more lightly on people, and that is a good thing. Party government is more responsible. In Abraham Lincoln's words, you can't fool all the people all the time."

Discussing changes in the New York State government, Roosevelt mentioned that "Alfred E. Smith put through" state government reorganization stronger than ever before.

The crowd applauded mention of Smith's name.

Daniel Flynn Is Dead in Florida

Jacksonville, Fla., Sept. 3.—(AP)—Daniel Miles Flynn, 74, native of Cumberland County, North Carolina, and vice-president of the Laurinburg and Southern Railroad in North Carolina, died at his home here yesterday.

A pioneer Naval Stores operator, he was a director of Turpentine and Restin Factors, Inc. and of the Atlantic National Bank here.

Among survivors is a sister, Mrs. Ella J. Rushing, of Hallsboro, N. C. His body will be cremated and buried beside that of his wife in Seattle, Washington.

PRESIDENT OF MEXICO SENDS IN RESIGNATION

Mexico City, Sept. 3.—(AP)—President Pascual Ortiz Rubio sent his resignation to Congress today, bringing a turbulent political crisis to a head after nearly three weeks of rumor and uncertainty.

He disclosed his decision to his cabinet secretly and the ministers also stepped aside to give congress and the president to be selected a free hand.

Paris—Germany's recent memorandum requesting equality in armaments will be submitted by the French government to the signatories of the recent European pact of confidence and also to the United States, Premier Herriot said today.

ALL MIXED UP Now that Henry J. Allen has made a speech it seems safe to announce the Republican campaign as having opened. Henry told his support audience that "England has been driven forward by the Socialist leadership of men who believe, as Jack Garner believes, that the way to make people happy and prosperous is to give them all the money they need out of the Government Treasury."

Beneath these husks of rhetoric Henry means to suggest that Mr. Garner believes in the dole and that the dole represents a socialistic attempt to get money out of the Government. Actually, of course the English unemployment insurance scheme was inaugurated by a Liberal Government and has not been challenged in principle even by the Tories. With the deepening of the crisis it cannot be described as financially self-liquidating, but on its behalf it could be plausibly argued that it has prevented the appearance of such phenomena as the bonus campers, the farm picketers and ubiquitous panhandlers that now give official Washington acute willies.

Surely this unemployment insurance fund, toward which the worker contributes himself, does not represent the philosophy Senator Allen condemns so perfectly as do our own tariff dole, our Farm Board dole, our R. F. C. dole and the millions of dollars in frankly unreclaimable charity that are handed out to the miserable in every section of America today. If Mr. Garner is to be attacked on the gratuitous supposition that he would like to give people money out of the Federal Treasury, what is to be said of the present Administration's myriad agencies which are actually handing it over?—Baltimore Sun.

The aldermanic presidency was made vacant by the elevation of Joseph V. McKee, who held that post, to the mayoral chair. The ninth district aldermanic vacancy has been created by the elevation of Dennis Mahon to McKee's old post.

His plane looked like a fat red-headed bug as it flattened into the distance.

A strong wind was blowing and the air was bumpy, but the Major held his plane close to the ground. The timers averaged his second, third, fourth and fifth laps at 296.27, 297, 297 and 297 miles an hour. The rules provided that any four consecutive laps may be used to determine the record.

This average is almost 18 miles an hour faster than the old record. The barograph and timers' official records must be calibrated by the Government Bureau of Standards at Washington, D. C., and then approved by the Federation Aeronautique Internationale, world governing body of competitive aviation events, before the record is made official.

(Continued from page one) kind of fountain be provided to take care of the situation. The report in detail follows:

NORTH CAROLINA, PITT COUNTY, TO HIS HONOR, W. C. HARRIS, JUDGE PRESIDING, AUGUST 1932 TERM SUPERIOR COURT: GREETINGS:

We, the Grand Jury for this term of court respectfully submit herewith the following report.

We have acted upon all bills and other matters which have been brought to our attention.

We have carefully inspected the offices of the Register of Deeds, the Clerk of Court, the Board of Education, the Auditors, the Treasurer, the Sheriff, the Tax Collector, the Welfare Department, the Health Department, and the Farm Agents. In each case we found the records well kept and the work pertinent to each office being carried on in a very efficient manner.

We inspected the Court House, the Jail, and the surrounding grounds and have found each in a well-kept condition. The prisoners seem satisfied with the food and other conditions touching the jail. While being held within the jail we have noticed that the people attending this term of court have experienced much difficulty in obtaining drinking water. We do, therefore, recommend the County Board of Commissioners provide a place so that the people, both white and colored, may have water to drink whenever they have business in the courthouse. We desire that there be a fountain or cooler, so arranged in the court house or upon the lawn, be placed, one for the white people and one for the colored people so that cooled water may be had by the public-at-large during the various terms of court.

We inspected the State convict camp near the County Home, and we want to commend Mr. D. M. Sellars for his excellent work in connection with this stockade. We found it in a very fine and sanitary condition, and the prisoners whom we saw appeared content insofar as food, clothing, and living conditions were concerned.

We inspected the County Home, and want to commend Mr. J. O. Harris in his attempt to make the County Home as near self-supporting as possible. We found the Home in good shape from the standpoint of cleanliness. We do, however, make the following recommendations with reference to the County Home:

1st. That immediate steps be taken to rid the Home of flies and bed bugs. While the windows and doors have had the wire screening thereon recently reworked, there are large cracks at the doors which could be closed with just a little work.

2nd. That immediate steps be taken to provide a better water supply for the livestock and cattle at the County Home. We do not believe that mules and cows should have to drink from the same trough in which hogs have wallowed, and we believe that action on this at once will greatly improve the looks of the various types of livestock.

3rd. That steps be taken to rid

New York Cotton

New York, Sept. 3.—(AP)—Cotton futures opened very steady, 17 to 23 points higher, in response to higher Liverpool cables and renewed general buying.

Houses with Liverpool connections were among the early buyers. There was also considerable trade and commission house buying on the advance which carried December up to 9.06 and March to 9.23.

Uncertainty as to weather conditions over the holiday and the tendency to scale down crop estimates contributed to the advance, but considerable Southern selling and realizing was encountered. Private crop reports issued placing the indicated yield at 11,100,000 bales compared with a report of 12,596,000 by the same authority last month.

Liverpool cables reported general buying and trade calling influenced by reports of unfavorable weather in the South. Cotton on shipboard at the end of the week was estimated at 68,000 bales against 59,000 last year.

Stock Market

New York, Sept. 3.—(AP)—The bull drive in stocks was pressed vigorously forward in one of the busiest Saturdays of the year in the stock exchange today.

Weekend profit taking was barely noticed, as a sharp gain in freight car loadings and confident predictions of a pickup in steel production, prompted heavy buying.

Extreme gains ranged from 1 to 5 points throughout the list, and closing prices were not far from the top, although a little profit taking developed in the last few minutes.

The turnover approximated two and a half million shares in the two hours of trading, which was at the pace of about 6,000,000 shares for a full session. The movement in shares was helped by further recovery in bonds, and a good tone in principal commodities. Brokers said public interest in the market had continued to increase with buying coming from many parts of the country.

Utilities and industrials led the day's forward movement with rails performing more sedately. The weekly freight car loadings report, while coming up to the optimistic forecasts, had apparently been partially discounted in advance.

Several of the steels again reached new highs for the year, with Bethlehem rising more than 3 points, and Youngstown Steel and Tube, Gulf States Steel, Republic, and McKeesport moved up about 2 points. In the utilities and communications, American Telephone gained 2, Western Union 5, and North American, Consolidated Gas, and others, one or more.
