TOBACCO MARKET WILL SWING OPEN TOMORROW

Mrs. Haizlip Sets New Landplane Record For Women Ohio Air Race

HUSBAND'S OLD PLANE IS USED

Noted Woman Aviator Flies Over 253 Miles an Hour To Shatter All Existing Records by 43 Miles an Hour; Makes Trio of Runs Over Course at 253.950 Miles an Hour Average.

Cleveland, Sept. 5.—(AP)—Mrs. Mae Haizlip became the speed queen of the world at the national air races today by shattering the women's landplane record with an average speed of 253.950 miles an hour.

Her margin was 44.887 miles an hour beyond the women's mark of 210.636 miles an hour, set April 17, 1931 by Miss Ruth Nichols, Rye, N. Y., society aviatrix.

Flying the same plane her husband, Jimmie, used a week ago in his transcontinental record dash of 10 hours and 19 minutes, Mrs. Haizlip attained the highest speed on her sixth run over the three kilometer course, averaging 268.700 miles an hour.

Mrs. Haizlip learned to fly after she was married. Eight months ago, at Clarksville, Tenn., her back was broken when her plane went into a tail spin at low altitude when she was taking off from an airport.

She was strapped to a rack for many weeks and Wednesday went up to fly for the first time since the crash. On the second time, Saturday, she unofficially shattered the women's landplane record, but she flew diagonally over the straight-way and her average could not be recognized.

With any four consecutive lap speeds counting for the record Mrs. Haizlip straddled over the straight away six times, the last four trials giving her the highest average.

While the record shattering runs can become official only after the barograph she carried has been calibrated and the mark homologated by the Federation Aeronautique Internationale, they marked an outstanding family and neighborhood speed conquest.

A week ago Mrs. Haizlip's husband dethroned his flying comrade and "boss" in every-day life, Major James H. Doolittle, as transportation speed king, only to have Doolittle come back Saturday to shatter the eight year old men's landplane record with an average of 296.287 miles an hour.

Lewis Bowen, of Omaha, flying the plane designed and built by Gordon Israel of Overland, Mo., averaged 202 miles an hour, fast enough to qualify for the 100 mile free for all race later in the day.

STORM MOVES ON FLORIDA

New Tropical Disturbance Reported Sweeping Over Bahamas to Coast.

Miami, Fla., Sept. 5.—(AP)—South Florida today prepared to weather another tropical storm as a disturbance was reported coursing through the Bahamas Islands some 140 miles southeast of Nassau and 300 miles east southeast of Miami. No high winds were reported from the actual storm area but the steamship Tarrabona, which gave a position 285 miles east of Miami, last night reported a 41-mile gale.

Richard W. Gray, Miami meteorologist, said the storm apparently was approaching Nassau and probably would pass near there this afternoon but would not cause any high winds on the lower Florida east coast until tonight or tomorrow. (Continued on Page Four)

BOARD DEFERS 1931 TAXES

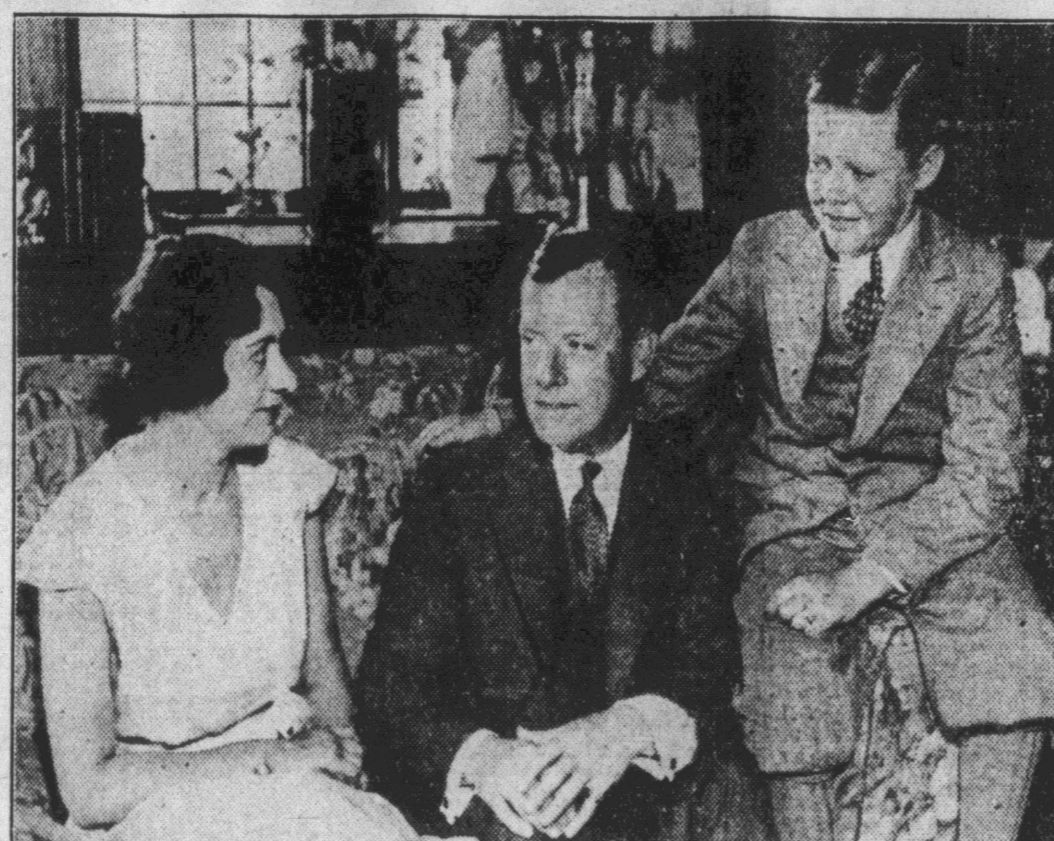
County Will Begin Advertising of Delinquents on October First

N. Y. IS UPSET OVER WALKER

Political Picture of the World's Greatest City Presents Varicolored Hue.

New York City's political picture today was a varicolored affair. The New York Times said Samuel Seabury, whose charges against James J. Walker led to the latter's resignation last week as mayor, would be proposed as a fusion candidate for the office in the event Tammany Hall champions the ex-mayor in the next election.

The Herald Tribune said John F. Curry, leader of Tammany Hall, is "unreservedly for nominating Walker for mayor this fall."

This paper also declared the Republicans have held out "the olive branch" to Tammany "by the suggestion that if the Democrats would drop Walker and put up a man of the type of Frank L. Polk, undersecretary of state in the Wilson administration, the Republican party might interpose no organization movement."

In still another quarter, the New York American criticized Walker for his attack on Governor Franklin D. Roosevelt for alleged unfairness at the hearing on charges against the former mayor.

TWO ROBBERS ARE NABBED

Men Held at Farmville Charged With Stealing Clothes At Pressing Club.

George Davis and James Moyer, colored, were held in the Farmville jail today charged with the robbery of a pressing club of that place Saturday night. Twenty suits of clothes were recovered when the negroes were taken into custody by county officers yesterday.

Officers said it looked as if the thieves had cleaned out the pressing club, judging by the two huge sacks of clothing which they had in their possession at the time of capture.

Officers surrounded the two negroes who were said to have recently completed terms on the roads, as they walked down the railroad tracks midway between Greenville and Farmville. The two men had paused for a rest and when they attempted to resume their journey they found themselves surrounded so completely that attempted escape was not to be considered.

Wood Again Captures British Speed Trophy

Harmsworth Course, Detroit, Mich., Sept. 5.—(AP)—The jinx rode again with Kaye Don's Miss England III today and eliminated him from the second and final heat of the Harmsworth trophy race after a thrilling start against Gar Wood, trophy defender.

Wood crossed the starting line a little less than a second ahead of Wood's Miss America X, Don made an heroic effort to keep his craft in the race. Roosevelt Prepares To Make 2 More Speeches

Hyde Park N. Y., Sept. 5.—(AP)—Armed with further assurances that party differences in New England will heal before election, Governor Roosevelt was preparing today for two more campaign appearances, one of them in Vermont within the next two days.

Resting at his Hyde Park home before proceeding to the New York State Fair at Syracuse tomorrow, Mr. Roosevelt yesterday received Peter P. Gerry of Rhode Island, and Mrs. Frances P. Sayre, vice-president of the Massachusetts state committee.

Gerry, who was a pre-convention supporter of former Governor Alfred E. Smith, told the candidate he believed feeling which grew out of Smith's failure to obtain the Democratic nomination would soon fade.

He expressed belief that many independent votes would go to the Democratic ticket because of the prohibition stand of the party and its candidates and the unemployment situation in Rhode Island.

TWO OFFICERS SLAIN IN FIGHT

Another Wounded As Attempt is Made To Arrest Negro Youth in Tennessee.

Lebanon, Tenn., Sept. 5.—(AP)—Bullets fired from a cabin in which five negroes were barricaded near here last night killed two officers and wounded another as they sought to arrest a negro youth for fighting with a white boy.

Reinforcements summoned from Lebanon routed the negroes from the shack with tea gas bombs and arrested them. Two were women. Constable Ben Northern, special deputies M. E. Brown and Sam Smith and Northern's son, Ben, approached the cabin to arrest George Benton Oldham who was sitting on the porch. (Continued on Page Four)

U. S. OBSERVES LABOR EVENT

Celebration Opens Up New Vista of Hope for Millions of Jobless People.

Washington, Sept. 5.—America took its last plunge in summer recreation today before turning more serious eyes toward winter's prospects.

For millions this 49th celebration of Labor Day opened a new vista of hope, bolstered by every tangible straw of business.

Many of the others—estimated at 11,400,000 by the American Federation of Labor that sponsored the holiday—saw in this seasonal turning point an end to their jobless days.

At least two groups in the country's life found their immediate outlook well defined. Millions of youngsters turned sadly back to school. (Continued on Page Four)

ROBBERS LOOT CHICAGO SAFE

Ten Persons are Held Prisoner as Vault Is Robbed of Between \$100,000 and Million

Chicago, Sept. 5.—(AP)—Loot variously estimated from \$100,000 to \$1,000,000 was taken by a gang of robbers from the safety deposit vaults of Koch and Company on South Halstead street but until the operation of a time lock Tuesday morning no definite check will be obtainable.

A gang of at least eight men held 10 persons prisoners in the building for 14 hours, bored through the floor of a second floor apartment, and burned their way into the vault. They then smashed about 350 safety deposit boxes, took their pick of the contents, and fled at 4 a. m.

The robbers penetrated two layers of armor plate with a combined thickness of 15 inches. The hole they made was small and entrance through it was difficult so officials of the firm planned to wait until the time lock released the vault door Tuesday before making a check of the loss.

Police at first estimated the loss would run from \$250,000 to \$1,000,000 but company officials said they doubted the loot would exceed \$100,000.

BIG AIR RACE IS ON TODAY

World's Fastest Sporting Event to be Pulled off at Cleveland at 5 O'clock.

(Associated Press Staff Writer) Cleveland, Sept. 5.—(AP)—The world's fastest sporting event, the 100-mile free-for-all airplane race, provided the grand finale today to the twelfth annual air races.

Only uncertainties of the weather, trickiest foe of airmen, stood between ten veteran pilots and the starting bomb at 5 p. m. An even chance was forecast for calm weather and good visibility.

Meanwhile, race officials attempted to iron out difficulties which sprang from the women's high-speed free-for-all, flown in a driving rainstorm yesterday and flagged down because of the hazardous conditions after four of the scheduled eight laps were completed.

Mrs. Mae Haizlip, winner of second place behind Gladys O'Donnell of Long Beach, Calif., protested she purposely had kept her plane throttled down, expect to spurt to victory in the final four laps which never were run.

Seven stream-lined racing ships, little more than winged motors, stood qualified for the men's 100-mile free-for-all. Each had surpassed the necessary 200 miles an hour average speed necessary to admittance to the elite circle of competitors and three others were poised for qualifying before the official starting time.

The three Jimmies, Major James H. Doolittle, James G. Haizlip and James R. Wedell were considered foremost contenders. Doolittle qualified his powerful low winged monoplane at 309 miles an hour and then hurled it three times more over the three kilometer course to a new unofficial world's landplane speed record of 296 miles an hour.

The contest committee, meeting last night, upheld the outcome of the women's free-for-all on the grounds that rules of the Federation Aeronautique Internationale prescribe that a race may be halted on or after the half way mark, and the positions held by the contestants at that point shall be the final positions.

Mrs. Haizlip, however, said she would reopen the matter and, unless the race was re-flown, would withdraw from racing as long as the national races were held under Cleveland management.

TREK TO CITY IS UNDER WAY

Five Sales to Officially Set Season in Motion Tomorrow Morning at 9 o'Clock

Eight Warehouses, Nine Factories and Big Corps of Buyers To be on Hand; City Prepares to Take Care of Visitors

The highways in this part of the country were dotted with thousands of vehicles of every description today as farmers moved toward Greenville for the opening of the great bright leaf tobacco market tomorrow.

Although scores of loads of leaf had been placed on warehouse floors today, the movement was not expected to reach its height until tonight when hundreds of workmen will be kept busy unloading the golden offerings and placing them on warehouse floors in readiness for the tuneful cry of the auctioneers tomorrow morning at nine o'clock.

Always one of the greatest days of the year, drawing much larger crowds than old-time circus days, thousands of people were expected to flock to the city tomorrow to get first hand information concerning the price situation. Hope of improvement in the price situation has been boosted materially by the constantly improved trend on South Carolina and border belt markets and growers were anticipated one of the most favorable openings in years.

The shortage of the crop in this immediate section—producer of the finest cigarette tobacco in the world, is also expected to be a tremendous factor for better prices. While a half crop has been forecast by government crop surveying agencies, it was believed by many the reduction would exceed this figure in view of unfavorable weather conditions which affected late tobacco—and there is a considerable amount in this locality caused by replanting during the early part of the season.

Five sales will be set in motion at one time tomorrow morning at 9 o'clock and from then on until the floors of eight great warehouses have been cleared the auctioneers will be heard in their peculiar singsong tones, quoting prices which will mean either better times or continued bad times for the thousands of people depending almost entirely upon this great industry for their livelihood.

Tobacco town, here, always a seething sea of industry during tobacco season, and especially opening day, has prepared to take care of the demands of the influx of visitors, and scores of cold drink, barbecue, hot dog and concession stands have popped up almost overnight to serve the hurrying, jostling crowds that will be on hand when sales are set in motion.

In order to take care of traffic and to hold congestion to a minimum the police department has made preparations for handling the crowds as usual, and while streets and buildings will be crowded to capacity, it was expected the situation would be handled to the satisfaction of visitors and townspeople alike.

Tobaccoists from markets of other belts began arriving in Greenville last week in preparation for the initial sales and when the curtain rises on the new season every warehouse, and buying concern will have its full corps of men on hand to help speed up the sales and keep golden wheels of industry moving at full blast.

Five sales going at one time, eight warehouses, nine factories and groups of the finest workmen in the market will enable the Greenville market to dispose of 1,750,000 leaf daily. This means that leaf daily "block" sales will be almost a thing of the past, although tremendous offerings caused several blocks last season.

ABOUT TOWN

Tomorrow is the big day for Greenville and this part of the state.

The opening of the bright leaf tobacco belt is always of great significance to the community because it is the beginning of a period when millions of dollars are poured into the pockets of the growers.

The growers in turn settle outstanding obligations and in a short time some of the money has warmed the pockets of nearly every individual in the community.

This is what is meant by circulation, the continued passage of money from one individual to another, and if we had the tobacco sales all the year around it is impossible to say what the financial status of the locality would be.

With one of the shortest crops in history, tobaccoists are anticipating better prices for their crop this year. Strength is given to this hope by condition of prices on the Georgia and border markets.

Good prices for this crop will enable the farmers to get rid of some of the debts accumulating during the low prices of the last two years and should improve business conditions in other fields.

We do not mean there will be any transformation to prosperity overnight. It will take this country years to get back where it was years ago, but improved prices will certainly ease the financial situation somewhat and make life more amenable for those who have had the wall from their doors.

Everybody will watch the market tomorrow, and around the prices will hang the answer to the question which has been uppermost in every mind the last several months.

The new grand jury sworn in during last week's session of criminal court started out by making more recommendations than any jury has made for a single term of court in years.

There was nothing in the attitude of the new jurors who accepted their task with keen realization of the responsibility and right of the bat assigned to show that they knew what they were about. It isn't necessary for the courts to admonish the affairs for they already have their eyes on their goal and mean to reach it as quickly and effectively as possible.

Had he started two years ago before the depression became so poignant it is likely he might have received good audience, but as it stands now his chance of gaining serious consideration is just about as slim as the chance of a camel crawling through a needle, and that is one of the unthinkables. Roosevelt is exposing the shortcomings of the President and by the time he gets through it will take ten Reconstruction Corporations and agencies backed by all the big interests one could gather with a search warrant to get the President out of the dilemma.

In 1902 butter sold from 18 to 22, hams 15 to 18, eggs 25, hens 30 to 35 cents a pound, and cabbage 75c, a barrel.

The quotation contained on each card which was usual for the time but which would be very unusual for these days, was the price of liquor. Whiskey prices were quoted at \$1.25 to \$4 a quart. This was for the best liquors. Bootleggers who have a hard time getting \$1.50 a gallon for their contraband look at the old quotations with watery eyes and wonder what has become of the "good old days."

Almost a score of new bright leaf belt markets in the state will open, among them some of the nation's greatest tobacco bartering centers. Cheered by rising prices on the South Carolina and border markets which opened nearly three weeks ago, and with prospects that the government crop estimate of a 266,500,000 pound crop in the state will prove still too high, farmers were optimistic.

The Eastern North Carolina markets handled more than 260,000,000 pounds last year, more than half of the state's crop. This year the belt is expected to produce less than half of the 1931 total, and reports from other markets indicate the ready aware of the fact and ready to bid high to secure an adequate supply.

Among the markets opening tomorrow are Greenville, Wilson, Kinston, Goldsboro, Rocky Mount, Farmville, Wendell, Zebulon, New Bern, Washington, Wallace, Tarboro, Enfield, Ahoskie, Robersonville, Williamston and Smithfield.

The new bright belt served by these markets is expected to produce about 150,000,000 pounds, a drop of almost 100,000,000 pounds under last year's total.

Brown gave chase to Oldham but a volley of shots from within mowed the officer down.

Two pistol shots were fired at Smith as he aimed at Oldham and one bullet struck his arm.

Ben Northern Jr., ran to the side of his slain father and a load of buckshot passed through his hat but he was unscathed. Sheriff Ed Climer and Deputy S. C. Shorter subdued the negroes soon afterwards with tear gas but Oldham escaped. Two shotguns and a pistol were found in the cabin. Northern was slain two hours before the expiration of his term as a constable.

(Continued from page one) school textbooks; thousands of political workers rolled up their sleeves for two months of intense campaigning before the next President of the United States is chosen.

Forecasters promised generally fair weather today for the hundreds seeking rest and relaxation at seashore and mountain resorts before the trek back to office, job and farm. Anxious as any for clearer skies was President Hoover, resting over the week-end at his Virginia camp.

It was cool on the Rapidan but low-hanging clouds had wrapped the camp in mist. The President spent much of his time indoors, talking with advisors and guests. He planned to complete rest that eliminated any participation in Labor Day ceremonies.

These were held throughout the nation, as they have been every year since proclaimed by the American Federation in 1884. Now, September's first Monday is a holiday by act of Congress and most of the state legislatures.

Here, the firemen's parade marched its annual course up Pennsylvania Avenue. Companies from New York, Delaware, Virginia, Pennsylvania and Maryland joined in the reviewing stand.

Secretary Doak of the Labor Department was en route to Syracuse, N. Y., to make the address opening the state fair. His support has been pledged to organized labor's renewed efforts this year for a 5-day work week, subject today of a national radio address by Frank Morrison, secretary of the labor federation.

John L. Lewis, president of the United Mine Workers of America, said in a formal statement that workers "have refused to listen to the false preaching of demagogues and dangerous prophets."

"Let us continue along that safe and sane pathway in the year that lies ahead," Lewis said, "hoping, praying and believing that better times and better things are in store for us."
